

a 69 percent average. Grade 11 rose 11 percentage points from last year to 72 percent.

In mathematics, the scores did not fair as well.

Algebra One rose two points from last year, but only to 33 percent. The high school has introduced two classes to address the problem, a conceptual algebra class and algebra support classes, Tash said.

"We have to do better, that is why we're trying the support classes," Tash said. "Our prediction is that will make a difference."

The support classes were introduced as electives and either preview or reinforce what is taught in algebra. Tash said the conceptual algebra classes teach students how to think about the problems in different ways, making it easier to grasp the material and solve problems.

Geometry rose 12 points to 52 percent.

"We took a real dive the year before," Tash said. "But where we are is back where we should have been."

Algebra two dropped to 44 percent.

While the lower and mid level math classes tested poorly, the advanced classes, which are everything beyond algebra two, rose 17 points to 74 percent.

Tash said while these scores are low, it gives the district a jumping off point to see where improvement is needed.

"We're going to break it down into clusters to see where they were strong, where they were weak, what they were tested on, what can be improved and what do teachers need to do," Tash said.

Elementary fared well in the English/language/arts test scores. Grades two through eight were tested.

Grade two saw an eight percent growth to 77 percent. Grade three and four rose six points each to 67 and 85 percent. Grade five rose nine points to 79 percent. Grade six declined three points to 76 per-

cent. Grade seven stayed put at 83 percent and grade eight rose 2 points to 83 percent.

"We're seeing that we're moving in the correct direction," Tash said.

Despite seeing improvements, Tash said the district still works constantly to maintain or exceed its scores.

Grade two through eight also saw improvements in math scores as well.

Grade two saw 9 point gain to 81 percent. Grade three maintained its 82 percent score and grade four rose 1 point to 85 percent. Grade five rose 4 points to 74 percent. Grade six and seven maintained scores of 65 and 74. Grade eight finished with 86 percent in algebra one, which is a 7 point gain.

Tash said the schools have worked hard to get where they are.

"We congratulate ourselves, we feel good about our work, then we say 'where do we have to go next,'" Tash said. "You can never lose sight of the fact that you can always improve."

He said over all, the district felt good about this year's scores.

"When I give these scores individually there is highs and lows but overall this is very good news when you look at it as a totality," Tash said.

September 11 Memorial Ceremony



Birds On Attack

And other news in BH

The city may be able to work out a compromise on the feeding of homeless, feral felines, but what about birds that probably had their training by watching **Alfred Hitchcock** movies?

We have, in our village, birds that have declared war on people and, for the residents on North Bedford, it has become a frightening invasion of their right to enjoy the Beverly Hills experience.

Certainly, safer streets and a world class police department are one of the major reasons people choose to live here even though that often means paying more for homes and higher rents. However, even our gendarmes are, up to now, powerless to help the attack victims on North Bedford.

For the past five months, two woodpeckers have been acting like dive bombers, aiming fearlessly at residents heads sometimes forcefully enough to draw blood, but always with sufficient force to send people running back to their homes or dashing to parked cars.

When not stalking and pecking at scalps, these hostiles peck away at doors, windows and parked cars causing considerable damage and creating noise from dawn to dusk.

So, why can't the city send out someone to reduce our bird population by two or, at the very least, scatter the flying fortresses out of Beverly Hills trees? If North Bedford was being threatened by a coyote or even a mountain bear, animal control would be there with tranquilizers.

First, a word about the one of the families under siege. The **Savars, Sara Lynne** and **Dr. David**, are long-time residents. Their three children are products of the Beverly Hills schools. They are active in their temple and in the community. He is head of ophthalmology at Cedars-Sinai and his medical office is in Beverly Hills. How best to describe them? We have known them for many years, but have never, ever heard either of them express even one negative comment about another person. In a community where disagreements on candidates and issues often lead to ruptures in long time relationships, their civility is always marvelous to experience. Yes, they care and stay very much informed, but they are not listed in Angry Residents of Beverly Hills.

Does this matter? Well, when **Sara Lynne** told us about the winged marauders, I knew she was not likely to exaggerate or express a frustration for the response from city officials without good cause.

However, it turns out there is little or nothing our city staff can do, at least not yet. Beverly Hills does not do animal control; we contract that service with Los Angeles Animal Services. Can they send out some bird snatchers?

Not exactly, since these woodpeckers are protected by federal law and animal control must obtain permission from the United States Fish and Wildlife Service to "remove" the woodpeckers.

Following conversations with city officials, **Lt. Jesse Castillo** from Animal Services did call **Mrs. Savar** and carefully explain the mating, breeding and nesting habits of the woodpecker. She needed no detailing of woodpecker habits since she and her neighbors understand all too well that they are flying people haters.

Los Angeles officials insist they need something in writing to take to the next level: the federal government. But now **Mrs. Savar** has a new ally, the very able code enforcement manager for Beverly Hills, **Nester Otazu** on her side. Apparently, code enforcement is liaison with animal control and reports through **George Chavez**, head of building and safety, another top rate city official.

The birds may have had their day. Now, if you feel this has received more attention than it deserves, your North Bedford Drive neighbors invite you to stroll to the corner of Carmelita and Bedford, but watch your head. You might also see damaged car windows, holes in doors and the exacerbating rattle of pecking at roofs of homes on the street.

We have another reason for trying to help. Apparently these sky devils are not fans of *The Weekly*. On Thursday morning, when **Sara Lynne** opens her front door to retrieve our paper, the bird goes into attack mode. Could the Republican Party actually have a winged auxiliary? Or has **Kurt Haber** been reincarnated?

More on this later.

One of the approved projects we neglected to mention last week was the renovation that will soon be completed at Pavilion's at Beverly and Olympic Boulevards.

Mostly structural improvements, store officials were not yet sure when or for how long the store might have to close, probably not beyond some late night hours. However, there has been a reduction in inventory replacement, and many displays are empty.

A major empty property we are trying to track is the Friar's Club at Little Santa Monica Boulevard north of the Peninsula.

Although the original Friar's ceased operations and became a private club with no affiliation with the Friar's in New York, it continued to operate for several years under private ownership. Now it is used for private functions and is not open to the public or former members.

Calls to the owners and brokers were not returned at press time, but there were earlier reports of a possible tie to the Peninsula.

That world class operation simply does not have adequate banquet facilities to meet the demand. Severely restricted when they finally won approval after seven years of going through the city's review process, the hotel, and the community, could probably benefit from an expansion of banquet resources.

The Friar's story is one worth recording, including their biggest scandal, the one that nearly closed the club 40 years ago.

Briefly, it was a well organized scam. Although not entirely legal, the club did permit card playing for high stakes. Gin rummy was the main event but what unsuspecting compulsive gamblers such as **Harry Karl**, the shoe magnate once married to **Debbie Reynolds**, and the legendary comic **Phil Silvers**, did not know was that the people sitting opposite them, the mob pros, were actually wired to a confederate who had a peep hole in the balcony, able to send crude signals on when to "knock" to their partners.

Each of them lost close to a million dollars as did other unsuspecting gamblers. When the cops finally found out about the rip off, the federal government indicted a small army of Friar members on conspiracy charges, most of them being found guilty. It took many years for the club to recover.

A lesser scandal involved the legendary Toastmaster General of the United States, **George Jessell**. When the club decided to honor one of their most illustrious members, it

commissioned the making of a bust to be installed at the club's entrance. Following a star studded unveiling and a mini-roast, the bust quite surprisingly disappeared. Within days, the club received a call that the Jessel bust was being held for ransom! Turned out, it was an inside job and our police were able to retrieve the bust without any loss of face, Jessell's that is.

A Beverly Hills restaurant legend, **Kurt Niklas** died recently, but even in death there was a bit of controversy.

Although Niklas, who founded the Bistro and the Bistro Garden, two of our most successful eateries ever, and the latter now the site of **Wolf Puck's Spago**, had a very caring wife during his last months, there was no mention of her in the obituaries.

Apparently, the family was not happy with Kurt's late in life marriage, but **Jutka** deserves much praise for her care giving during the last months of his life. Although confined to a wheel chair, I saw a still alert Kurt at Whole Foods being conveyed while helping with the shopping by a very solicitous Jutka. I am grateful to former Mayor **Joe Tilem** for calling this to our attention.

Of course, no mention of Niklas could be written without a recounting of an event that probably helped close the Bistro Garden. (A very beautiful satellite still operates, and very successfully, in the valley at Coldwater and Ventura Boulevards.)

The players in this story are all gone except a witness I totally trust and, although Kurt whose mother was Jewish had issues with his heritage, the allegations that some anti-

BHHS To Open Football Season Friday

Normans set to play host to Long Beach Jordan.

Beverly High will begin its 83rd football season Friday night with an offense designed to tire out its opponents and a new coach who describes himself as more aggressive than his predecessor, who happens to be one of his brothers.

The Normans, who are set to play host to Long Beach Jordan in a nonleague game beginning at 7 p.m. at Nickoll Field, will again utilize no-huddle and hurry-up offenses, according to coach Donald Paysinger.

"It gives us an advantage wearing the other team down," Paysinger said. "In the third and fourth quarters, when the other team is tired, we're still going. That's a huge advantage."

Junior Josh Newman will be Beverly Hills' starting quarterback, replacing Dex Lucci, who graduated after being the starter in the 2007 and 2008 seasons.

Newman started one game last season, completing eight of 17 passes for 120 yards and had one pass intercepted in a 37-28 victory over Santa Barbara before breaking a col-

lombone on a late hit, causing him to miss the remainder of the season.

"Josh is going to be a very good quarterback," Paysinger said. "He's been in the system. He knows what to expect. He's smart. He understands the offense. He knows what we're trying to accomplish — getting the ball to the open guy."

The Normans will use a three-receiver set, which will include Daniel Bradbury, Marcus Silbiger and Cameron Countryman.

"They can catch the ball," Paysinger said. "They all know the game."

Tight end Greg Townsend will be another target.

Running back Kenny Bassett, who rushed for 1,414 yards and 14 touchdowns on 186 carries last season, according to statistics posted on the Web site, Maxpreps.com, returns.

"I can't remember the last time we had a running that can see the field the way he can," Paysinger said. "He's very quick, knowledge-

able of the game."

Bassett has drawn recruiting interest from "three or four" Pacific-10 Conference schools, and "just about every Mountain West Conference" and Western Athletic Conference team, Paysinger said.

Beverly Hills starting offensive line is expected to consist of center Nick Enayat, quick tackle Camyar Meshkaty, quick guard Reese Wynton, strong guard Michael Gluck and strong tackle Torrey Lubkin, Paysinger said.

"They're young, they started off slow in practice, but they're picking up things quite well now," said Paysinger, who is also the team's offensive line coach. "They're making the correct reads."

The Normans will again use a 3-4 defense that will be led by Townsend, a junior defensive end and a member of the ESPNU 150 watch list.

Townsend, whose father, also named Greg Townsend, was a NFL defensive end for 13 seasons, 11 with the Los Angeles Raiders, told the ESPN affiliate Web site WeAreSC.com this week that he has received a written scholarship offer from USC.

"It makes me feel like I can go play at the next level since I have an offer from a big-time school," Townsend told WeAreSC.com. "But I still want to get better and get noticed by other colleges."

"I really want to hear from Miami and Texas. Miami is just known for producing athletes and in Texas, they are all about their football. I don't have a list of top schools right now but I like USC, UCLA and Oregon right now."

Under NCAA rules, Townsend may not officially accept a scholarship offer until Feb. 2, 2011, the National Signing Date following his senior high school season.

Townsend, listed at 6-foot-4, 235 pounds, has "got the ability to really have a break out season," Beverly Hills defensive line coach Mike Levy said.

"He's worked very, very hard," Levy said.

"He's got size, quickness and a good football sense. He's worked on his technique to the point where he's very difficult to block."

Meshkaty, a defensive end, nose tackle Mauricio Meneche and defensive end-nose tackle Brandon Pena, and will join Townsend as starters on the three-man defensive line, Levy said.

Bassett and Willie Woods will be the starting cornerbacks, while Silbiger and A.J. Fortier will be the starting safeties, defensive coordinator Vonzie Paysinger, a younger brother of Donald Paysinger, said.

Woods will be both the team's kicker and punter, Gregg Riesenber, who coaches the team's kickers, said.

"He's got a real strong leg, he's accurate when he has a smooth stroke and he has a good, calm discipline about himself, which is big for a kicker," Riesenber said.

"Punting right now is a new adventure for him. He hasn't done it in a year or so and something we're working on a lot this week."

Donald Paysinger, a longtime Norman assistant coach who was Santa Monica's coach in the 1998 and 1999 seasons, was named last month to succeed his older brother Carter Paysinger, who was the team's coach since 1990 and is now an assistant principal.

Carter Paysinger will continue to help call plays during games and develop game plans on weekends.

Donald Paysinger described himself as "more of an aggressive coach" and "more of a fiery coach."

"I'm one of those coaches that likes to get things going," he said.

Long Beach Jordan, Friday's opponent, was 7-4 in 2008, including a 28-13 victory over Beverly Hills, and was eliminated in the first round the Pac-5 Division playoffs, the Southern Section's top division.

The Panthers run a form of the spread offense. They return their starting quarterback, John Timu, who completed 105 of 217 passes for 1,395 yards and 15 touchdowns and had seven passes intercepted and ran for 642

yards and five touchdowns on 99 carries.

Against the Normans, Timu completed 11 of 21 passes for 125 yards and two touchdowns and had one pass intercepted and ran for 29 yards on nine carries.

"Our keys [are] to play our game, [an] error-free game, and speed the game up," Donald Paysinger said. "Our defense [needs] to swarm [and have] 11 guys on the ball every play."

Beverly Hills was 8-4 in 2008, sharing the Ocean League championship with Culver City, but being designated as the league's No. 2 team for playoff purposes because of its loss

to the Centaurs. The Normans reached the quarterfinals of the Western Division playoffs.

Beverly Hills has a 9-7-2 on-field record in its openers since 1990, including losses the past two seasons. The Normans were credited with a forfeit victory in their 2001 opener against South Torrance, which used an ineligible player in a 52-33 victory.

Semitic remarks were made one night at the Bistro Garden were probably untrue.

In any case, the furor was supposedly caused by his son Chris and not Kurt. It began when the very volatile community legend **Ellen Byrens** was entertaining a small group and as she arrived heard considerable noise coming from a private party room next to the outdoor dining area.

"Who are those people making all that racket," Bryrens a close friend of the Niklas family supposedly demanded to know.

What Ellen later reported was that Chris said: "You should know, they are your people."

However, one of her guests that night was former school board member **Dr. Arthur Malin** and he told me weeks later that it "never happened" and that Ellen never even mentioned the conversation that night.

Hard to understand what prompted her to repeat words she probably never heard or, at best, misunderstood, but within days the

whole story made the front page of the New York Post and Jewish organizations were quickly canceling all events at the restaurant.

Kurt was, during his prime, capable of all kinds of less than sensitive jibes only he considered amusing, even if they bordered on being anti-Semitic. His heavy, exaggerated German/Austrian accent didn't help.

One time, when I was waiting for Assemblyman **Mike Feuer** at Caffe Roma, Kurt arrived and took an adjoining table. When Mike came, I introduced him to Kurt. What did Kurt say, and I am not exaggerating: "Feuer, I like that name."

However, son Chris had no such sense of humor, was very careful and far more patron sensitive than his father and even less likely to have said anything remotely racist.

Although Kurt was very hard to like, I thought the restaurant was being unfairly targeted. Ellen was willing to admit she had made a mistake, but before anything could be done, she quite suddenly died, as did the Bistro Garden.

The Normans are "a very strong and experienced group," that can "definitely compete with Santa Monica for" the Ocean League championship, according to coach Marla Weiss.

The team's returning starters are Syline Kim, who had been an outside hitter but is being shifted to opposite hitter, setter Brianna Prince, libero Emily Rosen, outside hitter Mallory Smith and middle blocker Tamara Skootsky. All are seniors except for Rosen, a junior.

Junior Michelle Wolff, a part-time starter last season at middle blocker, also returns.

Several readers have asked why I have had no comments on the lawsuits involving a school contractor that have inflamed the school community.

I have also been somewhat reluctant to write about some of the side issues including a now well publicized tiff between board members over a civil lawsuit.

My reasons are mostly about confidentiality. I serve as first vice chair of the school district's Independent Citizens Oversight Committee and this committee is charged with reporting on how bond money is expended on school construction - to the school board and to the community.

When the committee, and it has some very outstanding resident members, begins to make its findings public, I will have much to say about what really happened here. In the meantime, and although they are seriously split on many issues, it was the action of the whole board that quickly responded to the contract problems. Give credit to President

Senior outside hitter Julia Ayeroff is also expected to start, Weiss said.

The team "built quite a bit of confidence" during its summer play, but "one area we really need improvement in is the mental game," Weiss said.



THE ART OF THE ARCHITECTURAL COMMISSION

The Weekly's exclusive interview with Architectural Commission Chair Allen Rennett

Tell us about the Architectural Commission.

The Architectural Commission reviews new construction and significant changes to commercial and multi-family buildings. We also handle requests for "sign accommodations" based on provisions of the Municipal Code that allow deviations from the usual rules if the Architectural Commission is able to make specific findings. We are also charged with advising the City Council on historic preservation matters.

We don't have any control over the size of the projects that we review: in most cases, by the time the project comes to us either the Planning Commission or the City Council has already defined how large it can be. So if we think a project is too large, all we can do is make sure that the architect avoids features that make the building seem even larger and uses techniques that make the building feel less intrusive.

What is the commission working on?

We are almost entirely driven by the projects that come before us. In the past few years we have had as many as 18 or so items on the agenda for a single meeting. With the economic slow-down, the agendas have recently been much shorter. I hope the low point was a few months ago, when we only had about half a dozen items. Since then, the volume has been bouncing back a little.

In a way, we were fortunate that the slowest period came when it did, because it gave us some time to adapt to a couple of administrative changes caused by the City's budget cuts. First, we now have a strict deadline for finishing each meeting because we can't keep the support staff overtime.

The second major change is the loss of our bus tour. We previously took a one-hour bus tour immediately before each meeting to look at the projects on the agenda. Now we are taking the bus tour only when absolutely necessary.

How does the Architectural Commission compare to the Design Review Commission?

The Architectural Commission deals exclusively with commercial and multi-family buildings – apartments and condominiums. The Design Review Commission deals exclusively with single-family residential. The line is clear in theory and even clearer in practice: nobody is building duplexes any more, and even triplexes are very rare.

What has been your favorite project to work on since joining the commission?

That's hard to say. A number stand out for different reasons. But my favorite is the Saban restoration of the historic Wilshire Theater. The project requires architectural archeology to discover what the building looked like in its early days. Colors are especially challenging because all of the photographs from the period were black and white. We had to work through a maze of regulations to figure out what materials, like neon, could be allowed even if they wouldn't be allowed today, and figuring out what historic things couldn't be done because they don't meet current fire and safety standards. Then, to top it off, the regulations prohibited us from approving anything that would create a sense of "false history." That means we couldn't allow any new feature that was true enough to the original style that it seemed historically accurate but wasn't.

What got you involved with the commission?

I spent the first twenty-eight years of my legal career at Richards, Watson & Gershon, where I practiced real estate and commercial law for both private and public clients, including City of Beverly Hills. After I left that firm to concentrate on representation of private clients, I was free to participate in City affairs as just a resident. I graduated from Team Beverly Hills, served on a General Plan Subcommittee and then starting watching for commission vacancies.

When a vacancy came up on the Architectural Commission, I was intrigued but wasn't sure whether to

apply, so I went to a meeting to see how the Commission worked. I thought the cases were interesting, and I liked that the Commissioners were physically active: they walked around to more closely examine the renderings and the material boards, to look at them from different angles and in different lights, and to actually feel the material samples. But I was most impressed by how the Commissioners worked together. They really seemed to enjoy working with each other. Even when they disagreed, it felt more like they were brainstorming rather than debating, which was really refreshing to someone who spends so much time dealing with other lawyers. So I applied and got appointed on the second try.

How long have you lived in Beverly Hills?

Thirty-four years, starting from a little house through tearing it down to build a bigger house, through a divorce, through an apartment and now finally a condo. I can't imagine choosing to live anywhere else.

What brought you to the area?

I moved to L.A. from the Philadelphia area right after law school. Aside from the climate, L.A. offered fantastic growth opportunities as compared to the stodgy old Eastern law firms. My ex-wife worked as a substitute teacher in many of the local school districts, and felt that Beverly Hills was easily the best. So, like so many people, I came here for the schools. My daughter, now 29, and my son, who turned 27 on Tuesday, both graduated from Horace Mann and Beverly.

What style of architecture would you like to see more of?

I don't care, as long as it is good architecture. I doubt that I would have applied for the AC if it was just charged with making sure that everything fit into the same style. The variety not only makes things interesting, but allows architects to go with their artistic visions. This is a very competitive market, and commercial properties want to draw attention to themselves. In other places they draw attention with gigantic signs, bright colors and flashing lights. Here, they compete on creativity, style and quality.

How does being a lawyer help your job as Architectural Commission chair?

I'm especially sensitive to making a clear record. We often have a lot of ideas

bouncing around our meetings, and it can be very confusing for an applicant to hear a series of sometimes conflicting opinions from the Commissioners. I try to pull together the threads of consensus and separate them from other ideas that have been suggested. Sometimes those ideas can be extremely helpful, and the applicants should consider them, but the key is making sure that the architect and the Planning Staff understand the Commission's concerns. As long as the architect understands what the Commission is concerned with, the architect is in the best position to figure out the best solutions. The Staff usually has a good feel for what the Commission is thinking, even when we aren't as clear as we should be, but they are most effective at helping us and the applicants when we are clear. Our goal is to get each project approved as quickly as possible so that it can get built and begin contributing to the community.

What does the future hold for the commission?

Once the General Plan is approved, we would like to see changes in the Municipal Code to address the effects of new technologies. New materials make it possible to do things consistently with Beverly Hills standards that previously couldn't be done. And digital displays present some significant challenges; due to their high resolution and brightness, a display all the way at the back of a store can now present a distraction to people on the other side of the street.

In the shorter term, we look forward to our annual awards for the best projects completed during the previous year. By generating good publicity for both the architect and the owner, we hope to encourage outstanding creative work. The awards are presented at a City Council meeting, and honorees have flown in from as far away as New York and Europe to personally receive the awards. Last year we had a reception before the Council meeting, featuring photographs of the winning projects taken by Zale Richard Rubins, a professional photographer and Vice Chair of the Commission, whose architectural photography is stunning!

We were pleased that the awards were so well received by the world-class architects who have already established their reputations, and are even more excited about bringing attention and recognition to talented young architects who are in the early stages of building theirs.




