

Beverly Hills Education Association Endorses Manaster, Korbатов

The Beverly Hills Education Association announced its endorsement last Thursday of Board of Education candidates Jake Manaster and Lisa Korbатов.

Nooshin Meshkaty refused an interview with BHEA, citing "conflicts of interest."

"BHEA looks forward to actively supporting cam-

paigns of Mr. Manaster and Ms. Korbатов as we believe that these two candidates will firmly move our district in a new direction," BHEA President Christopher Bushee said in a statement.

"We believe that [Manaster and Korbатов] possess the leadership qualities that the Beverly Hills community deserves in school board members," said BHEA President Christopher Bushee. "We feel confident that both ... are committed to fiscal responsibility and accountability."

Bushee said both candidates are very interested in ensuring the district budget is as transparent to the residents of Beverly Hills as possible.

"Obviously issues that are going on with Measure E bond money are things that Mr. Manaster and Ms. Korbатов wouldn't want to have happened under their watch," Bushee said. "I know they want to be completely open and upfront with the Beverly Hills community with contracts, how contracts are signed, what they're good for and what the decision-making process is when it comes to spending tax-payer money."

Bushee added that from an educational standpoint, Manaster and Korbатов are both in favor of including teacher and teachers' expertise in curriculum decisions.

"I know that [they] have a great deal of admiration and respect for the employees of our district," said Bushee. "I know they believe the teaching force is the backbone of our schools. We believe they will create a 'team' atmosphere here in Beverly Hills, and we can be thankful for that."

BHEA represents more than 400 teachers, office staff and instructional assistants throughout BHUSD.

Victimized Car Wash Workers Hold Vigil at Owner's Peck Drive Home

Disgruntled workers, religious leaders and members of the Community Labor Environmental Action Network gathered in front of the homes of Benny and Nisan Pirian on Peck Drive last week to protest several labor law violations within four Los Angeles car washes.

The Los Angeles City Attorney filed a criminal complaint against brothers Benny and Nisan Pirian — owners of Vermont Hand Wash, Celebrity Car Wash, Hollywood Car Wash and Five Star Car Wash — and car wash manager Manuel Reyes.

The charges include 220 counts of criminal misconduct such as conspiracy, grand theft and failure to pay \$450,000 in wages over five years. The car wash manager was charged with witness intimidation, brandishing a deadly weapon and sexual battery.

"Workers were getting paid \$35 for 10 hours of work," said Chloe Osmer, an organizer for the CLEAN campaign. "They had no meal and rest periods. No regular lunch hour. The manager retaliated against union members by flashing a machete to a worker, and a gun."

The Vermont Hand Wash employee who was threatened with the gun by the carwash manager was brutally assaulted on his way home from work earlier this month. The manager was relocated and given a different position within the company, Osmer said.

Workers who attended the vigil would not comment due to the case's ongoing investigation.

Benny Pirian did not return phone messages from the Weekly as of press time.

BHUSD Achieves Test Score Growth but High School Math Still Needs Help

The California Department of Education recently released this year's Growth Academic Performance Index results for school districts statewide, and for the first time, two BHUSD schools have earned a Growth API greater than 900 — El Rodeo and Hawthorne.

Beverly Hills' district-wide score was 874, well-above the State Board of Education's goal of 800 out of a possible 1,000.

API is calculated using the results of the STAR program and the California High School Exit Exam. Growth API is derived from comparing last year's test scores with results from this year.

Beverly High scored the lowest Growth API at 847. The school performed poorly on math assessments last year. In Algebra I, 40 percent of freshmen tested as proficient or advanced, sophomore tested at 35 percent and juniors came in at 11 percent. This year freshmen test results were up 5 percent, sophomore scores plunged to a 28 percent proficiency level and junior scores increased by 8 percent.

"It's absolutely an area of concern, and we're absolutely doing something to address it," said Brian Tash, director of curriculum, instruction and assessment.

Program changes were implemented this year, including the addition of a 8th grade algebra readiness course to be taken after 7th grade pre-algebra, and the division of Algebra I into traditional and conceptual algebra.

"We're trying to appeal to kids learning styles," Tash said. "There's certain fundamentals that need to be in place, and we're giving it to them."

However, Beverly High math teacher and Department Chair Jane Wortman said the elimination of 8th grade pre-algebra, mandat-

The Planning Commission of the City of Beverly Hills, at its regular meeting on Thursday, September 24, 2009 will hold a public hearing beginning at 1:30 pm to consider:

A request for a Development Plan Review to modify the original conditions of approval for the building currently under construction at the northeast corner of Robertson and Wilshire Boulevard located at **8767 Wilshire Boulevard** to allow medical and pharmacy land uses and to remove the public parking component. As originally approved, the building has a total of 75,116 square feet which includes a 3,000 square foot restaurant use and the remaining 72,116 square feet as general office and retail.

The Applicant is seeking to amend the conditions of approval to convert 53,784 square feet of previously approved general office space to medical and pharmacy uses. The existing approval included a condition which prohibited medical and pharmacy uses at the site. The specific request before the Planning Commission is to:

1. Allow 54,900 square feet of medical uses.
2. Allow 1,116 square foot of pharmacy.
3. Remove the requirement to provide 51 parking spaces for use by the general public.

The other uses in the building under the current proposal would include, a 2,000 square foot (with up to 999 square feet of dining and bar area) restaurant/sundry retail shop, 4,696 square feet of general commercial office, and 12,404 square feet of retail for a total of 75,116 square feet in the building. It should be noted that the Planning Commission, if it decides to approve the project, could modify any of the previous conditions of approval as part of the current application.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City, and an addendum to the Mitigated Negative Declaration for the existing Development Plan Review has been prepared since the proposed project will not result in new significant environmental effects.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Comments may be submitted in writing to the Planning Department prior to the meeting date and written or oral comments will be accepted at the Planning Commission meeting at the date and time noted above.

ed by the Board of Education, was a big mistake.

"Me, personally, I don't agree with state's philosophy that every student should be in algebra in 8th grade," Wortman said. "We're trying to put students in the appropriate class- es."

Along with the new traditional and concep- tual algebra classes, the school offers a sup- port class for students who have struggled to learn algebra basics. In addition, many teach- ers are using exam questions modeled after the state's standardized testing questions to help students get accustomed to the format.

New textbooks students received this year containing questions specifically geared

toward content standards could also lend a hand to improving math scores.

"Personally, I'd love to hit a 100 percent [proficiency level]," Wortman said. "But I'm also realistic. Any kind of growth, 5 percent or 10 percent, would be fantastic."

Former Board Member Mel Spitz Grills School Board During Meeting

Former Board of Education Member Mel Spitz presented a handful of ques- tions to the Board of Education members during Tuesday

night's meeting, and asked for an audit of Measure E expenditures.

His questions — which were directed to Board President Nooshin Meshkaty and Superintendent Jerry Gross — regarded the formation of a committee to select a company to manage and oversee Measure E expendi- tures. Spitz said Board members Brian Goldberg and Steven Fenton, who were not in the committee, first learned of its formation by reading the newspaper.

"Under what authority was that committee organized?" Spitz said during the meeting. "Why was the process not transparent? Why was it conducted in secret?"

Committee members included Gross, Meshkaty, Weekly columnist Rudy Cole and Board Vice-President Myra Lurie.

An e-mail was sent from the superinten- dent's office today stating a need to "correct some misinformation." According to the e- mail, Friday updates are sent every week to board members, and the past three updates have included committee details, such as members, responsibilities and the timeline for their work.

"The reason I said that is because that's what [Goldberg and Fenton] told me," Spitz said after the e-mail had been sent.

The board voted unanimously Tuesday, however, to continue with a financial audit of Measure E expenditures, continue paying authorized contractors and stop further author- izations of additional contractors.

"I think they did the right thing," Spitz said.

It was reported last week [in the *Courier*], "that the school district is rushing ahead and breaking all speed records" to find a replace- ment for the Measure E fired project manager's position. With no publicity and no notice to the public, a small advisory group made up of Jerry Gross, the present short term district Superintendent, Rudy Cole, who was paid to lobby for and promote Measure E, and two School Board members, president Nooshin Meshkaty and Myra Lurie, and decided on bid- ders for this position.

The Measure E bond issue and the ensuing decisions that were made by the Board and staff have turned into a disaster of epic propor- tions. The school board did not use due dili- gence nor did they use fiduciary responsibility owed to the voters and the bondholders. The lack of oversight and experience by those mak- ing decisions will in the end cost millions of dollars in litigation fees which will have to come out of the General Fund of the Board of Education Architectural plans, bond money and volunteer efforts have already been wast- ed.

These dysfunctional School Board members not only failed to communicate with each other but also failed to give proper notice in advising the public of what the problems really are and the actions that are to be taken. Notes about our village

When **Rose Norton** is honored next month by the National Council of Jewish Women and the role she and the organization played in the development of the El Nido Family Centers, those attending will certainly enjoy Rose's description of the life of a Beverly Hills activist.

"Activist" is hardly sufficient to define the life and times of this involved person who can switch from angry dissident to humorous competitor within moments, and make you appreciate both.

Last week, Mayor **Nancy Krasne** and the city council recognizing the award dinner, presented a proclamation to Rose that listed her many contributions to the city.

They are numerous, but not nearly as comprehensive or as complete as the back stories. Rose has been a city planning commissioner, wife of a city mayor (**Ben**), candidate for city council and leader of more campaigns to stop some major developments than even **Larry Larson**, but with great tact and balance.

Although she lost her bid for council in 1986, she did run ahead of an incumbent mayor, **Annabelle H. Hefferman**, who outspent her two to one and had most of the city establishment as endorsers.

When Rose was appointed to the planning commission, the rationale of the then council, who mostly disagreed with Mrs. Norton's anti-growth opinions, was to bring her inside the tent. It worked, partially, but inexplicably, the tent members began to bond with Rose, and for most of her tenure, became a far more balanced commission on development matters.

Ben and Rose and their family have had a wonderful, mutually supportive relationship, but that never prevented Rose from making clear her differences with Ben when he served as mayor.

At one council meeting, Ben was taking a position on some long forgotten issue, when Rose jumped to her feet to protest. In the process, she snapped a string of pearls that rolled all over the council chamber floor. The meeting almost came to a complete halt while all of us in attendance took to all fours to retrieve the pearls. Mayor Ben gave us a few minutes and then proceeded to vote as he intended, and over Rose's objections. No report on what happened that night after the council meeting.

If you can understand that her anger is never personal but always issue oriented and know how much she really gives back, you will join those who appreciate having Rose as a friend, supporter or, most often, vocal opponent.

In any case, next week more information on her dinner or you can call the National Council of Jewish Women.

Our state assemblymember, **Mike Feuer**, has been given one of the most important jobs in the history of the state legislature: Chair of a committee that will recommend changes on how state government functions.

Appointed by Speaker **Karen Bass**, the Feuer committee will consider many changes including making budget passage by majority instead of two-thirds vote of the legislature.

Many of the reforms will have to be submitted to the people for a vote, but this prestigious committee could well help bring California into the 21st Century..

Although not part of the original charge, which is sufficiently flexible to cover many other state challenges, they should address term limits. Feuer himself is one of the best arguments for removing limits. When we lose the services of independent, highly ethical and knowledgeable leaders such as Feuer, we give even more power to the special interests and the state bureaucracy.

As a community, we should be quite proud of the honor and recognition given Feuer. Concurrently, an independent citizen group is also studying the need for a state constitutional convention that will make similar findings on reforms.

Why do I think a Dr. Jekyll and Mr. Hyde play is appropriate for our village?

You can find your own explanation. But you should not miss playwright Jeffrey Hatcher's new adoption of the classic Robert Louis Stevenson work being presented by our own city treasure: Theatre Forty.

While the search for a city manager is entering final stages, the council will probably not have the recommendations of their sub-committee and the city's consultants until much later this year. The city has worked out an arrangement with City Manager **Rod Wood** to stay at his post until the selection is completed and to help advise on his replacement.

There is an historical note here: When **Jimmy Delshad** was first elected to the council, then city manager **Mark Scott** made known his intention to accept a job in a south eastern state's city. Delshad had hoped that Scott would help smooth his entry into city leadership.

Now, Delshad will become mayor just as the city welcomes a new city manager: this March. However, this time it will be a more experienced Delshad who will be doing the mentoring.

Hard to believe the recession isn't over or that it was not felt in Beverly Hills, which it was, but there is considerable renovation and new developments going on all over the city and our streets seem active with tourists, a good sign for business and city revenues.

But talk about cultural lag – uses catching up with current realities, and look at the construction barricades that all have the same signage: "Post No Bills."

History note: Post No Bills was originally used to discourage signs promoting carnivals and circuses on stores and other places that were not included in a trade program. The events would give free tickets, called due bills, to their shows for businesses that permitted placing of signs at their business windows or walls. As far as I know, its been years since we had a circus or carnival and just maybe "no signs permitted" might be more understandable. It made me nervous because one of my creditors might think it appropriate to post my bills on their walls.

Now, the Peninsula Beverly Hills has transformed their outdoor dining areas into a sculpture garden featuring the highly regarded works of Sabin Howard. His nudes were unveiled at a press reception Tuesday

Benefiting from the sales will be the River of Life Foundation, and their good works deserve more space later.

Speaking of hotels, the usually acerbic Los Angeles Times restaurant critic, **S. Irene Virbila**, who is not known for lavishing praise

on eateries, had nothing but rave words for the Montage Laguna's Studio restaurant last Wednesday.

Studio has one of the most dramatic settings, overlooking the ocean, of any restaurant in our area, but it has, from day one, been not only a destination place to see, but a great dining experience.

Virbila gave Studio a remarkable three stars and praised the work of their new chef, **Craig Strong** who comes to the hotel with considerable experience in the luxury hotel industry. The respected former chef, **James Boyce**, has left California to open his own restaurant in Alabama.

Our own Montage Hotel is bringing night life to a new level with entertainment in the lounge by the highly regarded **Rob Gonzalez**. You have to expect great artistry from anyone with two "z's" in their name.

You have to admire how quickly school board candidate **Lisa Korbatov** has become a major contender along with the better known **Jake Manaster**. The two challengers have widely different groups of supporters and are hardly a team entry, but are running imposing campaigns for school board.

The candidate who will be hard to defeat, not only because of her very across the board list of backers, but because she has been a steady voice during a time of turmoil on our board and in the school community, is board president **Nooshin Meshkaty**.

Finally a word of praise to city staff and the whole council for facing up to a real dilemma. What can you do when a new building goes up that does not come close to the designs approved. Or as Councilmember **John Mirisch** put it, we approved a Cadillac and we got a Buick.

The multi-residential property in the south east area, has new owners who will now have to comply with designs approved by the commissions and city council, with some appreciation of the realities involved. But an alert Community Development staff found the discrepancies and acted professionally to remedy a scoff law approach by the owners and developers.

Not the first time in our history for a non-compliance building issue. Years ago, when the Elkins building was completed on North Canon between Little and Big Santa Monica, somehow it was constructed in a non-conforming T Zone, created to prevent construction on land set aside for a possible Beverly Hills Freeway.

Only when **George Elkins** applied for an occupancy permit was he told it could not be issued. When Elkins appealed to the then city council and asked Mayor **Hugh Darling** what he was supposed to do with his new structure, Darling responded: "I would suggest tearing it down one brick at a time." Cooler heads prevailed and Elkins received his permit.

BHHS Football Team Edges Santa Barbara

Beverly High was unable to play mistake-free football as coach Donald Paysinger had hoped, but were still able to defeat Santa Barbara, 17-15, despite losing four fumbles in a nonleague game at Santa Barbara last Thursday night.

In a game where starting quarterback Josh Newman and Kenny Bassett were sidelined because of injuries, the Normans took the lead for good on Adam Lansman's 21-yard field goal with three minutes, 57 seconds left in the third quarter.



MESHKATY EVICTION RAISES RESIDENCY QUESTIONS

Board candidate and spouse were evicted from a West L.A. apartment while her daughter was simultaneously enrolled at El Rodeo

Meshkaty: Won't answer the Weekly's questions

Court documents obtained by the Weekly reveal Board of Education candidate Nooshin Meshkaty was evicted in 1994 from a West Los Angeles apartment while her daughter was simultaneously enrolled at El

Rodeo School.

The judgment takes on new life given comments Meshkaty made during Tuesday night's Board of Education meeting that illegally registered students are a more significant problem to the BHUSD than permit students.

The state judgment and lien document dated March 14, 1994 shows that Meshkaty and her husband Yar — who is a Coldwell Banker real-estate agent — rented an apartment in the Monterey Plaza located at 11701 Texas Ave. (See photo on cover)

Meshkaty and her husband, under his legal name "Shahryar," are the only occupants named in the complaint.

According to her re-election ballot statement, Meshkaty — who is the current Board of Education president — has lived in Beverly Hills for 32 years. Meshkaty immigrated to the U.S. in 1977, so this would mean 32 consecutive years since 1977.

Her daughter, Azadeh, was born in 1986 and enrolled at El Rodeo in 1991.

In the early 1990s, unlike today, inter-district permits were rarely granted to non-residents of Beverly Hills, with the exception of children of faculty or staff. Neither Meshkaty nor her husband were employed by the BHUSD.

Residing outside BHUSD boundaries was then, and still is today, grounds for student expulsion. There is no evidence Meshkaty had a permit at that time. A Beverly Hills resident would not need a permit.

In a Feb. 2003 Weekly article, issue 176, Meshkaty was featured in a Valentine's Day profile of Beverly Hills couples.

"They were married before hundred of guests on November 16, 1985 ... before moving into Yar's Westwood apartment," the article states, contradicting Meshkaty's 32-year residency claim.

spokesman Robert Knowles said Meshkaty's current Beverly Hills residence was purchased in 2004.

Meshkaty was automatically elected to the Board in 2005 when the election was cancelled due to a lack of candidates.

Although ballot statements are not signed under penalty of perjury, a candidate can be removed from the ballot on the legal basis of making false statements, said Attorney Fred Woocher, who specializes in public interest, including election law.

"It provides legal grounds for challenging [the results of the election], and, in fact, it is a criminal provision of the elections code, but you would have to show the elements of the crime itself," said Woocher. "If they're able to show clear and convincing evidence that the statement was not truthful or misleading, then a lawsuit can be filed by any third party or the election official."

Woocher said. "But you would not necessarily have to show that the misstatement somehow affected the results of the election."

Pursuant to the election code, there is 10-day period after a candidate makes a statement and the ballot statements are distributed to the public in which the election official or any voter can file a lawsuit to have the false statement removed. After the 10-day period, no action can be taken to remove the statement.

The 32-year residency claim was also repeated in a political brochure Meshkaty mailed to voters prior to her Sept. 12 campaign kickoff. (See adjoining materials)

The eviction complaint against Meshkaty was filed on Feb. 22, 1994, and a writ of execution — a court order granting the plaintiff possession of the property — was issued to Los Angeles County on June 22, 1994, according to the case summary.

The state judgment and lien document was filed under "forcible entry/detainer," which is an action that a landlord can take if the existing occupant refuses to leave after appropriate notice.

Complaints against tenants can be filed one day after nonpayment of rent by serving a three-day notice demanding payment.

"If you walk into a market, can you tell the people in the market that you'll pay for that steak in the next day and take it with you?" said Eviction Attorney Dennis Block, who is not affiliated with this case. "I wouldn't imagine that markets are any different than any other business, and it certainly is a business when you're dealing with landlords."

Landlords typically wait anywhere from seven to 10 days to file a complaint, though Block said he has handled cases where landlords wait months, sometimes even years, depending on the circumstances.

"People just sit, and it doesn't matter about responsibility or ethics," Block said. "They'll just continue to try to rape and tillage the landlord as much as they can."

Nonpayment of rent, however, is just one of many grounds for eviction, which usually results one month after a complaint has been filed if the tenant doesn't fight the case. If the tenant fights the complaint, it could take several months.

Other reasons for tenant evictions include illegal activities within the premises, alterations made by the tenant to the property and ongoing complaints from other tenants.

Ronald Weiss, attorney for the plaintiff — which was listed as Monterey Plaza Apartments — in Meshkaty's eviction case, said he could not comment because the case files were in storage.

Property managers of the Monterey Plaza Apartments did not return phone messages from the Weekly as of press time.

Meshkaty returned calls but refused a phone or in-person interview.

During Tuesday night's board meeting, Meshkaty said the district needed to crack-down on individuals using false Beverly Hills addresses and suggested using an anonymous tip hotline, as well as a verification process for Beverly High freshmen, to report illegal registrations.



**ORDINANCE NO. 09-O-2568
AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ADD REGULATIONS REGARDING THE FEEDING AND CARE OF FERAL CATS
THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS ORDAINS AS FOLLOWS:**

Section 1. A new Article 5 (Regulations Pertaining to Feral Cats) is hereby added to Chapter 2 of Title 5 of the Beverly Hills Municipal Code to read as follows:

"Article 5. Regulations Pertaining to Feral Cats

5-2-500: Trap-Neuter-Return Program Purpose and Applicability.

A program is hereby adopted to control feral cat populations in certain areas of the City of Beverly Hills ("City"), and to address associated health and safety hazards, and other impacts in the City. The program was developed in a collaborative effort with community residents and feral cat Trap-Neuter-Return (TNR) program professionals. The program shall be known as the City of Beverly Hills Feral Cat TNR Program.

5-2-501: Applicability of Feral Cat TNR Program.

A. Permits may be issued under this Article only for TNR activities in the Central Area of the City as depicted in the City's zoning map.

B. No feeding and/or trapping activity shall be permitted within 1000 feet of the perimeter of any City park.

5-2-502: Definitions.

For the purposes of this Article, the words and phrases set forth in this section shall be construed as defined herein.

A. "Cat" means a member of the species *Felis catus*.

B. "Director" means the Director of Community Development or his/her designee.

C. "Feral Cat" means a cat that lives permanently outside of a domestic home and is not owned and cared for as a typical companion animal or pet, as a result of having been born feral, abandoned by an owner, or rendered homeless, wild or stray by any other means.

D. "Feral Cat Caregiver" means any person who:

1. feeds feral cats, humanely traps feral cats, provides care, including shelter or medical care, to the feral cats, or any combination of the foregoing activities, and works in cooperation with a TNR Partner permitted by the City; and

2. is registered with a permitted TNR Partner and has proof of such registration.

E. "Food" as well as "Feeding" includes water.

F. "Trap-Neuter-Return," also referred to as "TNR" is the practice whereby Feral Cats are humanely trapped by Feral Cat Caregivers or TNR Individuals, taken to a veterinary hospital or spay-neuter facility where they are sterilized and vaccinated, ear tipped, de-fleaed, and adopted or returned to their Colony to be cared for until the end of their natural life.

G. "Trap-Neuter-Return Program Regulations and Guidelines" or "TNR Program Regulations and Guidelines" means the rules adopted by the City Council allowing permitted organizations or individuals to undertake TNR activities, which rules include standards of care and guidelines for implementation activities.

H. "Feral Cat Colony" or "Colony" means a group of cats and the geographic location where that group typically live or where they forage or hunt for food, or are fed and generally cared for by a TNR Partner by associated Feral Cat Caregivers or by TNR Individuals.

I. "TNR Partner" means an organization permitted by the City to engage in implementing TNR via education, training, funding spay-neuter, providing traps, holding spay-neuter clinics, providing long-term Colony care through volunteers or otherwise implementing TNR.

J. "TNR Individual" means a person who is permitted by the City to engage in implementing the TNR Program Regulations and Guidelines on the property of their primary residence without being affiliated with a TNR Partner.

5-2-503: Feeding of Feral Cats Prohibited; Exceptions.

The feeding of feral cats is prohibited in the City of Beverly Hills unless otherwise permitted pursuant to this Article and conducted in accordance with the TNR Program Regulations and Guidelines.

5-2-504: TNR Permit and Application Requirements

A. An annual permit shall be required for any organization or individual that wishes to operate as a TNR Partner or TNR Individual in the City.

B. A separate permit shall be required for each Feral Cat Colony, even if multiple colonies are cared for by the same entity or person.

C. A permit application shall be submitted in the form and with the information required by the City, including the following:

1. TNR Partner Permit Requirements. A completed TNR Partner Permit application form shall be submitted, and accompanied with the following supplemental information:

(a) Applicant contact and address information;

(b) TNR Partner contact and address information;

and

(c) A map of the colony location and colony details to the extent known, including but not limited to an approximate number of;

(i) cats in colony;
(ii) successful spayed-neutered, de-fleaed, and ear tipped cats; and
(iii) successful adoptions;

(d) A map showing the location of each feeder and trapping location.

(e) A list of all Feral Cat Caregivers providing TNR support for the colony, and contact information for each Caregiver.

(f) Feral Cat Caregiver affidavit forms signed by each affiliated Feral Cat Caregiver confirming their receipt of a copy of the City of Beverly Hills Feral Cat TNR Program Regulations and Guidelines and stating that they have read, understand, and will comply with those regulations and guidelines.

(g) If feeding or trapping is proposed on private property, a copy of both the property owner's and the resident's consent agreeing to allow TNR activities on the private property.

(h) If feeding or trapping locations are proposed on public property, proof of comprehensive general liability insurance in a form acceptable to and in an amount determined by the City's Risk Management Department, with the City named as an additional insured. The insurance shall be maintained in force through the life of the permit, including any renewals, and coverage shall not be modified without the consent of the City.

(i) A statement accepting and agreeing to abide by all of the standard conditions of approval set forth in the TNR Program Regulations and Guidelines signed by a duly authorized representative of the TNR Partner.

(j) Envelopes addressed to each owner of property within 150 feet of each proposed feeding and trapping location, with first class postage attached.

(k) Envelopes addressed to the occupant of each residential unit within 150 feet of each proposed feeding and trapping location, with first class postage attached.

2. TNR Individual Permit Requirements.

A completed TNR Individual Permit application form shall be submitted, and accompanied with the following supplemental information:

(a) Applicant contact and address information;

(b) TNR Individual's contact and address information;

(c) A map of the colony location and colony details to the extent known, including but not limited to an approximate number of;

(i) cats in colony;
(ii) successful spayed-neutered, de-fleaed, and ear tipped cats; and
(iii) successful adoptions;

(d) A map showing the location of each feeder and trapping location.

(e) Feral Cat Caregiver affidavit forms signed by each TNR Individual confirming their receipt of a copy of the City of Beverly Hills Feral Cat TNR Program Regulations and Guidelines stating that they have read, understand, and will comply with those regulations and guidelines; and
(f) A statement accepting and agreeing to abide by all of the standard conditions of approval set forth in the TNR Program Regulations and Guidelines signed by the TNR Individual.

(g) Envelopes addressed to each owner of property within 150 feet of each proposed feeding and trapping location, with first class postage attached.

(h) Envelopes addressed to the occupant of each residential unit within 150 feet of each proposed feeding and trapping location, with first class postage attached.

(i) If feeding or trapping is proposed on property that is not owned by the TNR Individual, a copy of the property owner's consent agreeing

to allow TNR activities on the private property.

5-2-505: Notice and Comment Period—Feeding.

A. Upon determination that an application for a TNR permit is complete for processing, the Director shall provide notice of the application and a ten (10) day comment period by first class mail to the owners of all property and residents within a 150 foot radius of each proposed feeding location.

B. The notice shall include, but is not limited to, the following:

1. The locations of feeding devices;
2. The feeding hours; and
3. Contact information for the TNR Partner and all affiliated Feral Cat Caregivers, or the TNR Individual

C. Notice for feeding devices that are not separated by more than twenty-five (25) feet from another feeding or trapping device may use a single notice, but which shall be mailed to all owners of properties and residents within the 150 foot radius of any device.

D. During the ten (10) day comment period, interested parties may submit written comments to the Director on whether the application meets the criteria of this Article or may submit a written objection to the location of the feeder if it is proposed to be placed adjacent to their property.

5-2-506: Notice and Comment Period—Trapping.

A. Upon determination that an application for a TNR permit is complete for processing, the Director shall provide notice of the application and a three (3) day comment period by first class mail to the owners of all property and residents within a 150 foot radius of each proposed trapping location.

B. The notice shall include, but is not limited to, the following:

1. The locations of trapping devices;
2. The trapping hours; and
3. Contact information for the TNR Partner and all affiliated Feral Cat Caregivers, or the TNR Individual

C. Notice for trapping devices that are not separated by more than twenty-five (25) feet from another feeding or trapping device may use a single notice, but which shall be mailed to all owners of properties and residents within the 150 foot radius of any device.

D. During the ten (10) day comment period, interested parties may submit written comments to the Director on whether the application meets the criteria of this Article or may submit a written objection to the location of the trap if it is proposed to be placed adjacent to their property.

5-2-507: Determination on Permit.

A. The determination of whether to issue a permit is a ministerial action. The City shall review permit applications deemed to be in compliance with the TNR Program and Guidelines requirements. The Director shall approve the application unless,

1. The permit application does not comply with the TNR Program and Guidelines requirements;

2. The permit application does not include all of the required information as set forth in this Article;

3. A letter objecting to the location of feeder and/or trap has been submitted by a resident or property owner whose property is adjacent to the proposed location of the feeder and/or trap;

4. A permit has already been issued to another TNR Partner for the same feral cat colony or a feral cat colony located in the same area or general vicinity;

5. The applicant has been previously issued a permit pursuant to this Article and has violated the requirements of this Article or the TNR Program Requirements and Guidelines; or

6. The Director of Public Works has reported that the proposed location of a feeder or trap will interfere with public works activities.

B. Upon approval of a permit application, the Department of Community Development shall issue a permit card(s) to the TNR Partners, Feral Cat Caregivers, and TNR Individuals as applicable. The permit card shall be worn by the permittee and any person conducting TNR activity so that it is clearly visible to another person at all times while conducting TNR activity. Residents and/or property owners personally conducting TNR activity on their own property are not required to wear the permit card.

5-2-508: TNR Permit Conditions.

A. As a prerequisite to receiving approval of a permit for a TNR Partner or a TNR Individual, the TNR Partner or Individual shall agree to comply with the standard conditions of approval set forth in the adopted TNR Program Requirements and Guidelines.

5-2-509: Standards of Care and Responsibilities of TNR Partners, Feral Cat Caregivers, and TNR Individuals.

TNR Partners, Feral Cat Caregivers, and TNR Individuals shall comply with and fulfill the responsibilities and minimum standards of care as set forth in the TNR Program Regulations and Guidelines.

5-5-510: Return of Feral Cats.

The return of feral cats as part of a TNR program is exempt from any abandonment laws because the feral cat is trapped solely for the purpose of neutering or adopting.

5-5-511: Feeding and Trapping Times.

Food may be placed in authorized feeding stations and traps may be placed in permitted locations during the hours set forth in the TNR Program Regulations and Guidelines.

5-2-512: TNR Programs on Public Property; Restrictions.

A. Feeding locations shall be maintained in accordance with the adopted TNR Program Regulations and Guidelines.

B. Recipients of a TNR Individual permit shall not be allowed to feed Feral Cats on public property.

C. Feeding and trapping of Feral Cats in public parks shall not be permitted.

5-2-513: Request to Remove Feeders or Traps Located on Public or Private Property.

A. After the issuance of a TNR Partner Permit, a property owner or resident may submit a request to the Director to request removal of a feeder or trap that is located adjacent to their property or on their private property.

B. Upon receipt of the request, the Director shall notify the permittee. The permittee shall remove the feeder and/or trap within 72 hours of such notice. If the feeder and/or trap is not removed, the City shall cause the feeder and/or trap to be removed without any further notice to the permittee.

C. The Department of Public Works shall receive copies of all applications involving placement of feeders or traps in the public right-of-way. The City at any time may request removal of a feeder or trap located on the public right-of-way by providing notice to the permittee. The permittee shall remove the feeder and/or trap within 72 hours of such notice. If such feeder and/or trap is not removed, the City shall cause the feeder and/or trap to be removed without any further notice to the permittee.

5-2-514: Annual Permit Renewals.

A. Permits may be renewed annually, and requests for renewal shall be submitted at least thirty (30) days prior to expiration of the existing permit on forms approved by the City. The permittee shall have no property interest in the renewal and the permit shall not be renewed if the Director makes any of the determinations set forth in Section 5-2-507, subsection A.

B. Notice pursuant to Section 5-2-505 and 5-2-506 of this Article is not required unless changes in feeder or trap locations or new feeders or traps, or a combination thereof, are requested in conjunction with a renewal.

5-2-515: Permit Modifications.

A. A permittee may request modifications to an existing permit to add or otherwise change the approved locations for feeding, trapping or combination thereof. Modification applications shall be submitted on a form approved by the City.

B. Removal of feeding or trapping locations shall not require permit modification but the permittee shall inform the city of the removal of the location. The permit shall not be modified if the Director makes any of the determinations set forth in Section 5-2-507, subsection A.

C. Permit modifications shall be accompanied with the same documentation required for an initial permit application.

D. Noticing shall be required if a new location is requested for a feeder, trap, or combination thereof. Relocation of any feeder, trap, or combination thereof shall require a new notice to be sent as required by Section 5-2-505 and 5-2-506.

5-2-516: Enforcement.

A. The City may enforce the standards of care applicable to TNR Partners, Feral Cat Caregivers and TNR Individuals in accordance with the City's Administrative Penalty Process or may refer violations of the standards of care to the appropriate TNR Partner or TNR Individual for assistance in correcting the violations. Nothing in this paragraph is intended to restrict the remedies available to the City for a violation of the requirements of this Article or the TNR Programs Regulations and Guidelines.

B. In addition to any other remedy available to the City, the City may revoke the permit of a TNR Partner or TNR Individual if the Director determines that the TNR Partner, TNR Individual or a Feral Cat Caregiver have violated the provisions of this Article or the TNR Program Regulations and Guidelines.

C. Complaints. Any person may file a written complaint with the Department of Community Development regarding any permit issued under this Article. Upon receipt of such a complaint, an investigation will be initiated by the City regarding the allegations in the complaint.

5-2-517: Prohibition Against Release

A cat not trapped through the City's TNR Program is prohibited from being released into the City or otherwise allowed to roam free in the City, whether or not the release occurs on private or public property. Any person violating this section shall be guilty of a misdemeanor punishable in accordance with Section 1-3-106."

Section 2. The City Council has considered the TNR Program and Ordinance and finds that this project is exempt from the requirements of the California Environmental Quality Act ("CEQA"). The project is exempt pursuant to State CEQA Guidelines, 14 Cal. Code Regs Sec. 15307 as an action taken to assure the maintenance, restoration, or enhancement of a natural resource where the regulatory process involves procedures for protection of the environment. The project is also exempt pursuant to Guidelines Section 15308 as an action to assure the maintenance, restoration, enhancement, or protection of the environment where the regulatory process involves procedures for protection of the environment. The project qualifies for these exemptions for the following reasons, among others:

A. The City currently has no regulations regarding feral cats or the management of any colonies that may exist in the City. If the existing condition is allowed to continue, the City Council finds there is a reasonable probability that feral cats will still be fed, but that the other TNR obligations in the Ordinance, which are intended to ensure the eventual decrease in the number of feral cats in the City, likely would not occur, including the trapping, spay/neutering, disease control measures, and removal of adoptable cats, such as kittens, from the colonies. As such, the new regulation of TNR activities in the City will maintain, restore, and enhance the City's natural resources by reducing the number of feral cats, and thereby reducing the predation effects of feral cats on the bird populations in the City, and limit-

ing the amount of fecal matter, including that which might contaminate waters in the City's public rights-of-way. The City Council also finds, for the same foregoing reasons, that the Ordinance constitutes an action to ensure the maintenance, restoration, enhancement or protection of the environment.

B. The City Council finds that TNR activities are appropriate in the Central Area of the City, but not in the Hillside Areas, because the Central Area of the City generally consists of higher density and more urban land uses, whereas, the Hillside Area of the City has more natural areas with the greater likelihood of birds and other wildlife that might be killed by feral cats. Although TNR activities in the Hillside Areas would not lead to a significant environmental impact, under the terms of the Ordinance, feeding of feral cats would be prohibited in the Hillside Area of the City. The City Council finds that limiting the areas of the City in which feeding of feral cats may be permitted further reinforces the conclusion that the Ordinance is a measure to protect not only natural resources but also the environment. The City Council also finds that no native riparian habitat, blue-line streams, or sensitive natural communities are located in the City limits, and as such impacts on such resources will not occur. (See, Draft General Plan Environmental Impact Report, August 2008, at p. 4.3-1.) Nor have endangered or threatened species of birds been observed in the City.

C. The City Council finds that the Ordinance will strengthen the regulatory standards applicable to the management, care, or feeding of feral cats in the City, and based on the lack of existing regulations, the Ordinance does not represent a relaxation of any existing standards. One goal of the Ordinance is, over time, to reduce the number of, and potentially eliminate, feral cats in the City. Based on the evidence in the record, the City Council finds that TNR programs are most successful in reducing feral cat populations when adoption of kittens and cats that can be socialized is emphasized in the Ordinance and program. The City's Ordinance and program expressly encourages cat adoptions to further the goal of decreasing the feral cat population.

D. The City Council considered the evidence in the record regarding the efficacy of TNR programs, and hereby finds that while there is no consensus as to how effective other TNR programs have been in reducing the number of feral cats, there is evidence, including the many comments from persons experienced in TNR activities, to support the conclusion that typical TNR programs can stabilize the number of and eliminate growth in colonies, and over time reduce the number of cats in a colony. The City Council reviewed, and finds credible, the study of the TNR program at the University of Central Florida, which documented a substantial reduction in the number of cats, as described in Evaluation of the effect of a long-term trap-neuter-return and adoption program on a free-roaming cat population, 222 J. Am. Veterinary Med. Assn, 42 (2003), by Julie Levy, David Gale & Leslie Gale. The City Council finds that, with the additional restrictions, limitations, standards of operation, and emphasis on cat adoption, Beverly Hills' TNR Ordinance is designed to be more effective than the other less stringent TNR programs in existence.

E. The City Council finds that stabilizing feral cat populations through the TNR Program will ensure that current impacts that the cats may have on natural resources, including birds, animals, and water quality (from the fecal matter) will not worsen and will, over time, be reduced as colony populations decline.

F. The City Council finds that adopting standards applicable to feral cat caregivers and their activities will require use of best practices to eliminate nuisance or unsanitary conditions that might otherwise exist if the activities were not regulated. These standards include periodic removal of fecal matter from the City's public rights-of-way in the vicinity of feeders, and use of feeders designed to prevent other types of animals from being able to access the feeders. Further, the Ordinance limits the placement of food in the feeders to an amount appropriate to the size of the colony, and requires removal of excess food daily before the earlier of sunset or 8:00 p.m., such that no food may be left in the feeders over night. This will minimize the attraction of other animals to the feeders during nighttime hours.

G. The City Council finds that feeding stations must be designed, constructed, and managed to minimize the attraction of other animals and pests.

H. The TNR Program will result

in vaccinations of feral cats to reduce the spread of disease and the risks associated therewith. The standards of the Program also require testing of certain trapped cats, and a prohibition on the return of cats that are infected with Feline Leukemia Virus (FeLV) or Feline Immunodeficiency Virus (FIV).

I. The Program requires persons conducting TNR activities to provide veterinary care to colony cats, thus if there is a flea infestation severe enough to indicate the need for veterinary care, those conducting the TNR activity would have the duty to provide the necessary care to the cat to address the flea infestation.

J. The City Council finds that there will not be any significant effects on the environment as a result of adoption and implementation of the Ordinance. Further, the City Council finds that to the extent that could be any adverse impacts, such impacts would result from the typical circumstances surrounding the City's exercise of its police powers within a large urban area to protect the health, safety and welfare of the community, including but not limited to when regulating in the arena of animal control. As such the City Council finds that there is no evidence of unusual circumstances that would prevent the City from relying on the categorical exemptions from CEQA set forth in State CEQA Guidelines Section 15307 and 15308.

Based on the foregoing and other substantial evidence in the record, the City Council hereby finds and determines that the Ordinance and Program are exempt from the provisions of CEQA, pursuant to State CEQA Guidelines Sections 15307 and 15308.

Section 3. Persons and organizations currently feeding or otherwise caring for feral cats shall obtain permits within ten (10) days of the effective date of this ordinance, but may continue to feed or otherwise care for feral cats during this ten-day period. If a permit is not obtained within that period of time, feeding and other care activities must cease. Failure to cease activities will be deemed a violation of the City's ordinances and TNR Program.

Section 4. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remainder of this ordinance. The City Council hereby declares that it would have adopted this ordinance, and each and every section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

Section 5. The City Clerk is directed to forward a certified copy of this ordinance to the Director of the City of Los Angeles Department of Animal Services.

Section 6. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
