

"Meshkaty Eviction Raises Residency Questions" [Issue 521]

On Tuesday November 3rd, the voters of Beverly Hills have an opportunity to choose two people to represent them as members of the BHUSD Board of Education. As a former teacher and administrator in the BHUSD for over 30 years, and a resident of the community during that time, I am well aware of the significance of this election. Since the School Board determines the policies for the District, provides solid leadership, seeks accountability, and determines ways to provide the finest education for students, it is important that the most qualified candidates become members of this board.

Board Members Disagree Over "District of Choice" During Meeting

During Tuesday night's meeting, Board of Education members clashed over the possibility of implementing "District of Choice" when the district enters basic aid.

Under DOC — proposed state legislation — BHUSD's current interdistrict permit policy would be eliminated, including all opportunity, legacy, diversity and city employee permits. Instead, permits would be granted based purely on random selection, with no preference based on academic or athletic performance. Siblings of currently enrolled students would receive the only priority.

Both Myra Demeter and Myra Lurie supported DOC, with Lurie calling the plan a "win-win" situation. Lurie also said she saw no conflicts between DOC and the district's JPA agreement.

Board member Steven Fenton challenged Lurie's statements.

"You're an attorney," Fenton said. "We have a signed contract with the city of Beverly Hills [to take city employees into BHUSD]. We would be in breach of our contract if we move forward with [DOC], so I'm baffled by that statement. I'm at a loss. Meeting after meeting, both you Myra Lurie and Myra Demeter continue to put Beverly Hills residents second."

Demeter said DOC would be a financially favorable and prudent plan once the district enters basic aid. According to Demeter, the district would receive 70 percent of the average daily attendance for each student they receive under DOC in addition to funds from basic aid.

Although it's not in the bill, Demeter said under a "silent conversion," current permit holders could be converted to DOC — which does not need to be renewed yearly — and, unlike new permit applicants, would not be subject to a random selection.

However, Board member Brian Goldberg said the 70 percent applies to the ADA of the student's home district, which would be significantly lower than the amount Beverly Hills receives for ADA funding.

He added that though the current DOC bill doesn't specifically refer to interdistrict permits regarding conversions, it doesn't mean it's legal.

Meshkaty said the bill has yet to be signed by Gov. Arnold Schwarzenegger, and given the current information, did not support DOC.

Suspect Convicted of Murder in Beverly Hills Last Thursday

Eleonora Igova, 31, was convicted of second degree murder last Thursday and faces 15 years to life in prison after fatally shooting her husband Jacob Lipson at their Beverly Hills residence last year.

Igova was arrested and charged with murder March 14, 2008 after police officers found Lipson with multiple gun shot wounds.

Her sentencing to determine prison time is scheduled for Nov. 19 at the Beverly Hills Superior Court.

"This was a culmination of a terrific observation made by patrol officers; diligent follow-up by detectives and the great forensics by our CSI team," said Lieutenant Tony Lee from BHPD. "Justice has been served, and we put away a bad person for a long, long time."

Welcome Back, Bauer

Class of 1991 graduate Justin Bauer has returned to teach U.S. and world history at Beverly High.

Bauer was recently told by a teacher in the school's hallway that he was the only student the teacher ever gave a referral to in the past 20 years.

Some things never change.

"I have not lost my rebellious streak," said Bauer. "I think it makes me a better teacher."

Bauer isn't the traditional dry-erase marker, on-the-board teacher. Last week, he came to school dressed in a full suit of armor.

"I'm kind of all over the place," Bauer said. "I do weird stuff. I like playing music from the [history] periods. I jump on the

table. I'm a more out-of the box, fun

Bauer's style stands in stark contrast to his mother's teaching methods. Merle Bauer, a longtime eighth grade English teacher at Beverly Vista, is more of a disciplinarian with a structured classroom, said Bauer

"Some of my students have had her," he said. "I think it's funny because they automatically think I'm going to be a certain way, [but] you can feel free to say anything [in my classroom]. It's almost a discussion format. My classroom set up is very safe."

Having previously taught at Riverside's University Heights middle school in a rough, gang-riddled neighborhood, Bauer

knows a thing or two about safety.

"I had a student with a gun in his waistband," Bauer said. "I had another incident where the dad was a gang member, the grandpa was a gang member, the older brother was in prison for murder, and the other brother had been murdered. It was a total culture shock for me."

Bauer taught eighth grade history for almost a year at University Heights where 70 percent of the mostly black and Hispanic student population were Englishlearners, and 5 percent were in homeless shelters or foster care - before he began teaching at Beverly High.

Still, Bauer was never afraid of going work to every day. He credits his lack of fear to his stint in the marines, which he voluntarily entered on Sept. 12, 2001. Bauer was stationed in San Diego, but due to a medical issue, he was discharged early.

Bauer's wife Sharon Shuster is a Class of 1993 graduate and Riverside's Deputy District Attorney. Shuster prosecutes criminal cases in the sex-crimes unit.

Coldwell Banker Sued for Negligence, **Theft During Open House**

A lawsuit recently filed by Los Angeles public relations executive Harvey Englander alleges Coldwell Banker Corporation and local realtor Sally Forster

We warned the community also that the District administrators were not competent to manage and control capital projects of such magnitude. Bearing out our position, immediately after passage of Measure E those administrators commenced monthly payments to Christiansen totaling some \$2 million; payments that were not contractually due her. She is now suing the District for \$16 million, and the District is suing her to recover almost \$5 million, which includes payments made to her prior to passage of Measure E. In all, the District may squander more than \$20 million in this fiasco. In addition, the District's legal fees must be paid out of the educational budget.

We warned the community also that the projects to be funded by Measure E bonds were vague and unbudgeted, put together to rationalize a blank check of one-third billion dollars. Bearing out our position, at its latest meeting the Board of Education stopped all projects not yet under contract, in order to re-study needs and justifications. As a consequence, some \$70 million from the first issuance of bonds sits idly in the District's bank account, generating property taxes for the residents of Beverly Hills, and placing the District at risk of penalties if not expended soon.

We three former school board members pooled our own money to circulate a citywide handbill and we wrote letters to the editors of the local newspapers explaining why Measure E was atrocious public policy. It was not comfortable or pleasant for us to oppose a school bond measure; but we were guided by principle. I daresay many Beverly Hills residents realize now with 20/20 hindsight that we were right.

Behind The News

From elections to coffee By Rudy Cole

It might have been somewhat shocking to find that the school board was hearing from the district attorney Tuesday, especially if you tuned to Channel Six late.

We know they have been having some serious issues, but not quite to the level of needing the help of the county's top law enforcement officer.

Well, it wasn't D.A **Steve Cooley**: the legal issues facing the board were being addressed by **Howard Fulfrost**, the "district's attorney." However, below his name on the tube was the title: District Attorney.

On the other hand, an overly zealous law enforcement officer could have taken action against a well-intentioned good Samaritan last Tuesday.

An angry speaker, I know that does not narrow the field too much, came to the board Tuesday to air some dirty laundry. In this case, the laundry did clearly need airing. The speaker was very upset with the sanitary conditions in the school food preparation area. A student of an adult school cooking class, she gathered up some very soiled towels which she said were utilized not only by her evening class, but by the cooking staff in the cafeteria.

She insisted that the towels she had collected be distributed to a less than enthusiastic board for inspection. Alas, congratulations to the messenger for unveiling the mess (alliteration intended), but her noble deed could be classified as removing school property illegally. In her defense, she could argue that the board probably did not keep the booty.

This, and all recent boards, have not been overly concerned with television ratings, or for that matter having the undivided attention of our more involved and interested citizenry.

After decades of holding board meetings on the second and fourth Tuesday's of the month, some years back this slipped into first and third, directly competing with city council meetings.

For those who really want to keep current on both school and council activities, the concurrent meeting dates and times is a problem. Aside from competing for television viewers, the same date sessions also inhibit those who might want to appear and speak or simply attend the meetings, including members of the council and board of education.

The rest of the education community may still be fuming and taking emotionally packed sides on the board battles, but the two main contenders seem to be getting along just fine, even if they are still poles apart on issues.

Last Tuesday, careful viewers would have seen board vice president **Myra Lurie** and member **Dr. Brian Goldberg** enjoying some mutual moment of good humor.

Just maybe, School Supt. **Jerry Gross**' efforts at conciliation may be working. He delivered a strongly worded appeal for civil-

ity at last Tuesday's meeting, warning the board members that their behavior is having an effect on the students of the district. Board President Nooshin Meshkaty is also becoming far more effective in controlling her board and her colleagues, including Dr. Myra Demeter, Steven Fenton, Lurie and Goldberg are more restrained. As we have said many times, this is an enormously talented board and all five have much to give to assuring the best in education services, emotionally loaded problems including student permits aside.

As for those who see only doom and gloom, they are ignoring some very important realities: Test scores are way up. In fact, the results for the high school will probably show the largest jump and improvement in the district's history! Also, unlike many other districts, there have been almost no cuts in education services and teacher's salaries and benefits remain the highest in the state.

Recent placement of some outdoor art in Beverly Gardens has sparked a jurisdictional dispute between two city commissions.

Recreation and Parks is the advisory commission on park activities and uses, but the Fine Arts Commission selects public art. What can Recreation and Parks Commissioners do if a sculpture is placed at a park site that could possibly obstruct other uses, including the semi-annual Affaire in the Garden?

In any case, the Commission, led by member **Jill Tavelman Collins**, took this problem to the city council Tuesday, asking for a council-commission liaison to resolve the territorial dispute.

The 2011 city council election, already is beginning to shape up as one of the most interesting in years, if at least some of the mentioned candidates and incumbents actually run.

Some of the likely contenders are off and running, although the formal filing and announcements will not come until late next year

Mayor **Nancy Krasne** will probably, but not yet for sure, seek a second term and Vice Mayor **Jimmy Delshad** could run for a third. Delshad is slated to take the mayor's gavel next March and would be running as an incumbent mayor.

Planning Commissioner **Noah Furie** has made it clear he will be in the race no matter who else files. He is expected to have the strong support of former mayor and now Councilmember **Barry Brucker**.

The early surprise in this campaign will be the entry of school board member **Steven Fenton**. Fenton has apparently changed his mind. Earlier, he had told friends he anticipated waiting until Assemblymember **Mike** **Feuer** was "termed out" and then run for that office. Fenton would make some history, if elected. It would be the first time a former councilmember's son, or daughter, won a council seat. The only precedent even close was when **Rose Norton** ran for an office once held by her husband, **Ben**.

Steven's father, **Frank**, not only served four years on the council, and thanks to a very gracious gesture from then Mayor Brucker, finished his term as mayor, but he was also an eight year member and president of the board of education, the elected city treasurer and a member of the city's Recreation and Parks Commission. In fact, he came on the commission when I was just completing my last term as chair and I valued his experience in youth sports and education. Did I neglect to mention that his mother's name is Judie?

She has her own power base too, I've been told

As for campaign energy, the only candidate who could match or surpass Fenton's campaign efforts would be Barry Brucker. A race between these two would mean a considerable boost in shoe store sales. They are both incredibly adept at door to door, retail campaigning. However, they are not ever likely to be in the same election.

Although Fenton's position on school permits probably has political value, what will be hard to judge will be voter reaction to the present board infighting. Voters have a habit of blaming both sides of ugly public disputes. But the board will clearly have a new majority after November and by next year, the district may have become basic aid and the permit issue will be behind us, hopefully.

The first order of business for the new board will be the election of a board president. Although Nooshin Meshkaty is favored to win a second term, the departure of Dr. Myra Demeter means that a new majority will make the selection.

Myra Lurie is, according to past board practices, in line to be president. Her differences with both Fenton and Dr. Goldberg are very obvious, but denying her the office would keep alive all the issues that have turned many in the community against the whole board. In the whole history of the city council, the succession issue only came up once and then for vice mayor.

A former school board never quite recovered from the divisions caused when board member **Gerald Lunn Jr.**, was not elected president. For the record, although I strongly differed with Lunn on many education, and later city issues, I thought it was totally wrong to deny him his turn as president.

The next board would be well advised not to begin their terms with a repeat of this debacle and to put aside personal goals and agendas in the interest of restoring more collegiality to their board. Not sure about Fenton or Goldberg, but I think candidates **Jake Manaster** and **Lisa Korbatov** understand the impacts of not electing Lurie very clearly.

One other historical note about the upcoming board election. Three of the four candidates are all registered Republicans: Nooshin Meshkaty, Korbatov and Manaster. In a city with a strong Democratic majority of registered Democrats, about 61 percent, this

is very interesting. I'm not sure about the fourth contender, former teacher Craig Davis.

It has been many decades since Republicans candidates dominated any city election.

A word about Davis, although he's a former district teacher, he did not receive the endorsement of the teacher's union, that went to Korbatov and Manaster, but he is very likeable and has appeared at many district meetings, including the Independent Citizen's Oversight Committee, on which I serve

Whether or not he will be able to mount a viable campaign, it has not yet happened. He has garnered no major endorsements and has limited himself to a few newspaper ads.

Quick notes: Wolfgang Puck, the food conglomerate who has become a restaurant legend and icon, has launched a new product: Organic, ready to drink iced coffee. He unveiled the beverages at his Beverly Hills flagship, Spago Wednesday. With many different taste choices, Puck's new entry will soon be found at markets also displaying his many other food offerings including soups, salads etc.

Thanks to health industry executive **Sam Solakyan** for alerting me to the massive Southern California rally at the Beverly Hilton last week protesting the Armenian president's move toward cooperation with Turkey.

The Armenian genocide, around 1915, which Turkish governments have never admitted even happened, let alone accept historical responsibility for and which the international community ignored, has strong meaning for the Jewish community as well.

Had the major democratic powers of the time actually acted to save the lives of millions of Armenians, a precedent could have been set that might have led to intervention in Germany when the Holocaust was launched.

The new Germany has vigorously worked to distance itself from the Hitler years, has totally accepted responsibility for the Holocaust and has enacted laws, some of the strongest in the world, against any form of hate crime.

Turkey is a valued and key ally, but it is time for her to face historical facts, accept responsibility for the Armenian genocide and heal the wounds of the Armenians here and in their own region.

Resident **Ardyth Freshman** is upset that someone is stealing her Korbatov for school board lawn signs, and it is not a good idea to upset **Mrs. Sam Freshman.** This removal of signs is not new and although there have been incidents when zealous supporters have been the culprits, mostly it is neighbors, gardeners, kids on there way to school or the city, if the signs are not legally placed, which Ardyth insists they were.

Hopefully, everyone will respect the rights of residents to have candidate signs and not vandalize private property. It is a crime to remove signs.



BEVERLY HIGH ATHLETES INDUCTED INTO HALL OF FAME

Honorees discuss how sports changed their lives. By Kimberly Cheng

The Beverly Hills Athletic Alumni Association will host its Third Annual Hall of Fame Dinner Saturday, Oct. 24 at the SLS Hotel. The association will honor five athletic alumni and one McCarthy Lifetime Achievement Award recipient.



Tony Behrstock Class of 1985 Golf

T o n y Behrstock's 14time club championship record at the Hillcrest Country Club is nothing short of

impressive. But his victory in the 2000 Southern California Golf Association Tournament of Club Champions solidified his mark on the sport.

Behrstock was an all-star golfer at Beverly High. He was named the Ocean League most valuable player in 1985 before continuing his golf career at San Diego State University and California State University, Northridge.

"I was 13 when [golf] really just grabbed me, and it was all I wanted to do," Behrstock said. "I remember being in little league and pony league playing baseball but getting dropped off in the golf course in my uniform so I could hit balls."

Behrstock said what grabbed him about golf was being able to play and practice without teammates, unlike other sports.

"It was something I could be good at on my own," he said. "You never needed anyone else to go do it."

Still, Behrstock said there were many same-aged golfers at the Hillcrest Country Club and, of course, within the Beverly High Golf Team, which Behrstock dubbed a "fraternity."

"The guys were all buddies, and we got to travel to events," Behrstock said. "It was such a great addition to the

whole experience of being in high school."

Among Behrstock's teammates and current best friends are Lindsey Richman and Brad Sterling. His Beverly High golf coach was Jerry Carpenter, who Behrstock said became more than just a coach.

Behrstock said he would confide in Carpenter about certain things — like his first girlfriend and varsity cheerleader Abby Levy — he couldn't tell his parents or friends.

"Quite honestly, I was better than he was so it's tough to even call him a coach," Behrstock said with a laugh. "More just like a good friend to manage the team. I could have taught him how to play."

Behrstock's exposure to golf didn't begin at Beverly High, however. It began at home. In fact, Behrstock and his father have won the father-son golf tournament at the Hillcrest Country Club several times.


"I'm usually carrying him around a little, but it's always fun," Behrstock said. "Any time you get to be on the golf course with your father, it's really a bonus"

Behrstock is passing down the tradition to his son Hogan, 7, his daughter Riley, 4, and eventually his 7-month old daughter Quinn. Hogan is currently in second grade at Beverly Vista School, while Riley will be enrolling in kindergarten at Beverly Vista next year.

"[Hogan, Riley and I] call each other the three amigos," said Behrstock. "We have a really great time on the golf course."

Behrstock now works at Lawyers Title Insurance Company as the vice president of sales, and has taken with him golf's "never quit" attitude. He encourages all student athletes in high school to pursue athletics in college.

"I think it really adds to the whole experience of school and really drives you closer to the institution," Behrstock said. "And I was lucky enough to be able to do that."



Robert Countryman Class of 1983 Football, Basketball, Track

Three-sport varsity athlete R o b e r t C o u n t r y m a n shatters the idiom

"those who can, do, and those who can't, teach." He can do both.

Countryman was a quarterback for the Beverly High football team almost three decades ago, and since 1991, he has been the Normans' quarterback and wide receiver coach.

Cuontryman's 15 year-old son, Cameron, is walking in his father's footsteps on the field as the Beverly team's starting quarterback.

"[Cameron] is wearing the same number [I did], number one," Countryman said. "It's a little scary seeing him out there looking just like me. I've been coaching [Cameron] since he was eight in football and to be able to coach him in high school is just a blessing."

Even Countryman's daughter, 13-year-old Kayla, participates in the sport as a cheerleader on the junior varsity team. Kayla also competes nationally with the Santa Clarita Cheer Club.

During his high school sports career, Countryman was all-league in basketball, an all-league quarterback and defensive back, and all-CIF and allstate in track.

Countryman said his senior year's football team consisted of many talented players including CJ Fulwider, Jeff James (one of last year's honorees), Chris Williams, Mike Stees, Dennis Revere and Adorium Williams.

"Jeff James and I live about five minutes from each other," Countryman said. "I stay in touch a lot with CJ Fulwilder. He's like my best friend."

Countryman played under Coach Carter Paysinger and eventually coached with him many years later.

"[It] has been a great experience," said Countryman. "We're great friends."

Countryman also considers Bill Stansbury, Dick Billingsley and Jack Dyck as influential coaches, the latter of which he called his "mentor." Countryman went on to play football and run track at University of Southern California.

Along with coaching, Countryman now works as a television director of situation comedies at Sony. His current project is with Eric Tannenbaum — Class of 1981 graduate and first-year Hall of Fame inductee. Tannenbaum's production company is filming a show called Brothers, which features actors Michael Strahan and Daryl "Chill" Mitchell.

"I think coaching kids is so similar to being a director because it is akin to teaching a play or having a vision and teaching kids how to implement your vision," Countryman said.

Countryman's biggest piece of advice to current Beverly High athletes is to make academics a priority. While good athletes with good grades have greater opportunities to extend their sports career, mediocre grades will close doors, he said.

"I always tell my son and daughter, 'You want to use athletics to open doors for you. Don't let athletics use you,"

said Countryman.



Stacy Margolin Potter Class of 1977 Tennis

Stacy Margolin Potter started her professional tennis career at Beverly High and went on to compete in roughly 10 U.S. Open Championships.

"I got to play in the stadium twice," Potter said. "Once in singles against Billie Jean King and another time playing mixed doubles with John McEnroe against Stan Smith and Anne Smith. That was pretty exciting."

Those are just a few notches under her belt. And it can all be traced back to Beverly High, where Potter was, at first, the only girl on the varsity tennis team.

"I was already competing in tournaments," she said. "I think about five of us [on the team] were all nationally ranked players, so we had an unbelievable team that first year."

Led by Coach Hal Seiling, Potter's teammates included then-boyfriend Rocky Lang, Howard Schoenfield, Perry Wright and Paul Donzis. The following year, Diane Morrison became the second girl to join the team.

"I had a comrade," said Potter, who is still friends with Morrison. Potter also counts Anne Factor and Theresa Moore as some of her close friends from Beverly High.

After graduating from Beverly High in 1977, Potter continued her tennis career at the University of Southern California, where she won the NCAA title as a freshman. Upon winning the NCAA team title during her sophomore year, Potter — with a world ranking of 18 — decided to turn pro. She competed in the professional tour for seven years.

She credits USC coach David Borelli, her first coach Jerry Teegarden from Rancho Park and Carl Earn from Hillcrest Country Club as key inspirational figures in her career. Both Potter and Earn, who passed away last year, were both inducted into the Jewish Hall of Fame about four years ago.

"[Earn] was very instrumental in my play," Potter said. "He was a left-hander like me, and he just brought fun into the game. [Teegarden] ended up coaching Margaret Court, who was number one in the world, and Virginia Wade, who won Wimbledon."

Potter's brother Mike Margolin, who is six years older, was previously Potter's coach during her professional tour, and is currently the tennis coach at Beverly High.

"He's definitely found his niche in coaching," Potter said. "[Mike has] been doing it now for probably 30 years, and he really enjoys it. He was the one who was playing tournaments and taking lessons, and that's how I pretty much got started."

Potter said sports have continued to play an important role in her life.

"I still have that competitive mentality," she said. "The sports program at Beverly helped form me as a tennis player and as a person. It's my breeding ground."



Brad Turell Class of 1975 Basketball, Baseball

Brad Turell was offered a basketball scholarship to the University of California, Santa Barbara more than

three decades ago all because of one coach — his Beverly High baseball coach Hank Friedman.

"[Friedman] believed in me as an athlete, gave me a ball and made me starting pitcher," Turell said. "I think that had a lot to do with why I became an all-league pitcher."

Turell was also all-league and all-CIF in basketball before playing four years on UCSB's basketball team. But Turell is quite familiar with being a leader on several teams.

He is currently executive vice president of corporate communications at Beverly Hills' Paradigm Talent Agency. Turell was previously executive vice president of communications at the Warner Brothers Network and Turner Broadcasting System, Inc.

"I think everything you do in business, you can reach back and draw parallels to sports," Turell said. "I've always been part of a group in business. I've been fortunate enough to be a leader for my whole career basically. And I think that I mark it back to being the team captain of the [Beverly High] basketball team, realizing that everyone's role in the success of the team is vitally important."

Not only has Beverly High sports taught him how to lead, but some of Turell's closest friendships today were formed at Beverly High. Turell's teammates included Steven Craig, Mike Suter, Alan Nierob, Steven DeCuir, Glenn Friedman and Councilmember Willie Brien.

"Willie and I had some great battles," Turell said. "We were pitchers against each other in the Beverly Hills Babe Ruth League. Willie was the Cy Young winner [for] the best pitcher in the league, but in the championship game, I was able to pitch a shut out and beat him. We give each other a hard time over that."

Turell said he even stays in touch with his former coaches, such as Carter Paysinger and Jason Newman.

"Beverly High and Beverly High sports has been an integral part of my entire life," said Turell.

team all-CIF in football, as well as the Scholar Athlete Award. But calling it beginner's luck doesn't quite cut it, since Williams was named the Los Angeles Times Westside Player of the Year as a senior, and went on to play freshman football at Harvard University.

"You learn good values [from sports]," Williams said. "And I'm still active today. I still can't go more than a couple days without exercising."

Williams said his most memorable moments at Beverly High all happened on the field, adding that some of his friends today were his teammates at Beverly High.

"Scott Bushman," Williams said. "Him and his dad Ben Bushman, the former principal at Beverly and [football] coach. Robert Countryman. We use to play up until fairly recently in those alumni games, what I call 'Old Man Games.""

Other teammates include Jeff James and Gregg Silver, who played on both the football and baseball teams.

Williams said Bill Stansbury and Dick Billingsley were the two most inspirational coaches during his high school career, though baseball coach Dick Schreiber was responsible for helping Williams play on the football team.

"I wanted to go out for the football team, but I hadn't played freshman football," Williams said. "Coach Stansbury talked to Coach Schreiber, [who] said I was pretty fast on the bases and that [he] should give me a try."

Williams remembers Schreiber as being "tough as nails."


"[It] takes a little while before that all sinks in and makes sense that they were actually helping you," he said.

After Williams attended Harvard his first year in college, he transferred to the University of California, Berkeley, where he played four years for the Cal rugby team. During his first season with Cal, the team won the national championship, and Williams was honored as the most valuable player of the championship tournament

Williams played with the United States Rugby Team before entering law school at the University of California, Hastings. Williams is currently working in business litigation at Venable, a Century City law firm.

"In my profession with these cases, you really have to have a focus and a certain drive that, to me, really started way back in high school athletics," Williams said. "You can always tell who's played team sports, who has that sense of 'get it done, no matter what' in the business setting."

Carter Paysinger graduated from Beverly High in 1974 and began his 30-year coaching career five years after.

Now, Paysinger has moved up into an assistant principal position at Beverly High.

"[For] the last three to four years, I though about a change, doing something different," Paysinger said. "I didn't really know exactly what I wanted to do. [But] this position presented itself, and I applied for it. And I'm so far enjoying it."

Although Paysinger said he misses the on-the-field, personal contact with students on a daily basis — and watching athletes as well as the team grow every year — being assistant principal is similar to coaching in many ways, such as trying to create the best opportunities for students.

"The difference is I'm working with a number of teachers and counselors, working closer with other parts of the school, and it's given me a larger perspective on what we do at the high school," Paysinger said.

Paysinger's brother Donald has stepped in as the new head football coach.

"We've coached together for 20 plus years, so the transition has probably been easier than any other transition," Paysinger said. "All the coaches, including Donald, really aren't doing anything different than what we've done the last 20 years."

Paysinger will be presented with the McCarthy Lifetime Achievement Award Oct. 24. The award, named after Justin and Joanne McCarthy, is given to an individual who exemplifies the McCarthys' commitment of Beverly High athletics.

"There are a number of people that are worthy of being honored in that way," Paysinger said. "It's just a huge honor for me to be selected this year."


