"What to Do About the Permits?" [Issue 533]

The calling for a change in direction as it relates to the opportunity permit issue at BHUSD has been an ongoing topic for at least two years. The former school board majority along with permit families refused to accept a very generous plan that offered natural breaking points (November of 2008). Instead they advocated for matriculation through 12th grade. No student who is a resident of Beverly Hills is guaranteed matriculation through 12th grade unless residency is maintained.

About 10 months ago came the discussion of basic aid. Again, the former school board majority dismissed the notion that basic aid

was indeed around the corner. During the summer, we found out that we would be certified as a basic-aid district in spring of 2010. Recently this past November, folks went to the polls and elected new leadership so that FINALLY many of these unresolved issues would be resolved!

I believe that this is a great city and do not believe we are an elitist town as Ms. Lurie and others have portrayed us to be in recent publications. It is a normal procedure for basic-aid districts to terminate permits...it's a practice adopted by most if not all of basic-aid districts. In addition, we are still maintaining permits for school and city employees, diversity and legacy students. And for the record...opportunity permits are granted on a year-to-year basis. Nevertheless, all of this has happened in the unfolding period of about three years. It seems to me that permit families have had about 36 months to plan ahead for the change that is inevitably now here.

Families all over Los Angeles would like to have access to an education from any of the schools in BHUSD. Our schools score higher than most of the other schools in our area, but it can be improved. It is quite possibly the only thing that both residents and non-residents can agree on regarding BHUSD.

Our elected school board must deal with the reality that we are now a basic-aid district and work within this new funding structure to improve our schools. In the next years, it will be our property taxes that will pay for the bulk of our funding for our schools, rather than the

limited funds provided by the State of California. Accordingly, we must re-evaluate how best to serve our children that reside in Beverly Hills. Opportunity permits were a function of the past system — the more students in our enrollment, the more revenue we received from the state because our funds were based on a per pupil calculation. However, student enrollment is not a factor in basic aid. Any student attending a BHUSD on any permit will be doing so at the benevolence of our tax dollars, a scholarship if you will.

Understandably, those on the outside want in. They want to keep the status quo...at least until their children have matriculated from our high school, but this cannot be an acceptable result. A permit does not guarantee enrollment through the end of high school. At best, it is an annual privilege that is reviewed and renewed each year.

Despite statements to the contrary, we are not a closed system — the school system is open to anyone who is willing to move into our district.

Is it expensive to move? Yes.

Is it disruptive to move? Yes.

Does that mean you are sacrificing your residence for your child's education? Yes.

Permit Controversy Picked Up by News **Outlets Nationwide**

The BHUSD opportunity permit issue has been making nationwide news - from the Associated Press to the New York Times to LA Weekly.

Two pictures are painted of the multipronged story: residents as elitist and nonresidents as ungrateful.

And what several news outlets have gleaned from the debacle is sympathy for students affected by a financially-prudent move.

But Board of Education member Brian Goldberg said the news coverage has been brought on by a small group of people in a coordinated effort to try to "influence the public policy in Beverly Hills through negative portrayals of Beverly Hills residents in outside media."

"They are reaching out to contacts they have in order to get their story out and paint us as elitists, and paint the city in a negative light and embarrass Beverly Hills," Goldberg said. "They're trying to trash the very city they're trying to benefit from."

An LA Weekly article titled "Beverly Hills Schools Take From the Rich and Give to the Poor No more" writes that "it's a bummer for those kids who have found an education oasis surrounded by the mediocre schools of the Los Angeles Unified School District."

Many have taken this point of view — one where BHUSD attempts to save roughly "one percent of its projected \$50.2 million" budget by kicking 10 percent of its students out of the district and into the "beleaguered [LAUSD], where more than a quarter of high-schoolers drop out," writes the Associated Press.

The result of the permit debate, according to the New York Times, has created "an unflattering snapshot of the social dynamic between Beverly Hills."

This snapshot has only been magnified by the media, which often neglects to mention that BHUSD's non-renewal of opportunity permits doesn't apply to all 484 opportunity students. The exception includes seventh, 10th and 11th graders.

Goldberg said Beverly Hills will continue

to be "the most generous basic-aid district in California when it comes to out-of-district students." Most people have a misconception of Beverly Hills being a mansion-filled city, he said, but many of the city's parents who send their children to public BHUSD schools live in apartments.

We make news if rich Beverly Hills is kicking out these poor kids from South Central L.A., and that's how they're going to portray it," Goldberg said. "People love to rip on Beverly Hills. The image in people's minds is Steven Spielberg's kids, and that's just not the case."

Meanwhile, according to the LA Weekly, a group of out-of-district parents have asked the Los Angeles County Board of Education to intervene in the cutoff.

New City Building on Foothill to Open in

A new city building on 331 Foothill Road is slated to open March 2010. The \$21.5 million building will house city offices, as well as other offices for potential tenants.

The city's cable office is the only office identified by the city to be housed in the building. The city does not know other offices that will be located in the building.

At this time, the only tenant is Participant Media, an entertainment company.

The building's construction is currently being overseen by the city's project manager Allen Rubenstein.

The building is approximately 72,000 square feet, and the \$21.5 million construction costs are within the city's budget.

In addition, a nearby parking garage on Foothill Road opened about six months ago to accommodate visitors. The parking garage is roughly 20 feet away from building.

The mayor discusses her goals for the new year



Tell me about some of the city's plans for 2010?

My plans are to get out of it alive. To tell you the truth, first of all, I'd like to finish out the year peacefully. I'd like to have a healthy prosperous year. My goal as the mayor has always been to support our local businesses and the residents. And I'd like to have a smooth transition to the incoming mayor [in March] and to the business community so they can have a prosperous 2010 with a healthy, safe year to follow.

What are some goals and priorities?

Before I leave office, I'd like to see the general plan completed. This has been an ongoing thing for years. It started when I was on the architectural commission, and we worked on it when I was on the planning commission and as a council member. I'd like to see it completed. At least the first part of it, so that we can move forward. This community has worked very hard to make it happen, and I'd like to see it evaluated and done

My second goal as mayor would be some infrastructure improvements completed and accomplished under my watch, because that's been a goal-favorite of mine, and I think the Coldwater Canyon reservoir, seeing that come to fruition and opened would give me an enormous satisfaction. Seeing the Coldwater Canyon reservoir completed and filled and knowing that the city has this infrastructure in place makes me enormously happy, because for every infrastructure work accomplished, I know the city is safer and better-equipped to handle an emergency

situation

I'd like to see some kind of traffic mitigation come to pass for our community. To stop the building in Century City and areas surrounding us, so that we have some control over traffic. But I'd like to see some sort of transit mitigation worked out to control the flow-through traffic within our city. Some kind of traffic calming that works for our residents so that they're not inundated by traffic, and they have a way to move through our city at a reasonable rate.

I'd like to see the preservation of our fabulous police and fire departments. I love our boys in blue. Each night, I feel secure in my home knowing that our city employees and our police and fire departments are protecting our city. That goes for the entire staff of the city and the police and fire department. Every employee protects us in some way. This community should really be proud to have these employees working for them.

How might the transition of city managers affect these goals?

I want [Jeff Kolin] to be friends with the staff, be part of the community and be professional in every sense of the word, and I think that's what we have with the new city manager. Now will everybody be happy? Probably not. There will always be a compliant somewhere from someone. But we're here to resolve it.

I think that the transition should be seamless. We've interview him. He knows what's coming, he knows what's going on, and he's certainly aware of Beverly Hills. I don't think that there should be any difficulty whatsoever. He's apprised of everything that's been going on here. He's been watching meetings via Web cast so I think he should walk in and be immediately able to get things done.

What are some of the biggest challenges for 2010?

The biggest challenge is the economy. I think the people are nervous. My job as the mayor and as a councilmember will be whatever I can do to promote business. Wherever I travel, wherever I go, I only buy in Beverly Hills. I want people to know I shop here because I

want to look like I shop in Beverly Hills, because I do. I want to look like I represent the merchants of where I go shopping, and that's who I am, and that's what I represent.

Tell us about revisions to the city's 30-year-old General Plan.

It's mandated by state law that the general plan has to be changed every 30 years and every five years it has to be updated. But until it actually comes forward from the planning commission and I have it to compare, I don't want to say what the revisions are. They'll be very minor things like land-use like housing things and height limitations. Development things will come later.

For example, Linda Briskman and I differed on development. She wanted to do heightened density before I did. She felt we could handle it right now. I felt that first we had to have mass transit and everything in place. I wanted all infrastructures in place before development occurred. And that was probably the biggest difference between us.

Once all your decks are in a row then you can build it. And that's where the contention was. That was the Hilton expansion problem.

Do you think the Eli Broad museum will come to fruition in 2010?

I have no idea. The only one that really knows is Eli Broad. It's in his hands. It depends on how much he wants it. If Eli Broad wants it to be here, it will be here.

Who would you credit as some of the city's movers and shakers of 2009?

The movers and shakers have been the school board of 2009. I think the school board has an enormous amount of work to do, and my hat goes off to them, but they have a lot of things to sort out and straighten out. Things are in an enormous flux. In order to straighten out the bond and the money and the school issue between the permits and issues that are on the table before them, and the buildings, I would throw my hands up and I wouldn't know where to start, but that's why I'm not on the school board. I think Steven Fenton has done an enormous job with the program, and I have tremendous respect for him. I wish them all the best.

David Seidel on [the health and safety commission] has done an extraordinary job. He's kept this city in good shape and is very wise and aware of what's going on. And our public works commissioners are very tuned in to our water problems, and we had some big issues coming forward with the peripheral canal that will be coming down the line and what to do and how to vote on that issue. It's going to be a lot of controversy on that one coming forward. That's been in the works for 40 y ears. The planning commission has been extraordinary under the leadership of Nanette Cole. She's been terrific.

What are some issues that won't be resolved in the new year?

Some issues that will never be resolved are infrastructure issues. They're ongoing. Will our telephone services and utilities ever be perfect? The answer is no, because we can always make them better. I would like to see every utility line underground, state of the art, high-tech, flawless and uninterruptible. And that goes for all utilities, whether it be water, communication and electrical. That's something that this city will strive for always.

Traffic calming. Will we ever get there? No. But do we hope to? Yes.

Good neighbor relations: Something we all want. And perfect schools, where everybody is educated in the best way possible. I'd like a state-of-the-art city. That would be our goals.

These are things that don't show on the surface. They're things that are underground that you don't see, but they make life worth living. They make things run smoother.

What is your proudest accomplishment of 2009?

My proudest accomplishment was bringing back the two hours of free parking. I pushed so hard to get it back. I couldn't get it everywhere but bringing it back to the triangle was the hardest thing I fought, and I'm thrilled that I was able to do it.

What is one of your fondest memories of 2009?

I think going to ribbon cuttings for little stores where nobody comes, and you see just a couple of people there, and they're so happy that the mayor has come to support them in their endeavor as they open their business in Beverly Hills. I'm thrilled to represent the community as I go in and support them as they start up a new business and as they achieve a dream.

I just hope that 2010 brings us all good health, happiness and prosperity and our community continues to enjoy the wonderful reputation that it's enjoyed in the past. I think we have been so fortunate and blessed. I hope it continues on for future generations I would hate to lose what we have.



Finding Beverly Hills

Thoughts on life in the village By Rudy Cole

Did you know we have a beach club? Now, I don't actually watch the latest reincarnation of the television series "90210", but inadvertently, I heard a promo for a recent segment that mentioned a story line set at the "Beverly Hills Beach Club." It will take a real tsunami for our homes to have Pacific Ocean views.

Geographic precision is also not a standard followed by my friends and colleagues at the Los Angeles Times. Last year, they expanded our borders to include a story about a "down and out physician of Beverly Hills" who, after careful review, turned out to practice closer to Fairfax than face-lift row on Bedford, and not as destitute as the story claimed.

Last week, the noted restaurant critic **Jonathan Gold**, who usually can be found in LA Weekly (no relation) in a Times piece cited The Bazaar at a "Beverly Hills hotel" as the best in Los Angeles. Although Gold failed to name the hotel, it's SLS on La Cienega that was recently remodeled and renovated, a quick check with his or his editor's GPS or Thomas Guide would have disclosed that the cited

hotel and eatery pay their taxes to Los Angeles, not Beverly Hills.

The Times editors should make a note of this number: (310) 285-1000, where they will find the excellent city clerk staff with quick answers to "is it in Beverly Hills" questions.

Oh well, the Los Angeles Times, even though it is suffering reductions in coverage and features, and absentee owners, remains one of the best in the nation. However, reducing the number of columns by sports writer **T.J. Simers**, one of the most readable and literate if acerbic columnists in America, did not help keeping me as a subscriber.

Speaking of reporting the action, the director of the ESPN coverage of the UCLA -Temple game was faked out more often than the defenders of either team. It was exciting to have the camera catch a run around the weak side of the defense only to discover that the ball was actually being carried in the opposite direction.

Some of the best stories of 2009 have yet to unfold: What will happen to 9900 Wilshire? When the financing for this

project unraveled, the London owners were harder to find than **Mike Garrett**, USC atheletic director.

This is at our western gateway, it was supposed to be an architectural and green marvel, and now it stands as a monument to the shrinking of competition in the department store world. Leonidas closes and now we can't find Candy and Candy.

The national coverage of our opportunity student permit program dispute has been less than objective with reporters using the "opportunity" to cite our village as "the normally sedate enclave of ostentatious wealth.." Sedate?

The writer of those words, an Associated Press columnist, should visit us the next time we have a land use referendum or with some modest research learn that we have a stronger rent control ordinance than Los Angeles, and a large population of renters on fixed incomes.

Note to out-of-city reporters: This is NOT, or shouldn't be, about continuing the opportunity permit program, No, the only issue now is one of fairness – ending it in a way that doesn't harm the kids now in our schools who played by the rules. Most people in our city, when they understand what is really at stake, agree: We welcomed the students when we needed them, now that we don't, we should let them graduate with their class.

Most important news story, for city government, is the departure of our highly regarded city manager **Rod Wood**. Aside

from the wrenching opportunity permit debate, our schools continue to make news, not all pleasant, with on-going law suits involving the district's primary construction consultants, Strategic Concepts, and the sad personal issues faced by board member **Brian David Goldberg's** civil law suit in a San Bernardino County court.

Some of the undertones in the recent and sparsely voter involved board election were ugly. Although it would have been very difficult for any incumbent to have succeeded last year, Nooshin Meshkaty's defeat raised questions about the mostly whispered injection of her ethnic and religious ties that should never be a factor in any public contest. True, her campaign lacked vigor and focus, but she did serve with distinction and dedication if at times her efforts to straddle the political fence muddied her election message. As for the former board majority and their backers, and what was once a coalition of strength, they lost without even finding one candidate who could have made the election a sharper contest on issues. We still owe a recognition to the outstanding service to our schools by Dr. Myra Demeter, who retired from the board this year. (No, we did not always agree.)

Finding qualified, rational and experienced candidates to serve our city is a continuing challenge. Who would really want to serve when the likely consequence is distrust and vilification for all those in public office. Somehow we do find good people who try, and the current city council faced up to some tough challenges in balancing an economy ravaged city budget without dismantling our most critical city services.

Norman Girls' Basketball Team Wins Tournament Opener

BHHS alumnus set to play in the Rose Bowl. By Steven Herbert

Beverly High girls' basketball center Chelsea Austin drew high praise from Brentwood coach Jimmy George for her 27-point performance in a 74-45 victory in a first-round game of the West Coast Holiday Invitational Saturday night at the Swim-Gym.

"She's the best player in the CIF," George said.

Beverly Hills (9-2) also got 23 points and 16 rebounds from Miranda Abdul-Mansour.

The Normans led 33-23 at halftime, then more then doubled its lead in the third quarter, outscoring the Eagles, 24-12, with Abdul-Mansour scoring nine points and Austin eight. The Normans scored the first seven points of the second half on a basket by Austin, a 3-point basket by Lisa Kliman and a basket by Abdul-Mansour.

Austin scored 11 points in the fourth quarter, including all seven during a 7-0 run that began with her 3-point basket, as Beverly Hills outscored Brentwood, 17-10.

There was one tie, 2-2, and the Normans trailed only once, 5-3, then went on an 8-0 run that began and ended with 3-point baskets by Kliman and Abdul-Mansour, sandwiched around a basket by Austin. Abdul-Mansour made a second 3-point basket later in the quarter, which ended with Beverly Hills leading, 18-12.

Brentwood (3-4) scored six consecutive points to cut the deficit to 25-21 three minutes, 25 seconds before halftime, but the Normans responded with six consecutive points of their own on two free throws by Jaina Abdul-Mansour, Miranda Abdul-Mansour's twin sister, and two baskets by Austin.

"I thought we played outstanding," Beverly Hills coach John Braddell said. "We had some lulls here and there, but offensively we got up and down the floor. Chelsea just played an outstanding game."

A key for the Normans was point guard Natalie Moy "finding girls on the fast break," Braddell said. Moy had 10 assists and 10 rebounds.

Beverly Hills played without four players who were on vacation, leaving it with just two available reserves, on a team where depth has been a concern all season, Braddell said.

Jaina Abdul-Mansour added 10 points, Kliman six, and Moy and Serena Shlomof four each for the Normans.

What's Next?

The Normans faced the Los Angeles Center for Enriched Studies in a fifthplace semifinal Wednesday at the Swim-Gym that ended after the Beverly Hills Weekly's deadline.

If Beverly Hills won, it would face the Los Angeles Marymount-Norco winner in the fifth-place game today at 6 p.m. at the Swim-Gym, while a loss would put it in the seventh-place game at 4:30 p.m. today at Harvard-Westlake School against the Marymount-Norco loser.

College Football

S p e n c e r Paysinger, a 2006 Beverly High graduate, will be a starting linebacker for Oregon in Friday's 96th Rose Bowl Game, but in the days leading up to the game has been

a self-described ambassador from Southern California to his teammates, accompanying them to a variety of sites and explaining the intricacies of the region.

"Coming from L.A. is kind of surreal because a lot of our players don't know what's around the city and I know the city in and out," Paysinger said.

Paysinger said he was in Santa Monica with fellow linebacker Brandon Hanna, who is from Coeur d'Alene, Idaho, who asked, "Is this Los Angeles? Is this downtown?"

Paysinger explained it was not, then asked Hanna, "If you drove down a street in your town two hours, where would you be?"

Paysinger said Hanna replied that he would be in Washington state.

"We were on Wilshire [Boulevard] and I said, 'If we drove two hours, we would still be on Wilshire," Paysinger said.

When Paysinger steps onto the field for the game against Big Ten champion Ohio State, he will be believed to be the first Beverly High alumnus to play in college football's oldest and most famous bowl game since New Year's Day 1971 when Steve Horowitz kicked two field goals, including a then-game record 48-yarder, in Stanford's 27-17 upset of Ohio State.

Paysinger's participation in the Rose

Bowl has drawn interest among Beverly High students he coached in a flag football competition when they were in eighth grade, he said.

"They've been texting me and saying they hope we win," Paysinger said.

Playing in the Rose Bowl means "everything to me," Paysinger said, going on to recall going to the Rose Bowl's parking lots to participate in pregame tailgate parties when Wisconsin played in the game on New Year's Day 1999 and 2000, and seeing the Badgers and their Heisman Trophy-winning running back Ron Dayne practice.

"Just seeing the excitement they had was amazing," Paysinger said.

Paysinger said he went to Oregon because he was familiar with its coaching staff, thanks to his longtime affiliation with Beverly High's football program, where he was a water boy and ball boy before becoming a student and player at the school, as his father Donald was an assistant coach, his uncle Carter was the coach and another uncle, Vonzie, was defensive coordinator.

"Don Pellum, and Nick Aliotti, Mike Bellotti they all had come to Beverly Hills to recruit athletes in the past," Paysinger said, referring to Oregon's assistant head coach, defensive coordinator and former coach turned athletic director. "I'd see them around because I'd be at Beverly since I was 3 years old.

"The Oregon coaches were the most real. They were most family-like environment. A lot of coaches would say, 'You can play right now,' just pretty much statistics, but the Oregon coaches sat and talked with you like they were your family members."

Paysinger was a victim of mistaken identity during an interview session Monday at the Marriott Los Angeles Downtown.

Los Angeles Times sports reporter Kevin Baxter thought Paysinger grew up in Beverly Hills, and asked, "People think of Beverly Hills as a place that produces Paris Hilton, not linebackers," "Do people look at you and say, 'Oh you're from Beverly Hills, you're soft,' do you have to overcome that?" and "Do your teammates want to go see the family mansion?"

Paysinger first explained that the school has a history of producing college football players, including Sonny Shackelford, a receiver with the University of Washington from 2003-2006, and current defensive end Greg Townsend is being highly recruited.

Paysinger later said that being a Beverly High alumnus means, "I do get looked at sideways from time to time," and with the team staying at a Century City hotel teammates told him, "This is your town."

Eventually Paysinger explained that he grew up in Ladera Heights, and was then asked, "What does your father do?" A reporter spared him from having to say his father recently completed his first season as Beverly High's football coach.

Beverly Hilton Sues Southwest Homeowners President for Campaigning Against Measure H Suit seeks \$4 million in damages from Ken Goldman for alleged 'malpractice' Issue 489, Feb. 12

Oasis West Realty LLC, owner of The Beverly Hilton, sued longtime Southwest Homeowners President and attorney Ken Goldman for malpractice after he campaigned against the hotel's revitalization plan "Measure H" more than two years after he was employed by the company to help gain approval for the project.

Oasis West is seeking a minimum of \$4 million in damages.

"I terminated my relationship with Oasis West two years before our city council approved the project that became the subject of the referendum," Goldman wrote in an e-mail. "After the council's vote and referendum activities were begun by others, I simply exercised my rights as a citizen and resident of Beverly Hills. I did not violate any duty of loyalty to Oasis West, or violate any duty to preserve the confidences of my former client."

After the Hilton project was approved by a 3-2 city council vote, Goldman, dozens of other residents and the Citizens Right to Decide Committee collected 2,574 signatures for a petition to put the Hilton project before voters on the Nov. 4, 2008 ballot.

Update: Ken Goldman motioned to dismiss the lawsuit because it infringed on his constitutional right of free speech under the "Strategic Lawsuits Against Public Participation" statute. The motion was denied. The court ruled that Goldman acted unethically by first representing his client on a matter he later attempted to defeat.

Goldman and his firm, Reid Smith LLP, are both appealing the ruling. Briefing was completed earlier this month, and they are currently waiting for a hearing date.

"Our view of the case hasn't changed, since the very beginning," said Dirk Vincent, Goldman's attorney. "I think our papers will speak for themselves."



Brucker, Brien, Mirisch Win Council Race Measure P loses Issue 492, March 5

Then-Mayor Barry Brucker and new-comers Dr. Willie Brien and John Mirisch won the three Beverly Hills City Council seats, while the business tax initiative Measure P was simultaneously defeated by almost 80 percent of voters.

Mirisch, an IMAX film executive, received 2,268 votes, a narrow 101-vote win over incumbent Linda Briskman, who was seeking a third term on the council.

Brucker was re-elected for his second term on the five-member city council after garnering the most votes of all 11 candidates with 2,980 votes.

As a first-time city council candidate, Brien, who is chief of staff at Cedars-Sinai Hospital, placed a close second with 2,843 votes.

Update: Briskman was subsequently appointed to the State Recreation and Parks Commission and also serves on the Convention and Visitor's Bureau Board of Directors



Cat Talk Brings Out the Claws Issue 510/Issue 529, July 9/Nov. 19

More than 100 people lined the hallway of the council chamber to show both support and opposition to the feral cat ordinance.

The ordinance, which was passed months later, prohibits the feeding of animals or placing of food on public property and publicly accessible areas. It focused on a trap-neuter-return solution for feral cats and utilized TNR partners to handle the caring and feeding of feral cats. The animals would be fed in city-approved feeders.

Residents were angered by the lack of enforcement of the ordinance and the continued feeding of feral cats by

non-resident Katherine Varjian, who many claim has no regard for the law, and has harassed many of the city's residents.

Update: Mayor Nancy Krasne appointed herself and Vice Mayor Jimmy Delshad as the sub-committee charged with resolving issues related to the ordinance. The process of designing and creating feeders is ongoing. Food for the animals can be placed by residents on their private property by obtaining a free permit from the city.



Beverly Hills City Council Names City Manager Finalist Issue 527, Nov. 5

The city council unanimously selected current Santa Rosa City Manager Jeff Kolin as the new city manager after Rod Wood

Kolin beat out more than 70 applicants for the highly-sought-after position. He has served in municipal government for more than 33 years, and has been the Santa Rosa city manager for the past nine years.

According to his employment, Kolin will earn a base salary of \$275,000 annually, a \$45,000 per-year increase from his salary in Santa Rosa.

"Jeff is a seasoned veteran with an outstanding reputation who would bring to our city

organization a tremendous record of executive leadership, professional accomplishment and integrity achieved throughout his career," Mayor Nancy Krasne said.

Update: Kolin will take office January 25.



Meshkaty Eviction Raises Residency Questions

Board candidate and spouse were evicted from a West L.A. apartment while her daughter was simultaneously enrolled at El Rodeo

Issue 521, Sept. 24

The Weekly obtained court documents revealing that former Board of Education President Meshkaty was evicted from a West Los Angeles apartment while her daughter was simultaneously enrolled at El Rodeo.

Both Meshkaty — who was, at the time, up for re-election — and her husband Yar were named in the state judgment and lien document dated

March 14, 1994. Her daughter Azadeh enrolled at El Rodeo in 1991. There was no evidence that Meshkaty had a permit for her daughter at that time.

Meshkaty's ballot statement had claimed a 32-year Beverly Hills residency status. She immigrated to the U.S. in 1977.

Update: Meshkaty subsequently lost the Nov. 3 Board of Education election. She claims she lived with her mother and children in a Beverly Hills two-bedroom, twobathroom apartment approximately 1,300 square feet in size. Meshkaty refused to speak to the Weekly on the record for this or any other story.



What to Do About the Permits?

Board of Education seeks to phase out opportunity permits but June 30, but will they go quietly?

Issue 533, Dec. 17

The fate of opportunity permits has been a longtime debate within the BHUSD community, and a Dec. 11 Board of Education meeting ended with a decision to start the preliminary process of eliminating opportunity permits starting June 30, 2010.

The 3-2 vote to draft a letter notifying parents of K-6, eighth and ninth-grade students of the nonrenewal of permits sparked heated ongoing debate among residents and non-residents, whose unruly conduct at the meeting has been a point of contention.

The issue also spawned multiple Facebook pages protesting the removal of opportunity students. Two students posted violent threats, one of whom suggested bringing "machine gun machetes" to the next meeting to spill blood, which prompted an emergency board meeting and police involvement.

> The final decision regarding the current 484 opportunity permits will be made at the Jan. 12 board meeting.



Korbatov, Manaster Elected; Meshkaty **Defeated**

Issue 527, Nov. 5

Lisa Korbatov and Jake Manaster were elected to the two seats on the five-member Board of Education during the Nov. 3 election.

Korbatov came in first with 2,102 votes, followed closely by Manaster with 2,075 votes. Nooshin Meshkaty trailed behind with 1,790 votes, and Craig Davis received 496 votes. A total of 3,672 ballots were cast, or a 17.2 percent turnout of registered vot-

Both candidates were endorsed by the Weekly and the Beverly Hills Education Association.

"We are ecstatic," said BHEA President Chris Bushée. "We believe this now completes a cycle of change that started two years ago with the election of Steven Fenton and Brian Goldberg. We are very much looking forward to a new direction for our school district."

Update: Lisa Korbatov and Jake Manaster were sworn in Dec. 7. Korbatov was elected vice-president of the Board of Education. Steven Fenton was sworn in as board president. The board will rule on out-of-district permits in what is expected to be a contentious meeting Jan. 12.



Raucous Board of Education Meeting **Tuesday**

Issue 519, Sept. 10

Community members stood before the Board of Education in support or opposition of the behaviors of board members Brian Goldberg and Myra Lurie over a civil lawsuit unrelated to the board.

Goldberg received a monetary judgment from the sale of his father's company, and Lurie drove to San Bernardino to attend the trial. Lurie also allegedly consulted with the opposing counsel.

Lurie was criticized for what one board member called "a diversionary tactic" as she "injected herself into

[Goldberg's] civil lawsuit," an act that many speakers felt was personal rather than political. More importantly, speakers said the lawsuit was irrel-

Lurie defended her actions, saying Goldberg's civil case "is directly relevant to our board's business." She said she was merely "an observer who sat in the audience" and "did not utter a word to any attorney."

Goldberg argued that his case was one that involved a "complex family matter, which has no bearing on [his] ability to service."



of Education Bombshell; Christiansen Fired

Construction manager fired amidst charges of contractual irregularities Issue 516, Aug. 20

The Board of Education cancelled its construction contract with Strategic Concept, LLC and fired construction manager Karen Christiansen amid charges of "irregularities in the procedure for formation of the contracts" between BHUSD and the company.

The board majority — then-President Nooshin Meshkaty, former Vice President Myra Lurie and Myra Demeter - supported renewing the district's contract with Christiansen,

whose company received 4.5 percent commission on the construction value of projects and 2 percent of the overall project budgets under the \$334 million Measure E bond.

'Why would you pay someone a percentage of everything they spend?" said current Board Vice President Lisa Korbatov. "That only gives them incentive to spend as much as they can as fast as they can."

BHUSD subsequently sued Christiansen and Strategic Concepts, seeking \$4 million in damages.

Christiansen responded with a countersuit, seeking \$16 million from the district.

Update: A moratorium resolution was unanimously passed by the board during its Sept. 22 meeting that suspended all future spending related to the Measure E bond. The move allowed for previously authorized and outstanding invoice payment. The Citizens Oversight Committee was charged with conducting a financial and process

Beverly's Proposed New Building Will it lead to better security, or a badly conceived boondoggle? Issue 502, May 14

In a 3-2 votes, the Board of Education approved the next phase of design for the new four-story Beverly High administration building, Building M.

Board members Nooshin Meshkaty and Brian Goldberg voted against the proposed new building, which proponents say will lead to improved security and safety. Visitors will be required to enter the high school campus through the building's single entryway.

Others argue that the building will do nothing for campus safety, and one main entrance will not necessarily secure the campus. They argue that there are better uses of Measure E bond funds.

Building M would include a security office, weight and fitness room, textbook storage, food services, learning improvement classrooms, the Associated Student Body and activities/athletic directors. It would house all administrative and student services, six teaching stations and about 39,000 square feet of total program area.

Update: The Building M project is currently on hold. The Board of Education will meet in the next few months in a study session to discuss whether to move forward with the building.

"We need to decide what direction, if any, we need to take," said board member Brian Goldberg. "I'm not sure it will do anything to deter someone who wants to do harm. I'm not sure it will accomplish that goal [of improved security and safety].
