

#### Former Beverly Hills Mayor Charlotte Spadaro on trial for alleged animal abuse

A non-jury trial has begun for former Beverly Hills Mayor Charlotte Spadaro, who is being charged with 30 violations of Riverside's municipal code, which requires dogs more than four months old to be licensed and have had rabies vaccinations

Hearing the case, in Riverside, is Superior Court Judge Michele Levine. Coincidentally, Levine is the daughter of former BHUSD Superintendent (1990-98) Sol Levine.

Levine is expected to decide the case after the prosecution and defense submit their closing statements in writing September 21.

Spadaro testified on Wednesday, August 11 saying while she did not have licenses for the dogs, they were being rescued and some were "bound for foster care."

"At those 30 counts, she's looking at \$100 fine for each count," said Riverside District Attorney Public Information Officer John Hall. "It's an infraction so there is no potential jail time."

Although Spadaro has a history with Animal Services of animal abuse and violations of kennel permits, she is currently charges for the April 23 raid on her

house which found 24 dogs, one cat and her four kittens at a property on Meyers Street, Riverside. The animals were found living in squalor and none of the dogs had licenses, as required per Riverside Municipal Code.

As a lawyer, it is unclear whether Spadaro will receive punishment from the State Bar of California due to her charges but the State Bar does not generally disbar attorneys for misdemeanors.

"For the bar to remove someone's license they really have to have committed professional misconduct which typically entail ethical violations like not performing competently as a lawyer, stealing a clients money or moral turpitude.'

Spokesperson for the State Bar of California Nancy McCarthy said. "It's unlikely that an attorney would be disbarred for a misdemeanor conviction. Depending on the nature of the misdemeanor she could face some type of disciplinary charge like probation or suspension."

Spadaro is also facing 16 misdemeanor counts of animal cruelty in a separate case filed by the Riverside District Attorney's Office from an incident in April. Each of the 16 counts carries a maximum of one year in county jail. She will be arraigned for those charges on Thursday, August 19.

## Roxbury Park upgrades pending City Council approval

Roxbury Park is waiting on City Council approval for upgrades to the community center to begin. The City Council will approve the Master Plan at their August 31 meeting.

If approved, Roxbury Park renovations will come in two phases. Phase one will bring an upgraded community center, including an expanded library and café, and phase two will bring ground upgrades including grounds renovations and some ancillary buildings.

The Roxbury Park Master Plan was originally approved in Spring 2008 with an estimated budget of \$12.8 million. The City Council will now vote whether to let the architecture firm, Hirsch and Associates, proceed with drawings and plans. Hirsch and Associates, who predominately is a landscaping firm, has subcontracted with the Albert Group, who will be working on the community center plans specifically. If approved, plans will take approximately six months to draw up. If the city

council approves the drawings, the project gets put out to bid and the new community center can be completed in two years, said Interim Director of Community Services Steve Zoet.

The upgraded community center will house a variety of new amenities including a small library, gymnasium, café and additional public meeting rooms that will be available by appointment to the community and currently costs \$37.30 for Beverly Hills residents and \$47.40 for non Beverly Hills residents. The gymnasium is especially significant because the city does not currently have its own gymnasium.

"A lot of the programs and activities that benefit the senior population during the day would continue and the gymnasium would be used by your sports organizations and adult basketball programs [which are currently held at the high school]," Zoet said. "Occasionally we get bumped because of the district needs and this, to some degree, will allow us to have the assurance to run programs without disruption."

The city council's decision on stepping forward with the drawings will bring the city one step closer to renovating the park and a long awaited ending.

"This is hopefully a conclusion to what has been a very lengthy public process," Zoet said. "I've been with this city for over two years and this process has preceded me."

#### BHUSD Modernization Project to be reviewed

Measure K modernization projects at BHUSD K-8 schools that were completed over two years ago are being relooked at due to a recent discovery during a walk through by BHUSD consultants and architects.

Approved under the \$90 million budget of Measure K, these enhancements are said to have updated fixtures and finishes in addition to bringing the districts K-8 buildings up to code. These updates were not approved by the Department of State Architects (DSA) and it is questionable as to whether or not they are up to the American Disability Act (ADA) code.

Board of Education Vice President Lisa Korbatov said she feels this is a matter of school security and student safety and needs to continue to be addressed.

"Without approval from the DSA, we don't know if we comply with safety and handicap requirements," Korbatov said. "I'm very concerned that there are no existing plans. We have no frame of reference, we have nothing in writing so to speak. No schematics that are full and

complete, no plans, no scope of work and no bidding process."

The project was overseen by Strategic Concepts LLC, a construction management firm who is currently suing the BHUSD for not being paid for several projects. The BHUSD is countersuing Strategic Concepts LLC for \$4 million in damages.

Because of the lawsuits, neither party is legally allowed to speak with each other. Therefore without any documents, plans or other marks of changes, the BHUSD has no way of ascertaining documents as to whether the DSA even needed to approve the updates or if they even existed.

"Without records and without the ability to talk to people who are directly involved, [staff is] working very hard trying to find information," Superintendent Dick Dou-

## **NOTICE OF PUBLIC HEARING**

The City Council of Beverly Hills, at its adjourned regular meeting to be held on **Tuesday, August 31, 2010, at 7:00 p.m.**, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210; will hold a public hearing to consider:

AN ORDINANCE EXTENDING INTERIM ORDINANCE 10-O-2585 OF THE CITY OF BEVERLY HILLS PROHIBITING THE ESTABLISHMENT OF MARIJUANA DISPENSARIES, STORES, CO-OPS, OR MARIJUANA CULTIVATION OPERATIONS IN ANY ZONING DISTRICT OR OVERLAY ZONING DISTRICT WITHIN THE CITY, AND DECLARING THE URGENCY THEREOF

This time extension would extend the period that Interim Ordinance 10-O-2585, which was originally adopted with a 45-day effective period, by 6-months until March 5, 2011 to allow adoption of a permanent ordinance regulating such uses.

This time extension ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. It can be seen with certainty that there is no possibility that the adoption and implementation of an extension of the interim ordinance may have a significant effect on the environment. The proposed time extension and associated interim ordinance do not authorize construction and, in fact, impose greater restriction on certain development in order to protect the public health, safety and general welfare. The proposed time extension ordinance is therefore exempt from the environmental review requirements of CEQA pursuant to Section 15061(b) (3) of Title 14 of the California Code of Regulations.

All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210 and should be received prior to the public hearing.

Please remember, if you challenge the Council's action in court, you may be limited to raising only those issues you or someone else raised at the hearing before the City Council or in written correspondence delivered to the City, either at, or prior to, the hearing.

glas said. "It is elusive but you hope to come across information that's held by the state or you find the person involved."

However, without the lawsuit, Board of Education member Brian Goldberg said he believes the board never would have known about the problems.

"Had we not been involved in the lawsuit this would have been swept under the rug and we would have never have known that any of this took place," Goldberg said. "I think that because we no longer are engaging Strategic Concepts, this information came to light."

A letter from PJHM Architect sent to Cayabyab Nelson, director of facilities for the BHUSD, detailed their findings regarding their restroom and auditorium modernization verification walk through. They told the district, "the above will require some of the 2007 modernization be removed and reworked to meet current ADA codes" and that "given the scale of the proposed comprehensive Modernization projects a complete access study for all three campuses should be included."

Measure K was not only supposed to enhance fixtures and finishes in the K-8 schools but also bring the buildings up to meet ADA codes. Goldberg said he thinks the problems all come down to politics. At the time Measure K was being finished in 2007, it was also time for BHUSD Board of Education reelection.

"The incumbents were adamant that they wanted to have 'something to run on' as a success and accomplishment in the 2007 campaign and I think the board really let down their guard and basically turned the process over to outside consultants and didn't provide the oversight and accountability that was required to ensure that what they were telling the community was actually being done," Goldberg said.

Regardless of whose fault it was, the current board cannot change the past and Korbatov said they need to fix the problem instead pointing fingers.

"I'm not here to point fingers or blame anyone," Korbatov said."I don't care about prior boards, I only care about what I can do as a board member from this day forward to make sure that our schools are safe, code compliant and ADA compliant."

The district will have to pay additional money to correct the mistake by hiring architects and consultants to look over the work and redevelop designs. The final cost has not be solidified and it is unclear where the total sum of money will come from, but the initial cost is coming out of the general fund.

"It's at least \$100,000 plus whatever we're paying the consultants to do the work," Goldberg said. "It depends on how much it costs to take out the work and redo the work. We're talking about having to undo work that's already been completed."

### Beverly Hills passes city- controlled tobacco permit

The Beverly Hills City Council voted 4-0, with Councilmember John Mirisch out of the country on business, to pass a tobac-

co retail permit, at their meeting August 17

The tobacco retail permit was instated as a solution to the sale of tobacco to minors. An April 2009 survey conducted by the LA County Department of Public Health found that 47 percent of the city's businesses sold tobacco to minors. This is four times higher than the 12.6 percent rate in a California 2008 statewide survey.

A tobacco retailer can get a permit from the City's Administrative Services Department Finance Division for an annual fee of \$204. A permit will remain valid as long as it stays in good standing, meaning the retailer does not sell to minors and follows all local and state tobacco laws. As a city mandated ordinance, it will allow for local regulation.

"This puts a lot of teeth into the regulation," Vice Mayor Barry Brucker said. "It allows the local jurisdiction, Beverly Hills, to enforce it directly. [The state regulations are] hard to enforce because the state has so few people and man power to enforce it, but here in the city, if we spot an abuse happening we can attack it quite quickly."

Violations of the permit will result in a fine and suspension. The first violation is a fine of \$250, the second violation is a fine of \$750 with a 90 day suspension and the third violation is \$1,000 and a revocation of the permit. These penalties were placed to give tobacco retailers incentive not to sell to minors.

"This is all about the health and safety of our youth and our community at large so I'm very pleased that we supported this measure," Brucker said. "I think it can only help encourage retail stores to make sure anyone purchasing cigarettes are of age."

Although the ordinance was passed at the meeting, it won't immediately go into effect

"The passed ordinance has to go through a clearing period, but it should go into effect relatively soon, maybe within a month," Brucker said.

#### BHEF uses donation to implement marketing campaign

A video will be made by Board of Director Elaine Maltzman and Chairman of the Board Jonathan Prince. The video will be a commercial shown to potential donors telling people about BHEF, what it does and how it is an integral part of the education system. The BHEF have also made changes to their website to make it more personable including changing their logo color to green and adding photographs and bios about their board members to add faces to the organization.

The goal of the new marketing plan is to reshape the way the community sees BHEF.

"We wanted to brand BHEF for people to be more aware of who we are, what we do and to hopefully raise more funds that way," Saleh said.

### New student store opens at Horace Mann this fall

The Husky Student Store is set to open at Horace Mann this fall. Located in what used to be a PTA storage room, this old coat and hat check will be a place where students can buy Horace Mann t-shirts, sweatshirts, pajamas, folders, pencils, pens and other school-branded supplies.

The student store will benefit not only those who want to purchase items but also special education, GATE and Spartan students who will be given the opportunity to volunteer there.

"The plan is to incorporate [the student store] as a part of the community service program and also involve our special education students so they can get life experience," said Horace Mann PTA President Howard Goldstein.

The store will be open during special events at the school and from 2:15 p.m. until 4:15 p.m. on weekdays. Teachers, such as Special Education Teacher Aubrie Amelang, and parent volunteers will help the students work the store

Having the store will allow Horace Mann special education students the opportunity to experience mainstream interaction and responsibility and give GATE students and Spartans the opportunity to earn community service credits.

"[Special education students] can interact with the students on a daily basis from the standpoint of having the kids come and working in the store and learning a lot of skills, having increased responsibility, which is always good for children, and a sense of accomplishment," Goldstein said.

#### Kuchel honored at city council meeting

The Beverly Hills City Council put forth a proclamation honoring the deceased Senator Thomas Kuchel on the 100th anniversary of his birth. Kuchel served as the California representative in the U.S. Senate for 16 years and following his retirement moved to Beverly Hills with his wife, Betty, and his daughter, Karen, where they lived for 20 years prior to Kuchel's death. Kuchel died in 1994 but his wife and daughter still reside in Beverly Hills.

Libraries are not losing their popularity, as the advent of technology suggests. They are necessary for education but the Beverly Hills library is trying to become a destination spot for students to go and relax.

"I've heard a lot of people say for years oh television will be the end of libraries or the internet will be the end of libraries, the reality is our usage keeps going up," Hunt-Coffey said. "We're more than just books. We're more than just information. We're also a place, a community center where people want to come."

#### Beverly Hills resident uses military and life experience to write book on love

Courage to love is a story about love, war and peace in the Middle East. Published last month, it is the first book by former war correspondent, Ebony magazine editor and Beverly Hills resident of 40 years Robert Ellis.

"My book is about the invisible power of love that can cross oceans and continents and is blind to color and it's affect on people," Ellis said.



Ellis began writing the book because he realized his two closest friends. Mohamed and Jacob. were Muslim and Jewish respectively, and he said he had to do more than just

befriend them but also respect them.

"I could not be their enemies if they were my brothers," Ellis said.

The book is about an American Israeli lieutenant from South Carolina and a teenage Palestinian freedom fighter living in the Gaza Strip who are thrown together during a hospital attack and under the spell of music, are attracted to each other.

"It's the story of what happens when love attracts two people of different beliefs who've been trained that they are enemies," Ellis said."How love, during war time, can conquer or is more effective than hate and how it can bring about peace between people."

The book, which took Ellis four years to write and two years for people from all different cultures to edit, has gotten good reviews. Although the review had to remain anonymous, Ellis said it still gives him hope his book can one day be influential in the Middle East.

Ellis is currently working on another book about "the actual moments when love has transformed people" that he said will be finished sometime next year.

Before we start impeachment proceedings, or give our friends at that other newspaper one more reason to trash President Barack Obama, some facts you might not have known about the Monday traffic nightmare that nearly paralyzed our southside streets.

Yes, the visit by Obama to Beverly Hills and the subsequent closure of Olympic Boulevard to accommodate his motorcade east of our city was the major reason for the inability of motorists in and out of Beverly Hills to easily navigate our streets.

However, the debacle was exacerbated by two other incidents, both impacting our streets. Late Monday afternoon, as the President was about to travel from the Beverly Hilton to an event east of the city, a two section MTA Red bus collided with a passenger car at Pico and Beverly Drive, two blocks from our borders. The large bus did split across Pico, leading to a this closure

This double whammy, as rush hour traffic was about to make its usual impact on our through streets, resulted in massive delays on Charleville, Gregory Way and, of course, South Beverly Drive.

A third traffic problem earlier in the day had a minor impact on Westside traffic. Police closed Wilshire Boulevard just east of the city when a "suspicious package" was found near the Israeli consulate.

The mayor and councilmembers had to field dozens of calls from irate citizens, but unfortunately they had no advance notice of the Obama motorcade and no information about the Pico or Wilshire Boulevard incidents. As for knowing about the President's route, tight security made providing data to anyone, including our elected officials, impossible.

The city council honored the late Sen. **Thomas Kuchel** Tuesday on the 100th anniversary of his birth, see photo on page 5. Kuchel was one of two United States Senators who actually lived in our village, the other was one-termer **George Murphy**.

Mrs. Thomas Kuchel and former Cong. Mel Levine were there and reminded us of the ties Beverly Hills had to the moderate Republican senator. Two of Kuchel's staunchest supporters were local businessman and philanthropist Sid Levine and his long-time associate, former Mayor Jake Stuchen. Mel is Sid's son.

Councilmember **Dr. Willie Brien** also has a strong link to Kuchel. It was his grandfather, then Governor **Earl Warren**, who appointed Kuchel when **Richard Nixon** vacated the office to serve as vice president. Dr. Brien even displayed a letter he had written to Kuchel in the late 1950s.

There was another "local" link to Kuchel that not everyone might know, but was sitting only a few feet from the presentation podium.

In two of his reelection campaigns, Kuchel defeated then State Senator **Richard Richards**. What was the connection? Our very able city attorney **Larry Wiener** is a partner in the law firm of Richards, Watson and Gershon and on the night the council was honoring Kuchel they also approved a contract with his firm. The late Democratic state Senator, Richards formed the law firm.

Kuchel's brand of Republicanism is rapidly disappearing. Always a moderate, thoughtful legislator, he was never a doctrinaire politician and kept his ties to those across the aisle both cordial and balanced. Interestingly, there were sufficient moderates in his party then for the more conservative **Everett Dirksen** to name Kuchel as assistant majority leader.

As for Richards, he was then Los Angeles only state senator. Why do we now have many more and a stronger voice in the legislature? Because of then Chief Justice Earl Warren's famous "one man/woman, one vote" supreme court ruling.

Kuchel and Richards had mostly tepid, attack free campaigns. The second time Kuchel beat Richards he sent him a telegram saying: "This was fun, can we do it again."

Actually, Kuchel could have given some of the credit for his second victory to the Cuban missile crisis and President **John Kennedy**. Kennedy called Kuchel back to Washington for a bi-partisan meeting and front page pictures of Kuchel in pilots gear boarding a fighter jet made California newspaper front pages days before the election.

Without Kuchel, we probably would never had a Senator Alan Cranston. Tom lost to the fiery and ultra right winger then State Superintendent of Instruction Max Rafferty in the Republican primary in 1968. "Mad" Max was simply too much for California voters who chose Cranston instead. Clearly, had Kuchel survived the primary, he probably would have defeated Cranston.

Although the November, 2011 election for school board is many months from even filing, Boardmember Brian David Goldberg has told friends he will definitely seek a second term. Also up for election next year are Board President Steven Fenton and Boardmember and former President Myra Lurie. Lurie would be running for a third and Fenton a second term.

Fenton appears to have taken himself out of consideration as a candidate for city council in the March, 2011 election.

Goldberg was by seniority in line to be

board vice president, he instead supported Board Member **Lisa Korbatov**, who is now likely to be elected president when Fenton's term ends next year.

Goldberg has reportedly told colleagues he would not seek the board presidency unless he won a second term.

More on possible candidates, including some surprises next week.

Economic upturns? Judging by reports we are receiving, our hotels are doing extremely well, some running ahead of occupancy expectations.

The Beverly Montage, opened at one of the worst times in our economy, is now a poster child for the recovery. Not only is the hotel close to record visitor numbers, the highly popular lounge and bar are booked solidly.

Saturday night at the Peninsula also had a near capacity room in their highly sophisticated Belvedere restaurant.

Our Italian eateries including Caffe Roma and all the Drago owned venues are also crowded and bustling.

We recently ventured beyond our borders, with some mixed results. First, the good experience: Wolfgang Puck's newest on the 24th floor of the LA Live areas Ritz Carlton is spectacular and deserves the raves it has received from food critics. A highly modern but comfortable design, great evening views of the city and an innovative Asian menu makes this a good reason to head for downtown Los Angeles.

Not nearly as impressive was our experience at the connected Marriott. Their restaurant is listed as part of the Ritz Carlton on the net, so it was reasonable to assume that the parking would be the same. Driving into the Ritz Carlton, the not so helpful attendant (the best in this profession are to be found at the Beverly Wilshire, Peninsula and Montage) said no, we had to drive around the corner to the Marriott even though it would have been simpler to walk through the hotel to our destination.

Before we describe the Marriott restaurant, one more warning about the parking. You do not retrieve your car where it was dropped. No, you must take two escalators floors to enter an interior parking facility where, after some considerable waiting, your car is delivered.

As for the buffet at the Marriott, the Beverly Hilton need not worry. There was no omelet station, no great selection of eggs, no cold cuts or salads. When asked about the fried potatoes, we were told, by an embarrassed and trying to be helpful server, that they ran out and had nothing to substitute

The Hilton has all and much more and at almost the same price. Yes, the Marriott is beautifully designed, even super high tech, but the buffet is, how can I put this mildly, a total rip off.

The Hilton has one more big advantage, and that works not only at breakfast buffets, their holiday and Sunday buffet specials but for all their other servings: One of the best pastry chefs anywhere, **Frania Mendivil**. Forget the diet, indulge in her pastries,

# A SYNAGOGUE PARTIE



Neman Hall provides a bustling facility for the Iranian Jewish community's family events — so why does the City of West Hollywood want to shut them down?

In an ongoing debate between a religious cultural center and its neighbors, the Iranian American Jewish Center's (IAJC) celebratory style is being threatened. The IAJC, located at Fountain Crescent Heights in West Hollywood, is home to many celebrafor Iranian tions

Jews, many of whom live in Beverly Hills.

First covered in The Weekly in 2005, Issue #291 ("Saving a Synagouge"), in 1999 Hollywood Temple Beth El was experiencing financial hardship and a significant loss in members. The temple building was then bought by the Iranian American Jewish Foundation (IAJF), who renamed it The Iranian American Jewish Center. With the support of individual donors, including the Neman brothers of Beverly Hills, Neman Hall brought money, renovations and new members to the congregation.

However, a new set of regulations threatens to change the way IAJC operates. Neman Hall has recently been

the center of dispute as some neighboring residents are unhappy with the noise surrounding the temple through deliveries and when people leave the facility at late hours. Complaints from the surrounding residents resulted in the Business License Commission placing limits on the IAJC.

Restrictions passed by the West Hollywood Business License Commission include delivery hours being limited to 8 a.m. to 10 p.m. and the hours of the temple changing to Sunday through Thursday 6 a.m. to 10 p.m. and Friday through Saturday 6 a.m. to 12 a.m. If passed, IAJC members say it would essentially render their facility unusable.

The West Hollywood City Council decided to wait on voting on the imposed time restrictions on Neman Hall, Monday. The staff did not include the IAJF's list of 13 appeals

in agenda booklet and the council decided it was unfair to make a decision without having time to deliberate.

"The staff apologized and said it was inadvertence, but that won't do," IAJF attorney Roger Diamond said to the West Hollywood City Council at the August 16 meeting. "The public had a right to review the arguments and more importantly you have the right in previewing the meeting tonight to know in advance what our arguments were."

The West Hollywood City Council is in agreement that the activities taking place are disturbing the neighbors. Both sides recognize that there needs to be appropriate conditions placed on the activities.

"What we're really debating about is what are those conditions and how are those conditions formulated," West Hollywood Mayor John Heilman said. "I don't think anyone is interested in restricting legitimate religious activities that are taking place but when the facilities are being rented out for banquets and other events, that's having a more severe impact on the neighbors and we need to address it."

The decisions will be made at the next city council meeting and until then nothing is final.

"I think that's all on the table," Heilman said.

The contributors to the IAJC renovations were heartfelt in their desire to help Temple Beth El become revitalized in the community.

In the 2005 article, Yoel Neman said "We did it as a charity for the community to have a place for the young people to gather together and the older people to have functions. We also have a low price for functions [in Neman Hall] and that helps the community."

At the West Hollywood City Council meeting Monday, neighbors of the IAJC complained the noise coming from the center and the traffic resulting from the center were unreasonable. A resident of Crescent Heights, Mark Lederkramer said since the IAJF has taken over, traffic has gotten worse due to the parties that take place at the center, which in his mind are not consistent with a religious center.

"I purchased my condo 16 years ago on a very nice

residential block and I do not want a commercial banquet hall," Lederkramer said. "I want to say right now, like so many others, I am Jewish and in every case, the Bar Mitzvah has taken place in a Schul and the reception takes place in a commercial banquet hall. A temple is a place of worship."

The IAJF is a non-profit organization, 80 percent of its income from events held at Neman Hall, said Neman. Because the restrictions include new hours for the temple, most of the ceremonies begin after sundown and wouldn't have enough time for completion before Neman Hall would be forced to close at 10 p.m. on weekdays and 12 a.m. on weekends.

If it's is a wedding, Beverly Hills resident and IAJF President Shahla Javdan said, there are things that need to be done before the ceremony and when it takes at least two hours there will be lit-



tle time left for celebration.

"Let's say someone wants to have a marriage and wedding ceremony on a Monday, Tuesday or Thursday," Javdan said. "How can they have the reception in half an hour?"

Some events held at the IAJC run until early hours in the morning, a main point of contention with neighbors.

"I have never had any problems with Temple Beth El," Crescent Heights resident Marla Miller said. "I am Jewish and religious and I would never want to do anything to interfere with their living situation. I want the same respect back. The past five years have been brutal due to the one to four parties [a week]. The IAJF has never compromised."

Looking only to restrict non-religious activities at the IJAC, Heilman said he recognizes the good work the center does. However, Heilman sees the time restrictions as a protective barrier for surrounding neighborhood.

"I've been to a lot of weddings and I've been to bar mitzvahs and there is no reason why those have to occur until one in the morning on a week night," Heilman said. "If they do, then they shouldn't be occurring in a residential neighborhood but that is something that we want to explore is what activities should be subject to limitations and what activities are really religious in

The IAJF is an umbrella organization for approximately 25 other religious groups like The Graduate Society Foundation and the Eretz Cultural Center. If the temple is no longer optimal to hold community events, it will lose most of its income.

"The entire community uses the center," Javdan said. "It's a popular place, people like it and we're very reasonable because we're nonprofit. Financially, it will be very difficult because that is the only source of income for the temple."

Wanting to accommodate the neighborhood as much as possible, the IAJF brought in consultants to assess the noise. The consultants suggested a parking structure would help ease the noise of delivery trucks and create a buffer.

Parking structure plans were brought in front of the West Hollywood Planning Commission and were denied February 19, 2009. They wanted a variance to build their parking structure, said Planning Commissioner Joe Guardarrama.

A variance is something an individual applies for to go around a specific zoning rule. In the case of the IAJF, they wanted to put their parking structure closer to the edge of their property than the zoning rules allowed. In order to get this variance, the IAJF would have had to prove that their property was different from the lots next to it and they couldn't feasibly build a parking structure within the already stated rules.

A variance is given if a property has a physical disadvantage the surrounding properties do not. As a hypothetical example, if all of the lots in a specific area are the same but one has a giant boulder in the middle prohibiting the person who owns it from building their house in the same spot as everyone else,

a variance can be given. This would allow the person to build their house closer to the property line to avoid the boulder. The specific disadvantage keeping the person from doing what everyone else is doing is the boulder and the person needs the opportunity to have what everyone else has.

"The fact of the matter is they wanted the zoning rules not to apply to them how they apply to everyone else and in order for us to do that we have to make certain findings and there was no way that we could legally make those findings," Guardarrama said.

Guardarrama said the decision to deny the variance had nothing to do with who owned the property and everything to do with the physical characteristics of the property itself.

"I was the one that made the motion to deny them the variance," Guardarrama said. "We couldn't make the findings for a variance. We grant variances all the time but we have to make them according to the law."

Variances aside, as a property owner the IAJF has a right to develop additionally on their property as long as they get the commission's approval and stay within the predetermined boundaries. So, while the original, denied parking structure needed a variance, Deputy City Manager and Director of the Community Development Department Anne McIntosh said the IAJF proposed a different design.

"When we looked at the structure, as it was designed, we decided it needed to be reviewed by the Public Safety Commission for noise impact," McIntosh said. "We were evaluating impact from the site exiting onto Crescent Heights."

A neighborhood meeting to discuss the proposed IAJC parking structure is scheduled for August

The IAJF has also offered to install double pane windows in the homes of their neighbors at no expense to them, Javdan said.

"The people who have taken advantage of [double pane windows] have been very happy," Javdan said.

Some residents, however, say the double pane windows don't help at masking the noise.

"They have a designated loading zone and their request to have more of a loading zone is consistent with the commercial venue not a religious center," Miller said. "Most of us have double pane windows, AC units, noise machines and we're still disturbed by the noise."

The West Hollywood City Council will hear the Business License Commission restrictions at their next meeting on Monday, September, 7.

With the hours potentially being restricted for Neman Hall, Neman said it's going to be a catastrophe for the IAJC and they may have to close.

"All [income] comes from Neman hall, there is no way we can afford to relocate," Neman said. "It would be basically a disaster."
