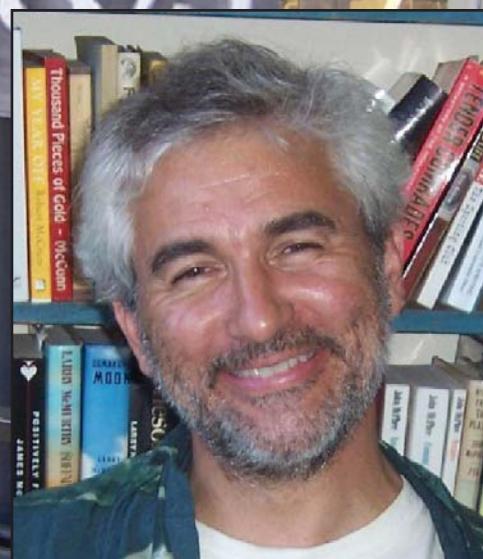

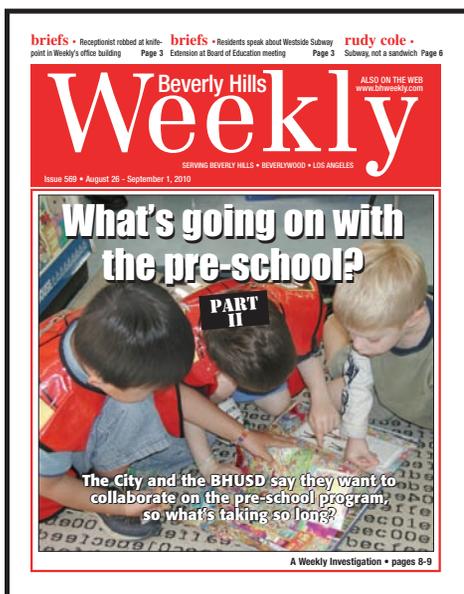

"Residents speak out about Westside Subway Extension at Board of Education Meeting" [Issue #569]

Your reporter and Rudy Cole seem to be ignoring one very critical reality check about the future subway: Santa Monica Boulevard runs along a well documented earthquake fault in the Century City area. In public meetings, Metro has clearly shown this fact and alerted the community about the risks of both tunneling along, and placing a station on, Santa Monica Boulevard. Not only would it be much riskier for the entire subway, but it would also be significantly more expensive - if not impossible - to put the subway tunnels and station there. Of course, Ken Goldman doesn't mention this fact, but journalists, columnists and elected officials should ask these questions. Let's hope that happens. Until then, let's see what the Draft environmental report says on the subject.

Let's be real -- it would be a travesty to sacrifice improved mobility on the Westside, accessibility to key regional destinations, incredible support for the subway and our ability to become a real transportation system to a handful of NIMBYs.

Suspect arrested for triple homicide in West Hollywood

A Los Angeles man was arrested Monday on suspicion of murdering three Iranian-Jewish men in the 600 block of North Kings Road last Thursday night. 31-year-old Harold Yong Park was arrested for triple homicide and possession for sales of marijuana, according to Sergeant Michael Thomas of the Los Angeles Sheriff's Department.

Park was arrested during a traffic stop in Lomita, where police found multiple pounds of marijuana in his possession. Once the police interviewed him, Park was booked for murder.

An e-mail written to the Associated Press from Los Angeles County Sheriff's Lt. Pat Nelson said investigators tracked Park's vehicle using a patrol car with a automated license plate recognition system.

"Technically, they're still investigating Parks connection to the victims and the motivation for the killing, but they believe robbery was part of the motive," Thomas said.

Beverly High 2001 graduate Bernard Khalili, 27; and brothers, Beverly High 2001 graduate Pirooz "Petey" Moussazadeh, 27 and Shahriar Moussazadeh, 38; were found in the West Hollywood Apartment, shot, at approximately 9:18 p.m. All three were pronounced dead at the scene.

WeHo News reported there is the possibili-

ty medical marijuana may have played a part in the killing of the three men. An area medical marijuana dispensary operator reportedly called anonymously to report that they feared one of their vendors (an individual who is the liaison between legal growers and legal dispensaries) was one of the victims.

Allegedly, both Khalili and Pirooz were involved with medical marijuana. Khalili was allegedly a vendor and although WeHo's anonymous source did not know how Pirooz was related, "he was involved in some way with medical cannabis."

"They had purchased the marijuana from a number of West Hollywood based marijuana collectives, recognized legal collectives, and they in turn were selling the marijuana," Thomas said.

Khalili is the brother of Bianca Khalili, who died in June 2008. Reported in the Weekly, Issue #452, Bianca died when she fell off the 15th floor of a condominium building on Century Park East after reportedly getting into an argument with friend Dora Afraim over a boyfriend. While the coroner ruled Bianca's death a suicide, many of her friends to this day do not accept the coroners findings and believe it was a homicide.

In December of 2009, Khalili was released from state prison where he was serving time for one count of gross vehicular manslaughter while intoxicated.

20-year-old Veronica Lozano, of La Habra, who was in the car when Park was arrested, was also arrested for possession for sale of marijuana. As of now Lozano has no connection to the murders, Thomas said.

Controversy arises over 9.02.10 commemorative keys

Unexpected controversy occurred after Mayor Jimmy Delshad announced he will be giving 9.02.10 commemorative event keys to celebrities attending and involved in the 9.02.10 event, tonight.

for the event and Marilyn McCoo and Billy Davis for singing it.

"The commemorative key is a key that a mayor can give for any event," Delshad said. "This is a brand new event in Beverly Hills, it never happened before so we decided to honor some of the people that participate with this. It's something to memorialize for them the reason they are here."

The late "Mayor Max" Salter was posthumously recognized with a Key to the City, at the City Council meeting Tuesday, for his role as a community leader, philanthropist and businessman in Beverly Hills. His wife, Janet Salter, accepted the Key to the City on his behalf and will be presented with it again at tonight's event.

Councilmember John Mirisch believes a Key to the City is the highest honor that can be awarded to an individual. Although the City Recognition and Gifts policy says the mayor may determine if a Key to the City is given to a visitor, this award is reserved for foreign dignitaries, honored elected officials or individual citizens who have shown outstanding philanthropy that benefits the Beverly Hills community.

While giving out a commemorative key is considered to be just a gift from the city,

Mirisch said many people will not know the difference between the event key and the traditional key, so they will hold the same meaning.

"I believe this is a thinly veiled attempt to circumvent council policy and I believe it is both on flimsy legal ground and most certainly flimsy policy ground," Mirisch said. "Clearly calling any keys awarded on Thursday's event, a special event key, is an attempt to circumvent council policy. Any key awarded as a result of this back door maneuver should not be known as a commemorative event key but maybe as the sneak-key because that was exactly how this commemorative gift was indeed created."

Former mayors such as MeraLee Goldman have spoke out against Delshad's decision to give the keys to celebrities. Goldman believes it's a procedural issue.

"If you have good process you're ahead of a problem that could develop and it's why we turn back to what is a legal and legitimate process," Goldman said. "That's why process is so important in government. We have a situation here where this key is supposed to be given to leaders, significant philanthropic contributions to the community, people who have done good for the community, that's the process."

Giving the key to celebrities goes against the policy and the process.

"You want to always do what's going to be right for the future of your city," Goldman said. "[They are receiving] an award that isn't really deserved, and it's the highest award that the city gives to world leaders. An award that's given for a purpose should never be given out of friendship or for something that doesn't benefit the future of our city."

Goldman, along with other former mayors including Steve Webb, Mark Egerman and Linda Briskman, sent letters to the City Council in opposition to Delshad's decision.

"The quality and meaning of an award from our city is diminished for all time forward when it is given lightly, as a favor, or without sufficient substantial merit," Goldman said in her letter.

The key Delshad is giving out at the 9.02.10 festivities is considered to be a key commemorating the historic event. The Key will read "9.02.10, the City with the Zip" and will not

Fourth grade section added at Beverly Vista

In an effort to avoid overcrowding at Beverly Vista, a fourth grade section is being added. The fourth grade class is currently over-enrolled by six students, with no option to transfer students per Board policy. This brought the student to teacher ratio to 32 to 1, while the teacher contract states the teacher to student ratio can go no higher than 29 to 1.

The fifth grade at Hawthorne is currently over-enrolled by two students, bringing the student to teacher ratio to 30 to 1. Prior to another section being added at Hawthorne, the BHUSD will have to confirm that all the students enrolled in the grade level are actually attending the school said Director of Human Resources Dawnalyn Murakawa-Leopard.

Board policy states that a resident who enrolls before June 30 is guaranteed a spot in the district but not guaranteed a spot in their home school. If necessary for space reasons, a student will be transferred from one school to another. A student is only involuntarily transferred once and if the resident desires, the student can be moved back to their home school once a space opens up.

"You have until June 30th to enroll your student in your home school and sometimes people will register for their home school after June 30th and after June 30th we can't guarantee anyone that we can accommodate their request," Board of Education President Steven Fenton said. "Other times there will be issues with a family that moves in during the summer assuming they can go to their home school but because they move in after the 30th cut off we can't guarantee enrollment at their home school. We can the following year if they stay in the district and enroll before June 30th."

The decision of adding new sections of a grade to a BHUSD school is done on a district-wide basis. The Board authorized the district to add additional classes if there are less than five or fewer seats in a given grade across all of the schools

"[Adding a section is] based on both the enrollment and the program needs of the school," Murakawa-Leopard said. "So we look at the number of classes that exist at the school. We try to keep as much as possible parity among the school sites while also looking at the enrollment and population at each school and doing the best we can to accommodate the needs of our students and their families."

Fenton said the district doesn't know if they will be adding more sections once the school year starts.

"We're dealing with that situation presently," Fenton said. "It's fluid, we still have two weeks to go. This happens every single year. Unfortunately It creates a little bit of anxiety for some parents but I'm confident at the end of the day that we'll start the first day of school on the right note."

A new teacher hired costs the district approximately \$85,000 in salary and benefits.

have the official city seal on it.

"it's just commemorating," Delshad said. "It doesn't say anything else about the city of Beverly Hills, it's just a key that says 9.02.10."

Because the 9.02.10 key is commemorative and supposed to hold none of the traditional sentiment, no Council approval was necessary for the gifts.

Although there are distinct differences between the commemorative key and the official key, any key given by the city holds honor that Briskman said she does not believe the recipients deserve.

"What kind of message do we give to the community, our children and teens and the world when we choose to recognize a family with their profile," Briskman said. "With all

the great families in our city, [the Kardashians] can hardly be first on the list. Recognize their branding, acknowledge their marketing skills with a proclamation but nothing they've done for the city of Beverly Hills rises to this honor and in fact some would argue quite the opposite."

To Delshad, the commemorative key is just a gift.

"It's the purpose of a key is [to open things]," Delshad said. "We've never done this so I'm opening this brand new chapter in Beverly Hills. That's why it's a key."

Roxbury Park budget approved

the City Council meeting Tuesday 3-2, with Mayor Jimmy Delshad, Vice Mayor Barry Brucker and Councilmember Willie Brien voting for and Councilmembers John Mirisch and Nancy Krasne voting against.

Architecture firm Hirsch and Associates will be receiving \$844,600 to begin plans on phase one. Phase one will bring an upgraded community center, including an expanded library and café, and phase two will bring ground upgrades including grounds renovations and some ancillary buildings.

As reported in the Weekly in Issue #568, The Roxbury Park Master Plan was originally approved in Spring 2008 with an estimated budget of \$12.8 million. The City Council voted to let Hirsch and Associates proceed with drawings and plans. Hirsch and Associates, who predominately is a landscaping firm, has subcontracted with the Albert Group, who will be working on the community center plans specifically. The plans will take approximately six months to draw up and the new community center can be completed in two years, said Interim Director of Community Services Steve Zoet.

All the councilmembers agreed that Roxbury park does need facility upgrades, however those against approving the budget said they believe it's too much money to be spending right now.

"My problem with the whole Roxbury plan is not the \$844,600 now but the \$14 million plus," Mirisch said. "It's just a question of priorities. I'd be in favor of upgrading some facilities. But right now, with the state of our

city budget, I don't feel this is something that can be supported at this time."

Paint spill on North Crescent Drive

The recently repaved 200 block of North Crescent Drive became home to gallons of white paint, August 26. Although it is unclear how the paint got on the street, it spread approximately six inches on either side and about 300 feet down the road. A resident from the senior citizen community called the Public Works department. Because the paint had dried and was no longer an environmental hazard, a member of the street maintenance team was sent to look at the damage.

The Public Works Department can take up 72 hours to respond to a call. If there is an environmental danger, such as wet paint splattered across a road, someone will be sent out right away. However if the paint has already dried, there isn't much to be done.

"If its dry paint, it's usually left out there unless it's completely all over and it's making it difficult for residents to follow the street markings," Street Maintenance Supervisor for the Public Works Department Frank Cictoria said. "Once the paint is dry I can grind it but the machine I have will do six inches. So if it's all over the street that's something I wouldn't be able to do. I'd either have to have a contractor come in or if I get the okay to black it out I can put black paint on it

Growing plants at El Rodeo expands the mind

For the second season in a row, El Rodeo Green Community Garden will be a place of learning and growing. The recently remodeled El Rodeo outdoor classroom is home to the organic garden kindergarten through third grade takes care of and learns from.

"It's an outdoor classroom, where the kids really learn about where food comes from because many of them don't have any kind of relationship with the land or understanding of the life cycle of plants," Chair of the El Rodeo Garden Committee and CEO and founder of Eden Green Living Jackie Kassorla said. "First and foremost, we want to give them the principles of organic and green gardening so they understand their responsibility to each other and also their responsibility to the earth. Secondly, we're involving the kids in eating and tasting and getting excited about healthy food."

The community garden is funded by the El Rodeo PTA and volunteer run by parents such as Kassorla. Community businesses, such as Pioneer Hardware and Anawalt Lumber, helped with the program as well.

"Local businesses gave us a consideration and discount for the purchase of tools and plants," Kassorla said. "So this has been a group effort of the community and the school."

The community garden program is a multi-disciplinary curriculum where students not only learn about planting and caring for a garden but other subjects as well.

"Gardening effects so many areas of their emotional and intellectual development," Kassorla said. "The kindergarten students will have a six pack of vegetables and they divide it into a three foot by three foot plot. Their understanding the basics of math. A third grade class is understanding the lifecycle of a seed from germination to harvest. It's not just gardening it relates to other disciplines."

This fall, each of the 31 three foot by three foot student-tended plots will become home to a cold weather vegetable. Cold weather vegetables include lettuce, spinach, radishes, carrots, beets, onions, cabbages, broccoli, cauliflower, sugar peas and cucumbers. After the vegetables are harvested, the students will make salads and eat the vegetables.

"I think the earlier we start the kids with helping them learn these great ideas the better they are," El Rodeo PTA President Azy Farahmand said. "They get used to [eating healthy] and grow up being used to it and we're building healthy habits this way."

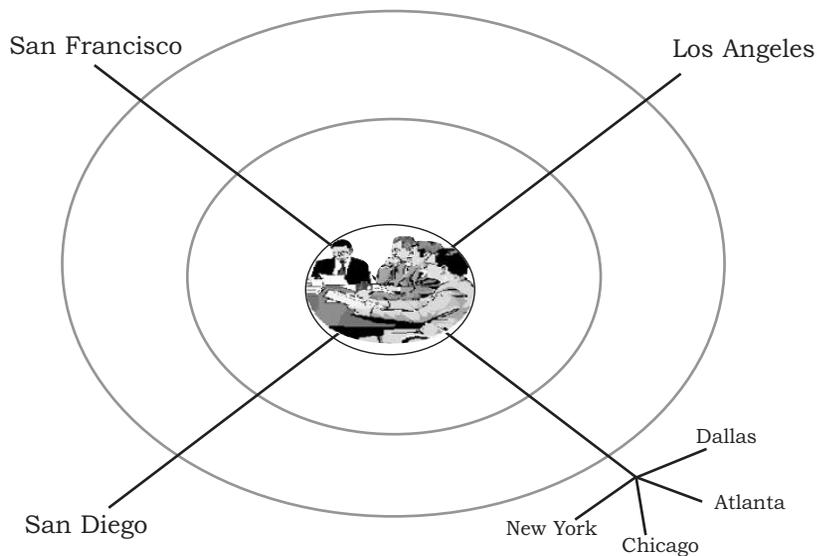

ically to play major college football, spent his freshman season playing for College of the Canyons.

Not being able to play at an NCAA Division I school directly out of high school “knocked me down a little bit,” Hauptmann said.

“It was disappointing to an extent,” Hauptmann said. “I was set on going to [a] Division I [school] straight out of high school.

“When I found out I couldn’t, I had to choose the best junior college possible, the one that could give me the most exposure with the best coaches. Having to go to a junior college definitely tested my love for the game.”

Hauptmann said he loved playing at College of the Canyons and praised its coaching staff.

“When I look back at it now it was actually better for me because it got me better prepared for Division I football,” Hauptmann said.

California, Kansas State and Washington were among the “quite a few” schools that showed interest in Hauptmann when he was at College of the Canyons, but for the 2011 season, he said.

UCLA showed interest in Hauptmann for this season, “but they were taking a long time and I just wasn’t sure on what they were going to do... so I [decided] to go where I can right now,” Hauptmann said.

That turned out to be Florida International, a Miami-based member of the Sun Belt Conference that began play in 2002 and has a 24-68 record in its eight seasons, including a 3-9 record in 2009.

Hauptmann said he chose FIU following an official visit to the university.

“I loved it out here,” Hauptmann said. “I love the coaching staff. They all treated me great. I met all the team when I came out here. I love the team. It seemed like the place for me.”

Hauptmann is majoring in international business and said he is hoping for a career in the music industry and would like to own a studio.

FIU became familiar with Hauptmann through its assistant linebackers and defensive line coach Juan Navarro, a coach at the University of Redlands from 2001-2006, whose recruiting responsibilities included California’s community colleges, FIU offensive line coach Alex Mirabal said.

“We saw what kind of talent he had, what kind of toughness he had,” Mirabal said. “He’s got the DNA that we want on the offensive line. We want our offensive linemen to be guys that dominate and discourage defenders.

“We dominate defenders by trying to move them from one point to another against their

will. When I say discourage defenders, [I want] the defenders we’re going against not to want to line up against our guys in the third and fourth quarters.”

Hauptmann “has been a tremendous addition,” both on and off the field, Mirabal said.

“He’s a guy that has a tremendous amount of pride, tremendous amount of determination and someone who is very eager to learn, to push himself to get better,” Mirabal said.

Hauptmann, listed at 6 feet 4 inches tall and weighing 311 pounds, is set to be the Golden Panthers starting left offensive tackle when they play host to Rutgers Sept. 11 in Miami. He was named as the starter on the third day of training camp, Mirabal said.

“Every day he’s gotten better,” Mirabal said. “He’s not satisfied with where he’s at, we’re not satisfied with where’s at, so, we continue to push him to get better.”

Off the field, Hauptmann has benefited the team “with his character, his toughness and his leadership,” Mirabal said.

“We’re lucky to have him here at FIU,” Mirabal said.

BHHS Hall of Fame Member, Pirates General Manager Joe L. Brown Dies at 91

Joe L. Brown, a 1935 Beverly High graduate and member of the school’s Hall of Fame, was fondly remembered for building the Pittsburgh Pirates’ 1960 and 1971 World Series-winning teams as their general manager.

“He was a great man and true Pittsburgh Pirate,” Pirates president Frank Coonely said upon learning of Brown’s death Aug. 15 at the age of 91.

“As the architect behind the 1960 and 1971 World Series teams, we were honored that Joe was able to return to Pittsburgh in June to help us celebrate the 50th anniversary of the 1960 team. The ovation he received from the crowd prior to the game was a special moment for Joe and his family, as was his company the entire weekend for all of us.”

When Brown was named as the Pirates general manager on Oct. 25, 1955, he promised to

get the team, which had finished last in the National League for four consecutive seasons, “back into the race and into the World Series.”

The goal was fulfilled in 1960, with the Pirates defeating the New York Yankees to win the World Series, with Bill Mazeroski hitting a tie-breaking home run in the bottom of the ninth inning in Game 7.

Under Brown, the Pirates were considered pioneers in scouting in the Caribbean and Latin America.

Brown remained as the Pirates general manager until 1976. He was also the team’s interim general manager in 1985.

Born in New York City on Sept. 1, 1918, the son of comedian Joe E. Brown, Brown attended UCLA and began his career in professional baseball in 1939 as the assistant business manager of the Lubbock (Texas) Hubbers, the Chicago White Sox affiliate in the Class D West Texas-New Mexico League.

Brown was the team’s business manager in the 1940 season and was president of the Waterloo (Iowa) Hawks of the Illinois-Indiana-Iowa League in 1941.

Brown enlisted as a private in the Army Air Force during World War II, rising to the rank of captain. After the war, he worked for the Hollywood Stars of the Pacific Coast League, handled publicity for the 1948 film “The Babe Ruth Story.”

Brown was the general manager of minor league teams in Zanesville, Ohio, Waco, Texas and New Orleans before becoming the Pirates general manager.

“Yes, he built championship teams and made superb trades,” Steve Blass, the winning pitcher in Game 7 of the 1971 World Series and now an analyst on Pirates’ broadcasts, told the Pittsburgh Post-Gazette.

“But he also built a pipeline to supply that team. People don’t understand how good that farm system was. He had a stockpile. You had to wait your turn to get to the big leagues. “He was the consummate GM.”

Blass also described Brown as “a baseball father to me.”

“I just thought the world of him,” Blass said. “He was living proof that not every champion wears a uniform.”

Survivors include a daughter, Cynthia, and a son, Don.

BHHS Offering Free Admission For Students For Football Opener

Admission will be free for high school and elementary school students for Beverly High’s season-opening football game Sept. 10 against Santa Barbara at Nickoll Field.

Norman coaches will be at the game to meet with elementary school students, co-athletic director Jason Newman said.

“We want to get the kids involved in high school at early age and have them become impassioned about the high school athletic program [and] have them look forward to one day being a part of it,” Newman said. “The best way to do that is to get them here at an earlier age as they do in many communities.”

Newman recalled such an experience from attending a Beverly High boys’ basketball game during the 1964-65 season when he was a Beverly Vista student.

“I remember as clear as it was yesterday, when I was in eighth grade looking at a cheerleader, who’s standing right in front of me and watching the team come out in that circle... and the [Swim-Gym] was very crowded... and I say, ‘I want to be on this floor. I want people clapping for the team that I’m on,’” said Newman, an All-Southern Section forward on the Normans’ 1969 Division 3-A championship boys’ basketball team.

“You never know when becoming part of an experience is going set the wheels in motion for something to become a passion.”

P.R. or not P.R.?

Notes on info flow

Public Relations officers: Are they helpful processors of information or another step toward an Orwellian world of thought control?

Having done both p.r. and news reporting, I should have some tolerance for both professions, but the proliferation of press information handlers in both the public and private sector raises some serious questions on press freedom and journalistic ethics, especially as the internet becomes more and more an alternative news resource.

Although far from perfect, journalistic practices have made enormous strides in fairness, objectivity and accountability. The era of "yellow" sensational journalism has, hopefully, passed, mostly among the larger surviving daily newspapers.

Some recent personal experiences you may find either amusing or troubling:

A new, small restaurant called the paper to complain about the length of time it was taking to obtain a county health permit. No problems with Beverly Hills city officials, but a final approval depended on obtaining clearance from the Los Angeles County Department of Health. It should have been fairly routine, however for some reason, the process was stalled.

So, we called a County inspector, who started out by being very helpful. After checking the file and explaining that a shortage of field inspectors and county furloughs were probably responsible for the delays, the clerk finally asked why I was interested.

When I told him I was a newspaper columnist, he froze. "I can't talk to you," he exclaimed. "You need to call our public information office."

"So, if I was just an interested citizen, you could explain the procedures but since I am a newspaper person, I have to go through your pr department?" I asked, somewhat incredulously.

"I'm sorry," he replied. "But that's my

instructions."

Hard to believe that some publicity person would be able to explain the complex plumbing safety rules of the County, but maybe my new source would have expertise in toilet technology and flacking.

A somewhat similar situation arose last week when I was researching some questions about the "alternative" route proposal for the subway to the sea project. This community has not taken kindly to the possible digging under the high school to accommodate a station in Century City, but I wanted to understand MTA reasons for the southwest instead of Wilshire and Santa Monica plan.

The community relations person was indeed helpful, if somewhat authoritarian. "Don't call it a "new" route, it has always been an "alternative," she instructed me. Not the best way to win my heart or mind, it has taken me 21 years to accept the fact that the wife has veto rights.

However, what was even more puzzling was the other person on the line. Here I was speaking to a "community relations professional," one who has spoken countless times at civic meetings without any "handling" but when contacted by a reporter, she and I were being monitored by a press information officer. True, he never intervened and courteously thanked me for my "interest" at the conclusion of the interview, still slightly unsettling.

Actually, we had exactly the same experience when we interviewed the staff director of a United States Senate committee that will probably be involved in possible federal funding for the subway. Two staffers and a p.r. person monitored the call although only the director spoke.

Which brings us to Beverly Hills. The city is fortunate to have some very able people in public relations. Our newspapers are very dependent on them, but here too there are issues of "control."

For routine questions on facts or figures, the press office can be an important first stop. Problems arise when the p.r. people intervene in deflecting calls for "opinions" from either elected officials or heads of departments. Reporters want access, not filtering or spins by public relations people, no matter how competent or informed.

No, this is not a personal problem, but new reporters on our papers often hit the p.r. wall when attempting direct interviews.

Certainly, the overall information flow has improved in recent years. The city's press releases are highly professional and helpful. Whether or not the information newspapers receive is as comprehensive as it should be is debatable, but that is mostly the responsibility of the policy makers not the p.r. writers.

Fortunately, this is a two newspaper community and that provides checks and balances on separating facts from opinions and gives us divergent and balanced takes on city issues. Considering the very strong opinions held by both our publishers, we are fortunate to have information options.

Which brings us to our Beverly Hills Unified School District. Now, here's a good example of an agency that cries out for professional public relations help.

For many years, including the wonderful era when **Ken Peters** was superintendent of schools, the district had a full time public relations officer. There were several good hands, but the best was **Ken Gelms** who understood our district, public education and worked well with Peters and the board.

Yes, there is a hiring freeze, but considering all the community relations problems facing the district, the board should give very serious consideration to the retention of p.r. pro.

The schools are achieving some very good objectives. A tough policy on cheating, stricter enforcement of rules on bullying and general discipline, many examples of improved test scores or even a report on a highly successful "retreat" for senior staff go unreported.

Another newsworthy item that has fallen off the information sphere is the status of the law suits, mostly meaning the ones involving former consultants.

What we read are the too frequent personality conflicts that make news and not the far more times when the board and the administration are in total agreement and working in harmony.

The board appears to also have made the right decisions on the selection of a "temporary" school superintendent in **Dick Douglas** and the cancellation of the contract with a search firm that bombed. But not one press release explaining the process was issued, of course because the district has no press officer.

A word about Douglas. For many rea-

sons, he is in a very strong position to finally help define the very different roles of a superintendent and a school board, which has been too muddled in recent years. Certainly, Dr. **Jerry Gross** understood the distinctions of duties and responsibilities, but his very temporary status made it difficult for him to implement change and clarity.

Board political battles, changes in administrative staff and at the site schools, the permit student disputes and, unfortunately, personal squabbles have given our district some very harmful p.r.. But on real basics there are probably few differences among board member, the teachers and administrators. Bad p.r., but in reality still one of the best school districts in the nation and clearly a school system broadly supported in our own community, no matter the problems. We must find the means of sending a more positive message and real news to all the stakeholders and that means finding a competent public relations specialist who reports directly to the school superintendent.

As for our new superintendent, if he indeed lives up to high expectations of leadership, and after a reasonable test period, the board might well consider a long term contract and some continuity of leadership at the district office.

One good side effect on the recent public debate on evaluating teacher performance and the anger among teachers at the Los Angeles Times disclosure of teacher evaluation based on test improvements, is that it has drawn attention to the crisis in California schools.

I was interested in how our own teachers felt about the test score debate, so I asked long time union leader, recently retired as BHEA president, **Chris Bushee** for his view on the newspaper disclosures:

"The release of the data in the manner being used by (The Los Angeles) Times is destructive. The branding of teachers as effective or ineffective based on students' performance on a single statewide test is myopic and shortsighted. ...Instead of damaging the reputation of public servants, the Times should reroute its aggressive journalism to toward discovery of novel ways to increase California's per-pupil funding of public schools, currently ranking an embarrassing 47 out of 50 states."

Recent city commission appointments raise some questions on process. One of our more veteran commissioners and community leaders, **Hamid Gabbay**, a highly regarded architect who has served as chair of the Planning Commission and chair of Design Review, was not given an extended term which instead went to a colleague with similar credentials but who does not live in the city. Obviously, preference should always go to residents. The council should give this another look and keep Gabbay on Design Review as long as possible.

Council colleagues expressed their appreciation to the remarkable efforts of

LIBROS SCHMIBROS

Beverly High grad David Kipen brings books to the masses in the “other” BH.

1981 Beverly High graduate David Kipen opened a lending library and bookstore, “Libros Schmibros”, on July 19, the first day of furloughs for the nearby Benjamin Franklin Library. The library and bookstore is a way for Kipen to get the thousands of books he owns out of storage and into the hands of people who can appreciate them.

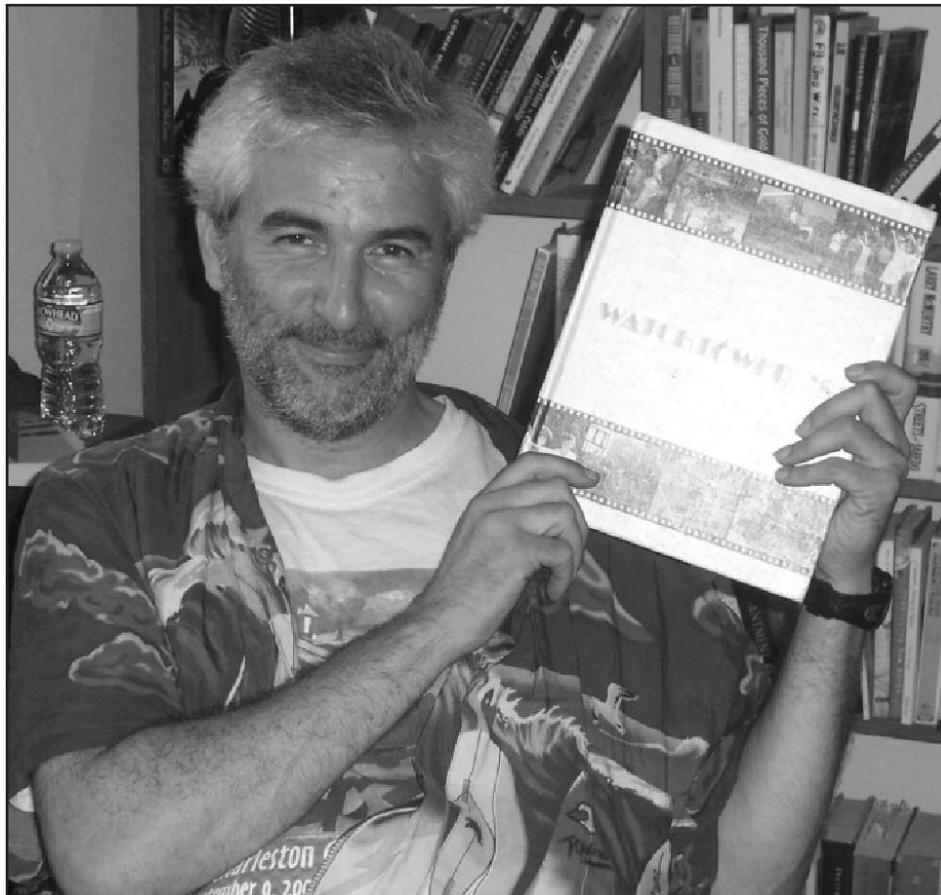
What is your background?

Well, I mean in a certain sense I’m a Beverly Hills kid. I went to Beverly High, I went to Beverly Vista starting in 7th grade. Other than a couple of years in Palm Springs in elementary school after my dad died and one of my brothers went away to Berkeley, I spent my entire youth on the west side of Los Angeles. Then I went away to Yale for four years, came back, started freelancing. After a lot of freelancing, I eventually found my way to [to my first writing job] for the LA Daily News. I freelanced for the Hollywood Reporter, the LA Times, Buzz magazine, Variety, but the first really great gig I got was I was the book editor for the San Francisco Chronicle starting in 1998. Being temperamentally a writer rather than an editor, from the first day I was looking around for someone who could accept the editorial responsibility so I could become the book critic. Sure enough I found somebody and after a year I demoted myself from editor to critic. So that’s my background, I’m an LA bred, partly Beverly Hills educated west side kid who has unaccountably found his way to the other BH, to Boyle Heights where I have family buried. So I guess that’s my background, a little easier to explain than my future. Although I guess we’ll see. I hope I’m here for a long time.

How did you come up with the idea for Libros Schmibros? Sorry I stumbled over the name, I have a lot of trouble saying it.

Practice. Which is probably not a great sign for a retail operation, if people have trouble pronouncing you. But when they do get it out or when they hear someone say it they tend to laugh, which is a point in its favor. How did I get the idea for it? Here I am, for the last four and a half years I’ve been the director of literature at the National Endowment of the Arts, pri-

marily working on a program called The Big Read, which helps cities and towns around the country do these one city, one book programs. For seven years before that I was a professional book critic and am now, again, a freelance book critic. So now, inevitably, in addition to all of the books I’ve bought over the years as a maniacal, ravenous, omnivorous reader, for seven years and today to a lesser extent even still, publishers are sending me books I didn’t even ask for. Here I am saddled with all of these books. Saddled is



the wrong word. I love these books and sometimes it breaks my heart a little to see some of them go out the door. Sometimes, people want to buy a book and I say wouldn’t you rather borrow it because I can’t bear the idea of never seeing it again. But that’s not a real healthy aspect of my personality and it’s not something I’m proud of. If circulating these books, in addition to getting them read by other people, helps me get over some of my less savory, itchy acquisitiveness maybe it’s doing everybody a little good.

Where did the name come from?

I wanted a name that would pay equal respect to the Boyle Heights that my grandparents lived in and the Boyle Heights that has welcomed me so hospitably in the months that I’ve been here. So Libros Schmibros seemed about the best way of splitting the difference. I only wish that without being too long to fit on the door, there were a way to pay equal tribute to the many Japanese and Russian and all the other communities that were once greatly represented in Boyle Heights. Everything you hear people bor-

ing you to tears with, how LA is this wonderful multicultural city which on a good day is even true, it was true in Boyle Heights almost 100 years ago. My relatives think, ‘oh Boyle Heights that used to be all Jewish’. It was never all Jewish. At most it was 70 percent. It was always this wonderful polyglot place where shamefully the government interred the Japanese in 1941 when WWII broke out and a lot of their Jewish and Mexican neighbors looked after their houses and mowed their lawns until they were returned in 1945. It was an amazing place and it still is now.

Is that why you choose to come back here?

I didn’t come back intending to live on Boyle Heights. I didn’t come back intending to come home to Beverly Hills either. So the first weekend I was back a friend had invited me to the ballet. I went to the Dorothy Chandler but I factored in time to go to Philippe’s French Dip on Alameda and there was this local newspaper called Brooklyn and Boyle, which it turns out is published by this great community center across the street, Corazon Del Pueblo. So I got on the Gold Line and I rode it to Mariachi Plaza, because I was ashamed that I hadn’t ridden it on the first day like I had the Gold Line and the Blue Line years ago. I followed the address to Corazon Del Pueblo and they took me in. I kept coming back, even as I was browsing other neighborhoods, and eventually I just took the hint and said ‘well maybe I oughta put down roots here’. I haven’t regretted it for a minute.

What do you hope to achieve with this bookstore?

I want people in Boyle Heights, not just teenagers but everybody, not to have to drive all the way to Skylight in Los Feliz to pay full price for a book or to drive all the way to, I don’t know, whose left, to get a used book. I certainly don’t want them to have to drive all the way down the street to the [LAPL] Benjamin Franklin library on a Monday and find it closed. I don’t want them to have to go in on a Wednesday or a Friday and not find the books that they’re looking for. I mean, It’s a good neighborhood library that tries its best but a library has to be all things to all people in a way that Libros Schmibros doesn’t. A library has to put out a dozen computers. I have internet access here and I’m more than happy for people to bring in laptops. But all of that [in a] public library doesn’t leave a whole lot of room for copies of Jack Kerouac. In fact, there’s a regular, who came in here and said, ‘wow, you’ve got better books in here than they do down the street at the library.’ I’m not looking to put the library out of business, California’s tax woes seem to be doing a good enough job at that without my help. But if I can augment some of what they’ve got I’m more than happy to do it.

Are you opening your own library because you feel the other libraries are insufficient?

I love libraries. I ran a nationwide reading program, a \$6 million reading program with taxpayer money that I did my best to spend wisely. In cooperation, in most cases, with libraries around the country. If libraries in Los Angeles aren’t all they could be, god knows it’s not librarians faults. It’s because we don’t fund them as generously as we should. So yeah, to a certain extent I’m trying to compensate for some of the ways that libraries, through no fault of their own,

fall short. Book stores are dropping like flies. Boyle Heights has one more bookstore and lending library than Beverly Hills does right now. When I grew up in Beverly Hills it wasn't true. When I grew up in Beverly Hills you had Doubleday and Hunters and Pickwick and Brentano's and they're all gone. If Libros Schmibros can get a toehold here in Boyle Heights, maybe I'll open a branch in Beverly Hills someday.

How can someone check it out a book?

It's easy. Checking out a book is free wherever you live. You can have it for a couple, three weeks. I use a rough ballpark policy of timing the length of the checkout to how long the book is because it doesn't make sense to lend somebody a copy of *The Old Man in The Sea* for the same period I would lend them a copy of *Gravity's Rainbow*, which is 10 times as long. Usually I factor in an anticipated reading speed of 10 pages a day and so if it's 200 pages they have the book for 20 days. If it's 2,000 pages, I'm not going to check them out a book for half a year, I'm going to give it to them for three or four weeks. But all I do is take their e mail address, if they keep it out for longer than the deadline, which I write on a post-it and stick it to the cover of the book, then I'll shoot them an e mail saying 'it's been a little long are you about ready to bring the book back? I understand that sometimes time gets away from people and as long as they stay in touch they have nothing to fear from me. To buy a book it's \$1 for residents of Boyle Heights. I wouldn't even charge that but I'd like to make a statement that books are actually worth something and a buck isn't going to kill anyone around here. Someone from Beverly Hills comes to see me, something's got to underwrite the operation so I'll charge half of the list price. Basically, it's competitive.

Who comes to this library?

Kids in the neighborhood, it gets really busy around 3,4,5 in the afternoon. That's the time of day when it's not brutally hot anymore and people are walking around and they see the sorting table out front and they come in here to investigate. Also, older folks, grownups. Sometimes they come in with their kids. There's a kids' corner in the back where they sometimes come in and read together and I'd like to explore story times when I've been here for longer than a month and actively try to bring in that sort of clientele and maybe story time for grownups. Kids aren't the only people who like being read to. People have listened to selected shorts on public radio, we all love to hear stories. There are certainly actors across the street, next to Corazon Del Pueblo is this theater called Casa 101 and if I could get



some of those actors to come in here and read a short story.

Too many people come in and ask if I have any Spanish language books, which they have every right do to but I wish I had more of them. If anybody can help me make some connections to Spanish-language publishers or large private Spanish-language libraries that might be willing to make a donation, I very much want to satisfy that need. I am a bilingual reader if not quite a bilingual conversationalist. Maybe I'm a sesquilingual conversationalist, speaking one and a half languages, but this is a very bilingual neighborhood. In some cases, especially older folks who haven't been to school in the united states, it's a monolingual neighborhood and the only language they speak is Spanish and by god were huge readers in the countries they came from and they don't have that opportunity in the United States. The library has a few Spanish books and bookstores have nothing.

So the neighborhood is predominantly Spanish speaking?

Predominantly Mexican-American.

When are you open?

For now I'm Monday, Wednesday and Friday from noon basically until Vin Scully comes on the radio. If the Dodgers start playing a little better and make a run for the pennant, people can stay here and watch the ball games with me. The book that made me fall in love with reading was *Ball Four*, a book about baseball and if that helps teenage boys especially come in here and maybe during the commercials, between innings, they look around and see a book they like, I'm not above that. I think that would be great.

Tell us more about growing up in Beverly Hills.

I was there for six years, my mom was there for a few years after so I retain a long-standing knowledge of and affection for the place. It was a neighborhood of bookstores. I would ride my bike back from Beverly to Oakhurst where I lived, just south of Doheny, and most cases it took me hours to bike 20 blocks because I would stop in at Brentano's or I would stop in at Pickwick and browse. It was a lovely education.

Another memory of Beverly Hills was giving my school commencement address. At Beverly High it was competitive. It wasn't just the kid with the best grades who got to give the speech. You had to audition. You had to write a speech out and they picked the one they liked best. I remember [former drama teacher] Andy Grenier said yours was the only speech I gave top marks to in some categories and bottom marks to in appropriateness. My speech was basically about how Beverly Hills ought to give half of its education budget to the high schools across town that didn't have the same resources as we did. So maybe I haven't changed as much as it might outwardly appear.

How do you pay for this facility?

I'm here on the indulgence of my landlord who is this nice Persian Jew from Tarzana who I think thought it was kind of cool that one of his coreligionists, a fellow Jew, was moving back into the old neighborhood. He is making me a good rate on the loft in back where I live but I've got this corner space until someone else with

deeper pockets comes along and wants to take it away from me. In which case I think it would shed a tear but give me the heave ho. He's doing this as a favor to me and I'm scrambling around, frankly, trying to find enough people who like me and think it's a good enough idea not to die and who might want to give him a little dough as so to perpetuate this. There's people in here who are discovering literature who might not otherwise do it. I hate to go around with my hand out and I hate it so much that I probably should do more of it than I do but I guess people ought to know that if they think this is cool there's a way they can help. If they like the idea of kids growing up in Boyle Heights with decent books to read, whether they pay for them or borrow them and bring them back, then there's a way to pitch in and keep it going.

How can people in Beverly Hills help?

The first thing I think people from Beverly Hills ought to do is do, what I did all to rarely when I was growing up in Beverly Hills, is to come see the place and to not be afraid of the place. I heard terrible things about Boyle Heights growing up and some of them were probably truer then than they are now and some probably aren't true now. Boyle Height's reputation is a good 10-15 year behind the reality in Beverly Hills. I have dear friends across town who probably think twice before coming to visit. I promise you, there is nothing to fear. There's something really charming about this corner of Los Angeles and I wish people would come out to see it. If people from Beverly Hills are curious about Boyle Heights and about Libros Schmibros, the first thing I would do is encourage them to come see it for themselves. If that encourages them to do no more than borrow a book or buy a book, I'm thrilled. If an eccentric billionaire wants to pay my rent for the next year, I wouldn't say no. But that's gravy. I just want people to see what I've seen and help me keep doing what I've been doing for a little bit longer.

Is there anything else they can do?

Become a customer, become a philanthropist, send me an e mail? It gets kind of lonely here around noon so if anyone wants to contact me instead of or at least before they want to come see the place I'd be more than happy to become a pen pal. There's just so much going on here, it seems selfish to keep it all to myself.

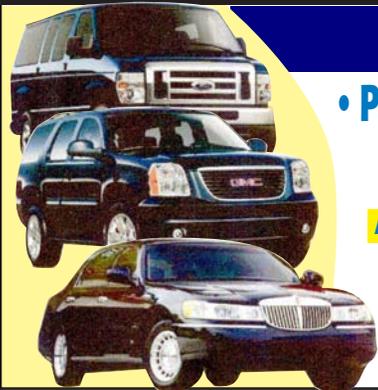

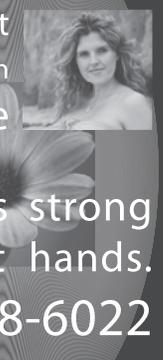
