VOTERS SHOULD BE AWARE OF CANDIDATE POSITIONS ON THE FOLLOWING ISSUES.

1) Streamline the regulation and permit process so that business and residential construction can be expedited.

2) The majority of traffic congestion in Beverly Hills is due to East-West through traffic. A redo of the Wilshire/Santa Monica intersection, one of the busiest in Los Angeles County, can solve this problem. “Chamber of Commerce Says No to Free Parking” [Issue #591]

I am writing regarding the article and particularly the headline of the story in the January 27 Weekly (“Chamber of Commerce Says No to Free Parking”). This headline is inaccurate and misleading to your readers.

The Chamber recognizes and supports providing complimentary parking to shoppers and other visitors to Beverly Hills, based on the premise that free parking helps attract customers and supports retailers and restaurateurs. Like many merchants, the Chamber recognizes that the availability of complimentary parking - which is clean, pleasant and consumer-friendly - is a significant factor in a consumer’s decision about where to shop, dine and visit.

The Beverly Hills Chamber of Commerce Board of Directors has taken a position to oppose Measure 2P and Measure 3P, both of which will be on the March 8, 2011 Beverly Hills election ballot. The Chamber believes that the City Council needs the discretion and flexibility to

make contemporary decisions about parking fees and their impact on both the City budget and consumer behavior. Although both measures would require the City Council to provide free parking (Measure 2P would require the City to provide two hours free parking at most City owned facilities; Measure 3P would provide three hours of free parking to Beverly Hills residents) the ballot measures would dilute the City Council’s authority and severely constrain their ability to respond to the needs of the City’s budget and resident and business communities. The Chamber Board of Directors opposes the ballot measures for these reasons. Sincerely yours,

Did Fulfrost violate ethics rules by bailing out Christiansen?

Whether former BHUSD attorney Howard Fulfrost violated the California Bar Association code for professional conduct by providing bail for a woman the district accuses of theft is a tricky legal question, local ethical lawyering experts say.

But it's one that some Board members are hoping is answered soon.

The question comes on the heels of a controversy surrounding his posting bail and testifying as a character witness on behalf of Karen Christiansen, BHUSD's former facilities director who has been charged with four felonies that include misappropriating \$1.3 million from the district.

Fulfrost and his firm Fagen, Friedman & Fulfrost, LLP, which also represents several other school districts in California, were clients of the BHUSD. The relationship ended on a sour note with constant clashes between Fulfrost and the Board over student permits.

But it was surprising to BHUSD when only months later Fulfrost testified on behalf of Christiansen and then posted collateral on his house to ensure her bail.

"Although it may facially appear to involve issues relating to conflict of interest, those ideas only apply to clients and she doesn't appear to be a client," said legal ethics expert Diane Karpman.

The California Bar Association's code of professional conduct states that an attorney has a duty to a former client to avoid doing anything that could hurt the client or disclose confidential information learned while employed. Similar case law from *City National Bank v Adams*, also sets the precedent for attorney conduct.

Fulfrost's ethics counsel, Kathleen McKee, insists that he has at all times followed ethics guidelines and that he has not violated any laws or oaths.

The question then turns to whether Fulfrost injured the district or disclosed confidential information by testifying on behalf of someone who the school district has a civil case against as well as someone who is facing criminal charges for actions taken at the school district.

It's not clear whether testifying or posting bail is a bigger question of ethics violations in this case. Some argued that testifying could violate the promise of nondisclosure. Posting bail on the other hand is a clear financial investment in someone who alleged harmed the district.

The California code relies on an attorney representing a client. Since Fulfrost did not technically represent Christiansen, he may not have violated that particular caveat, one attorney argued.

But the American Bar Association has more specific wording in their ethics code.

At least one Board member has vowed to seek any legal recourse available to the district against Fulfrost for these actions. The current BHUSD attorneys have reportedly been directed to investigate the Board's options.

Fulfrost's firm has requested that he "disengage" from assisting Christiansen. They

contend that he has.

Another former BHUSD attorney, David Huff of Orbach, Huff & Suarez, LLP, reportedly received racy photographs from Christiansen before he approached the district to renegotiate her contract, according to the *OC Register*.

Council may lift campaign contribution limits

As the race toward the March 8 election heats up, you may be able to donate as much as you'd like to your favorite independent political committee.

The Beverly Hills City Council will decide this evening whether to approve an ordinance that would remove limits on financial contributions to independent expenditure committees supporting or opposing candidates for local office.

City Attorney Larry Wiener's suggestion to remove the contribution cap comes after the Supreme Court's landmark decision in early 2010 that political contributions are a form of free speech that cannot be regulated when given to independent committees.

The decision in the case, *Citizens United v Federal Elections Commission*, dictates that independent expenditure committees, which are not controlled by the candidate, are not liable to influence or corrupt a candidate for office. Campaign contribution limits are only in place to eliminate corruption or the appearance of corruption, without that threat, the state cannot regulate donations.

Currently, Beverly Hills has a cap on both contributions to candidate campaigns as well as independent expenditure committees to limit corruption or the appearance of corruption from large contributions.

But thanks to the recent *Citizens United* ruling, the municipal code is no longer enforceable, the city says.

"This is the decision of the courts and we need to abide by it," Wiener said.

Wiener feels confident that the Council's recently adopted "very stringent and aggressive" disclosure requirements will counterbalance what will be lost without limits.

Other cities, like Long Beach and San Diego, have challenged *Citizens United*. They have lost. Those cities have also beefed up their disclosure requirements.

"I think the Supreme Court decision was supremely wrong," said Councilmember John Mirisch, who added that he is not inclined to vote for it.

In a smaller city like Beverly Hills, the potential for corruption could be greater, Mirisch argued.

BHUSD prepared to sue METRO over subway under high school

Calls for and whispers about a lawsuit against the MTA to stop the possible subway extension under Beverly Hills and Beverly High swept through a community meeting about the project Monday night at Roxbury Park.

The Los Angeles Metropolitan Transit Authority briefed more than 100 locals about the status of the Westside subway extension project, which would extend the purple line from Western Avenue to the VA Hospital in Westwood by way of Beverly Hills and Century City. The project was approved by more than 60 percent of countywide voters in the November 2008 election, under Measure

Margo releases Sci-Fi book

Margo has traveled the country promoting the book and is scheduled to continue with a signing tour this year.



Local students share-a-pair with Armenian children

Beverly High juniors and twin-sisters Kristen and Bridget Abajian are raising funds to buy 1,000 pairs of shoes for children in Armenia.

"So many of us take our shoes for granted," Bridget said in a statement. "We buy shoes because we want them, not because we need them. This is something that is simple for us to do and will have a huge impact on a needy child in Armenia."

The pair got the idea while living in Armenia and witnessing the poverty that meant most children own only one pair of shoes. Through the Paros Foundation, a non-profit focused on supporting arts, children and people with disabilities in Armenia, the project has chapters in Los Angeles' South Bay, Chattanooga, Tenn., and Detroit, Mich.

They have purchased 250 shoes as of Jan. 26. They hope to raise \$10,000 to purchase 1,000 shoes at \$10 for each pair. They accept financial and new shoe donations. All proceeds will go toward purchasing the shoes.

route down major thoroughfare Santa Monica Boulevard. Since then, Beverly Hills Board of Education members, elected officials and community members have voiced their strong opposition to the new plan.

At Monday's meeting, Board members and City Council members and candidates showed up to express concerns about safety, noise disturbances and the physical limits the subway would put on the district which has plans to modernize the district offices and high school, home to more than 2,000 students and the city's emergency disaster center. The MTA contended that they are exploring all the options, but tunneling under the school may be necessary given a fault line down Santa Monica Boulevard and the more strategic location of a subway stop at Constellation Avenue.

"Can the city of Beverly Hills take this to court?" Alta Drive resident Herb Wallerstein, one of the 33 who signed up to address the Metro representatives, asked blankly in front of the crowd of more than 100. Most were wearing "No subway under BHHS" buttons and erupted in applause with every vocal opposition to the project.

"Of course, anybody can take it to court," said Metro's regional communications representative Jody Litvak.

The Beverly Hills Unified School District Board of Education has retained an engineer and counsel to fight for the district's interest.

"I believe MTA is going to force the district spend education dollars fighting this in the courts, which is just wrong," Board vice president Brian Goldberg told the *Weekly* in an interview.

MTA spokesman Dave Sotero could not comment on whether the MTA was preparing for this. But added that Beverly Hills' concerns are being heard.

"The entire purpose of that meeting was to hear the public," Sotero said. "We had upwards of two hours of public comment... and the goal is to keep the community informed and allow them to provide input."

The MTA is conducting the environmental impact reviews required by the state and federal governments, which mandate that all viable routes for the train be explored and tested. The final reports will be available for public comment and review later this year.

At the heart of the issue is the direction that the subway will take from the proposed stop at Wilshire and Rodeo Drive to the next stop in Century City, at either Constellation and Avenue of the Stars or Santa Monica Boulevard and Avenue of the Stars. The former would require tunneling beneath Beverly High, that latter would tunnel under the major street.

MTA is concerned about the Santa Monica fault line and are testing the geotechnical problems there. They also raised concerns about the limited space available in that intersection to build a station. A station at Constellation would provide more room for construction and a longer station box to accommodate crossover tracks east of the station.

A handful of residents from outside of Beverly Hills showed up to throw their support behind the subway project. Some accused Beverly Hills residents of trying to use their wealth and status to prevent the rest of the city from getting the public transportation that it

needs. If Beverly Hills does tie up the subway in the courts, the rest of the county eager to ride the new subway warn that they will be very displeased.

"We cannot be paralyzed from acting because of the perception of Beverly Hills as an affluent neighborhood," Goldberg told the MTA. "If we do not stand up and speak out for what is in our City's best interest, we will wake up one day and realize what made us great no longer exists."

This was the third community update meeting for the Westside subway extension project. The first was held at LACMA West Monday, Jan. 24, and the second Wednesday Jan. 26 at the Westwood United Methodist.

MTA is putting together Station Area Advisory Groups composed of 10 area residents, businesses and property owners for input about the four stations in L.A. and two in Beverly Hills. They will meet three times in February, April and June to discuss station design, art, construction and nearby urban design. The meetings will be open to the public.

The subway is slated to begin construction in 2013 for completion in 2022.

Residents rally to save historic Durant Drive property

More than 500 residents have a signed a petition against the pending demolition of the five-unit historic building at 9936 Durant Drive, which may be razed to make way for a larger condominium complex.

The building is a two-story, 28-foot-tall, 12,145 square-foot structure. It would be demolished for a 14-unit, four-story, 45-foot-tall, 24,906 square-foot building with subterranean parking with 42 spaces. Two of the new building's units would be guaranteed to the city for moderate-income housing.

The proposed building is in the American Colonial Revival style which is appropriate for the neighborhood, the Planning Commission decided.

"It's been designed to be compatible with the balance of the neighborhood," said Murray Fischer, who represents the developer. "The planning commission spent many hours going over the project and they concluded this project was a good project for the city of Beverly Hills and will bring much needed affordable housing."

The original building was designed by architect Robert Derrah, most famous for his work on Los Angeles landmark structures such as the Coca-Cola building, the Crossroads of the World, Fairfax Farmer's Market and Charlie Chaplin's home.

Joining the effort to stop the demolition are the architect's daughter, Beverly Hills resident Bettie Derrah Jensen, and Paul Dentzel, the great-grandson of 1930s Beverly Hills Mayor E.P. Dentzel.

"Why would you paint over a Renoir just to get a blank canvas?" asked Jensen. "Beverly Hills is known for its beauty and that is slipping away with all these boxes they are putting up."

This is one of many historic structures that have been subjected to demolition in recent time. (see Rudy's column on page 6) In fact, the building at 9900 Santa Monica Blvd--former home of the Friar's Club--is being razed this week.

But Beverly Hills has no ordinance to ensure the preservation of historic homes or

places.

Planning Commission Chair Lili Bosse has asked the City Council to consider adopting the Mills Act, which provides incentives for preserving historic buildings. She said they told her it would be added to the Council's agenda priorities.

Historic buildings "add to the character and charm and history of our community, which is what makes our community great," Bosse said.

The Planning Commission has recommended its destruction. It's under appeal and the City Council will vote on it Feb. 15.

Beverly High's ongoing fence debacle

Incidents with a handful of unauthorized people trespassing on the Beverly High campus have triggered a series of discussions by the Board of Education about how to balance student safety with residents rights.

When transient entered a classroom dressed like a student in December, parents and officials were given a rude awakening about the school's vulnerabilities. In the age of increased school shootings and other types of violence, many believe it's time for the open campus to be secured. But community members want a postcard view and access to the track and field that have been guaranteed to them by a joint powers agreement with the city.

After an incident, "there's a pressure upon the Board and school administrators to put forward some kind of physical, tangible increase of security," school security expert Ken Trump said. "But what parents are really wanting when asking, directly or indirectly, for those physical securities is a guarantee that it won't happen again."

"School administrators know they can't honestly look parents in the eye and guarantee

Planning Commission just says NO

The Planning Commission said no to any marijuana dispensaries within city limits, at last Thursday's meeting.

They recommended a revised definition of marijuana dispensaries and an ordinance that prohibits any marijuana dispensary, store, co-op or cultivation facility within Beverly Hills.

"I don't believe [marijuana dispensaries] fit in the image and quality of life that we have in our city," said Planning Commission Chair Lili Bosse. "It's not reflective of our values."

The City currently has no explicit permanent ordinance prohibiting marijuana dispensaries in the city. They adopted an interim ordinance July 22, 2010, which was extended to expire on April 22 this year.

"The establishment of Dispensaries has the potential to change the character of the Beverly Hills Community," reads the staff analysis.

The push to adopt such an ordinance was part of the Council's Community Development Plan.

"The City Council is concerned that the City of Los Angeles' recent and ongoing enforcement of its regulations regarding dispensaries, and the recent direction from the County of Los Angeles Board of Supervisors to prohibit dispensaries in unincorporated areas, will lead to marijuana dispensaries seeking to locate in surrounding communities, including Beverly Hills," reads the staff report.

The report notes that dispensaries have been the subject of violence and robberies in other neighborhoods where they exist.

They additionally raised concerns about the effects this would have on other local businesses. The city's General Plan explicitly prioritizes and encourages the luxury retailers and current business owners to expand within the city and continue to foster rebounding economy.

The City Council will evaluate the ordinance at the Feb. 15 meeting.

100 percent security because there is not 100 percent security anywhere," Trump added. "So they will respond to that pressure and parental concern and anxiety by putting up those [physical securities like a fence.]"

The Board decided in a 3-0 vote last week to move forward with establishing a removable and reusable chain-link fence around the campus. They said it's a temporary fix and

first step toward developing a comprehensive strategy for keeping the school safe.

But there's a huge difference between the perception of increased security and actual security, experts say.

"Overall a chain-link fence is going to keep out the homeless guy and the causal type of person who is there to do something inappropriate," security expert Steve Kaufer said. "It's not going to keep out someone that's coming on to the campus with a twisted mission to do some serious damage but there's not much that can prevent that."

But the best thing to do is "not to rush to do something that's not strategic," said Kaufer.

The best security is increased awareness and training of the school staff and administration, experts explained.

Board members are eager to do something to create a perimeter around the campus and limit the entry ways into the school. Alternatives to a fence include installing exit-only doors on the majority of the doorways, getting keycards, more security guards and many more.

Early registration open for K-12th grade

New residents and kindergarten-eligible students can begin enrolling at the Beverly Hills Unified School District.

Early registration opened to new resident students at all grade levels and new kindergarten students on Feb. 1. Students must register before June 30 to guarantee a spot in their home school. Anyone enrolling past that date may be assigned to a different school. Parents can pre-enroll at the four elementary schools from 9 a.m. to 11 a.m. or 1 p.m. to 3 p.m. Registration at the high school is available from 8 a.m. to 10 a.m.

Potential enrollees must present a valid form of identification as well as proof of residency. Some forms of identification include driver's license or passport; and proof of residency includes items such as a lease or mortgage statement, a utility bill, an addressed financial statement and two bills with the guardian's name on them.


Reed takes over NMUSD

before that. The UC Irvine graduate has spent more than 40 years working in education.

Beverly Hills reports better-than-expected financials

The City of Beverly Hills' annual audit revealed a strong economy and transparent accounting within the city.

The city's assets exceeded liabilities by nearly \$615 million, for the year ended June 30, 2010. About one-third of that amount can be used by the city to pay its bills.

The city's total net assets increased by \$39,576,895 (or nearly 7 percent).

"I think this community really needs to stand up and cheer," said vice mayor Barry Brucker. The Council credited staff for the financial responsibilities.

"They really stepped up to the plate and worked extra hard so that community kind of didn't know we cut \$18.5 million from the budget," said Councilmember Nancy Krasne.

The City's net capital assets increased by \$43,968,186 from the prior year as a result of the current capital replacement programs activities including replacement of a major reservoir, construction of a new vehicle maintenance facility, two new parking structures and a new four-story 72,460 square foot office building.




And return of local hero

It's on. The city waited almost as long as legally possible, but the ballots for the March 8 election were printed this week and the mailing of absentees will begin Monday.

The delays were caused by hopes that the appellate court would make a final ruling on the legality of the Two Hour Free Parking initiative, first held illegal by the court, but then stayed by an appeals court temporary order.

No final ruling has yet to be rendered so the election will go forward. Two possibilities: An appellate court panel could vacate the lower court ruling and hold with the city that the Measure 2P infringes on the legislative authority of the city council or find that the voters should be allowed to decide.

Legalese aside, the vote on P2 could still be meaningless even if a majority of voters support Yes and a final court ruling upholds the city's appeal. However, a strong vote for 2P could encourage proponents to try again with a modified proposal. That would also mean a new petition effort.

Supporters of the ballot measure argue that only a vote by the people would guarantee continuation of two hour free on many city owned lots. The city responds that the elected city council alone should decide, and that in hard economic times parking lots that do not actually serve the needs of merchants and shoppers need to produce revenue. Translated, that means not providing free parking for visits to medical offices.

Best argument against: If free parking can be eliminated by an election what would prevent an anti-business license tax or water bill initiative being submitted by petition? If that passed, we could shut down city government.

Best argument for: The city should not be allowed to cherry pick where free parking is provided and assure fairness to every section of the business community.

However, what does not make sense is comparing free parking in, say, Century City, to Beverly Hills. The mammoth Century City Mall, now a Westfield, is subsidized by the merchants for free or validated parking and not city property. Our parking is paid from city revenues, not stores or restaurants, and certainly not by physicians and surgeons, few of whom validate parking in private lots.

Which brings us to the ill-conceived 3P, placed on the ballot by majority vote of the city council, to one up supporters of 2P and allow three hour free to residents only.

Aside from the enormous problems and costs of enforcement, and despite assurances that the technology is available to make sure that only resident autos will be able to obtain three hours free parking, the elitist message it sends could cause a serious shopper revolt. Our businesses depend on visitors to stores and restaurants, and we spend a small fortune each year to encourage non-resident shopping.

There is no "free" parking – someone pays, and in our case, the taxpayers, many of whom do business here but live somewhere else. Two hour free should be preserved as a good marketing tool. For now, I want to wait for a court finding on the legality of doing this by an initiative, but no such test is being made of P3. It could be possible that two hour free is ruled unconstitutional and we would be stuck with three hour, resident only, free parking.

The Beverly Hills Chamber of Commerce is opposing both (see Letters on page 2). What are specious arguments are the contentions that the Chamber is not led by the business community. On the contrary, the current leadership comes from local business leaders. To clarify a possible misunderstanding from our headlines, the Chamber does not oppose two hour free parking: it is against both ballot measures, supporting rational deci-

sion making.

Now, I have tried to avoid this, but I am a weak pundit: Is the question "two p or not to p?"

Side note: The ballot printing delay also threw off timing for the three city council candidate's campaigns. First and early mailers are most often timed with appeals to absentee ballot voters, and they now represent almost half of those who will vote.

As for the tax on oil, Measure O, this is one more example of the city moving forward on a ballot measure without a support plan in place. The effort to promote both "O" and "3P" is simply not very strong. While city resources may not be used in favor or opposition to ballot measures – aside from so-called "information only" data distribution, there is nothing in the law to prevent members of the council from actively promoting or opposing ballot measures providing they do not use taxpayer dollars.

This is all too reminiscent of a former council that placed tax measure P on the ballot and then, amazingly, urged a no vote. (Not by council action but by opinions expressed during the campaign.) No one was willing to be known as the father of that baby which the voters soundly rejected, merits aside. Yes, many of our current fiscal problems might have been avoided had "P" been approved.

Clearly, we need reform of pension plans for public employees, but at the same time we need to honor obligations previously made. City staffers that have stayed here and who were promised an attractive retirement plan can not now be told that all those years of almost universally loyal and highly professional service will not be rewarded. They spent their careers in our city's service with a reasonable expectation of being able to retire with some security.

We need to address future pension benefits, but not at the expense of those who lived and served by the rules.

Reform, yes, but why this focus on public employees alone? The mammoth and grotesque benefits top executives in the private sector receive in bonuses and retirements, frequently from companies dependent on government bail-out assistance, is far more egregious than all the public employee pension plans put together.

Going back on our word to our public employees is not the Beverly Hills way. There are some other cuts in half-baked expenditures all of us could suggest.

When *Weekly* publisher **Josh Gross** and I agree on an education issue, which doesn't happen that often, just maybe the school board should listen. Not only Josh, but my emails and phone calls universally support the need to keep Acting

School Supt. **Dick Douglas** on the job for two or at least one more year.

Even though a recruitment firm has been hired to find a "permanent" replacement, rushing that process in the middle of all the turmoil in the district simply makes no sense. Douglas has helped restore confidence in our schools within the whole education community.

One board member, who had supported the replacement process, did admit that one of the arguments for giving Douglas a longer contract and removing the "Acting" from his title was very valid: A replacement would mean hiring just before the election of a new school board, possibly even a new majority.

One thing is sure: If the Douglas contract is not extended, it will be a major and even dominating issue in the November school board election.

As first reported here, and why was that not admitted by our major daily – a common journalistic courtesy, the Friar's Club building is in the process of demolition.

Now, I am all for historic preservation and with full apologies to the buildings designers, this edifice hardly meets the test of esthetic and utilitarian importance.

Just as the Motion Picture Academy on Wilshire was given special treatment and entitlements to encourage their staying in Beverly Hills, the Friar's was not required to provide sufficient, minimum parking. A major event or roast required placing automobiles throughout adjoining residential areas.

An historical preservation group protested the city's approval of a demolition permit, however we have no ordinances that could have saved the building and probably none would have worked anyway.

True, the Friar's had an enviable record of supporting charities and their Sunday buffet rivaled even the venerable Hillcrest feast, but it had a dark side too that marred its time in Beverly Hills.

Equally important is our lack of control of demolitions. Some years back, the city council and planning commission considered putting brakes on tearing down buildings until plans for new construction were submitted and there were suggested time limits for the start of replacement projects.

Sources inside city hall seem to confirm that those rules were never formally adopted. Too bad. Unless we have some assurances that we will not have empty lots, demolitions should be, at least, delayed.

We have a large number of empty stores all over the city, including on Wilshire near our Western entry. Imagine how that would look with mammoth holes in the ground? Bad enough empty buildings, worse demolished eye sores.

The city should inhibit destruction of buildings, requiring some protection that the developer will move swiftly to submit plans for approval for replacements. Why rush to destroy structures? Only one possible reason: pressure on the city to

expedite the approval process, but not in the real interests of the community.

"Employee Associations' salaries and benefits"

The various Employee Associations of the City of Beverly Hills would like to take this opportunity to provide the residents and business owners of Beverly Hills factual information regarding our salaries and benefits since there has been inaccurate and misleading information printed in another local news publication. All or most of this information may also be found and verified on the City's website at www.beverlyhills.org and at CalPERS' website, www.calpers.ca.gov.

First, we would like the community to recognize the distinction between Public Safety and Miscellaneous employees. Public Safety employees are defined as sworn Police and Fire personnel and Miscellaneous employees are all other employees. This distinction is important because the benefits afforded these two groups are different. The current Memorandum of Understanding (MOU) provides for 3% at 50 for Public Safety and 2.5% at 55 for Miscellaneous employees' retirement formulas. (The formulas from CalPERS have been provided.)

Essentially, this means for every year of service provided we receive either 2.5% or 3% of our salary, respectively. Based on this mutually agreed upon formula, the more years of service worked and the older the retiree is, the higher the percentage of compensation the retiree will receive. Additionally, employees of the City do not receive Social Security benefits.

Secondly, the Associations and the City have worked cooperatively to contain costs associated with our employment and

post-employment benefits. Examples of this are:

- Total Compensation Surveys in lieu of cost of living increases
- A Cafeteria Plan for the purchase of health, dental, vision and other benefits
- A Tiered System for Post-Employment Health Benefits that only include medical health premiums

Finally we would like to THANK the members of this community for your continued support of us, the employees of the City of Beverly Hills, and for acknowledging the value of the service we provide. Our goal is to continue to exceed

your expectations as we strive to provide you with superior customer service.



BHEF V. OTHER EDUCATION FOUNDATIONS

Why does BHEF raise less than comparable communities?

The Weekly investigated three local school district's education foundations to see how they've weathered the recent financial recession. The findings show the Beverly Hills Education Foundation has some catching up to do if it wants to compete with the incoming donations to comparable districts.

Created after the passage of Prop. 13, education foundations are tax-exempt 501c3 non-profits dedicated to garnering financial donations to support their local public school districts. The California Consortium of Education Foundations, which lists more than 660 organizations, reports that education foundations statewide raised more than \$230 million in 2009.

"We call it an autonomous friend of the school district," said CCEF executive director Susan Sweeney. "It is supportive and we find that successful foundations work effectively with their school board."

Established in the late 1970s, the Beverly Hills Education Foundation has provided nearly \$1 million to the Beverly Hills Unified School District each year for the last four years. They provided \$953,469 to the Beverly Hills Unified School District in 2008, according to most recently available 990 tax documents filed with the IRS. The organization reported earning about \$1.3 million in annual revenue that year.

But a survey of other local education foundations shows that the BHEF has been raising less money for the schools while paying their CEO a higher salary than comparable districts like Palos Verdes Peninsula and Manhattan Beach [see graph].

"Why doesn't Beverly Hills raise as much

as Manhattan Beach? It's a different demographic and they've done a really successful job at educating their community [about what education foundations do]," said BHEF CEO Dev Hankin. "So we need to emulate that."

Hankin had been the unpaid president and a volunteer for the organization for several years before taking her current paid position in 2007. Prior to that, she had been a producer, whose credits include the 2002 Tom Hanks film "Catch Me if You Can."

"I'm not satisfied with where we are now," said BHEF Chairman Jonathan Prince. "But I'm happy to say that it's getting better."

Indeed, since Prince and co-chair Annette Saleh took their positions last year, BHEF officers say they have been reaching out to more of the community, being more transparent with their finances and reporting an increase in revenue this year.

Comparatively, the Manhattan Beach Education Foundation has consistently increased the amount of contributions it receives year-over-year, with contributions of more than \$4.6 million in the 2008 fiscal year.

"We've never had a down year," said MBEF's co-president Erika White.

Their foundation exclusively pays for personnel such as teachers or college counselors. They partner with the PTA, and several PTA members sit on the foundation's board of directors. It's a unique arrangement that helps streamline how the funds are effectively used in the district.

Foundation saw its contributions begin to dwindle so they amped up their efforts to get more contributions in smaller amounts.

They increased their pledge to the school district by \$1 million this year, and are aiming to garner \$2.5 million for the district by June 30. Half of their donation goes toward teacher salaries at the schools and half goes toward programming.

They haven't hit the goal yet, but are reaching out to new donors and business

partners to keep the organization going.

"We have been increasing our outreach through direct mailing, one-on-one meetings with major donors," Palos Verdes Peninsula Education Foundation president Kate Cocke added. They look to families and work to cultivate relationships with those not directly involved with the schools like grandparents, alumni and local businesses. They keep overhead costs low by getting supplies, including large office equipment, donated.

Education Foundations nationwide can have trouble maintaining a balance between funding school needs and paying the costs of operating a non-profit. A general rule for non-profit organizations is to keep overhead costs, like management and supplies, to 10 percent or lower of your total revenue.

"We definitely watch that," Palos Verdes' Cocke said. "Ten percent or lower is pretty awesome. We hover around there."

The MBEF keeps its overhead costs around 5 percent, an unusually low percentage of overhead costs for any non-profit organization.

BHEF was not forthcoming about its overhead costs or percentage. But according to 990 forms obtained by the Weekly, BHEF spent \$515,000 on overhead costs in 2008. This includes employee salaries.

That overhead amount however has steadily decreased since then, Prince noted.

Today, the officers say they have reduce costs and found ways to ensure all the donations that come from the two large events BHEF sponsors each year go straight back to the schools instead of to overhead. They have additionally taken over the summer school program and ensure that all the money beyond expenses is returned to the school district.

One constant cost for BHEF overhead in the last few years has been the \$100,000 that goes to the CEO's annual salary, making the BHEF CEO one of the best paid in the region.

"I don't think there's a dime that we're paying Dev that's being wasted," said Prince, who stressed that her job requires up to 10 hours of work per day. Hankin's contract comes before the executive board each year, and has been resigned at the same wage each year.

The rest of the Board is a volunteer-staff.

"The Board works their butts off," said Hankin. "I don't do this for the money... I was an unpaid volunteer for years before they gave me this job."

Hankin said she works countless hours

during the week running BHEF, including meetings and phone calls first thing in the morning until the late hours of the evening.

In 2008, BHEF saw a \$1 million drop in contributions, which could have helped fuel a year-end revenue loss of more than \$100,000 for the foundation.

BHEF acknowledged it was a rough year and that their message wasn't reaching the community effectively, which may have contributed to the loss of funds. The Board

of BHEF felt the community wasn't aware of what the organization did and how it could assist the school district.

So it recently underwent a rebranding campaign, which included an overhaul of their website, an educational video and meetings and talks with the community about how BHEF supports the district.

Unlike PTAs or the school district, education foundations can provide directed and specialized funding, most notably teacher salaries. This has helped many school district's retain teachers that may otherwise have been pinkslipped.

The five BHUSD PTAs bring in a combined average of \$500,000 each year, according to the district. The El Rodeo school PTA typically brings in the most funding.

The difference is that "BHEF pays for people; the PTA pays for things," said Hankin.

Last year was an exceptionally difficult year for most non-profits. BHEF felt a hit to its pocketbook as well. But it wasn't just the recession that affect BHEF's ability to pull in donations.

Mixed messaging from the school district and BHEF volunteers created a barrier, Prince noted.

"We are a system and if our system is perceived by potential donors as sick or ill... then I would say that we don't deserve them to invest," said Prince, noting that the recent financial problems in the school district had parents weary of what would happen to donated money.

But since the rebranding of BHEF, Hankin says they are seeing a pick-up in donations so far this year.

Experts warn that education foundations see their numbers fluctuate dramatically year-to-year because they aren't run like typical businesses. Unlike a local company whose mission is to make a profit, education foundations' sole purpose is to give money away to the school district, they say. So as soon as money comes in, it's making its way out.

"It's [also] hard to measure because some of it is in-kind or goes directly to the school," Sweeney added.

Some education foundations nationwide have been criticized for mismanagement or failing to meet the needs of a school district. Foundations have been disbanded or fired by their school boards for financial gaffes such as paying more in overhead and salaries than they paid to the school district. Such was the case in the Las Virgenes Unified School District only a few years ago, where their education foundation director was terminated for lackluster fundraising.

The best benchmark for the success of an education foundation is how it works with its Board of Education, according to Sweeney.

BHEF said they work closely with the BHUSD Board to ensure they are helping meet the district's needs. The Board can give direction to the BHEF about what's needed.

"Needs have changed, the economy has changed, demographics have changed and we need to sit down and discuss it," said Board president Lisa Korbatov, who said she has shared her constructive ideas for BHEF with the Board. "When the rubber hits the road, there are changes that need to come about and that will bear the fruit in my opinion."

BHHS Football Star Townsend Signs With USC

Beverly High defensive end Greg Townsend signed a letter of intent to accept an athletic scholarship from USC Wednesday, the first day permitted for this year's high school seniors under NCAA rules.

Townsend made a verbal, non-binding commitment to accept a scholarship offer from USC Jan. 5, but made an official visit to the University of Miami, Jan. 21, which also offered him a scholarship, according to the recruiting website Rivals.com.

Townsend also had a scholarship offer from Texas Christian, where he made an official visit Dec. 3, Rivals.com reported. Townsend's father, also named Greg Townsend, played for Texas Christian before playing defensive end for 13 seasons in the NFL, including 10 with the then-Los Angeles Raiders.

Townsend, listed at 6 feet, 4 inches tall and 260 pounds, was the unanimous selection as the Ocean League's defensive player of the year, and was chosen for the All-Southern Section and Best in the West teams. Rivals.com ranked Townsend fifth among high school senior strongside defensive ends.

BHHS Girls' Soccer Team Shuts Out Culver City, Hawthorne

The Beverly High girls' soccer team defeated Culver City, 2-0, Jan. 26 in an Ocean League game at Culver City, in what coach Ryan Franks called the Normans' "biggest win of the season" because it "keeps our hopes alive for a league title" or a second-place fin-

ish.

Kaela Reisfelt opened the scoring in the 63rd minute, putting in a rebound of a 30-yard free kick by Nicole Star that was stopped by the Centaurs goalkeeper.

Beverly Hills scored again in the 70th minute when Ashley Aviram broke through the right side, had her shot blocked and Tiffany Moore put in the rebound.

Norman goalkeeper Ida Trevino made seven saves for her seventh shutout of the season.

Defenders Monica Salandra, Mashar Zargar, Star, Elena Rust and Trevino drew praise for their play from Franks.

Culver City was ranked eighth in the Southern California High School Soccer Coaches Association Southern Section Division 4 poll released Jan. 24.

Beverly Hills defeated Hawthorne, 5-0, Friday in an Ocean League game at Nickoll Field, with Emily Rosen scoring her third and fourth goals of the season and Nicole Rosen having three assists to set a school record of 18, breaking her own record of 17 set in the 2008-2009 season.

Aviram had a goal and an assist while Nia Freeman and Reisfelt also scored for the Normans (13-5-2, 5-1 in league play). Moore was also credited with an assist.

With Trevino resting a sore knee, Sydney Segal made one save for her first shutout of the season.

Beverly Hills led 2-0 at halftime.

The Normans are scheduled to play league-leading Santa Monica Friday at 3:30 p.m. at Santa Monica College in a game where the winner could likely be the league champion and at Inglewood Tuesday at 3 p.m. in Ocean League games.

Beverly Hills was ranked ninth in the Southern California Soccer Coaches Association Southern Section Division 4 poll released Monday, while Santa Monica is ranked sixth.

BHHS Girls' Basketball Team Defeats Taft, Hawthorne

The Beverly High girls' basketball team defeated Woodland Hills Taft, 58-44, Saturday in the Santa Monica Westside Challenge at Santa Monica High, as Brittany Pourmorady tied a school record by making seven 3-point baskets for the Normans.

Pourmorady, a 6-foot senior forward who had made two 3-point baskets in her two-season career with Beverly Hills before Saturday, made one in the second quarter, two in the third and four in the fourth, for a game-high 21 points.

Pourmorady, who has received additional playing time because of a series of injuries to teammates, tied the school record set by Natalie Moy in a 65-45 victory over Brentwood Dec. 27.

The Normans had been working "a lot against zone" defenses in preparation for their Friday game against Hawthorne and Pourmorady "played extremely well in practice," coach John Braddell said.

"I said, 'Let's try to give her an opportunity in the ball game,' and she really capitalized on it and played well," Braddell said. "She struggled early. I told her to stay with it and she did."

Pourmorady made seven of her 11 3-point shots.

Beverly Hills led 20-11 after the first quarter as Chelsea Austin scored 12 of her 18 points,

including two 3-point baskets, and Moy four, including a 3-point basket.

The Normans led 35-25 entering the fourth quarter after both teams scored five points in the second quarter and it outscored the Toreadors, 10-9, in the third quarter.

Beverly Hills opened the fourth quarter with a 13-2 run with Pourmorady making two 3-point baskets and Austin making a layup and 3-point basket, increasing its lead to 48-27. The Normans led by at least 16 until Taft closed the game with an 8-2 run.

"I thought we were up and down," Braddell said. "I thought we played well at times."

The Toreadors ran a triangle-and-two defense that focused on Austin and Moy in an attempt to "interrupt our offensive flow" and "we had to set things up and change things around a little bit," Braddell said.

Moy had seven points and six rebounds.

"I thought Natalie did a nice job attacking the glass and getting offensive rebounds," Braddell said.

Tiffany Haney had four points and a team-high 10 rebounds. Tiffany Yadegar added four points and Debbie Reyhan and Dorsa Mehrannia two each for Beverly Hills (12-12).

The Normans "struggled, especially in the first half" but "played much better" in the second half of a 41-33 victory at Hawthorne Friday night in an Ocean League game, Braddell said.

Beverly Hills was outscored 10-2 in the first quarter, with Moy making its lone basket, and 14-11 in the second to trail 24-13 at halftime.

Moy's 3-point basket was the Normans' only basket of the third quarter, but Austin made five of eight free throws and Moy one of two as they outscored the Cougars, 9-5, cutting the deficit to 29-22.

Moy scored 13 of her game-high 19 points in the fourth quarter, with a 3-point basket and making eight of nine free throws, as Beverly Hills outscored Hawthorne, 19-4.

Austin added 11, including making two of four free throws and a basket in the fourth quarter, Pourmorady five, all in the second quarter, including a 3-point basket, Haney four and Mehrannia two as the Normans improved to 3-3 in league play.

Austin had 12 rebounds and Haney 10.

Beverly Hills made nine of 61 shots – Moy four of 12, Pourmorady two of eight, Austin one of 14, Mehrannia one of 11, Haney one of eight, Reyhan zero of five and Yadegar zero of three.

A foul-plagued Norman team trailed Culver City by one point entering the fourth quarter, but was outscored by 14 over the final eight minutes of a 56-41 loss Jan. 26 in an Ocean League game at the Swim-Gym.

"They just attacked the basket and we couldn't stay in front of them," Braddell said.

Austin, Beverly Hills' power forward, began the fourth quarter on the bench with four fouls, returning when trailed by four. Haney, the Norman center, fouled out in the middle of the fourth quarter.

The foul trouble caused Braddell to change defensive assignments.

"We just had to move some players around and there was some little weakness on defense that hurt us in the fourth quarter," Braddell said. "They did a good job of attacking Chelsea, knowing that she had four [fouls]."

Beverly Hills was outscored 23-9 in the fourth quarter, with sophomore guard Taylor

Tanita scoring 12 of her game- and high school career-high 22 points, including making six of nine free throws, freshman guard Kelsey Ueda five on two baskets and a free throw and junior forward Lunden Junious making four of six free throws for the Centaurs.

The Normans led 12-9 at the end of the first quarter, as Haney scored seven of her nine points. Beverly Hills trailed 23-21 at halftime, as it was outscored 14-9 in the second quarter, with Tanita scoring eight points, making two 3-point baskets.

The Normans outscored Culver City, 11-10, in the third quarter with Austin scoring six of her team-high 17 points and Moy making a three-point basket.

Austin also scored six points in the fourth quarter.

Moy added 11, and Mehrannia and Pourmorady two each for Beverly Hills.

The Normans are scheduled to play host to Santa Monica Friday and Inglewood Tuesday at the Swim-Gym in Ocean League games beginning at 6 p.m.

Beverly Hills was ranked 11th in Division Southern California Interscholastic Basketball Coaches Association Southern Section Division 2A poll released Monday. Santa Monica was ranked ninth in the Division 1AA poll and Inglewood sixth in Division 2AA.

BHHS Boys' Soccer Team Loses To Culver City, Hawthorne

The Beverly High boys' soccer team lost to Culver City, 4-3, as the Centaurs capitalized on "three defensive mistakes" to score three goals in a 16-minute span of the second half of an Ocean League game at Culver City Jan. 26, Norman coach Steve Rappaport said.

Culver City's goals in the 44th, 55th and 59th minutes erased Beverly Hills 2-1 half-time lead.

"We had many, many opportunities," said Rappaport, whose team led in shots, 23-6. "We completely controlled the game and it seemed every time they won the ball on a counter, we did a lousy job of tackling."

The Centaurs opened the scoring in the fourth minute. The Normans tied the score in the 38th minute of the 40-minute first half on Mariano Gonzalez's team-leading ninth goal of the season, off James Karlin's assist.

Beverly Hills took the lead one minute later on Nick Marmureanu's second goal of the season, both in the last past two games, off Elijah Lichtenberg's assist.

Josh Newman scored his second goal of the season in the 64th minute, off Lichtenberg's corner kick.

Norman goalkeeper Matt Davidov made two saves.

Defender Bryan Khalilrad, Lichtenberg and defender Shaya Noorian drew praise for their play from Rappaport.
