



Planning Commission will consider overlay zone for Gateway Project



Three landowners applying to change the zoning of their parcels from T-1 (transportation) to C-3 (commercial use) were dealt a setback last Thursday, when the Beverly Hills Planning Commission decided not to authorize a change in zoning of three parcels of land located along Santa Monica Boulevard near Wilshire Boulevard.

"We're leaving our options open," Planning Commission Chair Daniel Yukelson said. "We want to figure out what will work best with those parcels. We want to do it right because it's an important gateway to our city."

If approved, the project, known as the Gateway Project, would have changed the zoning of three parcels of land located along Santa Monica Boulevard near Wilshire Boulevard at Beverly Hills' western border. The parcels, totaling approximately 3 acres, were formerly part of a railroad right-of-way and the current zoning allows the land to be used only for transportation.

Two of the three landowners requested rezoning only, and a third requested rezoning and a development proposal for a three-story, 90,000-square-foot office building with four levels of subterranean parking providing 274 parking spaces.

Assuming maximum potential development on all three parcels, the final environmental impact report identified temporary air pollutant emissions and noise generated by construction activities, as well as traffic generated from development when added to existing traffic, as significant and unavoidable impacts. Aesthetics, cultural resources, hazardous materials, land use and planning, noise, and public services and utilities were cited as impacts less than significant.

According to the March 24 Planning Commission Report, "there has been discussion for development of the T-1 parcels for a variety of uses including parking, bus-only lane, bike path separated from traffic lanes, a green belt or other transportation use, [but] the City Council has not acquired the land or stated any policies that would exercise any of these considerations. Any development of the subject parcels with structures would severely limit future City acquisition and use of the parcels." However, the report cites a lack of a plan or policy direction that would indicate the city's interest in acquiring the land.

The report says that because of the three

parcels' location near Beverly Hills' western boundary, the "Commission may wish to consider whether development of the site should be representative of a major entrance to the City." Considerations for the area could include iconic architecture, mass and scale, proposed use, relationship to Little Santa Monica, and relationship to adjacent land uses across North Santa Monica Boulevard.

The next step will be a liaison meeting between the Planning Commission and City Council.

"There are many variables we want to study and look at and get some direction from City Council," Yukelson said. "Once we get some direction we're going to have staff study and make a proposal. One of the considerations is overlay zone for those parcels. With overlay we could create zoning just specifically tailored for those parcels."

A zoning overlay could be established to incorporate specific goals, objectives and development standards, similar to the city's other overlay zones, the report says. The Planning Commission could specify setback requirements, height limitations, floor to area ratios and other specifications, that the City Council would then consider for approval at a future meeting. The date of the meeting is to be determined.

"This is an important gateway to our city, so it makes sense to try to redevelop it and make it into something beautiful and beneficial to the city," Yukelson said. "Overlay zone may allow us a compromise. We may be able to shape the project so it's not as overwhelming for that site."

Planning Commission approves medical office building on San Vicente

On March 24, the Beverly Hills Planning Commission unanimously voted to allow construction of a three-story, 32,450-square-foot medical/general office building with three levels of subterranean parking at 119-123 San Vicente Boulevard, just north of Wilshire Boulevard.

The Planning Commission approved the project last October, but an appeal was filed on behalf of a neighboring apartment building and the project was sent to City Council for a decision. Before the City Council could consider the resolution, the applicant revised the project, and the matter was remanded to the Planning Commission for consideration.

"I was very pleased," Planning Commission Chair Dan Yukelson said. "The developer had a great willingness to work through the process, went through the appeal. Really, a good neighbor policy is always best. [The developer] was able to work out whatever issues there were with the owner of the apartment building next door. [The developer] brought back a less impactful project to the neighborhood."

Revisions to the project included scaling back square footage by 7,600 feet, eliminating one level of the subterranean garage, and incorporating a large setback for upper floors along the southern property line.

Project plans will be reviewed by the Architectural Commission at a future meeting.

Developer announces 39-story condominium project near Beverly High

On March 24, Los Angeles City Councilmember Paul Koretz joined developers and neighbors to announce plan details for luxury condominiums at 10000 Santa Monica Blvd., which is located about a quarter mile from Beverly High.

The developer, 10000 Santa Monica LLC headed by Casey Klein, has proposed a 39-story, 469,575-square-foot residential-only condominium development, containing 283 units. Miami-based Crescent Heights, one of the developer's investors, acquired the land from SunCal Companies, which had previously proposed a larger project.

"The 10000 Santa Monica condominium project that we are here to discuss represents the best kind of planning process—one that, throughout, has been full of community input and collaborative decision-making," Koretz said in a statement at a press conference at Los Angeles InterContinental Hotel in Century City. "It is estimated that 10000 Santa Monica will generate more than \$300 million in regional economic activity and that it will create close to 2,000 construction and construction-related jobs, and that is mighty good medicine for our city when we're all facing a still rough and gloomy economy."

According to developer representatives, the

building will be LEED-certified, provide more than one acre of green open space and offer housing that is more affordable than comparable condominiums in Century City.

"How you benefit a community with this type of development is you create a jobs-housing balance," project spokesperson Steven Afriat said. "People who work [in the area] will be able to afford to live [there]. You'll have people walking and biking to work in a way you haven't seen before in Century City."

According to Afriat, representatives from nine nearby Los Angeles homeowners associations were involved in the proposal plans. Comstock Hills Homeowners Association President Jan Reichmann, who spoke at the press conference, was invited to meet the developer and offer ideas regarding architecture and design.

"What I like about the building is number one, the design is elegant," Reichmann said. "It's green and also it's considerably smaller than [the building that was going to go up]. It's 100 percent residential, which means no

Consequently, the Project will be reviewed by the City Council.

This Project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City has determined that the Project will not have a significant environmental impact and is exempt from CEQA pursuant to Section 15301, 15302, and 15332 of Title 14 of the California Code of Regulations.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. traffic from any kinds of stores or retail."

Reichmann added, "This is the best design for a new building I've seen in years."

Ken Goldman, President of the Southwest Homeowners Association in Beverly Hills, expressed concern about the size of the development and potential traffic impacts.

"In light of a residential area, a block away in which there are two-, maybe three-story apartments, in light of the high school where there's maybe three or four stories, in light of the commercial area adjacent to it on Little Santa Monica with two stories, having [39] stories seems absurdly out of scale and out of place," Goldman said.

The next step for the project is drafting an environmental impact report. Public hearings scheduled by the Los Angeles Planning Department will follow.

"I would hope that the city of Los Angeles would be neighborly and would recognize that the residents and business people to the east of the project, half a block away, need the same consideration that the LA City Council would give to their own residents," Goldman said. "I would hope there would be some great cooperation, I would hope that Beverly Hills City Council and Board of Education would take a very active role in this."

Former superintendent steps down as Nantucket superintendent

Former BHUSD superintendent Robert Pellicone stepped down as superintendent of Nantucket Public Schools on July 1, 2010 after five years with the district.

He told The Morning Noon & Night Show in



September 2009 that his contract would not be renewed.

"I don't want to renew, I want to move on," Pellicone said. "My spouse is in New York. It was a family decision, we decided about a year ago we want to do something differ-

ent."

On the show, Pellicone talked about what he wanted his legacy to be.

"Accountability, fixing things," Pellicone said. "I came here to fix things, certification was a big issue in 2005. We have a new administrative team in place, great people working here."

Pellicone had a controversial reign as BHUSD superintendent from 1998-1999. After he was terminated by the Board of Education, he sued, alleging wrongful termination and discrimination based on sexual orientation.

Beverly Hills subway route discussed at Metro meeting

Community members who spoke at Tuesday night's Metro Westside Subway Extension Community Meeting shared a range of opinions about the alignment of the subway as it travels through Beverly Hills.

Metro is in the planning process of nine miles of subway extension that will add seven stations, after the current Wilshire/Western stop, extending to Westwood near the VA

The proposed station in Century City is a point of contention for some Beverly Hills residents. There are two options under consideration for a Century City station west of a proposed stop in Beverly Hills at Wilshire Boulevard and Rodeo Drive. One possibility is a station at Constellation Boulevard and Avenue of the Stars. Some Beverly Hills residents oppose this option because it would require tunneling under Beverly High.

The second option is a station at Santa Monica Boulevard and Avenue of the Stars. Geotechnical and fault investigations continue, as this station is located near the Santa Monica Fault. Metro is also looking at locating the station box at Santa Monica Boulevard and Century Park East, which may allow the station to be located outside the fault zone.

Councilmember John Mirisch was first to speak during the public comments portion of the meeting. He voiced support of the Santa Monica Boulevard station, and in light of Metro's recent announcement of reduced bus service, expressed the need for park and ride at stations.

"Metro is reducing bus service, which means access to actual subway stations is going to be decreased," Mirisch said. "That makes it more important for residents to be able to take advantage of this multibillion-dollar public works project through having better access. The best way is if there is extensive park and ride at some of the stations."

Mirisch also mentioned the need for multiple station entrances.

"In general, I think there should be more than one portal at each station," Mirisch said. "It's not only a matter of convenience, but also making the whole system as effective as possible. Metro is suggesting they want to learn from experiences of subways throughout the world. As someone who in the past regularly made use of subways in different cities, I think that most efficient systems have multiple entries and exits."

During her presentation, Jody Litvak of Metro explained that Metro will build and pay for one portal at each station, except for Westwood/UCLA because of high potential boardings at that station.

"Stations are going to be designed with what are called knockout panels, so adja-

cent property owners if they wanted to, at their expense, could connect in," Litvak said. "Many property owners find that very beneficial to do. We will build and pay for one portal everywhere, save Westwood/UCLA where we will do two and then we'll see from there."

Nick Leathers, a student at USC, voiced support for the station at Constellation Boulevard

"For my generation, convenience is the most important thing for mass transit," Leathers said. "People my age don't like to do anything that's hard, so if it's hard they won't use it. For mass transit, if it's easy to use, they'll use it."

Hollywood resident Alexander Friedman also supports the station at Constellation.

"I'm disappointed with the way the Beverly Hills residents have a strange mentality that the subway will destroy everything," Friedman said. "It's the 21st century and technology allows to build safely without damage, without causing any noise or vibration. This is not New York City where the subway tunnels are built directly under the street. This is LA, where tunnels are built more than 100 feet below the residences."

Ken Goldman, Beverly Hills resident and President of the Southwest Homeowners Association, supports the subway project, but opposes the station at Constellation.

"Simply in doing research, I have found four instances over the last few years in four cities around the world in which modern boring equipment has caused property damage and death," Goldman said. "Accidents and construction defects can happen. Why put a subway under a school of 2,500 students and teachers there five days a week, as well as residents over the weekend and at night, when you can put a subway under a public roadway, where it belongs?"

Beverly Hills resident Victor Moss expressed opposition to the subway extension project in any form.

"Stop the project now," Moss said. "If you insist on drilling under the high school, we will get a petition."

Mirisch said he hopes for cooperation between Metro and the community.

"I hope that Metro does take into account our concerns," Mirisch said. "We need to have the community continue to be involved mov-

ing forward."

The next round of community meetings is scheduled to take place later this year. Preliminary construction is expected to begin in 2012.

Board of Eeducation votes not to reduce consulting services

The BHUSD Board of Education unanimously rejected a resolution to reduce consulting services in the areas of information technology and child, welfare and attendance at the regular Board meeting on March 23.

"[Board President] Lisa [Korbatov] and I have spent a lot of time traveling on the East Coast touring school districts that have fully integrated technology into their curriculum and classrooms," Board Vice President Brian Goldberg said. "We're not going to be able to do that in Beverly Hills unless we have the individuals and infrastructure in place to support that."

Had the resolution been approved, the district would have saved approximately \$160,000 by eliminating one child, welfare and attendance consultant and reducing two information technology consulting positions by 50 percent.

The Board also discussed reorganization of adult education and zero based budgeting, and approved the Board of Education election, which will take place on Nov. 8.

The three seats up for election are those of Steven Fenton, Goldberg and Myra Lurie. Goldberg has announced he will seek reelection, whereas Fenton and Lurie have said they will not run.

The Board discussed possible reductions to the adult education program, in order to reallocate funds to K-12 education.

"In these difficult financial times, we need to look at every source of available funds," said Alex Cherniss, Assistant Superintendent of Business Services. "Unfortunately, this means that some programs may be reduced. We're going to look at a plan to bring our best recommendation as to what our adult education program should look like next year."

Assistant Superintendent of Human Resources Dawnalyn Murakawa-Leopard said that reductions to the program are likely.

"It's possible [ESL] will be the only component of the adult school program that will remain," Murakawa-Leopard said. "The current ESL program may be reduced from what it is now.'

The zero-based budget discussion was brief because the board will bring in expert Ron Bennett from Schools For Sound Finance for a study session on the topic. It will be held on April 7 at 3:30 p.m. in the EDC room in the Science & Technology Center at Beverly High.

A resolution regarding layoffs of classified personnel was pulled by the staff to accommodate possible changes to adult education.

"We are going to revise it and bring a comprehensive [resolution] at the next meeting," Murakawa-Leopard said. "We wanted to make sure we thought through all implications of [the Board's discussion of adult education] and that we have a good picture of what the district will look like next year."

The resolution, if approved, would have eliminated one senior secretary of educational services at the K-12 level and one adult or alternative education clerk, and reduced the hours of one purchasing assistant and one adult or alternative education senior clerk.

City furloughs cancelled for April 1

The Beverly Hills Firemen's Association has offered to contribute funds that will cover \$250,000 to \$270,000 in savings from furlough days scheduled for April 1, May 6 and June 3.

"[City employees] are at work giving a service to the community," Beverly Hills Firemen's Association Treasurer Dave Perusse said. "We thought it was a decision we had to make not only for employees, but for the community as well."

The furlough day on Friday, April 1 has been cancelled and the City Council will consider the offer at a formal meeting on April 5. The three furlough days were scheduled to help balance the budget.

Although these are the first city furloughs of Perusse's 16-year career, it's not the first time the Beverly Hills Firemen's Association has offered to help the City's budget.

"About five years ago we opted to go to a less expensive family medical benefits plan so the city would save additional dollars for that," Perusse said.

Report reveals mismanagement of BHUSD food services

A report presented at the Board of Education meeting on March 23 revealed significant management problems with BHUSD's food services department. The district invited the Fiscal Crisis & Management Assistance Team, which prepared the report, to visit the district on January 10 and 11. Debi Deal of FCMAT presented the findings.

"We brought in FCMAT because we knew food services was losing money," Board of Education Vice President Brian Goldberg said. "[Food services has been] a drain and encroachment on the general fund, taking money out of the classroom by subsidizing the food service program."

The report cites a number of areas that need improvement, including cash handling procedures, record-keeping, menu planning and nutrient analysis compliance with federal or state guidelines, low student participation, and efficiency. The report also provided recommendations for improving food service operations.

"The FCMAT team said this is the worst situation of the 850 reviews they've done in the state of California," Goldberg said.

The report revealed that BHUSD's meal preparation efficiency lags far behind the industry average of 30 meals per labor hour. Meals per labor hour is a tool used to calculate appropriate staffing levels compared with the total number of meals served each day. During a three-month period in 2010, Beverly High averaged 3 MPLH, and the K-8 schools averaged between 10 and 14 MPLH.

The report recommends hiring a full-time director of food services to improve "oversight and communication between food service staff and the district office manager." Another consideration would convert the K-8 schools into satellite kitchens that receive food prepared at Beverly High.

"If we're going to follow the FCMAT recommendations, we can't pick and choose which ones we want to follow," said Alex Cherniss, Assistant Superintendent of Business Services. "They laid out a template for how to improve our program. Having someone as a

full-time food services director is part of their recommendation. I think the board should seriously consider it."

Goldberg said he would not vote for adding a food services director.

"We are looking at finding creative and out of the box solutions to providing free or reduced lunch meals [which is required by state and federal law]," Goldberg said. "Several charter schools around us have to address the same issue without having a full kitchen. They've been able to find companies that bring that in for those students, that comply with state and federal requirements."


Of the six percent of district students that qualify for the National School Lunch Program, only 43 percent are currently participating, the report says.

Cherniss said the district is considering contracting with FCMAT for ongoing consulting services. Last summer, the district reduced hours for 10 food services employees, and is in the process of eliminating nine food services positions that will go into effect on

"All the internal control issues have been resolved on FCMAT recommendations," Cherniss said. "Our concern right now is becoming a more productive program. As hard as it is to have an independent body audit a program and reveal shortcomings, I applaud the Board of Education for taking that on and the staff for being willing to accept the recommendations and move forward."

Christian Fuhrer named Horace Mann interim assistant principal

Horace Mann technology teacher Christian Fuhrer will fill in as interim assistant principal while Dana Findley is on maternity leave. The Board of Education approved Fuhrer's appointment on March 23 at a regular meeting.



deserving of this," Principal Steve Kessler said. "He has put in the time and the effort. He has been our interim administrator when one of us had to attend a meeting. He was our go-to person

because he has his administrative credential and he will a have seamless transition."

During his nine years at Horace Mann, Fuhrer has taught technology, media arts, yearbook and served as the school's Technology Site Co-Coordinator. He has coordinated the middle school's outdoor education program for the last seven years. Last year, Fuhrer was a member of the inaugural Bosse Leadership Academy, which was created to grow leaders from within BHUSD.

Fuhrer holds a Master's degree in educational leadership and policy studies from California State University, Northridge. His wife, Christy, is a first grade teacher at Horace Mann and son Lucas is in second grade at Horace Mann.

Some early winners By Rudy Cole

Arch Ward, the greatest sports writer who ever wrote for a terrible newspaper, the Col. **Robert R. McCormick**-era *Chicago Tribune*, had a continuing note in his Wake of the News Column: "The Wake Upon its Friends Depends."

Our "Best of Beverly Hills" series really did depend on our readers, and we are grateful so many people took the time and the interest to nominate businesses and people for consideration.

Not too surprisingly, restaurants created the most interest. Readers opted for favorites generally, and by category. After restaurants, the small service stores were next. Surprise: Not one reader suggested any of our major department stores on Wilshire and very few Rodeo Drive retailers

A word about the process: Receiving the most votes mattered, and almost every business mentioned received a nomination by e-mail. However, I also canvassed some long-time residents, including heavy and more moderate spenders.

Winners in each category will receive an emblem: "Best in Beverly Hills by Beverly Hills Weekly." Unlike some other similar promotions, nominees were not asked to buy advertising. However, one reader did suggest I could benefit personally from the services of a makeup artist. Should I mark that as a friendly thought?

This week, first results, with more each week, and then a final tabulation and report. This is no formal, highly structured election so, yes, your nominations will still matter.

Most votes in any category: Spago, restaurants, and **Wolfgang Puck** for best restaurateur. As **Fred Hayman** said, "my all-time favorite for food, service, ambiance and sophistication." Before Mr.

Beverly Hills (Hayman) forever changed the fragrance industry and helped create Rodeo Drive, he was heavily involved in the food industry, first as food and beverage manager of the Beverly Hilton when it opened and later as owner of diners in the Los Angeles area.

What we also like about Spago is the genial and efficient front-desk welcoming staff and watching visitors' faces when they see Wolfgang Puck coming to their table. Big-name entertainment industry types commingle with the special event patrons. We spotted former Los Angeles area big-name political leaders **Mike Roos** and **Robert Hertzberg** at separate tables recently.

Best Deli: No real competition, but for the record, second number of mentions as best restaurant, first in deli category, Nate 'n Al's. **Larry King** may be the face of another deli type eatery, but here is where he does his lox and eggs almost every morning. (And how we miss his interview show. Compared to what? His anemic replacement.)

This iconic diner, with the traditionally testy servers and a policy of not taking reservations, still has the finest chicken soup (try the Chicken in the Pot for a complete, what mother would have made, experience) and brisket of beef. County Supervisor **Zev Yaroslavsky** is a regular. Maybe the food will mellow him on the subway route – couldn't hurt.

Best Makeup Studio: Second only to Spago in total votes in all categories is **Bobbe Joy Dawson**, the makeup artist who recently moved from South Beverly Drive to North Bedford. Dozens of readers not only sent endorsements, most waxed (and seldom has that adjective use been more fitting) enthusiastically about her many beauty related services.

One fan, **Jane Mintz Schwab**, sent a second e-mail because she was concerned her original message might not have made it clear she was writing about the Bobbe Joy Dawson Makeup Studio. Reader Mintz had high praise for the studio's work with eyebrows.

Real estate professional **Brooke Mandile**, another Dawson fan, writes that following a visit "to have my makeup done, people are telling me I look ten years younger! There is no better testimonial."

Another rave came from **Jennifer Castellanos** who boosted Dawson's for her expert "makeup and brow skills and great line of products" and also her "super personality" and dedication to the community. Client **Valerie Sans** appreciates Bobbe for her work and also her "makeup lessons." Sans says she has been a customer for "many years."

Many more nominations for Dawson that we will use in our wrap of winners, but this is not in my field of expertise, if I have any, so we are using names of real people to describe their experiences. (Fans also nominated other make up stu-

dios, and we will mention some later, but none had as many votes as Dawson.)

Back to Restaurants:

Most civilized nighttime dining experience: The quiet elegance and careful attention to detail of the Belvedere at the Peninsula, makes this restaurant the winner in a special category of most civilized and elegant.

(It is also open for breakfast and luncheons, but it takes on a very special sophistication for dinner when the lights are lower and, no matter how busy, you can actually hear yourself talk. A **Sooky and Sam Goldman** favorite, we recently saw **Lea Cordova Latta** with her son, former State Senator **Ron Cordova**, at a main room table.

Best Indian Food; Bombay Palace, 8690 Wilshire, leads the field. A very comfortable room, friendly family service and the traditional luncheon buffet, priced very moderately, makes this a fan favorite. This interestingly designed, standalone eatery has survived for decades in an area that has had continuing turnovers of some once very popular restaurants.

Some others with many votes:

Best French: Bouchon, elegant, well managed, professional servers, just north of Montage Beverly Hills.

Best Family Operations: We had to create that category for the many readers who divided their votes for the four Drago owned restaurants in Beverly Hills. (The brothers also have eateries in surrounding communities.) Of the many options, most readers seemed to prefer Il Pastaio on North Beverly where master Italian chef **Giacomino Drago** performs his magic.

Other Italian diners with votes were Caffe Roma: great food and servers, most comfortable outdoor dining area. There were also votes for other Italian restaurants, listed next week.

Best Steak House: No clear winners yet, but among those nominated:

Ruth's Chris Steak House on South Beverly Drive. Excellent choice of steaks, often spotty service. Wolfgang's, and how often do we have to mention this north Canon eatery has no connection with Puck, but there is still some confusion. Good quality, but the quantity is overwhelming. Long, comfortable bar with personality-loaded mixologist. Speaking of Puck, his "Cut" at the Beverly Wilshire, although pricey, has created a very strong fan base.

My personal favorite, of course, closed recently: "Porterhouse." When it first opened years ago, the eating habits of Los Angeles were turning against high calorie steaks. Just when that began to reverse, dozens of competitors arrived. The location and neighborhood parking issues didn't help, but their building once housed one of the most successful and moderate priced restaurants in Beverly Hills, the long running "Andre's." There have been many incarnations since they closed, and who knows, maybe a real American style, family, moderate priced diner will reopen the venue.

Best New York Style: "The Grill on the Alley" is as close as you can come to a Manhattan experience in Beverly Hills. Next to Spago, this restaurant prob-

Best Chinese: No contest, most readers mentioned Xian on North Canon.

Most Customer-friendly Informal Dining: Circa 55 at the Beverly Hilton with options for indoor or pool service. Best breakfast every morning and best brunch buffet on Sundays. Great wait staff, and selections.

More restaurants next week including nominations for best servers, best captains and bar tenders.



In a change from prior policy, resident students must enroll by May 16 in order to be guaranteed a seat at their home BHUSD school for the 2011-2012 school year. The

decision was made at the Board of Education meeting on March 23.

In previous years, the deadline was June 30. The May 16 deadline will allow the district additional time to plan and ensure that schools are staffed appropriately.

Resident families with school-aged children who are planning to enroll in BHUSD schools for the 2011-2012 school year are encouraged to enroll as soon as possible, as the K-8 schools have a limited capacity at each grade level. Students who enroll in their neighborhood school after May 16 may be assigned to another district school with available space. The district has requested that community members pass this information along to resident families with school-aged children.

Enrollment for the 2011-2012 school year is now open at all five schools in the district. The five schools, their locations and their registration hours are as follows.

VAPA teachers learn to play the ukulele from fellow teacher

Recently, Horace Mann music teacher Ethan Smith was given an unusual assignment. He was asked to teach fellow visual and performing arts (VAPA) teachers how to play the ukulele during BHUSD's professional development day on March 21.

"We brought ukuleles and handed them out to the teachers," Smith said. "I described a way in which I teach the kids the ukulele. I did the same with them. We all sang some songs and played on the ukulele. It was fun, but it was also about, a teacher can teach other teachers something."

Approximately 20 teachers participated in the ukulele workshop that took place as a trial run for a future district-wide workshop that allows VAPA teachers to teach nonarts teachers. The ukuleles were provided by Smith and Hawthorne music specialist Christa Gutheinz.

BHUSD VAPA Coordinator Deb Joseph said even as a visual communication and design teacher, playing the ukulele is a different discipline.

"I'm intrigued by using music to transition from one activity to another and different ways of changing up the environment in the room," Joseph said. "There are many ways that the arts could be integrated into other classes, and generalist classes as well. You could be teaching anything, it really doesn't matter. People who have the passion for something can integrate that into the curriculum and add dimension."

Smith says he uses his ukulele every day with his students, and teaches beginning and advanced ukulele classes to fourth and fifth grade students. When interviewing for his teaching job he was asked if he could bring along a guitar, but he brought a ukulele.

"It's great especially for younger kids because with [their] smaller voices, a big guitar can overwhelm them," Smith said. "I think it's better for them to sing with in a lot of ways. It does so many great things for kids' learning. [They] learn so much about music through it, including chord progressions, time signature, beat and rhythm."

Joseph said learning a new discipline gives teachers a different perspective.

"One of our teachers pointed out that it reminds you of doing something for the first time again, something that's outside your realm," Joseph said. "It reminds you of how that feels, makes you more empathetic. You're back at the beginning of learning a new task [which is] where your students are all the time."




