Sophomore dies after collapsing on Beverly High campus



Hundreds of Beverly High students gathered on the school's front lawn Sunday afternoon to light candles, lay flowers and join together in remembrance of sophomore Elena

Natanzadeh,

who died Friday after collapsing on campus. The cause of her death remains unknown.

According to a BHUSD press release, Natanzadeh collapsed on campus Friday morning "due to what appeared to be a medical condition." Superintendent Gary Woods said Natanzadeh collapsed while "walking from one side of campus to the other." She reportedly collapsed on the stairs leading up from the swim gym.

According to Lt. Tony Lee, emergency response fielded one call from the school district at 8:59 a.m. Friday. Both the Beverly Hills police and fire departments responded and were there "probably within two minutes of the call," Lee said. Deputy Fire Chief Mark Embrey said the first call was received at the fire station at 9 a.m. and first responders arrived at the high school at 9:05 a.m.

"Interventions were given to her immediately, 911 was called immediately, emergency personnel arrived within minutes," Woods said. "All appropriate medical attention was given to our student in a very timely manner."

The press release said Natanzadeh was transported to a local hospital within minutes, but medical personnel were unable to revive her. Embrey said paramedics left Beverly High with the patient at 9:21 a.m.

"She was transported very quickly," Woods said. "We had a school staff member [Assistant Principal Toni Staser] in the ambulance along with emergency personnel. The school principal [Carter Paysinger] followed behind."

According to Lee, there were witnesses. Woods said the district worked with a number of officers and detectives for several hours after the incident.

"We have and will cooperate fully with any investigation that might occur," Woods said.

Students, parents, teachers, administrators and school board members gathered in silence, placing candles and flowers around a tree adjacent to the tennis courts where

the less developed west end. Why lose all that business to Century City?

We all care about what's best for the entire City and its commuting public. It should be about ridership and safety. That points to Constellation, not Century the memorial was set up Sunday afternoon. Many dressed in purple, Natanzadeh's favorite color. Around 4 p.m., students were asked to light a candle in Natanzadeh's honor. A rabbi encouraged students to perform an act of kindness in her name.

The memorial was interrupted when a woman collapsed on the sidewalk in front of the high school. She was transported from the high school in an ambulance.

"We have a number of students that were really impacted by this event," Woods said. "So we're working with parents, working with kids, working with staff in trying to help with the grief right now."

Grief counselors have been available to students on campus since last Friday, and Woods said they would be available as long as necessary.

Natanzadeh's funeral took place on Tuesday at Eden Memorial Park. On a Facebook memorial page devoted to Elena, her brother Omid Tony Natanzadeh encouraged all family, friends and loved ones to attend. Woods, Paysinger, Staser, Board member Myra Lurie and several other faculty and staff members attended the funeral, Woods said.

Many friends who posted on the Facebook page commented on Natanzadeh's bright smile.

Daniel Panahi, who identified himself as Elena's locker buddy, wrote, "[I] will never forget the smile on your face when I would see you. You made the world a happier place just by your presence, and it will never be the same without you."

Chaliz Taghdis shared personal memories of friendship with Natanzadeh, who graduated from Beverly Vista in 2010.

"Elena, you were one of my best friends and I'll miss you so much and those amazing conversations we used to have," Taghdis wrote. "You're one of the funniest people I know and I will remember you forever."

Liora Eghbali commented on the significance of Sunday's memorial.

"Elena babe, when I was standing there looking at all the candles and flowers with everybody that cares about you it made me realize that you were really such an angel and we're all going to miss you so much," Eghbali wrote.

Los Angeles County Coroner's spokesperson Ed Winter did not return phone calls from the *Weekly*.

Beverly Hills to send employees to Bell on City's dime

In a 3-2 consensus, the City Council directed City Manager Jeff Kolin to move forward with plans to deploy Beverly Hills City employees to provide short-term assistance to the City of Bell. The City Council discussed the matter at the request of Councilmember John Mirisch.

"This is not for me and never was just a matter about the fiscal costs," Mirisch said. "This is a matter in my opinion of policy and

Mirisch said he brought up the topic because it appeared Kolin planned to offer assistance to Bell without city council approval. The ensuing discussion not only addressed whether councilmembers thought sending employees to Bell was a good idea, but also whether it was within Kolin's purview to decide. Three councilmembers believed the decision was within Kolin's authority, but Mirisch and Bosse disagreed.

Mirisch asked Kolin what he meant when he told the *Weekly* in issue #623 that the decision was within his authority in terms of the fiscal impact, which the staff report stated was "not expected to exceed \$10,000."



"My authority currently is \$50,000 for contracts. for public works contracts. \$100,000," Kolin said. "You've entrusted me with the allocation and direction of city staff within the city.

I think it is common for city managers to respond to requests for assistance for mutual aid in this fashion."

Mirisch asked if Kolin was suggesting he could spend up to \$50,000 without council approval, to which Kolin responded, "Yes, that's correct."

Mirisch continued: "If you want to buy

\$50,000 worth of Darth Vader masks and give them to Toys For Tots, that's okay?"

Kolin said common sense should be applied. When Mirisch asked if it would be okay to give money to worthy causes such as Jerry's Kids for muscular dystrophy without city council approval, Kolin said, "I think I would come to the council to ask for direction in those examples."

Mirisch said he agreed Kolin had the authority within the city to provide services to residents, but when it comes to providing services for external customers that would be a policy issue. Bosse agreed.

"We absolutely do entrust you with our community and our city, \$50,000, \$100,000 every day, but I think from my perspective, it should be in our city," Bosse said.

Mirisch and Bosse also expressed concern about sending Beverly Hills' employees to Bell when Beverly Hills had its own challenges. Both supported sending employees who wanted to volunteer their time.

"I think we have our own PR issues to deal with in our community right now in terms of salary issues and frustration at how some of our departments are functioning. Of course if our employees want to do this on their own time, that is wonderful, but I think we need to fix our own community first and to take away staff members at this time is not the right timing," Bosse said she wrote in response to an e-mail from Kolin, who reportedly was initially considering offering "key employees" to Bell.

Councilmember Julian Gold said he trusted Kolin and did not want to micro-manage

his job.

"That's not to say I want to give up oversight and I do think that if there were to be an issue, that is something we would address and we do address as a council as we evaluate not only the city manager, but the rest of the city staff," Gold said.

Brucker agreed Kolin had the authority, and also said he supported sending employees to Bell.

"I thought it was a very magnanimous gesture on the part of the city manager on behalf of the city saying we're there to help support a brother city in need," Brucker said. "I think that we should look at this also as a regional issue, and one might think about if Bell does not get the help it needs to sustain itself, then [it] could fall in the hands of the County to take them over."

Kolin said he supported assisting Bell in the interest of restoring faith and trust in local government and the council-manager form of government. He said several management analysts and personnel from the IT Department have already expressed interest.

"I think both of those are excellent examples of areas where we could make shortterm loans of staff without impacting operations to the community," Kolin said.

Much of the work would be accomplished with shorts visits to the city, Kolin said.

"[Bell has] asked us to structure things so that in a day or two visit we can do assessments and return to our community, develop recommendations, reports, draft policies and procedures, review those remotely via conference calls or video conferences and then send that information and recommendations for them to use," Kolin said.

Police Officers' Association attorney confronts City Council about contract negotiations

In an unexpected move, Beverly Hills Police Officers' Association attorney Stephen Silver asked the city council to engage in a dialogue about the ongoing contract negotiations between the City and the Police Officers' Association at the city council meeting on Sept. 8. Silver addressed the council during the public comment section.

"I have been asked by my client to address some comments and inquiries to you and particularly to Councilmember [John] Mirisch," Silver said. "Where I'd like to start is the Police Officers' Association is very concerned about the position the City has been taking during these recent salary negotiations which appears to be very draconian. The City is pushing very hard for reductions in compensation that would exceed 10 percent for current officers and God knows how much for new hires."

Silver singled Mirisch out because he said Mirisch is viewed as the "moving force behind the position the City has been taking" in the contract negotiations. Silver also pointed out Mirisch has publicly stated the beating death of Kelly Thomas by the Fullerton Police in July is something that would never happen in Beverly Hills.

"With today's leadership and today's

composition of [the] police department, something like that never could happen [in Beverly Hills]," Silver said. "Isn't anyone a little bit worried if you reduce the compensation significantly of current officers [and] particularly for those whom you want to try to attract in the future, you might have a problem where you might not get the best people and might do some harm to the citizens of Beverly Hills? Has anybody thought about that before taking this position in negotiations?"

Silver's legal firm Silver, Hadden, Silver, Wexler & Levine represents the Fullerton Police Officers' Association.

All five councilmembers responded to Silver's comments, expressing appreciation and respect for the police and fire departments in Beverly Hills, but Mayor Barry Brucker explained it was "highly inappropriate" to address bargaining unit contract negotiations, which are conducted in closed session, during a public meeting.

"Please caution yourself about making any inference that this council or any citizen in this community doesn't have the absolute, most utmost respect and admiration for our police and fire and all of our employees here in the city of Beverly Hills," Brucker said. "We are lucky and proud to have them and we are grateful they are first to respond to protect us and save our lives."

Mirisch, who said he has tremendous respect for public safety and all City employees, addressed Silver's comments about the Fullerton police beating.

"I believe Kelly Thomas' beating that he referred to could not happen in Beverly Hills, but more importantly, it shouldn't happen anywhere," Mirisch said on Friday. Councilmember Lili Bosse said the city council would never do anything to compromise the safety of its residents.

Silver also singled Mirisch out for attending a "pension reform bootcamp."

"Did anybody besides Councilmember Mirisch attend this event sponsored by the Orange County Republican Party that was described by the sponsors as a pension bootcamp whose primary objective was to instruct interested people on how to reduce the pay of public employees as much as possible without violating any law?" Silver asked.

No other councilmembers attended.

"I wanted to clarify, in fact I think I gave a report to the council about having attended pension bootcamp," Mirisch said. "It's no secret that I did. It was actually run by Californians for Fiscal Responsibility, which is headed by Marcia Fritz, who happens to be a democrat."

Mirisch has been looking into pension reform as a member of the League of California Cities Employee Relations Policy Committee for the past two years. Mirisch said much of what was discussed at the conference, which he said was nonpartisan, was in line with a report on pension reform from the Little Hoover Commission and City Treasurer Eliot Finkel's Aug. 2 report to the city council on behalf of the Beverly Hills Pension Task Force about public safety pensions. Finkel announced public safety pensions are among the biggest long-term financial threats to the City. His recommendations included requiring employee contribution to pensions, setting a maximum pension of 65 percent of salary instead of 90 percent, and raising the retirement age from 50 to 55.

"[The Employee Relations Policy]

Committee came up with the conclusion that we have an issue in the state and we need to try and achieve fair and sustainable pensions and benefits," Mirisch told Silver.

Vice Mayor Willie Brien said he supports collective bargaining and holding negotiations in closed session, and was insulted and disappointed by Silver's tone. Councilmember Julian Gold said he, too, was disappointed.

Silver invited Mirisch and the rest of the council to the next negotiation session, which took place this past Monday.

"I would, but the council has a decision not to allow councilmembers to be part of those negotiations, which I have to respect," Mirisch said in a phone call. "We're going to negotiate this through collective bargaining, the way we always have."

Korbatov accuses Brucker and Brien of holding clandestine subway meetings

Board of Education President Lisa Korbatov, speaking for herself and not the board during the public comment session of the city council meeting on Sept. 8, accused Mayor Barry Brucker and Vice Mayor Willie Brien of interfering with the school district's efforts to prevent the Metro Westside Subway Extension from tunneling under Beverly High and holding clandestine meetings with Metro Board members without minutes or notes.

"I have grown accustomed that there is a shadow government in our midst where clandestine meetings are now routine," Korbatov said.

Brucker, who called Korbatov's comments "shocking," explained that some meetings have not been made public because Leahy canceled the first scheduled meeting after a reporter found out about it and wanted to attend.

No City funds were used for the memorial, which was paid for by funds raised by the Beverly Hills 9/11 Memorial Garden Committee.

the indignities and lack of respect to a new level" on Sept. 8 when they, along with City Manager Jeff Kolin, gave Metro Board member and Second District Los Angeles County Supervisor Mark Ridley-Thomas an "abbreviated" tour of the Beverly High campus "uninvited and unannounced."

"You had no experts, you had no evidence, except what you could repeat or what we gave you," Korbatov said. "This is our primary responsibility, not yours. We asked you for your help, not interference. Common courtesy and common respect for other elected officials would demand that you would inform us and consult with us before you took off like lone rangers to present whatever you presented."

Brien said there was nothing clandestine about the mid-day meeting with Ridley-Thomas. He said he was not required to inform the school board of the meeting, his group did not enter school grounds, and that the tour also included Century City to show Ridley-Thomas the potential benefits of the Santa Monica Boulevard alignment.

"When we sent the letter [to Metro] out [on Aug. 12] and it was approved by this council, we said we were still going to meet with elected officials and decision makers, and the mayor and I have continued to do that," Brien said. "We [were] supported by the council to continue to do that even though the feeling was we were making no progress."

Despite the apparent lack of progress, Brien said it was important to continue trying to convince Metro Board members to select the Santa Monica Boulevard subway alignment. "Two members of the council have valiantly tried to get the majority to support our efforts to defend our high school. The mayor and the vice mayor and [Councilmember] Dr. [Julian] Gold refused until very recently to defend our high school," Korbatov said. "The

recent letter sent to MTA is not backed by any money or any muscle."

The City Council's Aug. 12 letter to Leahy and Metro Chair and Los Angeles Mayor Antonio Villaraigosa states the city council's support of the Westside Subway Extension is predicated on the Santa Monica alignment and the subway not tunneling under Beverly High.

"Please don't think for a moment that simply because this council isn't throwing grenades out there at the Metro Board that our resolve and determination isn't as potent as every one of your determination out there," Brucker said.

Korbatov raised the issue again at the Board of Education meeting Tuesday night, to address a comment from Brien that she said suggested the Board was unable to schedule meetings with Metro decision makers.

"That's not true," Korbatov said, explaining that she, with the district's hired experts present, has had at least 20 meetings with decision makers and had three scheduled for this week. In addition, the school district has a team of lobbyists in Washington, D.C. who have been meeting about the subway.

Board member Myra Lurie said she wanted to distance herself from Korbatov's comments.

"I believe when we engage in vitriolic, disrespectful, emotional kinds of exchanges like that, all we do is degrade our position," Lurie said.

Vice President Brian Goldberg and Board member Steven Fenton supported Korbatov's message.

"We have asked repeatedly for the City Council to join us as they've joined us in previous issues about having a joint defense agreement, so we can share all of our information," Goldberg said. "As of today we have not received a response from the City."

Fenton suggested changing the school board and/or the City Council's representatives on the liaison committee or eliminating non-JPA joint meetings.

"In terms of having city-school liaison meetings, it's now a number of times where important issues are not discussed at these meetings and later come up after the fact," Fenton said. "I'm very concerned that these *briefs cont. on page 7*

Bigotry and history

It could have been terribly divisive, even ugly, this debate we were having about changing the city's rules on noise control, mostly meaning amplified sound, at parties in residential areas, but a carefully structured approach by the city council found an almost Solomon like

compromise that might just work. Of course, we are a very passionate community. From proposals for new hotels to creating street permit parking, we have been known to become as intense as fans of a Birmingham soccer team following a victory, or a loss. Just short of rioting or mass public intoxication.

In a real sense, partisans on both sides of this decision making process, and our whole council, should be congratulated for the display of restraint and reason that helped keep the city's public hearings free of bigotry and name calling.

For many years, the city rules on noise meant a somewhat unrealistic 6 p.m. enforcement hour. That will now be changed, if the council makes final new ordinances for later hours for weekdays and weekends.

Some background: First, this was not an attempt to limit private parties in homes, only the level of acceptable noise created by electronic devices and/or entertainers. Second, there were peripheral matters including limits on rental of homes for events. This too needs more study and regulation.

One of the major reasons why the "noise" and party issues have not risen to the level of creating deeper divisions in the community is the wise and professional behavior of our police department. City law enforcement responded to complaints in a conciliatory manner, working to assure compliance, carefully explaining the rules and impacts, and not just issuing citations. Most often, their methods were highly successful and residents were cooperative.

Then too there was the good neighbor behavior of a resident in the southwest, reported to the council by **Lori Goldman**. One of her neighbors notified her two weeks before a party that would have amplified sound, and asked her to call if there were problems.

Communities, inevitably, change and when they do, all kinds of social behavior alters too. From the design and size of homes to educational expectations to political loyalties seldom remain the same. In Beverly Hills that cultural alternation has included greater numbers of Persian and even Asian residents, most often visible in our schools. This cultural diversity has had some very positive benefits, not the least of which are in education.

Example: When our school age population began to decrease, with fewer residents with school age children, the arrival of Persian families with larger families actually saved the schools. When we were almost totally dependent on the state, and funding was based on ADA, average daily attendance, without these larger Persian families, we would have faced even more serious financial losses.

These younger families had more children of party giving age and, just as their parents, preferred later hours of entertainment, causing some friction with neighbors. The rules needed both understanding and modification. Hopefully, this is what the community, with the creative and positive leadership of the council, has now achieved. No, not perfect, but a move in the right direction that will increase and improve community relations.

The side issue that needs more regulation: Rentals of homes by outside interests for private parties. We have hotels for banquets and social events, they should not be inflicted in residential areas. This does not mean banning fund

Now, for some history lessons: Any signs of bigotry and intolerance this debate might have exposed pales enormously to what once was true about our community.

I am indebted to the late **Greta Furst** who once gave me a lecture on religious intolerance that was a part of our history. Greta, who had carefully chronicled the discriminatory time in Beverly Hills, listed these among many examples, all aimed at the growing new Jewish residents. (Yes, there were Jewish families, mostly from the entertainment industry, for several generations, but there was also both housing and social controls that were offensive.)

1. Many of the residential areas had restrictive covenants. Owners agreed not to sell their houses to Jewish families and other minority groups.

2. A country club on our borders, Los Angeles, had very strict limits on Jewish and minority membership. Leading, of course, to the formation of Hillcrest Country Club.

3. The anger over growth in the business district led to a hate crime sign on Saks while it was under construction. Vandals painted this sign on their wall, just prior to opening: "Jews Go Back to New York."

4. Civic organizations had gentlemen's agreements on number of members. At one point, Rotary limited members to three non-Christians.

5. Even the venerable Beverly Hills Bar Association had an "understanding." The office of bar president would be rotated each year between Jewish and Christian members, regardless of merit or ability. (Thanks to the great lawyer and ethicist **Louis M. Brown** for ending this when he was elected bar president.) Incidentally, it wasn't until the 1950s that blacks were accepted by the Los Angeles Bar Association.

6. Even the pro-business coalition that gained control of the Beverly Hills City Council had this kind of unwritten agreement that there would only be one Jewish councilmember. (The first was **David Tannenbaum**, no relation to a later member with a similar name.)

7. When "Church Row" was created north of Santa Monica Boulevard, not one Jewish house of worship was included. The same exclusion included our very large Christian Science community. This group created a large church on South Rexford and a mammoth private school on North Swall. (For later history buffs, the Christian Science church is now, of course, an Iranian-Jewish house of worship, somewhat ironic.)

Why is this history lesson important? It should remind us that change in our community demands understanding and, certainly, tolerance. Most of the community does live by those standards, and the sensitive approach to "noise" rules demonstrated that. Of course, good human and community relations has to be a cooperative effort including the reality that change is often positive and not divisive.

(This effort dedicated to the memory of Greta Furst. She was also an early advocate of the e-mail political intervention; hers were tough. Also, one part of the noise discussion included the passionate views of Dr. **Charles Aronberg**, a former mayor, who warned of the health hazards, and those have no nationality or ethnic connection.)

Josette and I attended the early morning services for the Beverly Hills 9/11 event but were not able to be there for the larger remembrance later in the afternoon. Many thanks to our first responders and city officials for making this happen, it was a very positive act of real community unity.

Long time resident **Maynard Brittan** emailed this note to tell me that this "was the most inspiring event ever" for our city. He was especially moved by the words of Mayor **Barry Brucker** and followed with:

"We attended the 9/11 memorial presentation on Sunday: So inspirational and moving. Our first responders, police and fire, were all spiffed up in their dress blues and spit shined shoes, and performed elaborate color guard formations. Also, because of the national terrorist threat warnings, the area was heavily guarded by armed SWAT team snipers along the roof top. Lots of drama and pomp, with a compelling and tear-jerking program. Incidentally, the steel framed memorial statue (featuring actual twin tower twisted scrap frame) was magnificent. All of our friends and neighbors who attended were uniformly impressed, and proud to be an American citizen from Beverly Hills."

meetings are becoming an exercise in futility."

The liaisons met Sept. 7, the day before the City's meeting with Ridley-Thomas, but the school board liaisons were not informed about the meeting.

Board member Jake Manaster encouraged his colleagues to view this as a "joining moment" for the district and City to better coordinate their efforts.

BHEA endorses Bilak, Goldberg and Licht; L.A. County Dems support Goldberg and Licht

BHEA, the BHUSD teachers union, has endorsed Frances Bilak, incumbent Brian Goldberg and Andy Licht for the 2011 Board of Education election.

"Brian Goldberg [has] got a track record that we value and appreciate, even if we don't always agree on every decision," BHEA President Mark Frenn said. "We do believe by and large Brian is moving the district in the right direction. That includes improving working conditions for teachers and support staff."

Frenn said Bilak displayed understanding of BHEA's needs and concerns related to working conditions and total compensation, and also seemed "motivated to make sure the district is handling its finances properly."

"She really struck us as somebody who understands the district, teachers, support staff, the bigger picture," Frenn said.

Licht appeared to be teacher-friendly and understanding of BHEA's situation regarding total compensation, and demonstrated familiarity with the district's Measure E program, Frenn said.

"[Licht] appears to understand that there could be some balance [on] the school board so meetings are a little more respectful of the community and of one another, [so the board] can focus on getting business done," Frenn said. "Based on how he carried himself we believe he could be a nice, calming influence there."

Although BHEA did not endorse Lewis Hall, the fourth candidate in the Nov. 8 election for three seats, Frenn said the panel enjoyed interviewing Hall. Frenn said it seemed Hall's "heart was in the right spot."

A panel of six BHEA members representing three bargaining units-certificated, instructional assistants, and office, technical and business services employeesinterviewed the four candidates Sept. 7. The representative council, consisting of the BHEA executive board and each site's representatives, voted on the endorsements Sept. 8.

On Tuesday, the Los Angeles County

Democratic Party announced they endorsed Goldberg and Licht, and did not endorse a third candidate.

\$2.5 million BHUSD budget surplus greater than expected

Based on the 2010-2011 actual budget, BHUSD finished the year with a \$2.5 million surplus and a reserve of more than 10 percent, Assistant Superintendent of Business Services Alex Cherniss announced Tuesday night at the Board of Education meeting.

The \$2.5 million surplus was approximately \$700,000 more than was projected, due to a \$360,000 reimbursement grant from the state for remediating an underground source tank at El Rodeo, \$185,000 in deferred funding for Beginning Teacher Support, \$80,000 in additional class size reduction funds, and other adjustments and cost savings. Cherniss said another \$140,000 is on its way from the state for the remediation effort.

'We've been as tight as possible in staffing-we're still in a hiring freeze; we try to cut costs as far as supplies, budgets, site budgets; and salaries are a big piece of this," Cherniss said on Wednesday. "It was really a joint effort to keep our expenditures down.'

Because of property tax revenue fluctuations, Cherniss said school business consultants recommend at least a 10 percent reserve for basic aid districts.

Board of Education Vice President Brian Goldberg said the reserve has doubled in part because the district is no longer budgeting for substantial losses from Adult Education or food services. The Board significantly reduced Adult Education and hired Chartwells as a contractor to provide food services this year. Earlier in the meeting, Facilities Consultant LaTanya Kirk reported the cafeteria food has been so popular, a common complaint has been the lines are too long.

"The other big item is the fact that we use natural attrition to reduce our overhead in the district without using layoffs, which lower morale" Goldberg said. "By closing positions, reassigning and redeploying teachers in more efficient and effective ways, we have been able to save more than \$2 million out of the operating budget."

Chris Bushée of BHEA recognized the board and district for their accomplishments with the budget.

"The multi-million dollar, double-digit percentage reserves shown in the latest BHUSD budget represent the confluence of three things: strategic decision-making; mutual trust among bargaining unit rep-

resentatives, the administration, and the Board; and a willingness to put mediumterm and long-term goals ahead of shortterm desires," Bushée said.

Despite the success, Bushée said the district needed to continue to be vigilant. Cherniss agreed.

"While we are extremely pleased as a district that our general fund reserve has doubled during this fiscal year, we are also extremely cautious regarding the current economic situation of the State of California, and are doing everything we can to anticipate further reductions in revenue from the State of California and potentially from our property tax revenue," Cherniss said.

Planning Commission recommends Trousdale View Restoration Ordinance Part II to City Council

The Planning Commission voted 4-1 to recommend Part II of the Trousdale Estates view restoration ordinance, which pertains to a discretionary process to assist property owners in restoring and maintaining views, to the City Council on Sept. 8.

Commissioner Nanette Cole, who voted no, said she was not opposed to a view restoration ordinance, but she was concerned about the City's involvement in the view restoration process and potential legal exposure to the City.

"There are other well established means for private parties to resolve their disputes, before any court action and without subjecting the City to ongoing obligations and liability," Cole said.

The Planning Commission worked on the ordinance for more than two years, but it was not until the meeting on Aug. 4 that a two-track process for the restoration permit process was considered, with one track leading to a non-binding city advisory opinion and the other leading to obtaining a view restoration permit by way of a hearing before the commission, if necessary.

The city advisory opinion was introduced as a less costly option than a view restoration permit for residents to seek the City's feedback on individual cases. The ordinance's indemnification language, recommended by the city attorney's office, requires the view owner to be responsible for any and all costs incurred by the City in enforcing any view restoration permit, except for costs of enforcement the City may recover from the

The task of updating the City's noise ordinance presented challenges and controversy, as Human Relations commissioners and City Councilmembers attempted to balance residents' need for quiet use and enjoyment of their homes and other residents' desire for flexibility to host parties in their homes.

The Beverly Hills City Council voted 4-1 on an ordinance Sept. 8 that prohibits amplified sound that is "distinctly audible beyond the property line" between 10 p.m. and 8 a.m. seven days a week, imposes fines of up to \$250 for the second violation and up to \$1,000 for subsequent violations, and prohibits the rental of private homes for commercial parties, except for events or activities in connection with non-profit or charity functions. The ordinance is expected to come back for a second reading at the Sept. 20 city council meeting.

Prior to the vote, the City's noise ordinance prohibited amplified sound after 6 p.m., but police began enforcement at 10 p.m. A second section of the municipal code permitted some types of noise until 10 p.m. Part of the City Council's task was reconciling the inconsistencies in the two code sections.

"Just as the [Human Relations] Commission was unable to come up with one deciding direction, not everybody is going to be happy, but we're hoping to have some kind of compromise and understanding," Councilmember Lili Bosse said before public comment and council deliberations commenced.

Councilmembers were not all in agreement, with Vice Mayor Willie Brien voting no. He said imposing fines might pit neighbors against neighbors, and he also expressed concern about changing the current ordinance to 10 p.m., because statistics showed that police receive noise complaint calls before 10 p.m. Brien emphasized the ordinance pertains only to amplified sound, and as long as neighbors are not disturbed, residents can host social gatherings in their homes at any time.

Southwest Homeowners Association President Ken Goldman addressed the City Council requesting no change to the current ordinance, but he said he was pleased the City Council had listened to the public comments in deciding to set the cut-off time for amplified sound at 10 p.m., seven days a week. The City Council-Human Relations Commission liaisons Bosse and Mayor Barry Brucker had recommended allowing amplified sound until 11 p.m. on Friday and Saturday.

"Listen, the enforcement time is 10 o'clock now. That's what they kept and that's just fine with me," Goldman said Sept. 9.

Two other resident association presidents—North Homeowners Association President and former Mayor Robert K. Tanenbaum and Municipal League President Thomas White—and many residents also urged the city council to make no changes to the current ordinance, with many citing the argument, "If it ain't broke, don't fix it."

Bosse explained representatives of the police department

told the council liaisons that if no change was made to the ordinance, police would have to enforce it at 6 p.m. and it would likely generate more calls to the police. Bosse pointed out the City has a general disturbance-of-the-peace ordinance in place that allows residents to call the police about "loud and unreasonable noise" 24 hours a day.

"The issue here tonight is whether or not we will have a city

that respects the values that have distinguished us and those values are about civility, respect and maturity, and realizing how we behave in our community," Tanenbaum said. "We do not play out every impulse. We edit our conduct so that we don't interfere with the rights of our neighbors."

In her presentation of the council liaisons' recommendation, Bosse announced the committee had taken public comment, the police department's current enforcement practice, and statistics of noise complaint phone calls fielded by the police into account. Bosse also said the liaisons received a petition to allow amplified sound until midnight on weekends with 520 signatures, and a petition to allow amplified sound until 1 a.m. on weekends and a permit process to allow amplified sound until 2 a.m. with 384 signatures.

"I hope you reconsider because the notion of petitions strikes me that if that's part of the equation, we need a referendum to remove this from you and let the people decide the question," Tanenbaum said.

White said he would accept a technical change so the police department's practice would fit the ordinance.

"It's working perfectly for a community of 34,000 people and we are getting along in a matter that is harmonious and equitable for every member of this community and every cultural group that comprises the wonderful breadth of our residential community," White said. "If you need to make a technical change to make the practice fit the ordinance, go ahead and do so."

Although the majority of speakers at last week's meeting opposed any change to the noise ordinance, three residents spoke in favor of extending the hours amplified sound is allowed to provide residents flexibility to host parties in their own homes.

"I believe consideration should go both ways," Kathy Afshani said. "If I'm considerate of my neighbor, my neighbor should be considerate of me. I've lived in my house now for 12 years, and I have had a total of two parties. I think I am entitled to have those two parties in 12 years."

Afshani said she once had a party where guests were sitting around telling jokes, and the police showed up.

"The policeman told me, 'You have really bad neighbors, because I couldn't even hear you and I was out in the street," Afshani said. "I think some of these calls are just meant to bother people. They're calling out of spite."

Afshani supported changing the ordinance to allow amplified sound until 11 p.m. and pushed for midnight on Friday and Saturday nights. Her husband Shahriar Afshani said it was limiting to end parties at 10 p.m.

"It is not the intent of anyone to have a party to create a nuisance for their neighbors," Shahriar said. "In fact, we go out of our way to make sure our neighbors are not affected. We extend them an invitation, we let them know what's going on, and we try to make it as easy and painless as possible."

The noise ordinance has been challenging since the Human Relations Commission took up the task of updating it in April, beginning with three public outreach meetings, and two meetings of deliberations.

One point of controversy relates to why the 50-year-old ordinance was brought before the city council in the first place. Tanenbaum said the issue was before the city council not in order to reconcile two conflicting sections of the municipal code, but because of "political cronyism."

"One of your members who's not here now wanted this for his voting bloc, pure and simple," Tanenbaum said. "The last thing we want to do in the community is have the perception of that kind of cronvism."

Then-Mayor Jimmy Delshad requested information about the ordinance in late November 2010, and the previous city council expressed support for reviewing the noise ordinance at that time, according to the Sept. 8 staff report.

Tanenbaum shared statistics obtained by Thomas White via a public records act request that revealed in a 10-year period from Oct 1, 2001 to Aug. 31, 2011 there have only been 15 citations issued for disturbance of the peace: six for radios or televisions that were too loud, six for noisy parties, and three for public disturbance. Bosse shared statistics of phone calls in a 121-day period earlier this year, during which there were 313 calls or 2.59 calls each day.

"Why would we do anything if only one percent of calls

foliage owner. The City Council directed the Planning Commission to make the ordinance cost-neutral to the City.

View owners would be required to wait 12 months after obtaining the non-binding city advisory opinion before applying for a view restoration permit, to avoid the possibility of the City issuing conflicting opinions.

"I think quite frankly there's enough items in the ordinance that will really encourage people to resolve their differences before it ever needs to get to the Planning Commission, let alone the City Council on appeal," Yukelson said.

With regard to the ordinance's "safe harbor plane," the Planning Commission recommended 14 feet as the maximum permitted height of foliage from the flat bed of the property. Fourteen feet is the maximum height of homes allowed in the area. At the last meeting, the commission considered a maximum height of 16 feet.

"We're very pleased about [the ordinance]," Yukelson said. "We've worked very diligently on this ordinance and we're all very happy to see something recommended to the City Council."

The City Council approved Part I of the ordinance, the code enforcement portion that set standards for fences and hedges, on Aug. 2.

Planning Commission forwards oil well drilling ordinance to City Council

The Planning Commission voted 3-0 Sept. 8 to recommend the oil well drilling ordinance, which prohibits drilling and extracting oil, gas and other hydrocarbon substances from surface locations in the City, to the City Council. Commission Chair Dan Yukelson and Commissioner Noah Furie recused themselves because they receive royalties from Venoco, the company in charge of oil well drilling operations at Beverly High.

"We were directed by the City Council to forward an ordinance to them, so our purview was fairly limited," Vice Chair Craig Corman said. "We were just looking to make sure it would conform with the general plan, which it does."

The oil well drilling ordinance does not prohibit slant drilling in Beverly Hills, but language in the ordinance prohibits any drilling beneath the City from originating at a site that is within 500 feet of a school or park property.

The previous City Council passed an urgency ordinance prohibiting oil well drilling in Beverly Hills in March. The ordinance will not affect the oil well drilling currently taking place on the Beverly High drill site, the last remaining surface oil drilling and extraction site in the City, but it will prevent the school district and city from extending Venoco's lease when it expires Dec. 31, 2016. The three-party agreement between the City, BHUSD and Venoco was signed in 1978.

City Manager Jeff Kolin told the school board at its June 28 meeting that the ordinance was motivated by concerns from community members and elected officials about oil drilling on the high school site. Kolin also told the school board the City had heard there was interest or potential that the school district might commence discussions with Venoco about a possible lease extension.

"In terms of policy-is it a good idea financially for the City and schools as well as residents?--that was not what we looked at," Corman said. "That's really a City Council decision.'

relate to noise?" Tanenbaum said.

The topic also created the perception of a community divide. Residents provided a wide range of feedback and the Human Relations Commission was unable to reach consensus to make a recommendation to the City Council. On weekdays, Vice Chair Barbara Linder and Commissioners Tom Pease and Ilona Sherman proposed 6 p.m., Commissioner Rochelle Ginsburg proposed 8 p.m. and Chair Sharona R. Nazarian and Commissioner Yar Meshkaty proposed 10 p.m. as the cut-off time for amplified sound. On weekends, Linder, Pease and Sherman proposed 10 p.m., Ginsburg proposed 11 p.m. and Nazarian and Meshkaty proposed midnight.

Nazarian said she was disappointed the commission did not reach consensus, but the votes were "an accurate reflection of the different views of the community."

Kathy Afshani said she hated that the issue became so divisive.

"I don't think parties are just relegated to Persians. No other culture has parties?" Afshani said. "I really hated hearing that. I'm sorry; it really offended me. One more thing I kept hearing is [this was a] policy of 50 years. We're not the same demographics as 50 years ago. There are younger people living here. We need to change the laws."

Goldman said the issue was purely about noise and not cultural difference. Former Board of Education President Mel Spitz expressed a similar point in his Sept. 8 letter to the City Council.

"You should determine whether the right of Beverly Hills residents and their children to quiet repose every night of the week is of higher priority than the right of neighbors to make noise late at night, regardless of their cultural heritage," Spitz wrote.

Bosse said the noise ordinance process made it clear education is needed in the community about showing consideration

operations.

for neighbors and preserving the City's quality of life.

"This issue brought so much divisiveness to this community," Bosse said. "It really broke my heart. I think this is a real defining moment as to who we are and what we are as a community.'

In the end, Bosse was correct: Residents had mixed reactions to the outcome.

Afshani said she was disappointed, and Tanenbaum said he is interested in pursuing a way to decide the noise issue at the ballot box.

"[If you] increase the time, you increase the noise intrusion on innocent residents who will become victims of loud and abusive noise," Tanenbaum said. "That is something that is contrary to the values of the people that live in the city. That being the case, I certainly with others, we are considering a way to bring this to the voters of our city so that they can participate and have their voices heard."

In contrast, Goldman declared, "Democracy works!" in a letter to Southwest Homeowners Association residents.

"Because a number of residents came to the City Council meeting last night, wrote and e-mailed and spoke up, the City Council voted to keep the 10 p.m. cut-off for amplified noise every day," Goldman wrote.

Public Works Commissioner Joe Shooshani, who did not speak but attended the Sept. 8 meeting, said he had hoped for a later cut-off time on weekends.

"I think the demographics of the city have changed and this reality should have been shown in the ordinance," Shooshani said. "There are more younger people now, more cosmopolitan people who think the city is not a sleepy village. The city is an urban area."

Despite Shooshani's desire for a later cut-off time on weekends, he said the "most important thing is we keep our city balanced and a good relationship between the citizens."

continue as city attorney at Hidden Hills.

Spencer Paysinger, a 2006 Beverly High graduate, made his National Football League debut Sunday, in the New York Giants 28-14 loss to the Washington Redskins at FedEx Field in Landover, Md. in the season opener for both teams.

Paysinger, a reserve linebacker and special teams player, did not record any statistics. He is the first Beverly Hills alumnus to play in the NFL since 1998 when offensive lineman Rick Cunningham ended an eight-season career in the league by playing in 12 games with the Oakland Raiders.

Paysinger said he was surprised to make the team.

"I know I had a few good games in the preseason," Paysinger said. "The coaches really liked me. Paysinger signed with the Giants as an undrafted rookie free agent. He said felt the odds were stacked against him.

"They did draft two other backers and they brought in another outside backer," said Paysinger, a son of Beverly High football coach Donald Paysinger and a nephew of Carter Paysinger, the school's principal.

"If it did come down to cutting a linebacker, they would probably just cut the undrafted person because they already put money and stake into the person they drafted."

Paysinger was among four rookie linebackers to make the Giants regular-season roster, joining Greg Jones, a fifth-round draft choice from Michigan State, Jacquian Williams, a sixth-round draft choice from South Florida and Mark Herzlich, a free agent from Boston College.

"The best thing that they did was play special teams," Coach Tom Coughlin said Sept. 3 as he announced the team's cuts. Coughlin went on to specifically praise Paysinger for making "a couple of nice physical plays," in an 18-17 victory over the New England Patriots Sept. 1 in the final preseason game for both teams.

ORDINANCE NO. 11-O-2612

AN UNCODIFIED ORDINANCE OF THE CITY OF BEVERLY HILLS EXTENDING THE TERM OF ONE MEMBER OF THE ARCHITECTURAL COMMISSION (FRAN COHEN)

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. The City Council finds:

In accordance with 1.1 the provisions of the Beverly Hills Municipal Code, the City Council duly appointed Fran Cohen to the Architectural Commission ("Commission") on August 3, 2005, to serve an initial term of two (2) vears.

1.2 In accordance with the provisions of the Beverly Hills Municipal Code, the City Council duly reappointed Commissioner Fran Cohen to a second term such that she would serve an additional four (4) years. Therefore, Commissioner Cohen's term expires on August 2, 2011. 1.3

Pursuant to Section 2-2.105(b), Architectural Commissioners who serve two (2) successive terms are not eligible for reappointment to the Commission, and, accordingly, Commissioner Cohen may not be reappointed to serve on the Commission. The City Council 1.4

desires to match Commissioner Cohen's term expiration with those of two other retiring commissioners. This would permit the future reduction of the Architectural Commission from seven to five members, while allowing all current members to complete their terms.

1.5 The City Council duly considered this matter at a noticed public meeting and finds that it would be in the best interest of the City to extend the term of Commissioner Cohen on the Commission to July 11, 2012.

<u>Section 2.</u>Notwithstanding the pro-visions of Section 2-2-105 of the Beverly Hills Municipal Code, the term of Commissioner Cohen shall be extended to July 11, 2012.

Section 3. To the extent necessary. this Ordinance amends the provisions of Beverly Hills Municipal Code, Title 2, Chapter 2, Article 1 to allow the City Council to extend the term of the Architectural Commissioner designated herein under the circumstances described in this Ordinance.

Section 4. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage, in accordance with Section 36933 of the Government Code; shall certify to the adoption of this Ordinance and shall cause this Ordinance and his certification, together with proof of publica-tion, to be entered in the Book of Ordinances of the Council of this City.
