Margo launches write-in school board campaign

Two days after Andy Licht dropped out of the Board of Education campaign, Beverly Vista PTA Co-President Noah Margo has jumped in. Margo filed the paperwork to become a

write-in candidate at the Los Angeles County Registrar-Recorder/County Clerk’s office last Friday. With Margo’s candidacy, there are four candidates for three seats in the Nov. 8 election.

“Months ago I had entertained the idea of running,” Margo said. “When Damien [Bean] and Andy [Licht] were on the slate I felt the school board had a pretty good collection of

people coming in. When they dropped out I thought it was necessary for someone with a little different insight to get into the race.”

Margo, who attended Beverly Vista and graduated from Beverly High in 1986, is married to 1987 Beverly High graduate Laura Hornwood Margo. Margo was elected Beverly Vista PTA president last spring after years of volunteering in his children’s classrooms.

“I attended the Beverly Hills schools during the height of their nationally renowned success,” Margo said. “My understanding both as a teacher and as a builder [is] vital to continue the board’s current vision of excellence.”

Margo said he thought serving on the board would be a natural extension of the 10 years he spent as a teacher. He was a substitute teacher for BHUSD and LAUSD for two years before teaching fourth and fifth grade for eight years at Hancock Park Elementary in Los Angeles.

“My favorite part about teaching is the effect you have on the individual,” Margo said. “There’s no better way to connect and have an impact on society than teaching.”

Now a property manager, Margo attended USC, where he earned his bachelor’s degree and Master’s degree in writing. After graduation he worked for the City of Beverly Hills in the Recreation and Parks Department before becoming an LAUSD teacher. Following his teaching career, Margo got his contractor’s license and became a residential homebuilder. Margo also performs with his father, Beverly Hills resident Phil Margo, in the band the Tokens, which is known for “The Lion Sleeps Tonight.”

Since PTA policy does not allow presidents to campaign for school board, Margo has stepped aside as president while he campaigns. Margo said he is grateful that Beverly Vista PTA Co-President Laurie Okum has stepped up to fill his position. If elected, Margo will be required to resign.

Margo said he was aware of the challenges of running a write-in campaign. With about six weeks until the election, Margo has roughly the same amount of time Mayor Barry Brucker had to run his successful write-in school board campaign in 1997.

"I have six weeks to teach voters to write Noah Margo in on their ballot," Margo said. "I have to keep my name synonymous with the words 'write-in.'"

Margo said he was also aware of the level of commitment required to serve if elected.

"I'm well organized, and I feel confident that I can manage my time in such a way that my family is only slightly impacted by my obligations," Margo said. "Will it be different at our house? Absolutely. It has to be. If it's not, I'm not doing my job, but my children are very supportive of me doing this, as is my wife."

Write-in candidates have until 5 p.m. on Oct. 25, two weeks before the Nov. 8 election, to file a statement at the Los Angeles County Registrar-Recorder/County Clerk's office. Beverly High oil well to shut down after 2016

The City Council voted 4-1 Tuesday night to approve the City's oil well drilling ordinance, which prohibits drilling and extracting oil, gas and other hydrocarbon substances from surface locations in the City. The ordinance will affect operations at Beverly High, the City's last remaining surface oil drilling site. Councilmember John Mirisch voted no because he wanted to make sure that BHUSD's revenue from the drilling operations would be made up.

The ordinance will allow the three-party lease for the Beverly High site between the City, BHUSD and Venoco to continue until it expires on Dec. 31, 2016. BHUSD currently earns approximately \$1 million a year from the oil well operations, as does the City. The current lease has been in effect since 1978. The ordinance also includes a provision that the City Council may extend the date of the lease upon finding it is in the public interest to do so. The ordinance does not prohibit slant drilling in Beverly Hills, but language in the ordinance prohibits any drilling beneath the City from originating at a site that is within 500 feet of a school or park property.

"We have five years to look into different ways to make up that revenue and I am completely confident we will come up with a way to make up the revenue and that's why we're doing it now," Councilmember Lili Bosse said. "If we had waited until 2016, I think that would have been really irresponsible. To me there is no amount of money that would ever make sense to even take a chance of risking any sort of health issues."

Bosse said she supported the ordinance for

a number of reasons, including that current state law does not allow the construction of schools next to oil wells, that all 10 Beverly Hills elected officials agreed at a joint meeting that having an oil well on a high school campus was not a compatible use, and that there have been violations at the site in the past. In reviewing past city council meetings, Bosse said she learned that since 2003, the City Council has been discussing ending oil well drilling when the lease expires in 2016.

"It wasn't something that just came up now," Bosse said.

Mirisch initially proposed a waiting period on the ordinance, since the school board had requested more time before the City Council acted on it.

"I wanted to respect their wishes and allow for more time for them to have some of their own internal discussions," Mirisch said. "Even though I do not feel oil wells are a compatible use, I do not feel we were being deliberate enough in the process and we were not being respectful of the schools and so I did not vote in favor of the ordinance."

Mirisch proposed an amendment which would protect the school district from financial losses as a result of the ordinance, but the amendment was not supported by his colleagues.

"I would want a proviso in this [that] we are going to be committed to make [BHUSD] whole and to make sure that the kids don't suffer as a result of losing the revenue," Mirisch said. "I think we will be able to find ways to make up the revenue, whether it be slant drilling or through ground leases, and also through the JPA [Joint Powers Agreement] by increasing it. That's something we can do by eliminating wasteful spending in City Hall."

Although Bosse is confident the City and school district will find a way to make up the revenue, she did not support Mirisch's amendment because she did not want to detract from the main message of the ordinance. She said the motion was also ambiguous, since the price of oil fluctuates affecting the revenue to the City and school district.

"It wasn't a specific enough motion that couldn't be quantified, and my concern was by adding that, it would then dilute the big issue, which is shutting [the oil well] down," Bosse said.

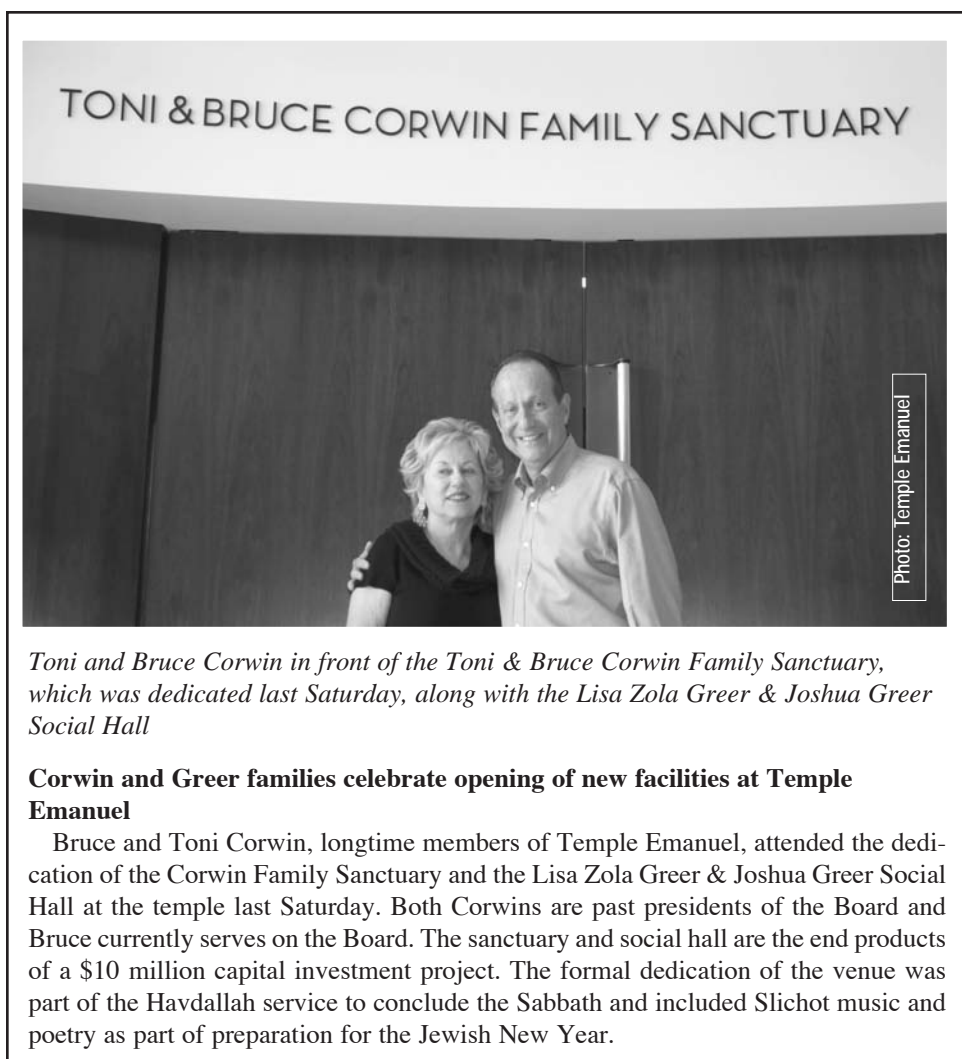
Board of Education member Steven Fenton questioned the City Council's decision.

"Barry [Brucker] is very emotional about this issue and his vote clearly reflected that," Fenton said. "I find it very odd that Barry and Willie [Brien] spent 10 years combined on the Board of Education and could have passed a board policy that reflected a non renewal of the oil lease. It makes me wonder why they're choosing to do it now, when they had every opportunity to do it as school board members."

Fenton said he is not pro-oil, but he is pro-revenue. He said there would have been plenty of time for the City Council and the school board to put together a "logical game plan."

"I commend John Mirisch for standing up for the school district," Fenton said. "He's the only one that understands that before you unilaterally take something away from the school district, you should first have a plan as to how you're going to give it back in some way, shape or form."

Despite the lack of unanimity on the oil well ordinance, Bosse expressed pride about

her vote to end oil well drilling in Beverly Hills.

"Last night will probably be one of the proudest moments I have as a city councilmember, and definitely a vote that I will forever be proud of," Bosse said.

Mayor Barry Brucker expressed a similar sentiment.

"I think this is really one of the most important votes that we as a city council have made, certainly in the seven years that I've served," Brucker said. "This is a strong statement to the community, that the health and safety of our children and our flagship public school, is of paramount concern and certainly would never be compromised by a royalty dollar."

The previous City Council passed an urgency ordinance prohibiting oil well drilling in Beverly Hills in March. City Manager Jeff Kolin told the school board at its June 28 meeting that the ordinance was motivated by concerns from community members and elected officials about oil drilling on the high school site. Kolin also told the school board the City had heard there was interest or potential that the school district might commence discussions with Venoco about a possible lease extension.

The City Council and Board of Education held a joint meeting on the topic and decided to form an ad hoc committee to brainstorm how to make up the school district's revenue from the oil well. The liaison committee of Bosse, Councilmember Julian Gold, and Board members Jake Manaster and Steven Fenton will meet for the first time on Oct. 31.

Judge rules Measure 2P invalid; City and G&L Realty reach settlement

More than six months after the March 8 election, the City of Beverly Hills and G&L Realty have at last come to resolution regarding Measure 2P, the ballot measure which would have required the City to offer two

hours of free parking at additional public lots in the City. On Monday, Judge Ann Jones ruled Measure 2P invalid, and the City and G&L Realty came to a six-year agreement in which the City will add one additional parking structure, at 461 N. Bedford Drive, to the City's two-hour free parking program, which is currently offered at seven of the City's 17 parking structures.

G&L Realty has agreed to contribute funds toward the purchase and installation of an automated license plate recognition system at the 461 N. Bedford Drive structure, where free parking will be extended from one hour to two hours beginning Nov. 1. The technology is intended to detect drivers who leave the structure and return immediately to receive more than two hours of free parking at a time.

"This agreement is created in the spirit of Measure 2P. It provides for the two hours of free parking that residents and visitors to Beverly Hills have always enjoyed and also allows for the City to manage its parking structures to ensure that they do not become a burden to taxpayers," G&L Consultant Harvey Englander said in a statement. "G&L Realty is pleased with the leadership shown by the City Council in resolving this matter."

Mayor Barry Brucker said the parking program encourages visitors and residents to shop and dine in the City.

"This agreement will continue the City's existing and longstanding tradition of providing free and reduced-cost parking throughout Beverly Hills as desired by residents," Brucker said in a statement.

On April 29, Jones granted the City a preliminary injunction, which gave the City a reprieve from implementing the measure until a final ruling was made.

Jones ruled Measure 2P invalid on Jan. 4, and it was uncertain whether the measure would appear on the March 8 ballot. The 2nd

District Court of Appeal stayed the decision pending the election. Measure 2P, proposed by G&L Realty, passed on the March 8 election, 3,452-2,112.

The City announced the settlement in a press release with statements from the City and G&L Realty.

Lexus Project shows improvement at Planning Commission hearing but neighbors still concerned about potential impacts

Jim Falk Lexus brought a significantly revised project proposal for its new dealership before the Planning Commission on Monday, a proposal that Chair Dan Yukelson said reflects feedback from the Commission and residents. Yukelson said some changes still need to be made, and the matter has been continued to the Planning Commission meeting on Oct. 27.

The proposed revisions include decreasing the height of the building from 56 feet to 45 feet; reducing the number of service bays by two and relocating all 70 service bays below ground instead of above ground; increasing the number of parking spaces from 250 to 352; moving loading operations to Wilshire Boulevard, away from residential uses on South Maple Drive; installing a traffic signal at Wilshire and Maple to better facilitate turning movements; and proposing a physical barrier to prevent left turns into the dealership from South Maple Drive.

it can be for the City and the neighborhood," attorney Mitchell Dawson said on behalf of his client, Jim Falk Lexus. "It really proves this applicant team is

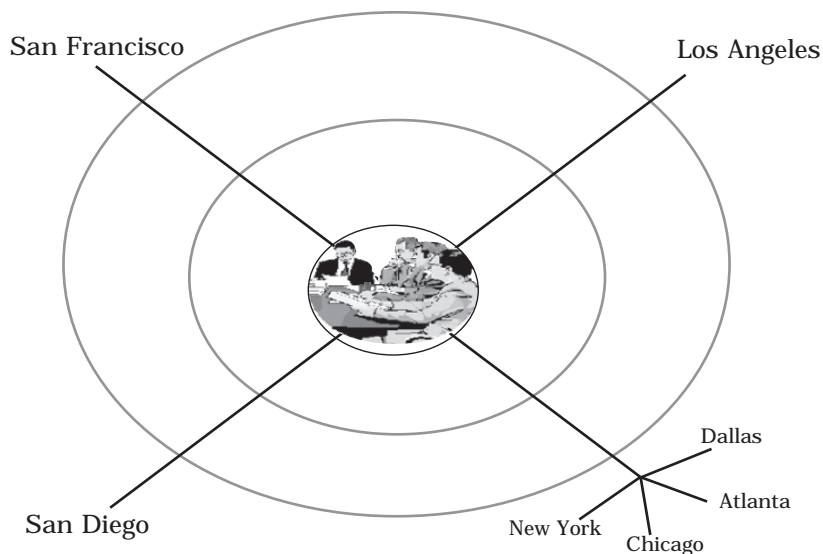
willing to address not only our commission's concerns but also the concerns of their neighbors," Yukelson said.

The proposed project would allow the demolition of the existing dealership and construction of a new 45-foot tall dealership with four levels, including two subterranean levels. The dealership would have approximately 29,000

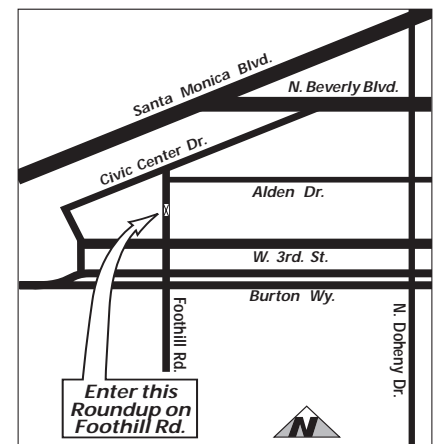

square feet of showroom and office space on the first and second levels, 82,000 square feet of vehicle parking and circulation areas within all four levels, and approximately 57,000 square feet of subterranean vehicle service areas. Of the 352 parking spaces, 84 would be used to satisfy zoning code requirement for sales and office areas and the remainder of parking would be utilized for vehicle storage.

The dealership has applied for a conditional use permit to allow the operation of the dealership, the relocation of an existing alley, and to allow loading operations on public property, which in this case is Wilshire Boulevard. The applicant has also requested a zone text amendment to exclude above-ground parking areas and subterranean service areas from the definition of floor area, which allows the project to comply with floor area ratio (FAR) limitations in a commercial C-3 zone, Yukelson said.

Yukelson said the proposed change to the alley is not an alley vacation, but an alley relocation. The City's Transportation Division studied the alley bisecting Wilshire and Maple, and recommends replacing the alley with a new, 20-foot wide alley, which is wider than the existing alley, immediately south of the proposed building. Yukelson said the relocated alley would provide a buffer between the dealership and the adjacent apartment building.

"There's always a concern about an alley vacation if the City's going to be giving up an alley," Yukelson said. "In this case the alley is literally being moved further south and it's going to be a much wider alley."

Barney's Department Store, Neiman Marcus

and the Montage hotel all required the relocation of alleys, Yukelson said. The Montage is the only recent example.

With regard to the zone text amendment, Yukelson said similarly situated businesses can exclude parking from the definition of floor area under certain conditions.

"Due to a technicality, car dealerships did not have that latitude, [but we're] going to correct code to allow car dealerships to have a similar right to other businesses in the City," Yukelson said.

According to the staff report, the proposal for the new dealership is the "result of the requirements of Lexus Corporate management to construct a new, modern facility to accommodate the local customer base" and the size, number of service bays and display area proposed are a "direct result" of Lexus Corporate requirements. Dawson said Lexus presently contributes over \$1 million in sales tax revenue to the city, inclusive of automobile sales and parts.

Former Mayor Steve Webb, who formerly represented the nearby Nessah Synagogue and opposed the project presented at the December 2010 hearing, said he still thinks the project would be impactful to the surrounding neighborhood. He currently represents the owner of a neighboring apartment building at 151 S. Maple Drive, but he said as a resident of the neighborhood, he had intended to speak about the project anyway.

"When I was mayor, I opposed BMW's request to build a similar service center because of its impacts on the residential neighborhood," Webb said. "I continue with that opposition with respect to the Lexus Project.

The burdens attached to a 70-service bay facility with over 100 employees and 350 parking spaces is simply too impactful for a residential neighborhood."

Yukelson said some "tweaks" are still needed, but he said a lot of progress was made at Monday's meeting. Yukelson identified the proposed barrier on South Maple Drive as one issue requiring review, since the proposed plan would affect the adjacent commercial property at 9200 Wilshire Boulevard.

Dawson said staff and the Department of Transportation are currently looking into how to resolve the barrier issue, and the applicant and staff will also review the appropriate width of the sidewalk remaining on Wilshire Boulevard, the number of employees parking offsite, the function of the turning abilities of the relocated alley, as well as light and glare.

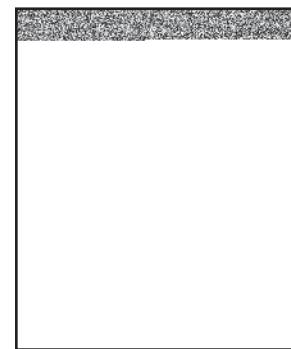
"The predicate for the workability of the new project is based on the installation of a signal at Maple Drive and Wilshire, and concrete barriers," Webb said. "If that will work, then the impacts will be significantly reduced. However, as of this point in time, there has not been sufficient analysis to determine whether those two aspects of the project will in fact work, and of equal importance, what will be the impacts on Rexford Drive with a new signal just a block away?"

Dawson said the applicant looks forward to solving the remaining issues and bringing forth responses to the next Planning Commission meeting on Oct. 27.

Four of five commissioners participated in the hearing. To avoid even the appearance of a conflict of interest, Commissioner Brian Rosenstein recused himself because his

father's company, New Pacific Realty, owns the empty lot directly adjacent to Lexus.

Fisher appointed to the Planning Commission

The City Council voted unanimously Sept. 27 to appoint Traffic & Parking Commissioner Howard S. Fisher to fill Commissioner Noah Furie's position starting in December.

Furie's term was extended last December to provide continuity on the Lexus Project. The City Council provided initial consensus for the appointment at the Sept. 20 study session.

The selection committee, comprised of Vice Mayor Willie Brien, Councilmember Lili Bosse, Commission Chair Dan Yukelson and Vice Chair Craig Corman, interviewed 10 applicants for the position.

Brien recommended Fisher's appointment take effect after the last Planning Commission meeting in December, and has requested Fisher attend all Planning Commission meetings before the start of his term.

"I believe that will be appropriate for the consistency of decisions [Furie is] actively engaged in," Brien said. "Obviously, this will not impact [Furie's] role as a planning com-

Try to think of one person you know everyone likes, admires and never badmouths, ever? Not easy. Does the name **Monty Hall** come to mind?

Just getting a frown out of this real hero, icon isn't easy. However, Tuesday night we were fortunate to have been at one of the most genuine and remarkable tribute events we ever had the good fortune to attend.

Recognizing his incredible career and astounding \$1 billion plus charity raising efforts, mostly through International Variety, a great party was held at the Canadian Consulate honoring his 90th birthday. (No, not a fundraiser.)

Hall has achieved, in his personal, family, civic and professional life successes that border on historic. Tuesday, the Canadian government and a packed outdoor venue of friends recognized Monty and listed some of his life works and deeds.

Representing his native Canada was Ambassador **Gary Doer**, who flew in from Washington to speak and greet Monty's friends, and Consul General **David Fransen**.

But aside from the beautiful setting, the Canadian consul home is in a secluded part of Hancock Park, the entertainment was not only impressive, but very professionally produced.

The evening began with a lyrical and touching rendition of the Canadian and American national anthems, seldom more beautifully performed than by the talented **Gloria Loring**.

A very hard act to follow, but **Nita Whitaker**, a vocalist I want to hear many more times again, did two songs, one an excellent Sondheim song from "Company."

In between the music, accompanied mostly by the **Nelson Kole** quartet, there were salutes from family members—**Richard and Sharon Hall** and a video from award winner, **Joanna Gleason**. Mrs. Monty Hall, the great life partner and wife, also captured our emotions in a brief appearance.

Then more entertainment: **Ron Korb's** flute was electrifying. Of course, he is a Canadian musical award winner.

The whole program could make a great PBS show. Consider what followed:

Norm Crosby, mixing words fast and unleashing two great jokes that were new, and clean.

The legendary **Paul Anka**, by video, did an emotional and touching tribute to Monty to "I did it my way." Anka reminded the audience that he was Lebanese, and in one line of his song added: "We need to remember how much we have in common and love one

another." Anka also demonstrated his ability to speak Yiddish.

Hard acts to follow? Wait, there was more. **Jack Jones** live received a standing ovation for his musical tribute to Monty, accompanied by his own group.

Long time friend **Peter Marshall** was an excellent master of ceremonies, mixing introductions with his remembrances of Monty's work and life.

The evening closed with a video from Australia by the International President of Variety, **Peter Drummond**, and thanks from Monty.

Impossible to list all the VIPs, including some from Beverly Hills but because Chief **David Snowden** (with beautiful wife Ellyn), Hall, Josette and I share one date, they get listed. Yesterday was Snowden's birthday, the Hall anniversary and ours too.

The chore I did not complete, was some investigative reporting on Monty's claim to be 90. Impossible. Sixty would be pushing it.

Thanks for including us, it was an evening we will not forget, a sentiment we shared with all those attending.

We are a very tolerant and forgiving community, but if you need any corroboration of this, consider the two people who reportedly negotiated the convoluted settlement of the Two Hour Free Parking referendum, and the lawsuits that followed.

According to our sources, the city council was often represented by Councilmember **John Mirisch** and the proponents of the ballot measure by veteran lobbyist **Harvey Englander**. An agreement was reached, despite their somewhat interesting history:

Here's what Englander said in a published letter in *Beverly Hills Weekly* about his partner in the talks:

"John Mirisch is a liar."

Mirisch, who has never been accused of being brief, responded in a lengthy, somewhat more restrained letter of his own with some harsh words about Englander.

Although the city won the lawsuit, the court ruling that the ballot measure was invalid because it improperly intruded on council prerogatives, the appeal process could have been lengthy and expensive, for both sides.

The primary proponent of the referendum,

which won by a wide margin, was G&L Realty, a major medical office building developer and manager, with significant holdings in Beverly Hills. Think medical offices on North Bedford, North Camden, North Roxbury as just some of their venues.

On the positive side of the company's ledger is the remodeling of what was once bland, gray buildings with street front retailing—improvements that were aesthetically significant and, very important, tax revenue producing. G&L had won several awards from the city for their design achievements.

But when the city even considered removing or altering two hour free on nearby city owned lots, G&L went to Englander who mounted the campaign to supposedly mandate two-hour free. Had the city made any move to charge, it could have produced close to \$1 million annually for the parking fund—and, just possibly, help build more facilities in other areas of the city.

G&L won, the ballot measure, mandating permanent two-hour free in many city lots. However, while the settlement was probably not what either side hoped would happen, it did avoid more angst and legal fees, so our appreciation to all involved, including Mirisch and Englander.

Incidentally, rack up one more legal victory for our City Attorney **Larry Wiener**. The city was a winner at the trial level.

If you think this school board election is exciting, I would be pleased to offer you ducats to a Dodgers game.

The only real drama is in who dropped out early and late, and the possibility of one or more write-in contenders.

Judging by the campaign kickoffs, the last of the on-ballot contenders, **Lewis Hall** had his Sunday, at the Salters, and although he had more voters than **Frances Bilak**, not nearly as many as **Brian Goldberg**; the election has yet to capture our interest.

Barring some October surprise, Goldberg has to be considered the easy front runner. He has a very strong base of supporters from throughout the district.

However, Hall has a very credible and diverse list of endorsers including Mayor **Barry Brucker**, who introduced Hall at the event, former mayor and former school board president **Richard Stone, Damien Bean**, an early strong board candidate who withdrew before filing closed, former school board president and member **Myra Lurie**, veteran civic leader **Lya Cordova-Latta** and many more. If endorsements matter, Hall and Goldberg are the front-runners.

However, adding to the drama is a newly mounted write-in campaign by **Noah Margo** who was recently elected co-president of the Beverly Vista PTA and who had earlier considered running.

His supporters, and they too are impressive, argue that a write-in campaign is justified because of "the lack of experience by some of the other candidates." They support this by citing the surprise withdrawal of **Andy Licht**, certainly an early leader in the election.

Write-in campaigns are not often successful and are mostly mounted, not based on lack of qualifications, but major differences with the other candidates. That does not seem to be Margo's reason for running.

When now Mayor Barry Brucker won an historic write-in campaign in 1997, it was because he launched a direct frontal attack on the then-school board majority and their campaign for reelection. He walked every street, launched a blizzard of mailers and made education issues the reasons for his

appeal for votes, not personal qualifications of his competitors.

Both Goldberg and Hall had good venues for the kickoffs. Goldberg at **Ardyth** and **Sam Freshman's** and Hall at **Janet Salter's**. But it is the home that Max built, that has the history of wins. **Lili Bosse** had her event there, and she won in every precinct, coming in first easily.

The Salter family has a long and commendable record of service in government, Max twice as mayor, and in the arts and support of national and local Democratic contenders. The late Mayor Max was proud of his having made the Nixon "enemies list."

The Salters did have one party that will not easily be forgotten, although Janet has tried. To celebrate the birthday of one of their canines, they held a "barkmitzvah." The "entertainment, of course, was two animal acts and their trainers. The dogs took center stage and immediately began to demonstrate their great affection for each other, to the

delight of the audience and a red faced Janet and trainer.

Next came a trained bird. The act was to have the bird fly to a member of the audience who held a bill of some meaningful amount. Then Mayor **Jimmy Delshad** was more than generous, producing a \$100 ducat. The bird flew down, took the bill in his beak and landed on a tree just outside the property. However, at the command of the trainer, the bird was supposed to fly back and give the bill back to the owner. Not this sharp black bird. No amount of coaxing could lure him from his safe perch.

Not to imply that this campaign too is for the birds.

Soon, this column will recognize contributions made by two board members who are leaving in November, **Myra Lurie** and **Steven Fenton**. We did note the Fenton family history of service and Myra's in-

laws, **Sooky** and **Sam Goldman's** legendary involvement in education and civic life.

But both Myra and Steven merit some thanks, even though they were often at opposite ends of education issues. Next week, only the positive parts.

My emails have overloaded my computer with rave notices for Councilmember Lili Bosse's direct and courageous stand against oil drilling (see page 3) and not knuckling under to school board pressure. The whole oil drilling matter and financial and environmental impacts are worth more ink.

Iman and Missoni to be inducted into Rodeo Drive Walk of Style

The Rodeo Drive Committee and the City of Beverly Hills have announced that the next recipients of the Rodeo Drive Walk of Style Award will be international supermodel,

actress and entrepreneur Iman, and acclaimed Italian fashion house, Missoni. The ongoing award, inaugurated in 2003, honors style legends for their contributions to the worlds of fashion and entertainment. Both recipients will also receive plaques on Rodeo Drive, featuring their signature and quote, which will be embedded permanently in the sidewalk of the celebrated street.

The awards ceremony will take place on Rodeo Drive on Oct. 23 with a special silent auction to benefit Save the Children in their efforts to respond to the needs of children and their families affected by the East Africa Food Crisis brought on by the worst drought in six decades.

"The City of Beverly Hills is pleased to honor Iman and Missoni with the Rodeo Drive Walk of Style Award," Mayor Barry Brucker said in a statement. "Iman's influence in the fashion, philanthropic and entertainment sectors, coupled with Missoni's genius aesthetic and presence on Rodeo Drive, make them both highly deserving honorees."

Iman began her career in 1975 as a model and has challenged the prevailing notions of

beauty ever since. The daughter of an African diplomat, Iman was born in Somalia and grew up speaking five languages. She studied political science at Nairobi University, where legendary photographer Peter Beard discovered her. Her first modeling assignment was for Vogue in 1976; since then, she has been a muse for fashion designers including Yves Saint Laurent, Versace, Calvin Klein and Donna Karan. During her 14 years as a model, Iman worked with top photographers Helmut Newton, Richard Avedon, Irving Penn and Annie Liebovitz.

Also being honored with the Rodeo Drive Walk of Style Award® will be Missoni. In 1969 Diana Vreeland, the famous fashion editor of American Vogue, declared Missoni's techniques as "ingenious." Her comment: "Who said there are only colours, there are shades too!"

The Missoni style reflects the successful venture of a husband-and-wife team: married in 1953, Tai and Rosita started a knitwear business that would come to symbolize Italian fashion in the mid-sixties with its signature designs. Missoni successfully introduced and established an unmistakable way of dressing and living. Today, Missoni is one of the most widely respected ambassadors of Italian fashion and design around the world. With its colorful aesthetic vision, the company continues to influence contemporary lifestyles, thanks also to the success of the Missoni Home line and the recent inaugurations of the Hotel Missoni in Edinburgh and Kuwait.

Haimowitz, community volunteer, passes at age 94

Oscar Haimowitz, a well-known volunteer in Beverly Hills, passed away on Sept. 15. He was 94. He was an active volunteer at El Rodeo, the police and fire departments and Cedars-Sinai Medical Center.

Haimowitz volunteered in retired teacher

Cindy Blum's kindergarten class five days a week at El Rodeo for a 20-year period that spanned most of Blum's career at El Rodeo from 1985 to 2008. Haimowitz missed school every once in a while for vacation or other reasons, but he would always call to let Blum know when he would be absent, Blum said.

"The kindergarten children at El Rodeo called him Papa Oscar," Blum said. "He loved helping them tie a shoe, read a word, or open a thermos. It was my good fortune that he was a volunteer in my classroom for 20 years. He enjoyed sharing his wonderful stories of travel and adventures with the children as well as the staff. Oscar was a man of many talents, who lived life to its fullest. I will miss him very much."

Retired El Rodeo Principal Steve Fisher, who was principal from 1989 to 2004, said Haimowitz was known for his work ethic and his impeccable style.

"He always came to school dressed in white pressed pants and a white pressed shirt," Fisher said. "Oscar's attire quickly became his trademark, one the kids looked forward to seeing since they knew Oscar was on his way to their classroom. Oscar will be missed and fondly remembered."

Blum echoed Fisher's comment about Haimowitz's work ethic. When Haimowitz was no longer able to drive, he started taking the bus to El Rodeo, Blum said.

Blum said Haimowitz had strong values.

"If [the students] wanted him to help them tie their shoes or help them read a word, he always said, 'What's the magic word?' He wanted the children to say please," Blum said.

Haimowitz was also an active volunteer with City programs, including the police department and the fire department's community emergency response team, which he joined in 2001 and was an active participant for about five years, according to Pamela Mottice-Muller, Director of the Office of Emergency Management. Mottice-Muller said Haimowitz was an advocate in encouraging others to be prepared for emergencies.

"Oscar was an extraordinary Beverly Hills resident, fully committed and dedicated to serving this community and the endless hours of volunteering of his personal time for the Beverly Hills Police Department," BHPD

Spokesperson Lt. Tony Lee said. "We will miss him."

Haimowitz settled in Beverly Hills in 1981 to be closer to his older brother and a number of cousins who had moved to the Los Angeles area after World War II. Haimowitz was born in Brooklyn, New York in 1917 and raised his family in Pennsylvania with his first wife, Sylvia Naides Haimowitz, who died in 1979. Haimowitz was a World War II veteran and a United States Marine before he became executive director of Temple Adath Israel in Merion Station, Penn., where he worked for nearly 30 years.

According to Haimowitz's widow Raquel Tarshis Haimowitz, Oscar went to visit a friend in Jerusalem after Sylvia's death. Oscar met Raquel, who was originally from Buenos Aires, Argentina, and they were married in Jerusalem about one year later, Raquel said. They decided to leave Israel in 1981 because of the turmoil between Israel and Lebanon at the time and also because Oscar missed the United States, she said. Raquel said Oscar had many interests, including traveling and going to the theater, symphony and opera. At one point in Oscar's life, Raquel said he had wanted to be an actor, so Oscar played an extra in some movies. Volunteerism was always important in Oscar's life, Raquel said.

Memorial services were held on Sept. 18 in Philadelphia, where much of Haimowitz's family lives. He is survived by three children, six grandchildren and seven great grandchildren.

The Weekly's exclusive interview with Rodeo Drive Committee President Jim Jahant

Tell us about yourself.

I joined Brooks Brothers when they opened the store here in Beverly Hills, which was in September 2003. Prior to being with Brooks Brothers, I was the vice president director of stores for Laura Ashley retail.

Are you a lifelong resident of Los Angeles?

I've lived in Los Angeles a little over 40 years, but I am originally from Akron, Ohio. I live in Westwood.

What brought you to Los Angeles?

I worked for a company at the time called Karl Shoes, which was owned by Harry Karl, who was the husband of Debbie Reynolds, and he was in Akron, Ohio at the store. He asked me to come to the West Coast to be an assistant buyer for them.

What do you like about living in Los Angeles?

I absolutely love Los Angeles. When I came out and drove over the mountains and saw the ocean, I said I'm never going back. I just love Southern California. I'm not relocatable and with all the companies I've worked for in the past, I've always had my base in Los Angeles. I've never had to relocate for a company.

How did you become general manager of Brooks Brothers in 2003?

They were opening a West Coast flagship store and they had heard what I had done with Laura Ashley and they contacted me to come in for an interview. I met with their vice president of stores here in Beverly Hills, we had dinner in Beverly Hills, and walked around. Once I saw the store that they picked to put their store in, which was originally built by

Tommy Hilfiger, I said absolutely, no questions. It's such a beautiful store.

What do you like about being general manager of Brooks Brothers?

[The company] afforded me the opportunity to get involved in the community, and they're very supportive. I have an excellent staff in my store, so it allows me to get out at any time to attend meetings, to meet with the City Council, meet with other general managers in Beverly Hills, and of course be part of the Rodeo Drive Committee and also part of the Beverly Hills Chamber of Commerce.

Brooks Brothers earned a City proclamation in 2007 for community involvement. What are some of Brooks Brothers' community efforts?

Brooks Brothers believes in being involved in the community. When we first opened the store, our first link into the community was joining the Chamber of Commerce. Then I had the opportunity to work with different charities here in Beverly Hills and I took the first two years doing special in-store events to help the different charities raise money, so I've worked with [Virginia] Robinson Gardens, Greystone Estate, there was an afterschool program in Beverly Hills at the time I helped raise money for, and on Dec. 1 we're doing a [fundraising] event for the Beverly Hills Bar Association's [charity].

Why is community involvement important to your business?

It's important to become part of any community where you have a retail business, and to let everyone know you're there to help the community and work with the community. I think it's important not to just be an established name in a community and open your doors and just think everybody is going to come into your store. It really takes a lot of effort to get outside your four walls. Networking, I think, is a key for any business.

What attracted you to retail?

I've actually been in some sort of retail since I was in high school. I started as a stock boy in a shoe store. I've had the opportunity to not only [work with] shoes, I've also been involved in women's clothing, a women's line of maternity, children's; I've been involved in almost every segment of some type of fashion retail.

What do you like about fashion and retail?

It changes every day; every day is a new challenge. It's just fun. It keeps you busy, it keeps you challenging yourself and wanting to do better each day than what you did the day before.

Outside of fashion, you were also regional director of KB Toys.

Absolutely. I was with KB Toys for about eight years. It was fun because it's toys. It brings out the little boy in all of us, but it was also great working there because you get involved with a lot of parents and children.

You've been Chair of Theatre 40 since 2008. How did you become involved with the organization?

Actually through one of my clients here in the store. I was invited to sit on their board, and I was on their board for about a year prior to becoming their chairman. That's networking with your clients. I've always been a theater enthusiast. Each trip I make to New York, I always plan a weekend visit to do some type of theater.

What are the strengths of Theatre 40?

It's all Equity actors, and it's outstanding. It is just amazing because it's a 99-seat theater so you truly can feel like you're onstage with the actors. They have a way of drawing you in and making you part of the play.

What is the Rodeo Drive Committee?

Rodeo Drive Committee takes in the three blocks of Rodeo Drive. People [are] familiar with Rodeo Drive as being the famed shopping street. It's known throughout the world. It's known for its luxury fashion, and it's where visitors can enjoy more than 100 renowned boutiques and hotels.

The Rodeo Drive Committee was founded by Fred Hayman and currently there are about 77 members, and you must be on Rodeo Drive to be a member of the committee. The committee's function is really to help the stores that are on Rodeo Drive in promoting and working with the different stores to do events on Rodeo Drive that in some cases work very closely with the City, but are actually specifically held on Rodeo Drive.

What do you think makes Rodeo Drive unique?

I would say that first, it's the stores that you have on Rodeo Drive all in one place. The merchants on Rodeo Drive truly have worked on having some of their most outstanding customer service and customer relationships that they have built. They don't only build relationships for Beverly Hills but from around the world. Many of the stores on Rodeo Drive are flagship stores for their parent companies so they carry merchandise that's not carried in any other stores, maybe in their New York boutiques, but I even carry merchandise [at Brooks Brothers] that's just for Rodeo Drive.

What are your priorities for the Committee this year?

[My priority] is to help in every way we can to stimulate business on Rodeo Drive. We are world-known for our Walk of Style, and we will have another Walk of Style on Sunday,

Oct. 23. That's going to be honoring Iman, the fashion model, and the Missoni family. But we're also known now throughout the world for our Concours d'Elegance that takes place every Father's Day, and each year it gets bigger and bigger. We just recently did Fashion's Night Out [on Sept. 8]. Of all the advertising around the world, Rodeo Drive was always listed as second or third of spectacular Fashion's Night Out [events]. It was sometimes New York, sometimes Italy, sometimes Paris, [but] Rodeo Drive was always listed. That's quite a [distinction] when you think about how many other Fashion's Night Out [events] were going on around us, including Beverly Center and Santa Monica Place. We also had a Ferris wheel. It was a fun carnival evening.

Tell us more about the upcoming Walk of Style awards on Oct. 23. Why have Iman and Missoni been selected as honorees?

There is a private committee of about eight people that selects the [honorees]. At this particular event, we're going to be having Iman and Save the Children, that's a charity that she sponsors. It's a very good event to not only meet the honorees and listen to them speak but we also do an amazing job on Rodeo Drive prior to the awards show, showing pictures and having things all throughout Rodeo Drive for each of the honorees. When we [honored] Ferragamo, we [displayed] some of their shoes, from when they first started making shoes, in glass displays. There's always something interesting and different to see.

Do you have a favorite Rodeo Drive event?

Concours d'Elegance [because] I happen to be a car person. We sponsor the event, and we do a private luncheon for all of the exhibitors, and we also welcome the committee and the board from the Petersen [Automotive] Museum. I'm going to [estimate] there were maybe 20,000 people at the last event and it stimulates a lot of business on the street. At least a lot of people see the stores. If they don't shop that day they come back later in the week and shop.

How does your past experience as Chamber of Commerce president help you in your role as RDC president?

It's similar in a way to the Chamber of Commerce. There are over 700 members. It's really outside of Rodeo Drive and really building more membership for the Chamber, and helping be a voice for some of the smaller businesses [by] working closely with the City Council and the City to help them overcome some of the challenges that they find opening a new business in Beverly Hills. [The Rodeo Drive Committee] invites the Chamber to each of our board meetings. We work closely with the Conference and Visitors Bureau (CVB); they also attend our board meetings. This makes us all work very closely as a family. We're working with [the CVB] now as we get ready for the holidays coming up and the decorations throughout the City.

What is the vision for Rodeo Drive this holiday season?

One thing about the City, it's going to sparkle this year. We're working with Swarovski

Crystal and they're helping us do the decorations throughout the City, decorating some of the trees, they're going to have banners throughout the City. We'll have special displays in the medium [of crystals] on Rodeo Drive. That's still in the process of working very closely with the City and the City is very excited about it.

City staff initially proposed removing Santa from the holiday display. What is Santa's status?

Santa will be just wonderful. We're not making any changes. He will still be flying high.

Last year's holiday decorations have been described as less than robust. What were their shortcomings?

I think you said that very politely. On Rodeo Drive they were worse than robust. We truly had no decorations for the holidays. They reused a lot of decorations from the year before. We did Snow 90210 [early in December], but unfortunately those were the

only banners we had up for the whole month of December.

Last year, Rodeo Drive worked in partnership with the City and we did Snow 90210, [and] we had it snowing on Rodeo Drive. It was very, very successful. It was in the place of the lighting ceremony to generate some traffic [to] Rodeo Drive. This was the only time we had actually gone to members of the Rodeo Drive Committee and asked for \$1,000 to participate to put this spectacular evening event on.

Will Snow 90210 repeat?

No, because we will have a spectacular Christmas this year working with the City, but it won't just be on Rodeo Drive. It will be throughout the city. Rodeo just might sparkle a little more. I promise you it will be spectacular.

What effect has the recession had on the merchants on Rodeo Drive?

It truly had not affected us like you hear and read in the paper [about] other retailers.

Our [Brooks Brothers] flagship store here on Rodeo Drive, being part of a chain, I have [seen] we truly have had the opportunity to continue to maintain our sales. We have seen it come back in the last two years now, and it seems to continue. We are continuously showing double digit increases over last year's sales.

Has Rodeo Drive as a whole done well in this economy?

When we have our monthly meetings, we all discuss what improvements we've seen. Hotels that are members of the Rodeo Drive Committee, they're seeing 80 to 94 percent occupancy.

Why do you think Rodeo Drive has been relatively unaffected by the downturn?

First, we still have quite a few tourists that are coming to Beverly Hills, and coming to Rodeo Drive. I think the exchange rate in their different monies throughout Europe and Asia have helped us in the U.S. and especially on Rodeo Drive maintain some of those sales,

and the last two weeks have been phenomenal, [with] very large families traveling, families traveling with children three plus.

What strategies has RDC implemented to overcome the challenges of this economic downturn?

Those were strategies that we use for each of our events, even for Walk of Style: Who could the nominees be particularly in this economic downturn to make sure we were attracting more people for that? Even last year in December, to do Snow 90210 was really to attract more people to Rodeo Drive.

What's your forecast for this holiday season?

I think it's going to be a very good holiday for us sales wise. I think we will see again more tourists coming in [and] we will see big increases for the holidays. I'm saying that knowing that's not what I'm reading in the paper, but I feel very confident about Rodeo Drive.

BHHS Football Team Loses On Late Touchdown

The 2011 version of the Beverly High football team was unable to be the first in school history to defeat Peninsula, despite playing what coach Donald Paysinger said was its best game.

The Normans lost to the Panthers, 32-28, as Okuoma Idah ran one yard for the winning touchdown with 17.1 seconds to play Friday night in a nonleague game at Nickoll Field with five lead changes.

Beverly Hills (1-2) had taken a 28-25 lead with 4:59 left as Frank Brown ran for the final seven of his 179 yards and second touchdown on his 23rd carry.

Peninsula (2-1) began the ensuing drive on its own 42-yard line. Nine running plays, six by Okuoma, advanced the ball to the Normans' 12-yard line with 32.7 seconds remaining.

On a second-and-nine play following a time out, Panthers quarterback Matt Imwalle threw his team's only completed pass, which went for a 10-yard gain to Tommy Webster, putting the ball on the Beverly Hills 2.

Idah, who ran for 133 yards on 24 carries, was stopped after a one-yard gain on the following play, but scored his third touchdown on the next one.

"We actually played like a team offensively and defensively," Paysinger said. "Our offense actually moved the ball, scored some points and did what we've been working on practice the last month, moving the ball."

The Normans out-gained Peninsula, 309 yards to 167, despite playing without quarterback Cameron Countryman, the starter in their first two games.

Countryman sprained an ankle while being tackled in a 20-14 victory over San Marcos Sept. 16. He will also miss Friday's game at Canyon, but may return for the Oct. 7 game against Alemany, Paysinger said.

Countryman's replacement, Brandon Adams, completed each of his first five passes and 11 of 22 overall for 120 yards, but had three passes intercepted, including one on the final play.

"He played great," Paysinger said.

Adams missed Monday and Tuesday's practices because of the flu and had only one full practice to prepare for his first varsity start as a quarterback.

When asked if the Countryman's absence hurt the team, Paysinger replied, "I don't know if it hurt us. We played well. We definitely miss him. We need him, but we played well."

Both teams capitalized on turnovers and

mistakes.

Beverly Hills opened the scoring on Brown's 14-yard run four plays after Ole Woods recovered Webster's fumble at the Panthers' 28-yard line.

The Normans increased their lead to 14-3 8:24 before halftime on Adams' two-yard run, six plays after a snap on an apparent fake punt went off the up back and punter Chris Whitehead was tackled for a seven-yard loss on Peninsula's 26-yard line.

A 34-yard return on the ensuing kickoff gave the Panthers the ball on the Beverly Hills 42-yard line. Seven plays later, Idah carried the ball for the fifth consecutive time, running one yard into the end zone cutting the deficit to 18. Holder Ian Escutia's two-point conversion run cut the deficit to 14-11.

Peninsula took an 18-14 lead 47 before halftime as Webster, playing linebacker, picked up a bad snap and ran 70 yards for a touchdown.

The Normans regained the lead, 21-18, as defensive lineman Madison Moore intercepted Imwalle's third pass (and last before the completion) and returned it 32 yards for a touchdown with 4:48 left in the third quarter.

Defensive back Matt Hezlep intercepted an Adams pass at the Panthers' 39-yard line with 1:27 remaining in the third quarter. Peninsula then drove 61 yards on eight plays, all runs and all but one by Idah, culminating with his 27-yard touchdown run with 8:52 to play.

Brown, the Beverly Hills offensive line, Adams and receiver Willie Green, who caught seven passes for 88 yards, drew praise for their play from Paysinger.

The Normans are 0-8-1 against Peninsula, formed in 1991 by the merger of Miraleste, Palos Verdes and Rolling Hills high schools. Friday's game was the first between the two teams since Nov. 7, 2003, when Beverly Hills overcame a 16-point third-quarter deficit to rally for a 23-23 tie.

The Normans are scheduled to play at Canyon (3-0) Friday in a nonleague game beginning at 7:30 p.m. The website Calpreps.com projects the Cowboys will win 62-7. Canyon was ranked second in the Southern Section Northern Division poll released Monday.

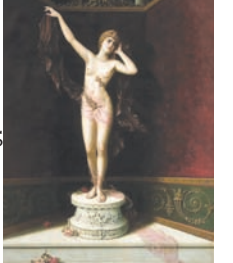

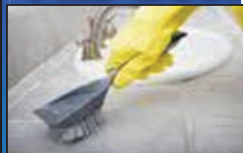
