Courier v. Metro

In its continued efforts to wrongfully denigrate our current Mayor Willie Brien, M.D., in Friday's editorial, the *Courier* attempts to create controversy where none has existed before and distorts facts in its efforts to do so. In response to the *Courier*'s prior attack for his attendance at a Metro event, Dr. Brien truthfully stated that there has been no controversy concerning the Metro subway station at Wilshire and La Cienega. In fact, the public hearings and the approvals for the station location are long behind us.

While claiming to double check its facts, the *Courier* apparently failed to do so in last week's editorial. The station box for the subway is projected to be about 1,000 feet long, not 2,000 feet, as claimed by the *Courier*; there is no plan to haul dirt from the station excavations 24/7; the street closures for the proposed subway construc-

tion will only be temporary, not permanent, because the excavated area will be covered by concrete decking for the vast majority of the time.

When challenged by Metro, Mr. Smith, in a Tuesday evening email blast, now concedes that he exaggerated ("a bit of exaggerating"), but since this was his editorial, he has the right to do so. Did he also exaggerate when he stated he double checks all of his facts?

Our Mayor understands that despite his continued opposition to tunneling under the high school, the City must keep good relations with Metro because the construction and excavation impacts and numerous possible mitigation measures to ease the burden on both residents and businesses will be the subject of numerous meetings and negotiations between the City and Metro.

For example, one proposal under consideration is for the excavation of the Wilshire/ La Cienega intersection to take place on weekends only for a period of 10 to 12 weeks, with the intersection covered and clear for use on weekdays.

There is no question that subway construction will result in intermittent disruption but most of us agree that the awards outweigh the pains. This is why the residents of Beverly Hills, in two separate elec-

7-Eleven loses appeal for Beverly Hills location

The Beverly Hills City Council voted 3-1 at the City Council formal meeting on Tuesday night to uphold the Planning Commission's decision that they could not make the required findings to approve a 7-Eleven at 401 S. Robertson Boulevard.

Vice Mayor John Mirisch recused himself because he lives within 500 feet of the proposed location. Councilmember Barry Brucker dissented.

Former Architectural Commissioner Fran Cohen represented 7-Eleven in the appeal hearing. The proposed location is currently a vacant lot that has been vacant since 2004. Previously, the site was the site of a gas station, but current regulations make the lot too small to be a gas station.

7-Eleven had gone before the Planning Commission in October of 2012 with an application for a conditional use permit to establish a convenience store and an application for an extended hours permit so the store could operate 24 hours a day.

The Planning Commission could not make the findings to approve the location because the commission found it was inconsistent with general plan policies, inconsistent with the southeast task force and efforts to enhance the area and would not contribute to the City brand image. The commission also felt there was an over-concentration of convenience stores in the area.

Cohen said the objective of the 7-Eleven was to bring a neighborhood market to the area with kosher and organic products. Cohen said the neighborhood market was consistent with the goals of the south east task force.

Cohen said the use of the store was harmonious with the surroundings. She said environmental and traffic impacts had shown there would not be negative impacts to the surroundings. The designs for the project included landscaping to minimize noise to the residents.

Cohen said given the size of the site, the site was not feasible for large development and the designs had been drawn with the goals of the task force in mind.

All members of the City council acknowledged that the architectural designs of the proposed store were well done.

Councilmember Julian Gold acknowledged the amount of work that had been done on the project and acknowledged that the 7-Eleven would be an improvement to what is currently on the site.

Gold said the council intentionally set standards different from what might be true in other parts of town.

"We wanted to ensure what happened there really does revitalize the area," said Gold, who supported the Planning Commission's decision.

Bosse said aesthetically the building is nice but because it would not be situated on the street level, it would not create a walkable experience.

"I do not believe that with this particular use that it is compatible in any way with what the south east task force goals are and these are goals that we initially, recently, put into place so they're not outdated. It does not agree with general plan goals and part of the goals of the city council and the task force is we want to revitalize this area and how we want to revitalize it is to have a pedestrian experience," said Councilmember Lili Bosse.

Brucker said he felt the project was "dead on arrival."

"It started with the brand and I think that's unfortunate," said Brucker.

Brucker said the area, with two gas stations and a minimart was probably not conducive to walking or strolling. Brucker said he would be ready to approve the project.

Mayor Willie Brien said he thought the project could be harmonious in the neighborhood, but said he had concerns with buffer areas for residents if the proposed store would be open 24 hours a day. Brien said he felt there already was an over-concentration of convenience stores in the area and could not support the project.

Off-leash dog park put on hold

The Beverly Hills City Council did not reach a consensus to move forward with an off-leash dog park at Roxbury Park.

The Recreation and Parks Commission and City Staff had previously recommended using a croquet field in Roxbury Park as an off-leash dog park. Council directed staff to reach out to the community.

After a Jan. 28 community meeting regarding a proposed off-leash dog park, staff brought an update to the City Council at the Feb. 5 study session.

Staff estimated there were approximately 80 to 90 people in attendance at the community meeting.

Councilmember Lili Bosse said she had attended the meeting and from her notes had gathered that 13 people spoke in favor of Roxbury as a location, 11 spoke against, and five spoke not in support or opposition to Roxbury. One speaker suggested the orange grove, which is located in the City of Los Angeles, and another mentioned the Century City mall as having a dog area.

"The issues that I see that we still need to address, for me, I certainly cannot make a recommendation that we do it absolutely at Roxbury," said Bosse. "There were some very good points that were brought up that I think we need to do our due diligence in getting the answers for."

Bosse said some issues that came out of the meeting was whether two dog areas -one for large dogs and one for small dogs -would be appropriate, the concept of double gates, whether a Beverly Hills dog license would be necessary, and whether the dogs needed to be spayed or neutered.

"We cannot let this become an issue between those who own homes and those who live in apartments," said Bosse. "We are all on the same page; we all love our animals."

Bosse also said there were concerns that owners will allow dogs off leash when not in the enclosed area. Bosse said that a dog park may not be safe if construction would be done at the community center for the

next year.

"Unfortunately what I think we need to go a better job at is reaching out to the community so they know that we're dealing with an issue," said Bosse.

Councilmember Barry Brucker, who also attended the community meeting, said some issues with the location were that it is undersized and adjacent to a preschool.

"I love the idea of a dog park and I would bring my dog often as much as possible but one of the things I think is really concerning is if people think it'll only be a park for local neighborhood dogs, they are sorely going to be surprised," said Brucker. "This will end up being a regional dog park."

Brucker said it would negatively impact parking.

Brucker said though there were differences of opinions, most people were respectful. Brucker suggested the baseball diamond at La Cienega Park, which is 104,000 square feet as a possible location, but that it would require creativity in relocating activities that take place there currently.

Brucker said he felt the idea needed further discussion.

Vice Mayor John Mirisch said Roxbury Park cannot be a good location if there are a divided number of people in support and against.

"We can't have a divisiveness, whatever the groups may be, whether its homeowners, renters or dog lovers versus cat lovers, whatever it may be, it's something that we would need to do to get the buy in of the community and it's clearly not there right now," said Mirisch.

Mirisch said it was a good idea to have a dog park, but is not ready at this moment. Mirisch said the questions raised for Roxbury should be the same questions that need to be answered at all possible locations.

"The process was basically to reach out to the community and we did that," said Mayor Willie Brien. "You all spoke up, came to the meeting and you expressed your concerns and I think raised a whole bunch of questions and some of those things are things that the five of us here don't always think about and that's the reason we go through the public process and I think that process worked."

Brien said even if there had been more support for Roxbury Park the council would need to hold more meetings. Brien said it would not go forward at the present time at Roxbury Park but assigned Vice Mayor John Mirisch and Councilmember Lili Bosse to form an ad hoc committee to look for other alternatives.

City Council unanimously appropriates \$7.74 million of \$10 million surplus

The Beverly Hills City Council unanimously appropriated \$7,740,000 of the City's \$10.24 million surplus at the formal meeting Tuesday night.

As discussed at the Jan. 24 study session, the council directed staff to appropriate \$1.25 million to the school district in exchange for use of space, \$1 million to the school district as an advance to the 9900 Wilshire Boulevard project, \$600,000 to police staffing and hiring incentives, \$690,000 to internal service funds, \$300,000 for a new paramedic ambulance, \$1.15 million to an OPEB contribution, \$500,000 to the storm water enterprise fund, \$250,000 to subway reserve funds, \$750,000 to Beverly Gardens Park fundraising matching funds, and \$1.25 million in land acquisition.

The remaining \$2.5 million has been reserved so the council can continue discussions regarding the Water Enterprise Fund and other items. Councilmembers had reached consensus on Jan. 24 to look into ways of offsetting a seven percent increase in water rate costs scheduled for July 1, 2013.

City's Natural Gas Fueling Station opens

The City's compressed natural gas fueling station on Third Street is now fully operational.

The station, which cost \$1.2 million, is

expected to save \$250,000 annually and pay back the City's investment in five to six years, according to a release by the City.

The California Air Resources Board has mandated converting diesel trucks to alternative fuels. The City of Beverly Hills received a \$550,000 grant fom the Southern California Air Quality Management District to offset costs. Of the grant, \$300,000 was used to fund the fueling station and the rest for the purchase of four compressed natural gas vehicles.

Additionally, the City has six compressed natural gas trash trucks, four street sweepers, a Honda Civic Sedan, and a truck for cleaning sewage pipes.

The station allows for both fast and slow refueling. The fast refueling is the equivalent amount of time at any gas station and slow refueling is an overnight process, but will pump more fuel because there is time to compress the gas.

The City heard a presentation on the station on Tuesday night at the formal meeting. The station has 20 slow refueling stations and 1 fast fill dispenser. Fred Simonson, Maintenance Operations Manager said the station has been running since November, but is now fully operational.

Countdown to Beverly Hills' Centennial begins

The Beverly Hills City Council announced a countdown to Beverly Hills Centennial celebration on the City website at the formal meeting on Tuesday night.

The countdown read 356 days, 4 hours,

31 minutes and the start of the city council formal meeting.

The City will turn 100 years old on January 28, 2014. Councilmember Lili Bosse announced that the centennial celebration committee led by Dick Rosenzweig, councilmember Barry Brucker and Bosse would be giving a full update on the centennial celebration at the council meeting on Feb. 19.

"To make sure we don't miss a moment

of this year long countdown, we have created a special countdown clock on the city centennial website page," said Bosse.

The City held a volunteer organizational meeting on Wednesday where they launched event committees, set meeting schedules and began developing initiatives.

"We hope to promote the Beverly Hills brand on a global scale and attract interest and participation from all over the nation *briefs cont. on page 6*

No 7-Eleven And other City notes

You probably had the same reaction when you heard a 7-Eleven wanted to open in my Beverly Hills: Not in my town, not ever.

Your perception of the chain was also probably similar. The stores were a target for gangs, armed robbery and the merchandise far below even convenience store standards. Just not right for Beverly Hills. Would we want a Burger King next to Spago? How about a Best Buy at Two Rodeo? Not in my village, or is that back yard?

As Councilmember **Barry Brucker** correctly pointed out during the store's appeal from a denial by the Planning Commission, the chain's image made their application "dead on arrival."

Members of the Planning Commission denied they had based their findings on "image" at all, but that they could not make the findings required by the codes. We have a very excellent commission, but I wonder if they are being entirely candid.

What we learned about this store's desire to build on a long– empty lot at Robertson and Olympic was a real surprise. First, the design of the structure would clearly upgrade a neglected City block. The concern about a neighboring private school was certainly answered when the City received a letter of support for the project from the school.

Only two residents appeared in opposition, but proponents were able to bring many more and also submitted support petitions from parents at nearby Horace Mann School. (These petitions might have been even more effective had the circulators explained that many were solicited by emails and copied by one person later. This information thanks to the ever sharp eyes of Councilmember **Julian Gold**).

With strong involvement by local residents, the store outlined a litany of food inventories that were very impressive: upscale food items and a large variety of Kosher offerings – especially meaningful for the nearby Orthodox Jewish community.

Actually, the whole presentation by **Fran Cohen**, a long time community activist and commissioner, was first rate. The testimony

by the architects, the independent, Cityapproved traffic engineer and corporate representatives were also excellent and, should have been, very convincing. Fran Cohen also made many offers to meet any objections on hours of operation and more if the council asked.

But Tuesday, the council voted three to one to uphold the Planning Commission and deny the appeal. Mayor **Willie Brien**, Councilmembers **Lili Bosse** and Dr. Julian Gold opposed and Brucker supported the appeal. Vice Mayor **John Mirisch** had to recuse himself because his home is near the site – a state mandated rule.

The council majority raised many relevant issues including traffic flow, how the development might impact more general plans for revitalization and more. But how much of this had to do with their perception of the store's history? They denied that was a major consideration and I have enough faith in their integrity to accept their statements – mostly.

Actually, looking at some nearby stores, I found them reasonably secure, clean and well managed, and they are everywhere around us. None had the look and feel of the designs presented to the City and had you seen the drawings at the hearings, you would have been very impressed.

But that raises the most important question. Again, granting the excellence of the council presentation, why didn't the proponents do more than just talk to Horace Mann parents and show their concept to the whole City? It might well have made a difference. As Mr. **Dooley** once said, and paraphrasing **Ring Lardner**'s fictional character: Yes, the Supreme Court is independent, but they do read the election news.

There was one historical parallel that stands out: About 40 years ago, Sears was interested in leasing space on Wilshire near the hotel. But then Mayor **Jack Freeman** mobilized the Chamber of Commerce and property owners to quickly derail the store's plans. Of course the best example of leasing controls is what happened on Rodeo Drive, thanks to the leadership of **Fred Hayman**, **Don Tronstein** and the **Mahboubi** family

Beverly High takes first in Super Quiz at L.A. County Academic Decathlon Competition

Beverly High's Academic Decathlon team took first place against 47 other schools in the county during the super quiz portion of the Los Angeles County Academic - they kept the famed street upscale from the start of revitalization to today's inventory of famed shops.

If there is a method to bring this back, with some revisions and responses to legitimate council and Planning Commission concerns, it could be worth the effort. However, next time the proponents need to make the same excellent arguments they gave the council to the whole community.

Mea Culpa, well at least partially. Last week when I wrote about my concerns about "giving" more funding to the school from a City "surprise" surplus, my interest was not just draining the City treasury but responsible fiscal planning by the school board and staff administration.

I also was, to put it softly, shocked by the amount of money being spent on lawyers – would you believe over \$400,000 in one fiscal quarter?

What I should have asked were two questions: What were the exact needs of the district to justify the City appropriation and why the high legal fees?

However, the board shares some blame, especially as to legal costs. When the district released the amounts paid, there was absolutely no mention that some of these legal fees were for other than lawyer's time and used for support consultants – in fact, according to our sources far more than half of the \$400,000.

What is also totally lacking, aside from data sharing, is some clarity on what information could be released under the Brown Act. I have the feeling that too many board actions are not made public because of some misunderstandings of our open government laws – the Brown Act. (The author was a state senator from a northern county and not a relative of either of our governor Brown's.)

Back to the City: In too many California cities, if the City manager walked into the mayor's office with some news about finances, the expected words would probably be "bankruptcy," but in our community with such really excellent financial managers and a responsible city council, we actually had an additional surprise surplus – over \$10 million, aside from our healthy, general financial condition.

This is certainly an important asset for the two councilmembers seeking reelection – of course, motivations for voting in our City are often very spread, sometimes even regional.

There just might be more interest in this

I totally admire the zeal and programs of the anti-gun activists, but I do have some concerns.

It seems that each time there is some horrendous mass killings; reform of gun control becomes a hot topic. Too often, when the memory of school shootings, mass murders in a movie theatre and the life altering wounding of a beloved congresswoman fade in memory.

Yes, we desperately need more effective gun control, and we need it now. Hand guns, assault rifles and other non-hunting weapons are now in the hands of the mentally disabled and others including street gangs.

What the control activists need to consider is protection of legitimate hunters' weapons and then turn to political reality.

Mass meetings, appearances at congressional hearings and more all are good but not what is really needed in the long-term. There will never, ever be real sound gun control until supporters build a network that could rival the activities of the National Rifle Association and the weapons industry.

Long after control activists have spent all their energy, the NRA will be in congressional districts all over the country ready to raise money to turn out of office control advocates – and they are well organized and well funded.

Gun control forces must be ready to do the same and over a longer period. Until that happens, the fears created by the NRA will have far more impact than all the mass rallies and hearings. All politics is retail and local.

It's a lot of pressure. You don't want to be the only one that's not getting the problems right," said Yoseph. "Everybody's staring at you, so it's like when someone shoots a free throw in a basketball game. All the pressure is on."

Scoring 65 out of 72 points, Beverly High scored 15 points higher than the second place team. The super quiz consists of oral questions on the topics of art, economics, literature, music, social science and science. Yoseph said the team has been preparing for for the decathlon since last spring.

Yoseph said the team finds out the total decathlon score on Feb. 13 and they are "very excited about that."

At the award ceremony, the first, second and third place winners will be announced. Last year, Beverly High got third and they're hoping to improve on that this year.

"That's when the kids pick up their awards, so I'm hoping for lot's of hardware," said Yoseph.

The Los Angeles Unified School District had its own decathlon competition over the weekend.

Beverly High grad reunited with lost class ring

Beverly High 1968 graduate Caroline Swan lost her class ring over 40 years ago while spending the day with friends at Venice Beach. Now, thanks to a Good Samaritan, it's back in her possession.

Though Swan is unclear about whether she lost it in 1968 or 1970, she said she would think about the ring from time to time and would feel angry.

"I remember thinking the people I was with must've stolen it," said Swan.

She said she had traded rings for the day with a surfer and when she went to return his ring, he told her he had lost hers. Swan said she believed the surfer still had the ring in his pocket.

Cally Barrier, a San Fernando Valley native and a Taft High School graduate, found the ring at Zuma Beach. Barrier who is five years younger than Swan has kept the ring in her possession for over 40 years.

The details are unclear as to how the ring traveled from Venice Beach, where originally lost, to Zuma Beach, where Barrier found it. Swan's theory is that the young surfer had stolen her ring and proceeded to lose it at Zuma Beach. Barrier said she would frequently go to Zuma Beach, but did not spend time at Venice Beach until years after she had found the ring.

"I remembered sitting there with my dad picking out how we should make it look and he's the one, he passed away about eight years ago, who said, 'the red stone would be nice,' so it does bring back a lot of memories," said Swan.

Swan said she never thought she would see the ring again.

"Well, I took good care of it for 45 years," said Barrier. Barrier, who is retired and worked for the sheriff's department for 30 years, said she made some attempts to reach Beverly High with little success but felt that now that she had more time, she had to find the owner. A few months ago, Barrier reached out to Beverly High and she was forwarded to the alumni association.

"I'm really touched," said Swan. "Isn't that amazing not just that she had it and she kept it, now 45 years later, she made the effort to get it back to me?"

Swan's late father Jeremy Swan was a cardiologist who worked at Cedars-Sinai for many years. He moved the family from Minnesota to Beverly Hills to attend the school system. Swan was one of the inventors of the pulmonary artery catheter, or sometimes known as the Swan-Ganz catheter.

When the *Weekly* received word from the Beverly High Alumni Association that someone had found a 1968 class ring with the initials CMS, the *Weekly* attempted to track down the owner. Of six Beverly High 1968 graduates with the initials C.S., three were found to have the middle initial, M. -- Christine Skirmuntt , Carl Switzky, and Carol Swan.

The Weekly reached out to Skirmuntt, a frequent Weekly reader

who still lives in Beverly Hills, but she was not the owner. Switzky and Swan were not current in the alumni database.

Switzky's address was listed on blockshopper along with Judith Brusslan, a co-property owner. Search results showed

Brusslan is a California State Swan's class of 1968 ring University Long Beach profes-

sor through, which we were able to reach Switzky. Once again, a dead end: Switzky was not the owner.

Switzky sent the *Weekly* a list of classmates who shared his initials, in which he clarified that Carol Swan's name is Caroline.

Searches with Swan's full name revealed her middle name is Mary. The *Weekly* could not find Swan's phone number listed, but was able to confirm names of her relatives via a 1992 *New York Times* obituary of her late sister, Katherine Swan Ginsburg. Swan, who has 7 siblings, has a brother, Jeremy, who lives in Studio City. Jeremy Swan owns a company with a listed phone number.

Jeremy Swan reached out to Caroline, who now lives in the Pico/Robertson neighborhood and confirmed she had lost her class ring over 40 years ago. She later told the *Weekly* her phone number was listed under C.M. Swan.

Swan said she had her hairdresser's license, worked in movies, and the insurance business, and when she turned 50 she received degrees in psychology, business law and management from CSU Northridge.

"It came as a shock," said Swan, as she wore the ring on her right pinky. "It feels very comfortable; it's like it isn't even there."

but is there any end in sight to the litigation? **By Andrea Aldana**

The Beverly Hills Unified School District the total payment for the quarter was paid paid Hill, Farrer & Burrill, LLP, the firm representing the district in the CEQA lawsuit against Metro, over \$439,000 in the final quarter of 2012, according to records obtained by the Weekly.

The firm represents BHUSD in the CEQA lawsuit against Metro, but also handles other

cases for the district. The CEQA case challenges the procedure Metro used to approve the environmental impact report and to approve the Westside Subway alignment under

Beverly High. The complaint claims Metro was legally bound to re-circulate the environmental impact report when new information was presented and re-open the public

comment period. "When a lawyer gets a case like this, his assignment is to do an investigation into the project history, the geotechnical data, the actions of the various governmental entities, and specifically the Metro, which is the one that is contended not to have followed the requirements of CEQA and then apply the law to the conclusions that are reached from that analysis," said Arnold Graham, an eminent domain attorney not affiliated with the case, who had represented property owners against Metro in building the Wilshire/ Western station.

Graham said the fees appeared to him to be very heavy, but noted he could only speculate without having seen the invoices. Graham said a CEOA case is fairly straight forward and not very complex for a lawyer that is qualified in land use matters.

"Instinctively, it says to me it's a high bill, but I'm saying that without knowing a lot of the details," said Graham.

Board of Education President Jake Manaster said that not all \$439,000 went to attorney fees.

The \$439,000 total is broken in to two payments -- one in the month of October and one in the month of December. Of the October payment of approximately \$160,000, 75 percent was related to geotechnical studies at Beverly High, according to Manaster. Of the December payment of \$220,000, about 80 to 85 percent was related to geotechnical studies at Beverly High.

Additionally, the remaining \$60,000 of

to a lobbyist firm, contracted through Hill, Farrer & Burrill. The \$60,000 payment is from the general fund.

The district paid Venable, a D.C. - based lobbying firm, over \$95,000 - about four times less than Hill, Farrer & Burrill -- in the same time period for NEPA litigation.

The NEPA lawsuit charges the Federal Authority with violating federal law by certifying the environmental impact report. Additionally, Venable has been contracted by the BHUSD at a rate of

\$15,000 a month for its federal lobbying efforts. Venable's lobbying contract with the

district is expected to end this month. "The vast majority of those expenditures

were for geotechnical work, which includes consulting and actually, the moving of earth, the analysis, and we have now completed our study of clearing the campus for safe building in the future," said Manaster.

According to Manaster, the work is billed through Hill, Farrer & Burrill to protect the documents and results. The analysis and report of the work is also protected and billed through Hill, Farrer & Burrill.

The recent fees include the geotechnical studies done in November at Beverly High on the Northwest corner of the campus. That area of the school had not yet been investigated and the California Geological Survey said they needed that information, according to Manaster.

"Trenching, especially when you're trenching around utilities, is very expensive unfortunately," said Hill, Farrer & Burrill partner Kevin Brogan, who is the lead attorney on the case. "It's a lot of different issues, but it has to do with the expense of getting equipment and things like that out there to get the job right."

Consultants that are paid through the law firm include Tim Buresh of Primesource Consulting, Leighton Engineering, Earth Consultants, and Miles D. Kenney of Kenney GeoScience, said Manaster.

Manaster said he does not expect any further geotechnical work at Beverly High and expects bills to drop in the future.

In 2012, the district paid \$2.58 million in legal and lobbying fees to seven firms. The payments to Hill, Farrer, & Burrill constitute

70 percent of the total fees, an equivalent to \$1.81 million.

Manaster said about \$1 million of the fees is related to trenching done at the high school earlier in the year.

"This was so we could prepare all the reports for the CEQA suit and the NEPA suit and by the way, most of the work was done as a response to requests from the California Geological Survey," said Manaster. "We could not build on the site after what we believe was an unfounded accusation that our campus had an active fault line running through it, such that it would be unbuildable in the future. We had to go and investigate that so that all of our plans in the future would be built on top of land that was safe."

Manaster said all the people working on the geotechnical data, as well as the firm, have given the district a discounted rate.

"On every bill that we get, there is a percentage that is discounted off the bill," said Manaster. "It ranges from 10 to 20 percent."

Brogan said there are two partners handling the CEQA case -- one who specializes in eminent domain and does CEQA and another who specializes in CEQA and does eminent domain. Though associates cost less, Brogan said they can be less efficient.

"Associates, their rates can be less, but because they have to research everything and learn it for the first time or second time or third time, it's much less efficient," said Brogan. "If we have something that's associate worthy and we can use a lower rate, we always do."

Brogan said that some weeks, work on the case can be very small and others more intense, but as they start working on briefs,

he expects the work to be more intense. Though he is unsure when the case will go to trial, his best guess is late 2013 or early 2014.

Brogan said he did not believe it is possible that the district would have to pay Metro's attorney fees if it loses the case. However, there are circumstances in which Metro would have to pay the district's attorney fees. There is a doctrine that "allows somebody who prevails in a CEQA case for the public benefit to recover their attorney fees," said Brogan.

This would not apply in the event the BHUSD's case is unsuccessful.

Manaster said that it is the Board's job to protect the schools.

"We have to fight and the legal challenge is the way that these things are usually worked out," said Manaster. "Even [Zev] Yaroslavsky said 'if you have a problem with it, your avenue to due process is to sue us,' which is what we've done."

Yaroslavsky criticized the Board of Education for spending so much money on attorneys when he addressed the Beverly Hills Rotary Club in November.

"Let's get in a room. Let's resolve this. There's a basis to resolve it without spending money that can be used to educate kids," he said.

Yaroslavsky also said that if the school district wins, it would force Metro to redo the environmental impact report where it is deficient and then approve it.

"It's not going to change the routing of subway tunnel. Just the school district alone will spend millions of dollars on lawyers pursuing a case that in the end they can't win," said Yaroslavsky in November.

Charlie Stansbury Named Norman Football Coach Son of former coach comes to BHHS from Golden West College By Steven Herbert

Charlie Stansbury was named as Beverly High's football coach Wednesday, nearly 23 years after his father Bill left the position.

The younger Stansbury had been the offensive coordinator and offensive line coach at Golden West College in Huntington Beach since 2009. He was an assistant coach at the University of San Diego in 2002, Concord University in West Virginia from 2003-2005 and Santa Barbara City College from 2006-2007. He was a graduate assistant at San Diego State in 2008.

Charlie Stansbury, 33, said the hiring fulfills his goal of becoming a head coach. He said he had some familiarity with the Beverly Hills program because two players on the 2012 Rustlers, receiver Frank Brown and linebacker Jeremy Bruce, played for the Normans.

Charlie Stansbury said he talked with his father "a little bit" as he went through the interview process "to see what his thoughts were" about the Beverly Hills program.

Charlie Stansbury said the Normans' 2-8 records each of the past two seasons is "some-what" of a concern, but "you don't want to really look too much into what they've done, you want to keep things moving forward."

Charlie Stansbury was among six finalists interviewed for the position Tuesday by a panel that included Beverly Hills' co-athletic directors Jason Newman and Vonzie Paysinger.

"We had a very difficult time trying to determine just who we were going to hire, because we had six excellent candidates," Newman said.

Newman cited Stansbury's experience, including coaching various positions, and football knowledge as reasons for the hiring.

Newman coached and taught physical education when the elder Stansbury was at the school. Newman said the only help Charlie Stansbury received in the hiring process from being Bill Stansbury's son was that "when we saw his name, we knew his stock, because we've know him since he was 3 years old."

"However, that alone would not have been enough for him to get the job because at the end of the day, we have to hire a person who's going to help return our program to prominence," Newman said.

Charlie Stansbury succeeds Donald Paysinger who resigned after four seasons as coach. Coincidentally, Carter Paysinger, a brother of Donald and Vonzie Paysinger, succeeded Bill Stansbury and fellow co-coach Dick Billingsley as coach in 1990, remaining in the position through 2008.

Bill Stansbury held or shared the Normans' head football coaching position from 1981-89, resigning in the spring of 1990 to accept a similar position at Paso Robles High. When his father was a Beverly Hills co-coach in 1989, Charlie Stansbury served as a water boy and ball boy for the team.

Charlie Stansbury played fullback and tight end at Paso Robles for his father, with his high school playing career ending with a Southern Section playoff loss to the Normans.

Cross Country

Beverly High senior Sydney Segal, the CIF state Division III girls' cross country champion, has made a non-binding verbal commitment to attend Columbia University to compete in cross country and track and field.

"I decided to pick Columbia because in the end, I wanted to take a risk," said Segal who also made official visits to Syracuse and California. "I enjoyed all three."

Segal said one element in her choice was "where do I see myself living." She first eliminated Syracuse because "it wasn't the big city, it wasn't my personality."

Columbia "had a lot more pros" than California, but "then it also had a little more cons," Segal said.

"It was a just little more exciting and I decided in the end, I wanted to take a risk and

try something new," Segal said. The risk is "leaving home," Segal said.

Under NCAA rules, Segal could have made official visits to two more schools, but decided not to because "adding more schools to the equation just makes things a lot more stressful," she said.

Segal said she plans to enter Columbia without declaring a major, but would like to major in either communications or linguistics to help her fulfill her goal of becoming a television host.

Columbia, like each of the other seven Ivy League universities, does not give athletic scholarships. Because it does not give athletic scholarships, its athletes do not sign letters of intent. Under NCAA rules, coaches cannot comment on athletes until their signed letter of intent is received or they arrive on campus. Although Columbia does not give athletic scholarships, its athletes may receive needand merit-based financial aid.

"My dad told me to work on getting into the school and then once I get in and I'm on the team and running well, I can focus on getting grants later in my career," Segal said.

Girls' Soccer Culver City 1, Beverly Hills 0

The Normans allowed an own goal late in the second half Jan. 23 at Culver City in a game to decide the Ocean League lead.

The goal came "on a cross that appeared to be going wide of the goal, and a missed clearance" attempt by a Beverly Hills player at the back post, Norman coach Ryan Franks said.

"Own goals are part of the game, they hap-

pen," Franks said after his team fell to 8-7-2, 4-1 in league play. "We just needed to create more scoring opportunities for ourselves if we were going to beat a very good Culver team at their place."

Franks described the game as "a strange game in that both teams were battling it out in midfield and minimal scoring opportunities were presented for either team."
