## Korbatov files for re-election

Board of Education member Lisa Korbatov is officially a candidate in the race for Board of Education.

"I am running again because I have not completed the

entire job that I set out to do four years ago," said Korbatov, who was first elected in 2009.

Korbatov said she will run again to ensure that the subways tunnels do not run under "the heart of [the district's] only high school." Korbatov said she supported mass transit but there are better routes than under Beverly High's campus.

"I believe the route will literally make building out our district for the future nearly impossible, extremely difficult and arduous and pose risks that I think are intolerable for our community, our students, and our staff," said Korbatov. "I am not willing to let Metro determine our fate."

Korbatov said she is also running because she believes the voters should weigh in on how the Measure E bond should be reconfigured at an upcoming election.

The date of that election has not been discussed by the Board of Education.

Korbatov also said the district needs to continue to embed technology in the curriculum, reinvigorate the libraries with certified library media teachers and ensure the financial viability of the district.

Korbatov filed on August 1 and is the third official candidate in the race. Citizens' Oversight Committee member Howard Goldstein and Beverly Hills dentist James Fabe have also filed for candidacy.

Two seats on the Board are up in November. Election day is on November 5.

## Candidates may still run for Board of Education

The last day to file for the November Board of Education election is tomorrow,

Friday, August 9. However, if Board of Education President Jake Manaster does not file, as he has indicated he will not, the filing period will be extended for new candidates until August 14.

Candidates must be registered voters in the BHUSD area. Filing fees and nomination petitions are not required. Interested parties must file a declaration of candidacy with the Los Angeles County Clerk/Registrar Recorder.

## City gives direction to subsidize Courier's use of Greystone

The Beverly Hills City Council directed staff to use funds budgeted for marketing in the Centennial's budget to waive fees for the Beverly Hills Courier's use of Greystone Mansion on Friday, Aug 9.

The Courier requested the City waive the City's commercial photography fees of \$2,598 for a full day of shooting at Greystone for its "Fashion Forward" section. The Courier believes that the promotional visibility for Greystone merits the fee being waived, according to the staff report.

Courier Associate Publisher Marcia Hobbs said the supplement was a Centennial supplement to support the kick off and feature some of the centennial events, such as the 100th anniversary of the bridle trail and watch week.

Hobbs said it was the Courier's intent to do two supplements over term of the centennial, one coinciding with the city's 100th birthday in January and one in the fall, as a kickoff to watch week and the bridle trail.

Councilmember Willie Brien was concerned that any for-profit company within the city could come before the city with a similar request. Brien proposed using funds budgeted for marketing in the centennial budget, which was supported by Councilmember Julian Gold.

"My concern would be ultimately we're setting a precedent if we actually pay for it with actual dollars. Next time someone comes and there's not a budget, where are we doing to take it from?" said Mayor John Mirisch.

Vice Mayor Lili Bosse and Mirisch said they were prepared to support the proposal as it was presented.

"I think much like the mayor said when

we're dealing with the shield at times, we have waived it because we decided it was for a public benefit. I think we're talking about a business that really is our newspaper in our city and represents how we get our word out," said Bosse.

Bosse said in exchange for foregoing city revenue of over \$2,500, the city would receive a supplement with pages of editorial and advertising for the Centennial, city events, and Greystone.

Mirisch said he was prepared to support the request even if the supplement was not for the centennial celebration.

"If this were the fall supplement and they were going to do something on Greystone, to me there's a value that they're highlighting one of the city's jewel properties as opposed to going somewhere else for the shoot," said Mirisch.

Councilmember Nancy Krasne agreed with Brien's proposal and suggested hard costs spent on park rangers or clean up be paid with the centennial budget.

## Traffic and Parking Commission tables parking regulation request on North Crescent

The Traffic and Parking Commission tabled a request for a parking regulation on the 700 block of North Crescent at the commission's meeting on Aug. 1.

The request was resident-initiated and is to establish a daytime parking restriction with a non-permit regulation of two hours, 8 a.m. to 6 p.m. except on Sunday.

The proposed Zone Text Amendment and Lot Line Adjustment have been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City, and have been determined to be exempt from CEQA pursuant to Article 5, Section 15061 (b)(3) of the Guidelines, which states that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Since the proposed Zone Text Amendment and Lot Line Adjustment would not result in physical changes to the property other than the relocation of property lines, no potential for causing a significant effect on the environment exists, and therefore, the project is exempt from CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

"The commission ended up voting to table the proposal for the moment because there was a lot of interesting comments from people who actually did not want the time restrictions," said Traffic and Parking Commission Vice Chair Andy Licht.

According to the staff report, the block has 23 single-family homes with approximately 58 on-street parking spaces.

In June, the city received a petition signed by 65 percent of the homes on 700 block of North Crescent requesting a two hour non-permit regulation.

Judson Mock, a 700 North Crescent resident, submitted the petition requesting a change in the regulations. Mock, in a letter to the transportation department, said many vehicles park for extended hours on the block. Mock said that for years it was a "tolerable annoyance," but in recent years has become much worse.

Licht said some other residents on the block enjoyed the freedom of having friends and family be able to park for

extended hours in front of their homes. Licht said the issues with the parking tended to be more prevalent on the south side of the 700 block.

"Some ideas were put on the table as to alternatives. One [was] lengthening the two hour restriction to maybe three or four hours and [another was] possibly shortening the hours when it was enforced," said Licht.

Jay Foonberg, resident of the 700 block of North Rexford, said he opposed a parking regulation on North Crescent because the regulation would just push the long term parkers to other streets. Foonberg appeared before the commission asking that they include a larger area in the study.

Transportation planner Martha Eros said the commission's decision is limited to the 700 block of North Crescent in response to the resident-initiated petition.

Eros said they will look at surrounding streets, but the decision will be limited to the Crescent block.

According to a parking occupancy survey on the 700 block of North Crescent Drive on July 11, long-term commuter parking concentrated at the south end of the block and duration averaged 8.5 hours.

Thirty-two percent of the spaces were occupied on average with peak occupancy of 41 percent, according to the survey.

Staff will investigate the issue further, which will return to the commission at a later date. Eros said a study will take place when school is in session to include impacts on parking caused by Hawthorne School. The city expects to conduct the study towards the end of September once school traffic normalizes.

The item will return to the commission in October or November.

The commission also recommended the city review parking zone U on the south side of the 9800 block of Charleville Boulevard.

Two households on the corner of La Peer and Charleville are in a different parking zone and are not able to park in front of their homes on Charleville. The commission recommended the zones be modified to allow those owners to park in front of their houses.

The city council will make the final decision.

the 400 block of North Crescent Drive to prepare and hold the Wallis Annenberg Center for Performing Art's Inaugural Gala on Oct. 17 and 18.

Opening event celebrations for the center will take place the week of October 14 through October 18. The Inaugural Gala will be held on Oct. 17 with a second Gala to be held on Oct. 18.

The Gala event will be held in a large tent on Crescent Drive in between North and South Santa Monica Boulevard. Attendance to the Galas will have special security and be by invitation only for approximately 1,000 guests on Oct. 17 and 500 guests on Oct. 18, according to a letter sent to the City Council from Annenberg Board of Directors Chairman Jerry Magnin.

Festivities earlier in the week, beginning on Oct. 14, include tours of the facilities, cocktail receptions, and a special performance in the Goldsmith Theatre, according to the staff report.

Annenberg had proposed a two week closure, which was extended to three weeks due to the extra amount of costs associated with completion in less time. Krasne said the cost of tenting was expensive.

“I’m not happy with closing Crescent but as Jerry Magnin said, this is a once in a lifetime deal,” said Krasne, who said she wanted communication from the Annenberg in writing that they would not ask for future street closures of Crescent Drive.

Community Services Administrator Gisele Grable said the liaisons had given pre-approval given the once in a lifetime nature of the opening of the center, but that the liaisons agreed that any future requests for street closures would be highly scrutinized. Bosse said they had discussed that street closures would not happen often.

“For this amazing event, which is actually before our centennial, it means that in our first 100 years, we would have had a world class performing arts center open and it’s about time,” said Mayor John Mirisch.

Proposed centennial budget presented at Aug. 6 study session.

### Centennial budget projected to be \$1.35 million

The City Council has allocated \$950,000 of city funding from the tourism and marketing budget for the centennial. A Rolex/Gearys sponsorship provides \$300,000 and a Mercedes-Benz of Beverly Hills sponsorship will provide an additional \$100,000.

The city has spent \$222,250 to date. Events proposed in chart above are expected to cost \$974,000. Staff also estimates an additional \$100,000 will be spent on staff such as

park rangers, police, and fire.

The city council was prepared to move forward with most of the proposed events. Councilmembers will discuss the 100th birthday block party, the Beverly Hills documentary and the sister city funding at a later date. Councilmembers wanted more details on both the block party and the documentary. There was also concern of the block party date being on a Tuesday as well as the chance of rain in January.

### North Bedford Craftsman House designated as local landmark

The Anthony-Kerry House located at 910 North Bedford Drive became the city's 14th landmark on Tuesday night, when the city council voted unanimously to place the property on the local register of historic places.

"I've put quite a bit of my soul into protecting it," said property owner Leslie Dixon, who said she has owned the home for 20 years. "I'm worried about its future. I won't live here forever and I hope when that ugly day comes that I have to part with it that it remain and become much more difficult for some subsequent person to tear down."

The property, which was constructed in 1909, was designed by Greene and Greene, who appear on the City's list of master architects.

"The Greene Brothers are considered the Frank Lloyd Wright of the arts and crafts movement in Southern California and this was maybe one of only two homes on the Westside that they designed – the other being in Santa Monica and being altered beyond recognition," Dixon said. "This one still looks like the homes in Pasadena both inside and out and all of the original features particularly on the exterior are still intact."

The house was originally located in a neighborhood west of downtown Los Angeles. Earle C. Anthony, one of the namesake's for the property, hired Greene and Greene to design his home. The house was moved to Beverly Hills to its current location in 1923 to be the home of Mr. and Mrs. Norman Kerry, a silent film star, according to the staff report.

The landmark evaluation report prepared by Ostashay & Associates, the city's historic consultant, said the property "is the best extant example of Craftsman architecture in Beverly Hills."

Vice Mayor Lili Bosse thanked Dixon for taking care of the property. Mayor John Mirisch thanked her for wanting to have the property landmarked.

### Twenty minute meters installed on north side of South Santa Monica in compromise reached with property owner

Three existing parking meters on the north side of South Santa Monica Boulevard in between Rodeo and Beverly Drives have been converted to 20-minute meters, as a result of a compromise between the City and a local property owner.

On July 11, the Traffic and Parking Commission discussed and rejected a request from a local property owner that would have eliminated a left turn lane on South Santa Monica Boulevard between Beverly and Rodeo Drives. The left-turn lane currently allows vehicles traveling westbound to turn into an alley in between Rodeo and Beverly Drives.

The request came from Sunny Sassoon, president of Sunvic Properties, and partial owner of a commercial building on South Santa Monica, where the left-turn lane is currently located. Removal of the lane would have allowed for additional metered parking spaces directly in front

of Sassoon's property. Additional parking may not be accommodated without the removal of the lane.

Sassoon wrote in a letter that the lack of parking on the street has been "detrimental" to the small businesses operating out of the property.

In response to the request, the city received 22 letters in opposition from surrounding business owners who depend on the left turn lane and the commission did not support the request.

There were four existing parking meters on the north side of the street. The first three as one travels east from Rodeo were two hour parking meters and the fourth one was a 20 minute parking meter, according to Transportation Planner Martha Eros.

The three two-hour meters were replaced by 20 minute meters on July 23. The decision was made on July 11 following the commission meeting.

"That way the turnaround can occur for those small businesses on the north side of South Santa Monica," said Eros.

## City Council denies mayor's request to discuss items only when councilmember who requests item is present

The Beverly Hills City Council on a 3-2 consensus did not support a request by Mayor John Mirisch that an item on the study session only be discussed if the councilmember who requested the item is present, unless the issue is time sensitive.

At the study session on July 16, two items were discussed that had been placed on the agenda at the mayor's request though he did not attend the study session.

"I just think it's a matter of common courtesy that if there's something that is not time sensitive, whoever it is who requested it should be able to be there to tee it up and discuss it," said Mirisch.

Councilmembers Nancy Krasne, Willie Brien and Julian Gold did not support the proposal. Krasne said councilmembers are expected to be available on the first and third Thursday of every month.

"When I ran for council, I knew I wasn't taking any trips that would interfere with those days and if I do, I was going to miss a meeting, and that's how it goes," said Krasne. "When we ran, we accepted that obligation to be here and if I put something on the calendar and I'm sick, I want it discussed... The boats sail, the planes fly, and the trains run whether I'm here or not. So if I miss it, I missed it."

Gold said if the council keeps delaying items, the agenda will keep growing and the chances of councilmembers missing meetings are rare.

Vice Mayor Lili Bosse said she felt very strongly that if a councilmember has put an item on the agenda, it's because it is something that they are passionate about and have done the research on.

"Out of common courtesy to the councilmember who put it on the agenda, I feel we should not discuss it because I don't feel that we really understand just by a staff report as to why they put it on there," said Bosse.

Though there was not support for the proposal, Mirisch said a councilmember could withdraw the request and resubmit it and the mayor could also choose to postpone the item as a matter of courtesy.

## City carries out disabled parking sweeps to combat misuse and gather data

The city has begun a series of monthly sweeps to record use of disabled placards on popular Beverly Hills city streets in order to gather data and reduce misuse of disabled placards, according to Parking Enforcement Manager Russell Platamone.

Both the City Council and the traffic and parking commission have made it a priority to address complaints from the community regarding disabled placard use, Platamone said.

Most complaints from the community are that people use the placards to park in the business area for extended periods of time and that some people who park with placards exit their cars and appear to be fine.

The City did an experimental sweep in April and in May. Over the next few months, the City hopes to carry out about four to eight a month, said Platamone. Two sweeps have been conducted in August so far.


"The thing with the enforcement is a lot of people think we're just going out for the citations, but we're actually documenting

every placard we get and we run it through the system," said Platamone.

Platamone said the report to the commission will show that there are some who use disabled placards legitimately. There have also been cases of misuse, which is when a person is using a placard that doesn't belong to them. Some placards have been found to be invalid, which can mean the placards, issued every two years, have expired.

Platamone said that four or five reports must be written for every placard confiscation. So far, 40 to 50 placards have been confiscated.

"We're trying to get the misuse cut back. That's done by citations," said Platamone. "We're hoping in the next three to six months, we can come back with statistics indicating there is or there isn't [misuse in the city.] Collecting the data on the good disabled placards gives us a better reference to what the actual violations are."

As part of the experimental sweeps in April, three parking enforcement units observed parking on Canon, Camden, and Beverly Drives, and Brighton Way to see how many placards the units would be able to observe and enforce.

"The sweeps themselves have been pretty successful and what we've done is [extra money has been] allocated for the next few months," Platamone said. "We're going to place one unit of two people in areas where we have received complaints from citizens that are concerned about it."

The sweeps may last four to six hours depending on the number of placards confiscated. The sweeps are scheduled based on availability of officers, who participate in the sweeps by volunteering to participate for overtime pay.

Platamone expects to report back to the traffic and parking commission in the next four months.

## City Council decides not to pass resolution regarding acceleration of Measure E

The Beverly Hills City Council did not take a position on the Board of Education's decision to accelerate the Measure E bond tax rate for the 2013 to 2014 fiscal year at the formal meeting on Tuesday night.

The council had previously tabled a resolution on July 16 that asked the Board of Education to rescind the Measure E acceleration voted on by the Board on June 25 and take the decision to raise the tax rate back to the voters.

During the discussion at the formal meeting on Tuesday night, councilmembers individually expressed their opinions, in which they all agreed that a promise had been made and acceleration of the property tax rate associated with Measure E should be decided by the voters.

However, the consensus of the council was that a resolution was not necessary.

Councilmember Willie Brien said passing a resolution did not have a solid end result.

"They have heard all of you and all of us and are keenly aware that there is not support," said Brien, who said a resolution

would only inflame the Board of Education who was already aware of the opinions of the City Council.

Vice Mayor Lili Bosse said her opinions regarding the acceleration had not changed but that she saw there was nothing to be gained by passing a resolution.

At the formal Board of Education meeting on June 25, the Board adopted a resolution on a 4-1 vote asking the county to increase the tax rate to facilitate issuance of bonds up to \$95 million. In addition, the Board directed district staff to draft a new ballot measure that would replace the remaining Measure E bonds if passed. The measure will be placed on a future ballot. The Board has not yet discussed the timing of the new election.

Mayor John Mirisch supported a resolution. He said the city council as a body voted on a resolution to support Measure E in 2008.

He said he was concerned with what would happen if the voters rejected a new bond measure. A letter sent to the city council from the school district said the Board has not discussed what position it will take on issuance of Measure E bonds if a new measure does not pass.

The tax rate will increase for the current year. The Board must vote again to issue the bonds. If no bonds are issued in the 2013 and 2014 fiscal year, the tax rate will fall to \$0 in the 2014 and 2015 fiscal year.

The Board of Education suggested the new measure as a compromise for many residents who attended the school board meeting asking the Board to take the decision back to the voters.

Former Mayor Robert K. Tanenbaum and Municipal League Chairman Thomas White spoke in favor of the council resolution at the formal meeting.

## Gas Line ruptures at 9357 Third Street on Wednesday

A construction crew building a warehouse ruptured a gas line at 9357 Third Street yesterday at approximately 3 p.m.

The buildings between Third Street, North Foothill, and Civic Center Drive were evacuated. Evacuees were sent to the Municipal Gallery at City Hall. Evacuated buildings included the City of Beverly Hills Public Works building, UTA Talent Agency, and Live Nation.

No injuries were reported.

## City discusses 2013 Holiday Décor Program; ice rink will not return

The City Council discussed the 2013 Holiday Décor Program at the study session on Tuesday.

The Rodeo Drive/Special Events/Holiday Committee consists of Councilmember Nancy Krasne and Vice Mayor Lili Bosse. The committee recommended the 2012 holiday program be replicated this year. The committee recommended infusing more color into the program and installing warm white lights for trees in the commercial area.

The committee met on June 25 to evaluate last year's program, review feedback from the city's partner organizations and develop options for this year's program,

## Beverly Hills celebrates National Night Out

The Beverly Hills Police and Fire Departments, Library and Community Services, and the Office of Emergency Management celebrated "National Night Out" on Tuesday night.

according to Marketing and Sustainability Manager Megan Roach.

Krasne asked if the incandescent warm lights stayed on the trees year long. Roach said the lights had a shelf-life of one holiday season because they weather during program.

"We are starting to phase in LED lights because now the technology is such that they make warm, white LEDs and these have a shelf life of two to three years so we are proposing to phase them in starting this year with the Rodeo sidewalk Palms and the trees on Canon," said Roach, who said the LED lights will be stored and cut down on costs for the following year.

Brien said he supported the LED lights.

Roach said because they are much more expensive, the city is phasing the LED lights into the program to stay within the budget.

Mayor John Mirisch suggested looking for lights that are more robust and last more than three years.

The committee recommended a total décor budget of \$500,000 or less, excluding Rodeo Drive. The budget includes installing "Joy to the Hills" holiday banners in the business triangle, adding warm white lights and red bows to the garlands on N. Canon Drive, adding warm white lights to the ficus trees on Camden Drive, adding more multi-colored ball spheres to the ficus trees on South Beverly Drive and to provide holiday music on N. Beverly Drive and N. Rodeo Drive.

The city has a contract with Utopia Entertainment, a full service design and production company. The contract with Utopia is for a total of \$488,594, according to the staff report.

The committee also recommended that the city not proceed with an ice skating rink this year due to lack of support for a Crescent Street closure.

The holiday décor program is seven

weeks long.

As part of the 2013-2014 funding request, the Rodeo Drive Committee is requesting \$168,000 to replicate the 2012 holiday décor program for the street. The liaison recommended accepting the Rodeo Drive Committee's request.

## City contracts Phoenix Decorating Company for 2014 Rose Parade Float

The Beverly Hills City Council voted 4-1 to approve an agreement with Phoenix Decorating Company for the 2014 Pasadena Tournament of Roses Parade Float and a purchase order of a not-to-exceed amount of \$250,000 at the formal meeting on Tuesday night.

Councilmember Willie Brien dissented.

During the study session on Tuesday, Brien said he did not support the idea of the float and would rather money be spent on centennial events within the city.

Of the \$275,000 allocated for the float by the Centennial Committee, the remaining \$25,000 will be used for community outreach, advertising and transportation to Pasadena from Beverly Hills.

Phoenix Decorating Company was chosen from three firms interviewed by Centennial Committee Chairman Dick Rosenzweig, Vice Mayor Lili Bosse, Bill Crowe and Nancy McCready. Phoenix Decorating Company has built 713 floats for 31 rose parades, according to the staff report.

Beverly Hills has not had a float in the Tournament of Roses parade since 2011. In 2011, the City Council voted to cover the cost of the float when the Beverly Hills Tournament of Roses Committee did not raise enough funds to cover the float's expenses.

## FINDING A CURE

### Beverly Hills residents share their personal experiences with life saving marrow transplants

The National Bone Marrow Donor Program is a registry that connects patients with life threatening blood based diseases like leukemia and lymphoma or other diseases with donors for a life-saving marrow transplant. We spoke with some residents who donated or received a life-saving transplant.

#### ISABEL HACKER PBSC DONOR



Hawthorne parent Isabel Hacker joined the registry when she was a student at UC Riverside in 1993. Her biology professor had offered extra credit for those who signed up for the registry because the National Bone Marrow Program was visiting the campus.

They had told her that the chances of her being called were like winning the lottery. Imagine her surprise when she received a call in 2006 and ended up being a perfect match with an unrelated man, who lives in Washington State.

Paul Leland, a former senior environmental planner with King County Metro Transit, had been diagnosed with acute myelogenous leukemia in the summer of 2005. Chemotherapy put Leland's leukemia in remission. Doctors told him there was 100 percent chance that the leukemia would return without a stem cell

transplant. It was six months before Leland was matched with Hacker.

Leland's siblings were not good matches for him. Typically, matches have similar ethnic backgrounds, but in this case, Leland is of British and German descent and Hacker is of Hispanic descent. Nevertheless, they were a perfect match.

"I was surprised that they actually found me because I had moved three times since and my last name is no longer Berver. I had registered under my maiden name," said Hacker.

She received a call prior to running a marathon. She donated a week after running the marathon.

Hacker donated through PBSC, or peripheral blood stem cells, donations which account for seventy percent of transplants.

PBSC donation is a nonsurgical procedure in which a donor's blood is removed through a needle in one arm and passed through a machine that separates out the blood-forming cells. The remaining blood is returned through the other arm. For five days leading up to the transfusion, donors are injected with neupogen, a drug which increases the number of white blood cells in the donor's body.

Hacker said she felt side effects from the neupogen injections, and later got a migraine, which she was told was normal.

Hacker said the procedure was over two days. She donated at UCLA and went in at seven in the morning and got home around 5:30 before going back the following day.

"Other than being a little uncomfortable around the vein area, it wasn't so bad. I was just exhausted," said Hacker. "But it was awesome. They wrote to me maybe two years later [asking if] I would like to release my information because the donor would like to meet [me]."

Leland said he was on strong immunosuppressant drugs for about a year after the procedure, as the body adjusted to a new immune system, but is now on very mild immunosuppressants. Leland said he goes back for routine checkups every three to six months.

Hacker and Leland communicated without knowing their contact information for a year following the procedure. Once a year had passed, Leland and his wife flew to Beverly Hills to meet her.

"That was a wonderful experience," said Leland. "She's one of the two angels in my life -- my wife and Isabel."

Leland said he sends Hacker a thank you card annually on the anniversary of the transplant.

"What was interesting to me was that he showed us pictures of what he looked like before the procedure and he was in a bed in the hospital with machines hooked up to him and he looked terrible," said Hacker. "He looked extremely healthy when we saw him."

Hacker said she received a poster two years ago for Leland's 70th birthday and his grandkids, his sister, his brother, nieces and nephews had all written to her saying thank you.

"Each happy day that I have, I realize that I have her to thank for it," said Leland.

"I think the rewards and the benefits of giving are much greater than receiving," said Hacker. "I just feel it was such a simple procedure. It was a little uncomfortable, but when you hear from the wife and the kids, it has changed and transformed their life. I think it's so amazing," said Hacker. "I feel really lucky that I was able to do this for somebody. It's just amazing that science has come so far and we should lend ourselves to that opportunity."

#### COUNCILMEMBER JULIAN GOLD PBSC RECIPIENT



Councilmember Julian Gold woke up one Sunday in September of 2006 in a cold sweat. The next day, he was diagnosed with acute myeloid leukemia.

After a few rounds of chemotherapy, Gold received a bone marrow transplant on Dec. 28, 2006.

"I was fortunate. They don't tell you who your donor is until a year later assuming both the donor and the recipient want to know and we did," said Gold. "In the year, you're allowed to communicate with the donor but it is very redacted. You don't know who or where they are."

Gold said the normally a person's white cell count will be between 5,000 and 12,000. His got up to 55,000, he said. The chemotherapy gets your white blood count down to zero.

"Then, the bone marrow comes back and you hope that the cells that grow from it don't have leukemia cells and if that's true, then you're in remission. Even if you are in remission, they'll do [chemotherapy] a second time and that's called consolidation," said Gold. "It's essentially the same as the first but the idea is if there are a couple of remaining cells in there, this will get rid of those."

Gold said his donor, who he wished to keep anonymous, had to donate twice because they could not take enough in one sitting.

"It turned out that the second time around was the day of his grandmother's funeral and his family told him that his grandmother would understand that he needed to go give the cells, which is what he did," said Gold.

Gold met the donor a year after the procedure. Gold said his donor joined the registry because someone in his neighborhood needed a donor and had only been in the registry for six months prior to donating his cells.

"It was pretty amazing. The City of Hope organized an annual survivor's luncheon and so they had two donor-recipient pairs who they featured and so they brought him up behind a curtain," said Gold. "The weird thing is he sort of looks like me. It was really strange."

Gold's wife, Michele, keeps in touch with him by email about three to four times a year.

"It saves lives," said Gold. "There's nothing more you can say other than that for not a whole lot of effort from your part, you can save somebody's life and that's a big deal."

#### RONITA RABBANI PBSC DONOR



Ronita Rabbani, 24, had forgotten she had signed up for the National Bone Marrow Registry in Israel when she received a call that she was a tentative match for a leukemia patient.

After receiving the call, Rabbani found out she was a 12 out of 12 DNA match and donated marrow twice -- once in 2010 and once in 2011 because the patient had gotten sick again.

"I felt like it was my duty," she said. "It's me. I'm the only person who can do it."

Rabbani had signed up for the donor registry, through Gift of Life, a nonprofit organization that registers potential marrow donors. Rabbani flew to New York to donate through PBSC.

"Physically, it was the coolest thing ever because my skin cleared up. I think I lost a couple of pounds. It felt like a complete cleanse," said Rabbani. "Emotionally, I never really felt like I did anything and I still really don't because I never saw the patient sick and I never met the patient so I feel like I just went to the doctor a few times."

Rabbani had matched with a 39 year old leukemia patient. To this day, she never met her match. Both transfusions had lasted eight hours. Rabbani said the length of the donation depends on the size of the recipient.

"It's really not what people think it is. It's a very easy procedure. It may be uncomfortable but it's not painful," said Rabbani. "The odds of you being a match are [very low]. If you're that one, come on. You have to do it."


