

Korbatov, Goldstein win Board of Education election

In the contest for two seats on the B H U S D Board of Education, incumbent Lisa Korbatov and former Horace Mann PTA President Howard

Goldstein have been elected.

As of press time, Goldstein placed first with 1,333 votes, with Korbatov coming in second with 1,332 votes. James Fabe placed third with 267 votes, with John Dohm receiving 162 votes. Dohm discontinued his campaign in September, but his name remained on the ballot after he missed the deadline to withdraw from the

race. An undetermined number of provisional ballots remain to be counted, but the results are not expected to change.

Voter turnout for Beverly Hills was not available as of press time. However, countywide voter turnout was 9.91 percent. Beverly Hills has approximately 22,000 registered voters.

Korbatov has been serving as a member of the Board of Education since 2009, and sought reelection after her previous term. This will be Goldstein's first term.

"The clock is ticking, and life is measured in real time and our students are experiencing life and education at Beverly Hills Unified School District in real time. I am ever mindful of the reality of the ticking clock and will continue to work diligently to fulfill my obligation on this Board," wrote Korbatov in open letter to Beverly Hills on her website.

Goldstein was gratified at the victory.

"I'm very optimistic that given the chance our superintendent, school administrators, and educators will have an opportunity to really thrive with this board," said Goldstein.

The new board is scheduled to be installed Dec. 10.

Electronic cigarettes almost smoked out of Beverly Hills

A representative from the City's Management Analyst Staff recommended to City Council on Nov. 5 the approval of an urgency ordinance to include e-cigarettes in the City's preexisting smoking ordinance.

City Council rejected the urgent ordinance with a vote of 3-1. The Council wished to hear an official report on e-cigarettes from the Health and Safety Commission before making a change to the City's smoking ordinance.

Gold voted in favor of the urgent ordinance because he questioned the safety of e-cigarettes. "I remember the 50s when we were told that smoking was safe, and anyone who relied on that particular piece of information is probably sorry," said Gold.

Councilmember Willie Brien was not present at the time of the vote.

If passed, the new ordinance would have included the prohibition of e-cigarette vending machines, the use of e-cigarettes inside or near public buildings, and the restriction smoking e-cigarettes outside of restaurants.

The City's Recreation and Park Rules and Regulations would have also extended their no smoking policy to include e-cigarettes.

"My job as a councilmember is not to stop people from smoking, but to protect other people who are disturbed by the smoke," said councilmember Nancy Krasne.

In an Oct. 15 study session, City Council asked City Staff to review State and Federal e-cigarette regulations in order to modify the City's definition of smoking to include e-cigarettes.

E-cigarettes are smoking devices that deliver nicotine, among other substances, in the form of a vapor to the user. They are operated by a battery-operated heating component, a replaceable cartridge containing the nicotine, and an atomizer that transforms the contents into an inhalable vapor for the user.

According to City Staff reports, the second-hand vapors emitted from e-cigarettes may pose some health risks. Staff is also concerned that the marketing of e-cigarettes will create nicotine addiction in young people, and will lead them to try other tobacco products.

There are currently no Federal or State regulations on e-cigarette usage other than the prohibition of e-cigarette distribution to minors. However, according to the Federal Drug Administration's website, the FDA plans to extend its tobacco regulations to e-cigarettes in the future.

Beverly Hills e-cigarette restrictions follow other California cities such as Duarte, Seal Beach, Temple City, and Pico Rivera that have fought the issue on a local level.

Management analyst staff will be working with the Health and Safety Commission to discuss future smoking regulations.

Rec. and Parks Commission and liaison recommend Roxbury playground equipment

The Recreation and Parks Commission, with the support of the liaison committee, will endorse to City Council the purchasing of Kompan playground equipment at Roxbury Park.

The Recreation and Parks commission liaison committee conducted a special on meeting on October 30 to receive updates on the Roxbury Park construction projects and to finalize the playground equipment proposal for the City Council.

The City Council liaisons are Councilmembers Julian Gold and Nancy Krasne.

The Recreation and Parks Commission previously recommended Kompan at its meeting on Oct. 22. The liaison committee supported the recommendation. The city council will make the final decision.

Among the pieces recommended is a three person teeter totter. The original budget for the playground was \$150,000 but it has been raised to \$155,000 according to the Assistant Director of Community Services, Nancy Hunt-Coffey.

The construction of the community center is on schedule and is \$1.3 million dollars under budget. The Center is expected to open mid next year. The multi use sports field construction had been bid on by various contractors, and the contract was awarded to Landscape Support Services in the amount of \$645,684 by City Council on October 15. The Liaison Committee expects the renovation of the sports field to begin on December 1.

The demolition and reconstruction of the field restrooms will be compliant with ADA standards, and that project will go

out to bid in early December.

Because the community center is \$1.3 million under budget, the Recreation and Parks Commission, with the support of the Liaison Committee, will recommend to City Council that the money saved from the community center be used for the construction of a sand play, mister, and sensory area. The addition of these play areas will cost approximately \$50,000 to \$60,000, according to Hunt-Coffey.





Crosswalk contract awarded; Audi pays half the bill

Civil Engineering Staff recommended before City Council on Nov. 5 the approval of a funding agreement with Audi, and the awarding of a contract to Steiny and Company Inc. for the construction of a new pedestrian crossing between Swall and Clark Drive.

City Engineers Mark Cuneo and Aaron Kunz, along with Civil Engineer, Tristan Malabanan, brought the item before City council.

The item was passed under the consent calendar.

The total cost for the new crosswalk is \$141,000 with Audi agreeing to fund \$70,500 toward the project.

Beverly Hills Audi contacted City staff about placing a crosswalk to facilitate easier access for pedestrians between the two Audi properties. The signalized intersections were located over a block away at La Peer Drive and Robertson, which motivated Audi customers to cross Swall and Clark Drive without any crosswalk protection.

The crosswalk project was initially brought to City Council in a study session held on May 7. Audi Beverly Hills agreed to pay 50 percent of the total cost for the construction of a signalized crosswalk between their main showroom at 8500 Wilshire Blvd., and an additional showroom on the north side of the street. The City Council agreed to the crosswalk plans and asked Civil Engineering Staff to return with an agreement.

The crosswalk project will include the installation of new signal poles, wiring, and an uninterrupted power supply.

so that he can get back to New York as soon as possible to deal with this case and attempt to clear his name," said Tevel's attorney Dana Cole.

New York officials have until Dec. 2 to retrieve Tevel from the custody of the Los Angeles County Sheriff's Department.

The Jewish Journal reported in August that four men, who live in Brooklyn, have accused Tevel of abuse when they were minors (ranging from ages 6 to 14 at the time of the alleged abuse). According to the Journal's reports, the men claimed that Tevel allegedly performed acts that included spanking on bare skin to sexually suggestive rubbing.

Had Tevel not waived extradition, New York law enforcement would have had to

send proof that Tevel is the person connected to the alleged offense, which Cole said could take an extra month.

Cole requested the judge to consider granting bail to Tevel based on concern that it would be difficult for Tevel to maintain a healthy weight in county jail while observing strict kosher dietary restrictions. Los Angeles Superior Court Judge Shelly Torrealba ruled against granting Tevel bail because she believed him to be a flight risk and because the charges were too serious, according to Cole who offered to personally escort Tevel to New York.

Cole is a Beverly Hills resident, a Beverly High 1972 graduate and an ABC news legal analyst.

these unfortunate charges would somehow tarnish the fine work and reputation of the JEM center or the people that have really worked tirelessly to provide a place for the community to go and kids of all denominations to participate in sporting events, youth leagues, and mentoring programs," said Cole. "We're just hopeful that its name will not be tarnished particularly because there's absolutely no allegation of any wrongdoing at the JEM center by any member including Rabbi Tevel."

Cole said they are not commenting on the charges because they do not yet know the facts related to the charges.

BHHS Football Team Loses to Hawthorne, Former Coach

Beverly High allowed touchdowns six of the first seven times the Hawthorne offense had the ball in a 50-7 loss in an Ocean League football game Friday night.

The host Cougars led 15-0 at the end of the first quarter, 36-0 at halftime and 50-0 entering the fourth quarter in what is believed to be the first time the Normans

faced their coach from the previous season.

Sebastian Torres ran six yards in the fourth quarter for the Beverly Hills touchdown.

"We didn't execute," said Norman quarterback Zack Bialobos, who completed five of eight passes for 39 yards.

"I thought we had some good drives. We didn't finish our drives. We didn't play the way we practiced. I thought we practiced better than this. We were out of synch for some reason."

Beverly Hills (0-9, 0-4 in league play) was again plagued by interceptions.

Pablo Bernal threw a 65-yard touchdown pass to Eddie Thomas one play after Bialobos threw the first of his two interceptions, increasing Hawthorne's lead to 15-0.

The Cougars went up 22-0 on Bernal's 41-yard touchdown pass to Thomas, three plays after Jesus Morando intercepted a pass thrown by Norman quarterback Mike Massie.

Rian Smith intercepted a pass thrown by Bialobos and returned it 33 yards for the final touchdown of the first half for Hawthorne (3-6, 1-3).

Massie and Bialobos combined to throw four interceptions Morningside turned into 24 points in the fourth quarter of a 62-27 victory Oct. 25.

Bernal completed four of seven passes for 186 yards and three touchdowns, all to Thomas, who also caught a 65-yard touch-

down pass from Bernal on the Cougars' first possession of the third quarter.

Hawthorne junior Paris McDaniel ran for 178 yards on 12 carries, including 15-, 24- and 15-yard touchdowns, in what Cougars coach Donald Paysinger called a typical game for him.

Beverly Hills "had some success in the run game that we didn't have two, three weeks ago," coach Charlie Stansbury said.

The Norman players are "building more resilience and overcoming the adversity we've faced," Stansbury said.

Offensive linemen Austin Greer and Calvin Silvera drew praise from Stansbury as "at times, we were beating them up front."

Stansbury also praised the play of receiver-defensive back Chris Johnson.

Paysinger, Beverly Hills' coach from 2009-2012, said his team played its best game of the season on offense, defense and special teams.

The game came on Paysinger's birthday and he called the victory a "great birthday present."

The victory was Paysinger's first over the Normans. He lost twice to Beverly Hills when he coached Santa Monica in 1998 and 1999.

Paysinger said he was not surprised the Normans are 0-9.

"I saw it going down three or four years ago when they cut out the outside permits," said Paysinger, a 1977 Beverly Hills graduate who coached the Normans

to 2-8 records in each of his final two seasons. "It started to deteriorate then."

Beverly Hills is scheduled to conclude its season Friday night by playing host to Culver City (5-4, 4-0) at Nickoll Field in a matchup of teams likely to finish first and last in the six-team Ocean League. The opening kickoff is scheduled for 7 p.m.

The Normans are 0-8-2 against Culver City since 2002 including 43-0 and 41-0 losses in 2011 and 2012. The high school football website Calpreps.com projects a 62-0 Culver City victory. It had projected Hawthorne would defeat Beverly Hills, 42-19.

BHHS Wins Race at Mt. SAC Invitational

The Beverly High boys' team won its race at the Mt. SAC Cross Country Invitational Oct. 25 and Norman senior Aaron Wolfe was the individual winner.

The Normans finished with 82 points, 27 fewer than the runner-up, Rio Americano of Sacramento, in the 22-team race for Division 3 schools.

Wolfe completed the 2.91-mile course in 16 minutes, seven seconds, 14 seconds ahead of the second-place finisher, Josh Guzman of Hanford West. Senior Will Ezzard was the next Beverly Hills finisher, finishing 12th in 16:54.

Organizers bill the meet as the world's largest cross country invitational.


Big Smiles raises \$27,000 to fund tumor research




The Beverly Hills Centennial Float wants YOU!



Beverly Hills residents discuss where they were when they first heard the legendary news




I was at Phil's Poultry on South Robertson Blvd, which is no longer there. I was getting some shrimp for a dinner party that I was having that night, and as I was getting out of the car, I heard on the radio that he had been shot. I walked into the poultry store and I said, "Has anybody heard that the President has been shot?" They all paled and looked at me like I was insane. Nobody has ever looked at me like that. Everybody picked up the phone to call their wives, and I was just completely in shock. I didn't even give the store my order. I just went back into my car, went home, and stayed by the television for the next

48 hours. I was riveted to the television. I never left my house. I was literally in bed watching television when Jack Ruby shot Lee Harvey Oswald. On the 48th hour I went to temple because they had a prayer session. As tragic as that was, for the next 48 to 72 hours there was total peace in the country. Everybody was so kind to each other. It showed that they community can come together and all grieve.



DICK DOUGLAS
FORMER BHUSD SUPERINTENDENT


[Sheila and I] were just married and I was in graduate school. I was at UCLA graduate school, and there was a big uproar. I went into the Student Union to see what was going on. All of a sudden I was mesmerized by a small television, and I just sat glued to it for what seemed like hours. Nobody even thought about going to class. We all just stayed there in a state of shock and disbelief. We were hanging on every word.



ROBERT K. TANENBAUM
FORMER MAYOR

I was a student at UC Berkeley. I was president of my class. We had a function scheduled that evening which was of course immediately cancelled. I was coming out of a philosophy lecture when people were screaming that the president had been shot. I didn't realize that they were talking about the president. I couldn't put that together. I walked into a store and lo and behold there it was--Walter Cronkite broadcasting that the president had been killed. I was just totally stunned and shocked. I couldn't believe that this could happen to President Kennedy in our country at that time. I met President Kennedy when he spoke at

Berkeley. Years later I was asked to go to Washington D.C. to be the Chief Counsel to the Committee Investigation into the assassinations of President Kennedy.



JOE TILEM
FORMER MAYOR

I was working at the time for Carte Blanche and I was sitting in the office. Someone ran into my office and said that the president had been shot. Barron [Hilton] was the only one that had a television set in his office, so I sat there and watched the whole thing. Then I watched as Jack Ruby killed Lee Harvey Oswald. I have very vivid memories. It seemed very personal. Many people have a great affinity for JFK. It was traumatic as can be. I just went right home after I watched as much as I could stand.



STEVE WEBB
FORMER MAYOR

When you get to be my age, you start to recollect. I was in my dorm room at the University of Denver. Somebody came running in and said to turn on the TV. I was shocked, stunned, and nobody was really saying much of anything. It felt like I had been hit in the gut. Kennedy was royalty. It was the first major incident for me.



NANCY KRASNE
BEVERLY HILLS COUNCILMEMBER AND
FORMER MAYOR

I must have been a freshman. I was walking on the grounds of UCLA and somebody said that the president had been shot. I thought that it wasn't very funny. I remember my first response was laughter. I thought it was a joke that wasn't very amusing. I stood there like a dummy. I remember the looks on people's faces and then I realized that it was real. It really happened. I must have gone home. I remember watching it on television and never leaving my house after that. I was wearing a green sweater and a green wool pleated skirt. There were people that were coming

out of class crying. I don't know how everybody knew simultaneously. It was not what I was expecting to hear.



MARK EGERMAN
FORMER MAYOR

I will never forget that day. I was at law school at UCLA. My wife [Lynn] was at the medical school on the south end of campus. We had heard that president had been shot. We did not know yet that he had been killed. These were the days before cell phones, and we did not have the means to communicate with each other. Serendipitously, she had been walking north and I started walking south, and we met about mid-campus. We were totally stunned. It was something that we could not fathom. We could not understand how something like that could happen. We walked

back to the law school together and went into one of the common rooms where there was a television. We just sat there watching the play-by-play, and finally they announced on the television that the president had died. There was that unbelievably sad picture of Jackie Kennedy in her blood stained suit. There was not a dry eye in the room, and just dead silence. It was just something that was totally incomprehensible.



LINDA BRISKMAN
FORMER MAYOR

I was 15 years old and a sophomore at St. Paul's Catholic High School in Santa Fe Springs, California. I had never seen the nuns who taught me so emotional. They couldn't hold back. I guess in some ways it was a loss of innocence for my generation. Nothing had ever had the impact of this. In a matter of minutes we felt vulnerable. Nothing compared ever in my life like that until an early morning in September of 2001.


