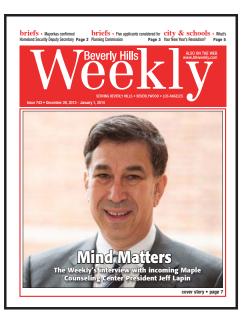

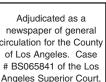

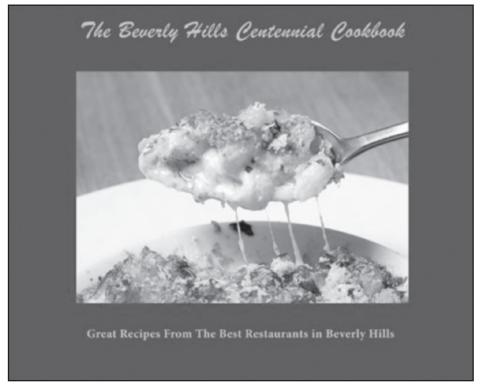

Homeowners question merit of landmark status

Homeowners Ana and Deryck O'Brien spoke in front of the Cultural Heritage Commission Dec. 18 to discuss their renovation plans for their home on 711 N. Rodeo Dr.

While planning the remodeling, which involves repairing the siding of the house, the two were informed that their house was on a list of properties by notable architects, and therefore was to be considered for "landmark status."

The O'Brien's spoke to the Commission about the intended modification. They also indicated that they would not like to be considered for Landmark status, citing concerns about the house's property

value.

"It can be used as a negotiation tactic against you if you're trying to sell," said Deryck O'Brien.

The Commission disagreed, arguing that landmark status not only benefits the property owners, but all Beverly Hills residents.

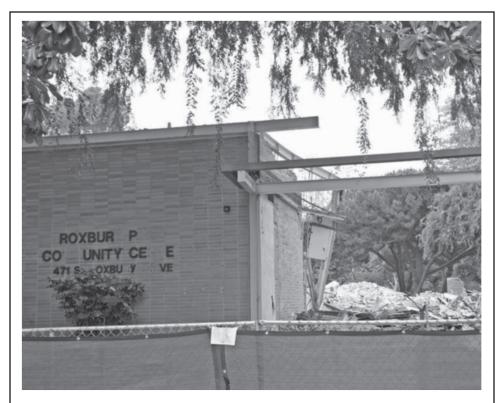
"All of the studies actually speak to the opposite of that," said Commissioner Noah Furie. "If anything, it's made the properties more expensive."

Initiating landmark status also protects the "character of the city," said Vice Chair Maralee Beck. "People are scared about the landmarking process. It's not in any way meant to be a punitive or negative process. I would think that since it's a family home you wouldn't want someone to mow it down."

The house has been in Ana O'Brien's family since the 1930s, and she said she hoped the next owners would be her children.

"Even though we would like to keep our house consistent with what it's looked like historically, I think if somebody buys our house in the future, I don't want to impose that on them," said Ana O'Brien

City staff briefs Rec & Parks Commission on expenditures of the first half of the fiscal year

City staff addressed the status the Recreation and Park Facilities Fund (Fund 16) with the Rec and Parks Commission at their Dec. 16 meeting. The expenditure report shows a total budget of approximately \$12.3 million for the fiscal year ending Jun. 30, 2014. As of Dec. 12, \$6.1 million has been spent, leaving \$6.3 million available.

The project with the highest budget and expenditures is the renovation of Roxbury Park, which has cost the city \$4.4 million out of an allotted \$7.8 million.

Remaining funds for ongoing projects such as street tree replacement, which has cost the City approximately \$460,000 this fiscal year out of an allotted budget of \$1.2 million, will "roll forward, and be committed to continuing of the project next year," according to Community Services Director Steven Zoet.

After street tree replacement, the Greystone Interior Project has the third-highest budget—just under \$1.2 million, of which about \$1 million has been spent. So far, none of the 12 projects on the report have reached or exceeded their budgeted costs.

"With all due respect, was this [report] created to show that in six months you've gone through fifty percent and we still have fifty percent available, or is this a realistic account?" said Commissioner Frances Bilak.

Zoet reminded the Commission that the amount of available funds will change as projects close-out through the remainder of the fiscal year.

"The reality is we're only about halfway into the fiscal year. Until we get closer to the projects' close-out, we're not going to know the reality of the dollars that remain," Zoet said. "What I don't want you to think is that we have \$6 million that's unaccounted for. Those dollars are committed to projects that will be drawn down over the course of six months. Then we'll have a better idea how many of these dollars really are discretionary. That's when we start maybe giving thought to another major project, which would be presumably be La Cienega [Park]."





Santa Monica Blvd., facing Century City

Santa Monica Boulevard Committee to hold public meeting Jan. 8

The Santa Monica Boulevard Blue Ribbon Committee will hold a third public meeting on Jan 8, 2014 to continue the process of collecting public input on elements to be included in the Santa Monica Boulevard Reconstruction Project. The project, scheduled to begin in 2015, will involve a full reconstruction of North Santa Monica Boulevard and including upgrading the century-old drainage system and other muchneeded street improvements along the entire stretch within Beverly Hills.

The15-member Blue Ribbon Committee, appointed by the Beverly Hills City Council, will meet at 6 p.m. in the Municipal Gallery, on the second floor of Beverly Hills City Hall to continue discussions.

So far, two public meetings and two mobile tours have been held and attended by Beverly Hills residents, members of the biking community and other interested citizens. At the last two meetings, consultants presented possible scenarios for changes to the roadway, including bicycle lanes and landscaped medians. Following the public outreach process, the committee will provide recommendations to the City Council, which will make the final decision on types of amenities to be included in the project.

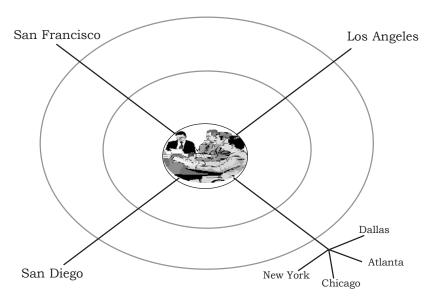
The library has been closed for service on Sundays for the past three years.

Regarding Furie's claim that studies showed a rise in property value for land-marked homes, O'Brien said she suspected that "for every house that that's the case, there are probably several others where the opposite is true." She would be surprised if the house was worthy of landmark status, she added.

"It's a very unusual case. Usually homeowners are thrilled to be landmarked," said Chair Richard Waldow after the meeting.

The Cultural Heritage Commission meets quarterly make recommendations to the City Council on designation of historic properties and applications to the Mills Act program as well as other preservation issues. So far, 14 properties have completed the process to attain landmark

status. About half are private residences, according to Waldow.

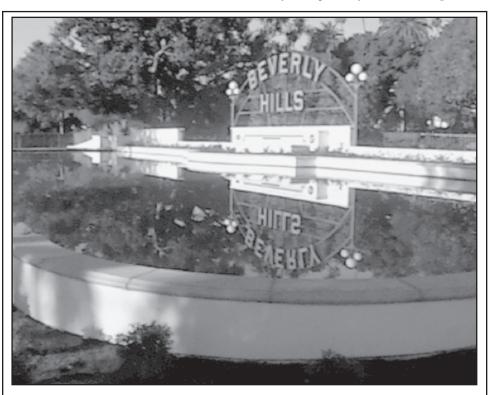
Centenarians to be honored at City Council Meeting

2013—A YEAR IN REVIEW

The Weekly looks back at some of the year's headline stories By Nicole Battaglia



"Big Bills" [Issue 697, February]

Beverly Hills Unified paid over \$439k in legal fees in the final quarter of 2012, according to records obtained by the *Weekly* in the beginning of January. The fees were paid to the law firm Hill, Farrer & Burrill, LLP, which represents the city in the CEQA lawsuit against Metro. The district sued Metro on the grounds that Metro was legally bound to re-circulate the environmental impact report when new information was presented and re-opened the public comment period.

The total legal and lobbying fees the district paid in 2012 were \$2.58 million, to seven firms. The payments to Hill, Farrer, & Burrill constitute 70 percent of the total fees, an equivalent to \$1.81 million. According to then Board of Education President Jake Manaster, \$1 million

was spent on trenching at the high school to prepare for the CEQA suit against Metro.

Update: In September, the district switched from Venable, a DC-based lobbyist paid to fight the tunnel under Beverly High on a federal level, to Kasowitz, Benson, Torres & Friedman. The Weekly will obtain and report on Beverly Hills Unified's 2014 legal fees in the future. In his interview with the Weekly in Issue #742, incoming Board of Education president Noah Margo cited Metro disputes as one of his greatest challenges for the coming year. Most recently, the Board

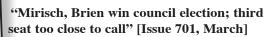
discussed the case with legal counsel at a closed session on Dec. 18.



"Remembering Rudy Cole" [Issue 698, February]

In honor of longtime columnist Rudy Cole, icon of Beverly Hills, the *Weekly* published tributes from such figures as County Supervisor Zev Yaroslavsky, Rep. Henry Waxman, Mayor John Mirisch, Vice Mayor Lili Bosse, and many others. Cole served Beverly Hills as a columnist for the *Weekly*, President of the Greystone Foundation, and Parks and Recreation Commissioner.

Update: A park bench and a Cape Myrtle Tree were dedicated in Cole's honor at a ceremony at Greystone Mansion on Oct. 6, as reported in issue #734. Cole was a founding member of the Greystone Foundation.



Incumbent Councilmembers Willie Brien and John Mirisch were both re-elected to the city council. Mirisch led with the most votes, followed by Brien, Nancy Krasne, and Brian Rosenstein, respectively. The *Weekly* had endorsed Brien and Mirisch—along with Rosenstein—two weeks prior in issue #699. Krasne would go on to win the third seat, defeating Brian Rosenstein by seven votes. The new council was sworn in on Mar. 27.

Update: Brian Rosenstein was elected Chair

of the Planning Commission on June 27, as reported in issue #718.



"Beverly Hills' Music Man" [Issue #714, March]

Lengendaty choral director Joel Pressman spoke with the *Weekly* about his growing up in Beverly Hills and 38 years of teaching at Bevery High. He thanked his colleagues for their support throughout the years. He had been battling cancer when he retired in June.

Update: Pressman passed away in November, as reported in issue #738. A public memorial is set for Jan. 26 at Beverly High.



"Weekly SLAPP's Courier" [Issue #716, June]

On Monday, June 17, Beverly Hills Weekly filed a SLAPP motion in Los Angeles Superior Court to quash Beverly Hills Courier's lawsuit regarding the size of legal notices published in the Weekly. The SLAPP (Strategic Lawsuit Against Public Participation) statute is a vehicle in which a defendant can file a motion if they were sued for matters related to freedom of speech.

Update: As reported in issue #741, "The court ruled in favor of the Weekly on two of the three causes of action [intentional interference with prospective economic relations and negligent interference]. As for the third cause of action, unfair business practice, the court ruled that there's no first amendment

issue, which is not necessarily a loss for the Weekly." said

Weekly attorney Ronald Richards. "The Weekly expects to prevail on that issue at trial; however, if corrective action is necessary, the Weekly will be happy to do so." The Courier is appealing the court's ruling.



"Candidates file for Board of Education race" [Issue #721, July]

Dr. James Fabe, a 25 year Beverly Hills resident, and Howard Goldstein, then Citizen's Oversight Committee member, filed for November's Board of Education election.

Dr. James Fabe, a 25 year Beverly Hills resident, has three children, one who currently attends Horace Mann School. Fabe has a bachelor's degree in economics from UC Berkeley, a DDS from USC, and an MBA from UCLA-Anderson.

Goldstein is an attorney and a former Horace Mann PTA president He has previously served as PTA Council Parliamentarian, school site member, and on the executive board of the

Beverly Hills Education Foundation.

Board of Education member Lisa Korbatov, who had announced her intent to run earlier this year, did not file for re-election until August, as reported in issue #723.

John Dohm, an executive for Beverly Hills-based RealD, a company that develops technology used for 3D films using polarized light, filed for election the following week, as reported in issue #724, but later suspended his campaign.

Update: Goldstein and Korbatov won the election and were sworn in December. In her speech at the Dec. 10 installment ceremony, Korbatov vowed to continue the fight against Metro. Manaster left the Board and has since applied, along with four other candidates, for a vacancy on the Planning Commission, as reported in issue #743. The chosen applicant, pending approval by the City Council at their Jan. 7 meeting, will be announced by City Clerk Byron Pope this Friday.



"The Wallis holds dedication and ribbon-cutting ceremony" [Issue #733, October]

The Wallis Annenberg Center for the Performing Arts, known as The Wallis, opened its doors on Oct. 15 following a dedication ceremony. The center includes the historic 1933-constructed Beverly Hills Post Office, the 500-seat Goldsmith Theater, and the 150-seat Lovelace Theater. The new center will also include a theater school, café, gift shop and sculpture garden.

Update: The Wallis, still in its inaugural season, has presented such events as the play Perfurmerie and a performance by the Martha Graham Dance Company. This month, they will hold shows by Les Ballets Jazz De Montréal, St. Lawrence String Quartet, and Jason and the

Argonauts. Eleven more events are planned for the rest of the inaugural season, which ends in March. A subterranean, three-level parking garage operated by the City of Beverly Hills is now open to provide parking for the Annenberg's future patrons and visitors to Beverly Hills. "Planning Commission unanimously rejects plans for Kobor Project Building" [Issue 739, November]

After the City Council unanimously authorized an agreement with the developers of 8767 Wilshire Blvd. on Oct. 22 that would allow 45% medical usage of the building, the Planning Commission unanimously struck down the application of a medical zonal overlay to the Kobor Project Building on Nov. 22. Five days after Commission's decision was finalized, Councilmember Nancy Krasne requested a de novo hearing to reconsider the medical overlay zone application. The council voted 4-1 to arrange the hearing, with Mayor John Mirisch as the only abstention. The de novo hearing will take place at the City Council meeting on Fri.,

Update: As reported in issue #743, a residents meeting was held on Thurs., Dec. 19, to make the public aware of the Kobor Project Building application's return to the City Council. Bryan Brown Extreme Kayaker



Beverly Hills resident Bryan Brown, a securities consultant and wilderness enthusiast, recently completed the first continuous descent of the entire Colorado River watershed in American history. He took the trip as a tribute to his younger brother, who died during late 2012 of Muscular Dystrophy.

Why did you decide to take this trip?

I had a brother, Bruce, who had adultonset muscular dystrophy. When we were kids we were a one-income military family from Indiana, and my dad had an assignment out West. Bruce was 11 and I was 15, and we were sitting on the Grand Canyon with a copy of John Wesley Powell's [the first known traveler through the Grand Canyon] book. We saw a tiny little bit of water in the canyon, and we said, "That's it, we'll do that river."

Bruce got muscular dystrophy in his early 20s, and outlived his life expectancy by about 30 years. You could tell he was having trouble—it's severe pain that gets you with muscular dystrophy. So I assigned it to him. I said, "Plan this trip." He filled up two huge boxes with clippings, maps, and plans for a trip he would never take. I assigned it to him to keep him alive, and it worked.

He died last year, and I immediately set in motion the plans to go. He died at age 53, four years younger than me. It's one of those things where life caught up with us, and I didn't do it when I should have, when he was alive. But I got it done when he was dead. I carried a little bit of ash in my life preserve and sprinkled it where he would want to be sprinkled.

I kayaked solo and unsupported all the way to the Mexican border, then circled back around to Rocky Mountain National park, then kayaked down to the National Confluence down near Moab, Utah. It's the first time it's ever been done in one trip. John Wesley Powell hoped to do it, but had never

been able to achieve it logistically in 1860. He just did a chunk of it, and stopped at what is now Las Vegas.

What did you do to prepare?

I stay in pretty fair shape. I'm 57, but I'm a spry 57. So the short answer is it wasn't kayaking—I already had the skill to do that. What I was doing was on our own property up the hill, building walls. You know, we

live on a mountainside and come from Indiana, so we learn to do a lot of things you all don't do around here. We were hauling concrete and building retaining walls.

What kind of injuries did you sustain on your trip?

I ended up losing four toenails, because I travelled in scuba boots. Every time I came to a potentially threatening piece of whitewater, I'd have to pull over, tie the boat up, and walk through rough terrain. Boulders kept crushing my toes.

I also broke or dislocated a rib. I couldn't even roll over on my sleeping pad for about a month. I didn't have any drugs for pain. I just would lay down and stay there at night. Sometimes it took 20-30 minutes to get up.

I also got tendinitis in my forearm 2,400 miles in, and I looked like Popeye. It was so big that I couldn't get a watch on. I knew I wouldn't be able to finish if it was casted up, so I just toughed it out.

And you were alone the whole time?

Almost all the time. On very rare occasions I would overlap with other people who were going the same way, but not very often. It was pretty desolate.

Nothing about this is a cakewalk. It's an incredibly remote area. I went one stretch of

This is not the first thing of this nature that I've done. I've done the Appalachian Trail, and I've also done a transcontinental bike ride. I don't do them alone because I crave solitude. I do them because I can't find anyone else to do them with. It does take a lot of time, and a lot of times people can't take that

What is your career like? How were you able to take so much time off?

I'm a securities analyst. I've been a consultant for 30 years, give or take. Many years ago I branched out into doing a hybrid investment-analyst-strategist kind of thing that most people won't understand. Visualize somebody you see on CNN who gives a

broad overview of market dynamics. So if I don't have an idea, I can take 100 days off and go plant my brother's ashes.

Tell us about your philosophy for travelling in the wilderness.

I'm a "leave no trace" camper. I didn't use a stove. I haven't built a fire in the wilderness since the 70s. I only camped on places where there were no plants—I didn't sleep on anything that would be important to your children or your grandchildren. I was very picky about it.

I should note, by the way, that the water in the Colorado river runs out at the Mexican border. You can literally see where it goes dry at the border. Then it stays dry through what used to be a full-blown delta, to the Gulf of California. We have completely abused our poor neighbor, Mexico.

There used to be a salmon run from the Sea of Cortez, and those salmon no longer run. So we've made a big ecological dent that we are repairing.

But things are better than they could be. There was no trash in the watershed—of course there were no people either.

I saw otters, beavers, minx, big horn sheep, elk, and all kinds of undulates. I almost got

stomped by a moose in the middle of the river one time. The wildlife was phenomenal, so there's cause for optimism on the Colorado [River].

How did you get from Indiana to Beverly

A small boutique securities firm based out here hired me from Houston, where we were living at the time. We [Bryan and his "high school sweetheart" Sandy] both went to Indiana University, and Exxon's thinktank hired me out of college. I have an odd background—a chemistry degree with a second full degree in English literature, and then a master's in English.

Exxon was spinning out lots of ideas, and I worked there developing chemical technology until I was hired by a securities firm. I have been working in securities ever since.

We've been in Beverly Hills for 24 years. We're not natives, but we love it here. It's occasionally 20 degrees below zero where we come from, and we don't wrestle with that here.

Tell us about your family.

My dad was professional military, and so was my brother until Muscular Dystrophy struck him down. I have two sisters as well. We're a close military family. We didn't have a whole lot, but it was plenty. We lived for most of our lives in very rural southern Indiana. My dad was the kind of guy who said, "Camp, hunt, fish, do whatever you want, as long as you get your homework done!"

What surprised you most while travelling?

People were outrageously kind—unbelievably kind. They didn't know what I was doing and I frequently didn't tell people, but people knocked themselves out. In the lower Colorado the agricultural chemicals get concentrated the farther you go down, so my feet got so infected it was hard to walk. A woman at a middle-of-nowhere desert boat launch saw that I was crippled, and offered to take me into town. She drove me two hours, waited for my prescription to get called in and filled, and drove me all the way back. She wouldn't take money, and would even let me buy her lunch.

What's your goal now that the trip is

Ultimately I'd like to use the experience at speaking engagements to spread the word for Muscular Dystrophy. It's an appalling way to live. People don't die of the disease, they die of the side effects, such as heart failure and pneumonia. It's not like cancer where you can put your finger on it.

And as of about three weeks ago, I was tentatively invited to become a member of a kayak competition team called Team Piranha, which consists of a bunch of current and former world champions and Olympians, and now 57-year-old river troll Bryan. I'll be 27 years older than my next-oldest teammate. So, "Old guys rule!" may be the take-home here.

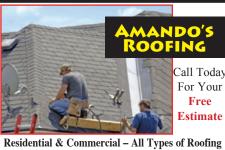
