

"Tuesday's City Council meeting"

I am writing to express my extreme dissatisfaction with Councilmember Nancy Krasne's behavior Tuesday night at the City Council meeting. She lashed out at the City Treasurer, and she became unhinged during Larry Larson's remarks. Surely members of the Council must be sick to death of listening to residents expressing their views, feelings, and conclusions. But no sitting Councilmember should raise his or her voice at a public servant, as she did following Mr. Finkel's presentation. And while Mr. Larson was within his rights to address Ms. Krasne, her remarks were far more offensive than

his. Ms. Krasne knows how lightening rod issues can ignite in the community. No one forced Ms. Krasne to seek office again-- so if she didn't want to face her public and scrutiny, she need not have run.

It is not often that I am unsettled by a local representative. Her demeanor, especially towards Mr. Finkel (whom I don't even know and have never met) was not only offensive, it was also repellant. I had no desire to be yelled at, or abused, so I tamed my own remarks in order to avoid a potential lashing. She began the meeting last night with a scolding to her critics, and sat smiling while being praised by former mayors. Does she have the ability to vote fairly, in an unbiased manner on this issue? This question concerns me greatly.

Hubbard acquitted on appeal; what's next?

The convictions against former Beverly Hills Unified Superintendent Jeffrey Hubbard, have been reversed by a state appellate court on Dec. 31, 2013.

Hubbard was found guilty in Jan. 2012, of misappropriating public funds while superintendent of Beverly Hills Unified School District from July 2005 to June 2006. Funds were allocated for an increased car allowance from \$150 a month to \$500 a month in 2005 and a \$20,000 stipend in 2006 to former district director of planning and facilities, Karen Christiansen.

Hubbard was terminated as superintendent of the Newport Mesa Unified School District in 2012 after he was convicted.

"It's clear he should have never been charged, just because he testified in favor of Christiansen," Hubbard's and Christiansen's attorney, Hillel Chodos said.

According to the 10-page court ruling, Hubbard testified that the raise in car allowance and the stipend was to compensate Christiansen for her increased workload. He also argued that he is not a person "charged with the receipt, safekeeping, transfer, or disbursement of public moneys."

The former Board of Education members testified against Hubbard at the trial.

"I think it's an unfortunate decision by the appellate court," prosecutor Max Huntsman said, who now works as the New Inspector General for L.A. County Sheriff's Department.

According to Chodos, the case has been appealed which will take up to 60 to 90 days for a final verdict.

Michael Lifrak and Steven Madison, attorneys from Quinn Emanuel Urquhart & Sullivan, who represents the BHUSD in the case, did not return a phone call from the *Weekly*.

According to Chodos, Christiansen is suing the school district for \$7 million dollars for the termination of her employment in 2005 before finishing her contract. She is also suing for malicious prosecution.

Finalist selected as new BHUSD general counsel, but pulled from agenda

Davis has been the General Counsel of San Francisco Unified School District since Jan. 2012.

He attended USC and graduated with a broadcast journalism degree. He went on to serve in the Marine Corps for 30 years as an aviator, and later as a judge advocate.

Davis received his law degree at USC and has been a member of the State Bar of California for almost 33 years. He retired from the Marines as a colonel.

Davis joined the Office of General Counsel (OGC) of the LAUSD in 2001. In Nov. of 2006, he was appointed as LAUSD's Chief of Staff, and returned to OGC as Deputy General Counsel in 2008.

BHUSD Superintendent Gary Woods said the position's budgetary impact was being reconsidered for the position.

become a haphazard program.

Legacy permits were created and pitched to the community in the hope of having grandparent "stakeholders" contribute money to the district/ Education Foundation since their grandchildren were going to be educated here for several years rather than their home district or private school. In other words, it was a gift to some. There was never a way to monitor donations, nor should there be, and thus the program was deeply flawed on that point from the start. Residents believe Legacy is a huge bonanza for a few lucky grandparent residents and parents who have no incentive to move into the community as others have to. Now if natural breaking points are disregarded it is even more of a free for all and a quiet nod to parents that they have nothing to worry about and maybe they'll safely get a free ride through high school. All of this, after at least two of you ran against permits telling us we were going to be a Basic Aid district, and we stood to lose from such policies. So how do we benefit from this program?

Please decide who your constituents are: The residents or the few who entered this program which had natural breaking points in it. This will be hard because these permitted students and parents have gotten used to policy by whim and friendship and it is not how district programs should be run. The appearance now is that the Legacy program sounds like, and has the appearance of, a "friends and family" program with quiet promises made to friends who were lucky enough to get a free ride.

The Board has made a choice twice now not to enforce the legacy program containing natural breaking points which is not a policy at all. Residents are looking for consistency, leadership, integrity and the truth. It's not difficult and they are entitled to just that.

Next December residents will be watching and listening to see if you choose to continue this haphazard program that doesn't benefit BHUSD nor makes for good policy.

was a member of the North Homeowner's Association in year's past. She also recently served as a chair of Lisa Korbatov's reelection campaign for the Board of Education.

However, during the City Council study session, Councilmembers Willie Brien, Nancy Krasne and Julian Gold objected to selecting Gallup as planning commissioner.

"Whether I'm on planning commission or not, it's an issue of process," Gallup said. "This is something far beyond whether or not I'm selected."

Gallup said that her nomination was blocked because of her personal opinions towards the Javors, developers of the Kobor project (see cover story)

According to Councilmember Nancy Krasne, e-mails were sent with a 'spin on information' and the behavior and actions she has seen from Gallup were not suitable characteristics for a planning commissioner.

"It does feel personal, it also does feel political," Mayor John Mirisch said. "Unless there's been some kind of obvious conflict of interest, it's always been deferred to the ad hoc committee because they are the ones doing the work and interviews.'

Councilmember Willie Brien suggested selecting a candidate who has already gone through the interview process and meets the qualifications for planning commissioner. instead of going through another interview process.

Councilmember Lili Bosse agreed to not have another interview process, and recommended selecting the candidate who had the second most votes.

Selection of a second finalist for planning commissioner will be determined by the Planning Commission interview panel, and will return to the council for final approval.

Newborn safely surrendered in Culver City; Still no dropoffs in Beverly Hills

A newborn baby girl was safely surrendered at a Culver City hospital over the weekend.



She is the first newborn in 2014 to be safely surrendered since California implemented the Safely Surrendered Baby Law in 2001. The baby is under protective custody until she is placed with a fam-

ily approved by the Department of Children and Family Services.

Though no infants have been safely surrendered in Beverly Hills since the law took effect, 114 babies have been surrender countywide.

Any hospital or fire station in the county serves as a safe surrender site with no questions asked.

The safe surrender program accepts newborns up to 72 hours of age.





Board of Education Expected to Hold Study Session on Athletics Goldberg supports examining leaving Ocean League.

Brian David Goldberg said Wednesday he hopes his fellow Beverly Hills Unified School District Board of Education members support his call to look into options with Beverly Hills High School's athletic program "to support safe competition for our students that also prioritizes their education first."

Goldberg wrote in an email that he supports holding a board study session "to discuss these issues which will allow for input from all stakeholders so the board can make informed decisions about the direction we want to see our district go with our athletics programs."

Board President Noah Margo said he is planning on holding a study session on the subject this spring.

In the November edition of "Goldberg's Perspective," the monthly email he sends

to individuals with interest in the school district, Goldberg wrote that he has "argued for several years" Beverly High "should leave the Ocean League."

"We should either find or start a league that creates more parity for our students and is aligned with our goal of academic excellence," Goldberg, the board's vice president, wrote.

Goldberg said he supports "looking at the possibility of leaving the Ocean League if it makes sense from a safety and academic standpoint."

Playing in the Ocean League "has had a direct impact on our ability to schedule games that do not conflict with our instructional day," Goldberg wrote.

"This obstruction has resulted in a subpar bell schedule that robs our students of much needed instructional time with their teachers and creates a culture and expectation that most of our students and teachers are done with academics by 1 p.m. most days of the week," Goldberg wrote.

Goldberg went on to explain that the

Goldberg went on to explain that the high school has not increased the time teachers have contact with students to the 1,450 minutes allowed per week in their contract because "too many student athletes would miss too many minutes of class in order to get to various games."

When playing Ocean League teams, "our students are usually physically out matched on the football field," Goldberg wrote.

Since the 2011 season, Beverly High has lost 13 of 15 Ocean League football games, with both victories coming over Hawthorne.

Additionally, "schools in the Ocean League don't just want to beat Beverly Hills High School; they want to hurt Beverly Hills High School students," because of the wealth of the city's residents, Goldberg wrote.

Vonzie Paysinger, a member of Beverly High's varsity football coaching staff since 1988, said he could only recall one time when an opposing player or players tried to intentionally injure a Norman player.

"We addressed it with the school and the school addressed it with two or three kids who illegally tried to do something that the referees didn't see," said Paysinger, who said the incident was captured on videotape. "The other school disciplined the kids."

Paysinger declined to name the other school.

The other Ocean League schools are Culver City, Hawthorne, Inglewood, Morningside and Santa Monica.

Under a releaguing plan approved in May by the members of the South Bay

Athletic Association – the high schools that are members of the Bay, Ocean and Pioneer leagues -- Inglewood and Morningside will move from the Ocean League to the Bay League and El Segundo and Lawndale will move from the Pioneer League to the Ocean League.

The changes will take effect with the start of the 2014-15 school year.

Beverly Hills Principal Carter Paysinger was chairman of the releaguing commit-

Under Southern Section rules, releaguing is a two-part process undertaken every four years, according to Glenn Martinez, an assistant commissioner of the Southern Section, meaning Beverly High would likely have to remain as part of the Ocean League through the 2017-18 school year.

The first part is area placement. The Southern Section has 10 areas, eight geographic along with separate areas for parochial schools and small schools.

Beverly High is part of the Coast Area, which consists of the Moor League in the Long Beach area and the South Bay Athletic Association.

After a school requests placement in an area, releaguing is then undertaken by area or association.

COVERSTORY KOBOR PROJECT STILL UNDECIDED

City Council continues discussion on medical overlay zoning at Wilshire and Robertson By Nancy Yeang

After five hours of public comments and discussion, both residents and commercial business owners voiced their opinions for or against the medical overlay zone at the commercial building located at 8767 Wilshire Boulevard last Tuesday.

The newly constructed building, known as the Kobor project, has not been occupied since its completion because of concerns with office space usage, traffic, and parking.

Former mayor Tom Levyn, who is representing the developers of 8767 Wilshire Blvd., presented two petitions that support the project: One, with over 200 signatures from neighbors of the project; and another with 'almost every commercial property owner and retailer along Robertson Blvd.'

"There is going to be a better solution once this building is going to be open," Restaurateur Giacomino Drago, owner of Il Buco restaurant situated directly across the project, said, "I'm here to support this building and that we can get some free parking."

Past elected officials also spoke at the meeting for their support on the project.

"We are here to listen to the facts and not to the emotions," former mayor Jimmy Delshad said. "The public benefits are very clear to us [and] that area of the city needs that public benefit. We should really go ahead and approve that."

Delshad voted no on the project in 2006 while he was still on the council, admitting that he didn't fully understand the parameters of the proposal at the time. After studying the project with the new terms, he voted yes in support of the project in 2009.

Levyn described several public benefits during the meeting, including 336 public parking spaces that would be available for patrons. Current businesses already in the area will also benefit from the parking space usage, with up to two hours free validated parking and low parking fees. The nearby Temple Emanuel will also have access to 50 free parking spaces during holiday season.

To ease traffic congestion, a new left hand turn on Robertson Blvd. would be created to allow easy access to the parking lot, and a loading and waiting zone will be available inside the building for taxis and of the project about traffic congestion, increased circulation of vehicles in the neighborhoods, as well as an increase in drivers using handi-

"To have discrimination against the use of a handicap placard is not only against the law in California, but it is against the law in the country," Alan Toy, executive director for Westside Independent Living, said. Beverly Hills residents, you will rush to your medical buildings and you will get your handicap placards. So don't discriminate on that basis."

Isabel Hacker, member of the Southeast Task Force, gave a presentation on the saturation of medical buildings and pharmacies on the surrounding streets of the 8767 Wilshire building. She presented a total of 26 medical buildings and 10 pharmacies already existing in the area.

"There is a medical world growing in the Southeast," Hacker said. "It doesn't matter

traffic and street parking in residential areas. He projected that there would be 675 patient trips every day, and estimates to about 85 trips per hour in an eight hour workday, and 125 trips during peak midday hours.

"The false hypothesis is that you only get the benefit by only putting in medical," Willmer said. "It's not the restaurant that's

One factor that is being taken into consideration by the City Council is a litigation that is pending against the city by the developers after medical space was denied by both the Planning Commission and City Council in 2009.

According to a Planning Commission report from the Nov. 21, 2013 meeting, the litigation is ongoing and is currently on pending review by the Court of Appeal. A settlement agreement was reached on Oct. 22, 2013. No approvals were given to the applicant, but a proposed project was made which included allowing 'medical offices, a pharmacy, ground-floor automobile showroom space, and an increase in the amount of floor area that can be occupied by a restaurant.' If the medical overlay zone is approved, then the litigation will be dropped.

Councilmember Julian Gold said that impacts on parking and traffic are important to consider in his decision and if the settlement agreements between the Kobor family and the city council are met.

"I think it was great that a lot of our residents came out," Gold said. "The staff will have the ability in the next two weeks to come up with more information."

Although the meeting ended at about 1 a.m., the City Council will continue the issue at the next City Council formal meeting on Jan. 21.

Congress needs to work constructively with President Obama's administration

By Congressman Henry Waxman

Last year, Congress earned all-time low job approval ratings. A recent poll showed that two-thirds of Americans believe the current Congress is the worst one in their lifetime. As a long-term Member of Congress with a strong record of bridging differences to get bipartisan legislation enacted, I am profoundly frustrated that Congress has failed to meet its most basic governing responsibilities.

Fortunately, the President has begun to use his executive authorities to tackle the pressing issues that Congress is ignoring.

The low point in Congress came when extremists in the Republican caucus forced a shutdown of the federal government and threatened to default on our debt. This reckless action weakened our economy, delayed our recovery, and

broke the public's trust.

In the House of Representatives, we have spent countless hours debating unsuccessful Republican attempts to repeal or defund the Affordable Care Act. Over the last three years under Republican control, the House has voted over 400 times to weaken environmental laws. Last year, the House voted 51 times to pass legislation that would benefit the oil and gas industry.

Time and again, key priorities -- immigration reform, economic growth, climate change -- were neglected in favor of partisan maneuvering.

The gridlock in Congress has forced the Obama Administration to work around the obstructionists to advance important national priorities.

A good example is health care. The

botched roll-out of Healthcare.gov has rightly been criticized. But it has also distracted attention from the many accomplishments that have been achieved as the Administration implemented the Affordable Care Act.

More than 6 million Americans have signed up for quality health insurance coverage just since October 1. Millions of these Americans have coverage for the first time, and millions more are finally eligible for lower premiums and better coverage regardless of their gender, their job, or their medical history. This is a huge step forward for the health and economic security of the middle class.

Seniors are also seeing the benefits of the law. Over 7 million seniors have received nearly \$9 billion in discounts on their prescription drugs - more than \$1,200 in savings per person - because the Affordable Care Act closes the Medicare Part D 'donut hole.' The law has also helped reduce the number of hospitalizations for seniors by 130,000 in just over a year, and it has helped keep health care cost growth at its lowest levels in 50 years, all while expanding and improving benefits rather than slashing them.

The Obama Administration has also made progress on the environment. Under the President's leadership, the nation has doubled the production of clean, renewable energy like wind and

solar. The new tailpipe standards for automobiles will double the fuel efficiency of new cars and trucks. And toxic air pollution from power plants has been cut dramatically, delivering health benefits to the American people worth as much as \$90 billion.

There are important challenges, however, that cannot be adequately addressed until we have a fully functioning Congress. I am encouraged that our final action in 2013 was a strong bipartisan vote for a budget compromise that will keep the federal government funded for two years. With a budget in place, I start the year more optimistic than I was last year, with the hope that we can turn our attention to initiatives needed to move our country forward to prepare us for the future.

We have unfinished business on job expansion, immigration reform, commonsense gun control, rules for technology that will guard our national security without eroding individual privacy protections, and comprehensive energy legislation that will promote alternative energies and address climate change. A good New Year's resolution for Congress is to put partisanship aside and work constructively with President Obama to forge constructive solutions


