

Former Los Angeles City Controller Wendy Gruel placed a disappointing third with 13,976 of the votes (16.77 percent), despite being endorsed by four out of five Beverly Hills City Councilmembers and several former mayors.

In the State Senator 26th District race, Santa Monica-Malibu Unified School District Board of Education member Ben Allen (D – Santa Monica) placed first with 19,710 of the votes (21.82 percent) followed by women’s rights

 activist Sandra Fluke with 17,797 votes (19.70 percent). Former Assemblymember Betsy Butler (D – Marina Del Rey) placed a distant fourth with 15,064 votes (16.67 percent).

In the race for county Supervisor, former State Senator Sheila Kuehl (D – Santa Monica) placed first with 43,348 votes (36.18 percent) and former Santa Monica Mayor Bobby Shriver placed second with 34,509 votes (28.80 percent).

West Hollywood Councilmember Jeff Prang, also supported by a number of Beverly Hills elected officials, led the field for Assessor with 89,742 votes (18.06 percent), but not with enough to avoid a runoff. Los Angeles Deputy District Attorney John Morris placed second with 81,523 votes (16.40 percent).

Long Beach Police Chief Jim McDonnell, endorsed by Beverly Hills Police Chief Dave Snowden, led the field for Sheriff with 264,104 votes (49.15 percent), just a hair below 50 percent +1 required to avoid a runoff.

Countywide, there were 636,186 ballots

cast, reflecting a 13.19 percent turnout.

The general election is November 4.

### City and BHUSD appeal court decision to allow subway tunneling under Beverly High

BHUSD and the City of Beverly Hills filed appeals on May 29 to the trial court decision that allows Metro to tunnel underneath Beverly High.

L.A. Superior Court Judge John Torribio ruled in March that Metro conducted accurate environmental studies and provided substantial information when choosing a Century City station location.

According to a statement released by the city, BHUSD and the City support the Purple Line extension, which includes two stops in Beverly Hills, but oppose tunneling underneath Beverly High for a Century City station located a few blocks away from the high school.

The two parties claim that Metro did not follow proper procedures when determining

the location of the subway tunnel, according to the statement. The reports conducted by Metro state that active faults were located within the Santa Monica Station location and underneath the high school.

According to BHUSD attorney Doug Evertz, Metro did not give BHUSD, the City, or the public a “fair opportunity” to comment on seismic information regarding the route underneath the high school.

“We now know that much of the information relied upon by Metro was simply incorrect,” Evertz said in the statement. “Metro’s rush to approve the revised alignment before all studies were finalized has left the School District with no choice except to continue the legal challenge.”

BHUSD claimed that Metro did not conduct a comprehensive Environmental Impact Report, and did not find any faults allegedly discovered by Metro, according to the statement.

“We continue to believe that Metro did

In some cases fees were adjusted by 0.4% based on the Consumer Price Index (CPI) for November 2013 to reflect the increase in the City’s costs. In other cases, the fees were adjusted to reflect a change in service level, or more equitable distribution of costs, rather than by the CPI. Most fees would become effective on July 1, 2014.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, June 12, 2014, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider a request to construct new, 20’ tall cellular antennas on the roof of the commercial building located at **9301 Wilshire Boulevard**. The Planning Commission will consider the following entitlements in reviewing the project:

**Variance.** A request for a variance to allow the installation of new cellular antennas on the roof of the building. The project includes a total of 12 panel-style antennas that would be contained within two separate rooftop enclosures. The antennas and enclosures would have a maximum height of 20’ as measured from the adjacent roof deck, which exceeds the 15’ height limit established in the Municipal Code for cellular antennas mounted on commercial buildings. The variance is requested to allow the antennas and enclosures to exceed the 15’ height limitation.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 1 Categorical Exemption for minor alterations to commercial structures, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

Kevin Brown and Renee Cobb were named at the Board of Education meeting Monday night as two of three Beverly High assistant principals.

English teacher Michelle Halimi was previously named as an assistant principal as well.

Brown has held administrative positions at Inglewood High School since 2009, including principal, assistant principal, and safe school coordinator.

Brown taught social studies and P.E. at Beverly High in the mid 1990's, and then taught at Culver City High School and in the Inglewood Unified School District for a combined 13 years. Brown taught college level courses at Kentucky Wesleyan College, Santa Monica College, and Moberly Area Community College.

Brown has 15 years experience coaching basketball nationally and internationally at the college and high school level.

Brown obtained his Bachelor's in Psychology from the University of California, Santa Cruz. He received his Clear Single Subject Credential in social science and physical education, Administrative credential, and his Master's in Education from California State University, Dominguez Hills.

Cobb is currently Compton Unified School District's College and Career Readiness Administrator. Previously, she was the principal of Whaley Middle School for two years, and the assistant principal of Centennial High School and Compton High School for a combined two years.

Prior to holding administrative positions, she was a counselor at LA Trade Technical College, an adjunct professor at Santa Monica College, and a special assignments teacher in the Lynwood Unified School District.

Cobb received her B.S. in Business Administration from DePaul University in Chicago, and her Pupil Personal Services and Administrative credentials from National University. She obtained a Master's in Counseling from California State University, Long Beach.

She is pursuing a Master's degree in choral conducting from California State Fullerton.


Beverly High's vocal music teacher Ethan Smith will be returning to Horace Mann for the next school year.

### Beverly High grads react to Santa Barbara shooting

2012 Beverly High graduate Matthew Kohanbash was visiting his friend Ariel Saadat (Class of 2011), who attends University of California, Santa Barbara, the night six Santa Barbara students were killed and a dozen others were injured in a shooting rampage on May 23.

Kohanbash finished his spring semester at the University of Southern California and vis-

ited Saadat for the Memorial Day weekend. Saadat lives on Del Playa, only a few houses away from where the shooting took place. Kohanbash said that they usually go

out to eat, but because he was tired from driving they ate at Saadat's house.

"We brought food from my friend's mom because she [had] just cooked for us," Kohanbash said. "[We were] lucky because right about when we finished eating we heard noises."

Since people were playing with fireworks earlier, Kohanbash and his friends didn't realize the noises were gunshots. When Kohanbash went to the balcony and looked towards the street, he saw a group of girls "running for their lives."

"It was very clear that they were running [really fast] away from something," Kohanbash said. "At that point we all knew there was something going on."

Kohanbash saw the shooter's black BMW drive by. A few seconds later police officers were yelling at everyone to take refuge inside and people on the street gathered at Saadat's house. Soon after, Kohanbash heard a car crash.

"It was a pretty horrific scene," Kohanbash said.

Kohanbash and Saadat left the house to make sure their friends were okay. When they went back to the house, the police prevented them from entering.

"I didn't like how the police handled the situation," Kohanbash said. "We told [the police] that we didn't have anywhere to stay and they just said, 'That's not our problem.'"

Kohanbash, Saadat and their friends eventually found a place to stay, but were unable to enter the house until the next day.

"I think [the school] worked swiftly and did a great job informing [the students]," Kohanbash said. "I noticed they weren't using the shooter's name and I found [it] really respectful [that] they were focusing on the victims as opposed to the shooter."

Kohanbash and his friends attended the candlelight vigil for the victims the day after the shooting.

"I'm not a person to talk a lot about tragedy and to glorify [the shooter]," Saadat said. "It was very unfortunate that it happened and it could happen anywhere."

According to Saadat, UCSB provided counseling for the students after the incident.

"Everyone is about the same age as you," Kohanbash said. "Even though we all go to different schools, everyone was there for each other. Everyone in the city just [came] together for this tragic event that occurred."

## GLOBAL EXCHANGE

### Beverly High English teacher Julie Goler teaches in Siberia

#### What is Teachers for Global Classrooms?

Teachers for Global Classrooms [prepares] teachers to teach their students with an eye on the emerging global market. When I was in college it was about diversity, and training kids to deal with an ethnically diverse population, and that's not what it's about anymore. We recognize that our students could end up with jobs anywhere around the world and it's preparing them to enter that world.

#### Tell us about your trip to Russia.

I was [in Russia] for two weeks and we started out in Moscow [where] we got an overarching sense of what was going on politically. We met at the U.S. Embassy with the ambassador and they outlined the recent history of Russia as far as the education system, [and] also what happened recently with Russia. There were 12 of us and we [all] went to five different schools all over Russia. I was in a small industrial town called Barnaul and I was primarily at a language school. The bulk of the work that I did revolved around working with teachers [and working] a little less with students than some of the other fellows chosen for this program.

When we got to Moscow we saw some of the schools. Thirteen percent of the city's revenue and the city budget actually goes to education. They don't take any money at all from national.

I was in Siberia for a week and then we came back to Moscow for [a] debrief [with the] 12 teachers.

The Russians would only show us the best of the best. When things heated up between Russia and Ukraine, they pulled one of the schools that we were allowed to see. We [didn't] know what that meant [and] we never got a reason, but they told our people at IREQs, which watches over the program for the state department, that it was just not a good idea that teacher goes.

#### What are some of the differences between American and Russian schools?

The major difference between U.S. and Russian schools is that it's completely determined at the government level. There's no sense of state control or regional control. All textbooks are approved by the Russian government at the national level, and everything is standardized grade by grade. That is a major difference from the U.S. where we have much more state control and even local control where districts can set policy.

We saw terrific science programs, and the thing that I was most impressed with was the emphasis they put on foreign language. There's a commitment that starts from when the kids are in kindergarten or in the first grade, so the time we were meeting with the kids that are the age that I teach, sophomores, they're completely fluent in English.

All administrators must also teach. You can't be a principal of a high school and not have a class. Because of this, I felt there was tremendous respect for administrators [and] closer relationships with students. All grades go to school in the same building, from kindergarten to high school. Teachers really know the kids as they [grow] up. It's a very close relationship.

There's very little critical thinking happening, it's all about the facts. The Russian education system is facts over synthesis and analysis. There's a real sense of right and wrong. In the United States I feel there is more emphasis on process, analysis and synthesis.

Men almost have no place in the Russian education system. I met with teachers in Barnaul in Siberia [and] if I met with let's say 200 teachers, I think I only saw two men. One of the things we gathered from that is they can't make enough to support their families. [Russian teachers] have to have two or three jobs to support their families.

The teachers seem to be really dedicated to their students [and are] extremely authoritative. When you walk into a classroom, kids pop out of their seats like jack-in-the-boxes. They stand in attention and they do not sit until their teacher or administrator says, "You may sit now."

I don't mean that the kids are unhappy at all it's just a different system there. Teachers are in charge. When we spoke to them about the playfulness that can be in an American classroom they didn't even understand that.

#### What were some of the differences in schools in each region?

I think there wasn't a regional difference as much as the difference between the schools. If you went to a STEM type school, then that's going to be very different than a language type school.

#### What did you teach at the schools you visited?

I was prepared to teach classes, but I ended up [giving more] presentations to kids and to teachers about the American education system. When we were in Siberia, [the students] wanted to know about us. They wanted to know how our schools worked [and] how our education worked. I [prepared] a lot of presentations about Beverly High with the help of my students.

#### How did your students help?

I can have kids collaborate on [presentations] from their own homes and work together. My students pool[ed] together the aspects of school that they thought were the most important, [which] included, academic requirements, extracurriculars, [and] sports. Some of the things I couldn't show. For example, you can't ever talk about [a] gay straight alliance program, it's actually illegal to put that in your classroom. One of my students had prepared a slide that talked about that on campus and I was told to take it out of the presentation.

There is no free speech. I felt like at the end of the time I was there I was really grateful to be an American and come back where I didn't have to watch what I say. I felt really sort of camped down by the system. It may have been the message we were getting from the embassy too, like don't create problems where you don't need to create problems. They expected us to never bring up certain topics, but if the Russian brought up certain topics it was okay, or if we were in the privacy of homes it was okay, but I never really felt like it was okay. I never really felt like it was okay to talk about Ukraine in a really

easy way like you would in the United States.

#### How were you able to connect with your students back in the States?

I had a blog [and] my students were reading that and the sub was talking with them [about] what was in the blog. On the tenth day I was able to facetime with my [sophomore honors English class from] Moscow. I really missed them at that point. I missed the way that we talk to each other in the United States which is candid and open.

When I came back the very first day I prepared a [presentation] for [my students] complete with pictures and explanations and they just had a lot of questions, like what did they think of us, what did they think of who we are as students, [and] what did they think of the United States.

The basketball coach at Beverly, Jarvis Turner, sent me with a bunch of basketball jerseys [and] I got some stuff from other teachers as well. The [Russian students] were so delighted by the gift. When you see them wearing the basketball jerseys they look just like our kids.

Russia has no extracurriculars. If you were in a robotics program, it may be a class [but], I don't know if that's an extracurricular. Definitely in Siberia, there's no football games [and] there's no sports after school. In order to fit all of the kids into the school building, kids have to go in one of two shifts; you either go from 8:00 a.m. to 1:00 p.m. or 1:30 p.m. to 6:30 p.m. That's a lot of time in [the] day that kids are left alone [and] not in school. If parents have money, they [can] plug them into a language program after school or a tech program or a gymnastics program but it's not something that originates with the school. Parents have to be the ones who look for something.

We talked about what [American] kids do in their free time [like] go[ing] to the beach, hiking, hanging out with friends and shopping. That was baffling to them. [Russians] don't dine out; you eat in your home, [and] spend a lot of time with family.

#### How do you bring what you've learned through the program back into your classroom?

I guess to work in elements of other countries and cultures in[to] what I do, to constantly remind kids that there's a world outside of the United States. We're not [only] preparing our kids for jobs in Los Angeles, even in the U.S., we have to prepare our kids for jobs around the world. I think part of that is in developing an appreciation for other cultures.

For our students we should be cultivating curiosity and empathy for other cultures. If I'm teaching *Macbeth*, and tyranny is one of the ideas in *Macbeth*, I'm going to ask to the kids to look at tyranny around the world, and see if there's places where tyranny still exists. Where are other revolutions around in the world? *A Tale of Two Cities* is a result of oppression and an old form of feudalism; where is that presence in the world? I want [my students] to make connections in what we read that may have been written in the 19th century and today in 2014.

#### Tell us about yourself.

I am a native of Southern California [and was] born in Pasadena, raised in Orange County in Fullerton. I spent seven years on the east coast [and graduated with a math and social science degree from] Dartmouth College and [I went to] Yale Law School where I met my wife, Ainslie. We have three children; two girls and a boy; eight, seven and five years old. We live in the Pacific Palisades.

#### What did you do after law school?

After law school I worked at McKinsey and Company, which was a management consulting company. When I left McKinsey and Company I set up a professional advisory firm where we provided legal services, consulting services, and financing services to small businesses in Southern California. During that period, I [founded] the Law Offices of Steven Sugarman, [which] was in the West Hollywood area. I also got my real estate broker license. Then [it was] really a prelude to what I'm doing now [in] serving small businesses and venture investors throughout Southern California, [by setting] up [their] finances to operate their business.

#### How did you get to Beverly Hills?

I've been working out of the Beverly Hills office for a few years now and we acquired a business recently called CS Financial which is located at Wilshire and Camden. My headquarters for Banc of California is now within that building, so I've been working out of Beverly Hills for a couple years and I've enjoyed it.

#### When you worked in Beverly Hills, was the entire time for Banc of California?

I've had a lot of business in Beverly Hills prior to Banc of California. When I took over [as] CEO, we established an executive headquarters in Beverly Hills.

#### What were some of those other businesses that you had?

I've had a few. I started [an] investment and advisement business in 2005. It was headquartered in Santa Monica. In 2009, I spun off and started COR

Capital, [which is] also headquartered in Santa Monica. We did a lot of business, and I had an office in Beverly Hills at the time as well.

#### Are you involved in any Beverly Hills organizations?

We joined the Chamber of Commerce recently. I'm involved in a few charitable organizations with roots in Beverly Hills. I joined the Los Angeles Teen Mentoring [board recently], which has relationships with a number of elementary schools, and middle schools around Los Angeles, and I'm [also] involved in [the Jewish Vocational Service] charity.

#### Tell us about Banc of California.

I led investment of recapitalization of [Banc of California] in 2010, [when] it was a small bank headquartered in San Diego County [with] about \$700 million of assets. It's a bank where a lot of the local businesses, business owners and

investors were participants in recapitalizing this bank. [It] focus[ed] on banking services and lending particularly within Southern California. One of our main investors is Oaktree Capital.

Since that time, we've acquired three additional banks and most recently we announced the acquisition of the California banking business of Banco Popular [which runs] under the Popular Community Bank brand [that] we will integrate later this year. That will bring us to about a little bit more than \$5 billion in assets.

So we'll be the ninth largest independent public bank in California.

We have the ability to meet the needs of most clients or businesses so we can make large loans. We're also still a regional player in a community-focused bank that takes pretty special [care] in relationship approach [with] our clients.

A lot of the things we're pretty proud of include [having]

just north of about \$5 billion of assets. With our lending platform and the financing we provide for the Southern California community we expect to make about \$5 billion of loans this year. When you think about it, for people who put a dollar on deposit with our bank, we'll take that dollar and lend it out

to the local community.

#### Can you tell us about transferring to the New York Stock Exchange?

We're really excited to join the New York Stock Exchange. It's a trading platform that is really exclusive to some of the premier bank holding companies around the country. It provides an orga-

nization like ours really nice liquidity and recognition for our bank.

It's also a milestone accomplishment to meet the qualifications, which are pretty rigorous and important. Our depositors and our clients [will] know that we meet the highest level of qualifications to trade on the New York Stock Exchange and we have the safety and security that comes with having a stock and access to capital.

We were back there last week with our senior management team where it was a great opportunity to take a step and celebrate the milestone accomplishment. We spent time at the New York Stock Exchange with some of our investors, talking with some of our investors about what's next and where we've come from. We've also spent a lot of time with our employees because the amount of work, effort, progress, growth and resolve that they've put in really lays the foundation for being qualified and accepted onto the Exchange. It's been an active week or two and it's been a fun one because it's nice to hit a milestone. It's not our last milestone, but it's an important milestone along the way.

We're just now regrouping and looking forward to our next milestone, which is the closing of our acquisition of the Popular Community Bank branches.

#### What was it like to ring the big bell?

Ringing the bell was something that's dreamed about as a public company. It was fun, it was exhilarating, [and there was] a lot of energy. To have the whole team there alongside to celebrate it was also really rewarding. What was interesting for us is we also got to ring the bell on the first trade for our stock which happened about three minutes [after the start of trading] on the floor of the Exchange. It's a great traditional ceremony where we got to open our stock for first trade.

#### What are the plans in the future for Southern California?

The main thing that we are really focused on is making sure that we get our client experience right. Then [letting] our borrowers and depositors know that we're open for business, we're making loans, and we're meeting [the] folks' needs. [We're] building, developing and redeveloping that niche that [focuses on] Southern California's needs. We're able to lend money to private businesses, entrepreneurs and homeowners. [Also giving] great service [to] our private bank and community bank and branch.


