Chodos' fees too high, Richards says

Beverly Hills attorney Ronald Richards told a state appeals court on Friday that Hillel Chodos' award of \$7.8 million for unpaid attorney fees in a lawsuit against Navabeh Borman was not justified due to violations in the Business and Professions code.

Chodos also represents Karen Christiansen, who is suing the BHUSD.

According to the *Daily Journal*, a California legal newspaper, fee multipliers are usually awarded to attorneys "for winning certain exceptional cases in order to further the public interest," though Chodos was awarded a fee multiplier for unpaid attorney's fees in a divorce case.

Borman appealed a 12 - 0 jury vote in September 2013 that increased Chodos' \$1,000 per hour rate to \$5,000 per hour for his unpaid services representing Borman for an undocumented 1,500 hours he claimed he accumulated in two separate divorce lawsuits and a palimony case between Borman and her husband, according to the *Daily Journal*.

No written fee agreement was made for the \$1,000 per hour rate, which is a violation of the State Bar code, according to the

Daily Journal.

"Chodos has never sent a bill to this client," Richards said. "There has never been a case in the history of the United States of a jury awarding a multiplier in a fee dispute."

In Borman's divorce lawsuit, Chodos was able gain a settlement that amounted up to \$26 million in assets, including partial ownership of a Frank Gehry-designed Malibu home and other properties and ownership of several art pieces, according to the *Daily Journal*.

Borman fired Chodos after he "threatened to drop her divorce case if she did not wish to take the settlement" according to the brief.

Chodos' attorney in the appeal case, Phillip Kaufler, said that the \$1,000 per hour rate was not adequate for the work Chodos did for Borman, according to the *Daily Journal*.

"[It's] not enough, the jury didn't think it was enough, [and] the trial court didn't think it was enough because he got his client a jackpot result," Kaufler said on Friday.

Judge Michael Mink, who sat on the appeals court panel on Friday, said Chodos would have been paid for his work at \$1,000 per hour if there was a written fee agreement, but was instead "rewarded with five times his usual rate," according to the *Daily Journal*.

"He doesn't follow the State Bar and provide a written agreement and that gives him the benefit of getting by that when he goes to trial," Mink said. "It makes no sense to me."


The panel is expected to rule within 90 days.

Richards also represented *Beverly Hills Weekly* in its recent successful SLAPP motion against the *Beverly Hills Courier*.

Karlin argues successfully in front of the U.S. Supreme Court

The appeal on the *Fernandez vs. California* case, argued in front of the Supreme Court in November 2013 by Deputy State Attorney General and Beverly Hills resident Lou Karlin, was denied in February with a 6 – 3 vote in the State of California’s favor.

Justices Ruth Ginsburg, Elana Kagan, and Sonia Sotomayor dissented on the grounds that in the process of obtaining a search

warrant, the police could have stayed on the property and prevented individuals from going in and out of the house, according to Karlin. Ginsburg favored the need for a warrant rather than relying on consent

The majority’s opinion held that the co-

owner had the right to allow people in and out of the property, including authorization of a police search. If another occupant who objects to the search is not present on the property, then the consent of the co-owner who authorized the search is still valid.

The case involved a 2009 police search of Walter Fernandez’ home in Los Angeles while he was not present. Fernandez was sentenced to 14 years in prison for robbery, gang activity, and illegal gun possession, but appealed his arrest on the grounds of his fourth amendment rights.

Along with an Obama administration attorney, Karlin urged the court to uphold the search and seizure as reasonable.

Karlin was featured in Issue #741 of *Beverly Hills Weekly* discussing his appearance before the high court.

The opinion for the appeal came out on February 25, but Karlin found out about the decision through a live blogging website on Supreme Court cases called *Scotusblog* prior to being notified on the decision.

“I [knew] that the opinion was probably coming out soon,” Karlin said. “I just went to *Scotusblog* that does live blogging every day that court’s in session [and] I found out pretty much instantaneously.”

Though Karlin doesn’t have a Supreme Court case coming up in the near future, he said that he was “very lucky” to have the opportunity.

“I would love to do another case,” Karlin said. “I think that I became a better lawyer by forcing myself to get up to that level that’s expected.”

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, June 26, 2014, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

A request for a variance to allow an accessory structure (pool house) to be built on a property without a main residence, and to allow the pool house to be located less than 100’ from the front property line. The subject property is located in the hillside area at **1297 Monte Cielo Drive**, at the intersection of Monte Cielo Drive and Monte Cielo Court near the border between the Cities of Beverly Hills and Los Angeles. The proposed one-story pool house would include approximately 850 square feet of floor area, have a height of 14’, and be set back a minimum of 5’ from the nearest property line. The subject property is currently inaccessible except from the adjacent property at 1721 Monte Cielo Court located in the City of Los Angeles. Both properties are held under the same ownership, and if approved would function as a single site, with the pool house being accessory to the main residence at 1721 Monte Cielo Court.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 3 Categorical Exemption (New Construction or Conversion of Small Structures) in accordance with the requirements of Section 15303 of the Guidelines for the “construction of an accessory structure appurtenant to the primary dwelling unit in a residential zone.”, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.



Peninsula Hotel permit extension allows late night rooftop usage

The Planning Commission unanimously approved the Peninsula Hotel's permit extension on May 22 for rooftop pool and dining usage with late night business hours.

Residents who live in the neighborhood near the Peninsula Hotel expressed concerns on amplified music and noise that is "loud" and "disruptive" and claimed that allowing late night business hours are "disturbing on weekdays."

Business hours for Sunday through Thursday will continue to be open until midnight, and open until 2:00 a.m. on Friday, Saturday, and evenings before a holiday. The hotel will be allowed up to 12 rooftop events per year to last until 2:00 a.m. during weekdays.

When Planning Commissioner Craig Corman asked if the noise occurred after 10:00 p.m. or what day the disturbing noise occurred, the residents could not recall exactly what day, and stated the noise was before 10:00 p.m.

"I actually walk the perimeter of that Charleville/Lasky area, and I'm in contact with the management team on the roof," Peninsula Hotel executive assistant manager James Overbaugh said. "I ensure there's no noise that is extending beyond that area."

Seven events were held in 2013 at the Peninsula Hotel, and no calls, out of 35 service department calls, were related to excessive noise after hours and there were no code enforcement cases instances, according to associate planner Andre Sahakian.

"We're not going to have events where there is going to be an impact to the neighborhoods because it's going to be a big impact to our hotel guests who are not going to tolerate any noise whatsoever, long before it becomes an issue for the neighborhood," Overbaugh said.

Overbaugh mentioned that noise can be heard from the Hilton Hotel, and the Peninsula Hotel should not be held accountable for noise not associated with their establishment.

"I would just say to the neighbors, if you do hear noise, I would make complaints at that time because the records seem pretty clear that there [were] no police complaints made," Planning Commissioner Alan Block said.

According to Peninsula Hotel attorney Mitchell Dawson, the events do not continue extensively past 10:00 p.m. Due to the lack of events that go past 10:00 p.m., city staff was unable to determine the full impacts for the late night usage permits.

The managers were advised to contact the community director of development should events go past 10:00 p.m., as required by the conditions on the permit.

Planning Commission Chair Brian Rosenstein asked if the extended hours were necessary to continue operations, and if limiting the closing time to 10:00 p.m. would

have adverse impacts to the business.

Peninsula Hotel managing director Offer Nissenbaum said that having a closing time at 10:00 p.m. would dissuade potential customers because of having limited time availability.


"We want that flexibility [and] it has nothing to do with noise or music," Peninsula Hotel managing director Offer Nissenbaum said. "While the major event may be winding down, we want people to be able to sit in a beautiful environment. You don't want to push people away and tell them to go unless they're doing something detrimental to the hotel so we want to be able to be welcoming there, and [for guests to] be able to occupy the space, obviously without noise."

Where were you during the OJ Simpson Bronco chase?

JUNE 17, 1994

JONATHAN PRINCE FORMER BHEF PRESIDENT



It was 1994 [of] June, [and] I was directing a movie called, Camp Nowhere, [a summer camp] movie for Disney. We were at Disney Studios and we were on a sound stage looping some performances. The movie was in the can, so we were just looping. We were on the sound stage on a quiet day and the movie was in really good shape, the executives were happy [and] everything felt right.

Then somebody said, "Hey, you should go look at see what's on T.V. There's this OJ [Simpson] chase." When you're looping, you aren't anywhere near a T.V. All you're doing is playing back the movie over and over and over again, and the actors are

reiterating their lines, making them clearer or changing them for performance. There [are] no televisions around [and] we're not watching T.V. so we had to go out to another office building and watch because everyone was saying, "You have to see this." So we think to ourselves, "Well, how long can it last? Let's go check it out."

And, like everybody else in America, [we were] glued to the television set. Of course the clock is ticking and as the sand shifts through the hourglass, we [were] spending too much time watching OJ Simpson and not enough time looping. Back then you're not DVR-ing anything [and] there's no Tivo, so all I remember is that I had to go back to

the sound stage with my editor and my mixing team and the actors would come in and out doing their lines. Everybody came in talking about it and of course any time there was a break in the action, like if an actor was done with that one moment of looping that they had to do, they [would] go running out to the television set in the other office building. [The actors kept] running back and they would give us [the] progress [on the chase], so all the progress that I got on the OJ chase that day until the evening was coming from actors who would run in and out from where the television set saying, "He's still going." I didn't get to watch much of it so I kept thinking, "How slow is this guy driving?"

Even though I knew it was going on, I was watching Camp Nowhere, over and over and over. So the crew's [watching] breaking news, and I'm watching the same scene from a movie 50 times in a row that I directed, so I knew every inch of [the movie]. I may be the only person in the world who heard about the chase secondhand even though I could've watched it at any point in time.

Here's the other part that was strange for us. He lived on the corner of Rockingham [in Brentwood and] my first cousins lived literally two blocks from OJ's house; they're on Rockingham also. That night [my cousins] kept calling saying, "There's cops everywhere," so I [was] getting reports from everybody and I'm seeing nothing.

My entire experience from the OJ car chase was one of frustration, but I did watch the trial. I have to say, the trial was the best T.V. of all time. There [was] a great article of how the OJ Simpson trial was really the first reality television show. It was the show that everybody watched that was real, and [defense lawyer] Johnnie Cochran became a star, [prosecutor] Marcia Clark became a star, [witness] Kato Kaelin became a star, even the Kardashians, [OJ Simpson's friend and lawyer] Robert Kardashian, they all became celebrities off that trial.

I missed most of [the car chase but] I would have [preferred watching it]. Even though nothing happened, there's something about the communal experience of watching a live event on television. We're all watching it together [and] there is something bizarre about it. It's like watching the Super Bowl, or watching the Tony Awards, the Academy Awards, or watching breaking news. We become a community. Television unites us, and we all react together. For one moment we're in the same place, whether it's as something as ludicrous as a low speed car chase or something as important as the beginning of a war.

I was in San Diego, still in the Navy. We weren't out at sea doing operations [and] we were in port at the time. My parents were in town visiting me from Philadelphia at an apartment outside the base in Pacific Beach, California. I think we turned on the T.V. [and] it was everywhere. We caught it somewhere in the middle and had no idea what was going on.

We ended up, [like] what a lot of other people did, [ordering] pizzas and watch[ing] the craziness unfold on T.V. I saw a story somewhere where more take-out or delivery was ordered that day

than any other day, because people just stayed home and didn't leave their T.V.s.

We were just shocked. You watch this Bronco drive slowly and they're talking about OJ [Simpson] being in the backseat laying down or something. How could a Heisman trophy winner, all American, NFL future Hall of Famer, how could someone like that get themselves in this kind of situation and make these kind of choices? It was shocking and sad.

I was glad [when the chase] was over, and of course it was just the beginning of the

drama for Nicole Brown and her family. I remember watching the people on the highway jumping up and down too and you don't think [about] that. [It was] sad also, not a great day for L.A. or America, nothing good about it. The trial just became kind of a circus which is again not good either.

Actually, probably a more interesting story is my [future] wife [Sharon] lived close to Brentwood at the time. I didn't know her at that point [and] we met a couple of years later, but she lived next to Ron Goldman [the waiter who was stabbed at Nicole Brown Simpson's Brentwood home]. [Sharon] had an apartment with I think two other girl friends. [Goldman] was a waiter, who ended up getting killed [and] he lived next to Sharon and she didn't know anything about it. The camera crews knocked on her door, and [when] they opened the door, there [were] all these cameras standing there. They [said], "Well, Ron lives next door, so we want to interview you guys." They were shocked - they didn't know what his name was. In fact, he was such a good-looking guy that they called him, "The View."

They must have known what happened, but they didn't know Ron's name at all, they just knew he was a really good-looking guy who lived next to them and walks by their place all the time. I don't think they connected their neighbor to the death, until the cameras showed up. [Sharon] was a little more closely involved than I was.

I followed the trial pretty closely, I think I was probably at Beverly Hills [as a science teacher at Beverly High] when the verdict [was decided]. I think it was determined when I was listening to the radio between classes when they announced the verdict.

The kids would talk about [the trial] once in a while [and] the staff would talk about it. We were all kind of saturated with it at that point [and] we were all sort of living this drama whether we wanted to or not.



**ROBERT K. TANENBAUM
FORMER MAYOR**

I couldn't help [seeing the OJ Simpson case]. I tried to avoid it by putting on ESPN [but] it was on there [too]. I was working and there is was. I knew nothing about the case at that particular moment but like everybody else, I was in my office working with the set on. I was somewhat astounded on what was going on. [I did not watch the whole chase], just caught a glimpse of it, I'm not a T.V. watcher. How could you just stare at a set? It's like staring at a monitor. It was far from a chase [and] it was more of a slow motion drama that was going to end badly for OJ

Thereafter, I was asked by KCAL [Channel 9] at the time, to come to the studio and give my commentaries [on the Simpson's case] as [it] was unraveling. Because of my books and the cases that I tried when I was an Assistant [District Attorney] in Manhattan in the homicide bureau prosecuting murderers, I was asked on many occasions to do commentaries as well as being on court T.V. I've prosecuted over 200 cases in the DA's office.

I was just on the Simpson's [trial] with respect to this though. [KCAL] sought me out for some reason or other, [and] I said I would do it and I had a great time. The Simpson case was such an important case, it presented a window into the justice system. I was so disappointed with the inept prosecution of the case; the prosecution has a tremendous advantage on the system. But you have to prepare, you have to have experience, [and] you just can't do this because you want to get some publicity.

I did [commentary] for [the duration of the trial], and I was on two [to] three days a week. There were always two anchors and me, and sometimes there [were] just two of us; myself and the anchor. They were asking questions as to what the defense would do, what the

prosecution would do, and then when they did it, how did they did it, [and] how did they perform. Basically, I was there to answer questions proposed by the anchors.

That was a heck of an experience. I was with outstanding anchors at KCAL and they were very poignant in their analysis, they were insightful, and they had very incisive questions to ask that would inform the public about what was happening with respect to the case. That explanation was in non-legal terms.

It was a lot of fun. I just was appalled at the lack of expertise coming from the prosecution side.



**JASON LAWRENCE
CITY CLERK'S EXECUTIVE ASSISTANT**

It was either the sixth or seventh grade and I was [watching] the NBA finals [between the Knicks and the Rockets] in 1994. I was sitting in my parents' room [watching] the game and in the middle of the game, [the screen split] in half, so they were showing the game on one half of the screen and then the chase on the other half of the screen. After a certain time, [the chase] completely overrode the [NBA] finals, and they just focused on [the chase].

At the time, I wanted to watch the game and I was upset because the T.V. was only 13 inches so [with] the 13 [inch] screen split in half, you're not really seeing much of anything. I didn't understand the magnitude of what had happened at the time with the whole chase, and I [was thinking], "I can't see the game, it's too small."

I paid attention [to the trial and] I [watched] it, but I wasn't really actively following it. I don't think I really knew [the trial was a big deal] until after it was over because I never saw a trial like that being covered like that on television. I hadn't recalled a trial being shown on television the way that one was, but then again, I wasn't actively thinking about it either.

For me, because I was so young at the time, I wasn't following court cases, trials and things like that. I think when the verdict was read, there was such a reaction to it that you really understood that this was something that people were seriously interested in and it had a big cultural impact. Some people were happy about it [and] some people were mad about it, [and] that's when you kind of understood how big it really was.

It was one of those things where I was going to school, and I wasn't reading the papers every day [and] following what was going on. If I didn't know where they were in the trial I would just come home and see the news, [then] do my homework and move on with the next day.

That [playoff] series was also highlighted by the trial since they go hand-in-hand. I believe they even did a feature on ESPN that tied both of them together. They did a collage of images that were happening at the same time the trial was going on. Those two things just kind of go hand in hand when I think back to that year, 1994.



**LINDA BRISKMAN
FORMER MAYOR**

I was playing golf in Brentwood close to [OJ Simpson's] house and all I remember was the helicopter noise which was deafening. Once we were done and started watching [the car chase] we couldn't believe it. Actually, when the murder happened they searched our golf course for the weapon. I come down on the side of guilty. So sad and justice wasn't served in this case.





SUMMER READING

What are your neighbors reading?

The City

Beverly Hills residents can get a head start on reading Daniel James Brown's *The Boys in the Boat* for the One Book, One City community-wide book selection.

Nine working class boys, who were sons of loggers, shipyard workers, and farmers in the American West, compete as the U.S. men's rowing team in the 1936 Olympics. In an era of the Great Depression and with the 1936 Olympics set in Berlin, Germany, when Adolf Hitler and the Nazi regime were in power, *The Boys in the Boat* chronicles the American team's struggles and success.

Events and activities for the One Book One City program will unfold in the fall.

The Friends of the Library Book club will be discussing Melanie Benjamin's *The Aviator's Wife* in June, Herman Koch's *The Dinner* in July, and Jonas Jonasson's *The 100-Year Old Man Who Climbed out the Window and Disappeared* in August. In September, they will be reading *The Boys in the Boat*.

The group meets in the Library Meeting Room South and will hold three meetings in June, July, and August. Though one meeting passed already for June, two more dates to join the discussion are June 11 at 10:15 a.m. and June 19 at 1:00 p.m. The meeting dates for July are July 1 at 10:15 a.m., July 9 at 10:15 a.m., and July 17 at 1:00 p.m. Meeting dates set for August are Aug. 5 at 10:15 a.m., Aug 13 at 10:13 a.m., and Aug. 21 at 1:00 p.m.

The Great Books Discussion Group, which meets year round, will continue to meet throughout the summer on the second and fourth Mondays of each month at 6:00 p.m. on the second floor of the Beverly Hills Public Library in meeting room north.

The group will discuss Tom Stoppard's *The Design of Love (Play)* on June 23, T.S. Elliot's *The Hollow Men* and *Tradition and the Individual Talent* on July 14, Jean-Paul Sartre's *Existentialism and Human Emotions* on July 28, Antov Chekhov's *Short Stories: In the Ravine, Sleepyhead, Peasants* on August 11, and Michel Foucault's *Discipline and Punish: The Birth of the Prison* on August 25.

Joining the Grown-Up Reading Club will be the new Seniors Reading Club, where both groups take on the theme, "Turn a Century, Turn a Page," in commemoration of the City's Centennial. The reading clubs encourages local adults and seniors to read or listen to books. Those who register in either clubs are eligible to win prizes, which includes an eReader. Entry forms are available online at www.beverlyhills.org/src2014 and at the library and must be turned in by August 17 to be eligible for prizes.



Children

Signups for the Children's Summer Reading Club have already begun.

Children, aged pre-k to the third grade, can sign up online through www.bhpl.org or in the Children's Library during library hours and report their reading progress until August 10. Each child will receive a reading log, where they will color in one cupcake for each hour read.

Children, tweens, and teens have their own theme for the Centennial this year: "Life of the Party."

Children will receive a reading certificate and one free paperback book once they read 30 hours.

Participation also counts towards the BHUSD's Summer Reading Medalist program. To reach the BHUSD Silver medal, children must read 40 hours, and to reach BHUSD Gold medal 50 hours must be read.

The Children's Reading Clubs will hold free performances in the Civic Center Plaza from 4:00 p.m. to 5:00 p.m. on Terrific Tuesdays, with the first performance by Juggler

"Fantastick Patrick" on June 17. Other performers include Luce Puppet Company, Clint Perry and the Boo Hoo Crew musical group, and Magician "Amazing Dave."

Beginning July 7 and lasting until September 11, the library will host free weekly programs featuring storytelling, music, and puppets for babies, toddlers, and preschool children.

Along with the library's recommended list of classic children's books including Ian Fleming's *Chitty Chitty Bang Bang* and Richard Atwater's *Mr. Popper's Penguins*, Library Services Manager Marilyn Taniguchi recommended Barney Saltzberg's *Chengdu Could Not, Would Not, Fall Asleep* and Divya Srinivasan's *Little Owl's Night*.

For readers in middle grade levels, Taniguchi recommends Jim Opper's *Boundless* and Laurel Snyder's *Seven Stories Up*.

High School

Students entering honors and AP English courses in the fall will have enough books to keep themselves busy over the summer.



Completion of summer reading will be assessed by essay testing for all grades. The assessments count for 10 percent of the student's semester grade.

Incoming freshman will be required to read three books, sophomores are required to read two of five books, juniors are required to read three of nine books, and seniors are required to read two texts, with a recommendation to read Homer's *Odyssey*.

Selections for the various grades include Rudolfo Anaya's *Bless Me Ultima*, William Manchester's *A World Lit Only by Fire*, John Steinbeck's *The Grapes of Wrath*, and Mary Angelou's *I Know Why the Caged Bird Sings*.

All students will be required to read *The Boys in the Boat* by Daniel James Brown as part of the One Book One City community-reading program.

Teens in grades six to twelve can sign up for the Beverly Hills Public Library's Teen Summer Reading Club. Teens will receive a free book once they have read 15 hours. Once they have read 30 hours, they will receive a \$5 gift card and be entered in a drawing for prizes.



Former Traffic and Parking commissioner IRA FRIEDMAN is currently reading *Stars of David*. Abigail Pogrebin, 60 Minutes producer, interviews 62 accomplished Jews in America, including Sarah Jessica Parker, Supreme Court Justice Ruth Bader Ginsburg, and Larry King, on how they feel about being Jewish.

Friedman attends Sinai Temple, where Pogrebin spoke about her book and sparked his interest in reading it.

On his summer reading list are back issues of *The New Yorker* and *Vanity Fair*, as well as daily newspapers from *The New York Times*, *LA Times*, *The Wall Street Journal*, and other newspapers.

"I've read newspapers since I was about 10 years old," Friedman said.

"I've always loved newspapers. [In my fourth grade class] one day a week we got *The Herald Tribune* and that was part of our curriculum, reading that paper."




Pubic Works Commission vice chair RON SHALOWITZ is currently reading *10% Happier* by ABC News correspondent Dan Harris.


full of books.





Fine Art Commissioner CAROLYN HILLER finished reading *Purple Hibiscus* by Chimamanda Adichie.


Hiller read one of Adichie’s other books, which she was “so impressed with” and was a “beautifully-written book” that she wanted to read more books by the author.

Cultural Heritage Commission to consider Kate Mantilini and Gibraltar Savings tower for landmark distinction

The Cultural Heritage Commission unanimously approved on June 3 moving forward with the landmark distinction process for the iconic Kate Mantilini restaurant, Gibraltar Savings and Loan Tower, and a parking structure located on lot 9107 to 9111 Wilshire Boulevard.

The Gibraltar Savings and Loan Tower was design by Master Architect William Pereira and his firm, Pereira and Luckman in 1958. The bank was headquartered in Beverly Hills, and closed in the early 1990s. The tower has the potential to be considered for the California Register for its Post World War II modern office building.

Kate Mantilini’s last day of operation is this Saturday, and was redesigned by the recipient of the Pritzker Architecture Prize, Thom Mayne and his team. Morphosus, who designed and recently completed the Emerson College Hollywood campus on Sunset Boulevard.

The restaurant was named after 1930s boxing promoter Kate Mantilini. The owners, Harry and Marilyn Lewis, requested Mayne to use a clock element when redesigning the space, according to Urban Designer Bill Crouch.

Mayne and his team incorporated elements to reflect boxing elements, including the cage-like exterior bars. A mural depicting Marvelous Marvin Hagler’s eight-minute knockout of Thomas “the Hitman” Hearns that took place in 1985 is set inside the restaurant, and can be seen through the building’s windows.

Commissioner Rebecca Pynoos told the story of how the muralist, John Wehrle, was inspired by the fight.

“The muralist had never seen a fight before,” Commissioner Rebecca Pynoos said. “The story goes he saw it on video tape, and he saw the ropes and gloves as musical lines and notes, so there’s some sort of musical element in the red gloves that you see in the mural.”

Crouch said that to consider Kate Mantilini as a landmark designation, though the restaurant may not be saved the building itself could be preserved. Since the building does not reach the 45-year threshold, character-defining features “must be defined by exceptional significance.”

The commission agreed that the building exhibits several “exceptional” features that would override the 45-year-old criteria.

Since Mayne is considered a prominent architect through his work and his team Morphosus, Vice Chair Maralee Beck said that the commission should discuss considering notable architects who do not yet have a Master Architect title in order to not lose potential properties “that may be given to our futures.”

“Heritage by itself does not mean age, it means an inheritance, and an inheritance can come at any age,” Beck said.

Hawthorne named as California Distinguished School

Hawthorne was recognized as one of 424 California Distinguished Schools, at the California School Recognition Program regional ceremony held at Irvine Hotel Wednesday morning along with schools from across Southern California.

"It's generally recognition for performance improvement, and they look at the API of the school and they look at the overall growth out of that school and note the improvement in the [Academic Performance Index]," Chief Academic Officer Jennifer Tedford said. "If you look at Hawthorne's API over the last five years, they've shown overall growth over the last five years."

According to California Department of Education website, Hawthorne's API from 2013 was 935, 2012 was 936, 2011 was 925, and 2010 was 909.

"It's also about the achievement gap, meaning students who are considered low performing [are being moved] forward," Tedford said. "Hawthorne in particular has done a great job dedicat[ing] resources to students [with learning challenges], track[ing] and monitor[ing] the performance of those students, and they've shown a lot of growth."

All five schools in the BHUSD have been recognized as a California Distinguished School. Beverly High was named as a National Blue Ribbon School and a New American High School.


