## "City employees, teachers to receive increases; but how much is too much?" [Issue #776]

I read with considerable disappointment the response of former school board members to the recent salary settlement between our school district and its employees. While I'm sure we all agree that the district needs to stay solvent, it amazes me that so many people who should know better are willing to obtain that solvency on the backs of teachers and other school employees.

One problem with fiscal management in this district has always been an unwillingness to budget for inflation adjustments for salaries as we do for inflation in every other kind of expenditure. What was the result of this approach? When I first started with the district, it boasted publicly about having the highest salary schedule, not just in the county, but in the state. (So much for the current board policy being unprecedented!) At that time board members and administrators seemed to grasp the idea that you get what you pay for. As we lost that commitment to paying the highest salary to get the best teachers, more and more fine educators have either left the district or passed up the opportunity to come here. As a member

of several interview committees over the years, I have seen with my own eyes the negative effect of lower salary and benefits on recruitment. Particularly heartbreaking was seeing top candidates be offered jobs in our district and turn them down to work elsewhere. In virtually every case, "elsewhere" had better salary and/or benefits.

If, as our former board members imply, paying competitive salaries is the first step on the road to insolvency, how can they explain how districts that have been paying higher rates for years are not insolvent already? It is also worth noting how many of these districts actually have lower per pupil funding than we do. I'm not a math teacher, but even I can see that the argument made by these former board members just doesn't add up.

Recently a number of former BHUSD Board of Education members took exception to the outcome of the school district's Collective Bargaining Agreement (CBA) with the Beverly Hills Education Association (teachers).

The former Board members had it correct that the current Board of Education has made an "unprecedented commitment" to our teachers to make them the highest paid in Los Angeles County.

While many teachers cite intangible rewards as reasons for staying in the profession, concrete remunerations such as salary, benefits, and working conditions are inextricably linked to attracting, developing, and retaining highly-qualified teachers. Our community regularly mentions the professionalism of our emergency services as positive factors for the success of our city. The Beverly Hills Police and Fire Departments both have contracts stating they will be the highest paid in Los Angeles County. It is time we acknowledge that the same level of professionalism exists with our educators.

The former Board members are also correct that salaries and benefits amount to 80 percent of total district expenditures. That is true for almost every public school district. That is precisely the reason that for the first time in over two decades our board, in collaboration with BHEA, has worked to ensure this district is not overstaffed. Reducing the number of employees will result in savings of millions of dollars in salary and benefit liabilities, while still maintaining small class sizes.

Along those lines we have taken affirmative and significant steps to reduce the school district's overall financial exposure by offering "Golden Handshakes" to our veteran educators. This fiscal strategy has significantly reduced current salary and benefit liabilities.

Prior boards have kicked the can down the road regarding subsidized medical and dental coverage for retirees under the district post-employment benefits program (OPEB). Our board is the first board to actively work toward eliminating the \$24 million OPEB liability we inherited. Our board, with the assistance of our District Finance Committee, has been working on a fiscal strategy to eliminate that liability. In fact, our board is currently working to implement the May 2014 recommendations of the Actuarial Valuation Report regarding our OPEB program. The purpose of the independent valuation report was to assess the district's OPEB liabilities.

Finally, this board has built and maintained a reserve account in the amount of \$10 million.

It is disingenuous when prior board members argue that the Collective Bargaining Agreement "ties the hands of future school boards." The current CBA is for a defined period of merely three years ending June 2017. The three-year contract period is the same time frame that was used by prior boards. In addition, matters are periodically sun-shined throughout the term of the contract.

Our board is actively taking calculated "risks" only after carefully weighing the advantages and disadvantages before implementing financial strategies. By partnering with our employees for the mutual success of our school district we have been able to reduce our liabilities and secure our financial outlook.

Board President Noah Margo and his colleagues on the Board of Education deserve praise and recognition for ratifying the tentative agreements with the certificated and classified employees in the Beverly Hills Unified School District. The agreement, recognized by the Los Angeles County of Education as fiscally sound and responsible, is a testament to the commitment the board has made to the high quality public educators in this community. This commitment is substantiated not only by words, but through provisions in the agreement that link teacher salary increases to secured property tax revenue with the condition that salaries continue to increase until the highest point of the salary schedule is equal to or higher than all other districts in the county. While doing so, the board is also maintaining a healthy reserve fund of that vields interest and provides protection for unexpected expenditures down the line. In short the Board has, through this ratification, made a significant investment in its educators while protecting the bottom line.

As we finish the first month of the 2014-15 school year and prepare for the first day of a new bargaining season, I know both BHEA and the board have areas in our negotiated contracts we want to work on. The difference right now, more so than ever before, is the positive and collaborative atmosphere from which we begin. The conversation will not only be about what each side needs, but more importantly what each side can do to work together to continue providing the children in the community a world class education. With this in mind, we look forward to a climate of honest, friendly, and collaborative communication and partnership as we move ahead.

# BHPD mistakenly detains television producer as bank robbery suspect

The Beverly Hills Police Department misidentified television producer Charles Belk as a suspect to a bank robbery on August 22, after 47-year-old Brianna Boulevard at about 5:20 p.m., he was detained by the BHPD and was told to sit on the curb.

Belk wrote that a few minutes later, six police cars arrived on the scene, hand-cuffed him, and had him sit down on the curb again. He was then taken to the BHPD headquarters within an hour and was photographed, fingerprinted, and had a \$100,000 bail and was accused of armed bank robbery and an accessory of robbery of a Citibank.

"After an eye witness positively identified the subject in a field show-up, police

Clemens Kloutse of Los Angeles was arrested after a bank robbery on the 8400 block of Wilshire Boulevard.

According to a press release from the city, officers believe that Kloutse is responsible for nine recent bank robberies and two attempted bank robberies in Los Angeles, West Hollywood and Beverly Hills. Witnesses believe that Kloutse was working with another individual in the robberies.

The BHPD detained Belk who was less than a block away from the bank robbery.

According to Belk's Facebook page, he was at an Emmy Awards Gifting Suite and was invited to a VIP Emmy pre-party the same night in Beverly Hills. After leaving a restaurant on Wilshire Boulevard to check his parking meter on La Cienega

arrested Belk for suspicion of robbery," the press release stated.

According to attorney Jaaye Person-Lynn's Facebook, the detectives confirmed that Belk was not the suspect at approximately 11:00 p.m. by reviewing the bank's ATM surveillance tapes.

"All they saw was something fitting the description," Belk wrote on his Facebook. "I have always stayed as far away from being on the wrong side of the law as much as possible. We all do not fit the description."

Belk listed a slew of achievements on his status, including receiving a Bachelors of Science in Electrical Engineering from USC, an MBA from Indiana University and an Executive Leadership Certificate from Harvard Business School, and being a consultant for the NAACP, a film and television producer, running community affairs for the Atlanta Hawks, among other positions he has held.

"Surely, folks that fit the description wouldn't qualify as any of those," Belk added.

According the press release, the police department has a thorough process to verify that Belk was not the suspect before releasing him, which includes speaking with any witnesses, communicating with between the FBI and Los Angeles Police detectives who were investigating the earlier bank robberies, and examining the surveillance video from the bank.

"The Beverly Hills Police Department deeply regrets the inconvenience to Belk," the press release stated. "However, based on witness accounts and his location close to the bank, officers properly detained and arrested him based on the totality of the circumstances known at the time of the field investigation."

The second suspect is still at large.

# City Council approves additional Centennial allocations from remaining \$59,145 Centennial funds

The City Council approved allocating \$20,000 from remaining balances in the Centennial budget and using \$26,000 remaining from the Arts of Palm budget on August 19 for tree yard bombing, compensating Judy Kessler for her work on the Centennial cookbook, and purchasing Centennial books and licensing clearances for the Centennial Concert and Sing-Along.

The Arts of Palm Committee proposed using \$26,000 of their unallocated funds to tree bomb at least five trees on Burton Way. Tree bombing is a form of street art where knitters close stitch yarn patterns onto tree trunks.

According to Arts of Palm Committee member Alissa Roston, to continue with their initial art installation work they would need to go out to bid to have more money for the installations. The committee decided to "shift gears" and found that tree bombing would fit within their budget while still providing a lively art form to Beverly Hills.

The Arts of Palm Committee would include setting up and taking down as part of the contract costs and will seek a

tree bombing knitting group with the City Council's approval to continue with the project.

"For years we've always talked about what we could do with Burton Way," Mayor Lili Bosse said. "I think you're now giving us an opportunity to see something very unique."

Recreation and Parks Commissioner Robbie Anderson, with the help of photographer Richard Zale Rubins, created a Centennial book titled, Beverly Hills: The First 100 Years. Anderson suggested that the books be used as gifts for dignitaries, VIPs, and other individuals. The cost of each book would be \$100 with an additional \$20 for a commemorative box. A suggested 25 books will be purchased for \$3,000.

The Centennial Cookbook features recipes from notable Beverly Hills restaurants, and approximately 650 books generated a revenue of \$10,500. The Center of Visitors Bureau helped fund for the cookbooks to get it started. According to Meghan Roach, the CVB will be reimbursed for the costs, and then the remaining funds will be allocated to the city's general fund.

Beverly Hills resident Judy Kessler edited, wrote, and did the graphic design and layout of the cookbook. Centennial Committee Chair Dick Rosenzweig proposed \$20,000 as payment to Kessler for her work.

"There are an awful lot of people who spent an awful lot of time and did some amazing work here who didn't get paid a dime, so why is this different?" Vice Mayor Julian Gold asked.

Roach mentioned that Kessler would be the only volunteer who would be retroactively paid for the work they did regarding Centennial events. Roach said that the payment was merited because of the highly specialized and professional work Kessler spent in writing, editing, and graphic designing the book.

"It's something that will have the test of time and something that is great branding and marketing for our city," Bosse said.

Another \$12,000 would be allocated for licensing clearance for the Centennial Concert Sing-Along to use in media and for any marketing proposals.

The \$20,000 will come out of the \$59,145 remaining funds of an approved \$1.35 million in the Centennial budget.

# Ferrari's 60th anniversary celebration to be held in October



A silver 1954 375 MM coupe is the first Ferrari to win "Best in Show" at the recent 2014 Pebble Beach Concours d'Elegance, and the first postwar car to win in 46 years.



Ferrari's versary celebration will coming Beverly Hills with a private gala October 11 and a free public event exhibiting Ferraris October 12.

"We cannot be more thrilled about bringing this one-of-a-kind world class event to Rodeo Drive and to the City of Beverly Hills," Rodeo Drive Committee President Mark Tronstein said.

The October 11 gala will be exclusive for 500 invite only guests, which includes Ferrari owners and international press. The free public event on October 12 will feature 60 vintage Ferrari vehicles and two never before seen models.

The celebration will require closure of the 400 block of North Crescent Drive adjacent to City Hall from 9:00 p.m. on October 8 until the end of the public event. The 200 and 400 blocks of North Rodeo Drive will close from Saturday afternoon until the end of Sunday. Street closure times include set up and break down of the events, and the streets will reopen by 6:00 a.m. the following Monday.

Local merchants and churches that will be affected by the street closures will be notified of the event and the Rodeo Drive Committee will plan to have reserved street parking available to church goers.

The Santa Monica five parking structure will be open only on Sunday to help with the parking and staging of cars and vehicles for Ferrari owners and Ferrari Club drivers.

By having a city sponsorship of the event, the Rodeo Drive committee will be able to use banners and other materials to promote

The Rodeo Drive Committee will be introducing a new award, the Honored Marque, which will be presented as a permanent plaque each year that will be installed either in the pavement or on the Sidewalk on Wilshire at Rodeo Drive.

Local merchants were concerned that customers would be discouraged from entering their business during the time the streets are

closed. The City Council suggested to have catering and refreshments be provide by the local merchants to help promote the local businesses and to help mitigate any financial impacts during the street closures.

The City Council liaison committee, consisting of Mayor Lili Bosse and Councilmember Nancy Krasne, suggested to have maps available to all Ferrari owners to help increase customers to local mom and pop stores, and also to have signage visible on the streets to let the public know that businesses are still open.

According to Tronstein, the event will bring worldwide attention to Beverly Hills and have a meaningful and lasting economic impact on hotels, businesses, and restaurants. Ferrari has also agreed to cover all the City costs for the street closures.

Councilmember John Mirisch requested to have more concrete plans on the event promotion plans.

"The whole world is going to be [watching] Beverly Hills," Bosse said. "We need to use that fact and really bring people into our business community [and] bring them on to Crescent Drive."


# **Board of Education tables GATE** coordinator position



# Architects add enhancements to master architect building at 8665 Wilshire

The Architectural Commission unanimously approved a façade remodel and sign accommodation for 8665 Wilshire at Willaman Drive, which was designed by

Master Architect Maxwell Starkman, on August 20.

8665 Wilshire was built in the 1960s, and the project architects proposed to update the building with exterior enhancements, such as new materials, tiles, and windows

Though the site has neither been nominated nor designated as a local historic property as of date, City staff and the project's architects worked together to maintain Starkman's design while still adding enhancements to the building.

"The new design respects the existing architecture in a creative way without inhibiting the design and intent of the original building," Associate Planner Sheena Rojemann said. "It will serve as a positive enhancement to the streetscape of Wilshire and the surrounding neighborhood."

The architects proposed adding three windows on a vertical wall element for corner offices that currently doesn't have windows.

Urban Designer Bill Crouch recommended that either the windows match the same size and shape of the surrounding windows or to minimize the window size, instead of having elongated windows.

"The windows don't necessary need to follow the wall," Crouch said. "Because that was always a solid wall, the massiveness of that vertical wall is an important character defining feature."

Crouch said that according to the Secretary Interior of Standards, new designs should respect the original architecture to maintain the historical integrity of the building.

"The idea of the Secretary of Interior Standards is to not necessarily freeze the building in time, but in this case to respect Starkman's design and keep the big picture," Crouch said. "Working with the times is very subjective. You're also allowed to interpret the standards."

Conditions were added to reduce the width of the windows and to remove the mullions to have narrower windows, and to have a solid piece of glass to keep in line with the massing of the vertical elements of the wall.

The project architect Soogun Park said that adding the windows would increase value to the office building, and adding narrow windows would go against the original design.

"We tried to keep the original design as much as possible, and come up with a clean, durable and bright materials to [have the building] last longer," Park said.



Brian Goldberg said. "There's something flawed in our process when we get one candidate for this position this important and this critical."

Goldberg said that he would have preferred a more extensive applicant pool that included external applicants.

Currently, Chief Academic Officer Jennifer Tedford has been running the GATE coordinator duties until the position is filled.

Board of Education member Lisa Korbatov said that the GATE coordinator position is better suited as a full-time position, and she did not want to "break up a cohesive first grade." Korbatov suggested to have a K-8 librarian who could help run the GATE program while at the same time run the libraries.

According to Chief Administrative Officer Dawnalyn Murakawa-Leopard, another search for potential applicants could take weeks if the job posting were for a limited amount of days and if interviews were set up immediately. However, in reviewing external candidates' applications, the process to check references, set up interviews, and perform background checks could amount up to months before finding a suitable candidate.

"The longer we delay in getting support for

the program the more challenging it becomes to really build the kind of program that we proposed to you," Tedford said.

# Board of Education request for spending plan on \$20,000 donation; tables item

The Board of Education tabled an item that would allow a donation of \$20,000 to be spent on instructional materials and supplies under the discretion of Beverly High Principal Carter Paysinger on Tuesday.

A total of \$25,275 was donated to Beverly High; \$75.00 from Doris B. Sebulsky and \$200 from Diane and Judith Weinstein went towards the Sebulsky Scholarship; and Shirley Wong donated \$5,000 to the Best Buddies Club, a special education program and \$20,000 which was allocated to a "BHHS 00635.0" account.

According to Executive Director of Budget Mary Anne McCabe, the donation account that the \$20,000 is allocated towards is used to track this specific donation amount.

"If anybody wants the report we can generate one based on how it was expended," McCabe said.

Board of Education member Brian Goldberg raised questions on if the princi-

pal should be able to handle that amount of money and what kind materials and supplies would the principal be able to purchase According to Chief Administrative Officer

According to Chief Administrative Officer Dawnalyn Murakawa-Leopard, based on donor constraints the principal does have discretion on how the funds are spent. However, based on the BHUSD's process, the principal would make a request through the business office to make sure that the purchase is "in compliance with the appropriate expenditures." A purchase order will be made, and Murakawa-Leopard will sign off on the order.

"All of that would be reviewed prior to the actual order being placed and materials being procured," Murakawa-Leopard said.

The Board of Education would then see the approved purchase order on the consent calendar.

"We can ask for a spending plan so that we know exactly where [the funds] are going," Superintendent Gary Woods said.

ALS, amyotrophic lateral sclerosis, or known more commonly as Lou Gehrig's disease, is a disease that degenerates nerve cells, specifically motor neurons, in the brain and spinal cord. Motor neurons are vital in muscle movement, and as they are depleted the brain eventually is unable to control muscle movement. Some patients may encounter paralysis in the later stages, and eventually face death.

Approximately 30,000 Americans suffer from ALS and affects people between the ages of 40 and 70. There is no cure or treatment for the disease.

The ALS ice bucket challenge raises money and awareness for the disease, and nominees have the option to donate to the ALS Association at http://www.alsa.org, or to douse themselves with a bucket of ice water.

# SB 1200 allows advanced computer science in lieu of math for undergraduate admissions

The California State Senate unanimously approved bill SB 1200 by State Senator Alex Padilla (D-Pacoima) on August 20, which would allow high school advanced computer science classes to satisfy the advanced math requirement for undergraduate admissions to a University of California (UC) or California State University (CSU).

"More high school students will take advanced computer science courses if they know that the classes help meet requirements for undergraduate admission," Padilla said in the press release. "We can't expect California to remain the world's leader in computer technology if we don't value computer science in public education."

According to the press release, only one out of 1,304 high schools in California offers a computer science course that has been approved as meeting a math requirement for admission to the UC and CSU.

At Beverly High, AP Computer Science is currently offered as an elective course.

"For now, it's an elective credit course unless the state and college board make a decision to change something," Chief Academic Officer Jennifer Tedford said.

Beverly High students follow "A-G" requirements for undergraduate admissions, which are minimum common high school core courses set by the UC and CSU that includes history and social science, English, mathematics, laboratory science, foreign language, visual and performing arts, and electives

Tedford said that school districts don't have control over what credit each course is approved for. Schools would submit a

# David and Deborah Alessi discuss their organization's upcoming Venetian Masquerade

Beverly Hills residents David and Deborah Alessi are the founders of Face Forward. Purchase tickets at http://faceforward.ticketleap.com for the Venetian Masquerade on September 13. It will be located at the Millennium Biltmore Hotel in downtown Los Angeles and start at 6:30 p.m.

### Tell us about Face Forward.

**Deborah:** Face Forward rebuilds the faces for mostly women and children who have been victims of domestic violence. We're open to men too but we've never actually had a male patient. Our patients are local and worldwide.

David: Not only do we rebuild their faces but we also rebuild their lives too. One of the reasons why Face Forward was started was because I was doing some reconstructive work for some patients at Cedars [Sinai Hospital] and they would just go out back into society. They wouldn't really be cured or have their emotional scars healed. Face Forward is not only a tool to rebuilt their faces, but also to get them involved with vocational rehab and psychological rehab and so these patients can move forward and heal.

What's wonderful about Face Forward is that instead of just rebuilding their faces and giving them a [helping] hand up, all these women we've worked with so far have gone to do something great with their lives. They are spokespeople for domestic violence, they have their own company, or have gone back to school.

**Deborah**: I think a lot of people don't understand the need for what we do. Nobody wants to talk about [domestic violence]. When you're in a room in Beverly Hills, one in four woman [in that room] have been affected by domestic violence. It may not be as severe as the cases we deal with. We've dealt with women who have been set on fire or are acid victims.

I was at the gym [on Tuesday] and I could tell there was a woman [who's] eye socket was punched in. She was very frail and very timid and I said to my trainer, "Her boyfriend did that to her." I tried to start a conversation with her and I could tell that she was uncomfortable. I knew it was domestic violence.

It's so common. It happens with celebrities who probably don't want to talk about it, and it makes it harder for us [to

talk about it]. Everything is hidden. These women, they may not be disfigured, but they could be living in Beverly Hills or Santa Monica and living behind a closed door. The person you love and have children with tells you every day that you're worthless, and he beats you if you don't do something that he thinks you should be doing. The next level is what happens to our patients.

How do you go forward in life? If you have a bad hair day and your makeup doesn't feel right, then you don't feel

good. How do these women go forward every single day and become achievers in life when their faces are disfigured or they have one eye? It's very severe.

The more we talk about it, the more women will come forward and ask for help. That's actually what the message is, and that's why it's important to have celebrities involved because when they speak people listen.

# What were your reasons for starting Face Forward Deborah?

**Deborah**: My first boyfriend was abu-

sive when I was 17 in Scotland. I feel like I was very lucky to get out of a bad situation. I never really talked much about it because I felt ashamed and I think a lot of women feel that way. I always wondered why I put myself in that situation and I blamed myself like most of the women do. When I met my husband, [David,] we both had a feeling to make a difference and it came together. We decided we should start something.

# You mentioned you help patients locally and worldwide. How do you reach out to these patients and find them?

**Deborah**: Individuals who are involved in the community, such as workers in domestic violence shelters or spokeswomen for domestic violence, connect with us.

We have a woman coming in October from Africa and she found us. I don't know how she found us, but she found us.

**David**: Most women who are victims of domestic violence are survivors of it. Their abusers will do anything they can to get back at them so they want to hit them as much as possible. But through public relations, people will hear about it.

There was one time we had a brief interview on Entertainment Tonight for one minute. We were talking about the Chris Brown and Rihanna beating and the domestic violence related to that. Probably within an hour, we had 100 phone calls and e-mails from around the country from women hiding in these little dark corners who are trying to get help. People will hear about it and press is one of the ways we do that.

You mentioned that reconstructive surgery as well as psychological and emotional recovery is part of the program as well. How do you provide these services to the individuals who reach out to you?

Deborah: David provides all the sur-

gery pro bono and we raise the money. Each patient cost between \$5,000 to \$12,000 per visit because we raise the money for after care, the anesthesiologist, airfare, and we try to take care of them full time while they're here. They don't come with their families so they're on their own.

We'll provide the therapy. We have a few different partners we work with and it depends on each case. Some are local, some can Skype with the patients. The woman who is coming from Africa will be in

therapy during the time she is here and in between her treatment.

# Tell us about your careers.

**Deborah:** I'm from Scotland. I went to Glasgow University. After that I traveled the world to the Middle East and I worked with the royal family [of Bahrain] and managed their fleet of aircraft and then from that I did a similar job here in the United States and then I met my husband.

**David:** I'm from Washington D.C. I went to medical school and did my residency at UCLA and I trained in both head and neck surgery as well as facial reconstructive surgery. I have practiced in Beverly Hills since 1989.

# How did you find yourselves in California?

Deborah: I like warm weather.

**David**: It's so funny. Here you have a girl from Scotland and if she's around any kind of cold weather she's so unhappy with it and I have no idea how she even grew up in Scotland.

**Deborah**: It does not appeal to me anymore.

David: When I was a resident in medical school I was figuring out what I wanted to do. I went to medial school in Detroit, and I was accepted into the University of Virginia's neurosurgery program and at the same time I got accepted into UCLA's head and neck and facial reconstruction program. I thought to myself I like both of them quite a bit but I think I'd like to see palm trees instead of insidious trees, and so that's what brought me out here.

# What are other events that Face Forward puts on throughout the year?

**Deborah:** We usually do local events, but the big event once a year is our annual gala coming up on September 13, which takes six months to put together.

## Tell us more about the gala.

**Deborah**: The theme of the evening is, "Venetian Masquerade." We have many, many surprises from the moment you arrive to the moment you leave. During the whole event you'll feel like you're in Venice. The most exciting part of the evening is that Estelle is performing and I'm super excited to see her myself.

We will have an amazing live auction. We have over \$250,000 in auction items donated that myself and other board members have brought in. We've found local sponsors and we have alcohol. We're trying to have as much as we can donated so that all the money we raise go towards our cause.

We have a fundraising goal of \$500,000. Last year we were able to raise \$300,000, and every year we've gone up. I'd like to aim high and achieve high, so I'll set my goals high for this year. If there's anyone who would like to buy a ticket for a table let me know.

**David**: Being run by a Scot, this is the most fun party you'll ever go to. Last year our main performer was Macy Gray and we had to hire a second band because people were drinking and dancing until two in the morning. It's just the most fun gala you can ever go to.

**Deborah**: Every year I don't want the topic to be dark at the gala. I want to celebrate life, and that's why we have the theme, "Venetian Masquerade." You're hiding behind a mask and you come out because we want to celebrate life after domestic violence.

Since launching her blog, Kahen has been recruited for photo shoots for designer clothing labels and fashion brands to post on her blog.


"I'm pretty new, but I'm hoping to continue to have that partnership," Kahen said. "Eventually I want to be a designer and sell my own clothing."

Kahen has a motto of, "Because fashion is forever and style comes from within us all"


"We all have our unique styles and it's really what you make of it yourself," Kahen said. "It's something that comes within you."







# **BHPD** enforces distractive traffic violations

The Beverly Hills Police Department conducted a 90 minute operation targeting drivers talking on their cell phone on August 20, and cited 17 drivers in the 400 Block of North Rexford Drive.

"I think that's indicative of a bigger problem," Motor Sergeant Scott Dowling said. "Distractive traffic violations are a primary, causal factor for crashes

Dowling said that there have been crashes that involved vehicles hitting parked cars in a wide, open street, or hitting trees and curbs while the driver was distracted with other tasks.

Distractive traffic violations include any general action that takes away from the task at hand, which includes talking on a cellphone; texting; eating; and putting on makeup. "It could be a number of things that could distract you from focusing on driving 100 percent of the time," Dowling said.

The BHPD will increase enforcement on distractive traffic violations at different locations throughout the city to reduce the number of accidents caused by distracted driving.
