**Louisiana gay marriage ban upheld**

Reagan-appointed Judge Martin Feldman describes the rights of gays to marry as “society’s latest short fuse.” This extraordinarily narrow view of human rights – gay, straight, whatever – ignores that his “short fuse” is some real couple’s personal relationship (and perhaps that of their children). This judge echoes the Republican mantra that a majority of voters have the right to determine that certain humans have fewer basic rights than others. Fundamental human rights are not subject to, in the words of John Adams and Alexis de Tocqueville, “the tyranny of the majority.” Otherwise, minority school children would still be in second-class segregated schools and blacks would still have to spell “chrysanthemum” in order to register to vote. What is unclear to Judge Feldman about the simple phrase in the 14th Amendment that, “No state shall...deny to any person...the equal protection of the laws”?



## Cole pleads guilty in Mamtek case; faces up to seven years in prison

Former Mamtek CEO Bruce Cole pled guilty on Sept. 2 in the St. Charles County Circuit Court in Missouri to two counts of securities fraud and one count of theft in the case relating to the failed sucralose operations, Mamtek.

Cole will be sentenced from five to seven years in the Missouri Department of Corrections, according to a Missouri Attorney General press release. Prior to pleading guilty, Cole was facing up to 55 years in prison.

Attorney General Chris Koster did not return phone calls from the *Weekly* before press time.

“Bruce Cole knowingly deceived the City of Moberly and investors about the Mamtek project and kept bond money for his own personal use,” Attorney General Chris Koster said in the press release. “He will be held accountable for his actions.”

Cole was arrested on Sept. 18, 2012 in Dana Point in connection to a failed artificial sweetener business deal between Mamtek and the City of Moberly, Missouri involving a \$39 million bond. An additional \$8 million in funding came from private investors, and another \$500,000 in grants and services from Moberly. The *Weekly* covered the charges in issue #677’s cover story.

Further investigations by the Attorney General’s Office and Randolph County Prosecuting Attorney Mike Fusselman showed that Cole used more than \$700,000 in Mamtek funds for his own use, including \$281,046 to stop the foreclosure of his Beverly Hills home. Investigators determined that Cole made false promises of bringing over 600 jobs to the city of 14,000 residents.

Cole returned to his Southern California home and will remain on electronic monitoring until his sentence hearing scheduled for Nov. 3, according to the *Columbia Daily Tribune*.

Cole’s attorney Raymond Legg’s request to release Cole’s electronic monitoring was turned down by St. Charles County Circuit Court Judge Daniel Pelikan.

Legg did not return phone calls to the *Weekly* before press time.

The Board of Education approved a purchase order that authorizes over \$1.6 million in legal fees at Tuesday’s meeting with a 4 – 1 vote.

Board of Education member Lewis Hall dissented on two of the items in the purchase order. One is for the amount of \$250,000 for technology consulting services from the City of Beverly Hills and the other is for the amount for \$500,516.50 for Evidence Based, Inc. for second semester fees. Hall said that the technology consulting services were previously discussed as an open item for discussion at previous meetings, and EBI is a security issue that should be discussed.

“I feel more comfortable that they were being addressed before going ahead with this purchase order,” Hall said.

Purchase orders authorize purchase transactions for supplies, equipment, and services, including legal fees, for the BHUSD from the General Fund, the Measure E Bond, and Cafeteria Fund.

Total amounts approved were \$972,093.70 from the General Fund, \$3,504,318.56 from the Measure E Bond, and \$164,104.13 from the Cafeteria Fund. Legal fees allocated from the Measure E Bond and General Fund totaled \$1,675,000.

The purchase order would allow the BHUSD to continue to pay for the services that are being used, according to Chief Administrative Officer Dawnalyn Murakawa-Leopard. The total amount approved for purchase orders gives the authority for the BHUSD to spend that amount, but not necessarily “obligate” the BHUSD to expend the whole amount, according to Murakawa-Leopard.

## Mandatory water conservation plans includes 10 percent water use reduction

The City Council unanimously approved a mandatory water conservation plan, which includes a 10 percent water use reduction, at a formal meeting on Sept. 2.

Citywide, water consumers are required to reduce water usage by 10 percent compared to last year’s water usage. Any water usage above 90 percent will be charge two times the basic rate.

“I don’t think everybody really knows what ten percent necessarily means,” Mayor Lili Bosse said. “We need to give people a warning with ample time to try and shift [water usage]. We want to try and make this process so simplified so that everybody can really understand how their water is being tracked.”

The City Council suggested a notification process or alert system for water consumers to be alerted of when their water use is close to reaching the 90 percent limit.

Vice Mayor Julian Gold suggested having a more fair water use comparison, instead of only using a single, billing cycle period from the previous year. Gold mentioned examples of “the comings and goings of kids and the determination of the number of inhabitants of a house at any point in time” that may increase or decrease water usage in a particular month.

“It might be fairer if we actually average usage over some period of time,” Gold said.

Currently, a water tracker system is available at <http://www.beverlyhills.org/app/water/>. Water consumers will need their account number and the last name that appears on their billing statement to log into the system to find information on their water usage.

City agencies are encouraged to reduced water use by 20 percent by the end of the year to “lead by example,” according to Utilities Manager Patricia Rhay.

## Board of Education to resume discussions with City on closing oil operations

Though the Board of Education approved a Cash Collection report at Tuesday’s meeting that include a check of \$55,901.23 from Venoco, Inc., members brought up a discussion on the status of how the City of Beverly Hills will supplement the loss in income from oil drilling.

The oil drilling operations at Beverly High along Olympic Blvd. will end when the current three party lease between Venoco, the City and the BHUSD expires on Dec. 31, 2016. The City Council voted in 2011 to cease oil drilling in the City of Beverly Hills no later than the end of the lease.

The BHUSD receives approximately \$1 million a year in royalties from Venoco.

Board of Education President Noah Margo said that previously, former Board of Education member Jake Manaster and Margo were part of an ad hoc committee that discussed how the city was going to supplement the loss in income, as well as details to what will happen to the site after oil drilling ceases. Margo said that proposed plans would be to have an open field for at least two years.

Margo said that he will send an e-mail to Mayor Lili Bosse on the matter.

approximately 10 million gallons a day, where 6.5 to seven million gallons goes towards landscaping, according to Rhay.

“Next year if the drought continues, it will become tougher,” Rhay said. “Be that we use Metropolitan [Water District] water or city water, the state will still look at us to cut 20 percent regardless of where the source is.”

Tier one water consumers, who use about 130 gallons of water a day, will be exempt from the 10 percent reduction restrictions and penalties.

“If they’re in tier one, to cut 10 percent is exceedingly difficult in that tier,” Councilmember Willie Brien said.

These customers consist of approximately 17 percent of accounts, which are about

1,700 to 1,800 accounts, according to Senior Management Analyst Daniel Cartagena.

The plan will take into effect either when the water systems are in place to bill correctly, or on Oct. 3, whichever date is the latest. Prior to starting the plan, the Public Works Department plan to educate and notify residents of the mandatory water conservation changes prior to implementing the fines.

The mandatory water conservation plan includes restaurants serving water upon request, water conservation signage in restrooms, and repairing water leaks within seven days of notification.

Previous water conservation implementations include limiting watering down drive-

ways and sidewalks and washing vehicles with no shutoff nozzle. Properties north of Santa Monica Blvd. will water their landscape on Mon., Wed., and Fri. Properties south of Santa Monica Blvd. will water their landscape on Tue., Thur., and Sat. Watering on Sunday will be prohibited.

Violators will incur a \$100 penalty fee per infraction. Mandatory watering days could be implemented if conservation goals are not met.

Other points the City Council suggested the Public Works Department to look into were how to enforce the conservation plan for landlords, who were concerned that they are not in control over tenant water usage, and how to work with approximately 8,000 West Hollywood residences that consume Beverly Hills' water.

According to Rhay, the billing system will not be an issue for West Hollywood customers, but enforcing overwatering miti-

gation and fines will be more difficult.

The conservation plan will go into effect on Oct. 3 or when the City's utility billing system has been modified to accommodate the billing changes, whichever is later



BHUSD kindergartens have some of the highest rates of personal beliefs vaccination exemptions when compared to other southern Californian kindergarten according to a chart published in the LA Times on Sept. 2.

Cedars-Sinai Medical Center Clinical Director of Pediatric Infectious Disease Deb Lehman that because vaccinations prevented dangerous outbreaks and mortality due to infectious diseases such as measles, influenza, chicken pox, and meningitis, parents may have never seen anyone who has died from these diseases. Lehman mentioned that though she saw common cases of bacterial meningitis at the beginning of her career, some pediatricians today might not see cases of certain types of influenza and meningitis due to vaccination development.

"There's a sense of complacency that these vaccines are no longer necessary," Lehman said.

Beverly Vista, El Rodeo, Hawthorne, and Horace Man all have exemption rates surpassing eight percent, of kindergarteners who have been exempted from at least one vaccination due to personal beliefs, according to the LA Times chart.

Depending on the level of vaccinations that schools require, parents can choose to opt out of any vaccination without a specific reason, as long as they submit a form signed in their physician's office acknowledging that they have been informed on the risks and benefits of vaccinations.

The decreasing number of people overall who opt out of vaccinations leads to a loss of herd immunity in schools and communities, which is leading to some outbreaks such as whooping cough and measles, according to Lehman. Herd immunity is when an individual who is not vaccinated is protected because a certain percentage of the population is vaccinated in a particular disease.

"Vaccines are important and are a definite issue that we're seeing because of misinformation," Health and Safety commissioner Gail Millan said.

According to Lehman, infants become vulnerable to whooping cough since they don't receive vaccines until they are six or eight weeks old.

"They're being infected by people in the community who have whooping cough," Lehman said. "The cases of measles in the U.S., and in CA specifically, are almost exclusive to people who have declined vaccination. We certainly see the occasional case of meningitis in parts of the country where people have declined vaccination as well."

Lehman mentioned that specific diseases are not included in herd immunity, such as tetanus, where a non-vaccinated person will become infected regardless of the amount of vaccinated individuals in the community.

Lehman said that though there is a rise in disease cases, people are still not likely to receive vaccinations. A study that was published in pediatrics looked at a well-publicized outbreak of whooping cough in Washington State. The study looked at the cases of vaccinated individuals before and after the epidemic, and saw that there was no change in vaccination behaviors.

"We as pediatricians and as other health care providers need to continue to talk about the benefits of vaccines and remind people of the risk to children in the pre-vaccine era," Lehman said. "The majority of children do get vaccinated, and that's really important. But there are areas where the tipping point has been hit."

## Nestdrop liquor delivery app services Beverly Hills

Liquor delivery service app Nestdrop is now available to Beverly Hills residents.

"We're growing very quickly," Nestdrop co-founder Roddy Radnia said. "When we started we were just in little pockets of LA two months ago. Now, we're about to expand to Orange County."

Radnia, a 2007 Beverly High graduate, and co-founder Michael Pycher came upon the idea of Nestdrop when they noticed that though bigger companies were reaching out to the "on demand market" for goods such as groceries, there was a lack of presence for on demand services for serving goods, such as liquor.

"There are a lot of small businesses owners who are starting to become obsolete because people are now able to go to Ralphs and buy [alcohol] for much cheaper," Radnia said. "Now we're able to give these small business owners, like small liquor stores, a way to stay competitive in a time when their business is less in demand."

After two months of operation, Nestdrop has delivered tens of thousands of dollars worth of products within the Los Angeles region. Delivery services have expanded to Manhattan Beach and Studio City, with plans to reach out to Orange County and Long Beach within the next month. Radnia said they want to eventually expand nationwide.

"Our model is very cost-efficient and that's why you see our competitor's prices astronomically higher than ours," Radnia said. "There are other delivery companies that do what we do, but we're easily one of the most affordable alcohol deliver apps out on the market right now."

Nestdrop can be downloaded for free through the iPhone App Store or Google Play. The user's location will be indicated on the app, or a user can also input what address they want delivered to.

The app then searches for the nearest liquor stores partnered with

Nestdrop. Besides liquor, beer, and wine, other items available for purchase may include cigarettes, chips, and ice depending on the liquor store's inventory.

Once the user purchases the items in their cart, the items will be delivered to their address in under an hour.

Beverly Hills residents can receive a \$10 discount on any Nestdrop order through Sept. 15 by using the promotional code, "Bhills."

Aside from the convenience of having liquor delivered, Nestdrop allows a safer and more convenient drinking option.

"If we can spare customers getting on the road and offer a product that keeps them safer by not drinking and driving, then we feel it is worth doing," Pycher said.

### Planning Commission to look into ordinance for Hillside area

The City Council unanimously approved not extending an emergency ordinance that would prohibit the expansion of level lot areas in the Hillside area at the Sept. 2 formal meeting, to allow more time for the Planning Commission to develop a more comprehensive ordinance for the Hillside area.


"We should let the Planning Commission review each of these cases as they come forward," Councilmember Nancy Krasne said. "The hillside, wherever you are, is so unique. Everybody has a different, specific problem that's specific to their lot, their terrain and how it lays out."

The current emergency ordinance that prohibited Hillside level lot expansions, with the exception of current applications, will expire tomorrow. Due to a number of construction projects that would change the nature and character of the Hillside and how construction activities may impact safety, the Planning Commission sought to have more purviews over lot expansions and terraced lots.

According to Community Development Director Susan Heely Keene the 45 day emergency notice did not provide sufficient time to inform impacted residents to receive community input.

Keene recommended to not extend the emergency ordinance, and to instead allow proper time to notice residence and any impacted stakeholders to provide direction to the ordinance, and have the Planning Commission have a more thorough discussion.

The ordinance would include Hillside level pad expansions and other development aspects, such as an establishment of more appropriate grading and retaining wall thresholds, limiting the use of retaining walls for terracing, and an analysis and possible modifica-




1201 Laurel Way retaining wall system in the Hillside area

tion in how wall height is measured.

"I think we have to go the extra yard to ensure that the potentially impacted residents [and] developers understand that the planning commission is undertaking this exercise," Vice Mayor Julian Gold said. "This is the opportunity for them to come forward and be very clear in what they think we should and should not do."

The Planning Commission will discuss the subject at their Sept. 29 meeting, which will provide enough time for the planning department to provide sufficient notice to the affected community members and receive any input. The departments will be able to return to the City Council at a meeting in October with a more complete ordinance.

"I really want [the Planning Commission] to take their time," Mayor Lili Bosse said. "I want the community to feel that they've had the opportunity to have been heard."

## Who is the Best Candidate for Assessor?

### Jeffrey Prang

Finally, as you can see, I played a large part in fixing the problems and putting forth a responsible, accurate and fair Assessor's Office.

Now, what will I do when elected as the next LA County Assessor?

The first is restoring public trust in this agency. We made tremendous progress in the last years, but I recognize that until Mr. Noguez is officially gone we will continue to have that cloud over the office. Moreover, it may take several years for people to once again have the confidence in this agency that they deserve.

The most important operational needs of the office are the replacement of our antiquated computer system. Some elements of our system is a 1970s era, mainframe, green screen, DOS based system that requires COBOL programmers. I know this may sound too technical for your readers but bear with me. This is important to make this office more efficient, accurate and fair.

The Assessor is responsible for appraising 2.6 million parcels of property every year and each of those parcels is associated with a paper file. When calling the assessor for service, employees may need to access as many as six different screens to get property information. They may need to refer you to a district office. And that district office employee may need to go to a cavernous file room to get a copy of your paper file.

Clearly this is inefficient. A new computer system will increase customer service, employee efficiency, increase security controls, and provide better, more accurate data about properties in the County. Over time, we can shift resources to more appraisal functions. What this means is that taxpayers will have more fair and accurate assessments, and we will have more appraisers to ensure that every dollar of assessable property is taxed fairly, this means more accurate revenues for public safety, schools, hospitals and roads.

Also, I propose increasing the minimum reporting value or visit business personal property and equipment. Currently, if you are a small business, you must report your equipment and furniture annually as property tax. Any furniture and equipment valued at more than \$2,000 is reportable. I want to increase that minimum to \$10,000. The reason being is that we value furniture and equipment the same as real property, one percent. A \$2,000 copy machine generates only \$20 in tax revenue; thus it costs more money to process that equipment that we generate in revenue. The Board of Supervisors has the authority to raise the minimum standard from \$2,000 to 10,000. I will advocate that.

Those are just a few of things I will do as soon as I'm elected as the next LA County Assessor.

As a veteran public manager, I oversaw large budgets, and managed complex government programs. I have served as Mayor and Councilmember of one of California's most fiscally sound cities and am recognized throughout California as an effective leader with unquestioned integrity. Also, I am a former Realtor and a graduate of the LA County Real Estate Appraiser Training Program.

As Assessor, I will ensure that all taxpayers are treated fairly and will protect homeowners and small businesses by fully enforcing Proposition 13.

We deserve a proven reformer, experienced administrator and leader with a plan to guarantee fairness, accuracy, and outstanding customer service to the Assessor's office.

## REMEMBERING MARCH SCHWARTZ

1917 – 2014



March and Linda Schwartz

*Beverly Hills Courier* founder March Schwartz passed away Sept. 7 at age 97.

Schwartz was born on April 9, 1917 in Philadelphia. He attended the University of Pennsylvania and continued studying at St. John's University and Chenglu University after arriving in China as a stowaway on a boat.

He later left his studies to join the U.S. Army during World War II and rose through the ranks to Captain. While Schwartz was an aide to General Joseph "Vinegar Joe" Stillwell in China, he eventually became a public relations officer in Washington, D.C. for Eleanor Roosevelt.

After completing his studies at Southwestern University Law School, he entered into a career with the *Los Angeles Mirror* where he eventually became the editor. After the *Mirror* merged with the *LA Times*, Schwartz became the ad sales manager for the *New York Times'* West Coast edition.

Schwartz then established the *Beverly Hills Courier*, with the purpose of covering issues fairly and accurately that affected Beverly Hills' residents and taxpayers, and giving specific attention to tax rates, schools and public services. The *Courier's* first issue was published on July 22, 1965.


In 1978, Schwartz became a member of the White House Press Corps and covered President Jimmy Carter, Ronald Reagan, George H. W. Bush, and Bill Clinton on domestic and foreign trips.

Schwartz has been honored by several organizations, such as the Beverly Hills Education Foundation for the "Man of the Year" award and the Chamber of Commerce for the "Citizen of the Year" award.

Schwartz eventually sold the paper in 2004 after suffering a severe stroke in the early 2000s.

He is survived by seven children, ten grandchildren, a great grandson, and his wife since 1996, Linda Schwartz.

Funeral services will be held on Sunday, Sept. 14 at 2:00 p.m. at Hillside Memorial Park located at 6001 West Centinela Ave.



**STANLEY BLACK**

March was a good person. He always said, "Hello," I always talked with him, [and] he was very cordial. He was friendly and he was the number one citizen of Beverly Hills.



**LINDA BRISKMAN**  
**FORMER MAYOR**

Even though we moved to Beverly Hills in 1979, strangely enough I didn't meet March until 1988. By then, I was the Vice President of Publicity for the BHEF and was charged with getting more coverage from the *Courier*. Naively, I called and called but March never called back.

Then, while on a cruise in South America, our traveling companions met him on a day trip and couldn't wait to introduce us. I said, "This is a heck of a long way to come to answer my phone calls, but I'll take it." March held that against me for another 10+ years and when I ran for office he made me suffer to win him over, but eventually I did and we became good friends and found out we had some very unusual things in common. March was born in Harbin, China... so was Gary's dad. March worked for the *Los Angeles Mirror*... so did my dad. Eerie coincidences.

He told me many times how proud he was of my record in office and how much he liked that I couldn't be influenced. We didn't always agree, but we definitely had a mutual respect. After his stroke, his devoted wife Linda would always find me at events to say hello to him. I got so much pleasure of the thumbs up and big smile I got from him every time we met.

March was tough, but in a way that most people respected. He didn't pull punches. He used the power of his pen most of the time fairly, and rarely publicly embarrassed anyone who couldn't defend themselves. He was larger than life. I will miss him very much.



**LES BRONTE**  
**FORMER MAYOR**

When I was the Mayor of the City of Beverly Hills, I always enjoyed my father and son discussions with March, but oftentimes we had difficulty defining who was who. And I will always miss him.



**JUDIE FENTON**  
**FTA EVENTS**

When I first moved to Beverly Hills, I was really afraid of March Schwartz. If I had to go the *Courier* to drop off something, I shivered because I didn't even want to see him. I just heard he was a big bad wolf. After I met him and started working with him, I realized that his bark was much louder than his bite because he really was a nice guy.

[It took] about five years [to finally meet him,] partially because I wasn't involved very much in the politics in the community. When I started getting involved, I met him. In his day, he was very tough and he ran a tight newspaper.

My fondest memory of March was [at] Finney's on the Alley, and I think the whole community could relate to that. He opened up this little restaurant in the back of his [building], and everybody came and ate in the alley every Saturday. If you were running for office, it was the best place to collect votes. More political action was taken at Finney's on the Alley. When he sold the paper [and] they took away Finney's, it was really a big loss for all of us.

We went there every Saturday and he wanted me to come to help him make matzah brei during the Jewish holidays. That's where we really bonded, over the matzah brei. That humanized him. That made him not the publisher and the editor anymore [and] made him a community person. His son Sande, a lovely man, had come in and to make his famous matzah brei and he loved it.

That's my fondest memory of March: being so afraid of him and then realizing his bark wasn't so loud. He just became a friend. [He] opened Finney's and then everybody got to know March on a whole different level, which was really nice. But on Monday morning he would go back to being the editor and publisher.



**DICK ROSENZWEIG**  
**CENTENNIAL COMMITTEE CHAIR**

I moved from Chicago to Beverly Hills in 1977. I was reading the paper on a regular basis at that point. I became involved with various elements of Beverly Hills, like [becoming] part of the Chamber of Commerce where I became the President, and the Conference and Visitor's Bureau [where I became] the Chairman. [When] I became interested in the city, that's when I would have met March. He was very actively involved on the Board of the Chamber of Commerce as well.

I would see him at the events in the city which both of us attended on a regular basis. He definitely had an ear for what was happening with the city and what interests or problems the residents were having, whom he represented quite well.

As we all look forward to receiving both papers on Thursdays and Fridays, and a little earlier online now, it was definitely the paper of record from those early days. He and his staff did have access to not only what was happening in City Hall, but again, he had his ear to the community. People confided in him and he represented them well most of the time. Through his weekly editorials, he let his voice be heard whether you agreed with him or not, and generally I did agree with him.

He really became a dominant factor in the development of the city during the years that he owned that paper. It was widely read. Some free circulation papers don't always get read carefully, but in this city, the papers for the most part do get read on a regular basis and help [the residents and visitors of Beverly Hills] form opinions on issues that primarily deal with Beverly Hills, but sometimes go beyond that.


He normally presented both sides of the issues, although there was no question on where he was on these issues. He made it clear. But he was a fair editor. I think that's why people liked him, because he always had a jovial streak and good sense of humor, although he was quite serious about his work.

I had forgotten that he [named a Finney's on the Alley item after me.] Certainly he couldn't have done [Finney's] as a for-profit venture, but that was a place to meet and greet other residents and talk about various things. I always looked forward to going there. I would always see people I knew, or people that I didn't know [who] I probably wanted to know better. It was great fun.

He did that probably because as the years went by we developed a closer relationship. We had fun taking with each other and sharing views, whatever they were, whether we might agree or disagree. He was pretty much an objective observer of the scene.

It never ceased to amaze me what his background was when he was much younger in the army and the kind of people that he served, everyone from General Stillwell to Eleanor Roosevelt. His experience as a stowaway on [a boat] to find his way to China was spectacular. Little did he know what was going to happen in China in later years as it became one of the dominant societies in the world and how important China has become to Beverly Hills.

He never missed an event, even in his later years in his fragile condition, although he didn't look fragile. He always had a smile on his face through all these events, and of course Linda took very good care of him. When he went off the scene, he was sorely missed by a lot of people in the city. Even though they could communicate with him, he had a hard time communicating with them because of his malady. But he was a good fellow and I would say he would fall into one of the major movers and shakers in the history of this city.



**ROBERT K. TANENBAUM**  
**FORMER MAYOR**

I met [March] when I first ran [for Council] in January of 1986 and we remained close friends through all these years. March was a pioneer in many respects. He was fearless and he was an intellectual. He understood what people were concerned about and he saw the very large picture of how policy ought to be, instituted it, and made it acceptable to the people.

March [traveled often] and he went to the Soviet Union on many occasions. He came back and he gave a talk about it when I was president at the Rotary Club, in about 1988 or 1989 before the [Soviet Union] collapsed. He mentioned

that the Soviet Union was crumbling. [At the time,] people had not written about it in large measure. People somewhat skeptical of March's observations said, "Well, why don't you tell this to the State Department?" March [said] that the State Department didn't know about this. He gave a series of observations that the Soviet Union was going bankrupt, from the lack of clothing in stores, the lack of inventory selection and grocery stores, all the kinds of observations that reflected a Paddy Chayefsky ear.

Paddy Chayefsky is one of the great American authors, playwrights, and movie makers. All of his movies [and] all of his writings were social commentaries that were biting, caustic, and very relevant. When I'm saying March had Chayefsky's ear, I'm saying that it's an ultimate compliment of understanding the pain, anxieties, concerns and fears of everyday Americans. March reflected that when he came back from the

Soviet Union.

He was an everyday person. He would go to the finest restaurants, and then he had Finney's on the Alley, and [his son] Sande ran it. You had to have a Philly's cheesesteak.

He touched many different areas of living. He was aggressive, he was persistent, he persevered personal attacks as well as financial ones that were made to try and put him out of business. His editorial policy was very clear. How do we deal with residents first? How do we deal with those issues [while] trying to balance the need to have a vibrant business community that would flourish so that our treasury would be able to support the services that the residents required, wanted and needed? He was a treasure to the city.

I treasure my relationship with him, because he was a very dear person who really cared about the welfare of the city.



**AJ WILLMER**  
**FORMER BOARD OF EDUCATION MEMBER**

My eldest daughter, Dejah Judelson, was in kindergarten at Horace Mann. I was oblivious to any city politics whatsoever, [and] one day, I walked her to school and the teachers are on strike. My immediate empathy was towards the teachers, [and] I started walking the picket line in October, 1989. It was interesting, you would send your kids into school and then you would walk the picket line.

I got involved with a group called Children First, and we were primarily supporting the teachers. In Children First, there was a group of us who were the leadership of the group. We went and met with March Schwartz. That was my first interaction [with March] and I remember being very unprepared to handle the issues.

March and a variety of other people, [including] Judie Fenton, really steered me down the line of really beginning to understand the issues. When I ran for the school board in 1991, I spent a fair amount of time inviting myself into March's office doing my best to get his endorsement. I don't think I did, but we developed a mutually, respectful relationship. I did not win that school board election, but a variety of complicated things happened, a school board member resigned, and I was appointed to the board in 1991. I completed a term and in 1993 I ran for the school board again and won re-election.

Between 1991 and 1993 [when] I was on the school board, there were two dominant newspapers in town [the *Courier* and the *Post*.] I spent a fair amount of time, probably a couple times every month, inviting myself into March's office and just going through school board issues. We didn't always see eye-to-eye but it was very important that we shared information or he knew the information as I saw it.

You learn a healthy respect for the newspaper business. I learned some of the issues of being on the record and off the record and being very careful. March told me that there were times when, to give him the full background, it was important to be off the record and he always honored it. I learned a healthy respect for how that part of the newspaper works. [It was] never information that was not appropriate, but sometimes you just wanted information that you didn't want attributed to you in a damaging story and it allowed him to do the research and pull out information.

In 1997, I was running for re-election again and it was a very competitive election. I went after March big time to get the endorsement and you could never read him. I was incessantly inviting myself into his office. Thursday night, sometime shortly after midnight when the *Courier* papers got dropped off, there was a paper with the biggest headshot of anybody ever on his front page. There was this big headshot of me on his front page. It was huge, it was almost embarrassing. I called him to thank him the Friday before elections and he goes, "You worked really hard for this endorsement and you've earned [it.] I don't believe my endorsement means as much as you think it does, but you need to know that's the largest picture of a candidate I've ever put on my front page."

I lost the election that Tuesday. It was the election where Barry Brucker, in a write-in, [and Gerald Lunn] beat Lillian Raffel and me.

March really did like people to call him [and] the only time he ever called me was [the] Wednesday morning after the election. He said, "I really wished you won the election. I was very serious about my endorsement. I did tell you I don't think my endorsement means that much."

I worked so hard to get an endorsement from him, then I got a huge endorsement from him, and then I lost the election.

March and I didn't see eye-to-eye on a lot of issues. [We] always [had] a mutual respect [for each other]. I had a great deal of trepidation about approaching him in the early 1990s when I was just dipping my toe into politics. Then I got to a comfort level where I really felt that I had an understanding of what was going on in the schools and was on more even footing with him. But he still made you call him.







## BHHS football team loses to Templeton in season opener

Normans to play host to North Torrance Friday

Beverly High was shut out after scoring a touchdown on the opening series and allowed touchdowns on six of Templeton's first seven possessions in a 41-7 season-opening loss Friday night in a nonleague football game at Nickoll Field.

The loss was the 11th in Charlie Stansbury's 11 games as the Normans coach, their 12th straight dating back to 2012 and 29th in 33 games dating back to 2010.

"To lose 41-7 is tough, but I think we showed what we can do on the first drive," Stansbury said.

On a possession when Beverly Hills did not officially throw a pass, the Normans drove 87 yards on 14 plays, consuming eight minutes, 18 seconds.

Sebastian Torres ran for 46 yards on five carries, Joe Kolko 20 yards on five carries and Rashad Ysaquirre 13 yards on three carries, including the final one for the touchdown, which gave Beverly Hills its first lead during Stansbury's coaching tenure.

The Eagles (2-0) responded with a touchdown 1:58 later on Jordan Bernal's 18-yard touchdown pass to Christian Hauser on a fourth-and-16 play, six plays after Hauser's 54-yard kickoff return gave Templeton the ball on the Normans' 40-yard line.

Beverly Hills kept the lead as Angel Avelar missed the conversion.

Templeton took the lead for good on its next possession, driving 90 yards in 16 plays, culminating with backup quarter-

back Gunnar Griffin's three-yard run. All the Eagles' yards on the drive came on the ground.

Templeton converted two fourth down plays on the drive. On the first, Nate Avery ran nine yards for a first down on a fourth-and-six play. Griffin ran 12 yards for a first down on a fourth-and-10 play on the second.

The Eagles increased their lead to 20-7 on Griffin's three-yard run and Bryson Messer's two-point conversion run 5.2 seconds before halftime.

The drive appeared to have ended when Griffin threw an incomplete pass on a fourth-and-one play, but the Normans were called for a personal foul, giving Templeton a first down on the Beverly Hills 14-yard line.

Bernal threw 22- and 19-yard touchdown passes to Avery Shannon and Hauser in the third quarter and Griffin threw a 14-yard touchdown pass to Avery in the fourth.

"We had great energy to start," Stansbury said.

"Once we got past the first quarter in my opinion those six quarters they already played made a difference in the adjustments they could make. We haven't had to make those adjustments yet."

After gaining 82 yards and picking up six first downs (and another on a pass interference penalty) on their first drive, the Normans were held to 70 yards and six first downs for the rest of the game.

"We need to clean up our passing game,"

Stansbury said. "That would have helped us tremendously, just to complete a few of those in the second and third drive. That would have been huge."

Beverly Hills quarterback Mike Massie completed two of six passes for 18 yards. He suffered a leg injury while playing defense in the fourth quarter, and missed the rest of the game.

Kolko rushed for a game-high 76 yards on 16 carries and Torres 68 yards on 10 carries, both drawing praise from Stansbury along with offensive lineman Jon Revah.

#### What's Next?

The Normans are scheduled to play host to North Torrance Friday at Nickoll Field in a nonleague game set to start at 7 p.m.

Massie is listed as questionable, Stansbury said Wednesday. If he is unable to play, Jake Wolken and Dylan Rutigliano and would replace him at quarterback, Stansbury said.

If Massie is unable to play "it changes a little bit of what we do," Stansbury said. "At the same time, there are things we can do with the other guys we can't do with him."

The Saxons (2-0) defeated Redondo, 13-10, Aug. 29, and Peninsula, 34-19, Friday.

North Torrance alternates between the pass-oriented three-receiver spread offense and the pro set, Stansbury said.


