## "Kuehl and Shriver debate transportation and economic development"

I attended the first candidate forum between Supervisor candidates Bobby Shriver and Sheila Kuehl at UCLA not knowing quite what to expect.

There was a full house at MacGowan Hall and the moderators had two topics: Transportation and the local economy. As Kuehl was introduced, she immediately chastised the moderators for limiting the subject to two, and began mentioning other off topic favorites she preferred to address.

Shriver addressed the controversial subjects with candor, insight and courage. Yes, he said he was endorsed by the Chamber of Commerce, but that "sometimes you have to say no to people."

Both he and Kuehl support raising the minimum wage.

Kuehl attacked him for having no experience and that this was not an "entry level" job he sought. He came back with his accomplishments in getting Washington leaders to approve funding to fight HIV/AIDS and worked with leaders to create debt relief in other parts of the world.

As Kuehl kept dropping endorsement



## Kuehl and Shriver debate transportation and economic development

LA County Supervisor candidates Sheila Kuehl and Bobby Shriver debated issues from transportation to economic development at UCLA Tuesday evening.

Kuehl and Shriver sparred with each other the issue of the Purple Line extension route, which plans to tunnel under Beverly High.

Though Kuehl doesn't mention which specific alternate route she supports, she said that she is open to changing the route of the subway extension to avoid tunneling under Beverly High.

"I don't like the route under the high school," Kuehl said in a May article published in the *LA Times*. "I had been hearing about a third way, which I hoped to help happen. But I am not in any way going to stand in the way of the completion of the Purple Line."

In the debate, Kuehl said that finding a route that doesn't tunnel under Beverly High would halt the lawsuits between the city of Beverly Hills and Metro.

"If we could get people to feel like they have a little win, that would get the [lawsuits] to stop," Kuehl said.

Shriver said that Kuehl received an endorsement from the Beverly Hills Courier due to her opposition to the Purple Line alignment, and that saying, "No," is a "test of political courage."

"Zev [Yaroslavsky] has been working on this for years," Shriver said. "It's already financed. The minute you talk about changes, the financing gets put on hold. You have to be willing to tell people 'No.'"

He added that if the extension is completed, there would be an increased amount of metro riders to the Westside.

"Ridership would be through the roof," Shriver said.

## Federal agents seize \$90 million in suspected money laundering schemes in fashion district raid

Federal agents raided and targeted 75 locations in the downtown fashion district on September 10, and arrested and charged nine

individuals and named four businesses that may have been involved in money laundering schemes with drug organizations in Mexico.

"[Federal agencies] could do surveillance for a couple of years depending on how long it takes them to get evidence," criminal defense attorney Ronald Richards, who is not affiliated with the case, said. "They do as much as necessary to acquire evidence or rule out any wrongdoing if they don't find anything. They've probably done surveillance on these people for a long time."

The raid seized \$90 million, in which \$70 million was in cash. One condo had \$35 million in banker boxes and a mansion in Bel-Air had \$10 million in duffel bags, according to the *LA Times*.

"The defense attorney would focus on the fact that cash sales are commonplace in large garment purchases where credit is low or non-existent," Richards said.

Drug organizations in Mexico have used Los Angeles businesses to convert their money into pesos, according to the *LA Times*.

Since 2012, Mexico has limited deposits of U.S. currency to banks, brokerages and exchange houses. By restricting how American dollars enter Mexico, drug cartels

could no longer send large amounts of cash home to be spent and deposited in the way they wanted.

Black market peso brokers found a way for drug cartels to navigate the system by forming connections between Mexican importers and U.S. clothing wholesalers.

The brokers would contact importers in Mexico who wanted to buy goods in Los Angeles. If the importers wanted to buy clothing in the U.S., the broker would get a U.S. drug contact to pay a clothing wholesaler in dollars for what the Mexican importer needed.

The importer in Mexico would then pay the broker in pesos, who takes a cut of the money and pays the rest to the drug organizations.

"The defense attorney would attack the fact that it would be difficult to attach the specific cash recovered to an actual illegal transaction," Richards said.

Pacific Eurotex Corporation owners allegedly hid \$2.6 million in drug money for over two years by depositing amounts less than

tial targets were potential victims of a kidnapping," Richards said.

According to Richards, the international implications do not result in a longer sentence, though there are different crimes with bringing money into the U.S. without declaring it if it's over \$10,000.

Q.T. Fashion owner and manager, Jong Hack Park, 56, of La Canada Flintridge, and Sang Jun Park, 36, of La Crescenta, were arrested on charges related to money laundering and smuggling goods. Jose Isabel Gomez Arreola, 49, of downtown Los Angeles, who worked for Maria Ferre, was arrested on suspicion of distributing the money and changing labels on the clothes to indicate they were made in America to avoid Mexican tariffs. Three other defendants, the owner of Maria Ferre, its accountant and an employee, are at large in Mexico, federal authorities said.

"It's federal court, you don't automatically get bail," Richards said. "Because these are business owners and this investigation has been going on for a while, I believe that most or all of them will get bail. It's not the type of events where they wouldn't normally bail people out."

For the defendants who are out of the country, they must be extradited, which is when a country transfers a person who is facing criminal prosecution or punishment.

Seven defendants pled not guilty on Sept. 17. Two others will be arraigned at a later time.

## 9900 Wilshire project plans to break ground in 2015

The Wanda Group, China's largest commercial property developer, plans to break ground in 2015 for the eight-acre site located at 9900 Wilshire Boulevard, according to a statement released by CBRE and Savills Studley on September 12.

Wanda is currently in the process of establishing a project office to manage the mixed-use development, according to the press release. Approved plans for the 9900 Wilshire project included commercial and residential uses.

Joint Treasure International completed the sale of 9900 Wilshire to The Wanda Group on September 12.

9900 Wilshire was marketed by CBRE Beverly Hills Executive Vice President Laurie Lustig-Bower, CBRE Hong Kong Executive Director of Investment and Project Marketing Rebecca Shum, and Executive Managing Director Robert Stamm and Real Estate Capital Markets Senior Director Frank Marriott of Savil Studley.

"This was an opportunity to develop a high-profile, entitle property located in one of the most recognizable cities in the world," Lustig-Bower said. "Full entitlements from the appropriate municipalities have been carefully processed by a previous owner, which will allow the buyer to leverage the value already created and promptly commence construction."

Entitlements for the project are set to expire on December 18, 2016. Building permits must be obtained from the city prior to breaking ground.

9900 Wilshire, formerly the site of the demolished Robinson's May building, was bought by New Pacific Realty in 2003 for

\$33.5 million. Candy & Candy later bought the site for \$500 million in 2007.

Condo plans, designed by Pritzker Architecture Prize recipient Richard Meier, were approved in 2007 and 2008. The resi-

dential space will feature 235 total units in two towers.

However, Candy & Candy were foreclosed on in 2010. Joint Treasure Interantional Ltd., a Hong Kong based private equity group, bought the site for \$148.3 million.

Wanda Group won the bid our of ten other bidders in August for an undisclosed amount.

“With its premier Beverly Hills address, 9900 Wilshire is expected to rank among the most well-known addresses of rival world-class cities such as Lodon, Paris, Hong Kong and New York,” Lustig-Bower said.


## Sharing the Bounty charity dinner canceled; meals to be donated to PATH


### Single-family development maximum height linked to front and side setbacks

The Planning Commission discussed amendments to the central area, single-family development standards including roof and building height guidelines linked to front and side yard setbacks at a September 18 meeting.

Single-family developments north of Santa Monica Boulevard for any roof type

will have a maximum plate height of 22 feet. Plate height is where the base of the roof meets the building. An additional foot of plate height, up to 25 feet, can be added with an additional 2.5 feet added to the front yard setback.

Currently, the maximum building height is set at 28 feet. Depending on the roof type, the commission proposed alternate ways for developments to have a higher roof height if the building has side setbacks at 10 feet or more.

For sloped roofs with no horizontal ridge-

### Bosse highlights healthy initiative accomplishments at Evening with the Mayor

Beverly Hills Mayor Lili Bosse delivered her State of the City address to over 400 community members at the Evening with the Mayor held at the Greystone Mansion on September 10. At the beginning of her term as mayor, Bosse launched her Healthy City Initiative, which encompassed three areas: healthy people, healthy economy, and healthy government.

Bosse mentioned several programs that she began as Mayor. The Walk with the Mayor program allows community residents, business owners, and city visitors to walk the streets of Beverly Hills and visit at least one local business.

“We are building stronger, healthier people,” Bosse said. “As we walk, we talk. That’s the healthy government piece of the walk.”

Bosse also mentioned in her speech unfunded liabilities, which are payments that will be due for city employee pensions in the future, which are estimated at \$200 million. The city has allocated \$2 million from the last fiscal year and \$2 million from the current year towards unfunded liability, but the city needs to “establish a specific percentage goal for our unfunded liabilities.”

“We will be exploring other alternatives and ideally, new approaches to prepare for our future obligations,” Bosse said. “This is

line, the maximum building height is 28 feet. If the development includes 10 feet side setbacks, the maximum building height can be 30 feet.

For sloped roofs with a horizontal ridgeline, the maximum building height is 32 feet with an average roof height of 28 feet. If the development includes 10 feet side setbacks, the maximum building height can reach 34 feet with an average roof height of 30 feet.

A slope is currently defined as roofs where 95 percent of the roof area has more than a 10 percent slope.

Commissioner Craig Corman said that having the option to push the house further back with the additional roof plate and building height would make the house appear smaller when compared to the neighbors’ houses.

and will continue to be a very high-priority item for this Council.”

Bosse said that the overall healthy financial landscape of Beverly Hills have been due to an improved economy, good city budgetary practices, and reasonable cost control measures and contributions of Beverly Hills business partners.

Business tax accounts for 20 percent of the general fund reserves, hotel transient occupancy tax accounts for 18 percent, sales tax accounts for 15 percent, and property tax accounts for 24 percent, with some of the percentage belonging to businesses.

“Any planning for the future will abso-

lutely include very strong continue support of and partnership with our fabulous business community,” Bosse said.

Bosse mentioned city renovations to parking facilities, parks including the Electric Fountain renovation at Beverly Gardens Park and an improved La Cienega Park, as well as a potential dog park location on city owned property at Foothill and Alden Drives.

“You are the reason Beverly Hills is thriving today and you are the reason our future is bright,” Bosse said. “We will do everything we can to keep Beverly Hills going on for another hundred years.”



This would reduce the appearance of bulk and mass by setting the house further back on the property.

For single-family developments south of Santa Monica Boulevard, buildings with flat roofs will have a max plate height of 22 feet,

and a max building height of 25 feet, but no setbacks would be allowed.

“These are smaller lots,” Corman said. “We didn’t think pushing back and adding more height was appropriate for the south.”

The only change would be to define sloped roofs with and without ridgelines, and to have the maximum plate height be at 22 feet,

and the maximum building height at 28 feet. Currently, developments with no ridgelines have a maximum building height at 30 feet.


Architect Hamid Gabbay expressed concerns that architects would be limited in designing creative houses.

“You limit the architect’s ability,” Gabbay said. “You basically force the architect to cut

[the roof] at a certain height, have a lower portion of it one way and an upper portion another way.”

Gabbay also suggested having visuals accompany the three different options to help guide the designing process.

That includes preserving technical education in our schools from budget cuts and expanding job-training programs for youth to prepare them for the jobs of tomorrow. **Health and Safety Commission Chair Stacia Kopeikin discusses making Beverly Hills safe**

**How did you become involved with the commission?**

I became a commissioner in 2007 when the commission restarted. There was a health and safety commission years ago. I was on the first group of seven and I had an interest in it. I had done Team Beverly Hills and part of that is to encourage community involvement, which I had been involved in very much in Beverly Hills. It just seemed like a perfect fit, specifically, the safety element is something that I'm passionate about.

At the time, and currently, I work with the Beverly Hills Police and it's something that's close to my heart. I thought that this would be a good fit for me to be involved in the city side as well as being involved professionally.

I'm actually finishing up my term. I've been on the commission for seven years now. It's been a fabulous rewarding opportunity.

**In what ways has the commission grown and changed since it restarted in 2007?**

It's definitely changed when the commission first started. We had two medical doctors. We have a dentist now, but we don't have an MD. The composition has changed, but it's a diverse group of citizens. Everybody seems to bring a different area of expertise to the table. It's a really good mix of people.

There are seven [commissioners] although we're going down to five.

We're the last commission to have seven. The City Council has voted to make everything more uniform so we will be going down to five like the other commissions.

**What other organizations were you involved with in Beverly Hills?**

I went through the CERT and CPR training. I was vice president of the PTA at both the elementary and high school level when my children were attending the public schools. I was a member of the General Plan Update Committee with the commercial and residential interface. Then I managed numerous political campaigns and was involved politically for many years, both on the school board and the city council level.

**We interviewed former Chair Gail Millan in the Weekly's Issue #733. She said she hoped to "make people aware of doing a better job of taking care of their health and safety" and that the commission continues "to work to really build a better, stronger community that's more aware of health and safety issues." What is the Health and Safety Commission working on to continue those endeavors?**

Currently, we are working with the Human Services Department of the city. We're going to be supporting and hosting a collaborative event for networking agencies that assist with Beverly Hills' older adult community with health and safety issues. That's going to be held in November. That's probably the biggest thing we're working on right now.

We most recently participated last month in National Night Out. We had a booth doing outreach on a diverse number of subjects from flu prevention to clean hands, pedestrian safety, [and] vector control issues.

Recently, we studied, reviewed and provided policy recommendations for the City Council on the issue of the sale and use of e-cigarettes, which followed up on us doing the same thing for tobacco. We are suggesting doing the same laws that are currently being held for tobacco with e-cigarettes.

We get presentations from different

city of Beverly Hills' departments and interface with them regarding health and safety issues. For example, we would go tour the Emergency Operations Center and then learn about the different citizen's parts within each of the departments and what people can do and then we do the outreach to get people involved

We also instituted the Health and Safety Award a few years back. It is for an individual or an organization that has made a contribution to the city in the department of health or safety. For example, one of the winners was the Every 15 Minutes Committee. They received the award as the group for putting on the event at the high school.

Also, we're involved in Dangerstoppers. We helped developed and participate in the Dangerstopper videos, and that's in conjunction with the city's cable office. Our latest is on pedestrian safety, but we've also done them on fighting the flu [and] protecting your pet. They're scenarios and situations for different emergencies and health issues, and how the community can best get the information of what to do during these [situations]. The commissioners participate in the videos. For example, you can see me and my dog Buddy in the "Protect your Pet" video.

**Recently, the LA Times released a chart showing that BHUSD has one of the highest rates of personal belief exemptions for kindergarten vaccinations in the LA County. How does the commission plan to inform the community on the importance of vaccinations?**

Our commission has addressed this issue. We've had speakers give us presentations regarding that and while we don't take any hard and fast policy statement on it, [it] has been discussed that vaccinations are very important and necessary for the health of our community.

The speakers come to the commission meetings, which are public. Everybody is invited to attend our meetings and they are televised live as well. Any presentations we get are for whole community.

**Tells us about what you do for the BHPOA.**

For the BHPOA, professionally I have a business partner, and I do all of their events, fundraising, marketing, merchandise, PR, just about everything.

**What are some upcoming BHPOA events?**

The Police Service Day and Pancake Breakfast day was Sunday from 8 a.m. to noon. It was an enormous success. Approximately 2,500 people braved the heat to attend and enjoy delicious free pancakes prepared by Beverly Hills' finest, station tours and other interactive BHPD displays. We want to thank our fabulous sponsors, Rotary Club of Beverly Hills, Langers Juice, The Beverly Hilton and Individual Foodservice.

The Black and White Gala is on Nov. 3. It will be held at the Beverly Hilton. This is our largest fundraising event of the year. We expect close to 1,000 attendees and to have a fabulous silent and live auction. It's the community's way to say, "Thank you,"

back to this fabulous police department that we are so lucky to have.

**Tell us about your family.**

I'm married. We just celebrated our 30th wedding anniversary. I met my husband, Larry Kopeikin, in college and he is a partner at an entertainment law firm, Morris Yorn, in Century City.

I have a son, Max, who's 26 years old. He lives in San Francisco. He is in graduate school getting his masters to become a marriage and family therapist. He's also a yoga instructor who specializes in acro-yoga, which is acrobatics in yoga.

My daughter Hannah, 24, works in events and marketing for Yahoo in New York. Both my kids are graduates of UC Berkeley. My daughter graduated Phi Beta Kappa.

**What are your goals as Health and Safety Commission Chair?**

Our goals are pretty much consistent. As Gail said, our mission is to create community culture of awareness and preparedness. We serve as ambassadors to the city in all health and safety related issues.

This year we're continuing to do what we've done in the past. We help the Office of Emergency Management under Pamela Mottice Muller [Office of Emergency Management Director] to get involved in hoping and helping our city be prepared in the event of a disaster. It's not a question of if it will come, it's when.

We've partnered with Mayor [Lili] Bosse in helping with the Mayor's Lunch and Learn program. We've been providing input on the subjects. In fact, one of our former commissioners spoke at the

first Lunch and Learn program on heart health. That's something that we've been continuing and is a goal of ours this year.

#### What have you learned from being on the commission?

It's incumbent on us as individuals to be informed and to be prepared. We have

to [have] more individual responsibility. We can't count on the city to do everything for us, and not in the way that they can't do it, but in the sense that there are things that we need to take responsibility for ourselves. A lot of that has to do with preparedness in the event of an emergency as well as our own everyday health needs.

We deal with things like washing our hands and trying to avoid getting the flu.

#### Besides being involved with the BHPOA, in what other ways will you continue to be involved with the City?

That's probably my main way that I will stay involved with the city right now.

My kids are both grown and gone and I'm not involved in the schools anymore. My main involvement will be through the police.

It's sometimes not a bad thing to take a step back from things.

"I had a great experience as a principal at Hawthorne. I would say that one of the most important lessons I've learned as principal of Hawthorne is that there's no such thing as a small issue because to somebody it's a big issue. [I understood] that when parents or teachers come to you with a matter or a concern, to them it's a big deal. To be able to learn that and

to value the input of all stakeholders in the school community is a really important lesson that I translate to my job as superintendent at the SMUSD.

The SMUSD is the highest achieving school district in the state of California, which we're very proud of. At the same time, there's also a really high expectation to succeed. It's my job to continue that tradition. Not so much focusing on being the highest achieving district in the state of California, but really focusing on providing the best and most innovative programs for the students and having the most highly trained teachers in the state of California. If we do that, then the results will take care of themselves.

The community in San Marino is very similar to Beverly Hills in that the schools are really the crown jewel of the community. The entire community has a lot of tradition and a lot of second and third generation folks that come to the schools. The schools drive the community and it's been an unbelievable place to work.

There's a special place in my heart for Beverly Hills because that's where I spent the majority of my career as a principal and as a district administrator. My wife [Liz Cherniss] still works as a preschool teacher at Beverly Vista.

There's a lot of untapped potential in the BHUSD, and I don't believe they are where they want to be or where they need to be. But I hope in time, with the right people leading the district, that they'll get there."

"Working in Beverly Hills was terrific. I started my first 11 years of education there as a teacher, an assistant principal, and a principal. The support and the expectations from the community, the parents, and the staff, [made] it an amazing place to learn and grow. Some of the leaders that I learned and fol-

lowed from, and modeled myself after [were] Tanis Harris, Art Fields, Steve Fisher, Sol Levine, Ben Bushman, Gwen Gross, Vivian Saatjian-Green, Carter Paysinger, Toni Staser, Stewart Horowitz, Jane Wortman, and Joel Pressman. There were so many great people and many are still there. Even the police chief, Dave Snowden was always great to the schools, and he still is.

I learned a lot about servant leadership. You're really going to earn a lot of credibility if you're willing to roll up your sleeves, work next to everybody, be a team player and listen. The more you listen, the more you gather information and perspective from others, and the better chance you have of moving an organization forward. When people have a sense that you've considered their points of view and perspectives, and their concerns and excitement, and their ideas or any of those kinds of things, they're much more willing to follow someone like that [instead] of a top down leadership model.

I tried to capture a lot of the best of the elements that were part of Beverly when I was there. A family feel, an open door feel and a small town feel, and a team approach to things. That doesn't mean that we don't disagree. Disagreement is going to happen. It's natural, it's good and to be encouraged, but let's focus on solving problems, checking our ego at the door and focusing on the mission of student learning. Many things come at schools, especially higher profile schools like Beverly and Las Virgenes, we get easily pulled by lots of forces in different directions. Keeping it simple and focused on kids and what's best for kids is what we're trying to do."



## BHHS football team routed by North Torrance

### Norman basketball player commits to Arizona

Beverly High lost to North Torrance, 48-0, in a nonleague football game Friday night at Nickoll Field.

"They were able to make some big plays which we knew we had to stop going in," Charlie Stansbury said after his 12th loss in 12 games as the Normans coach.

"Our effort on defense at times was tremendous and at other times we were in position to make the play and we got a guy who makes a really athletic play."

Beverly Hills (0-2) "put some nice drives together" but "didn't have the consistency running the ball that we thought we were going to be able to," Stansbury said.

Jake Wolken "did a little more than expected" in his first varsity start at quarterback, Stansbury said.

"We've got a lot to work on, but it was encouraging to see him react during the game and take control of the offense," Stansbury said.

Wolken started in place of Mike Massie who missed the game because of a leg injury sustained in the Normans' season-opening 41-7 loss to Templeton Sept. 5.

Running back Rashad Ysaquirre "did a nice job running the ball," Stansbury said.

North Torrance improved to 3-0.

#### What's Next?

The Normans are scheduled to play at San Gabriel Friday night in a nonleague game beginning at 7 p.m. that could be their best chance to win a game this season.

The Matadors (0-3) have been outscored 142-0, losing to Montclair, 42-0, Aug. 29, Glendale, 35-0, Sept. 5 and San Marino, 65-0, Friday.

Beverly Hills' narrowest loss during their 0-10 season in 2013 came to San Gabriel, los-

ing, 13-6. The Matadors are 1-8 since then, with their only victory coming over Mark Keppel, 13-12, on Oct. 25.

A key to the game is "controlling the ball," Stansbury said.

"The team that makes the fewest mistakes is going to win the game," Stansbury said. "Defensively, we have to play consistent football to be there at the end."

Massie is probable, despite missing practices Monday and Tuesday, Stansbury said on Wednesday.

#### Basketball

Beverly High center Chance Comanche announced on his Twitter account Sunday that he would accept a scholarship offer from the University of Arizona.

"The visit was good but it was that I felt comfortable with the coaches and the players," Comanche told the Tucson-based Arizona Daily Star on Sunday afternoon.

"Coach (Sean) Miller has been recruiting me since my freshman year, so I felt comfortable with them...It was the players, the coaches, the school, the whole thing, really." Miller and other Arizona athletic department officials could not comment on Comanche's announcement because NCAA rules forbid them from publicly discussing any recruits until they sign a letter of intent. The signing period begins Nov. 5.

The 6-foot-10 Comanche is ranked 87th on ESPN's list of the top high school boys' basketball players in the class of 2015. He transferred to Beverly High from View Park, a charter high school in South Los Angeles, before the start of the school year.

#### Softball

Len Mitchell has stepped down as Beverly

High's varsity softball coach, citing in part a knee injury he said makes it difficult for him to be the "hands on" coach he seeks to be. "It's tough to let go," Mitchell said in an interview this week. "It was a tough decision, but I feel good about the decision. I'm not ready to leave altogether."

Mitchell said he would serve as the junior varsity coach or a varsity assistant if his successor approves. He will continue to be an assistant coach in the girls' basketball program and teach math.

Mitchell had been the softball coach since 1991.

"I would like to thank all the parents for their support of the program and I always wish that the players enjoyed their softball experience," Mitchell said.

Potential replacements are being interviewed, said athletic director John Johnson. Johnson said he hopes to select a successor by mid-October or mid-November.

"It's hard to replace Len Mitchell," said Johnson, who took a math class taught by Mitchell when he was a Beverly High student in the late 1980s. "He's one of the best people I've ever met. All you can do is try to work to continue his legacy."

#### Girls' Volleyball

The Normans defeated the Falcons in a nonleague match at the Swim-Gym Sept. 9 thanks to keeping the ball in play, being strong defensively, their success in receiving serves and avoiding unforced errors, according to Beverly Hills coach Tanner Siegal.

Junior outside hitter Elsa Woods and sophomore setter Landry Bearden drew praise for their play from Siegal.

The Normans acclimated themselves to the Kares nontraditional defense to win the final three games of a nonleague match at Rio Hondo Prep Friday, Segal said.

"By the time we figured it out, they couldn't stop us," Segal said.

The defense consisted of putting up one blocker and dropping "a lot of other people into coverage," Segal said.

"They were taking away a lot of court," Segal said.

Bearden was Beverly Hills' best offensive player, Woods its best all-around player, said Segal, who also praised the play of senior opposite hitter Paige Dubelko and the defensive play of defensive specialist Alyssa Thompson.

#### Burbank Tournament

The Normans lost to Sylmar, 27-25, 25-23, 26-24, and won two of three games from Campbell Hall in pool play and Heritage Christian, 25-21, in the single elimination portion of the tournament Saturday at Burbank High.

Beverly Hills played without any of its seniors who were taking the ACT standardized test, Segal said.

"It was nice to see our young players stepping up and handle a bigger workload," Segal said.



**RESOLUTION NO. 14-R-13007**

**RESOLUTION OF THE COUNCIL OF THE CITY OF BEVERLY HILLS DECLARING AND IMPLEMENTING STAGE "B" WATER CONSERVATION MEASURES**

The City Council of the City of Beverly Hills does resolve as follows:

Section 1. Recently, the Governor has declared a drought in the State of California and the State Water Resources Control Board has enacted emergency water conservation measures. In light of this water emergency and for the reasons set forth in the agenda report presented to the City Council on September 2, 2014, the City Manager has determined that a ten percent (10%) reduction in potable water use is required and that water conservation Stage "B" be declared and implemented by the City Council. Beverly Hills Municipal Code Section 94301 provides that the City Manager or his designee is authorized to implement certain water conservation measures after holding a public hearing before the City Council.

Section 2. On September 2, 2014 the City Council held a duly noticed public hearing to consider the recommendations of the Assistant Director of Public Works Services to implement water conservation Stage "B." After receiving oral and written testimony, including the agenda report, the City Council hereby determines as follows:

(a) Water Conservation Stage "B" is hereby declared throughout the City of Beverly Hills and the City Council hereby directs that the Assistant Director of Public Works Services implement Water Conservation Stage "B" as set forth herein.

(b) The Assistant Director of Public Works Services and/or appropriate City Staff shall hereby communicate to residents, visitors and businesses the following mandatory water conservation measures for implementation: (i) restaurants shall serve water upon request only; (ii) all public restrooms in the city and private bathrooms in hotels shall notify patrons and employees of water conservation goals; (iii) plumbing and irrigation leaks shall be repaired within seven days notification to the property owner by the City; and (iv) users in Tier 2 and above shall reduce water usage to ninety percent (90%) of the baseline period amount as determined by the City Council; the watering of lawns and other landscape shall occur in accordance to a watering schedule promulgated by the Assistant Director of Public Works Services; and drought emergency water conservation regulations as promulgated by the State Water Resources Control Board. In ad-

dition to these elements, the City Council hereby authorizes the City Manager or his designee to implement other mandatory water conservation elements as determined necessary by the City Manager in order to achieve a ten percent (10%) reduction in potable water use.

(c) For users in Tier 2 and above during the current billing cycle, a water penalty surcharge of up to two (2) times the basic water rate shall be charged for water usage in excess of ninety percent (90%) of the baseline period amount as determined by the City Council.

(d) Violation by any person of the stage "B" mandatory requirements described in subsection (b) shall constitute an infraction and, upon conviction, shall be punished by a fine not to exceed one hundred dollars (\$100.00). The violation of each element described in subsection (b), and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.

Section 3. The procedure for a water customer to appeal the imposition of the water penalty surcharge will be as outlined in Resolution 09-R-12672 adopted by the City Council on May 13, 2009 will be reinstated.

Section 4. In accordance with Beverly Hills Municipal Code Section 94303.B, the City Council hereby directs the City Clerk to publish this Resolution at least once in a newspaper of general circulation within the city and to post this Resolution in at least three (3) public places and continue to post this Resolution until such time as the restrictions set forth herein are repealed by resolution of the City Council.

Section 5. The provisions of this Resolution shall become effective upon a final determination by the City Council of the baseline period or completion of modification to the City's utility billing system to accommodate these conservation measures, whichever is later.

Section 6. The City Clerk shall certify to the adoption of this resolution and shall cause this resolution and his certification to be entered in the Book of Resolutions of the Council of the City.


