"Board of Education calls for plan to address 'Program Improvement' but what does it mean for Beverly High?" [Issue #787]

I am responding to [the Courier's] October 17, 2014 article "State Labels Beverly Hills High For Program Improvement."

Our family (Clark, my husband of 51 years and I) are long term residents here in Beverly Hills since 1967. Two of our children graduated from Beverly [High]. Our grandson is now enrolled at Beverly.

Particularly, as a devoted and committed educator to inner city youth in urban settings, I am commenting on the statement where [the Courier] indicated that Superintendent Gary Woods [said], "It doesn't mean much beyond a bit of bad publicity and a letter that goes out to families letting them know there's an alternative school to send their kids to that doesn't have that designation."

First of all, I don't think the state can label a school in "Program Improvement," since these are federal funds, and since the new testing procedures of Smarter Balanced Testing (CAASP) are in effect, schools are getting as tech savvy as possible and not going into "Program Improvement."

K-3 grade maintains studentto-teacher ratio, second grade class to have additional staffing

The Board of Education voted at their October 28 meeting to maintain the hard cap of a 20:1 student teacher ratio. In order to not rearrange current second grade classrooms at El Rodeo, the Board also approved the hiring of an additional long-term, fully certificated substitute teacher in an El Rodeo second grade class.

Kindergarten and second grade classroom at all four BHUSD elementary schools have full enrollment with a 20:1 student teacher ratio, and the district has one more second grade student to add to a classroom.

"BHEA respectfully believes that an increase to a class size ratio of 21-1 at the K-3 level has to be negotiated at the bargaining table," BHEA President Telly Tse told the Board members.

The current collective bargaining agreement includes a class ratio size of 20:1.

Board member Howard Goldstein and President Noah Margo voted against maintaining the student-to-teacher ratio cap to 20:1.

According to Goldstein, each new open classroom would cost the district between \$100,000 and \$125,000, depending on the needs of the class. If an additional teacher were to be hired for a new open class, the district would have to reassemble the classrooms and move 13 to 14 students to a new classroom.

"Our educators [and] our site administrators need to make a determination whether that additional child will impact that class," Goldstein said. "If you put that student in that class and there's no impact to the learning environment, essentially there's no harm, no foul to the learning environment. If you open up another class, you have an impact of this district of \$100,000 to \$125,000. You're also removing 13 to 14 children to another class two or three months into the school year."

Instead of opening up a new classroom for any new K-3 level student, a long-term certificated substitute teacher will be hired to assist a current second grade El Rodeo teacher

"If any additional second graders come, they're going to go to that classroom to maintain the hard cap with minimizing disruption to the teachers and to the students in second grade in this district," Board Vice President Brian Goldberg said.

Margo was the sole vote against hiring additional faculty.

"The best teaching is one-on-one, so once you start adding kids to a room after the first one that's the end to the experience," Margo said. "It's still the cost of the teacher that's the issue."

Health and Safety Commission go over preventative measures from the flu, EVD68, and Ebola

Updates and preventative measures were presented to the Health and Safety Commission at their October 27 meeting on influenza, enterovirus D68, and Ebola.

The flu and enterovirus D68 (EVD68) are contagious illnesses that can infect anybody. Symptoms for both ailments are similar and include high fever, sore throat, and body aches. The flu and EVD68 can be contracted if a person sick with either infection coughs or sneezes in the air or comes into close contact with another person.

Prevention includes washing hands with soap and water or using hand sanitizers and not touching the eyes, mouth, or nose. If the individual is sick, they should cough into their arms instead of their hands, and should stay at home until they get better. A flu shot is also recommended.

As of October 16, there are six cases of EVD68 in Los Angeles County, three in Long Beach, and 8,800 nationally in 46 states.

The Ebola outbreak is mainly in three countries in West Africa; Liberia, Guinea, and Sierra Leone. Ebola does not spread through air, water, food, mosquitoes, or other insects, and can only be contracted by having direct contact with the infected person's bodily fluids once symptoms appear. The virus takes anywhere between two to 21 days to show symptoms.

"The key are not just these common symptoms because it can look like other things," Commissioner Gail Millan said. "But the key is that you've had exposure [to Ebola] or you yourself have been to these

There are currently no medicine, treatment, or vaccine for Ebola.

Current preventative measures from Ebola are to avoid unnecessary travel to West Africa. A doctor should be contacted if a person has traveled to West Africa and show symptoms of Ebola.

There are currently no cases of Ebola in LA County.

"If there was a suspected patient who were to come into urgent care, there's a specific number to call as well as an epidemiology department," Millan said. "[Cedars Sinai has] been drilling [and] preparing. That has been a top priority and the education of the staff so people are prepared to do that"

Assuming that this statement was a direct quote of the Superintendent, may I state that when a school is designated as in "Program Improvement", it carries a larger meaning.

As Founder of Today's Fresh Start Charter School, much has been learned on educating young people regardless of their economic challenges and domestic situations. "Program Improvement" means that there are a number of students who did not achieve "proficient." Granted, for there to ever have been the expectation that all students (100 percent) enrolled in all public schools who accept Title 1 funds to reach "proficiency" at a particular single point in time is totally unrealistic, and will never,

ever be realized!

Here is why it is an impossible expectation; because teaching young people cannot be packaged into a "one size fits all." There are many variables to easily disqualify and be able to immediately understand why the expectation is impossible; the expectation that all students will reach proficiency at a single point in time. Here are a few: 1) varied home/domestic environments; 2) students coming in from other countries at all times and at any times during the school year; 3) with the NCLB (federal) guidelines there are also subgroups to deal with (English learners, Asian, African American, white, Latino, schoolwide,) and others; 4) different learning styles and levels of abilities coming into the district.

When a school receives Title 1 funds

(these are federal funds, not state funds), that means that the school's responsibility is to tutor those students after school, Saturdays or other times. Now, those students who did not make "proficient" in English language arts, mathematics, science, social studies and other subjects; those who ranked "below proficient," that would be basic, below basic, far below basic, the school knows who those students are individually. Title 1 funds are a set aside funding for tutoring those children who ranked below "proficient," starting with those students who were at "far below basic," then those at "below basic" and then those who are at "basic," ascending upward leading to proficient.

Now, that being said, in all respect to our Honorable Superintendent, it means more

than "bad publicity and going to another school." Let's think this through. Here are some other factors that come into play. Bad publicity is at the bottom of the list. More importantly, there are some students who need some help in their English language arts and their mathematics and other studies. Then, here is another consideration. As a "Charter School Founder" that's the purpose of charter schools, especially to help students who need more help than others. The school system loses enrollment!

The requested modifications and associated entitlements include the following:

Conditional Use Permit. A Conditional Use Permit is required for modifications to existing hotels. The proposed modifications to the Peninsula Hotel include the following:

- 883 square feet of new open air dining area located on the ground floor of the hotel, adjacent to the hotel's existing dining area;
- 1,829 square feet of new storage space within the subterranean parking area of the hotel;
- 331 square feet of new floor area on the ground floor, in place of one existing loading zone; and
- Modifications to existing conditions of approval that result from the above changes (e.g. number of required parking spaces, maximum restaurant occupancy, and maximum meeting room occupancy).

Extended Hours Permit. A previously approved Extended Hours Permit allows the hotel's outdoor areas to be occupied until midnight Sunday through Thursday, and until 2:00 AM Friday and Saturday evenings, as well as evenings preceding a holiday. Additionally, 12 times per year the outdoor areas may be occupied until 2:00 AM on a day other than a Friday, Saturday, or day preceding a holiday. As part of the proposed project, the applicant wishes to clarify the review process that must be followed for the 12 events. No changes to the permissible hours are proposed.

Former Beverly High Principal F. Willard Robinson passes at 96

Former Beverly High Principal (1959-1976) F. Willard Robinson passed away in Idaho on October 25.

Born on September 11, 1918 and raised in Long Beach,

Robinson received his bachelors from USC. After graduating, he pitched to the Raleigh bicycle company that he would ride one of their new model bikes across the country for publicity and as long as he would keep the bike. He rode a total of 2,500 miles in two weeks.

After working as a farmhand in Boulder, Colorado, and journeying from Seattle to Alaska in an 18-foot boat, he enrolled at the University of Alaska where he volunteered for flight training where he became the first government-trained pilot certified in the Territory of Alaska.

He applied for Navy flight training the day after the Pearl Harbor bombing.

After the war, he received an M.S in Education and Ed.D. in administration and philosophy.

While he was Beverly High principal during the Vietnam War, he allowed students

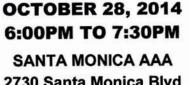

Some question whether BHUSD's naming policy is being administered effectively

The El Rodeo courtyard was named the "Michael Libow Courtyard" on Tuesday after longtime Coldwell Banker Realtor Libow made a donation to The Foundation of \$30,000. But not everyone at El Rodeo supports the decision.

"I find it very disturbing that the Board of Education and The Foundation sold such prime real estate for such little money," El Rodeo parent Marty Halfon said. "If their goal and responsibility is to raise funds, why wasn't a proper notification and mailing done to all family members and alumni of this wonderful opportunity?"

According to The Foundation President Ronit Stone, naming opportunities and donations are ultimately approved by the Board of Education, and are publicly available through The

Foundation website and in the Board of Education

"Nothing was mailed out or publicized to the families of El Rodeo that such a naming opportunity was available or going on," Halfon said. "Many parents were very disturbed when they saw this 'Michael J. Libow Courtyard' on the wall as they walked in to the school which they will have to pass every day coming and going."

Stone said that The Foundation is currently working on marketing material for naming opportunities.

"It's not maybe as promoted as it could be but really now it's out there," Stone said. "I think people are vaguely aware of it. We do have these areas at the various schools that are named after various people, so the

fact does exist. It allows people to come forward and support our schools. This is just one of a lot a ways that people can do it."

Libow has sponsored classrooms and two other play-grounds at other BHUSD schools, including Beverly High's "Libow Math Lab," for \$30,000, Beverly Vista's "Michael Libow Atrium" for \$21,750, and Hawthorne's "Michael Libow Kindergarten Playspace" for approximately \$23,000.

"Why I don't do it anonymously is to hopefully inspire others who can afford to do much more than I to make a similar donation or greater," Libow told the *Weekly*. "It's what I've done for all the community and school system, and what I do as part of my philanthropic efforts in the community. A lot of my efforts are unsolicited."

Donation amounts are recommended by The Foundation and approved by the Board of Education (see attached chart).

Unlike each school's PTA and family donations, donations that are approved by the Board of Education go towards The Foundation's general fund and endowments, not necessarily to the school itself.

"It just doesn't make sense that Michael Libow has his name on four out of the five schools," Halfon said. "Is he the only philanthropic individual in this town

who is buying up real estate to promote himself? If he's so philanthropic why isn't he giving \$50,000 to the police department? Why isn't he given \$50,000 to the fire department? Because they're not going to put his name on a fire truck. This is all a marketing ploy."

Libow mentioned future plans to take on other naming opportunities at Horace Mann and Beverly High.

"I will continue to make my efforts, and they will be public and I'm okay with that," Libow said. "I think [The Foundation] is certainly a known entity in the community and I really do feel that if somebody wants to donate, they can find a way. Let's assume that they raised [naming opportunity donations] from \$30,000 to \$100,000, do you really think that will really generate more people to donate? I do not. There is a point where you can make it so elusive that it is exclusionary."

Prang holds razor-thin lead in race for Assessor By Nancy Yeang

In the November 4 election, 33rd Congressional District candidate Ted Lieu (D-Torrance), 26th State Senate District candidate Ben Allen (D-Santa Monica) and LA Supervisor candidate Sheila Kuehl (D-Santa Monica) were elected. LA County Assessor candidate Jeffrey Prang holds a slim lead as of press time.

Lieu received 58.37 percent, 79,708 votes, with Republican opponent Elan Carr receiving 41.63 percent, 56,854 votes.

Allen received 60.78 percent, 92,391 votes, with his opponent Sandra Fluke receiving 39.22 percent, 59,627 votes.

Kuehl received 52.78 percent, 114,348 votes, with opponent Bobby Shriver receiving 47.22 percent, 102,319 votes.

"I want to thank all of my supporters for their unwavering faith and encouragement over the course of this campaign," Kuehl said in an e-mail to the Weekly. "I am honored to have been chosen by the voters of the Third District to represent them on the Board of Supervisors. I look forward to beginning the important work of tackling the many issues facing the County.'

In the closest race with local connections, Prang received 50.52 percent, 442,253 votes, and his opponent John Morris received 49.48 percent, 433,417 votes, in a countywide race.

"It's always good to be ahead and we are

very encouraged by the lead that we have," Prang's Campaign Manager Steven Afriat said. "We expect that the provisional ballots will widen our lead based on our strong showing with the early absentee ballots. Councilmember Prang is looking forward to being sworn in as the next assessor and continuing his work to reform and modernize that

Prang has until Thursday at the close of the business day to resign as West Hollywood Councilmember in order for his council seat to be consolidated with the March 3 municipal election.

In the event that he doesn't resign by Thursday, a special elec- Source: lawde.and tion would have to be held for his seat, which would cost the City of West Hollywood approximately \$100,000.

In the only televised debate between the Assessor candidates, moderated by Beverly Hills Weekly Publisher Josh Gross, Morris stressed his outsider status running for an office that has been tarred with scandal in the wake of former Assessor John Noguez's indictment. Prang emphasized his endorsements from many prominent

The next vote count will be announced by the County Registrar of Voters on November 7. An estimated 114,229 provisional ballots, 119,862 vote by mail ballots received at the polls, and 10,656 election day vote by mail ballots still need to be processed countywide.

There was a 25.25 percent voter turnout countywide, with 1,147,248 ballots cast, 325,421 voting by absentee.

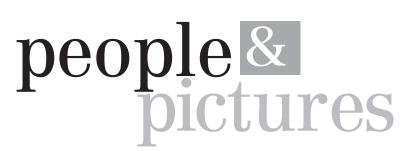
The Centaurs employ a run-oriented offense with multiple sets, Beverly Hills coach Charlie Stansbury said.

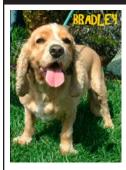
