"What's in a Name? Some question whether BHUSD's naming policy is being administered effectively" [Issue #788]

I have received and read Michael Libow's e-mail drafted to a plethora of recipients. His position and allegations are both shameful and disgraceful.

Facts do not lie. The facts are that Mr. Libow paid \$35,000 for a sprawling naming of the main quad of El Rodeo, which is a permanent fixture. The price at El Rodeo for the computer lab, hidden up on the second floor is \$50,000. Then the kindergarten playground is priced at \$150,000, despite it being in a location vastly inferior in visibility to the main quad of the school. So the most prime area was given to Mr. Libow at 80 percent less than the price of the playground? And speaking of \$150,000 kindergarten play areas, funny how Mr. Libow landed the Hawthorne kindergarten playground for just \$21,000, not \$150,000. The sum of \$21,000 doesn't even get you a classroom at the end of the hall on the third floor! amount. So someone at The Foundation or the Board of Education needs to explain to the people of this city how this came about. Now I realize that Mr. Libow repeatedly suggests in his email that I am ignorant, but even through the ignorant label he has bestowed upon me, I was able to figure out standard math and unusual circumstances.

Please understand that I am beyond appreciative to people who donate to the school and I am very appreciative of Mr. Libow's desire to donate at all. However, the act of philanthropy cannot demand a reward so greatly disproportionate to that which has been donated and cannot result in the donor receiving a lifetime applause totally inconsistent with the very published naming benefits released by The Foundation. The fact that Mr. Libow still remains comfortable with his prize in relation to his donation, especially in light of the factual revelation that the El Rodeo quad naming was given away for such an inequitable amount, surprises me. He is free to do as he wishes. I guess we will wait and see.

Finally, Mr. Libow's allegation that homophobia was behind my criticism of the naming, is both outrageous and irresponsible. I suppose, however, that in these times, throwing out the homophobia card has become a common tool to make everyone stand down and drop everything. It seems to scare everyone. If Mr. Libow, as he made a point to write, suffered bullying as a child at the hands of terrible people who taunted him over his weight and sexual preference, then he was indeed wronged by others. However, none of that has anything whatsoever to do with the facts presented here.

I'm disappointed by the one-sided coverage *Beverly Hills Weekly* displayed in its article on the Michael J. Libow naming at El Rodeo this week. The digital and print editions of the paper ran a photo and gave valuable inches of column space to a community member who is not an elected official, nor a member of the board entrusted with naming policies. Mr. Halfon is blissfully ignorant as to the difficulties facing our public schools' fundraising organizations, as well as unaware of the ways in which donations are serviced and of the naming policies, themselves.

Where are the voices of the knowledgeable others, who were available for comment and who, when asked, put comments on the record? Others who hold publicly elected offices and board positions in the district and the Foundation. Others who serve as district officials and volunteers. Others who invest their passion, time and efforts in the quest for increased funding for our public schools, rather than those who toss snide verbal Molotov cocktails from the sideline, safely after the fact of the donations given. Others who, when given the choice between philanthropy and criticism, choose to always give the former and eschew the latter.

Any who claim that they didn't know of existing philanthropic naming opportunities is being disingenuous. Or, perhaps, they don't read our community's newspapers - which cover every school site ribbon-cutting and naming ceremony. Or, perhaps they don't enter the five campuses, each of which has several "named" rooms, buildings, halls, and other spaces.

I, and many others, question the motives of those who criticize the generous donors who have chosen to give to our schools whether in naming opportunities, targeted giving, or in any other board-approved manner. At this moment, I'm aware of no significant wave of negative reaction to the recent Libow naming at El Rodeo. There is no outcry from elected officials, BHUSD officers, or fellow philanthropists whose names have become forever associated in our district with our children's education: names like Bosse, Nazarian, Konheim, Salter, Cherney and Nickoll to point out only a few.

Beverly Hills Weekly chose to ignore the voices of generous fellow givers, of the alltoo silent majority of grateful parents and students, and of the knowledgeable insiders. (Note: the short, obtuse quote from Ronit Stone hardly reflects the respect she should be given as the President of the BHEF) Instead, the paper elevated Libow's critic (and competitor, in the world of Beverly Hills real estate) to a seemingly level playing field, giving him "free PR" with a photo and quotes under the guise of a news story. There is no news here, other than a community member has stepped up, once again, and donated generously, under BHEF, district, and board guidelines. And in the aftermath, as the adage says, "No good deed goes unpunished." Shall we continue to make it more and more uncomfortable to volunteer? To give? To donate?

The tiny handful of critics who have chosen to question the recent generous donation by Mr. Libow assail this as a vastly underpriced but extremely valuable marketing opportunity. I know Michael Libow. That is not, in any way, how he views his ongoing donations to our K-8's and to the high school. But to these critics, I say: "The naming policies are in place. The prices are set. If, as you state, this is such an exceptional and cheap opportunity for philanthropy (and/or self-promotion), there are multiple such opportunities waiting for your name. The Foundation's phone lines are open. I expect that we'll be hearing from you today.'

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ESTABLISH AN HISTORIC INCENTIVE PERMIT

The proposed Ordinance would amend various sections of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding Historic Preservation for the purpose of incentivizing the protection of significant historic resources by providing a permit process by which owners of locally designated historic landmark properties may request deviations from certain development standards set forth in the Beverly Hills Municipal Code. The proposed Ordinance would establish provisions for a new entitlement called the Historic Incentive Permit and would set forth the requirements and procedures for review and approval of those permits.

A resolution recommending City Council adoption of the Ordinance was previously reviewed and adopted by the Planning Commission on October 23, 2014.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City has determined that the adoption and implementation of the Ordinance will not have a significant environmental impact. The City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations, as well as Sections 15308 and 15331 because adoption of this ordinance is an action to protect and preserve historic resources.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the Council's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

PLEASE TAKE NOTICE that at its regular meeting on Tuesday, November 4, 2014, at 7:00 p.m., in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, the Council of the City of Beverly Hills adopted an ordinance entitled "Ordinance of the City of Beverly Hills amending the Beverly Hills Municipal Code development standards for single family properties in the Central Area of the city to address issues related to building scale and mass and parking." The ordinance will become effective on December 4, 2014. A summary of the ordinance, which has been prepared and published in accordance with the requirements of Government Code section 36933, follows:

Summary of Ordinance

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE DEVELOPMENT STANDARDS FOR SINGLE FAMILY PROPERTIES IN THE CENTRAL AREA OF THE CITY TO ADDRESS ISSUES RELATED TO BUILDING SCALE AND MASS PARKING.

The Ordinance amends various sections of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding development standards for single family properties in the Central Area of the City. The amendments address the following development standards:

- 1) Definitions of roof types for single family houses, including the addition of a new roof type, "Roof, Sloped with Ridgeline."
- Maximum roof plate height and maximum building height for houses in 2) the Central Area north of Santa Monica Boulevard including introduction of a maximum roof plate height, with additional roof plate height permitted if an additional front setback is provided. Additional building height may be permitted for buildings with sloped roofs with ridgelines and additional height may be permitted for buildings with other types of roofs through issuance of a Central R-1 Permit.
- 3) Maximum roof plate height and maximum building height for houses in the Central Area south of Santa Monica Boulevard, reducing the maximum building height for buildings with sloped roofs in certain areas, and increasing the building height for buildings with sloped roofs with ridgelines.
- 4) Minimum required side setbacks for houses south of Santa Monica Boulevard, extending the required nine-foot (9') wide side setback the length of the property.
- 5) Permissible encroachments in front yards to prohibit lightwells in front vards.
- 6) Permissible encroachments in side yards or street side yards to allow decks located at grade, covering portions of driveway ramps that lead directly to subterranean parking for residences; to permit mechanical equipment in side yards if certain criteria are met; to require porte cocheres to be set back from the front setback line; to prohibit lightwells in side yards; and, to permit lightwells in street side yards if screened.
- 7) Parking standards for new houses or for bedrooms added to existing houses requiring additional parking spaces to be provided onsite.
- 8) Setback and landscaping standards for walls and fences located in front vards:
- Required landscaping in side yards. 9)
- 10) An additional limitation on paving in front yards of properties south of Santa Monica Boulevard.

Qualifications to run for election include being 18 years old, a citizen of the U.S., and a registered voter within the city limits at the times nomination papers are issued.

The City of Beverly Hills will hold their Municipal Election on March 3.

Land to not seek re-election; Prang has yet to resign

Assessor candidate Jeffrey Prang has yet to resign from his West Hollywood Councilmember position as of November 10.

If Prang were to win the Assessor race, he would need to resign from his seat on the West Hollywood City Council. He has until before he is sworn in as Assessor to resign.

Should Prang resign, the West Hollywood City Council would need to appoint someone to fill Prang's seat for the remainder of his term, or call a special election. Since Prang did not resign on November 9 in time to have his seat consolidated with the March election, a special election would be held on June 2 if the City Council does not appoint a temporary councilmember.

The cost of a special election to the City of West Hollywood would be approximately \$100,000 to \$150,000.

Meanwhile, West Hollywood Councilmember Abbe Land will not seek re-election in



March. Land has served on the Citv Council for 18 years, and served as the city's Mayor times. five Along with Land, West Hollywood

Mayor John

D'Amico's and Mayor pro-tempore John Heilman's seats will be up in the March 3 election according to West Hollywood City Clerk Yvonne Quarker.

Land was first elected in 1986 to fill a vacancy when Mayor Valerie Terrigno resigned after being convicted on federal charges of embezzling money from a nonprofit organization.

In 2012, Land was named executive director and CEO of Trevor Project, a non-profit organization focused on suicide prevention among LGBT young people. According to WEHOville, Land's job requires a lot of travel and attention.

Land could not be reached for comment.

EBI defaults on contract

The BHUSD's campus security program, Evidence Based, Inc. (EBI), will no longer provide services to the BHUSD campuses due to financial difficulties, the BHUSD announced on November 6.

BHPD field training officers and beat officers will be responsible for checking on the schools responding to calls for service. There will be no cost to the school district, according to Lieutenant Lincoln Hoshino.

ADL honors Waxman for 40 years of public service

The City Council approved to cover half of EBI's cost to the district for the 2014-

2015 school year on an October 21 meeting, which would have been \$440,712 of the total \$881,423.

Campus safety officers had not received a paycheck for three weeks from EBI, according to the press release.

EBI campus security officers' hourly wages were between \$25-35, based on their contract, with the majority of the officers earning \$30-\$35 an hour.

Other costs includes \$3,500-\$4,500 in equipment issued to each officer, which includes uniforms and computer and radios compatible with BHPD frequencies. Each school site has a safety officer vehicle, which are leased at \$10,000 per vehicle per year from EBI, and includes insurance, fuel, and maintenance.

The BHUSD gave a notice of termination on November 4, and according to contract stipulations, EBI would have to continue providing its services for nine days after the notice.

On November 5 at approximately 10:30 am, EBI informed its officers that the termination was effective immediately, and vacated the campuses the same day.

"Due to EBI's termination of the campus officers, the officers are currently without the necessary insurances required to perform services on the District's campuses," the press release stated. "The District and former EBI Supervisor Joe Chirillo are feverishly working to find the necessary elements to affect a rapid solution."

EBI's contract was to expire in May 2015,

when it would go out for a competitive bid. Originally, EBI's contract was not selected out of a bid process.

EBI's Campus Safety Program Vice President Joe Chirillo, a retired BHPD Lieutenant, did not return phone calls from the *Weekly*.

Cole to serve seven years in a Missouri prison



J u d g e D a n i e l Pelikan sentenced Former Mamtek CEO Bruce Cole to seven years in a Missouri prison on November 10 for two counts of securities fraud and one

count of theft

in the case relating to the failed sucralose operations, Mamtek.

According to the Columbia Daily Tribune, Cole's defense against the charges was that he took "bad advice."

"I don't buy your argument that you have just taken bad advice," Pelikan said. "I don't buy it, and I am not going to fall for it."

Cole pled guilty in September and accepted a term of five to seven years. Prior to pleading guilty, Cole was facing up to 55 years in prison.

Assistant Attorney General David Hansen said that Cole has yet to take responsibility for his acts, according to the Tribune. Cole has been allowed to live in California with an electronic monitoring device since March 2013. Hansen said that Cole has not paid the \$9,000 bill for the service.

Cole was arrested in September 2012 in Dana Point in connection to a failed artificial sweetener business deal between Mamtek and the City of Moberly, Missouri involving a \$39 million bond. An additional \$8 million in funding came from private investors, and another \$500,000 in grants and services from Moberly. The Weekly covered the charges in issue #677's cover story. Further investigations by the Attorney General's Office and Randolph County Prosecuting Attorney Mike Fusselman showed that Cole used more than \$700,000 in Mamtek funds for his own use, including \$281,046 to stop the foreclosure of his Beverly Hills home. Investigators determined that Cole knowingly made false promises of bringing over 600 jobs to the city of 14,000 residents.

"Cole lied to the people of Moberly and conned investors in his project in order to steal hundreds of thousands in bond money for himself," Missouri Attorney General Chris Koster said in a press release. "Today's prison sentence brings a measure of closure to the pursuit of justice for Moberly."

Beverly High Principal Carter Paysinger and former Board of Education member Steven Fenton on their recently released memoir

The subhead of the book, "the true story of an unlikely leader and an unlikely friendship," what does that mean?

CARTER: I came from South Los Angeles. At the time that I was in Los Angeles it was just called Los Angeles. Since I was a kid, it became South Central LA and now it's South Los Angeles.

As a student, coming from my neighborhood into Beverly Hills was unlikely, but it happened. Being a leader, not just attending the school or coming to work at the school, but being a leader at Beverly High is considered to be unlikely.

STEVEN: Carter and I come from different races, different religions, different economic backgrounds, but we are the same person. We share the same set of values, morals and ethics. We're teammates who have always been stronger together than apart.

CARTER: Throughout the years I've developed great relationships with many families in the city. Steven and the Fentons were one of the first families that I've established a great relationship with.

But that friendship [and] the fact that it was unlikely for me to attend school at Beverly Hills, or even work here in Beverly Hills, lends to that subtitle.

Why did you want to write the book, and why did you want to write the book together?

STEVEN: The idea for the book came from our agent, Lacy Lynch [who is a senior literary agent and TV/Film representative at Dupree/Miller & Associates.] They represent a lot of people in the inspirational space [like Tony Robbins, Maria Shriver, Joel Osteen, Dr. Phil and the late Stephen Covey] and I think that's why they responded so favorably to our story.

[Lynch] asked me if I would be interested in writing a book with Carter.

CARTER: My initial thoughts were, "I really don't have the time to do that." I really wasn't interested in it at first but then thought about it and agreed to do it.

Carter, when you first went to Beverly High you said you had "one foot in the door and one foot in the hood." Was there ever a moment in Beverly High when you felt like you could be who you are?

CARTER: I've always had a strong sense of who I am.

In Beverly Hills, I had great friendships when I was a student here. I didn't try to pretend to be wealthy or anything like that. When I was in the neighborhood that I grew up in, I felt that I had great relationships there and I was being me there as well.

The only thing was that I just kept my two worlds separate. I very rarely had my friends from my neighborhood join me and come with me to any functions in Beverly Hills and vice versa.

Tell us about how the both of you met.

STEVEN: I met Carter when I tried out for the freshman baseball team in 1985. I had heard quite a bit about him from my brother Gary who was a junior at the time. My brother used to film all the football games and was a member of the baseball team. He spoke very highly of Carter.

CARTER: I knew Steven's dad, Frank [Fenton]. He was a School Board member and I was a young teacher and coach. Frank and I had a good, pleasant relationship

When Steven was trying out for the baseball team, I noticed right away that he was the smallest kid out there trying out.

STEVEN: I think I was about 5' 1", barely 100 pounds. I had just finished playing junior varsity soccer and before that freshman football.

CARTER: But [Steven was] probably the most intense and determined kid out there and he reminded me of myself, because when I came to Beverly I was one of the smallest kids trying out for the baseball team. I knew I had to impress the coaches and everyone around, and I wanted everyone to know that I belonged on the baseball team. That's exactly what I saw in Steven. He just stood out right away.

We both played the same position. He was a second baseman and I was a second baseman. He could play and I felt like I could play, but because of our size and not know-

ing anyone, I thought it was important for me to really show what I could do and I got that same feeling all over again watching Steven.

Steven, did you make a point to introduce yourself so directly to Carter since you've heard about him before?

STEVEN: I did. I went up and introduced myself to him right away at the beginning of tryouts.

I had the great fortune as having Carter as my coach all four years at Beverly.

What about when the both of you reunited?

STEVEN: Right out of college, I started my career in the mailroom of the William Morris Agency. I led a very

fast life in the entertainment industry. The faster I ran the further away Carter became. I didn't realize back then how destabilizing that was for me.

For many years in my 20s and into my 30s, I would go over to Beverly [High]. That was my safe haven, that baseball field. When no one was around, I would lie down at my position at second base. Looking for a sign, looking for strength, trying to reconnect again to my former life.

I was in a very bad place in my life during my mid 30s. Like so many nights in the past I drove to Beverly [High]. I got out of my car and the door to the Konheim athletic building

CARTER: Close to 20 years after [Steven] graduated, [the football team and I] we were out in the football field [and] we were coming into the locker room.

STEVEN: All of a sudden I started to hear the clicking and clacking of cleats. I lifted my head up and there were two kids in a

> football uniform walking towards me. The kids suddenly turned to the right to go into the team locker room.

> CARTER: Then that hallway that leads into the locker room I was just kind of standing there, and I saw this guy walking toward me. [He] looked like he could have been a parent, but the closer he got to me I recognized immediately who he was.

> STEVEN: Carter appeared from behind [the kids]. There he was right in front of me. It turns out it was halftime of a football game. I looked at Carter and Carter looked at me. I put my arms around him and gave him what felt like the hug of a lifetime.

CARTER: I was just excited to see [Steven]. He was one of my

favorite students. It was like we hadn't lost touch at all, like nothing had ever changed.

Carter, in the book you wrote, "There would be times I would be judged by my appearance and not the content of my character. Sometimes it would be subtle and easy to forget – like hearing the click of a car door locking as I walk by – and sometimes it would be more difficult to shrug off." Do you still feel the same way?

CARTER: Not as much, but it still happens and not just in Beverly Hills. I was raised to feel that these types of issues are not my issues, not my problem. I just happen to be who I am.

You refer to what your mom told you, "It's not enough for you to be as good as everybody else, you have to be better than them," several times throughout the book.

CARTER: My parents really followed Martin Luther King Jr. and that was one of the things that they would preach: "Be the best that you could possibly be." My mom and dad instilled that philosophy into our entire family. It's not good enough to be good. You have to be better than the person that you're competing against, regardless of what it's for.

In fact, I can hear her still saying, "Whatever it is you choose to do, you be the absolute best at it."

You just strive to be the best at it. I spent

most of my younger life playing sports, and it just fed right into that culture.

In the book you wrote, "We're working our butts off because our work is important. But what if Beverly isn't the same school anymore? What if it's turning into something else altogether?" In what ways did Beverly High change?

STEVEN: During those days it was very difficult for people to get promoted from within. I don't think they put a premium on continuity, hard work or loyalty.

CARTER: Over a 15-year period, we had a huge turnover in leadership. Superintendents were coming and going, district office personnel were coming and going, and then some of my mentors were leaving and that was really concerning to me. Ben Bushman, Chuck Kloes, Dick Douglas - they were all retiring or seeking other employment.

These were guys that I looked up to when I was a student here, and they were teachers. Then [I came] back to work with them and they became my mentors. After a while, I'm seeing these guys leave one at a time. Leaving because of the change in the direction, the change in leadership. I wasn't sure what the district's goals were anymore. I thought, "Well how much longer should I stay before I leave?"

That's when I paid more attention to what was going on and I needed to look at all of my options at the time.

STEVEN: There was very little continuity left in the school district. The institutional knowledge was eroding quickly.

Why do you think that this was happening?

CARTER: At the time, I was told there was a philosophy of doing away with the old and starting new. I don't think anyone

Belk and Snowden release joint video statement on internal investigation results

Police Chief David Snowden and television producer Charles Belk released a joint video statement on November 4 on internal investigation results after the producer was mistakenly arrested in August.

"Out department has conducted an internal review of the events surrounding Mr. Belk's arrest and identified areas that could and should have been handled differently," Snowden said.

Brianna Klouste was arrested by the BHPD at the Citbank on Wilshire on August 22. She was wanted by the FBI and LAPD for a series of bank robberies that took place in the course of over two years.

Belk was in the area of the bank robbery and was misidentified by a witness.

"Further investigation ultimately determined that the second subject in the bank was not involved in the robbery," according to a statement released by Snowden. "This subject was an irate customer whose actions were misinterpreted by the witness."

"The errors or shortcomings identified are all foundational principles of good basic police work both at the field officer level and the investigator level," the statement said. AN ORDINANCE OF THE CITY OF **BEVERLY HILLSAMENDING THE BEVERLY** HILLS MUNICIPAL CODE TO INCREASE THE CAMPAIGN CONTRIBUTION LIMIT FOR CANDIDATES WHO ACCEPT THE VOLUNTARY EXPENDITURE LIMIT FOR CITY ELECTIONS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. In order to increase the contribution limits for candidates who accept voluntary spending limits, from four hundred dollars \$400 to \$450, the City Council hereby amends and restates paragraph A of Section 1-8-3 ("CONTRIUBITON LIMITATIONS") of Chapter 8 ("CITY ELECTION CONTRIBUTION CAMPAIGNS; LIMITS VOLUNTARY EXPENDITURE LIMIT AND DISCLOSURE REQUIREMENTS") of Title 1 "GENERAL PROVISIONS") of the Beverly Hills Municipal Code to read as follows:

"1-8-3: CONTRIBUTION LIMITATIONS:

A. Limits On Contributions By Persons And Committees

1. Except as provided in this section and section 1-8-4 of this chapter, no person or committee shall make to any candidate, including the controlled committee of such candidate, a contribution in excess of one hundred twenty five dollars (\$125.00) for any single election at which the candidate is attempting to be, or is, on the ballot. Additionally, no candidate or candidate's controlled committee shall solicit or accept any contribution that will cause the amount contributed by the contributor to the candidate or the candidate's controlled committee to exceed one hundred twenty five dollars (\$125.00) for any single election at which the candidate is attempting to be, or is, on the ballot.

2. Notwithstanding subsection A1 of this section, if a candidate accepts the voluntary expenditure ceiling established by section 1-8-4 of this chapter, no person or committee shall make to any such candidate, including the controlled committee of such candidate, a contribution in excess of four hundred fifty dollars (\$450.00) for any single election at which the candidate is attempting to be, or is, on the ballot. Additionally, no candidate or candidate's controlled committee shall solicit or accept any contribution that will cause the amount contributed by the contributor to the candidate or the candidate's controlled committee to exceed four hundred fifty dollars (\$450.00) for any single election at which the candidate is attempting to be, or is, on the ballot,

3. The city council may, by resolution, adjust the contribution limit established in this subsection A in October of every even numbered year to reflect any increase or decrease in the California consumer price index since the last such adjustment of the contribution limit. Such adjustments shall be rounded to the nearest ten dollar (\$10.00) amount.

4. The limitations of this subsection A shall not apply to contributions of a candidate's personal funds to his or her controlled campaign committee on behalf of his or her own candidacy, and shall apply to contributions from the candidate's spouse.

Section 2. Severability. If any sec-tion, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Effective Date. This Section 4. Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
