Goldstein and Talei have yet to file papers; Council election to be cancelled?

Jacob Goldstein and Michael Talei, who have both pulled papers to run for City Council, have both yet to file as of press time. Talei previously ran unsuccessfully in the 2013 election and Goldstein previously ran unsuccessfully in the 2005 election.

The deadline to submit nomination papers is December 5 before 5:00 pm.

Mayor Lili Bosse and Vice Mayor Julian Gold have filed re-election papers to run for City Council in the March 10 election. Since both Bosse and Gold have filed papers, there will be no five day extension period.

The 1999 City Council race was cancelled due to a lack of candidates. The 2005 Board of Education race was also cancelled.

Five taxicab companies to service Beverly Hills

The City Council approved five taxicab companies to service the City of Beverly Hills with a 4-1 vote at Tuesday's meeting. Vice Mayor Julian Gold dissented.

work that the staff did and certainly that the panel did is amazing and very reflective of that process. It was objective and at the end of the day it came out with an answer. Very different people, very different backgrounds, very different perspectives and yet a consensus recommendation."

The taxicab franchise agreement allows the city to implement a penalty structure to ensure high quality taxi services, that the companies are meeting the city's performance standards, and will work in cooperation with the city to maintain their permits.

"There were serious quality issues and they got better when the process started because they wanted to make sure that they stayed in the game when we got here to tonight," Councilmember Willie Brien said

A Citizen's Commission consisting of community members ranked taxicab companies according to various standards that involved safe, reliable and prompt taxi services. Out of the five possible taxicab companies, four were recommended: Bell Cab Company, Beverly Hills Transit Cooperative, Independent Taxi Owners Association and United Independent Taxi. The fifth taxi company, LA Checker Cab, was not selected by the panel.

Harvey Englander, who is a managing partner in the public relations firm

Englander, Knabe & Allen and represents LA Checker Cab, pointed out that the City Council was not provided with all five reports, and that the staff report did not provide an "apples to apples comparisons of all five proposals."

"The problem is we don't have all five reports," Englander said. "The system used to make this decision does not reflect best practices in public sector procurement"

Englander said LA Checker Cab's report shows that the company has the most extensive three week training program, is one of two companies that offered weekly inspection, and provides the highest percentage of clean air vehicles.

"It's not just a process issue," Englander said. "It's an issue of driver training, driver safety, vehicle safety, and passenger safety."

In addition to adding LA Checker Cab as the fifth taxi company to the franchise agreement, there will be ongoing analysis and review to ensure the companies are meeting performance and behavior expectations set by the agreement. Depending on the reviews, each cab company may have an increase or decrease in the amount of vehicles they service in Beverly Hills.

"We have the ability now [that] if a taxi company is not providing what we're asking for our seniors or our residents there are remedies," Mayor Lili Bosse said.

The Beverly Hills Police Department detained two bank robbery suspects, one who was shot in the Luxe Hotel lobby, on December 1.

At about 4:00 pm, the BHPD received a phone call of a bank robbery at the Bank of America located at South Santa Monica and North Beverly Drive, where two bank robbery suspects fled the location, according Sergeant Max Subin. Witnesses on the scene notified the BHPD of a bank robbery suspect who was in the immediate

area; Henry Shark, 36, who is a homeless black male. Shark was detained and arrested.

Approximately 20 minutes after the bank robbery occurred, the BHPD were receiving GPS pings from the money that was handed to the robbery suspects in the 300 block of North Rodeo Drive, according to Subin.

The BHPD had a description of the second suspect; a white male, Joseph Ralph, 29, of Beverly Hills. A BHPD officer entered the Luxe Hotel and told Ralph to stop, and then shot Ralph. A weapon

The Planning Commission of the City of Beverly Hills, at a REGULAR meeting on **Thursday**, **December 11**, **2014**, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider the following:

PROJECT DESCRIPTION

The proposed project involves the construction of a single-family residence on a currently vacant lot at 1184-1193 Loma Linda Drive in the Hillside Area of the City. The residence would include two stories and a basement, have a total floor area of 23,632 square feet, and have a height of 28 feet. The project would also include pools, a cantilevered deck, retaining walls, and water features. The proposed project would be located toward the center of the existing level pad on the northern portion of the site. The project would also include amending the City's Streets Master Plan to vacate portions of Loma Linda Drive and an intersecting, unpaved alley, and dedication of a new vehicle turnaround to replace the portion of the street proposed for vacation. Approval of the project requires approval of the following entitlements:

- Hillside R-1 Permit to allow cumulative floor area in excess of 15,000 square feet, and for export of earth material in excess of 3,000 cubic yards (approximately 8,000 cubic yards of earth material are proposed to be exported);
- Amendment of the City's Streets Master Plan for a street vacation, alley vacation, and street dedication; and
- Tree Removal Permit to remove 1 protected tree.

ENVIRONMENTAL REVIEW

This project is being assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City prepared an Initial Study to determine the proposed project's potential impact on the environment. After reviewing the Initial Study, the City has determined that this project may have a significant effect on the environment, but by implementing certain mitigation measures, the project's potentially significant effects could be reduced to less than significant levels. Accordingly, a Mitigated Negative Declaration (MND) was prepared. The MND was circulated for a 20-day public review period, from October 1, 2014 to October 20, 2014. During the public review period, a public hearing was held on October 9, 2014 regarding the draft MND, and written and verbal comments concerning the document were submitted. Comments were also submitted directly to staff during the comment period. Comments and responses are outlined in the Response to Comments section of the final draft of the MND.

The following summary of the above-entitled Ordinance of the City of Beverly Hills has been prepared and published pursuant to Government Code Section 36933.

Summary of Ordinance

This Ordinance amends Chapter 4 ("Public Transportation Vehicles") of Title 7 ("Traffic, Parking, and Public Transportation") of the Beverly Hills Municipal Code ("Code") in order to implement a taxi franchise system in the City. Currently, the Code provides for regulation of taxis in the City through the issuance of Certificates of Public Convenience and Necessity. The Ordinance will remove the Certificate system and require that no person, corporation or membership organization can operate a taxicab service without a franchise granted by the City, which shall be awarded through a competitive process. The Ordinance provides for a franchise term of five-years, with five additional one-year extensions, for a total term of up to 10 years. Franchisees shall enter into a franchise agreement, pay the associated fees, including an annual franchise fee, and be subject to annual evaluations. The Ordinance further provides that the Director of Public Works Services will promulgate rules and regulations related to the implementation and enforcement of the taxi franchise system.

- 6. Redrafts Landmark and Historic District Designation Criteria (§§10-3-3212; 3213);
- 7. Revises Landmark and Historic District Designation Proceedings (§10-3-3215);
- 8. Clarifies procedures for temporary protections and permit issuance on properties while designation proceedings are pending (§10-3-3217);
- 9. Adjusts the hold period on permits to alter buildings older than 45 years (§10-3-3218);
- 10. Refines Certificate of Appropriateness procedures (§10-3-3219);
- 11. Revises Certificate of Economic Hardship findings and procedures (§10-3-3220);
- 12. Replaces the Director's Determination of Ineligibility process (§10-3-3204) with a new Certificate of Exemption Process (§10-3-3221):
- 13. Inserts a section to enable designated historic properties the ability to apply for inclusion into the City's In Lieu Parking Program (§10-3-3228);
- 14. Institutes timeframes within which applications must be processed and acted upon:
- 15. Integrates the Historic Incentive Permit into the Ordinance
- 16. Additional minor text changes.

was found on Ralph, and he was taken to a local hospital where he underwent surgery. Detectives spoke with Ralph at the hospital. No pedestrians or civilians were harmed in the shooting.

"Preliminary, we don't release the names [in officer involved shootings]," Subin said.

Why the officer shot Ralph is currently under investigation by the BHPD.

Measure E bond acceleration won't appear on March ballot

The Board of Education has decided to not put the Measure E bond acceleration to a vote on the March 2015 ballot, according to Board of Education President Noah Margo. The deadline for any measure to appear on the March ballot is December 5.

"When the board has made an official decision the public will be informed immediately via district emails, press releases and news stories," said Margo.

Approved in 2008, the Measure E bond has yet to be fully distributed to the district, and may not be issued in time to finish the proposed construction activity. The acceleration would expedite the issuance of the bond and lower the overall cost for taxpayers.

"We are hoping to have this discussion in January and finalize a decision regarding any future election related to the bond," said Margo.

Cultural Heritage Commission reviews Historic Preservation Ordinance

The Cultural Heritage Commission met on November 24 to review the proposed amendments to the Beverly Hills Historic Preservation Ordinance, as presented by Planning Commissioner Craig Corman. The meeting was a continuation of an earlier meeting on November 17.

"The real idea was to create some kind of objective standard beyond the subjective standard which was in existence beforehand," said Corman, who produced the initial draft of the ordinance in consultation with Planning Commission Chair Howard Fisher. "I understand that in the preservation community these are not definitions that are typically used and I think that's fine. Because the real question isn't whether they're typically used—the question is whether they're appropriate and good for the city."

Both Vice Chair Lisa Greer and Commissioner Rebecca Pynoos expressed concern that Corman's draft detracts from Beverly Hills' history.

"I feel like that's the message we're getting through," said Greer, "that things that are important in Beverly Hills—unless they're important to the rest of the country—aren't important."

They highlighted Corman's definitions for "master architect," "iconic property," and "person of great importance" to bolster their opinions.

Master architect was previously defined as an architect of recognized greatness in the field of architecture who is included on this list of such architects compiled by the Cultural Heritage Commission, and updated from time to time.

The new proposed definition states that a master architect shall have won a major architectural award, or his/her work shall have been either the subject of a published monograph on his/her career or substantively discussed and photographically depicted in at least three published scholarly works written by experts in the architectural field.

"I don't think it does the city any service to define [master architect] in such a stringent way," said Pynoos. "To me it seems like it's rooted in opinion and not based on any professional standards."

The original Historic Preservation Ordinance, adopted in 2012, did not include definitions for "Iconic Property" and "Person of Great Importance." The amended version defines Iconic Property as a property that has been visited and photographed so often by residents and visitors to the city that it has become inextricably associated with Beverly Hills and forms part of the city's identity to the world at large.

Person of Great Importance is defined as a person whose activities had a substantial impact on the history of the nation, which impact can be demonstrated through scholarly research and judgment. At a minimum, a person of great importance is someone whose name and exploits were widely known across America during his/her lifetime, and whose widespread fame continues through to the present day. A person shall not be considered to be of great importance by virtue of his/her position or title, race, gender, ethnicity, or religion, or by virtue of his/her activities within the entertainment industry.


Chair Maralee Beck emphasized that the proposed ordinance is a "living, breathing document" that will undergo revisions and modifications.

Commission members also discussed time frames for processing historic reports and preliminary assessments. Beck and Commissioner Richard Waldow voiced concern that the proposed time limitations will not allow applicants and property owners to gather enough information to accurately complete reports.

Commissioner Noah Furie stated that although the current ordinance is a departure from what he helped develop over three years ago with Commissioners Corman and Brian Rosenstein, he generally supports the current edition, believing that it will help the program rather than be a detriment.

The Cultural Heritage Commission's suggested modifications will be addressed during the Planning Commission meeting on December 11. --Mina Riazi

COVERSTORY NEWNAN ON THE NETWORK

Beverly High graduate Gary Newman discusses taking the helm at Fox Television Group

How has the transition been like so far in your new position as Chairman-CEO of 20th Century Fox TV?

It's been about four months and it's been an exciting transition. At first, the initial responsibilities were overwhelming just trying to manage our time. There were so many new issues that [Chairman-CEO Dana Walden and I] had to deal with that we didn't have to deal with before; getting up to speed with a lot of programming that the network has [and] that the studio [has] that we knew nothing about, new people to get to know, there's an entire digital emphasis with the network, there is non-linear transmission of our programs that we certainly need to get our arms around a strategy there to make sure that we are approaching it in a smart way.

We were getting up to speed and understanding issues so that we can guide people. Now that it's been four months, we feel pretty integrated with the issues. We feel as if we've gotten much more efficient in terms of dividing our means between us.

It's fantastic at this stage of my career to have new challenges, to learn new things, to have new problems and issues to deal with [and] new people to get to know. It's been a great four months of work.

What are some of the differences between running the studio and now running both the studio and the network?

I think that the big change is supervising both the studio and the network. We're able to look at our business much more holistically. The studio is charged with responsibilities of creating the content. The network is charged with the responsibility of the launch platform to give these shows awareness with the public [and] to drive the audience to it. Then, once that happen, the studio has the opportunity to look to ancillary markets to create revenue opportunities [to] make, hopefully, big access out of these shows.

When you're only doing one thing or the other, you're really only seeing half of the equation. It's really great to look at it over both the network and the studio. I have far greater appreciation of what FOX needs [and] how to guide and direct our studio and the writers who work there to create programs that can be meaningful for the network.

Conversely, I see shows that are working for the studio. When you're on the network side of things, having that awareness with studio issues may give you some sensitivity to the needs of the studio. For instance, scheduling programs in ways that can be successful. It really gives you a chance to be efficient and to see things from both sides.

How did you start working at 20th Century Fox TV?

I grew up about a mile from the [20th Century Fox TV] lot from [the] fourth grade on. I grew up in South Beverly Hills, so I [have] always been aware of Fox. The first time I visited the lot, I was still a teenager. My dad's cousin, [who at the time was vice chairman of NBC, Irwin Segelstein,] got me a drive-on pass. I drove out here and I remember driving over to the set of M*A*S*H when it was in production many, many years ago.

I went off to college and law school, practiced law for a while and ultimately decided that I wanted to be in the entertainment industry

I was a young, junior business affairs executive [at NBC] and I probably worked there [for] five, six years and began to work my way up the ladder there. I got a phone call from an ex-colleague of mine, [Larry Jones] who was at FOX and [he] said, "We need someone to come in here and run business of legal affairs for the studio." I came over, interviewed, [and] got the job. I joined Fox in 1990 to run those areas. I think when I left [NBC] I was vice president of business affairs, the number two person in the department, but I got a chance to come over to Fox and run a department.

It's been a fantastic experience. It kept me close to where I grew up in Beverly Hills, to my parents who remained in Beverly Hills for all these years, to Beverly High where I attended [and] my brother, [Jason Newman] taught [P.E.] for many years. I always felt very connected. It's been great to be working in this part of town that feels so much like home to me.

What brought about the change in leadership structure?

Kevin Riley, who used to be chairman of

the network, decided to part ways with the company so the job was available. We would not have sought it out otherwise.

Dana and I came to the realization that having an independent studio, which had been such a successful thing for us for the last 15 years, was no longer as opportunistic as a strategy as it had been. More and more networks, both broadcast and cable, were interested in owning the content so they were less willing buyers of the studio. At the FOX network, we found that the executives over there were really interested in trying to create their own production unit so that they could own content and be closer to the content.

We thought that it would be best for the studio if it became aligned with the network so that we could create a much more streamlined pathway to get shows developed in the studio and ultimately broadcasted on the network.

Conversely we've worked at this company for a long time. I've been here for 24 years, my partner Dana has been here for 21 years. We care deeply about this company and the broadcast network FBC was really struggling. It had become the fourth placed network. It was no longer a great network to launch programs on.

We felt that it could be turned around and we saw that it's the kind of challenge we wanted to take on. We decided to meet with our bosses and suggest that they realign the company so that we could supervise not only the studio but also the network. Fortunately they agreed, they saw the logic of what we were talking about and went right along with it.

In what ways have the network and the studio worked well together under the new structure?

The new structure is called Fox Television Group. So far, all that we've been able to do over the last four months is start developing next year's programs. During development season, things ran much smother between the studio and network, there was far greater communication, [and] there was far greater transparency instead of that sibling rivalry between two divisions in the same company.

We've been preaching to our teams that the biggest success that any of us can have is a successful show developed by the studio that ends up airing and working on FOX. The studio is going to continue to sell shows to other networks; it's very lucrative to do so. The network is going to continue to be in business with other studios, because other studios also have talent that we very much want on our air.

The big win will be when we can broadcast

shows that we own, because as I've said earlier, it gives you an opportunity to holistically support those shows to have what you do on the network benefit what you do from the studio and the ancillary markets.

We're early in the development stage. We're just beginning to get scripts in now but we set up many very promising projects that work from the studio and we're hopeful that that's going to bode well for us as we get into pilot season and ultimately order shows for next year

What are some of the series featured in this season?

The most successful show we've had this year is *Gotham*, which we licensed from Warner Bros. We're very happy with the way it's been performing. It's rare to see a new show lead off the night at 8:00 and generate an audience. We thought with the awareness of the title in the Batman world that the show would be strong enough to do it and thankfully it was. We've had another show on the air, *Red Band [Society]*, which we have a very passionate fan base for. They're watching the show on air, Hulu and other platforms. We're hoping that show will grow the numbers.

What other types of series are you looking to bring into the network?

We've learned long ago being at the studio that you shouldn't close yourself off and limit yourself to anything in particular. We want diverse programs. We want dramas. We like big, serialized dramas which the studio is pretty famous for, 24, Homeland, [and] Sons of Anarchy, to series that deal more episodic in nature, like Bones, which our studio has produced for 10 seasons now. On the comedy side, we're interested in the old-fashioned, multi-camera series that do so well, like Big Bang Theory and How I Met Your Mother that we produced for CBS, to single camera comedies [like] Modern Family, which is one we do. We're open for more animation. We certainly have a monopoly on animation. All those Sunday night animated series on Fox are produced by the studio.

We're also very excited to work in the unscripted, reality space. We haven't done a lot of that in the studio and we're having a lot of fun working with our "alternative department." They bring in pitches, develop ideas for new shows. We had a big one on this fall called *Utopia*, which sadly didn't catch on, but we have *American Idol* coming up in the winter. We have several Gordon Ramsey shows on from *MasterChef Junior to Hell's Kitchen* to the regular *MasterChef* and we're looking to have additional reality shows that can play both the summer and throughout the broadcasting.

You were inducted into Beverly High's Athletic Alumni Hall of Fame in 2007. You told the *Weekly* in the cover story issue #415 that sports changed your life. Tell us about that.

I think so much of the values that I bring to working in a corporate environment [and] in a team environment were things growing up playing team sports. I'm a pretty big believer in, it isn't about individual achievement; it's about the achievement of the group. You've got to create an environment where different

people have the opportunity to contribute. You need to value everyone's contribution, whether you're the head of the company and you're getting all the attention or you're one of the junior guys in the company doing a lot of the hard, time-consuming grunt work. Everyone's contribution is important. If you don't keep everyone motivated and feeling appreciated then it's pretty easy for the company to crumble.

I really try to act as a coach. I try to be a good leader [and] realize that this company existed long before I got here [and] it will exist long before I'm gone. It's a privilege to do this job and you're really only as good as the team who surrounds you. We have a very close-knit team here at the studio where Dana and I [have] run for 15 years. We try to develop that same culture [in the] network. We've known many of the people for a long time, but we haven't worked together the way we are now until this summer. Our hope is to create the same tight-knit culture at the network.

You also mentioned that you "learned a lot about not being afraid of challenges and a very close bond was cemented taking on the neighborhood challenges between you and your brother, longtime Beverly High coach who recently retired, Jason Newman.

My earliest memories are my older brother dragging me outside to play sports to have adventures with the other kids on our street.

Jason was an amazing athlete and really pushed me and helped me develop my interest in skills in sports and he was very coordinated. He was so physically mature and gifted at a very young age. I was a little bit of a slower developer so at times it was a little painful because I couldn't keep up with him being three years younger. I think those challenges really helped me grow and learn the value of hard work. [To] not being discouraged by failures because in sports you're not going to win all the time. You're going to have lots of failures and you have to learn to keep your equilibrium, not get down when you fall behind nor

and jump into the midst of the game and be incredibly competitive and talented. She has lived in London for the last 15 years or so, so unfortunately we don't get to see her quite as much as we'd like.

Tell us about your family.

get too far down when you lose because you get another opportunity shortly to play again.

It's been great to grow up in a place like West Los Angeles [and] Beverly Hills and to live our lives here as well. To both come back to this area, raise our families here and be near our parents and have our kids all be friendly.

My sister, Deena Stuart, lives in London, three years younger than me, was actually the best athlete in the family. Unfortunately for her, she grew up in a time where girls' sports weren't quite as celebrated. She has so many other talents from art to dance that she didn't take sports all that seriously. But honestly, she would just walk out in front of the house

Richman, Rush & Kaller, L.L.P.] We have three children. We have boy/girl twins. Our son Jordan is finishing up his second year at Wharton Business School after having graduated from Yale undergrad and having worked at Google for about four years in between. His twin sister, who lives here in Los Angeles, is Hillary [and] attended Boston University[as an] undergrad and is working for a company called Omaze where she is Director of Social Media and is doing very well there. We have one other child, a son, Reed, and he is a junior at Cornell, majoring in environmental science.

My mom Edith, is still living in Beverly Hills at the home I was raised in, and she's been there since 1962. My dad, Ben, was there with her until May when he passed away.


What goals and plans do you have being Chairman-CEO for Fox Television Group?

Our feeling is that the way you turn around a broadcast network, you really do it one show at a time; create a successful show, use it as a launch pad for another show, slowly build a night then move on to another night. You can't replace five, six shows at one time and expect it all to work. You can't fix three, four nights at one time. Slow and steady is the way to do it.

This year, when we joined in July, our focus of our marketing campaign was *Gotham*. We saw that as being the show that had the most potential. We're thrilled with the results there. The launch of *American Idol and Empire* in January as well as a couple of other shows that we're going to be launching, *Backstrom*, and Last Man on Earth, a drama and a comedy both from our studio, are also very important launches. We're hoping we can get another hit out of at least one of those shows, if not more.

If we come out of this year having had two successful new series, we'll consider this first year an incredible success. Then we'll look to do some smart scheduling to use those shows as launch pads and next year deliver another one or two successful series.

I think ultimately we're looking to improve the ratings and the economics of the network. We're keeping our head down and we're looking at one step at a time. If we can just program some successful shows, pretty much everything else will take care of itself.

Marat Dukayev Ballet Theatre and School's Nutcracker performers

Nutcracker features Beverly High students Del Rosario and Love

The Nutcracker performances by the Marat Daukayev Ballet Theatre and School will begin this weekend, and will feature two Beverly High students, Elizabeth Del Rosario and Matisse Love, and Chloe Harris in the role of Masha.

"Every year it feels like a very different production," Marat Daukayev Ballet Theatre and School Managing Director Pamela Daukayev said. "It's the same Nutcracker and the same music, but every year it feels very different."

Marat was established in 2001 in Los Angeles by Pamela and Marat Daukayev, with approximately 400 students every year. This year marks the 14th production of The Nutcracker, and 148 students will be featured this year with ages ranging from five to 21.

"We have five different casts or principal dancers because it's our way of sharing the wealth," Daukayev said. "[It's] us giving every child who is capable of dancing the solo an opportunity to do that."

Two of the lead dancers who will be performing as the Sugar Plum Fairy are Beverly

High junior Del Rosario and sophomore Love.

"Many of [the students] have been in our school for eight or nine years," Daukayev said. "By the time they're dancing a leading role so we know their capability very well. The audition process is really just to look at one moment in time to see where everyone is and to see what more we can do."

Del Rosario has been with Merat since she was five, and Love since she was seven. Both are also featured in Getting to the Nutcracker, a documentary by Director Serene Dillman who filmed the 2012 Nutcracker from the point of view of the dancers.

"It was just amazing looking back at the film its hilarious because I was so young," Love said. "I still barely had teeth and now it's crazy how things have changed so much these past years."

Del Rosario is said that some of her favorite classes this year is her history class taught by Malia Frutschy and her chemistry class with Chris Bushee.

"They're my more challenging classes and I believe in a challenge, especially with ballet." Del Rosario said. "Ballet is a challenge because every day you're trying to make yourself better and in these classes I see ballet. I see discipline and I see a challenge for me."

Love is planning to focus on her dancing after graduating from Beverly High.

"There's always the debate whether you go to a college or go to a company," Love said. "Education matters so much to me. I would want to go to performing arts school if a company doesn't work out. I think if I do end up going to college it would be [The Julliard School]."

Del Rosario also plans to go to a dancing company. If that doesn't work out, she plans to go to a four-year college with a degree in English and possibly continue to law school.

"They have that technique of learning to look at yourself and seeing what's wrong, seeing what you need to fix, seeing what's next, seeing what needs to be corrected and being constantly self-critiquing and improving," Daukayev said. "When you learn to love the process, you love the process of improvement, which is basically learning and you can turn that to learning anything."

The Nutcracker performances will be on December 6 at 2:00 pm and 7:00 pm, December 7 at 11:30 am and 4:30 pm and December 13 at 2:00 pm. Gala performances, featuring Maria Kotchetkova and Gennadi Nedvigin from the San Francisco Ballet, will be on December 13 at 7:00 pm ad December 14 at 2:00 pm. All performances will be at the Luckman Theatre at Cal State LA.
