### **Planning Commission rejects Loma Linda project**

Planning commissioners and Beverly Hills residents voiced their concern about the proposed erection of a new single-family home at 1184-1193 Loma Linda Drive during a Planning Commission meeting on December 11. Chair Howard Fisher was the only commissioner who did not outright reject the project.

"Homeowners have substantial property rights and they should be allowed within reason to build what they believe meets their tastes and their needs," Fisher said.

The project will result in a home with two stories and a basement equaling 23,632 square feet of cumulative floor area and reaching a maximum height of 28 feet. According to Vice Chair Alan Block, the proposed home is "three times as large as the other homes."

"I think that this [project] is going to have an adverse affect on the preservation of the existing neighborhood," Block said. "I think that this project will have a substantial impact on the scale, integrity and character of the area and the privacy of the surrounding properties."

Francesco Aquilini, proprietor of the Vancouver Canucks hockey team and the project's prospective owner, attended the meeting with his attorney-former Beverly Hills Mayor Tom Levyn. Crest Real Estate's Jason Somers is the representative for 1184-1193 Loma Linda Drive.

Somers is also requesting that an amendment be made to the Streets Master Plan, which would allow portions of Loma Linda Drive and an intersecting alley to be vacated for the property owner's personal use. A portion of 1884 Loma Linda Drive would be dedicated to the city to provide a new vehicle turnaround area.

Several neighboring residents, including Glen Revivo, who lives in the adjacent property, voiced their rejection of the project.

"We oppose the project because what's being asked to make this project happen mainly the vacation of the public street for private benefit- is fundamentally wrong."

The Planning Commission unanimously agreed to continue the item to a meeting on January 22, 2015.

"I am very hopeful that we will get a version of this project at our next or following hearing that we can pass," Commissioner Brian Rosenstein said.

including several of the smaller South Bay cities. Butts will serve a four-year term.

Councilmember John Mirisch was delegated by Mayor Lili Bosse to cast the vote on behalf of Beverly Hills. Mirisch was initially going to run for the seat himself, but deferred to Butts.

"Los Angeles already has four seats on the metro board, it doesn't need a fifth," said Mirisch, who voted for the

and ends at the Palos Verdes Peninsula, Inglewood Mayor. "I think [Butts] is unafraid to address and fix the issues of disenfranchisement which a majority of the residents in the county are faced with. [Butts] is going to do a very good job, not only for the interests of his city but all of our interests."

Councilmember Willie Brien, who also attended the meeting, spoke at the meeting on behalf of O'Connor.

"[Pam] has done a great job," Brien said. "She gets input and direction from

us and I believe that she represented the interests of the entire region well. You just don't go and subvert the needs of your city—I think this is going to have a major impact going forward and I think that it was done for the wrong reasons."

Prior to running for office, Butts was Santa Monica Police Chief from 1991 to 2006.

According to Mirisch, Butts' win means that transit issues affecting Beverly Hills, such as the Westside subway extension, will be better addressed. Mirisch does not believe the city was well represented on the Metro Board during O'Connor's term representing the Westside and South Bay Cities.

"We've got to get back to basics and remember to represent the people," said Mirisch.

### **Planning**, Cultural **Heritage Commissions** clash over new ordinance

The Planning Commission voted 4-1 to move forward with the proposed amendments to the Beverly Hills Historic Preservation Ordinance during a meeting on December 11. Members of the Planning and Cultural Heritage Commissions hold conflicting views on the new ordinance.

Planning Commissioner Craig Corman made amendments to the ordinance in consultation with Planning Commission Chair Howard Fisher. The proposed amendments include a new definition for "master architect," which will reduce the current master architect list of approximately 180 architects to around 70.

"The list has not been minimized," said Fisher. "It has been focused on great architects-people who are known for having done great works." Fisher called the amended document a "vibrant ordinance for preserving the best historic architecture in Beverly Hills."

The changes also include renaming the Cultural Heritage Commission to Historic Preservation Commission. The new ordinance will limit the Cultural Heritage Commission to a maximum of four involuntary designations to landmark a property per year.

Cultural Heritage Commissioner Rebecca Pynoos attended the meeting and expressed her opposition to the sug-

#### gested changes.

"To me, [the ordinance] is not tailor made," said Pynoos. "It's really ill-fitting for our city. The definitions that are contained in it, the neglect of standards, the neglect of our city's history and also the process I find very troubling."

Rosenstein, who established the city's first-ever Historic Preservation Ordinance in collaboration with Cultural Heritage Commissioner Noah Furie in 2012, voted against the modified document.

"I support some of the changes regarding expediting the process and giving surety to property owners about whether or not their property is historic," said Rosenstein. "However, I felt some of the other changes to the ordinance were somewhat arbitrary and punitive to the Cultural Heritage Commission, taking away or limiting their responsibilities, powers and authorities."

Beverly Hills Heritage president Kimberly Reiss also spoke at the meeting.

"There are a lot of aspects of the rewritten ordinance that are good but there are some that are definitely unacceptable," Reiss said. "The ordinance as it was gives historic building the consideration of due process and the ordinance as it's been rewritten is considerably less protective."

As a next step, the ordinance will be scheduled for a public hearing before the City Council.

employee for revealing information to an agency or person that the employee reasonably believes discloses a violation of a statute, rule or regulation.

"Paysinger survived both the motion to dismiss and the anti-SLAPP motion," said criminal defense attorney Ronald Richards, who is an expert on SLAPP. "And now the school district is going to have to defend the case all the way up to trial unless they file a summary judgment motion. But based on the court's ruling on the anti-SLAPP motion it doesn't seem likely that they will also win a summary judgment motion."

Richards is not affiliated with either side in this case.

Beverly High Principal Carter Paysinger filed a lawsuit against Hall and the BHUSD on nine causes of actions including discrimination and retaliation on July 16. In opposition to the anti-SLAPP motion, Paysinger claimed that Hall violated 1102.5 by committing a number of actions, including deliberately leaking information to the Los Angeles Times and making racially discriminatory statements, in response to Paysinger complaining about Hall to the district.

"We are pleased with the Court's decision and it is exactly as expected," said Paysinger's attorney Reed Aljian. "Mr. Hall argued there is insufficient evidence that he had engaged in unlawful retaliation and racial discrimination. After reviewing over 130 pages of evidence, the Court disagreed. We look forward to presenting the entirety of our case at trial in August."

Hall argued that the Court should strike Paysinger's claim for retaliation under 1102.5 because it arises out of communicative activity protected by the anti-SLAPP statute. He also attested that Paysinger is unable to demonstrate the merit of this cause of action with evidence.

The Court engaged in a two-step inquiry outlined by the anti-SLAPP statute and the California Supreme Court. First, the Court decided whether Hall had demonstrated that the 1102.5 claim arises from acts that are protected under the anti-SLAPP statute.

The Court considered the pleadings and evidence submitted by both sides before concluding that

although some of the acts forming Paysinger's1102.5 retaliation claim against Hall are protected under the anti-SLAPP statute, the Beverly High Principal has displayed enough evidence of malice on the part of Hall to deny the anti-SLAPP motion.

"We respectfully disagree with the court's ruling," said Hall's lawyer Gary Gibeaut, who had not read the decision as of press time. "Discovery will continue on the case and the court has ordered the parties to mediate the case before a magistrate judge."

U.S. District Judge Philip S. Guitierrez denied Hall's first motion to dismiss

### Traffic and Parking Commission addresses Olympic Blvd. parking challenge

The Traffic and Parking Commission addressed a comment submitted by resident David Lewin regarding parking challenges on Olympic Boulevard for multifamily residents during a meeting on December 4. Lewin, who has a Zone C permit, resides on the 9700 block of Olympic Boulevard and must regularly move his vehicle in order to abide by the City's overnight parking ordinance. He has requested dual permits for Zone C and Zone QQ on Spalding Drive. The challenge is that a preferential permit parking zone cannot be established on Olympic Blvd. between Linden Drive and Beverly due to Olympic being a major arterial road and also having peak hour restrictions. Beverly Hills Municipal Code 7-3-205(A) Certain areas where Preferential Parking is Not Allowed states that a "street block on an arterial street" shall not be established as a preferential parking zone. Olympic Boulevard is denominated as an arterial street in the City's General Plan and Street Master Plan.

According to Commissioner Jake Manaster, many of the multifamily residents on Olympic Boulevard have not been updated in decades, making the inclusion of additional parking spaces a challenge.

"You can't expect a building that is out of code for 60 years and is nearly a hundred years old, or at least 80 years old, which is the case for some of these build*briefs cont. on page 5*

ings, to accommodate multiple vehicles," Manaster said.

Zone C was established by ordinance in 1979. In the early 1990s, the City issued Zone C permits to multifamily residents with qualifying overnight parking permits. According to the On-line Business Center (OBC) customer service database, approximately 106 Zone C permits were issued in 2010. Since then, that number has dropped to 60.

Offering a final suggestion, Manaster proposed that Lewin talk to the school district about whether or not there is available parking in their structures during certain times of the year.

"It's a difficult situation but I think the staff and the commission will continue to investigate potential solutions," said Commissioner Andy Licht.

### Public Works Commission evaluates emergency water capacity

Harvey Gobas presented findings from engineering firm Psomas' review of the City's water system capacity during a Public Works Commission meeting on December 11. The Commission had



expressed interest in understanding how the City's system capacity compares to the Metropolitan W a t e r District's (MWD) recommended emergency

storage capacity of water providers in their service area.

"Fortunately we're very, very lucky that we have not had a great catastrophic event that had to stress or test the system," said Commission Chair Ron Shalowitz. "But now that we're very clear on this information, the question is what do we do with it?"

Currently, the time required to fully deplete the emergency storage is approximately 3.5 days. This is based on the Average Daily Demand (ADD) condition and preserving operational and fire storage in the reservoirs.

If the City wants to provide enough emergency reservoir storage capacity to

meet a seven day demand during peak demand periods, then 35 MG in storage should be considered to be added to the existing system. Beverly Hills currently has 10 active reservoirs with a total nominal storage capacity of 43 MG.

"I think our task is to advise the Council rather than be advised by the Council,"

said Commissioner Barry Pressman. "So our job is to get this work done, come up with a plan and see if they agree."

The Commission will need to decide how they are going to implement the rationing, whether it's through the addition of wells or the expansion of reser*briefs cont. on page 7* 

# coverstory ERRI'S CRUSADE TV/Radio Personality Kerri Kasem discusses her fight to allow adult children to visit ailing parents

Kerri Kasem is the daughter of late radio broadcaster Casey Kasem. You and your brother Mike both attended Beverly High?

My brother Mike, my sister Julie and myself-we all attended Hawthorne. My brother and I both went to Beverly [High] for a short time, we did not graduate Beverly. We went to private schools after that.

#### Tell us about your crusade to pass AB2034, which would protect the right of children to visit ailing parents.

The bill AB2034 is dubbed the visitation bill, which Assemblyman Mike Gatto has taken on, authored, and really been a great advocate for. What it would allow a judge to do is just rule on visitation because right now there's a gap—you have to have a conservatorship or a durable power of health to actually get into the court and fight to make decisions for your loved ones and fight to see them. And that can cost upwards of \$100,000 to \$300,000 with no guarantee that you'll ever see your ailing parent again. What this bill would do is just allow a judge to rule on visitation. So, like in my case, my father said loud and clear to the court, "I want to see my children." Judge Leslie Green said, "Do you hear that? Casey wants to see his kids, now go figure it out."

"Now go figure it out" is the worst thing you can say to people who have spent six months trying to see their father because their stepmom, his wife, would not let us see him. So we've tried to figure it out, judge, we've done everything we couldit's not going to happen. My stepmother has lied to the press saying we're estranged, that we borrowed money, that we're not good kids.

So there was no ability for the judge to rule on visitation or not, even though my dad said, "I want to see my children." She could not rule on it. Instead, we had this mediation back and forth, my stepmother said if you drop your entire case and the conservatorship bid I will let you see your father, once a month, for an hour, with a guard in the room, and you are not allowed to bring a phone, camera, computer, you can sit with him one at a time—you are not allowed to all go in together.

So my sister and brother decided that they wanted to sign that. And I said, there's no way in hell I'm going to sign anything like that and Mike, Julie, Casey and Kerri Kasem

I continued to fight and I eventually won conservatorship.

So instead of going through all that mess, a judge, with AB2034, the visitation bill, would say "Hey, you know what, we think these kids deserve visitation or we don't." So at least she would be able to decide because right now she cannot adjudicate on any of that. There's nothing in the law books that allows her to.

#### How did you find Assemblymember Mike Gatto (D-Glendale) to sponsor it?

Mike Gatto's office called me and they eventually took the bill on. Gatto said that through my advocacy-I was all over radio, I was all over TV saying we've got to do something about this and he said he's going to help me. And he took the bill on. He worked with my lawyer, who's the one who won me the conservatorship, he worked with my stepfather, who's a lawyer and a lobbyist up in Sacramento. So my stepdad is my lobbyist. We really did what we could for this bill and I think it's going to be passed this year.

#### What advice do you have for other families in a similar situation?

Advice I give to people who think they might be in a situation like this or don't get along with family members or don't get along with-whether it's your mom or dad or second wife or second husband, whatever it may be—is please, get your estate plans. It may not protect you completely but at least it will get you through the door in court. And then it could be fought there.

Now this is where my bill would come in-at this point, instead of spending the hundreds of thousands of dollars going back and forth or not even getting to court because you don't have that money, you could ask a judge for visitation and explain what's going on. So, what I would do is please get your estate plan, your will, get your durable power and video tape all of it.

And then, support my bill. Get out there-

you can do what I'm doing, too. It doesn't just have to be me. Call me up, write me at www.kasemcaresfoundation.org, find me anywhere on social media. And I will get want to see my children." this bill started in your state. I'm one person She could not rule on it." and I need help. I've had many people call me and say "Hey I know this assemblymember, I know this senator" and that's

why it's in five different states. Also, donate-it's so important.

Since day one, since we were very little kids, [my stepmother] has made it very clear that we're not part of her family. Very clear. We were not invited to the wedding. in fact, there were times when we were all together-my brother, my sister, me, my father and her--and [my father] would walk out of the room, he'd walked back in, and she'd tell him that we'd done something to her. And I remember one time my father smacked my brother because of something Jean said he had done to her, and he hadn't. So this is what we're dealing with.

When I was a kid I had a sleepy toy that I slept with, it was a penguin, and he got chewed up by my dog. And we saw my dad every Friday, Saturday and Sunday; we were with my mom on the weekdays. [My stepmother] said leave him with me, I love to sew, I'll fix your penguin right up, just leave him. And it's like living my sleepy toy, my blanket, my safety blanket with her. I wanted her to like me so bad that I left it. She had thrown it to her dogs when I came back and I said, "Dad, my penguin!" The memory burned into my brain. That's what we're dealing with-I was eight years old. This has been around for a long time—this is 34 years of it. And I'm done. And justice

> is going to be served, it will be served, one way or another.

Tell us about your **Kasem Cares** foundation.

The Kasem Cares Foundation is just here to support the visitation bill and in California AB2034just to really push it so we can get into all 50 states. It's so important that children and

siblings get to see their loved ones before they die. And not everybody is going to deserve that. We know that there are bad seeds out there and there might be kids that are toxic. But for the most part, especially if someone's dying, even if you didn't have a great relationship, you want to say bye, you want to say sorry, you want to make amends, whatever it may be. So to stop that and to let that person die thinking you never wanted to see them again is horrific for the person dying and for the person that lives. You'll regret that for the rest of your life.

We hold little fundraisers around Los Angeles and Orange County and people

have contacted me that they want to get this bill started and they're raising funds as well and now we have the bill in five different states. And there are little fundraisers going and if there's a fundraiser and you want to donate there's a guy here-fantastic, generous man-who does these Harley rides. Whether it's a ride from here to Santa Barbara or Camarillo-he's done events like that for us and part of the proceeds and tickets go to Kasem Cares foundation.

Another woman, this last weekend, did an event where part of the tickets went to the Kasem Cares Foundation, it was a fashion show. So people have raised money that way which is so helpful.

We've had people for their birthday, instead of a birthday gift, ask to please give to the Kasem Cares Foundation. We have a lady who does car rides-you can get in a real Nascar. And anytime people bought tickets they gave to us as well

Aside from being an activist and a TV and radio personality, you also own a vapor store in Beverly Hills. Tell us about that.

The vapor that I sell here is different from the disposable e-cigarettes. A lot of the disposable e-cigarettes have liquid made in China, which has got a lot of chemicals in it that are not good for you. We have an organic store here. In fact, Dr. Joel Nitzkin, Chair of the Tobacco Control Task Force for the American Association of Public Health Physicians concluded that, "If we all get tobacco smokers to switch from regular cigarettes to electronic cigarettes we would eventually reduce that death toll from 400,000 a year to less than 4000 a year, maybe as low as 400 a year."

People aren't talking about the real studies that are coming out. Look at the Drexel University study where it says that there's no such thing as secondhand vapor. Look at the Oxford University study where they took 9,000 people and during that year people who switched from tobacco to vapor, their cardiovascular systems and their lungs were healing.

So look at the good studies—look at the real studies. Don't listen to the propaganda and the tobacco lobbyists—they're killing people and they want to keep killing people. Both of my grandmothers died of smok-

ing, lung cancer. And my boyfriend was a smoker for five years and this is the only thing to get him off of it. So, while putting nothing in your lungs is best, this can save your life. And for anybody who's against it: shame on them for not doing their research and listening to the tobacco companies and the tobacco lobbyists. Shame on the politicians for not doing their research.

I really feel like I found the light in something that was tragic in a situation that would bring most people down to their knees and just break their spirits. I found the light and I found something that was good and that was helping people through my situation. And that's something my father would have done—he would have turned something terrible and said ok, let's find something good about this. What can we do to fix this and make this better? And I think I've done that for a lot of people in my situation.

The Beverly High boys' basketball team defeated Santa Monica, 63-53, Saturday in the seventh-place game of the 74th Sax Elliot Invitational in what coach Jarvis Turner called "our best team effort" among the eight games its has played this season.
