



## "Bond running out of money" [Issue 804]

What we know for sure: There is not enough money left in the Measure E Bond to finish the job without further Bond Acceleration. This is factual and incontrovertible. On November 4th 2008, Beverly Hills voters were asked to authorize a ballot measure (Measure E) approving \$334 million dollars to be used for the purposes of modernizing and repairing our five school campuses. To be exact, the Ballot question appeared as follows:

"Measure E: To provide safe and modernized school facilities, make necessary structural seismic safety repairs, upgrade, repair, and reconstruct aging classrooms, infrastructure, multiuse, gyms, libraries, science, technology & labs, roofing, plumbing, heating, ventilation and electrical systems; renovate BHUSD schools to better protect student; staff from unauthorized entry, security risks and natural disasters; shall Beverly Hills United School District issue \$334 million in bonds at legal interest rates subject to mandatory audits, independent citizens' oversight, without an estimated increase in tax rates?"

By January of 2013, the Board already knew what was becoming painfully obvious to the community, \$334 million at the current rate of funding was not going to be sufficient

to get the job done.

By March of 2013, the Finance Committee issued a special report to the Beverly Hills community advising them that “with the benefit 20/20 hindsight it is obvious that the 2008 campaign promise was too good to be true. Community leaders who endorsed it in good faith should recognize now that it is not realistic, and they should support a reasonable alternative for funding essential upgrades of our school buildings.”

On Tuesday March 3rd, 2013, by a 4 – 1 vote, the Board of Education voted to accelerate the payback rate of the \$334 million Measure E bond, with Board Member Goldberg voting no. This vote triggered a notification to the County Assessor that the district might issue up to \$95 million in bond sales for the 2013/2014 tax years . . . Dare we call it what it was . . . A BOND ACCELERATION by any other name!

To make it even sweeter, a Bond Acceleration without a vote of the people. Along with our money, there went the election slogans, “transparency and accountability.”

Let’s not confuse the facts, there are those who simply oppose the bond, and there are those like me, who oppose the bond acceleration WITHOUT THE VOTE OF THE PEOPLE. You could say it has something to do with the democratic process.

And where are we today? The BHUSD Finance Committee, Citizens Oversight Committee and the School Board agree there is not enough money to get the job done. Not only is there not enough money to get the job done, but there is not enough money to meet the very basic mandate of this Bond Measure and that was to “make necessary structural seismic repairs.”

It would appear that the earliest a new bond could be voted on would be in 2016, and what are we to do between now and then?

Well if we were to heed [Lewis] Hall’s advice, we would keep on spending, finish the job at Horace Mann and show the Community what a great job they could do if they only had the money . . . Sounds like a Dog and Pony Show to me.

If we were to heed [Noah] Margo’s advice we would take the bond to a vote of the people. It would appear to be a reasonable recommendation had we done it in 2013. 2014 and dare I say 2015 . . . But 2016 . . . Oh yes I get it . . . AFTER the November election . . .

And what of [Brian] Goldberg, the ONLY school board member who voted against the acceleration? Why hasn’t he pressed the issue? Why hasn’t anyone on the Board championed taking this vote back to the people? Why two years later are we still waiting for our voices to be heard? If Hawthorne and Horace Mann were equally identified as deficient, and FOURTEEN buildings district wide have been identified as having seismic deficiencies why was Horace Mann built out first?

This Community must ask itself did the Board fail in adequately identifying and prioritizing safety concerns, were they building “castles in the air” or safeguarding our schools.

Ms. Korbatov, there are some, like you who would argue that opposing the Bond Acceleration was “akin to a moral hazard”, I beg to differ, the hazards moral or otherwise, are turning a blind eye to poor governance and poor fiscal management.

Ms. Korbatov, why has this been allowed to drag on for seven years with little to show for it, and ultimately, and I am not suggesting that you have, but ultimately why have our children been used as political fodder?

In defense of Mr. Goldstein, I will allow for the fact that he is the newest member of the Board, and he has inherited much of this mess. Yet he cannot get a “pass” as his voting record speaks for itself. Silence and appease-

ment do not go hand in hand with leadership. I will share with you a difficult lesson that my grandfather who knew persecution in his youth passed on to us, and that is either you stand for something or you stand for nothing.

But don’t just take my word for this, for those of you who cannot attend the endless meetings and study sessions, I urge you to do your homework and go online, Meeting Minutes including Tim Buresh’s recommendations can be found online or go to the BHUSD website and you can search for the

COC and Finance Committee meeting minutes. Unfortunately no Minutes are taken of the study sessions as those are less formal meetings. Maybe it’s time consuming, but our children deserve no less.

In the final analysis this Board is charged with first and foremost safeguarding the safety of our children. If the reports from the various consultants are to be believed there are significant seismic risks and other hazards on our five school campuses. Without being Chicken

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, March 12, 2015, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider a request to allow additions to an existing multi-family residential building located at **310 North Crescent Drive**. Construction of the proposed project requires the following entitlements:

**Zone Text Amendment.** The project includes a request to amend portions of the Beverly Hills Municipal Code. The proposed Zone Text Amendment would amend BHMC §10-3-2804B and §10-3-2850 to allow additions to existing buildings with legally nonconforming height through an R-4 Permit application.

**R-4 Permit.** The proposed project includes a request for an R-4 permit pursuant to the abovementioned Zone Text Amendment to allow for additions to two existing penthouse units at the subject property. The R-4 Permit would allow the additions to be built up to the same height as the existing legally nonconforming building, which has a height of approximately 42 feet. The project would result in a total increase of approximately 1,300 square feet to the uppermost story of the existing building. This provision is contingent upon the approval and implementation of the proposed Zone Text Amendment.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for Class 1 and Class 5 Categorical Exemptions. The exemptions are applicable to projects characterized as minor additions to existing buildings, as well as minor changes in land use limitations such as the amendment to the zoning code to allow an R-4 Permit to allow additions to nonconforming buildings, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission’s action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.



Currently, automated parking cannot be used for the purpose of meeting the minimum parking requirements set forth in the Municipal Code. The Planning Commission will be holding a study session to discuss whether automated parking should be allowed to satisfy the City’s parking requirements. At the study session, the Planning Commission will hear and consider all comments on this topic. The purpose of this meeting is to consider policy alternatives, and no final decisions will be made at this meeting. All interested persons are invited to attend and speak on this matter. A separate, noticed public hearing will be held at a future date to discuss this topic further and consider a draft ordinance. ## “Tip Jar Bandit” pleads no contest in felony theft case

The Los Angeles County District Attorney’s Office announced on February 25 that “Tip Jar Bandit” Jessica Shub has pleaded no contest to felony grand theft for stealing money from tip jars.

Los Angeles County Superior Court Judge Mark Windham sentenced Shub to one year in a live-in residential drug rehabilitation facility and three years of formal probation. Shub will also have to pay \$1,500 in restitution.

A 2013 Beverly High graduate, Shub was arrested and charged with commercial burglary by BHPD officers on February 12 after a series of tip jar thefts.

As a result of the defendant’s no contest

plea in the felony case, the misdemeanor charges have been dropped.

## ANOTHER BHUSD LAWSUIT FILED

### Former Assistant Principal Amy Golden's retaliation lawsuit names Goldberg, Korbatov

Amy Golden, who served as Assistant Principal at Beverly High from 2005 to 2008, and again from 2011 to 2014, filed a lawsuit against the BHUSD, Board of Education President Brian Goldberg and Board member Lisa Korbatov last week.

The 26-page filed complaint alleges violation of privacy, defamation, retaliation, negligence, intentional infliction of emotional

distress and negligent infliction of emotional distress.

Upon Golden's return to the high school in 2011, she was assigned as the administrator that oversaw Associated Student Body activities, among other duties.

The complaint alleges that on February 15, 2014, Golden received a text from an employee within the BHUSD Human Resources

was "letting her go."

A few days later, guidance technician Michelle Redston informed Golden that PTSA Co-President Jodi Galen had heard that the reason for Golden's dismissal was because "[her] boyfriend is black." Golden's fiancé is an African-American man.

In March 2014, Golden received official notice that her contract was being terminated effective June 30, 2014. There was no reason cited.

In May 2014, Golden applied for a position as Assistant Principal at San Marino High School. Despite being told she was the most qualified candidate and had "hit it out of the park" during her mid-June interview, Golden never moved forward in the process.

The complaint alleges that she later learned that Korbatov had met with San Marino

department, ostensibly Dawnalyn Murakawa Leopard, stating "Please call me." In a 30-second conversation with Leopard, Golden learned that the BHUSD

Unified School District Superintendent Alex Cherniss and told him not to hire her, revealing facts that were part of Golden's private personnel file and further damaging her reputation. Cherniss is a former BHUSD Assistant Superintendent and Hawthorne principal.

The complaint alleges that in August 2014, Goldberg published information he knew to be false about Golden on his blog *Goldberg Perspectives*, blaming his decision to terminate her contract on information that he alleged was available to him as Board member related to missing ASB funds.

Former Beverly High ASB and textbook technician June Tapscott-Bazzi, who technically answered to former BHUSD Director of Finance Marry Anne McCabe, is currently being charged with grand theft by embezzlement and was arrested by the BHPD in September.

Tapscott-Bazzi was arraigned on December 23 after a court determined at a December 9th preliminary hearing that there is sufficient evidence to continue with her trial.

Florencia Albert-Aranovich, who represents Golden, and Christopher Darden, who represents Tapscott-Bazzi, did not return calls from the *Weekly* by press time.

The BHUSD has not yet identified which attorney is representing them in this case.

### Councilmember John Heilman unexpectedly defeated for reelection

West Hollywood Councilmember John Heilman, a fixture in West Hollywood politics since the city's incorporation in 1984, was narrowly defeated Tuesday.

The winning candidates were incumbent councilmember John D'Amico, Lauren Meister and Lindsey Horvath.

Former

Chair of the West Hollywood Planning Commission, Joseph Guardarrama was also expected to win Tuesday but placed fifth.

A Southwestern and USC law professor, Heilman became West Hollywood's second Mayor in 1985. Heilman is also the longest-serving

openly gay elected official in the United States.

Meister, a slow-growth candidate who was backed by Beverly Hills councilmember John Mirisch, formerly served as president of the West Hollywood West Residents Association. Meister has also served on West Hollywood's Planning and Public Safety commissions.

"I want to thank the people of West Hollywood for expressing their confidence in me and my hope for our future and I look forward to working with John [D'Amico] and Lindsey [Horvath] to move our city ahead," Meister said.

Horvath, who was previously appointed to the Council but defeated for reelection, made a comeback. A former entertainment advertising executive, Horvath currently chairs the West Hollywood Transportation Commission and was backed by former Beverly Hills Planning Commissioner Brian Rosenstein.

tem for the new trees, in addition to the repair of root-displaced sidewalk and curbing in direct proximity to the tree wells.

One of the prevailing concerns with the existing ficus trees—which Javor said have “served their duty”—is that they obstruct business signage.

Staff joined the commission’s Street Tree Master Plan liaison at a public meeting in early February to hear feedback from the business owners that would be impacted by this change. The meeting was sparsely attended, despite notice being provided twice before the event.

Park and Urban Forest Manager Ken Pfalzgraf recommended that the Southeast Task Force repackage and reintroduce the proposed tree removal, as it has not received a robust-enough response from the community.

Beverly Hills resident Eric Schwartz presented a petition at the meeting last week seeking the replacement of the Idaho locust trees on Peck Drive. A group of Peck Drive residents have expressed concern with the large deciduous trees for the past several years. There are around 140 trees that will be replaced.

“We don’t feel we have a canopy that’s representative of the city or the neighborhood,” Schwartz said, speaking on behalf of several neighboring residents who support the petition. “We think that it does an injustice to our street. It lowers property values and it’s just not something that’s

consistent with the way the other streets in Beverly Hills look. So we would very much appreciate your support of removal of the trees.”

As reflected by the petition, more than 50 percent of the property owners on the streets support the change.

The tree removal proposal will be presented to the City Council this summer.

Pfalzgraf recommends that the best time to plant the trees is the fall.

### Reinsich performs surgery on Microtia patients

Mending Kids, a non-profit organization that provides surgical care to children worldwide, has collaborated with leading pediatric plastic surgeon Dr. John Reinsich to perform surgery on two children with Microtia at the Specialty Surgical Center on Wilshire Boulevard.

The patients are four-year-old Arabella and eight-year-old Rodrigo. One of the surgeries took place yesterday; the second surgery is scheduled for today.

Microtia is a congenital deformity where the external ear is underdeveloped.

KISS lead singer Paul Stanley, who was born with the defect, will visit the children after the surgery.

Reinsich, who is currently Director of Craniofacial and Pediatric Plastic Surgery at Cedars-Sinai Medical Center, will be volunteering his services.

## BHHS basketball team to play for Southern Section title Normans to face Corona del Mar Friday at Azusa Pacific

Beverly High earned its first berth in a Southern Section boys’ basketball final since 1969 by defeating Esperanza, 54-49, in a Division 3A semifinal Friday night at the Swim-Gym.

The fourth-seeded Aztecs missed a potentially tying 3-point shot in the final 30 seconds and Denzel Holt sank two free throws to seal the victory, finishing with a team-high 12 points.

“We played good defense,” Norman coach Jarvis Turner said after his team won its 15th consecutive game and 21st of its last 22.

Esperanza (22-8) had been held under 50 just one other time this season.

Holt “had a great overall floor game,” Turner said. “He held their best player (Jarrett Brodbeck) in check defensively and hit some big shots for us down the stretch.”

Beverly Hills led 10-7 at the end of the first quarter, 19-17 at halftime and 31-27 entering the fourth quarter.

“Offensively, we just couldn’t get into our groove. We didn’t get an opportunity to take advantage of Chance’s size as much as we wanted to but they also did a good job of taking that away,” Turner said referring to the Normans’ 6-foot-11 Arizona-bound center Chance Comanche.

Comanche was held to nine points, making three of seven shots and three of four free throws. He pulled down a team-high 10 rebounds.

Jalen Sands added 11, Trevor Bergher eight, making two 3-point baskets, Eman Rafalian six, Max Walder five and Ryan Manoocheri three on a 3-point basket for top-seeded Beverly Hills (24-5).
