"Remembering Sam Simon"

Animals have lost a stalwart ally with the passing of PETA Honorary Director, Beverly High graduate, entertainment giant Sam Simon. Immediately after Sam was diagnosed with terminal cancer, he summoned me to his hospital room to help him draw up his unique "bucket list." Sam didn't want to climb Mt. Everest or go skydiving. He wanted to save animals' lives, even as his own life was slipping away.

Sam said that the last two years-during which he worked with PETA to close bear pits, rescue an abused elephant in India, send lone roadside zoo chimpanzees to a sanctuary, and find homes for hundreds of chinchillas, a camel, and even a bull condemned to death in Ireland for being "gay"-were the happiest of his life. He took boyish delight in throwing open cages and letting animals run and jump and climb and swim for the first time in years-or the first time ever.

I'll bet Sam died with a smile on his face, knowing that elephants were on their way out of the circus, something that, together with the closure of SeaWorld, he dreamed of and talked about all the time.

Many unanswered questions surround Goldberg's arrest

Updated from Tuesday's e-blast

BHUSD Board of Education President Brian Goldberg was arrested Monday night at approximately 8 p.m. for battery, according to BHPD Lieutenant Lincoln Hoshino.

Goldberg allegedly shoved an 18-year-old woman after a verbal altercation, knocking her to the ground inside of the condominium building on the 200 block of Tower Drive where they both are residents. The verbal argument concerned Goldberg's unsafe driving in the building's sub-garage.

Facebook page: "[Goldberg] was driving so fast, about to run her over and she told him to calm down and he yelled 'Shut the fuck up.' Then he waited for the lobby/elevator because it is the only place we don't have building cam-

The victim's sister wrote about the incident on her

eras. He pushed my sister to the wall, got in her face and pushed her again. This to me is considered attacking someone."

According to Goldberg's attorney Anthony Salerno, the young woman committed a crime against Goldberg by standing in the doorway of the elevator and blocking his way. The young woman then fell down following Goldberg's attempt to leave the elevator.

"She yelled at him in a derogatory and threatening way," Salerno said in a statement. "Her language included a veiled threat that 'her father' was going to 'take care of' Brian. Brian told her to back off. Brian then got onto the elevator and this young woman pressed the button to keep the elevator doors open and forced her way onto the same elevator with Brian. She then continued her verbal assault."

Goldberg, who has told supporters that he plans to seek reelection in November, was released at 8 a.m. Tuesday morning and issued a citation. The Board President is scheduled to appear at LAX Superior Court on May 4.

tion in 1984 but defeated unexpectedly in the March Jury awards Strategic Concepts, LLC \$13.7 million

Former BHUSD Facilities Director Karen Christiansen's project management firm Strategic Concepts, LLC was awarded \$7.7 million after a Los Angeles Superior Court jury unanimously decided Wednesday that the BHUSD had breached its contract with the company.

The jury also found that BHUSD conduct destroyed Strategic Concepts' business and awarded the firm an additional \$6 million, bringing the total to \$13.7 million.

"The BHUSD did everything in its power to try to deny Karen Christiansen of Strategic Concepts from ever going to trial," said Christiansen's attorney Philip Kaufler. "First, by instigating frivolous criminal charges which were ultimately dismissed after a three-year battle. And then by intimidating the highest ranking officials of the school district from testifying on behalf of Karen Christiansen. The school officials were Kari McVeigh, [former] superintendent of schools, and Nora Roque, head of human resources."

Kaufler maintained that former BHUSD superintendent Jerry Gross had used his influence to get the Strategic Concepts agreement canceled with the complicity of the Board of Education.

We are extremely disappointed at the jury's verdict and intend to file a notice of appeal," said the BHUSD's attorney Fred Fenster. "There were a number of decisions that the jury made which are not supported by the evidence. For example, the percentage fee to be paid to Strategic Concepts, LLC was based upon the amount of money that the District realized from the sale of its bonds. Although only \$72 million in bond proceeds were received, the jury awarded Strategic Concepts, LLC damages as if all \$334 million had been received from the bond sales. Also, the jury engaged in rank speculation when it decided that Strategic Concepts was entitled to an award for the destruction of its business since there was no basis to support that conclusion."

Christiansen's lawsuit against the BHUSD alleging wrongful termination went to trial late last month.

Christiansen had previously been found guilty of four felony counts of conflicts of interest.

When Christiansen was convicted in November 2011, the BHUSD received a \$6.6 million settlement from Johnson

Planning Commission green-lights one-story accessory structure

At their February 26th meeting, Planning Commissioners unanimously approved a request by project applicant and property owner Schuyler Hewes for a Central R-1 permit, allowing the one-story accessory structure on the property located at 507 Hillcrest Road to encroach into the required height envelope for side-yard accessory constructions.

Assistant Planner Alek Miller presented an overview of the project, which encompasses a 14-foot tall accessory structure that contains a two-space garage, cabana and subterranean basement totaling 1,589 square feet. The accessory structure will be located on the northwest corner of the property, four feet from the north property line. According to Miller, neighboring residents have not yet voiced opposition to the project.

"I see no negative impacts," said Vice Chair Alan Robert Block. "I agree with Alek's summary of the project: that it's a better project than what was approved in 2008, it has the same angle as the house and there are other accessory structures on the block."

In 2008, a two-story accessory structure had been approved for the same site, but the owner never began construction.

Board of Education approves back-up internet service provider

In an effort to assuage the problem of unreliable internet caused by frequent denial-of-service attacks on BHUSD servers, Board of Education members voted to approve a back-up internet service provider at their meeting Tuesday night.

Acting Board President Howard Goldstein presided over the meeting due to Board President Brian Goldberg's arrest.

"I'm so excited about the prospect of having a reliable, working internet so that my students and I can do our best," said Beverly High English teacher Julie Goler. "I'm looking forward to moving on from the era of unreliable internet."

For teachers who rely on the internet for everything from taking role to delivering presentations via cloud-based software Prezi, the weekly "internet blackouts" have been considerably disruptive.

Earlier this month, bids were solicited for a service provider to supply the BHUSD with high-speed internet connection to bolster the existing connection and provide an additional line.

Time Warner Cable and AT&T responded to the call for bids, and Board members voted to approve the former as the internet provider for three years.

City to hold community meetings on subway station construction

Two community meetings will be held at the La Cienega Community Center this month to provide information on construction activities related to the Wilshire/La Cienega subway station development.

City staff will provide an overview of the La Cienega Station construction process at the two meetings, the first of which will be held this Monday from 6:00 p.m. to 8:00 p.m. The second meeting is scheduled for March 26 from 12:00 p.m. to 1:30 p.m.

When is the Board of Education going to accelerate the Bond?

The BHUSD wants to issue the third series of bonds under the 2008 authoriza-

tion in an amount not to exceed about \$217 million.

At the Board of Education meeting Tuesday night, two representatives from Keygent Advisors, the BHUSD's bond financial advisors, provided an overview of the two bond sale methods: negotiated and competitive.

In order to carry out a negotiated sale, the BHUSD would have to hire an underwriter to purchase the bonds and then allocate the bonds to investors. In a competitive sale, bonds are advertised for sale, meaning that any broker, dealer or dealer bank may bid on the bonds at the allotted date and time.

Speaking on behalf of the Beverly Hills North Homeowner Association, former Beverly Hills Mayor Robert K. Tanenbaum urged Board members not to accelerate the bond without a vote of the people.

"There will be other times when you're going to have a parcel tax, when there may be other community needs," Tanenbaum said. "And if we breach this trust, and erode the credibility of this Board, and this institution, who in the community will believe that we have to reach down and get into our pockets and actually vote in favor of Measure E?"

Despite rapidly dwindling funds, the Board of Education decided to not put the Measure E bond acceleration to a vote on the March 2015 ballot, shelving the acceleration until 2016.

Board member Noah Margo has been advocating for a new, robust bond measure that can sustain all long-term construction goals.

"I have felt, for a very long time, that as the district rolled out a more comprehensive construction plan for all of the sites, that the existing Measure E bond is not effective, nor is it sustainable, to address

the long term goals of the district," Margo said. "The idea of a new bond measure to replace Measure E is no different than wanting to do a remodel on your house making sure you know how much you need to do the remodel and then designing and spending according to what you have."

Acting Board President Howard Goldstein, who presided over the meeting due to Board President Brian Goldberg's arrest (see page 3), said that the Board is still vetting out what the cost of construction will be on the BHUSD facilities.

The BHUSD tax rate would climb to \$106/100,000 with the bond acceleration.

Comparatively, the current LAUSD tax rate—the fifth highest in Los Angeles County—is \$146/100,000.

According to the Keygent representatives, the highest tax rate in the County for a unified school district is Wiseburn School District, followed by Pomona Unified School District, Baldwin Park Unified School District and Inglewood Unified School District.

As discussed at the Citizens' Oversight Committee Audit subcommittee meeting last month, the remaining \$1.8 million on the Measure E report leaves little room to accomplish much else following the completion of Horace Mann; construction at the elementary school broke ground last



Proposed design for 511 North Elm Drive

Design Review Commission rejects North Elm Drive project

Design Review Commissioners voted 4-0 at their hearing on March 5 to send the project at 511 North Elm Drive back for restudy after concluding that it required simplification. Commissioner Efi Hubschman was absent from the meeting.

Property owner Katy Younesi attended the meeting with the project's architect Vigen Pezeshkian. The proposed style of the two-story, single-family residence has been identified as Mediterranean Revival.

"The very nature of the design itself seems to be overly complex," said Chair John Wyka. "It's not a matter of looking at things around the margin like the railings or the moldings. It's basically the major design elements there don't work and it creates a very busy, very massive house across a relatively small expanse of front yard."

The project features more than 20 landscape lighting fixtures, which Vice Chair Arline Pepp called "excessive." Pepp also identified the proposed wrought iron fence as a potential issue, pointing out that very few of the neighboring residences have fences. Pepp, who mentioned that the current design would not enhance the neighborhood, called for a total redesign

"I think it's pretty much a box with a small setback at the entry," said Commissioner Ilene Nathan. "The overall impression of the design is that it's very, very busy. When you look at it you don't know where to look first and all of the elements, as [Vice Chair] Pepp stated, seem to be fighting each other."

Commissioner Mahnaz Sharifi Ardani did not support a total revamp, stating that certain elements can be modified to soften the complexity of the current design. Ardani said the proposed design had enough modulation.

The Design Review Commission will revisit the project at their meeting on April 2.

The \$1.8 million sum reflects a \$2.5 million drop since the Audit subcommittee meeting in early January.

The BHUSD issued the first series of bonds in February 2009 in a total amount

Nixon White House Counsel John Dean on his new book and life in Beverly Hills

You have a new book out called The Nixon Defense: What He Knew and When He Knew It. After so much has been written about Watergate what made you want to write this book?

The project that resulted in this book really sought to answer the question: How could somebody as savvy as Richard Nixon make the mess out of his presidency he made? To answer that question, I thought I could find some of the transcripts of the existing recordings that had been transcribed and go from there. When I started looking at them, I realized that nobody had ever catalogued all of Nixon's secretly recorded

Watergate conversations, let alone began to transcribe them all, because I would find that one conversation would lead me to another to understand why he was taking difpositions. ferent So I ended up tranconversations, which are all of his Watergate conversations. They run from very quickmaybe a couple minutes- to many hours. There's one conversation, for example, of Nixon listening to tapes for eight hours. So it's a recording of Nixon listening to record-

ings. So they run a very wide gamut, but they tell the full story, and that's why I decided to do them. My book is not a book of transcripts—I drew the narrative and the dialogue from the transcripts.

Forty years after Watergate, do you think the story just gets better with time?

I don't know that it gets better; our understanding of it becomes deeper. We have new facts that keep coming up; I found countless things in the recordings that I had not known. I had not known, for example, that Nixon was very active in suborning perjury of one of the key witnesses very early, and this surprised

me, because I think most people wandered into the criminal area quite by mistake, but Nixon was a very sophisticated lawyer and understood perjury very well because that's how he'd sort of made his bones as a young congressman, by getting a witness to be indicted for perjury when appearing before the House Un-American Activities Committee. So that surprised me. There were lots of surprises and that was probably one of the bigger ones.

Tell us about your life after Watergate.

My life in California has been wonder-

"I will be remembered in the context of Watergate. What happens, I guess everywhere, is once the media puts you in a pigeonhole, you live there scribing about 1,000 forever. And so regardless of anything else I may or may not have done, I will always be remembered in connection with that. And I can only hope that they recall I was the one that told the truth." -Nixon White House **Counsel John Dean**

ful. I live here in Beverly Hills, up in the hills of Beverly Hills, and here we are on a beautiful, 80-degree day in March when the East Coast is blanketed with snow. I can't even envision owning snow tires on my car. So it's been a good place and often we have to fly a little further when you do a lot of business on the East Coast, but that's alright, you get to come home to this.

How did you become an investment banker in Beverly Hills?

When Watergate was over, I decided that I did not want to get my law license back-I had been there, done that. My father was a Carnegie Mellon-trained engineer and he would go into different companies and turn them around and it was always kind of an interesting business; he always thought there were a lot of opportunities out there. And so I sort of fell into the business of buying businesses with a couple of partners. I'm not an engineer, but I went to UCLA for several years, studied accounting, and I'm pretty good with looking at the numbers and analyzing businesses and had good partners, and we had some really nice success over the years in dealing with

small and middle-market businesses. We always thought we might take one or more of them public but we always ended up selling them off to somebody else or a much more major company in the business. And I never really left California, or Southern California, to do any of the transactions we did. There was so much to do here: everything from ready-mix cement companies to a company that made backhoes and digging equipment for John Deere. It was a lot of fun, and I did it for a number of years, and then was in a position where I could retire and take up the avocation of writing and had no idea I would have one bestseller after another. I've had about five [bestsellers] in a row now.

Your wife [Maureen] worked with [former City Treasurer] Frank Fenton at Smith Barney in the 1980s?

My wife went to Smith Barney, she's a very savvy finance person and a good trader and she was there for about a decade but getting up at the very, very early hour of 4 a.m. in California to get to the office before the opening of the markets really started to wear on her. So she decided she'd had enough but she's still active in business for our own account.

Tell us about your family.

I have one son, John, three granddaughters, they are all in Pittsburgh, and the oldest [granddaughter] has just been accepted to college-they're great girls. I have a wonderful son, he is on his second business, he's not what I would call a

but when venture capitalists are looking for someone to run a business he's a very good chief financial officer. He decided not to get a law degree but rather he went and got his MBA in Business. He's been a very successful businessman and he decided to stay Pittsburg in until the girls are all through high school, at least, and then he'll maybe even come out here, which would be wonderful. When you're stopped by people who see you, what is the most common

thing they

say to you about Watergate?

"Thank you" is the most common thing. Another very odd thing- particularly from 80 million Americans who watched my testimony for a week back in 1973 – they say something that catches me off guard, they say: We enjoyed, or, I enjoyed, your show. It wasn't exactly a show, but looking at it really from a distance, there certainly was theater in it and I think they have that reaction. In all the years I've never had anyone say anything negative to me.

How do you want to be remembered in the context of Watergate?

Well I think your question is wellframed for this reason: I will be remembered in the context of Watergate. What happens, I guess everywhere, is once the media puts you in a pigeonhole, you live there forever. And so regardless of anything else I may or may not have done, I will always be remembered in connection with that. And I can only hope that they recall I was the one that told the truth. I think that [The Nixon Defense] certainly shows that. While I got some of the dates wrong on what I remembered in my conversations with the president, I certainly got the gist of all the conversations right. I did conflate some dates but our memories are not time-stamped and that was probably one of the most difficult things in testifying.

BHHS Wins Division 3A Basketball Title Three Normans in double figures in victory over Corona del Mar. By Steven Herbert

Beverly High won its first Southern Section boys' basketball championship since 1969 Friday night thanks to the dominating presence of 6-foot-11 center Chance Comanche on both offense and defense, a strong third quarter and nearly perfect free throw shooting.

The top-seeded Normans made 16 of their 17 free throws, including eight consecutive by Denzel Holt over the final one minute, 19 seconds, in a 55-47 victory over second-seeded Corona del Mar in the Division 3A final at Azusa Pacific University.

"Most teams game plan around (Comanche) which then opens it up for the rest of the guys on the team," Norman coach Jarvis Turner said. "Jalen Sands had a pretty good game because they were focused on Chance."

Sands finished with a team-high equaling 12 points. He pulled down eight rebounds, including five offensive rebounds, both game highs.

Comanche, who has signed with Arizona, had eight of his 10 points in the first half. He made all four of his shots and both free throws.

"We've kind been using him as a decoy and he's been able to pass out of double teams and make plays for us that allows us to get good shots," Turner said. "That's what we've been living off of."

Holt also scored 12, all in the second half.

Beverly Hills led 10-8 at the end of the first quarter and 26-21 at halftime, then outscored the Sea Kings, 15-9, in the third
