"Jury awards Strategic Concepts \$13.7 million" [Issue 806]

I find that what I do not know far exceeds what I know about things.

In the case of the recent judgment against the Beverly Hills Unified School District (BHUSD) by Christiansen for \$13.7 million I only know the following:

- 1. A judgment is now against the BHUSD for \$ 13.7 million
- 2. The judgment represents about 24% of the BHUSD budget

Here is what I do not know and am hopeful someone who does know can provide information on not necessarily in order of importance:

- 1. Is there insurance to cover any part of the judgment? If so, what are the limits of the policies and how much of a deductable will BHUSD have to pay?
- 2. If there is insurance did the carrier defend under a reservation of rights?
- 3. If there is insurance was the policy limit subject to a "burning limits" where the cost of defense is deducted from the policy available to pay a judgment?
- 4. Was there a policy demand made by Christiansen? If so, did the carrier reject the policy limit demand?
 - 5. Were any offers made by BHUSD?
 - 6. Did any policies require BHUSD's letters cont. on page 3

Kessler to be named BHUSD Superintendent

The Board of Education unanimously decided Tuesday night to appoint Horace Mann Principal Steve Kessler as the new BHUSD Superintendent, effective July 1.

"We really have someone that will be honest with us as a Board, that has our respect and respects us and most importantly, someone who has the respect of the community at large," said Board President Howard Goldstein.

In selecting Kessler, the Board opted for a known figure in the community, as opposed to conducting a national search.

became Horace Mann principal in 2010. after three over decades school the where he taught many different grade levels, most recently middle school

math and physical education.

Kessler was first hired in 1976 as one of the first male kindergarten teachers in the BHUSD. Having spent his whole career at Horace Mann, Kessler has taught generations of families, including many children of former students over his 39 years in

Kessler public education.

Kessler graduated El Rodeo, Beverly High and the University of Pacific. His two children are Beverly High graduates. Kessler is also a member of the Athletic Alumni Hall of Fame.

Kessler was unavailable for comment.

BHUSD Superintendent Gary Woods made a surprise announcement Friday that he is resigning June 30.

BHUSD running out of Measure E funds

During the Citizens' Oversight Committee Audit subcommittee meeting last week, the Measure E cash flow balance report showed a remainder of \$900,000. This is the balance outside of the \$78 million set aside for Horace Mann.

The amount does not reflect a recent

contract approved for \$4.9 million for architectural work done by DLR Group.

When asked about the \$4.9 million DLR contract, Director of Facilities Fiscal Angeli Villaflor confirmed that this contract would be captured next month. Subcommittee members expressed concern, as they expect a negative balance in next month's report. As of today, the Board of Education has not given direction to accelerate Measure E.

Later during the meeting, it was announced that BHUSD Director of Fiscal Services Mark Keriakous had stepped down from his position and that Villaflor would be his replacement, leaving her position vacant.

"We're really tight on the budget and the budget that we're looking at right now for Beverly Vista is not even enough," briefs cont. on page 4

The Planning Commission of the City of Beverly Hills, at its regular meeting on Thursday, March 26, 2015, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS REVISING AND CODIFYING RECONSTRUCTION STANDARDS RELATING TO BUILDINGS DAMAGED BY DISASTER

In 1995 the City adopted an Ordinance to establish a program to facilitate reconstruction of commercial and residential areas after a disaster. On March 26, the Planning Commission will consider an Ordinance to revise and codify the existing program. A majority of the proposed revisions consist of minor language changes to bring the program into conformance with the current structure and practices of the Community Development Department. An additional revision would extend the amount of time that a temporary structure or use, as allowed by the program, can be in place after a disaster from 90 days to 180 days, with the possibility of a one-time 180-day extension.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance is eligible for a class 5 categorical exemption for minor changes in land use limitations and will not have a significant environmental impact. Accordingly, the Planning Commission will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

- 7. Were there any demands/offers of settlement? If so, for how much?
- 8. Did a third party (not the BHUSD lawyers) do an analysis regarding the BHUSD's exposure for damages?
- 9. If the Court will not grant a stay of enforcement can the BHUSD post an undertaking (bond) to stay enforcement/ levying on assets of BHUSD by Christiansen.
- 10. How much will the premium be for an undertaking? Where will the funds for the premium for the undertaking come from?
- 11. Will the trial Court reduce the jury verdict?
- 12. Will the trial Court grant a motion for a new trial if one is filed?
- 13. If the judgment is upheld on appeal where will the finds come from to pay the judgment?
- 14. If the judgment is upheld on appeal and BHUSD does not have sufficient funds to pay the judgment will BHUSD have to file for

bankruptcy?

15. If the BHUSD has to file for bankruptcy will it be able to discharge the Christiansen judgment?

Other questions I have not related to the Christiansen judgment:

- 1. How many more lawsuits does BHUSD have that is defending?
- 2. Are any of these lawsuits covered by insurance? If so, what limits are there on these policies?
- 3. Are these policies where BHUSD is being defended under a reservation of right?
- 4. Are these policies subject to "burning limits" whereby the costs of defense is deducted from the amount available to pay a judgment?
- 5. Have there been any demands/offers in the other lawsuits, if so, what has BHUSD done with the demands/offers?

Obviously if the Christiansen judgment is reversed none of the questions about it above will need answers as they will be moot.

said Ethel Walker, CEO of engineering and management firm Paragon, which is subcontracted with Totem.

Recent Board of Education meetings have spotlighted another component of the Measure E bond package: state seismic mitigation, commonly referred to as SSMP (State Seismic Mitigation Program.)

According to the SSMP website, all SSMP projects are funded on a 50/50 state and local match basis.

Audit subcommittee member Isabel Hacker pointed out that the Measure E balance sheet distributed at the meeting last week does not reflect the Board's latest SSMP commitments.

"I've been watching the meetings and just last month on SSMP they approved about \$1.7 million, \$1.8 million, and that hasn't hit?" said Hacker.

The amount of Measure E funds spent on litigation has also been an ongoing concern.

"I continue to be stunned at the amount of legal fees," Audit subcommittee Chair Joe Safier said.

The legal fees paid from July 2014 through February 2015 totaled \$2.3 million, which reflects about 16 percent of the \$14.6 million charged to the Measure E report from July 1, 2014 to February 28, 2015.

By the end of the meeting, the consensus among subcommittee members was

that that the Board should communicate what their plans are for Measure E, since there are no more funds available for any projects outside of Horace Mann now that the unencumbered funds have gone negative.

As the business of the audit subcommittee concluded, Harvey Rose Associates joined the group to discuss the preliminary Measure E Performance Report. The *Weekly* was asked to leave by Safier, whose request was then backed by COC Chair Woody Clark. It is unclear whether that violates the Brown Act or not, because there is no such thing as closed session meetings for a Citizens' Oversight Committee.

A Citizens' Oversight Committee meeting will be held today at 4:00 p.m. in the District Office Board Room.

"I have a problem with the fact that it's basically attached to a building," said Vice Chair Brenda Potter. "To me, [Lane] seems more of somebody who falls in the decorator/design realm as opposed to a fine artist who's in museums. Half of the press that you showed me is all design related, it's not fine art magazines. It's nothing that's related to fine art."

Priced at \$210,000, the sculpture would be affixed to a wall in the building's lobby and visible from the street through glass entry doors.

Chair Sandy Pressman recommended that Fine Art Commissioners visit Gray Gallery in order to become more familiar with Lane's artwork.

"I think that I'm having a little trouble getting my arms around it because I have not seen the work," Pressman said.

The Commission will revisit the project at their meeting in April.

Rosalind Wyman on 60 years in Los Angeles politics



You were elected to the LA Council in 1953 at age 22. What was that like?

Well it was quite remarkable; it was a headline in the Los Angeles Times saying "It's a Girl." And when I gave birth it said "City Dad Gives Birth." That was another headline. I had two kids when I was on the City Council. The whole story went across America, by the way, I was the youngest woman—somebody said that I was the youngest woman ever elected at that

moment to a major City Council. Here, it was just not believed at all, because the LA Times controlled whoever got elected and they didn't support me. It was a big fluke. I meant it was just unreal, the news that was carried on it. I was asked for interviews from all over the country, I must say, not only here, but it just kind of burst—everybody who had an organization in LA, it seemed, wanted me to come and talk. That's actually how I met my husband [Gene Wyman]. But it just kind of took everyone by surprise that a 22-year-old could get elected to the Los Angeles City Council and it opened a lot of extra work for me, although I didn't have enough sense. I was just ready to move out of my folks' house when I ran- that was our headquarters. There were so many things I was going to do so I decided to stay home for a little bit because I can't possibly find an apartment and get moved and all that. It was kind of strange to have a City Council person living at home with their parents. I finally moved when I got married.

Your late husband Gene Wyman was

a major force in the Democratic Party and you lost him at a young age. Tell us about that.

He was just the most remarkable man in the whole world. I've never doubted that it was the best marriage and people who knew us said that we were just made for each other. And he plotted how to meet me. It's a great story. He was practicing in Beverly Hills and I was speaking for the Beverly Hills Bar Association and a great lawyer was introducing me, he was very famous, and Gene decided he would go. Anyway, he couldn't get anybody to go with him so he said, "Oh what the heck, I'll go anyway." So he went and he said he had asked me a question which I never remembered, for some reason, but he left the meeting, the luncheon, and he went back and his partner was there and he said, "I just saw the woman I'm going to marry."

Tell us about some of the people in Beverly Hills you've worked with over the years.

Vicki Reynolds. In fact, Vicki Reynolds is, in my opinion, 99 percent responsible for the library in the building of the Wallis [Annenberg Center]. I've chaired all of Senator [Dianne] Feinstein's campaigns, as a volunteer, not paid. And I don't think Dianne spent one year in office that Vicki didn't come about for that library for the arts. Dianne for years fought that battle because everybody said, "All those rich people—you want to give them a library

in the middle of town on that piece of property?" Dianne Feinstein has not been given the proper credit for that building at all. I've worked with Vicki, I've worked with the mayors, one after many of them. I have tons of friends: Karen Platt, she's one of my dearest friends. I've just had tons of friends: [former Beverly Hills Mayor] Donna Ellman [Garber], Maralee Beck, she's on a major committee, she's also the president of the Robinsons Gardens in Beverly Hills, I was at her wedding. There's no end to people in Beverly Hills that I have known. [Councilmember] Willie Brien, the great Willie Brien, he's just a dear. There's no end. I know many of the mayors personally. Remember my district borders on Beverly Hills- we had fights over oil, we had fights over streets. Chuck Heston was a dear, dear friend-it's hard to believe he was such a Republican. We had a lot of arguments when [Chuck] started with the guns and the National Rifle Association but we decided we wouldn't talk about that issue. I thought there's no point in fighting with Beverly Hills if we can get along.

Goldstein elected new president

BHUSD Board of Education Vice President Howard Goldstein was elected Board President at the special meeting Tuesday night following a 4-1 vote. Board member Lewis Hall dissented. "I'm honored that my colleagues have faith in me to assume the position, the duties and the responsibilities of the Board President. I understand that it's very ceremonial but I'm nevertheless humbled by it," Goldstein said. "[I have] respect for each and every one of my colleagues sitting up here because I recognize, for the last half of this year, how difficult this job is and how much more difficult it becomes when the community has put us in their sights."

Board President Brian Goldberg stepped down from the position after his arrest by the BHPD early last week on charges of battery.

"I wish I had a clear answer for

you," Goldberg said at the meeting Tuesday night, addressing Hall, who had asked when the former Board President might reassume his position. "I've talked to my defense attorney, the detective for the BHPD, Detective [Mark] Schwartz, who is in charge of the investigation, is on vacation this

week. I have to tell you Mr. Hall, in all fairness, and not to sound self-serving, but this is not a top priority for the BHPD. It's a citizen's complaint."

Goldberg then made a motion to nominate Board member Lisa Korbatov as vice president, which failed with a 1-4 vote.

"It would be beneficial for the [Board of Education] to keep those who are temporarily engaged in legal issues away from the lime-

light," Board member Noah Margo said.

As reported in issue #805 of the *Weekly*, former Beverly High Assistant Principal Amy Golden filed a lawsuit

against Korbatov, Goldberg and the BHUSD late last month. The 26-page filed complaint alleges violation of privacy, defamation, retaliation, negligence, intentional infliction of emotional distress and negligent infliction of emotional distress.

light from a disgruntled former employee who has logged an empty lawsuit at myself and others in this district," Korbatov said.

Goldstein's motion to nominate Margo as president vice also failed, com-Board pelling members to withdraw the agenda item altogether. Later that day, Goldstein consulted BHUSD General Counsel Vincent Ewing, who said that it is not necessary to

appoint a vice president during this time.

HOW WILL THE BHUSD PAY THE \$13.7 MILLION CHRISTIANSEN JUDGMENT?

Two legal experts give their perspective

Former BHUSD Facilities Director Karen Christiansen's project management firm Strategic Concepts was awarded \$13.7 million last week after a Los Angeles Superior Court jury unanimously decided that the BHUSD had breached its contract with the company.

The *Weekly* consulted two legal experts for their perspectives on how the BHUSD will pay the \$13.7 million judgment.

The BHUSD's attorney Fred Fenster told the *Weekly* that they intend to file a notice of appeal. If the judgment is upheld and the BHUSD cannot pay the

\$13.7 million, they could be forced to file bankruptcy, according to attorney Raymond Zolekhian, who is not affiliated with the case.

"They have to get the money," said criminal defense attorney Ronald

Richards, who is also not involved with the case. "They will have to borrow the money from the City."

Richards said that the BHUSD probably has a burning policy in place, meaning that whatever they spent on the defense will be reduced from the coverage.

"The BHUSD is almost certainly going to appeal the verdict, and that's a very costly process for both sides that could take years

and ultimately lead to the verdict being overturned," said Zolekhian, who is a partner at Oakwood Legal Group. "So to alleviate that risk, the plaintiff's attorney can negotiate a settlement with the BHUSD for an amount slightly less than the verdict. And then in exchange for that the BHUSD would waive their right to appeal and pay that settlement amount in a timely fashion."

According to Christiansen's attorney

Philip Kaufler, the contract between Strategic Concepts and the BHUSD has an attorney's fee provision, meaning that the winning party is awarded attorney's fees.

It is unclear whether Kaufler, who defended Christiansen probono because she was destitute in her criminal trial, will collect attorney's fees for both the criminal and the civil case. The attorney's fees

alone could total several hundred thousand dollars.

Board of Education President Howard Goldstein said he would not comment on pending litigation.

"We had two wide-open layups that we missed consecutively," Turner said. "We made some mistakes down the stretch and took a couple of bad shots. That pretty much was the difference in the game."

Chance Comanche, the Normans' 6-foot-11 center who has signed with Arizona, scored a team-high 15 points, making seven of 16 2-point shots and one of four free throws.

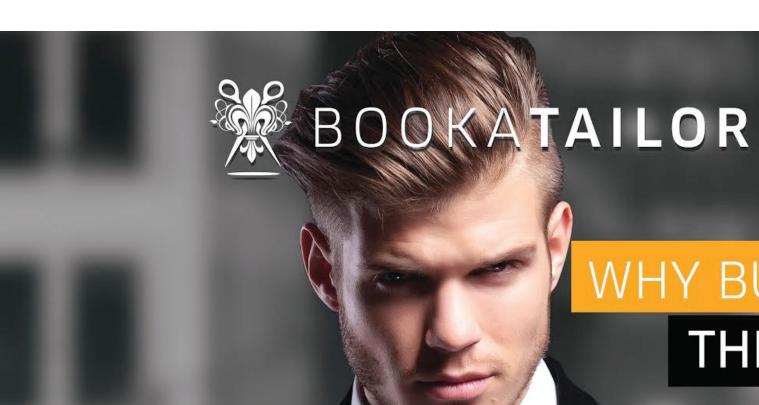
