Beverly Hills Police Department Chief David Snowden announced earlier this week that he will be retiring June 13 after 49 years in



law enforcement. His retirement was advanced several by months due to upcoming back surgery. Snowden, a former brigagendier in the eral

Reserve, began his term as BHPD Chief of Police in 2004. Over the years, Snowden has received numerous awards, including the Sherman Block Law Enforcement Professional of the Year Award, Costa Mesa Hall of Fame Award and the National Law Enforcement Commendation Medal.

'Our residents and businesses have benefited tremendously from Dave's commitment to providing the community with the finest in public safety," said Mayor Julian Gold in a statement. "We wish him well in his retirement and thank him for his years of service."

During Snowden's tenure, the City's police department launched and expanded high-tech public safety programs, including citywide security cameras and automated license plate readers.

there are "engineering reports here in our main office," but, "we have also requested to have a second opinion from a licensed structural engineer to verify the current recommendation."

The fact that there is a disagreement between Mr. Margo and Mr. Goldstein on the one hand, and Ms. Korbatov, Mr. Goldberg and Mr. Lewis, and Mr. Woods on the other hand is inexcusable, confusing and untrustworthy. At the PTSA meeting last Friday, Board President Brian Goldberg expressed uncertainty about the agenda item's origins, initially stating that Superintendent Gary Woods had approved the addition.

Board Vice President Howard Goldstein later said that Woods had been absent during that time and could not have reviewed and authorized the agenda item, which was slipped in April 10 at 5 pm.

'The agenda item was snuck on at the eleventh hour by an anonymous staff member," said former BHEF President Jonathan Prince at the PTSA meeting. "It just reeks of lack of transparency-there's no transparency'

Though the auditoriums were closed last week, licensed structural engineers have not yet examined them, leading numerous community members to wonder why the buildings were deemed unsafe before an engineer's assessment.

In an emailed letter to the district Wednesday morning, Woods called the closures temporary, and said that they 'were ordered pending the receipt of a formal written safety assessment by structural engineers/experts."

Woods also revealed that the district has requested a letter from engineering geology firm Earth Consultants International (ECI) to "assist in placing the various seismic risks facing the district in perspective."

"The auditoriums, if indeed they are in danger, if indeed the reports that you have on file have proven that they have been unsafe for however many years that you've had these files, I wonder why the decision wasn't made years ago," Prince said. "Why was it made this week? Why did that happen?"

BHUSD paid \$2K to hide information from the Weekly

According to BHUSD Chief Administrative Officer La Tanya Kirk-Carter, the district paid \$2,000 to redact bills requested by the Weekly late last year.

"Our legal counsel [Vincent Ewing]-we had a reduced rate-redacted 40 pages and the total amount was \$2,000," Kirk-Carter said at the Citizens' Oversight Committee meeting last week.

In December, the Weekly requested billing information pertaining to BHUSD interim Director of Facilities Tim Buresh's involvement in producing a series of videos with KBEV on the Metro issue.

As covered in issue #798 of the Weekly, the district initially redacted the requested billing information. Ewing, in an email response, wrote that the "information has been redacted because it is exempt from





Kaufler requests attorneys' fees, prejudgment interest

A Los Angeles Superior Court judge will decide on two motions Friday pertaining to the Christiansen vs. BHUSD case.

Attorney Philip Kaufler, who represented former BHUSD Facilities Director Karen Christiansen in her lawsuit against the district alleging wrongful termination, is requesting \$5 million in legal fees and \$4 million in pre-judgment interest.

Christiansen's project management firm Strategic Concepts, LLC was awarded \$7.7 million last month after a Los Angeles Superior Court jury unanimously decided that the BHUSD had breached its contract with the company.

The jury also found that BHUSD conduct destroyed Strategic Concepts' business and

The \$9 million being requested tomorrow brings the total sum Christiansen's attorneys are requesting to \$22.7 million.

BHUSD General Counsel Vincent Ewing did not respond to an email from the Weekly asking whether Measure E bond money can be used to pay for Christiansen's

punitive damages.

Goldberg attacks Snowden on 870 AM radio show


Board of Education President Brian Goldberg continued his attacks on Beverly Hills Police Department Chief David Snowden during a guest appearance on *The Randy Economy Show* Saturday night.

"Chief Snowden is a very large, tall gentleman, he uses his body—his physical proximity with you—in order to be intimidating," Goldberg told host Randy Economy.

During the 10-minute segment, Goldberg accused Snowden of harboring a "personal vendetta" against him because "[he] had exposed [Snowden's] corrupt behavior and practices" with regard to the now-defunct private security firm Evidence Based Inc.

"I've learned a very valuable lesson from this experience," Goldberg said. "There is unfortunately corruption that exists here in Beverly Hills and across the country."

Repeating claims he made in a letter to the community last week, Goldberg

asserted that Snowden had targeted him and his family.

COVERSTORIES COUNCIL APPROVES NEW WATER CONSERVATION MEASURES

Violations punishable by \$1,000 fines

At their study session Tuesday afternoon, City Council members approved the implementation of a modified version of Stage D of the City's emergency water conservation program in order to meet the state-mandated goal of a 36% reduction in water use.

"We are in a crisis situation with the drought and Beverly Hills is determined to meet the new water conservation goals," said Mayor Julian Gold in a statement. "We will evaluate our progress on a regular basis and make adjustments to our conservation program as needed. New technology as well as education will be a big part of the program because saving water is a long range as well as a short range goal."

The new conservation measures were

imposed in response to the severe statewide drought and a projected 15% cutback in water delivery from the Metropolitan Water District, which supplies 90% of the City's water.

The changes include limiting landscape watering to two days a week, rather than three. The City will also launch an outreach program to educate residents about the new restrictions and the ways that they can lessen their water usage.

"I do believe that we as a community need to lead and I don't believe we can ask residents and businesses to do something but we don't," said councilmember Lili Bosse.

Reduction of residential landscaping irrigation, which currently accounts for 60% to

• Restaurants shall serve water upon request only.

All public restrooms in the City and private bathrooms in hotels shall notify patrons and employees of water conservation goals.
Plumbing and

irrigation leaks shall be repaired as soon as practicable. The City may issue notices to repair visible leaks.

Landscape irrigation shall be restricted to two days per week
Existing swimming pools cannot be drained and refilled

• Exterior wash-down of buildings and wash-down of vehicles shall be prohibited, unless:

• The washing is done on the immediate premises of a commercial car wash or commercial service station or with reclaimed wastewater.

• The health, safety and welfare of the public are contingent upon frequent vehicle cleaning, such as the cleaning of garbage trucks and vehicles to transport food and perishables.

• Water usage from fire hydrants shall

• Except for single-family and multi-family residential users in tier 1 who will remain in tier 1 for the next billing cycle, users shall reduce water usage to seventy percent (70%) of the amount in the baseline period as determined by the City council.

• Except for single-family and multi-family residential users in tier 1 during the current billing cycle, a tiered water penalty surcharge based on the cost of providing the higher volume of water will be established.

• Violation by any person of the mandatory requirements for outdoor watering shall constitute a misdemeanor and, upon conviction, shall be punished by a fine not to exceed one thousand dollars (\$1,000.00). Continued excessive use may result in termination of water supply through irrigation water services and/or restriction of water supply through domestic meters. The violation of each element, and each separate violation thereof, shall be deemed a separate offense, and shall be punished accordingly.

COVERSTORIES MEL SPITZ ANNOUNCES BOARD OF EDUCATION CANDIDACY

Wants to resolve "formidable problems" in the BHUSD

In a letter to current and former City councilmembers, former Board of Education members and City Treasurers *(see right)*, longtime Beverly Hills resident Mel Spitz announced Tuesday that he will run for a seat on the Board in the November 3 election. Spitz, who previously served on the Board from 1971 to 1979 and the BHUSD Finance Committee from 2011 to 2013, listed the "unsound" financial condition of the district as one of the reasons driving his decision.

A 1950 UCLA graduate, Spitz worked for Hilton Hotels for 10 years, starting out as a trouble-shooting auditor in the early 1950s before becoming chief accountant of Hilton international hotels. He later played an integral role in opening several international hotels.

Later, as managing partner of Bedline Manufacturing, a company that manufactures folding steel construction for furniture and bedding, including sofa sleeper mechanisms, Spitz designed several products and developed 25 patents.

Spitz and his wife Barbara will be married 60 years this November. Their

Dear Former School Board Members,

I have received a petition signed by more than 100 residents urging me to run for the school board in November. Under normal conditions I would not consider it; but the financial and organizational problems of the District have become critical:

Micromanagement by the school board over the past several years has sidelined the superintendents and blocked them from providing essential leadership. As a result, turnover of key personnel has been excessive, violations of employment policies have spawned lawsuits, morale throughout the District is low, the educational program is at an all-time low as measured by the percentage of high school graduates attending junior colleges, and the California Department of Education has designated the high school academic program as deficient. Support and confidence within the community has been diminished.

The financial condition of the District is unsound. Expenditures other than those related to Measure E exceed \$14,000 per student, which is 40% more than the average of five neighboring high-performing school districts. The District is involved in many lawsuits, the costs of which will likely deplete its reserves. Maintenance of capital assets has been deferred for years and is critically needed. An unprecedented formula adopted in the 2013 collective bargaining agreements ties salary scales to property tax revenue, and requires that salaries be higher than those of any other school district in L.A. County. Consequently, the District will operate at a deficit in any future school year when property tax revenue is less than that of the prior year.

The Karen Christiansen court award of \$13.7 million plus her legal expenses will be appealed by the District. Meanwhile, the judgment is drawing interest of ten percent annually. The District is not required by law to record these liabilities during the appeal process; however, later this year the independent auditors may require such recording, which would expose the District's insolvency; or they could settle for a footnote in the financial statements which would hide it.

The 2008 \$334 million bond Measure E has been mismanaged according to the two latest annual independent performance audits. Now, seven years after passage of the measure school buildings remain unsafe in need of seismic upgrading, and this school board cannot agree on a sensible comprehensive plan for remediation.

To serve our community once again I will be a candidate for one of three seats in November. Hopefully other qualified persons will step up, to offer the voters a competent majority for the school board, capable of supporting a new superintendent and resolving these formidable problems.

If a Bidder fails to meet these qualifications, City shall consider the Bidder to be not responsible.

The successful Bidder will not receive a Contract award if the successful Bidder is unlicensed, does not have all of the required licenses and project-related experience, or one or more of the licenses are not current and active. If the City discovers after the Contract's award that the Contractor is unlicensed, does not have all of the required licenses, or one of more of the licenses are not current and active, the City may cancel the award, reject the Bid, declare the Bid Bond as forfeited, keep the Bid Bond's proceeds, and exercise any one or more of the remedies in the Contract Documents.
