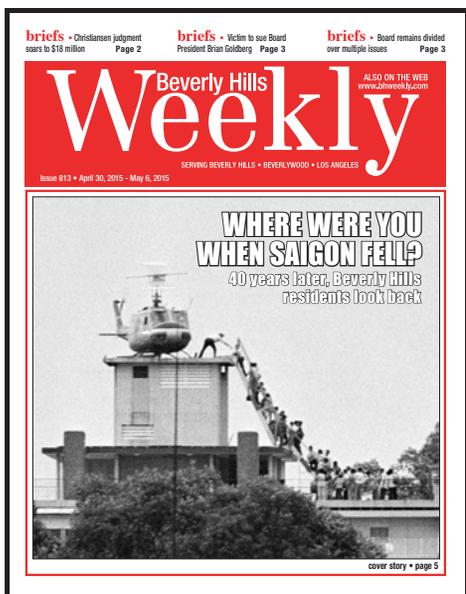

“Board votes to close three school auditoriums” [Issue 811]

An open letter to the Board of Education, regarding the BHUSD Auditorium closings:

The following questions must be answered to the community, and to the children whose graduation ceremonies, performances, and final awards assemblies have been made less special, less traditional due to these closures. Transparency is everything. Process is everything.

- 1) Do the letters from the engineers, cited by the majority in the 3-2 closure vote, have license numbers or merely signatures?
- 2) Do said letters call for closures? Or do they only call for corrections?
- 3) Do the architect's letters, cited by the majority in the vote, have a license number? Or do they lack such a number?
- 4) It had been explained to the community that the Board requested/required “stamped” letters, as such letters bore the necessary weight for real consideration when making such an impetuous decision. Were all such letters, indeed, “stamped”?

Now that the decision has been made, now that our K-8 and BHHS Administrative staffs are scrambling to put together last

minute arrangements - most of which are, admittedly, second rate venues - the community demands transparency as to the future of these auditoriums. These are not merely the palaces of the Performing Arts, they are truly the communal gathering places for our children and their teachers, a place where school spirit is spread to the greater population. Some of these auditoriums also have had a history of bringing in revenue to our District and experience for our students when rented to outside companies/vendors. What will happen now? Are there plans in place to address the issues in time for fall of 2015? If there are no auditoriums at certain schools for the 2015-2016 school year, is there a plan in place to create first-rate alternatives for the arts and for school community gatherings?

Perhaps the Board and our new Superintendent might ask for some community involvement from local professionals if, indeed, there are such issues facing our schools next fall.

Margo says Board lacks civility in speech to Human Relations Commission

In a speech to the Human Relations Commission April 16, Board of Education member Noah Margo asserted that the Board has not been demonstrating civility as of late.

“The Board did not embrace civility in our last two meetings, where we had Board members [ostensibly Lisa Korbatov] using tactics that would not be recommended by their mothers in public to try to sway voters and try to sway fellow Board members on particular issues,” Margo said.

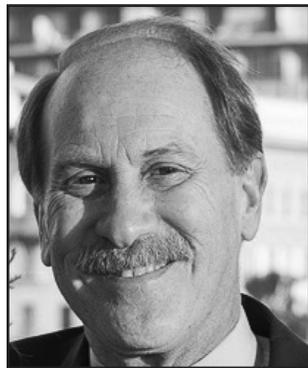
While the Board has always disagreed on major issues, in recent months, their debate has been especially heated.

“I, for one, as a Board member, did not appreciate that behavior from my colleagues,” Margo said. “I restrained myself completely through both meetings, though I was taunted and pointed and bullied and dragged through the press [in *The Courier*]; I don’t think that’s the way to conduct business or govern a school district.”

Korbatov left the April 14th Board meeting following the Board’s vote against the Measure E bond acceleration, only to return 10 minutes later after being heckled by an audience member.

Horace Mann to celebrate Kessler

Tevel faces jail time for molestation plea

Mendel Tevel, a rabbi affiliated with the JEM Center, pleaded no contest to one sexual abuse charge involving a 17-year-old boy in a New York courtroom last week.

“Rabbi Tevel was accused of conduct that involved one person, in New York City, eight years ago in 2007,” said Tevel’s attorneys Dana Cole and Alan Lewis in a statement. “To avoid the specter of a lengthy trial, he pled guilty to one count that alleged sexual conduct with one person, who, at the time, was on the verge of his 17th birthday. The charge to which Mr. Tevel pled guilty did not involve force. The prosecution has agreed to dismiss with prejudice the charges that alleged force.”

According to Cole, Tevel will serve a period of four months in jail.

In an August 2013 investigative report by the *Jewish Journal*, four individuals allegedly victimized by Tevel detailed instances of sexual abuse spanning nearly a decade—from 1995 to 2004. The victims’ ages ranged from six to 14.

Tevel was arrested by the BHPD in October 2013 following a warrant issued by the NYPD.

According to a *Jewish Journal* article from August 2103, a victim alleged that Tevel “came up with extreme ways to motivate him to work out harder, including repeatedly whipping him with a metal coat hanger, which [lacerated his skin] and caused bleeding.”

Tevel is the son-in-law of JEM Center Founder Rabbi Hertzell Illulian.

Board considers next steps for Superintendent house

During a closed session meeting Saturday, the Board of Education began the process of deciding whether to sell or lease the property at 220 North Doheny Drive, which currently houses outgoing BHUSD Superintendent Gary Woods and his family.

As reported in issue #663 of the *Weekly*, the Board approved the \$1.54-million purchase in June 2012 to lease the home to Woods for \$3,500/month.

Coldwell Banker realtor Michael Libow represented the district when they bought the house.

While the property is expected to sell for a profit, any profit received will likely go towards satisfying the Christiansen judgment, which currently stands at \$18 million.

Five Beverly Hills residents, one business listed among Top 500 Debtors

Five Beverly Hills residents and one business ranked among the top 500 delinquent taxpayers in the state, according to a list published by the Franchise Tax Board (FTB) April 30.

Collectively, the individuals and businesses listed owe the state more than \$132.5 million in income tax.

FTB removes a taxpayer from the biannual list once the debt is paid or once the taxpayer agrees to make payments under an approved compromise.

Incoming Citizens' Oversight Committee Chair



What major challenges do you think are facing the Citizens' Oversight Committee in the next year?

The COC's responsibilities have definitely changed in the sense that we have actual construction going on now in the [BHUSD]. Horace Mann is substantially underway so there are real items that we are reviewing. The district probably has known for quite some time, now, but it's really coming to a head now with regards to how much construction they can do with Measure E as it stands today versus whether they do a new bond, a replacement bond [or] accelerating this Measure E Bond. [There is] lots of talk

about different ways of trying to maximize the dollars. That's really going to have an impact on where the COC goes forward because we don't get to tell [the Board of Education] what to do, we just watch and report and analyze what they do with the money. But with real construction [happening], it changes the dynamic.

How do you plan to chair the committee differently than recently resigned Chair Woody Clark?

My plans for the committee are really to keep our eye on the ball. [Harvey Rose Associates] does the performance audit of Measure E—they've done it for a few years, now—and they've continually found findings that need to be taken care of. So my goal is to make sure that we hound the Board to make sure that those findings are taken care of. Also, [my goal is] to inform the public annually regarding how Measure E bond proceeds/expenditures are being used—whether appropriately or not appropriately.

You're an attorney, how did you get involved with the schools?

I have three children currently enrolled at El Rodeo and both my wife Erica and I are

very actively involved. I went through the Team Beverly Hills program. I learned about the opening on the COC through the Team Beverly Hills alumni e-newsletter—I'll call it that for lack of a better description. I found it to be very interesting and right up my alley [because] I could get involved with the schools and my kids' futures. Just to clarify, I have three children [Madison, Olivia and Zander] that are currently at El Rodeo. I also have a preschooler [Hunter] that will eventually be going to El Rodeo.

Why should the community have any faith in acceleration when the Board has broken many promises with regard to construction so far?

I was not a part of the COC when certain promises were made and I'll start by saying that the COC's job is not to tell the citizens or the Board to accelerate or not to accelerate. That is not our job at all. Our job is to make sure the monies that they do have access to and that they do use are used properly. The COC's responsibility is to oversee and make sure that monies that are taken out and drawn down for Measure E are properly used and efficiently used on appropriate Measure E projects. That's really our calling. So we don't make the decision and we don't make recommendations to accelerate or not to accelerate so that's really beyond the scope of what the COC would do. That being said, the construction at Horace Mann right now is on schedule and on budget and seems to be going smoothly. So that should give the citizens some comfort. With regards to all the other issues surrounding promises

and this and that, that's way beyond anything I feel comfortable commenting on.

What are your goals as COC Chair?

The Harvey Rose performance audit this past year came out with 13 findings; findings are another way to describe a deficiency. So I want to make sure that the Board is on top of those and make sure those deficiencies are rectified. Also, [I want] to continue to make sure that all

Measure E dollars are used only for Measure E projects and are efficiently used and if they are or are not, make sure the public is aware of what's going on by making sure there is good publicity for those issues. Our job is threefold: one, to make sure that Measure E dollars are being used on Measure E projects; two, to make sure that they're being used efficiently—[that] there's no waste involved; three, to inform the public concerning the Measure E bond proceeds/expenditures.

Do you have any interest in running for the school board?

At some point, maybe. I [would] have to discuss that with my wife and family and friends and figure that out. Even though [being Chair of the COC] is a big commitment, that would be a much bigger commitment.

Once the 2015 application period opens, any persons interested in serving on the COC can access the application on bhUSD.org.

BHPD STILL STRUGGLING TO HIRE NEW OFFICERS

715 applicants yield only two hires

At the City Council study session Tuesday, BHPD Division Commander Erick Lee updated councilmembers on the police department's progress in filling vacant police officer positions.

The police department's low acceptance rate has been an ongoing concern of the Council's.

"The vast majority of the candidates are

being failed for moral character integrity issues, [poor] work habits or communication skills," Lee said. "We do have a number of [applicants] that are reporting substance abuse issues or that demonstrate poor decision making."

Lee later said that the candidate pool has not been "rich with talent."

The City is currently recruiting to fill ten openings. From January 1, 2015 through April 27, 2015, the police department received 715 applicants for the police officer position. During this period, 49 candidates passed both the written and physical ability tests and 11 of them, or 22 percent, passed their initial interviews.

"I would hope and assume that we would have a lot of people that would want to apply to our police department," Councilmember

Lili Bosse said. "I think the concern that we as a Council had was: Why are we not filling the positions?"

Of the 11 applicants who moved forward to the secondary interview phase, ten passed. Four of those ten candidates were later disqualified or voluntarily withdrew from the background process. Two of those six candidates were hired and four are currently undergoing the background process.

"Many of the challenges we are experiencing are not unique to Beverly Hills, but are being experienced throughout the state and throughout the industry nationwide," Lee said. "The City is not lowering its standards for police officers. However, efforts to continually recruit police officers are ongoing and the police department is making good stride."

Although four police officers have been hired since early February, when 12 vacancies were tallied, three police officers have retired since then.

Entry-level BHPD officers are hired at the "pre-service entry level" salary rate of \$5,675/month, according to the BHPD website.

Police officers with at least one year of prior experience within the State of California, also called lateral officers, start with a salary that ranges from \$6,461 to \$7,604, not including overtime.

"The fact of the matter is, [if] we're trying to attract people to our police department, we need to sell it a little bit," Vice Mayor John

Mirisch said. "We should be doing a better job of trying to leverage the extreme interests in people who apply to our fire department and try and get them interested in joining the police [department.]"

The City requires its police officers to have an Associate's Degree or complete at least 60 college units by the end of their probationary period.

Shelley Ovrom, Assistant Director of Administrative Services in the City's Human Resources Department, did not respond to inquiries from the Weekly regarding starting salaries for BHPD police officers

Assil compared to "popsicles" for their sticky, gel-like consistency. Assil has fallen twice from slipping on the berries, which coat the sidewalks for up to 60 days a year during the annual berry drop period.

"The City's contract price for tree removal is \$21/inch of trunk diameter measured at 4.5 feet above the ground," Pfalzgraf said. "This is commonly referred to as diameter breast height. For example, a tree that is 10 inches in diameter at 4.5 feet above the ground would cost \$210 to remove. A tree that you can't wrap your arms around is much more expensive to remove both economically and emotionally."

As a next step, a plan detailing the automated replacement of the trees will be agendized and presented to the City Council for consideration.

Prior to moving to Beverly Hills, Hacker managed state and local grants for Cerritos College. While in Cerritos, she also served as a district liaison and coordinated with surrounding K-12 school districts.

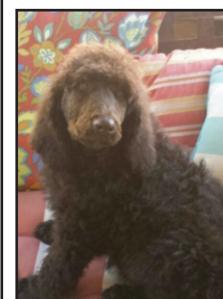
