Kessler says "So far, so good"

BHUSD Superintendent Steve Kessler finished his first week at the job last Friday.

"So far, so good," Kessler said. "I'm really optimistic about the future."

Looking to fill the principal position at both Beverly High and Hawthorne, the district has held two rounds of interviews and will enter a third round June 20. Kessler said some of the candidates have been "excellent."

"I'm happy about the recent developments," Kessler said. "The individuals in the school district have continued to be ultra supportive, so I feel like I've got the support of the community."

Board members, four district personnel to receive parking permits

At their Study Session Tuesday, the City Council approved a request made by the

Beverly Hills Unified School District for parking permits for four district personnel and all five Board of Education members.

Under the original proposal, the parking permit would apply to several different zones, including the area near the BHUSD property, non-metered parking spaces and the metered spaces near Horace Mann.

"I don't fully get why they need it at all campuses," said Councilmember Willie Brien. "At the high school, at the district office, that whole area there, there's plenty of parking on campus, there's plenty of parking on the street right in front of the administrative building."

Brien called for clearly defined, specified parking zones.

"I actually take a little bit of a broader view," said Vice Mayor John Mirisch. "I think the logic that applies to giving Class 1 permits to any of our commissioners, in theory, should also apply to our school board members."

Following the Council's decision, Superintendent Steve Kessler, Chief Administrative Officer La Tanya Kirk-Carter,

BHUSD legal expenditures for the third quarter fiscal year, spanning the time period from January 1 to March 31, totaled \$1.2 million paid to eight different law firms.

The amount represents a decrease from the \$1.6 million paid to law firms the second quarter fiscal year. Legal fees totaled \$882,403 for the first quarter.

Of the \$1.2 million, \$600,351 was charged to the general fund and \$599,668 to the Measure E fund.

General Counsel Vincent Ewing's fees are represented through the law firm Alvarez Glasman & Colvin. Attorney Fred Fenster from Greenburg Glusker represents the district in the litigation involving former BHUSD Facilities Director Karen Christiansen and former Beverly High Principal Carter Paysinger; the latter was settled last week.

As of October 2014, Haight, Brown & Bonesteel was working on oil relations; Atkinson, Andelson, Loya, Ruud & Romo was working on human resource matters; Best, Best & Krieger was being retained to handle general counsel affairs, such as bond funds and bond projects; Horvitz & Levy represented the District in the CEQA appeal regarding Metro's proposed Purple Line extension project; Murphy & Evertz represented the district in the CEQA case against Metro in opposition to the Purple Line extension route.

Ewing did not return calls from the *Weekly* seeking clarification as to which law firms are working on which projects.

Note: the *Weekly* requested these legal fees on April 2 and did not receive them until June 9.

Council jumpstarts landmark proceedings for 515 Sierra Drive

Following a request by Councilmember Nancy Krasne, the City Council voted 4-0 at their Study Session Tuesday to initiate landmark proceedings for the property located at 515 Sierra Drive, a 1941 American Colonial Revival-style residence.

"I would be sad to see it go, knowing the history of that block," Krasne said.

Councilmember Willie Brien, who lives within 500 feet of the property, recused himself from the discussion.

A notice of pending demolition was posted on the site on May 14, jumpstarting the 30-day posting period, which ends June 13.

Krasne requested that the property, which was designed by Master Architect Gerard R. Colcord, be considered for potential inclusion onto the Local Register of Historic Properties. In accordance with the Beverly Hills Municipal Code, Master Architect properties are required to post a 30-day Notice of Pending Demolition before the City issues a demolition permit.

At the Study Session, Marcy Brubaker, who lives four houses north of the subject residence, pointed out that a second Colcord house on the same block will soon be torn down.

"[515 Sierra Drive] has not been changed, affording a unique opportunity for restoration," Brubaker said. "I have been informed that no house has ever been denied a demolition permit. The continual tearing down of original, architecturally significant and worthy homes in our community signals visual disorder on our streets."

As a result of the Council's decision, the City's historic consultants will prepare an analysis of the property which will be forwarded to the Cultural Heritage Commission for a recommendation.

If the Commission votes to nominate the residence, the Council will consider designating the property as a Local Landmark and placing it on the Local Register of Historic Properties.

"Before we demolish it, we should look very carefully at it," Krasne said.

Director of Student Services and Special Projects Chris Hertz, Chief Academic Officer Jennifer Tedford and all five Board members will be granted parking permits.

The permit, which will be affixed to the windshield of the vehicle, excludes the area around Beverly High and the district office, as well as metered parking spaces. Horace Mann will be off limits until construction of the new parking garage is complete.

Permit holders will be able to access areas that have yet to be defined around Hawthorne, El Rodeo and Beverly Vista.

"If the [district put] the money that they spend on litigation in our parking meters, we'd be in great shape," said Councilmember Nancy Krasne.

Tevel sentenced to one year in prison

Mendel Tevel, the rabbi affiliated with the JEM Center, was sentenced to one year in prison Monday on sexual abuse charges.

Tevel pleaded no contest to one sexual abuse charge involving a 17-year-old boy in a New York courtroom last month.

One of Tevel's victims, whose identity has not been revealed, delivered his victim impact statement in court June 8: "The man who abused me is named Mendel. I met him when he was my dorm counselor at a boy's yeshiva. He took advantage of the position of authority he had over me and used it to physically and sexually abuse me. I went through horrific



Mark Slavkin discusses his new role as the Wallis' **Director of Education**

You served on the LAUSD Board of Education from 1989 to 1997. Tell us

I ran in 1989 as a parent with a very young child; our son was two. I was concerned about the state of public schools, so that was probably the inspiration, or the motivation. I served for eight years, which is an incredible experience. I feel like we made progress on my main goal, which was to decentralize and move more authority to local schools.

You have worked for the Getty and the **Music Center during your arts education** career, which spans 17 years. Why did you feel like the Wallis was the next step?

I had been at the Music Center almost 14 years, which was a long run and a great experience—I loved my time at the Music Center. The spark for me was in October of last year, our president at the Music Center, Steve Roundtree, announced that he would be stepping down at the end of the year. That was really the impetus for me to think about where I wanted to be, my future and so on. I was ready for a change and was ready to be in a new opportunity. And the appeal of the Wallis, for me, was to be part of something brand new and to have a role in shaping something from the ground up-it's a pretty rare thing; actually [it] doesn't come along very often. So that was appealing to me when I considered it and remains exciting to me now that I'm here.

In your 2011 TED talk, you called yourself a "recovering politician." Does anyone ever really recover from elected politics?

I grew up in a family that was very involved in politics and government and that remains an interest of mine, a passion of mine [and] something I care a lot about. So I think that will always be true, but I felt lucky to get involved-in terms of elected office-at a pretty young age. I was 27 when I took office on the school board. And that was a great experience. So a little bit, for me, is kind of "been there, done that." I lived that life, I had that experience, got a lot out of it, but I'm not really clamoring to get back into elected office but I'm happy to be involved as just a citizen.

How did your career in elected politics prepare you for your role at the Wallis?

I think my background in government and the school district leads me to think of a systemic approach to whatever the issue is, because I've been in a position to help influence change on a very large scale. And so I carry that with me. Whether it was at the Music Center, or here, at the Wallis, [I ask] how can we support and leverage change within schools and school districts?

As opposed to just seeing it as one child at a time or one school at a time, I think part of the way I look at the world is to take a broader leadership role, so I think we will be an active voice here for advocacy for arts education both in Beverly Hills, as our local community, and in the larger LA region. And so I think I just bring that orientation from my prior life. Probably wouldn't be the case if I came more from a traditionally arts perspective.

How did you make the leap from elected politics to arts education?

During my time on the Board, we just didn't pay attention to arts education, frankly. It just wasn't really on the radar screen in any kind of major way. So I was not perceived as "Mr. Arts Education" when I was on the school board. I wasn't anti-art, but it wasn't my signature issue. When I was thinking of leaving the school board, a friend of mine connected me to the opportunity at the Getty, which was completely not on my radar screen at all. This was before the Getty Center had opened, it was still under construction, and I was aware of it but I wasn't gunning to work there, because my perception of the Getty was [that it was] a fairly elite institution, in terms of being a global leader in the museum world. But a friend of mine said [I] should at least talk to them, so I had an initial conversation, and the more I went along, the more intrigued I was, because the Getty said they wanted to make a difference in LA, that they wanted to be relevant in LA in a bigger way once the Getty Center opened. And they thought that I could help in that regard. And they would teach me everything that I needed to know on the arts side, so it was an incredible opportunity. I traveled to different parts of the country, I met with all kinds of experts, they gave me all kinds of access to learn and get much smarter about the arts. So it was really the Getty-they were willing to take a risk

on me, a gamble on me, if you will, because I wasn't a traditional museum candidate. The Getty was staffed with the world's greatest collection of experts in the arts but they didn't have people who really understood the public affairs and politics and education dynamic of LA, so I feel like I contributed some of that, and they taught me

One of the things I've realized since being here is we're not going to be able to implement every program and idea in one single year. I'm learning to pace myself a little bit—we have to be here a long time, so it's not all at once. As we look at this coming school year, we've launched the New School Partners Program that will serve K-12 schools in two different ways. And schools are now

Wallis Focus Schools—that's a more in-depth partnership, so that will include students coming here for field trips to see performances and teachers coming here for different professional development workshops about the arts. 

together to come back here and see perforsupport from artists to go into those ten schools, and that will be highly customized. Each school will identify what they need the most: it might be a particular art form one school might want, workshops for kids, another school may want training for teachers. Each school in that program will get 20 hours of support from artists, but the details will be customized with each

school, because we really want to help them advance their goals, and that's different from school to school. So we're calling those Wallis Focus Schools. And for this next year we're starting with ten and that could expand over time, but I don't want to bite off more than we can chew. And then we'll have a broader circle that we're calling Wallis Partner Schools that we'll sign up to bring students here for art student matinees. So we have identified four particular shows for elementary age and four shows for middle and high school. Schools sign up based on their grade level and which particular shows they want to attend and how many students would participate. We're also launching courses for young artists—classes that will take place here and after school and weekends. This coming fall, we're going to have three different classes: one on choreography for young dancers to learn about choreography, the second one called Songwriting for the Theater, and the third is about the art of small ensemble in chamber music and jazz. The [classes] were designed to overlap with artists that will be presenting on our stages next year. So the choreography class will have a regular teacher but will also [provide] the chance [for students] to interact with dance companies and choreographers that will be here next year. I think our kind of special "value added" is to [allow students the opportunity to] interact with the artists that will be here and be a part of the Wallis community of artists. Young people and adult professionals will get to work together rather than have the education thing walled of and just separate. The more interaction, the better, as far as I'm concerned. That's the idea of immersing



young people in the arts and letting them be a

part of what happens at the Wallis.

I am probably most excited about the series of courses we will offer for young artists. It is thrilling to contribute to their growth and to give them opportunities to interact with the artists we are presenting on our stages.
