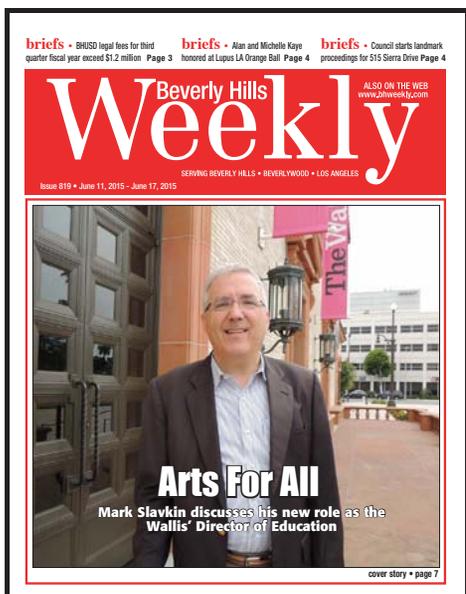

### A Case Against the Preservation Ordinance Amendments

Unfortunately, the new amendments will have the effect of denying landmark status to original and historically significant homes.

At present it is easy to get a permit to demolish a house and a complex list of obstacles stand in the way of saving one. The paradigm needs to be reserved.

I urge the City Council to:

- Reject the rigidity of proposed definitions of structures that could qualify for landmark status. They are so limiting that virtually no home will meet the criteria.
- Refuse to accept any changes to the establishment of Historic Preservation Overlay Zones.
- Dismiss efforts to limit the number of structures the Cultural Heritage Commission can initiate for landmark status.
- Establish the City Council vote for landmark status be a simple majority.
- Reduce the fifteen-year wait for a property to be reconsidered for landmark to no more than five years.
- Require that qualified preservation con-

### BHUSD settles with Quinn Emanuel law firm for \$450K

The Beverly Hills Unified School District entered into a \$450,000 settlement agreement with Quinn Emanuel Urquhart & Sullivan last month.

Dated May 11, the agreement states that Quinn Emanuel billed the district for legal services provided in a total of seven separate billing categories. The law firm claims that the district owes an outstanding balance pursuant to the fee agreement for legal services.

The law firm initially represented the district in the litigation involving former BHUSD Facilities Director Karen Christiansen, but was replaced by Greenberg Glusker in June 2014.

Quinn Emanuel later represented Board of Education President Brian Goldberg when he sued his former attorney for conflict of interest and received a large settlement.

BHUSD General Counsel Vincent Ewing did not return calls from the *Weekly* by press time.

Santa Monica.

### Council adopts amended Historic Preservation Ordinance

Following an extensive discussion that lasted almost four hours, the City Council voted 3-2 to adopt the amended Historic Preservation Ordinance at their meeting Tuesday night. Vice Mayor John Mirisch and Councilmember Lili Bosse dissented.

In December 2014, the Planning Commission passed a resolution recommending amendments to the ordinance, which was originally adopted in January 2012. The Commission green-lit the modified document with a 4-0 vote at a special meeting late last month.

Though the months-long revision process has drawn in countless participants, including Planning and Cultural Heritage Commissioners, historic consultants and LA Conservancy representatives, the process has been primarily spearheaded by Planning Commission Chair Howard Fisher and Planning Commissioner Craig Corman.

Fisher said that the revised ordinance is "more objective and less subjective" and better addresses the City's unique needs.

"Most of the changes focus on definition or process and relate to the involuntary process," Fisher said. "The proposed revisions do not change the powers of the Cultural Heritage Commission."

The newly approved ordinance includes modifications to the Landmark and Historic

District Designation proceedings, as well as other changes. Under the amended document, single-family properties would no longer be eligible for inclusion in a historic district, but there still would be procedures in place for multi-family and commercial properties.

Southwest Homeowners Association President Ken Goldman, who did not speak on behalf of the association, said that the original ordinance is "good," but needs more "certainty."

"You have a list of Master Architects with 180 names of architects and contractors," Goldman said. "That's not notable—and what does notable mean? You would never have a city ordinance that has fuzzy, subjective language for setback, for height, for density."

The original definition of Master Architect—"an architect of recognized greatness in the field of architecture who is included in the list of such architects compiled by the Cultural Heritage Commission, and updated from time to time"—qualified 180 individuals as master architects.

The new definition reads "an architect of widely recognized greatness in the field of architecture whose individual genius influence his or her age," and accompanies a pared-down list.

The bulk of individuals who expressed opposition to the ordinance through letters read into the record by Councilmember Willie Brien, were not residents of the City. On the other hand, the majority of letters conveying support for the amended ordinance were written by City residents.

"The unrestrained elimination of our historic resources makes me incredible mad," said Beverly Hills Heritage President Kimberly Reiss. "If you pass this article as it's currently

The modified ordinance has not yet won the support of the entire Cultural Heritage Commission, with Commissioners Rich Waldow and Rebecca Pynoos speaking against the document.

sultants make decisions on ineligibility for landmark status.

- Assure that Beverly Hills reservation policies conform to state and national standards.

- Notify by mail all neighbors within a two-block radius of a property when a demolition permit is requested. A small sign is not sufficient.

- Require that plans for a replacement structure be submitted and approved before an existing house can be torn down.

- Offer incentives to homeowners willing to save the facades of original structures.

- Study and project the long-term consequences to the City's character by tracking sales and demolition permit data. Make the results public.

## NOTICE OF PUBLIC HEARING

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, June 25, 2015, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard, to consider a request to convert 474 square feet of existing retail space to medical use in the existing building located at **320 North Canon Drive (Rite Aid)**. The proposed project requires the following entitlements:

**Medical Use Overlay Zone:** Application of the City's Medical Use Overlay Zone to the subject property is required to allow any new medical office uses. The subject project is located within the existing 19,044 square foot building occupied by Rite Aid, a retail/pharmacy use. If approved, up to 474 square feet of medical office space could be established within the existing footprint of the building. This would be equal to approximately 2.5% of the building's floor area.

**Planned Development Review:** Pursuant to Beverly Hills Municipal Code (BHMC) §10-3-1859, a Planned Development Review must be processed concurrently with any application for a Medical Use Overlay Zone. A Planned Development Review approval is possible if the reviewing body finds that the proposed project will meet the requirements of the BHMC and will advance the objectives of the zone in which it is located.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 1 Categorical Exemption. This exemption is applicable to projects characterized as minor alterations to existing structures, when the project involves negligible or no expansion of an existing use. In addition, application of the overlay zone is eligible for a Class 5 categorical exemption since the overlay zone results in minor changes in land use limitations that would allow additional types of commercial uses. The project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

**How did you become involved with the Conference and Visitors Bureau?**

I came to L'Ermitage a little over five years ago and I was invited to join the

CVB a year later.

**You have been the General Manager of L'Ermitage Hotel for the past five years. Tell us about that.**

My role has actually expanded in the last two years—I'm actually a Regional General Manager. Currently, I'm talking to you from our property in Santa Monica: the Viceroy Santa Monica. So I'm going back and forth between the two properties. As an hotelier, there are two locations that I've always wanted to sometime in my career be a part of: Beverly Hills and New York. And I feel that I'm ok with Beverly Hills and they've welcomed me here and I've enjoyed working with the community. If this is where my career ends, I'm a pretty delighted guy.

**How does your role at L'Ermitage give you special insight into what it means to attract visitors to Beverly Hills?**

I think what we bring to the table from L'Ermitage, is we corroborate and

validate with our colleagues at other hotels and retailers—we're all on the same page. Additionally, especially in the summertime, from emerging markets such as Australia and Brazil, [visitors] come here and they do shopping at our local retailers, so that's another cache.

**L'Ermitage is currently being renovated. Tell us about that.**

The renovation [of] all public spaces, all the rooms—[are part of] this year's phase. Phase two will be the rooftop, which will be happening sometime by [second quarter] of next year. The designers are SFA, which is Smith Firestone Associates. They're based out of Santa Barbara, but they do have offices here, [on] La Cienega, and they do primarily residential [projects], but they have done hotels. One of the hotels that they did was the Four Seasons on Doheny, a few years ago, I believe. It's going to be an entirely new look, fresh look [and a] major departure from the last time the hotel reopened in 1998. But it will still keep a very elegant and residential feel to it.

**What are your goals as Board Chair?**

One of the dynamic things that has happened over the last year is the CVB has actually focused on international business: China, Brazil, the Middle East. And we are going to pursue expanding those areas for continued business to bring into the Beverly Hills community. For

example, last month we visited Chicago and San Francisco—and perhaps on our horizon, Boston. [We will] continue on with our #1 source of business for most of the hotels in the area, which is New York; we do an annual fall trip there.

**As Board Chair, what will you be happy to have accomplished one year from now?**

I would like to continue the legacy of my predecessor Ben Trodd, to continue and expand our international visibility within the travel community.

**In your interview with the Weekly in issue 672, you said "One of the exciting parts of the CVB is this summer we're moving to our new headquarters... We'll be much more visible, much more approachable by the locals and the people that comes to visit us." How have things changed with the new location?**

From my vantage point, the location is just fantastic, it's literally across from the Annenberg and just steps away from City Hall—it's at a great crossroads. It's much more visible, because most of the majority, the bulk of the people who come visit, the first destination [they want to visit] is Rodeo Drive and at least from L'Ermitage, they walk over there and they walk in front of the CVB offices. And the famous iconic signage is right there. I think it's an ideal location.

## SNOWDEN HANGS UP HIS BADGE

### Retiring BHPD Police Chief Dave Snowden looks back on 49 years in law enforcement

**Forty-nine years is a long time in law enforcement. What made you want to first enter the police academy?**

I first entered the police academy in my hometown, which was Montebello. I grew up there, [my] friends and family were there, I went to high school there—barely graduated from high school. I had a great time in my community and during that period of time I got to know several of the police officers. So, after getting out of active duty in the Army, I applied because a friend of mine, who was a reserve officer there, encouraged me to apply. I did. I'm proud to say that I came out number one in the examination process, and I came out number one in my sergeant's promotional process six years later. And I enjoyed every moment of my career as a young police officer in my hometown. Those people I went to the academy with—that I worked with in those days—are still my best friends: we have an annual reunion, we talk, you've never seen a brotherhood like it. So I'm very proud that I became a cop and that I'm one 49 years later.

**How has law enforcement changed since you first started?**

I would say that law enforcement officers today have to know an awfully lot more than you did when I went to the academy. When I went to the academy, the academy was eight weeks long, now it's close to five months long. Officers have to be computer savvy, they have to know more about different facets of law than they did. The training requirements—not only the academy, but afterwards—are much more rigorous than they ever were in my day. And they've gotten more so as the years pass. Add to that the political correctness of everything you do. How do you tell a young officer to come in and protect the community? And God forbid he ever has to take a life in the line of duty, he now becomes the victim, and he's put on trial for all those actions. As is his family. And it's much more difficult to be a police officer today than it ever has been. And I only envision it getting worse as time goes on. [Also], the technology that is at our fingertips today is so much different. I mean, when I started we didn't have portable radios, we didn't have computers—we did have cars, I'll give you that. All of that

has changed to the point where Beverly Hills, which is probably the most technically advanced department anywhere—large part of that is on my tenure, my 11.5 years here, I'm proud to say, we got everything from automated license plate readers to red light cameras, videos, everything from a British operation center that's technically advanced and other cities can come use it and time a disaster from our place. I could go on and on about the technology systems—they're quite frankly amazing.

**You've worked for four departments, most recently Beverly Hills. How does the BHPD stack up to other departments?**

All of the departments that I've worked for have been very good departments, particularly Costa Mesa. I was the third [person] in the history of [Costa Mesa] to become chief, and I worked there for close to 18 years. The teamwork that was exhibited there was absolutely phenomenal—they're good people, they're friends of mine to this day. There's never been a community as far as I'm aware, that does police work better, that works more cohesively as a team [than Beverly Hills]. Maybe they do that because the community supports them more than any community in the world, probably. I mean, the officers here get to know the residents by first name, as

well as their children. They know the value of keeping themselves safe, the families safe and the businesses safe. If you look at the response times of the police department, they're under three minutes for the last 11 years for emergency calls. The apprehension rate here is exceptional. Just the other day, we had a home invasion robbery and within two days our team had them all in jail, including the car they used. This isn't an anomaly—this happens all the time. They catch people in the act of committing crimes: the other day they stopped a guy right before he was able to smash windows on Rodeo Drive. They caught him with his car with a sledge hammer and ready to operate. They're sharp, they pay attention to what they're doing and the community knows it. It's quite frankly an amazing city to work for. I'd put the Beverly Hills [police department] right at the top.

**What are you most proud of achieving during your 11 years as BHPD Police Chief?**

I am very proud of having created an environment in our department that has resulted in such strong teamwork, innovation and service to the community. I have empowered department members to think out of the box, to try innovative ideas to make the department more effective and to encourage officers to become even closer to our residents. The result has been unequalled response times, the latest technology and the lowest crime rate in the region.

**Do you have any regrets about the EB1 incident?**

When I first started with EB1 it was strictly another business activity which I had

proper clearance for, was totally legal and of no particular significance. I did not realize at the time that people of ill will could later twist that and use that against me for their selfish purposes. At no time was there anything inappropriate in any way with my relationship with that company. Notably, this was all completely disclosed to the City as I proceeded.

**Tell us about your family.**

I'm married to Ellyn. We have two sons: Scott and David. Scott is 43, David is 37. They're both married: Scott to Lisa and David to Angie. David and Angie have two little girls: Maya, who's nine, and Audrey, who's four. I'm very proud of my sons, my daughter-in-laws and

certainly my grandkids. My son Scott has come close to [law enforcement] because he does work as a PI and he does sub-rosa investigations for workers' comp and other kinds of things; he does background checks and subpoenas. David has his own business called Pivotal.com and he does website design, marketing and he's an art director for a company in Arizona. David and Angie just bought a home in Huntington Beach and Scott and Lisa live in Costa Mesa.

**Your wife Ellyn is an event planner with FTA. Tell us about that.**

She went to work for them many years ago, about 10 years ago. At that time, FTA was doing the Black and White Ball for the police department, as well as the Backdraft Ball and Tower Cancer and other things. In fact, one of their big jobs was MusiCares for the Grammy Awards week and Person of the Year award. The POA went away, now they do Tower Cancer and many events, including Person of the Year for Grammy week. She loves doing that. She's the auction coordinator and is responsible for not only going out and finding donations, but making sure those things are presented properly and that the auctions go well. And she loves it, absolutely loves it. She is a major volunteer, not only when we're in Costa Mesa and Newport [Beach], but here in Beverly Hills. She's been on the Board of Directors for the Senior Citizens Association with the City; she used to help with the bookstore at the library. I'm also going to stay at the Beverly Hills Rotary Club and Ellyn and I are seriously thinking of moving into town full time. My other plans after that, I'll save for a future announcement.

ORDINANCE NO. 15-O-2680

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING SMOKING IN PUBLIC AND PRIVATE PLAZAS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby amends and restates Section 5-4-14 of Chapter 4 ("SMOKING REGULATIONS") of Title 5 ("PUBLIC HEALTH, WELFARE, AND SANITATION") of the Beverly Hills Municipal Code to read as follows:

"5-4-14: PROHIBITION OF SMOKING IN PUBLIC AND PRIVATE PLAZAS:

Smoking is prohibited in all public and private plazas except in areas of private plazas that are specifically set aside for smoking and designated by posted signage, provided that such areas are not within twenty feet (20') of building entrances or exits or designated pathways. For purposes of this section, a "public and private plaza" shall mean any unenclosed place, other than a publicly owned sidewalk, that is paved and permanently set aside for pedestrian use, including, for example, a courtyard, plaza or promenade."

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
