“Bond acceleration”

The reason that the new issue of Measure E Bonds have such a high rating is because they are backed by the Beverly Hills high real estate tax base. What the issuer does with the funds is of little concern. The rating agencies are only interested in the ability of the issuer to pay the interest and return the principle. However, if the agencies did additional due diligence they would discover that the financials of the school district are in a state of disarray.

For example: The Beverly Hills school district has more law suits pending than any other school district in the state of comparable size. Measure E bond money to be used for construction purposes has been used to fight the METRO route thru Beverly Hills. General fund money should be used. Beverly Hills spends more than \$14,000 per student on education while other districts having higher ratings spend about \$7,000.

Items of this type and more are not considered by the rating agencies. If they

were, I do not think that these bonds would have such a high rating.

Rec & Parks OKs dog park

The Recreation & Parks Commission unanimously approved a dog park for the southeast intersection of Foothill Road and Alden Drive at their hearing on Tuesday.

The standing-room-only meeting drew in a crowd that included BHUSD Superintendent Steve Kessler and Councilmember Lili Bosse.

A longtime proponent of bringing a dog park to the City, Bosse expressed the need for a more clearly defined timeline.

“At some point, there needs to be some direction so we, as a Council, can move forward or not move forward,” Bosse said.

The Commission has yet to determine whether the park will be accessible to non-residents, whether it will include a division for large and small dogs and whether park users will have to apply for a license or an identification card. The Commission will discuss these issues by October at the latest.

Although four nearby synagogues requested that the dog park not operate during their hours of service and Jewish High Holy days, the Commission recommended that park hours coincide with primary park hours in Beverly Hills.

The Council has already approved \$400,000 for the construction of a dog park, which City staff believes is enough to fund a “functional park” at the proposed loca-

tion, Community Services Director Steve Zoet said at the Council’s August 4th Study Session.

Currently leased by West Coast Arborists, the rectangular project site is approximately 160 feet by 130 feet, with an area of 21,000 square feet.

Total spending per student in the BHUSD amounts to \$14,734, barely a smidgen below the projected expenses of \$15,000 per pupil.

In his “welcome back” letter to district parents and faculty last week, Superintendent Steve Kessler wrote that “[the district is] looking to increase funding by at least \$1,500 per pupil.”

“Our goal is 100% participation by our families to both your school’s PTA and the Beverly Hills Education Foundation,” Kessler wrote.

As a basic-aid district, the BHUSD does not receive state funding based on enrollment numbers; instead, the district receives a lump sum that is distributed evenly among students.

As of Tuesday, BHUSD enrollment stands at 4,162, a 122-student increase since the first day of school, when it hovered around 4,040. This number includes faculty, staff and City employee permits, which usually total around 100.

Climbing from 665 to 709, enrollment at

El Rodeo experienced a 44-student increase, the greatest among all five campuses.

Due to ongoing construction at Horace Mann, students in that zone have the option of attending other neighboring BHUSD schools.

NOTICE OF PUBLIC HEARING

The Council of the City of Beverly Hills, at its meeting to be held on **Tuesday, September 1, 2015 at 7:00 p.m., or as soon thereafter as the matter may be heard**, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ALLOW SYNTHETIC TURF IN RESIDENTIAL FRONT YARDS AND SET STANDARDS FOR SYNTHETIC TURF LOCATED IN STREET SIDE YARDS THAT ARE VISIBLE FROM THE PUBLIC RIGHT OF WAY AND ALL FRONT YARDS

Currently, the City does not allow synthetic or artificial turf in the front yard of single-family and multi-family properties. The City Council will consider a proposed ordinance to allow synthetic turf in residential front yards and set standards for synthetic turf in street side yards that are visible from the public right-of-way, as well as all front yards. Under the proposed ordinance, the installation of synthetic turf would require a building permit.

A resolution recommending standards to the City Council for the Ordinance was previously reviewed and adopted by the Planning Commission on August 19, 2015.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance is eligible for a class 5 categorical exemption for minor alterations in land use limitations and will not have a significant environmental impact. Accordingly, the City Council will consider finding the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the City’s action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

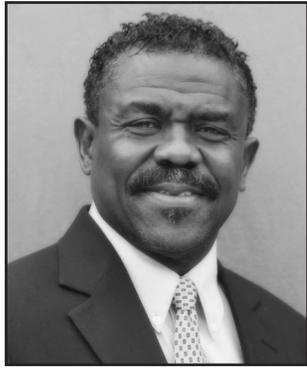

Monday night to recommend for endorsement Board of Education candidates Noah Margo and Carter Paysinger after interviewing both.



Incumbent Board member Lewis

Hall declined to be interviewed by the committee and the other two candidates are not registered Democrats.

The recommendation will go to the full membership on September 30 for a final vote.

Fine Art discusses Kusama fencing, restoration

Pending the search for a designer and an engineer, Yayoi Kusama's "Hymn of Life: Tulips" sculpture at Beverly Gardens Park is currently encircled by a temporary green fence.

The Fine Art Commission approved a fence design submitted by John Lavezzo of Craft Design Build at their meeting in February, but the City has since hired a new designer.

"The plans that were submitted by the previous designer were complete but they were not quite what we had asked for in writing," City librarian Nancy Hunt-Coffey said at the Fine Art Commission meeting on August 20. "The response was that it was going to take a long time and more money to get them where they needed to be; so, after some conversations, we decided to go in a different direction with a designer that would get it done."

"Hymn of Life: Tulips" was originally surrounded by plants, but the City began considering fencing options after it was determined that the plants did not provide a protective barrier.

Both the Fine Art and Recreation & Parks Commissions have been involved in the process, which has exceeded a year.

"Hopefully [the package] will be out to bid by the next meeting," Hunt-Coffey said.

The outdoor sculpture will be restored before the new fence is erected, a three-to-four-week process that will involve checking the hand-painted tulips for water intrusion, rust, corrosion and cracks.

City attorney Larry Wiener said that the goal is to complete the restoration in time for the Beverly Hills Art Show, slated for October 17 and 18.

Council discusses tour bus activity

The City Council continued a longstanding discussion about tour bus operations in the City at their Study Session on August 18.

"Many of the stores in the triangle, especially Rodeo [Drive], want the tour buses, but they don't want them to stop on their street," said Councilmember Willie Brien.

Brien later said that tour buses do not follow the rules and they create traffic congestions. He mentioned that staging is oftentimes a nuisance, as drivers leave the engines running, "creating fumes."

Currently, around 25 City streets are designated for heavy-vehicle usage, meaning the vehicle and its load cannot exceed three tons.

Rodeo Drive Committee President Mark Tronstein read a joint statement drafted by the Committee, the Conference and Visitors Bureau and the Chamber of Commerce advocating for tour bus activity within the business triangle.

"Visitors stay in our hotels, eat at our restaurants and last year spent an estimated \$1.7 billion, and are responsible for generating over 11,000 jobs and \$46 million in tax revenue," Tronstein said. "Approximately 24 percent of our visitors come by bus and they spend an estimated \$137 per person, per day."

Tronstein pointed out that nearby "luxury destinations," including the Beverly Center, the Grove and Westfield Century City, welcome the arrival of tour buses.

The Traffic & Parking Commission reviewed seven tour bus loading zone alternatives at their meeting in July, prioritizing three locations: 200 block of North Beverly Drive, 500 block of North Canon Drive and 9355 Burton Way, adjacent to the courthouse.

"The tour bus loading and unloading situation is a very difficult one to try and solve," said Traffic & Parking Commission Chair Lester Friedman. "No matter what the solution is, it's going to create problems and basically, it's up to the City Council to determine which one is the best option of the ones that are in consideration."

Friedman said that the Canon site makes the most sense, logistically.

The Council directed staff to implement tour bus parking areas on the 200 block of North Beverly Drive near the Montage, for two shuttles only, from 10 pm to 4 pm daily; in front of the courthouse on Burton Way, on weekends and for shuttles only, and on North Crescent Drive next to City Hall, on weekends only.

Following the Council's decision, a six-month pilot period will be put into action on the proposed streets to observe and evaluate tour bus practices.

BHHS set to open football season Friday

Normans to play host to Oak Park

Beverly High is scheduled to open its 89th football season Friday night by playing host to Oak Park at Nickoll Field in a nonleague game involving two teams that were a combined 1-19 in 2014. The opening kickoff is set for 7 p.m.

The Normans have a “senior-dominated team” with goals of starting fast and playing “with a lot of energy on defense,” according to third-year coach Charlie Stansbury.

“We believe we’ve put our kids in a position to be successful,” Stansbury said. “Now it’s time to prove they can do it.”

Beverly Hills was 1-9 in 2014, with the lone victory coming over San Gabriel, which was replaced by Oak Park in the only change to the Normans’ 2015 schedule from 2014.

Beverly Hills allowed at least 40 points in all nine of its losses last season. The Norman offense was held under 10 points six times.

However, in addition to avenging a 2013 loss to San Gabriel, Beverly Hills had smaller losing margins against all five other teams it played in both 2014 and 2013, when it was 0-10 in Stansbury’s first season as its coach.

The Normans have an approximately 35-player roster, five players fewer than Stansbury said he would like.

The team has “a lot of” seniors who were on the 2013 and 2014 teams, Stansbury said.

“Their sophomore year it was a very tough situation, going from freshman football and having a limited numbers where a lot of our sophomores had to play varsity because it was more of a numbers game,” Stansbury said.

“Last year ... we had a limited number of seniors, so a lot of those kids were juniors and they were on the field. Last year was a learning experience for a lot of them because their sophomore year was moving so fast.”

The high school football website calpreps.com projects a 1-9 record for Beverly Hills.

“I don’t care,” Stansbury said. “Let’s play the games.”

Stansbury said he plans to operate a balanced offense using multiple sets. Senior Jake Wolken will be the starting quarterback after starting most of last season.

“He did a great job in the summer,” Stansbury said. “(He) definitely improved from last year to this year. I think he’s going to do a great job managing the offense.

The receiving corps will include seniors Luc Mendez, Hayato Kawamata and Niall Bauer, Stansbury said.

Senior tight end Solomon Nwankwo was a first-team all-Ocean League selection in 2013.

Senior running back Rashad Ysaguirre was a second-team all-league selection in 2014. The Normans’ other running backs include juniors Alex Dennis “who did an amazing job last year for the frosh-soph team” and Wyatt Rhoades, Stansbury said.

Seniors Elijah Klapper and Dylan Rutigliano will play fullback, Stansbury said.

Seniors Paul Garcia and Nathan Meadows will start at tackle, juniors Harrison Van Pelt and Hyunjae Won will play guard and

Genesis Wilson, also a junior, will play center, as part of a seven-man offensive line rotation, Stansbury said.

On defense, “you’ll see us move around in more multiple sets,” Stansbury said.

“We’ll be much more aggressive,” Stansbury said.

Wilson will be the starting nose guard and be joined on the defensive line by Garcia, Meadows and senior Roey Marcus, Stansbury said.

The linebackers will be Jonathan Hakimi, a senior, Mendez, Nwankwo, Rutigliano and Ysaguirre, Stansbury said.

The defensive backs will be senior Skylar Derrick, who “has done a great job this year,” Stansbury said, along with Bauer, Dennis and Rhoades.

Junior Patrick Levy will return as kicker and punter.

Beverly Hills was initially going to face Oak Park in a scrimmage, but when Eagles’ second-year coach Tim Kenney was able to cancel the second year of a contract to play Bishop Diego, it was decided that the Normans and Oak Park would play in a game.

The Eagles opened their 0-10 2014 season by losing to Bishop Diego 56-0.

Oak Park uses the spread offense and expects to pass more than it did last season, said Kenney, who played college football at Notre Dame in 2005-2006.

Dick Billingsley, who was Beverly Hills co-coach from 1985-89 with Stansbury’s father Bill, is a co-athletic director at Oak Park and is expected to attend the game, the younger Stansbury said.

The Normans conducted a 40-play scrimmage with Windward on Friday where they “did some really good things” and “made some mistakes that hopefully we got out of the way,” Stansbury said.

“We were able to move the ball on offense and on defense we made some stops and we had some big hits that we haven’t seen in the last two years,” Stansbury said.

The mistakes included jumping offside, losing a fumble and having a pass intercepted.

“Right after we threw it we knew exactly what we did wrong, so that was encouraging when we know how to correct the mistakes we’re making,” Stansbury said.

Beverly Hills also caused and recovered a fumble against the Wildcats, Stansbury said.

The Normans have lost four consecutive season openers and seven of their last eight, including a 41-7 loss in their 2014 opener to Templeton, which it will play against on Sept. 5.

“More than anything, I think that our team is going to represent the school and the community in a way that they can be proud of through their effort and their commitment,” Stansbury said.

“This group of seniors has done a lot to improve themselves in the last two years. The expectation is that when they go out there and they play in the game, they’re

Temple Emanuel debate focuses on the Iran Nuclear deal

Temple Emanuel hosted a debate on the Iran nuclear deal featuring 30 Years After President Sam Yebri and USC lecturer Josh Lockman on Monday night. AJC Los Angeles and 30 Years After cosponsored the event.

How did the Temple Emanuel debate go Monday?

Yebri: I think there was a great demand for this debate among the Jewish community and among those who are following these issues. It's ironic that Josh and I were identified as participants here because we both are from the Los Angeles/Beverly Hills area and have a very similar educational background at Yale and USC and studied and examined this deal very closely. In my view, I thought the forum was spirited and informative, yet we were able to keep it very civil at a time when the debate raging over this deal has become quite emotionally charged and divisive.

Lockman: Sam and I agree wholeheartedly on the threat that Iran poses, not just to Israel or the region, but possibly the entire international community. What we were able to do [Monday night] was have a civil and constructive discussion [about] what are reasonable arguments of both sides. While he opposes [the deal], I support it. Relative to the kind of vociferous rhetoric that's come out, not just in Washington, but in the American community, we were able to model the civil, constructive type of debate that we're not seeing so much of but that should be occurring. Also, the American Jewish community on all generational levels—whether our age, [because] we're young, or older—is not monolithic on this issue.

Sam, you think the Iran nuclear deal is a dangerous one for the United States. Why?

I think the biggest weakness of the deal is the fact that the restrictions of the deal expire after 10, and in some cases 15, years, which means that if Iran complies with the letter of the agreement, it would be free from any restrictions to sprint to obtain nuclear weapons at that point. And then the Iran that we face, at that point, will be freed from international sanctions, very economically wealthy, militarily strong because the arms embargo and ballistic missiles embargo would be lifted, and we would face a much more dangerous threat within Iran, [and Iran] will potentially be days away from a nuclear weapon.

Josh, what is your perspective on the deal?

No deal is perfect, this one included, but this is a good enough deal and acts as a first and important step in preventing Iran—in the short and long term—from obtaining nuclear weapons. It's important to remember that this deal won't occur in a vacuum, but will be implemented in tandem with tough policies, not just by the United States, but by other nations, which will guarantee that the balance of power in the Middle East does not shift in Iran's favor and actually bolsters the position, in the shorter and long run, of our allies—namely Israel and Saudi Arabia and the Saudi Gulf. Again, as Sam pointed out, it remains the policy of the United States that Iran never obtains nuclear weapons. This deal has the imprimatur of legitimacy and support from a huge number of people in that community who believe that this deal does a good enough job at year one, year five, year ten and year fifteen. It's important to remember that we're putting in place a deal that the architecture of which will be enhanced over the coming years and decades. By no means does the United States or the international community intend, after year ten or year fifteen, to acquiesce to an Iran that moves towards nuclear weapons. [Sam and I] just have a difference of opinion

on what happens in a decade or 15 years from now. There are people that think, like Sam, that Iran could quickly move, in a matter of days and weeks, to revert their program into a fully functional nuclear weapons program and there are others that think it's naïve to think that they will be able to do that with the type of monitoring and intrusive mechanisms of oversight that the deal entails.

What is your response to people who say that support for the deal equates to support for the Iranian regime?

Lockman: I disagree. I think equating people that oppose the deal to the hardliners in Iran are people that support the deal as being weak on Israel—I really just don't buy into that tone. I don't think it's constructive and I think it really belies the reality of what this is about—which is narrowly, this deal stops Iran from obtaining nuclear weapons. I disagree with that kind of moral equivalence, if you will.

Yebri: That type of argument is blatantly an attempt to silence valid criticisms of the deal at a time when what we need more than anything else is a broad, robust, open debate.

Do you plan to do other debates like this in the future?

Yebri: If others invite us, then yes. Encourage your readers to invite us to do it again.

Lockman: Yes, we'll do it again, it went well. Sam and I are longtime friends, like I said, and it was a great experience.

ORDINANCE 15-O-2685

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING PARKING PERMITS FOR BEVERLY HILLS UNIFIED SCHOOL DISTRICT PERSONNEL

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby adds Section 7-3-124 ("SP PARKING PERMITS") to Article 1 ("General Standing, Stopping, and Parking Provisions") of Chapter 3 ("STANDING, STOPPING, PARKING") of Title 7 ("TRAFFIC, PARKING, AND PUBLIC TRANSPORTATION") of the Beverly Hills Municipal Code to read as follows:

"7-3-124: SP PARKING PERMITS:

A. For purposes of this section, "street block" is defined as the portion of a street that lies between two (2) immediately intersecting streets, and includes both the side of the street immediately adjacent to a school property and the opposite side of the street.

B. A vehicle which bears an SP parking permit may park as follows while being used for official Beverly Hills Unified School District business:

1. In a non-metered parking space for a period of time in excess of the posted maximum parking time permitted on a street block adjacent to Beverly Vista School, El Rodeo School, Hawthorne School and Horace Mann School, except as follows:

a. During posted peak hour parking restriction periods.

b. The SP parking permit may not be used on a street block adjacent to Horace Mann School after construction of the underground parking facility on the Horace Mann School campus is completed.

2. In any preferential parking permit zone on a street block adjacent to Beverly Vista School, El Rodeo School, Hawthorne School and Horace Mann School, except as follows:

a. The SP parking permit may not be used on a street block adjacent to Horace Mann School after construction of the underground parking facility on the Horace Mann School campus is completed.

3. In the City-operated parking structure, located at 450 North Rexford Drive, without payment of the required fees and in excess of the maximum permitted time for parking.

C. An SP parking permit shall be issued by the Director of Public Works Services only as follows:

1. One permit to each current member of the Beverly Hills Unified School District Board of Education. When such persons cease to be on the Beverly Hills Unified School District Board of Education, the SP parking permit issued to the holder under this subsection C.1 is deemed void and is invalid for the uses set forth in this section. The permit holder shall return the permit to the Director of Public Works Services.

2. One permit each to the following employees of the Beverly Hills Unified School District: (i) Superintendent of Schools; (ii) Chief Academic Officer; (iii) Director of Student Services and Special Projects; and (iv) Chief Administrative Officer. When such persons cease to be an employee of the Beverly Hills Unified School District or are no longer in the position listed herein, the SP parking permit issued to the holder under this subsection C.2 is deemed void and is invalid for the uses set forth in this section. The permit holder shall return the permit to the Director of Public Works Services.

D. SP parking permits shall be displayed in the lower left corner of the front windshield of a vehicle legally registered to a person issued a permit under this section."

Section 2. CEQA Findings. The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption and implementation of this Ordinance may have a significant effect on the environment. The Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Section 3. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 4. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

ORDINANCE 15-O-2686

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING BICYCLES ON SIDEWALKS IN THE BUSINESS DISTRICT

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The city council hereby amends and restates paragraph B of Section 5-6-801 ("Bicycles, Skateboards, And Roller Skates Prohibited on Sidewalks in the Business District") of Article 8 ("Bicycles, Skateboards, And Roller Skates Prohibited In Certain Areas") of Chapter 6 ("MISCELLANEOUS RESTRICTIONS AND PROHIBITIONS") of Title 5 ("PUBLIC HEALTH, WELFARE, AND SANITATION") of the Beverly Hills Municipal Code to read as follows:

"B. Subsection A of this section shall not apply to on duty peace officers as defined in section 830 of the state Penal Code, on duty city parking enforcement officers and city parking control officers, and other persons as authorized by the City for a specific purpose."

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

ORDINANCE NO. 15-O-2687

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ESTABLISHING PROCEDURES FOR EXPEDITED PERMIT PROCESSING FOR SMALL RESIDENTIAL ROOFTOP SOLAR ENERGY SYSTEMS, AND AMENDING TITLE 9 OF THE BEVERLY HILLS MUNICIPAL CODE

WHEREAS, the State of California and the City of Beverly Hills have

consistently promoted and encouraged the use of solar energy systems; and

WHEREAS, the State of California recently adopted Assembly Bill 2188, which requires local agencies to adopt an ordinance that creates an expedited, streamlined permitting process for small residential rooftop solar energy systems; and

WHEREAS, creation of an expedited, streamlined permitting process for small residential rooftop solar energy systems will facilitate timely and cost-effective installation of solar energy systems and help reduce the City's reliance on environmentally damaging fossil fuels.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. Article 1 of Chapter 1 of Title 9 of the Beverly Hills Municipal Code is hereby amended by adding a new Section 9-1-105 to read as follows:

“9-1-105: EXPEDITED PERMITTING PROCESS FOR SMALL RESIDENTIAL ROOFTOP SOLAR ENERGY SYSTEMS:

A. Definitions:

1. “Small residential rooftop solar energy system” means a system that meets all of the following criteria:
 - a. A solar energy system that is no larger than 10 kilowatts alternating current nameplate rating or 30 kilowatts thermal; and
 - b. A solar energy system that conforms to all applicable state fire, structural, electrical, and other building codes as adopted or amended by the City, and paragraph (3) of subdivision (c) of Section 714 of the Civil Code; and
 - c. A solar energy system that is installed on a roof of a single or duplex family dwelling; and
 - d. A solar panel or module array that does not exceed the maximum legal building height as defined or prescribed in this Code.

2. ‘Solar energy system’ has the same meaning as set forth in paragraphs (1) and (2) of subdivision (a) of Section 801.5 of the Civil Code, as such section or subdivision may be amended, renumbered, or redesignated from time to time.

3. ‘City’s adopted checklist’ means and refers to a checklist of requirements with which small residential rooftop solar energy systems must comply in order to be eligible for expedited review pursuant to this Chapter. The checklist shall substantially conform to the recommended process and checklist contained in the current California Solar Permitting Guidebook, as adopted by the Governor’s Office of Planning and Research. The City’s adopted checklist shall be published on the City’s website.

B. A small residential rooftop solar energy system permit application that satisfies the information requirements in the City’s adopted checklist shall be deemed complete and shall be promptly processed, consistent with the recommended process contained in the current California Solar Permitting Guidebook as adopted by the Governor’s Office of Planning and Research. Upon confirmation by the Building Official that the permit application and supporting documents meet the requirements of the City’s adopted checklist, and are consistent with the requirements of this Chapter, the Building Official shall, consistent with Government Code Section 65850.5(b), approve the application and issue all necessary permits. Such approval does not authorize an applicant to connect the small residential rooftop solar energy system to the local utility provider’s electricity grid. The applicant is responsible for obtaining such authorization from the local utility provider. If the Building Official determines that the permit application is incomplete, a written correction notice shall be issued, detailing all deficiencies in the application and any additional information required to be eligible for expedited permit issuance. Consistent with Government Code Section 65850.5, a solar energy system permit shall not be conditioned on the approval of such system by an ‘association’, as that term is defined in Civil Code Section 4080.

C. Consistent with Government Code Section 65850.5, the Building Official shall allow for electronic submittal of permit applications covered by this Ordinance and associated supporting documentation. ‘Electronic submittal’ shall mean by email, Internet, or FAX. In accepting such permit applications, the Building Official shall also accept electronic signatures on all forms, applications, and other documentation in lieu of a wet signature by any applicant.

D. The Building Official shall require only one inspection for small residential rooftop solar energy systems eligible for expedited review as provided in this Chapter. Such inspection shall be performed in a timely manner. If the small rooftop solar energy system fails the single inspection, an additional inspection may be conducted at the applicant’s expense.

E. To the maximum extent permitted by law, the provisions of this Chapter shall supersede and govern in the event of any conflict or inconsistency between this Chapter and any other provision of this Code or any ordinance of the City.”

Section 2. Exemption from the California Environmental Quality Act. The City Council finds that the adoption of this Ordinance is exempt from the California Environmental Quality Act (CEQA) pursuant to the General Rule (14 C.C.R. Section 15061(b)(3)) because the project involves updates and revisions to existing administrative building permit regulations consistent with California law, specifically Government Code section 65850.5 and Civil Code section 714. It can be seen with certainty that the Municipal Code text amendments adopted herein will have no significant negative effect on the environment. Additionally, the adoption of this Ordinance is categorically exempt from further environmental review as a regulatory action taken to protect natural resources and the environment in support of state and local climate action goals pursuant to CEQA Guidelines, 14 C.C.R., Sections 15307 and 15308.

Section 3. Severability. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of any competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance, and each and every section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional without regard to whether any portion of the Ordinance would be subsequently

declared invalid or unconstitutional.

Section 4. The City Clerk shall certify to the adoption of this Ordinance.

Section 5. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage, and shall become operative on September 18, 2015.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ADOPTING BY REFERENCE ARTICLE 3 (“ANIMALS AND FOWLS”) OF CHAPTER V (“PUBLIC SAFETY AND PROTECTION”) OF THE CITY OF LOS ANGELES MUNICIPAL CODE, AND AMENDING ARTICLE 3 (“ANIMAL CONTROL AND LICENSING REQUIREMENTS”) OF CHAPTER 2 (“ANIMALS, FOWL, AND REPTILES”) OF TITLE 5 (“PUBLIC HEALTH, WELFARE, AND SANITATION”) OF THE BEVERLY HILLS MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby amends and restates Section 5-2-301 of Article 3 (“ANIMAL CONTROL AND LICENSING REQUIREMENTS”) of Chapter 2 (“ANIMALS, FOWL, AND REPTILES”) of Title 5 (“PUBLIC HEALTH, WELFARE, AND SANITATION”) to read as follows:

“5-2-301: CITY OF LOS ANGELES ANIMAL CONTROL ORDINANCE ADOPTION:

A. Except as hereinafter provided, Article 3 of Chapter V, Animals and Fowls, of the Los Angeles Municipal Code, as amended and in effect on July 1, 2015, is hereby adopted by reference as the Animal Control Ordinance of the City of Beverly Hills and may be cited as such.

A copy of article 3 of chapter V, Animals And Fowls, of the Los Angeles municipal code, as amended and in effect on July 1, 2015, has been deposited in the office of the city clerk of the city of Beverly Hills and shall at all times be maintained by the city clerk for use and examination by the public.

B. Notwithstanding the provisions of subsection A of this section, whenever any of the following words and phrases are used in the animal control ordinance, except for Sections 53.18.5, 53.34.2, 53.34.3, and 53.34.4 of the Los Angeles Municipal Code as adopted by reference, such name or term shall be defined as follows:

BOARD OF ANIMAL SERVICES COMMISSION: Shall mean and include the Beverly Hills hearing officer.

CITY OF LOS ANGELES OR CITY: The city of Beverly Hills, except where the city of Los Angeles is the correct notation due to the circumstances.

DEPARTMENT (Or Any Similar Term): Shall mean and include the code enforcement division of the Beverly Hills building and safety department.

GENERAL MANAGER (Or Any Similar Term): Shall mean and include the director of community development, or his designee, of the city of Beverly Hills.

Whenever the animal control ordinance refers to a “person owning or having charge, care, custody or control of any animal”, or whenever the animal control ordinance refers to an “owner”, that person or owner shall mean “guardian” for the purposes of the animal control ordinance, referring to any person who cares for a domestic pet.”

Section 2. The City Council hereby amends and restates Section 5-2-302 of Article 3 (“ANIMAL CONTROL AND LICENSING REQUIREMENTS”) of Chapter 2 (“ANIMALS, FOWL, AND REPTILES”) of Title 5 (“PUBLIC HEALTH, WELFARE, AND SANITATION”) to read as follows:

“5-2-302: ANIMAL CONTROL ORDINANCE AMENDED:

A. Notwithstanding the provisions of section 5-2-301 of this article, the animal control ordinance is amended by deleting sections 53.08, 53.15.1, 53.38, 53.39, 53.42(c), 53.42(d), 53.43, 53.47, 53.49, 53.55, 53.59, 53.60, 53.63, 53.64, 53.68, and 53.69.

B. Notwithstanding the provisions of section 5-2-301 of this article, the following text from section 53.50(f) is hereby deleted: “The fees imposed herein for a pet show or a dog show shall be waived in the event that such show is held in a public park”.

C. Notwithstanding the provisions of section 5-2-301 of this article, the following text from section 53.73 is hereby deleted: “The ordinance will become operative six months after its effective date, and expire on June 30, 2016, unless extended by ordinance”.

D. Notwithstanding the provisions of section 5-2-301 of this article, the animal control ordinance is amended by amending sections 53.00 (amending the definitions of “Cat Kennel” and “Dog Kennel”), 53.06, 53.06.2, 53.15.2(c), 53.18.5 (amending the first two sentences only), 53.27, 53.33, 53.42(e), 53.50(a), and 53.66 to read as follows:

53.00 Cat Kennel.

“Cat Kennel” shall mean any dwelling unit, structure, or premises, whereon or wherein six (6) or more cats over the age of four (4) months are kept, harbored, or maintained for any purpose, other than in a pet store for sale to the public or for care or treatment in an animal hospital.

53.00 Dog Kennel.

“Dog Kennel” shall mean any lot, building, structure, or premises whereon or wherein four (4) or more dogs over the age of four (4) months are kept, harbored or maintained for any purposes other than in a pet shop for sale to the public or for care or treatment in an animal hospital.

53.06 Animals at Large

No person owning or having possession, charge, custody or control of any animal, except cats which are not in heat or season, shall cause, permit or allow the animal to stray, run, or in any manner to be at large in or upon any public street, sidewalk or park.

53.06.2 Restraint Of Dogs.

Every person owning or having charge, care, custody or control of any dog shall keep such dog exclusively upon his own premises provided, however, that such dog may be off such premises if it be under the control of a competent person and restrained by a substantial chain or leash not exceeding six feet in length.

53.15.2(c) Breeding Permit.

- (1) No person shall cause or allow any dog or cat owned, harbored or kept within the city of Beverly Hills to breed.
- (2) Any commercial establishment selling dogs and cats shall prominently display the name and address of the breeder(s) of such dogs and cats and any other information required by the general manager.
- (3) Any commercial establishment which sells or otherwise transfers a dog or cat, whether for compensation or otherwise, shall provide to the new animal owners city application(s) for a license and permit as well as written information regarding the license and permit requirements of the city applicable to such animal.

53.18.5 Hearing Procedures and License Revocations

This section shall govern procedures for the revocation of dog licenses and related matters. For purposes of this section the term “dog” includes the plural and the term “owner” means the owner or person having charge, care or custody of a dog.

53.27 Transfer Of Ownership; Notice Required.

Each owner or operator of any dog hospital or pet shop or a veterinarian who sells, gives away or in any manner causes the ownership or permanent possession of any dog, whether over four (4) months or age or not, to be transferred to any person, shall notify in writing the department of that fact within five (5) days after the date of such sale or transfer. Such notice shall state the kind of dog, the name of such dog, if any, and the person to whom such dog has been sold or transferred.

53.33 Vicious Animals - Private Premises.

It shall be unlawful for any person to keep within the city a vicious dog, nor shall any person, owning or having custody or control of any dog, or any other animal known by such person to be vicious or dangerous, shall permit it to run at large, or permit it to run loose on or within the premises of such person in such a manner as to endanger the life or limb of any person lawfully entering such premises.

53.42(e) Animals, Sale Of - As Novelties - On Streets.

(e) This section shall not be construed to prohibit the display or sale of rabbits, natural chicks, ducklings or other fowl, in proper faculties by stores engaged in the business of selling the same, to be raised for food purposes.

53.50(a) Permit Required.

No person, without first obtaining a permit therefor in writing from the department, shall keep, contain or operate within the city any pet shop, animal grooming parlor, pony ring or pony ride, circus, pet show, cat show or animal acts or exhibitions.

53.66 Guard Dogs.

- (a) No person shall keep, use or maintain any guard dog or sentry dog within city limits.
- (b) For the purposes of this section, “guard dog” means any dog kept, used or maintained on any commercial or industrial premises or any dog used to guard, protect, patrol or defend any property or person.
- (c) For the purposes of this section, “sentry dog” means any dog trained to guard, protect, patrol or defend any premises, area or yard, or any dog trained as a sentry or to protect, defend or guard any person or property or any dog which is schutzhund or any similar classification.”

Section 3. The City Council hereby amends and restates Section 5-2-303 of Article 3 (“ANIMAL CONTROL AND LICENSING REQUIREMENTS”) of Chapter 2 (“ANIMALS, FOWL, AND REPTILES”) of Title 5 (“PUBLIC HEALTH, WELFARE, AND SANITATION”) to read as follows:

“5-2-303. VIOLATIONS; PENALTY:

A. Unless a different penalty is provided for in this chapter, violation of any provision of the animal control ordinance shall be punishable as provided in Article 1 of Chapter 3 of Title 1 of the Beverly Hills Municipal Code.

B. Any person violating any of the following sections of the Animal Control Ordinance is guilty of a misdemeanor that is punishable as provided for in Article 1 of Chapter 3 of Title 1 of the Beverly Hills Municipal Code:

Section 53.03(c)
Section 53.06.5(c)
Section 53.15(f)
Section 53.15.2(b)(2)(F)(7)
Section 53.15.2(d)
Section 53.15.3(b)

Section 53.18.5(n)
Section 53.34
Section 53.34.2(a)
Section 53.34.4(f)(1)
Section 53.58
Section 53.64(e)
Section 53.72(c)”

Section 4. CEQA Finding. The City Council hereby finds that it can be seen with certainty that there is no possibility the adoption of this Ordinance will have a significant effect on the environment because the Ordinance only regulates animal services within the City. The Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act pursuant to Section 15061(b) (3) of Title 14 of the California Code of Regulations.

Section 5. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 6. The City Clerk is directed to forward a certified copy of this Ordinance to the Director of the City of Los Angeles Department of Animal Services.
