City holiday program comes with \$325K price tag

A liaison team that includes councilmembers and members of the Rodeo Drive Committee met Monday to discuss the City's event plans for the upcoming holiday season.

Estimated to cost around \$89,000, the lighting ceremony will kick-off festivities on November 22 at 6 pm. According to the agenda packet, the event will take place on a stage erected on the southern end of Rodeo Drive's 200 block. A variety of performers and musical guests "with cross-generational appeal" will participate in the ceremony.

The total estimated cost for the City's holiday program stands at \$325,000. The amount includes the lighting ceremony, entertainment and holiday décor (see charts on the left).

Ordaz files police report following signage theft

Beverly Hills resident Alma Ordaz filed a police report Monday after four lawn signs for Board of Education candidates Isabel Hacker and Mel Spitz were stolen from her property over the weekend. Ordaz, who is Hacker's campaign co-chair, later discovered the signs inside a



dumpster.

"When we returned from dinner at approximately 9:00 pm [on Saturday], my four lawn signs were gone, including the two that were deep within our property line and not near the public walkway," Ordaz said.

That afternoon, Ordaz had received a call from a young woman asking her to support Board candidate Lewis Hall.

"I politely but firmly declined to answer," Ordaz said. "Is it too much of a coincidence that four to five hours later my lawn signs were gone? What discomforts me the most is that these people had to come well into the private space."

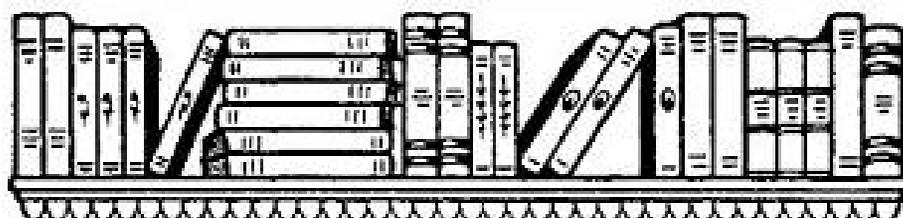

"Every time I visit the Wallis I feel passionate about the opportunities that exist for this amazing organization in the heart of Beverly Hills," Crewes said in a statement. "I recognize the challenges of making a performing arts center work in Beverly Hills; however, it is those very challenges that will inspire me to think differently about how to generate audiences for the center's work."

While at Kneehigh, Crewes produced theatre and dance pieces for several different performing arts institutions, including the West Yorkshire Playhouse, the Lowry and Phoenix Dance Theatre and Metal.

The Wallis began its international search for an Artistic Director in March.

A critically acclaimed Off-Broadway production, *Wiesenthal* kicks off the Wallis' 2015-16 theater season in the Lovelace Studio Theater on October 24 at 8 pm.

The play tells the true story of Holocaust survivor Simon Wiesenthal, who is often called the "Jewish James Bond." *Wiesenthal* devoted his life to bringing more than 1,100 Nazi war criminals to justice after World War II.

Wiesenthal will run until November 8. The one-man production stars Tom Dugan.

PLEASE TAKE NOTICE that on **Tuesday, October 6, 2015 at 7:00 p.m., or as soon thereafter as the matter may be heard**, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, the Council of the City of Beverly Hills will consider adopting an ordinance entitled:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ALLOW SYNTHETIC TURF IN RESIDENTIAL FRONT YARDS

A summary of that Ordinance, which has been prepared for publishing in accordance with the requirements of Government Code Section 36933, follows.

Summary of Ordinance

Currently, the City does not allow synthetic or artificial turf in the front yard of single-family and multi-family properties. The City Council will consider a proposed ordinance to allow synthetic turf in residential front yards and allow synthetic turf to count toward required landscaped area in front yards. Under the proposed Ordinance, the installation of synthetic turf would require a building permit.

The Ordinance would establish regulations for maximum front yard coverage and required barriers of synthetic turf from the front property line and residential buildings. Under the proposed Ordinance, synthetic turf may not be installed more than 70% of the landscaped area in a front yard (not to exceed 40% of the entire front yard). Additionally, synthetic turf will not be allowed within eighteen inches of the front property line and three feet of a residential dwelling.

The Ordinance would also establish criteria for synthetic turf that is installed in residential front yards. These criteria state that synthetic turf must:

- be of a type known as cut-pile infill;
- consist of parallel-long slit blades that are manufactured from polyethylene or polypropylene (minimum two blade colors);
- have a blade length between 1 3/4 and 2 1/2 inches;
- contain a thatch layer that is beige or tan;
- comply with all federal and state standards related to lead and heavy metal content;
- be resistant to staining, weather, insects, rot, mildew and fungus growth;
- contain an infill material of clean silica sand or zeolite (no rubber infill allowed);
- be affixed to a permeable backing with a tuft bind strength of at least 8 pounds;
- have a drain rate of at least 30 inches per hour;
- have a manufacturer's warranty lasting at least 8 years;
- have a spacing between tufting rows of no more than 3/8 inch;
- have a face weight of at least 60 as defined by the manufacturer;
- have a tear grab strength of at least 200 pounds; and
- pass the pill burn test for flammability.

Finally, the Ordinance would establish regulations on the installation of synthetic turf in residential front yards and the maintenance of turf. Under the proposed Ordinance turf would be required to be installed by a licensed installer. Seams of the synthetic turf must be sewn and not visible, and all existing irrigation infrastructure in the synthetic turf area must be capped or removed. The Ordinance would require property owners to maintain turf in an attractive and clean condition without holes, stains, discoloration, seam separation, uplifted surfaces, heat degradation, or excessive wear.

BHHS football team routed by San Marino Normans to play at South Pasadena Friday

The Beverly High football team was in "great shape" at the end of the first quarter of its nonleague game against San Marino Friday night, trailing by eight points and just having stopped the Titans on a fourth-and-one play, Norman coach Charlie Stansbury said.

Beverly Hills then "sputtered on offense at times" and was held scoreless the rest of the game, losing 49-6 at Nickoll Field, Stansbury said.

"(We) had a chance to make some plays to keep us right there and we weren't able to do it," Stansbury said. "When you leave your defense out there for a long time against a team like that, you're going to pay a price and we did in the second quarter."

Titan quarterback Carson Glazier threw four of his six touchdown passes in the second quarter as San Marino turned a 14-6 lead at the start of the quarter to a 42-6 advantage at halftime.

Glazier completed 12 of 17 passes for 401 yards, as the Titans out-gained the Normans 601 yards to 94.

Beverly Hills quarterback Jake Wolken completed three of nine passes for 79 yards and one touchdown and had one pass intercepted.

San Marino took a 14-0 lead on Glazier's 77- and seven-yard first quarter touchdown passes to J.P. Shohfi and Quentin Dunkel.

Norman senior running back Rashad Ysaguirre broke a tackle to turn a third-down five-yard out pass from Wolken in the first quarter into a 75-yard touchdown, Ysaguirre's third touchdown of the season and Wolken's second touchdown pass.

Titan senior Aiden Santino ran nine yards for the game's final touchdown with eight minutes, 41 seconds remaining in the third quarter. About the final quarter-and-a-half was played with a running clock, Stansbury said.

Beverly Hills (0-4) was held to six or fewer points for the third time this season because of poor field position and the difficulty of sustaining a drive against a good Titan team, Stansbury said.

Norman senior nose guard Dashawn Lomax drew praise from Stansbury for making "a couple of big plays," including on the four-and-on stop. Linebacker Solomon Nwankwo also drew praise from Stansbury, as did Ysaguirre.

One accomplishment by the Beverly Hills defense was forcing San Marino to

PROJECT DESCRIPTION

The proposed project involves the construction of a new multi-family residential condominium building containing a total of 31 units on the property located at 332-336 N. Oakhurst Drive. The subject property is partially located in the City of Beverly Hills (westerly portion, including building frontage on N. Oakhurst Drive), with a majority portion located in the City of Los Angeles (easterly portion). The proposed project would have a total height of 4 stories and 40' for the portion of the building located in Beverly Hills, and a total height of 5 stories and 59'-11" for the portion of the building located in Los Angeles. The portion of the building located in Beverly Hills would contain a total of 7 units, with the remaining 24 units located in Los Angeles. ENVIRONMENTAL REVIEW

The subject property is partially located in the City of Beverly Hills, with a majority portion located in the City of Los Angeles. As the designated lead agency for this project, the City of Los Angeles prepared an Initial Study to determine the proposed project's potential impact on the environment. After reviewing the Initial Study, the lead agency determined that this project may have a significant effect on the environment, but by implementing certain mitigation measures, the project's potentially significant effects could be reduced to less than significant levels. people & profiles

Jon Gluck

Co-Founder & President of Beverly Hills Drink Company, home of 90H2O

Tell us about your pathway to entrepreneurship.

I started my first business when I was 14, I started very young. I have an incredible dad who exposed me to business from a very young age—he was the kind of dad who was bringing me to board meetings when I was five and ten and exposing me to the world of business. Something sunk in, and when I was 14, I had the itch to dive into business for myself for the first time. That was the first time and I haven't stopped since. Ever since [I was] 14, I've been building companies and I've been building brands. I really enjoy creating something that people can fall in love with and find value in and that can bring something special into their life. Over that journey, I've been in a number of different industries, so it's kind of worked out that way. I've been in everything from sports to technology to events to marketing and now, [the] beverage [industry]. One of the keys to entrepreneurship is that you have to be comfortable with change and chaos—it's just the way it is, there is no way around it, there is no shortcut.

Give us one of the most challenging aspects of being an entrepreneur.

I smile because there is so much that's challenging about entrepreneurship. There's a saying I really believe in that [states that], "Entrepreneurship is a nightmare disguised as a dream"—until you make it, until it becomes the actual dream, but that journey is an absolute nightmare, and that's not unique to me and that's not unique to first-time entrepreneurs. I've been fortunate enough to sit down with Fortune 500 executives and I make sure to actually carve out time out of every week where I'm making sure that I'm either having calls or meetings

or coffees with both novice entrepreneurs and very successful people. [I find that] one of the things that's consistent is that this entrepreneurial journey is just very challenging. [For instance,] balancing all of the different areas it takes to build a company—in one day, having to pay attention to sales, marketing, operations, employees, regulation, taxes, distribution, manufacturing. I don't get to spend my entire day on marketing or my entire day on going out there and selling. When you're in that start-up, chaotic phase, you're literally balancing hundreds of things, so that is an incredibly challenging thing to do.

What's one thing that went differently in your business plan than you expected?

Manufacturing has turned out to be a much greater challenge than I would have ever anticipated. Here is what I've figured out to be the challenge with manufacturing: the nature of manufacturing is volume. Bottling facilities and material suppliers are all about pumping as much volume, as quickly as possible [and] as many as possible. That comes in conflict when you're trying to build a top-quality product. The reason that premium products and luxury products charge more [is] not just about a brand or an experience, it's because the quality of the product is actually better, and that quality comes from the manufacturing of that product. We had such a clear vision of this out-of-this-world quality we wanted from day one and what ended up happening is we ran up against every possible challenge you can think of in getting the manufacturing world to respond to our vision of a new level of quality. Fortunately, we've overcome that, but I can say there was a solid two years—prior to launch and just



after launch—where manufacturing was a major challenge. Now we're in an amazing place where we have the right manufacturing partners, we have the right systems, we have the right materials and we've been able to maintain and achieve the quality that we set out to achieve.

What's your response to people who say that water bottles are an unnecessary luxury?

People have to remember that bottled water started as a convenience factor. People wanted to stay hydrated and have access to water when they were on the go and there simply wasn't convenient-enough access. Once you leave your house, you no longer have access to the tap [water] at home. Municipalities and cities have never done a good-enough job giving access to water. What ended up happening was that a bunch of entrepreneurs saw a problem and they came together and said, "Let's provide a solution." People have to remember that even though bottled water has evolved—in some segments—[to become] a lifestyle product, an accessory and even a luxury, at its base, it has a very important convenience factor. Here we are, decades after Evian and Fiji and Voss, and the consumer has had the opportunity to reject the concept of premium water and they haven't. In fact, they've embraced the concept.

How did you get involved in local politics?

My roots are here in Beverly Hills

and I've really enjoyed this City for many years. In 2011, I came across the City's Team Beverly Hills program and I jumped on the opportunity, applied and was selected. That single experience sparked something within me, helping me fall even deeper in love with Beverly Hills and giving me a deeper appreciation for what it takes to run this incredible City. After that experience, I took a step back and thought *let's get more involved, let's see where I can help*. I don't want to be someone who's constantly taking, I don't want to be someone that is constantly just cruising along in life, I want to be the guy that's going above and beyond to deliver value every minute of every day. With those things in mind, I thought, *where can I contribute more?* One of the things that came organically was getting involved in local campaigns and the first campaign that I worked on was [Board of Education member] Noah Margo's 2011 campaign. My sister [Stacey Gluck] introduced me to Noah and mentioned that Noah doesn't have a background in politics—this was in 2011—and he's just really passionate about getting involved and helping the City and the schools and he needs someone to help guide him on messaging and marketing and strategy. That was my first experience in campaigns and I've stayed involved [ever since].

What advice do you give to other entrepreneurs?

Number one is following your passion. There are so many entrepreneurs that are chasing money and they're chasing what they think is opportunity—money, fame, notoriety, all the wrong things. You can't be driven by those things; you have to be driven by your passion. Business is simply too difficult to "make it" if you're not obsessed with what you're doing. If you're not in love with what you're doing, you simply will not be able to overcome the challenges and the barriers in your way. When you're actually truly in love with something, you propel through those walls. If you're not in love with something, those walls will really seem insurmountable.

CHAMBER PAC ANNOUNCES FIRST-EVER BOARD ENDORSEMENTS

Committee backs Hacker, Paysinger and Spitz

The Chamber of Commerce Leadership Political Action Committee (PAC) announced Tuesday their endorsements for Board of Education candidates Isabel Hacker, Carter Paysinger and Mel Spitz for the upcoming November 3rd election.

The PAC reached their decision after conducting extensive interviews with all five candidates, reviewing public records and viewing the debate hosted by the Chamber's Government Affairs Committee on September 17.

"This is a critically important election for the City of

Beverly Hills and its school system," said Chamber PAC member Mitchell Dawson.

The media release issued by the Chamber mentions that the district is

engaged in "extensive litigation costing tens of millions of dollars and has used Measure E bond funds to partially pay for litigation expenses."

"There is a \$9 million cumulative projected deficit over the next three years as per the 2015-16 budget approved by the Board of Education,"
—the Chamber of Commerce PAC in a statement

The Chamber's announcement later highlights Beverly High's "substantially" declining academic performance, citing the fact that 30% of students at the high school failed standard testing in English and 41% failed in math.

"There is a \$9 million cumulative projected deficit over the next three years as per the 2015-16 budget approved by the Board of Education," the committee said in a statement.

This marks the first time that the Chamber PAC, which was established in August 2014, has endorsed Board candidates.

HAWTHORNE, EL RODEO CUPOLAS REMOVED

District says original structures may never be replaced

The cupolas recently taken down from Hawthorne and El Rodeo's towers will be replaced with replicates, said Superintendent Steve Kessler on Tuesday. But Board of Education member Noah Margo claims the Board will decide the fate of the cupolas.

"Any decision regarding the cupolas must be Board approved," Margo wrote on his Facebook page Wednesday.

Following a two-day closure, Hawthorne was reopened Monday amidst news that a five-year-old beehive containing around 40,000 bees had been discovered inside the small dome.

According to Hawthorne Principal Ena LaVan, as the hive was being removed, the bees became aggressive and stung some of the workers involved.

"One of the Totum managers had gotten stung at least 20 times," Board member Lewis Hall alleged in an email sent out Sunday. Hall wrote that he was stung once.

In the email, Hall mentioned that "[the cupola] was just sitting on top [of the tower] with nothing attaching the 4,500 pounds of stone."

But Hawthorne PTA President Lorraine Eastman, who lives across the street from the school, remembers that a crew of six men worked for 45 minutes on Sunday to detach the cupola so that a 225-foot crane could carry the piece away.

"However they affixed it back in the day was quite strong," Eastman said. "That thing was not going to be falling off anytime soon."

At the Board meeting Tuesday, Hawthorne parent Hilary Hartman addressed Hall's claims that there was nothing attaching the cupola to the tower.

"I was told that while the cupola was not bolted on top of the tower, it was tightly cemented in place," Hartman said. "The cement holding the cupola in place was so

strong that the crane was initially unable to lift the cupola off the tower."

Board member Lisa Korbatov responded to Hartman's comments by calling up interim Facilities Director Tim Buresh, who purported that the only thing affix-

ing the cupola to its base was an inch of 100-year-old mortar.

The cupolas date back to the 1920s, when Hawthorne and El Rodeo were first built. Together, they will be stored at the district's maintenance and operations yard and used as models for duplicate versions.

On September 16, the Board authorized an agreement with California Access Scaffold for scaffold-

ing at El Rodeo for a not-to-exceed fee of \$20,000.

At their meeting Tuesday, the Board moved forward with a proposal for the installation, nine-month rental and tear down of the scaffolding at Hawthorne at an amount not to exceed \$70,000, which includes the \$18,000 spent on inspecting and removing the cupola.

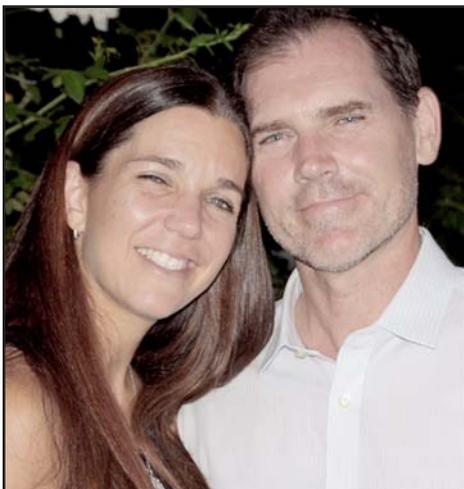

An Open Letter from Carter Paysinger to Beverly Hills Residents



Dear Friends:

Why would I sue the school district? After much thought, I decided to address the questions regarding my lawsuit once and for all. The information described in this letter is publicly available for all who are interested.

Filing the lawsuit was one of the toughest decisions I've ever made. I did everything in my power to avoid it. Ultimately, filing the lawsuit was my only option to address the wrongs that had been committed and to attempt to prevent those wrongs from continuing.

In simple terms, I was bullied. Unlike a schoolyard bully taking your lunch money, **these bullies were the District's elected leaders abusing their power and authority to destroy careers and reputations.** After dedicating almost 40 years to this district, I refused to allow these individuals motivated by personal biases to destroy my life.

Board members have claimed that there was no evidence that I suffered any retaliation or discrimination. This is wrong. Below find a summary of the facts:

- In July 2013, **a Board member came to my office and threatened that unless I did what he wanted, my family and I would be investigated for an unrelated matter.**
- Per District guidelines, **I reported the incident to my superintendent in the form of a formal complaint and fully expected the District to resolve the matter and prevent further misconduct.** The superintendent gave the complaint directly to the Board member in question. The Board member responded by demanding that I be reprimanded for filing a complaint against him. He then convinced the majority of his Board colleagues to initiate his threatened investigation of me, including hiring an outside attorney to perform a so-called "independent" investigation.
- A month passed and the District had not provided a response to my initial complaint, which forced me to have to submit a second complaint. Once again, the District delivered my second complaint to the Board member in question.
- In response, **that Board member wrote a letter to the Los Angeles District Attorney's (LADA) office on BHUSD stationary and asked the LADA to initiate a criminal investigation of me.** When he learned that the LADA had opened an investigation of me, he called the *Los Angeles Times* and informed them of the investigation, which resulted in the publication of a negative article about me. He also demanded that the superintendent respond "aggressively" to my second complaint.
- The Board hired a lawyer to investigate my two complaints. According to deposition testimony, the **Board allowed that Board member to select a lawyer of his choice to investigate him.** According to testimony, he chose a lawyer that he "trusted" based on her physical appearance. **That lawyer concluded, among other things, that the Board member had violated Board Policy and that the Board member should not participate in any decisions regarding me because any such decisions would be deemed retaliatory.** Her conclusions were communicated directly to the Board, including that Board member. In spite of her conclusions, the Board member never recused himself and he continued to participate in every decision related to me.
- Eventually, the attorney facilitating the "independent" investigation of me completed a draft investigatory report and presented it to the Board for review. The Board demanded changes to this "independent" report. In fact, two Board members including the Board member in question participated in a one-hour private conversation with the attorney facilitating the investigation. **There was nothing independent about the investigation or the report.** According to the lawyer's notes, someone stated during a closed session meeting of the Board that if I refused to resign, the revised draft report would "go out." **This is, by definition, coercion.**
- In January 2014, I submitted a third complaint with the District regarding the Board member in question. That same day, the attorney facilitating the "independent" investigation submitted another revised draft report to the Board. At that time, I had no idea that a report existed, draft or otherwise. I later learned that there were only six copies of the report distributed to the District (one to each Board member and one to the superintendent). One of those six reports was "leaked" to the *LA Times*, which resulted in another negative article about me.
- **Later, the District hired different lawyers to investigate this "leak."** These lawyers interviewed each Board member and authored a report. In response to a Public Records Act request by the *Beverly Hills Weekly*, the Board voted not to produce a copy of that report. Why?
- **In March 2014, the LA District Attorney's office closed its investigation and cleared me of wrongdoing regarding the very same matters at issue in the District's "independent" investigation.**
- On July 14, 2014, the District received a letter from the U.S. Department of Justice explaining that I had the "right to sue," which is the final prerequisite to filing a lawsuit. The very next day, the Board sent me a letter stating that it was reopening its "independent" investigation of me.

In light of all of the facts, this threatened "reopened" investigation is another example of how the Board frivolously and maliciously misuses District funds. **At that point, it was clear that the Board's bullying was never going to stop and my only recourse was to file a lawsuit.**

The settlement:

The mediator, a Federal Judge, set the settlement amount based on my legal fees and expenses. **I paid multiple law firms for nearly two years to address the "independent" investigation and the criminal investigation, both initiated by the Board member in-question.**

I am sure one or more of the current Board members will attempt to place their self-serving spin on these facts. However, I am going to continue spending my time fighting for our District's students and focusing on real issues, including student achievement, District finances, and the morale of the employees responsible for the well-being of our children.
