

I'm a writer, myself, and an English major who learned his craft at both Beverly Hills High School and Harvard University. With those analytical tools and - in a more contemporary setting - as the father of last year's co-editor-in-chief of the BHHS Highlights (now a freshman journalist on the Duke University Chronicle), I'm well aware of the kind of teaching that goes on in classrooms today, so that young journalists and columnists will learn the sometimes subtle (and often not-so-subtle) differences between "news" and "opinion." I have to admit that it's confusing, in this era, when opinion is all too often positioned as news in order to create "buzz."

It's much more seductive - in print and on-line - to publish biased stories rather than balanced analyses, especially for those unpracticed in the art of journalism. Yet one hopes that those in positions of editorial authority, however, would be experienced enough to know better and act as such.

I suppose that I assume we all know the difference between the two, much in the same way that Supreme Court Potter Stewart (in 1964) acknowledged his own powers of discernment regarding pornography.

The Justice wrote, "I shall not today attempt further to define the kinds of material I understand to be embraced within that shorthand description ['hard-core pornography'], and perhaps I could never succeed in intelligibly doing so. But I know it when I see it, and the motion picture involved in this case is not that."

Like Justice Stewart, I won't further try to define what makes for "editorial and opinionated content" as opposed to objective news reporting, but "I know it when I see it."

These aspersions have not only no place in our elective process, but also should play no part in our discourse with those with whom we interface. Our hope is that those outside our community realize that these School Board incumbents neither speak for us nor represent who we are.

At his "Ich bin ein Berliner" speech at the Berlin Wall, President Kennedy remarked, as an inspiration for Western liberty, that the proudest boast during the days of the Roman Empire was "Civis Romanus sum," "I am a citizen of Rome."

In Beverly Hills, we pride ourselves — and our neighboring communities take note — on these fundamental civic principles: we encourage and respect dissent; all are welcome to participate in our open, democratic, vibrant marketplace of ideas and that those who choose to do so never have to worry about reprisals from officialdom or querulous neighbors.

Bottom line: we are a moral people; we value dialogue; we respect and encourage dissent; we are tolerant and spiritual and, hopefully, never arrogant or demeaning.

One final thought: the School Board majority says that everything in the school district is A-okay. Yet, respected city institutions and distinguished citizens support a new majority of non-incumbents for the School Board. In substance, the Chamber of Commerce, the B.H. North Homeowners Association, a dozen past Mayors, and community neighbors and friends believe collectively that the School Board majority has mismanaged the district by engaging in fiscal irresponsibility and improvident and unprincipled practices.

It's up to all of us to decide on Election Day, November 3, 2015 — so please vote.

Recently, an unusual event happened. A petition was given to my father, Mel Spitz, urging him to run for a seat on the school board. Why?

Primary among many reasons, is that he served on the Board from 1971 – 1979, during which time he was one of the most influential among a great group of members. The district excelled in all areas.

A couple of things you might not know about Mel. He's worked for the federal government twice. The first came in the form

of a deal that you don't refuse. Nor did Mel want to. About six months out of college, and fresh in an accounting firm, he was drafted.

With visions of flying in the armed forces, he had the sky in his eyes. The Army had a different vision though, and saw numbers in his head. I am not seeking your blind support. I am simply requesting that you learn more about this fine man's qualifications, so that you can

support him in good conscience.

Mel is by far, the best candidate with a lifetime of financial, executive, and corporate directorship experience. (Of his long list of accomplishments, one of my favorites is that, at his very first board meeting he presented the members with an analysis showing that the district had no reserves. By his last meeting, \$12 million in reserves had been accumulated!)

Of course I'm biased. However, my bias extends beyond family ties, to the community which will always be a part of me. I received a first rate education. I want NOTHING LESS for your children. Mel Spitz is especially needed at this time to help the district recover financially, and to regain academic excellence.

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Council of the City of Beverly Hills, at its meeting to be held on **Tuesday, November 3, 2015 at 7:00 p.m.**, or as soon thereafter as the matter may be heard, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AUTHORIZING A ZONING AMENDMENT THAT WOULD APPLY THE CITY'S MEDICAL USE OVERLAY ZONE TO THE PROPERTY LOCATED AT 300-336 NORTH CANON DRIVE AND A RESOLUTION APPROVING A PLANNED DEVELOPMENT PERMIT FOR A MEDICAL USE ON THE PROPERTY LOCATED AT 300-336 NORTH CANON DRIVE.

Application of the City's Medical Use Overlay Zone to the subject property at **300-336 North Canon Drive** is required to allow any new medical office uses. The subject project is located within the existing 19,044 square foot building occupied by Rite Aid, a retail/pharmacy use. If approved, up to 474 square feet of medical office space could be established within the existing footprint of the building. This would be equal to approximately 2.5% of the building's floor area.

A resolution considering a Planned Development Permit for the project as well as a resolution recommending City Council adoption of the subject Ordinance were previously reviewed and adopted by the Planning Commission on June 25, 2015.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(2) of Title 14 of the California Code of Regulations, as well as Section 15301 (Class 1 Categorical Exemption) because adoption of this Ordinance would result in minor alterations to an existing structure involving negligible or no expansion of an existing use. In addition, the Planning Commission of the City of Beverly Hills considered a Class 1 Categorical Exemption for the Planned Development Permit associated with the project.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the Council's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

The Board has previously mentioned voting on a new, \$140+ million bond package to cover the ever-growing cost of construction projects.

In March, Board member Noah Margo told the Weekly that he “[has] felt, for a very long time, that as the district rolled out a more comprehensive construction plan for all of the [school] sites, that the existing Measure E bond is not effective, nor is it sustainable, to address the long-term goals of the district.”

BHUSD interim Facilities Director Tim Buresh told the Beverly Hills Courier last month that “another bond would be required to finish El Rodeo, do Hawthorne and finish the high school.”

At their June 18th meeting, the Board issued the third series of Measure E bonds in an amount not to exceed \$76 million with a 3-2 vote.

In a timeline prepared by the district’s financial advisor Keygent, the bond issuance is scheduled for August 2016, following a June 7th election.

Although the proposed bond is planned for next year, the first six activities on the timeline, which are included below, would be overseen by the current Board:

1. Develop or update District facility master plan to identify and prioritize potential bond projects
2. Assemble bond team, including District personnel, financial advisor, bond counsel, pollster and strategist
3. Determine all available sources of

capital improvement funds, including State funds, capital

fund reserves, donations, developer fees and bond proceeds

4. Begin community outreach to educate voters on District’s facility needs
5. Identify issues within the community that could impact the bond election
6. Conduct voter opinion survey (if required)

The voter survey (# 6) is being presented as an optional undertaking.

Under the current bond, which was passed in 2008, the one school site to undergo major construction has been Horace Mann.

Brien criticizes Board; JPA questioned

One month after Mayor Julian Gold warned the Board of Education against breaching their Joint Powers Agreement (JPA) in a strongly worded letter, the City Council discussed the impact that proposed BHUSD construction activities will have on City-related programming at their October 20th meeting.

Through the JPA, the City averages 90 hours per day of district field and facility use, which amounts to more than 32,000 hours annually. In return, the district receives approximately \$9.8 million.

But as the district’s list of construction projects continues to lengthen, less and less facilities are being made available for City use.

“Horace Mann has been offline for a year now,” Councilmember Willie Brien said.

“We did not adjust the JPA when we lost the field space at Horace Mann—the black top, the turf that AYSO and Little League were using.”

The district’s construction and modernization efforts began with the closure of the Horace Mann field in 2014, which forced the City to relocate its programs to other district and City fields.

In April, City activities were once again impacted when the Board approved closing down auditoriums at Beverly High, El Rodeo and Hawthorne.

Brien, who emphasized that the JPA is not a gift, later critiqued the Board for their “mismanagement.”

“You all have spent over \$10 million fighting the Metro and you’re going to lose,” Brien said. “You have spent \$5 million paying consultants and employees and their family companies, all out of the educational and facility pocket of the children of this community.”

An outspoken critic of interim Facilities Director Tim Buresh, Brien referred to Buresh as “the guy you’ve got to get rid of.”

“[Tim Buresh] is the worst fear mongerer in the district,” Brien said.

Brien asked Board Vice President Howard Goldstein and Superintendent Steve Kessler, who both attended the meeting, to notify the Council before they vote to move forward with substantial changes.

“Until you have a plan, don’t start accelerating [bonds] and taxing the residents of this community and asking for more money,” Brien said. “Keep your word and

keep your promise that you and the prior boards made about building and construction in this city.”

Brien’s comments were met with applause, leading Vice Mayor John Mirisch to say that the councilmember was “en fuego.”

Appeals court upholds EIR for subway extension

On October 22, a California appellate court upheld the Final Environmental Impact Report (EIR) for the Purple Line Extension, which will extend the subway from its current station at Wilshire/Western to Westwood. In an April 2014 ruling, a Superior Court judge had also upheld the EIR.

Though the City of Beverly Hills and the BHUSD challenged the studies in a state court, a panel of Court of Appeals judges ruled that “substantial evidence” supports Metro’s decision to route the subway underneath a part of the Beverly High campus.

Metro officials said they were grateful for the ruling. A federal lawsuit by the City of Beverly Hills and the BHUSD challenging the project’s Final Environmental Impact Statement (EIS) is pending.

Planning Commission deliberated an ordinance that will establish time limits for legally non-conforming and conditionally permitted uses once they have been discontinued for more than two years.

Non-conforming uses are currently prohibited or require some form of discretionary review, such as a conditional use permit, Associate Planner Timothea Tway elucidated in the staff report.

Examples of conditionally permitted uses in commercial areas include drive-through facilities, mini-shopping centers and museums.

"When these uses are vacated, they can continue even if the property is vacant or the use is discontinued," Tway said.

Unlike Beverly Hills, most neighboring cities impose time limits. In the City of Santa Monica, the maximum amount of time a property can remain vacant before its conditionally permitted use status expires is six months.

"West Hollywood, Culver City, Pasadena and Malibu all have time limits as well," Tway said.

Developer attorney Murray Fischer, who attended the meeting on behalf of "numerous" clients, spent 15 minutes outlining his opposition to the proposed ordinance.

"First of all, not all people who may be subject to the subtle revisions, own the property," Fischer said. "Some of them have long-term leases on their property and substantial investments. Their businesses also include the ability to sell the business,

should they elect to go out of business."

Fischer mentioned he has received phone calls from 10 different clients "with respect to what is going on."

Commissioner Craig Corman said he supports the ordinance in concept, but recognizes that it has some drawbacks.

"I think that the time period should be at least five years, not two years, to solve the problems that Mr. Fischer raised earlier," Corman said.

Chair Alan Robert Block later echoed Corman's concerns with the time frame.

"There could be a fire, there could be something else where it takes more than two years to resolve something with the insurance company and reopen the business," Block said.

As a next step, commissioners will meet with the Council to discuss modifying the ordinance.

Board to discuss selling District office property

The Board of Education plans to discuss



District office on Lasky Drive

selling the District office property on Lasky Drive, according to the staff report for Thursday's Board meeting.

The site address is listed under agenda item III.i: Conference with Real Property Negotiators.

Though selling the property has been discussed many times over the past few years, it is highly unusual to do it right before the new Board members are sworn in.

Based on this number, total turnout will be between 3,000 to 3,200 ballots, which is about half the number of ballots cast in a typical City Council election.



LISA KORBATOV VOTED TWICE IN TWO SEPARATE ELECTIONS, COUNTY SAYS

L.A. County voter records indicate that Board of Education member Lisa Korbатов voted twice in elections in 2005 and 2008.

County Registrar-Recorder/County Clerk’s office. “We referred the matter to the District Attorney’s Public Integrity Division and copied the Secretary of State’s Investigative Services. At this point it is in their court.”

in the same election is a felony and constitutes a crime in the State of California.”

The March 2005 ballot included a Beverly Hills city council election and the ultimately successful referendum on building the Montage hotel. In that election, “Lisa Kennedy Fisch” cast a poll ballot and “Lisa Kennedy Korbатов” voted by absentee ballot. The November 2008 election included a presidential race that first elected Barack Obama. The reverse occurred in that election, with “Fisch” voting by absentee and “Korbатов” voting in the polls.

Voting history is tracked by vendors who provide the information to candidates who wish to target high-propensity voters with campaign mail.

In a letter to the *Weekly*, Korbатов’s attorney, her husband Igor Korbатов, denied the accusations.

Korbатов threatened the *Weekly* with legal action if it published the story. He refused to provide an affidavit under penalty of perjury from his client refuting the charges.

BHHS to play homecoming game Friday

The Beverly High football team followed its narrowest loss of the season with its most one-sided loss, losing at Lawndale, 61-0, Friday night in an Ocean League game.

The Normans (0-8, 0-3 in league play) allowed two punt return touchdowns in the first quarter.

The Cardinals (7-1, 3-0) scored four more touchdowns in the second quarter to turn their 19-0 first-quarter lead to a 47-0 halftime advantage. Lawndale scored the third quarter's lone touchdown and led 54-0 entering the fourth quarter.



ORDINANCE NO. 15-O-2692

AN ORDINANCE OF THE CITY OF BEVERLY HILLS TO INCREASE RATES AND CHARGES FOR WATER SERVICES AND FACILITIES FURNISHED BY THE CITY

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Beverly Hills hereby finds as follows:

(a) The City Council is authorized pursuant to the California Health and Safety Code Section 5471 to prescribe, revise and collect rates and charges for water services and facilities furnished by the City.

(b) The City Council wishes to increase the rates and charges (the "rates") for water services and facilities furnished by the City, as provided in Exhibit A.

(c) The City Council identified the parcels upon which the proposed rates would be imposed and calculated the amount of the proposed rates.

(d) The City Clerk caused a notice of the time and place of a public hearing on the proposed rates to be mailed as required by Section 6 of Article XIID of the California Constitution.

(e) Each notice described the amount of proposed rates, the basis upon which the amount of the proposed rates was calculated, the reason for the proposed rates, and the date time and location of a public hearing on the proposed rates.

(f) On September 1, 2015 and on October 6, 2015, the City Council conducted a public hearing on the proposed rates and heard and considered all objections and protests thereto and at the close of the public hearing, the City Council determined that written protests had not been presented by a majority of owners of the identified parcels.

Section 2. The City Council hereby approves the rates in the amounts and on the effective dates as provided in Exhibit A.

Section 3. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage, in accordance with Section 36933 of the Government Code; shall certify to the adoption of this Ordinance and shall cause this ordinance and her certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 4. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.


