Courier says Christiansen lawsuit is over, then retracts story

A *Beverly Hills Courier* email blast sent out Friday night wrongfully reported that the BHUSD had “triumph[ed] against Christiansen’s allegation of fraud.”

The Courier retracted the story two days later, clarifying that the district’s pricey lawsuit against former BHUSD Facilities Director Karen Christiansen is not yet over.

“In fact, on Friday, the Court of Appeal ruled only on one of two lawsuits, determining that her allegations of fraud were without merit,” wrote staff reporter Laura Coleman.

Attorney Fred Fenster, a partner at law firm Greenberg Glusker, represents the BHUSD in the litigation involving Christiansen. The total judgment against the district currently exceeds \$20 million.

Fenster allegedly told *The Courier*,

“[That] case is now officially over.”

But the case Fenster referred to was just one part of the total entity.

“It was a collateral component, the main thing that the plaintiff is trying to win, of course, is the \$20 million,” said attorney Ronald Richards, an expert on SLAPP who is not affiliated with the suit. “The SLAPP is really a collateral issue.”

Christiansen, represented by attorney Philip Kaufler, filed the suit for fraud against former BHUSD Superintendent Jerry Gross, construction firm Telacu Industries, Board member Lisa Korbatov and several others in November 2013.

“It was a SLAPP case because it was geared towards the individual defendants and the law firms,” Richards said. “It really wasn’t the main judgment that’s still on appeal.”

The BHUSD was not one of the defendants.

Board President Howard Goldstein told *The Courier* he felt “relieved that this aspect of the Karen Christiansen and her company Strategic Concepts litigation has been decided favorably for the district.”

The district is currently in the process of appealing the March 2015 L.A. Superior Court ruling that resulted in a \$20+ million judgment.

“Some laws have changed since

[Kaufler] won and it's going to be a little bit more complicated for him now," Richards said. "There's no slam dunk on either side—that's a fair assessment."

City responds to tree cutting scandal

At last week's City Council meeting, Assistant City Attorney Carol Lynch summarized her investigation of the controversial tree cutting that occurred late last year and left two parcels on Civic Center Drive stripped of vegetation.

In the 13-page report's three-paragraph conclusion, Lynch mentions "there is a natural tension between responding promptly to the press and the public and the need to ensure that the information that is provided is completely accurate."

Her statement drew the ire of former Mayor Robert K. Tanenbaum, who addressed it during the public comment period.

"Natural tension? Is this *Pravda* that we're dealing with that we're demanding information?" Tanenbaum said.

Other speakers critiqued Lynch's report for its failure to outline the repercussions they believe city staff members should face for their involvement.

Vice Mayor John Mirisch asked, "Where is the accountability?"

Councilmember Willie Brien expressed a different perspective and commended Lynch for an "excellent" chronology and report.

"I know that Lyn Konheim would never intentionally do things that would subvert the rules," he said.

Beverly Hills Land Company's Konheim, who owns the two lots, supposedly directed the tree removal.

Located in the area between Santa Monica Boulevard and Civic Center Drive, parcels 12 and 13 total five acres. The lots were stripped of their trees November 21 and 22, without a 30-day notice and without notification to the Department of Toxic Substances Control (DTSC) and neighboring residents and business owners.

The cutting on the 22nd coincided with the weekly Farmers Market, which takes place Sundays on Civic Center Drive. Speakers' concerns focused on the possibility that Market goes and neighboring residents were exposed to toxic fumes after the trees were removed from the arsenic-laced soil.

"[My three grandchildren] are not going to get cancer, but who knows what they're going to get 20 years from now because of toxic arsenic in the food they

ate?" Marty Schwartz said.

At times, Lynch's appraisal of the tree cutting takes on a nonchalant tone that some residents found aggravating.

"Although mistakes obviously need to be avoided, they do provide an opportunity for analysis and improvement of city processes to ascertain the lessons that can be learned from the mistakes," Lynch wrote.

Design Review Commission could expand to hillside area

The Design Review Commission's efforts to expand its purview to the hillside area date back five years, Commission Chair Arline Pepp remarked January 7.

"We want equality with regards to design review," Pepp said.

Currently, the hillside area is exempt from design review and quality control.

At the City Council's priority-setting session last December, the item was deemed an "A-level" priority. The news was met favorably by commissioners, who have become accustomed to the proposal being marked a low priority.

"It just doesn't get anywhere and it's always been Cs or Ds," Pepp said.

City Planner/Assistant Director of Community Development Ryan Gohlich clarified that the project still requires funding, so it could take several years before it comes to fruition.

"At least it's moving in the right direction," Pepp said.

Design Review OKs North Camden Dr. remodel

At their meeting last week, the Design Review Commission backed the façade remodel of a two-story residence located at 705 North Camden Drive, in the city's central area.

The Commission originally reviewed the project last February and returned to it in November. Commissioner comments focused on the need for a simplified design.

At their January 7th hearing, the Commission commended MGA Designs for refining the original construction.

"I think the façade is very well-propor-

tioned and very nice, you've done a good job," said Commissioner Mahnaz Sharifi Ardani. "It's much easier on the eyes, compared to the previous one."

In addition to several other modifications, the roof parapet had been removed and the width of the second-floor balcony had been reduced, creating a cleaner façade. But four out of five commissioners objected to the molding, which they thought was excessive.

"You have an extra piece of molding here and you have several bands of molding here," said Commission Chair Arline Pepp, pointing to a rendering of the redesign on a TV screen. "Would you be receptive to reducing the scale of the molding?"

Newly appointed Commissioner Ilona Sherman agreed and said the molding "is almost overbearing."

The Commission approved the remodel on the condition that the moldings are minimized.

Traffic & Parking weighs in on fee structure for city's EV charging stations

Following a rise in bad etiquette among users, the city-funded electric vehicle (EV) charging program is about to undergo an overhaul.

On January 7, the Traffic & Parking Commission deliberated ways to promote short-term use of the EV stations.

"If somebody were to stay for X amount

of time too long, could ChargePoint lock them out for a week, for a month—like they can't charge? It is punitive, but it might stop somebody from doing it," said Commissioner Andy Licht.

Launched in 2011, the program was meant to provide a safety net for EV drivers concerned about not being able to complete the route home. But users are not moving their vehicles after they are done charging them. In fact, the average session length is around two hours and sixteen minutes.

Considering current usage statistics, revenues are estimated to total \$134,000 annually, if users are charged \$0.25 per kWh fee.

The city currently operates 35 publicly available EV-charging stations at Roxbury Park and 14 parking

facilities.

The Commission supported staff's recommendation that a fee structure be implemented for the city's EV charging stations

Eitan Aharoni appointed BHUSD Chief of Facilities

Following the expiration of Tim Buresh's contract last December, the BHUSD appointed Eitan Aharoni to the Chief of Facilities position at Tuesday's meeting.

The two-year contract began Wednesday and ends January 13, 2018. Aharoni's annual base salary is \$179,800.

The interview committee, which did not feature any Board members, considered 12 different candidates.

Aharoni formerly served as Director of Facilities, Planning, Design and Construction at Kern Community College District in Bakersfield.

Board sets annual inter-district permit cap

The BHUSD phased out its opportunity permit program in 2010, a controversial move that caused enrollment numbers to take a slight dip.

At their first meeting of 2016, the Board of Education dealt with a lengthy staff report that included an item pertaining to inter-district permits, which the Board set at a cap of zero following a unanimous vote.

But Board member Noah Margo indicated the Board may readjust that number sometime in the future.

"We have been looking into the basic-aid school of choice program, which is a possible source of funding for basic-aid schools that have permit students," Margo said.

The district currently enrolls approximately 4,153 students, 194 of which attend the schools on an inter-district attendance permit.

Of those 194, 114 students are enrolled on a district employee permit; 40 students on a city employee permit; and 40 students on an opportunity permit.

"I called a few basic-aid districts and none of them take opportunity permits," Board member Isabel Hacker said.

Since the start of the school year, district-wide enrollment has climbed by 130 students, but still falls slightly short of March 2014 numbers.

Q & A

Newly appointed Assistant City Manager George Chavez

George Chavez entered a new chapter in his 27-year career with the City of Beverly Hills when he was named Assistant City Manager January 7. The former Public Works Director takes over the position held by Mahdi Aluzri prior to his appointment as City Manager last year.

Chavez held various positions within the Community Development Department before becoming Public Works Director in 2013. Under his leadership, the Public Works Services Department and the Public Works Commission developed the Water Enterprise Plan.

Chavez, who started with the city in November 1988, will earn an annual base salary of \$246,216.

Who first hired you into the city?

Mark Scott was the City Manager at the time. I was hired under Mark, in his department, which was Environmental Services, but specifically I was hired into the Building & Safety Department. [Editor's note: See our interview with

Mark Scott in issue #847.]

What attracted you most to the new role?

It's very attractive continuing my work in the city. I've worked here for 27 years and it's about continuing my career in the city, which I've really grown to love. I feel like I'm a part of the community and the fabric of the community.

Tell us about your educational background.

I have a master's degree in organizational leadership from Woodbury University. All my prior education is more technical, [and in] construction or engineering. More recently, I earned my master's in organization-

al leadership, which really helped me understand how organizations work, how people react to change and how we can change things and move forward in a positive way.

What is the most noteworthy change you've detected in the city in the past 27 years?

As a commuter—I drive in from the Pasadena area everyday—I would say that the traffic has gotten significantly

worse over the years. I think it's going to be one of our biggest challenges as we move forward, with the Metro construction impacting Wilshire Boulevard, with our Santa Monica Boulevard reconstruction and all the developments that are taking

place in West Hollywood and Century City. I would say that the biggest issue is congestion.

What projects will you be working on?

I'm currently still the acting Public Works Director, so I'm in transition right now. One of the biggest projects that we're currently dealing with is the drought. We have our Water Enterprise Plan, which is intending to create much greater reliability with our water sources—with our shallow groundwater and other projects we have planned. I mentioned earlier the challenges we're going to be facing with our local traffic, with Metro coming through. On top of that, there's going to be the reconstruction of Santa Monica Boulevard. Our two major roadways will be impacted and that could have some potential economic impacts on our business community, and that's a big concern.

Tell us about your family.

I've been married for 21 years. My children are 14 and 16 years old, so they're teenagers and they keep me pretty busy. I'm a big animal lover and I like to volunteer with animals, so my family also includes two rescue cats from the Lange Foundation and a little dog that I just adopted from the Amanda Foundation.

How will your background in public works shape your approach to the new position?

I think that [public works] is a critical piece of background for me, because it's the streets that we just take for granted, the sidewalks we take for granted, the trash pickup that we take for granted. Public works is an essential service for the community. I've never met such a dedicated group of employees as the public works employees. I have really come to appreciate the work that they do, whether they're picking up the trash, sweeping the streets or providing safe-drinking water to the community. Ultimately, we will be there in any emergency. We've got dedicated individuals that are going to be here to help us come through anything that we're facing.

What is your top priority as assistant city manager?

At the moment, on the front of my mind right now, is to really understand what I can do to assist our City Manager [Mahdi Aluzri]. Mahdi has been by himself in this role the last year and I think it's going to be really important to offload some of his work and allow him to focus on the really major issues the City Manager should be dealing with. Mahdi and I have worked together in the past, so we have a great partnership and an ability to communicate and trust and collaborate. Really, it's going to be trying to preserve the quality of life in this community. We've been here a long time, we've seen the changes and we understand the impacts. Together, with the City Council and staff, it's really about getting everybody focused on doing what we can to preserve the quality of life that our residents, businesses and visitors enjoy.

an over-staffed district. Last July, Chief Administrative Officer La Tanya Kirk-Carter said the over-staffed Beverly High campus is costing the district \$1.8 million annually.

As a basic-aid district, the BHUSD does not receive state funding based on enrollment numbers. Instead, the district receives a lump sum that is distributed evenly among students.

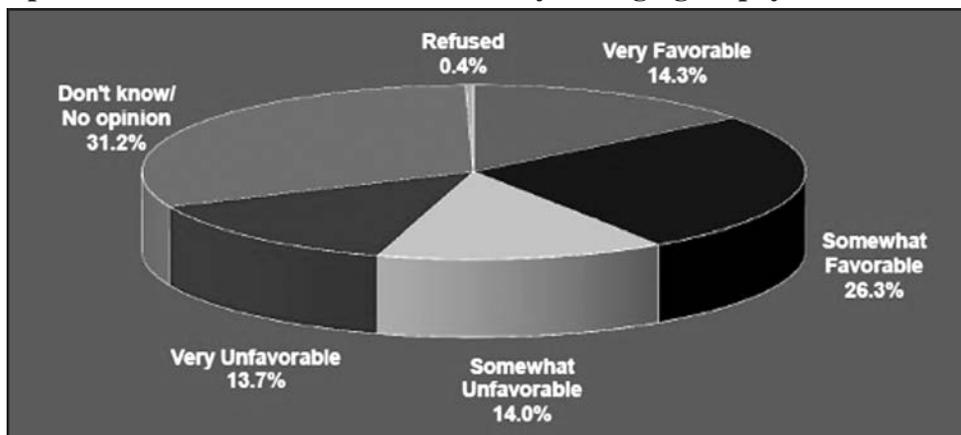
Most basic-aid districts offer no permits, not even for children of faculty and staff.

that wasn't afraid to appeal and spend the money to go to the 9th Circuit and change the law, because we knew we were right on the law," said attorney Ronald Richards.

On Friday, the 9th Circuit reversed a decision by the federal Bankruptcy Appellate Panel which ruled that property owner Eden Place unlawfully evicted Sholem Perl after he defaulted on his mortgage.

"Basically, it ended bankruptcy abuse, because the only judges that ever decided this issue were bankruptcy judges," said Richards, who represented Eden Place on appeal.

Board shelves bond survey

Requesting more information and clarification, the Board of Education postponed voting on agreements with Godbe Research and TBWB Strategies at their meeting Tuesday.

Godbe Research, a market research firm, and TBWB, a strategy and communications consulting firm, would have helped the Board conceptualize voter support for possible general obligation and "technology" bonds.

Board member Isabel Hacker pointed out that the contract spans 12 months, meaning it would outlive the November election.

Godbe Research's hybrid survey would have involved both a telephone and internet component.

In order to gauge support for a construction bond, the district had hired the market research firm in 2014, but voter response was lukewarm at best.

The Board agreed that newly appointed Chief of Facilities Eitan Aharoni should weigh in on the matter.

Richards prevails in 9th Circuit ruling

A decision by the 9th U.S. Circuit Court of Appeals earlier this week heralds a change in the way the court deals with foreclosures and evictions on litigants who have filed for bankruptcy.

The three-judge panel cited a 2015 U.S. Supreme Court decision in *Bullard v. Blue Hills Bank* that maintained the rules are different in bankruptcy.

Richards called the case one of the most important of his career "because of how many people [it] affects."

The ruling impacts thousands of litigants who were plagued with bankruptcy filings. Every bankruptcy and federal district court in the nine western states will have to follow the decision.

"There were victims on both sides—the debtors and the creditors," Richards said.

BOARD DELIBERATES MARGO'S CONSTRUCTION PLAN

Students to move into portables in the fall

Late last year, the Board of Education pushed back work on Beverly High's Building A and delayed the arrival of high school portables by approving "Plan B."

At Tuesday's meeting, the Board requested that Totum Consulting confirm that enough funds exist under Measure E to fully finance a plan proposed by Board member Noah Margo that will prioritize work on Buildings B1 through B4 at the high school, as well as Hawthorne's Building A.

"Based on the total revenue of Measure E at \$290 million [and] based on the fact that we've already spent almost \$84 million, Horace Mann has a remaining budget of approximately \$40

million; Beverly Vista, \$4.5 million; and El Rodeo, about \$69 million," Margo said. "There is still enough money in the capacity to address Building A at Hawthorne and Buildings B1 through B4 at the high school."

Beverly High's Building B is divided into four areas: B1, domestic sciences; B2, old classrooms; B3, the KL Peters Auditorium; and B4, the Salter wing (performing arts). The Hawthorne auditorium is located inside Building A.

Margo said he anticipates that remaining Measure E funds will not have to be accelerated for another year or two.

Hawthorne construction plans, currently in the design development phase, are expected to be completed and

submitted to the Department of State Architect by late 2016.

"This is the fastest way to do the most we can with the funds we have," said Board Vice President Mel Spitz.

Board member Lisa Korbatov disagreed and called the Hawthorne plan a "piecemeal" project.

"It's really not the most cost-efficient way of doing it," Korbatov said. "Additionally, it's not really answering the problem because the buildings on both sides of [Building] A are interrelated to A."

Margo expressed opposition to Korbatov's suggestion that the district instead initiate work on Hawthorne's Building C.

"Completion of [Building] C is still based on a new bond election, that's the problem with starting C," Margo said.

In an effort to avoid an overlap with April and May's standardized tests, the district will wait until the fall to move Beverly High students into portables.

Newly appointed BHUSD Chief of Facilities Eitan Aharoni, whose official

start date is January 19, is expected to assess Beverly High and Hawthorne's auditoriums in order to determine whether they can be temporarily reopened.

"We will start the abatement work on [KL Peters auditorium] by May 1," said Totum Consulting's Rick Panos.

Margo suggested work on the auditorium be pushed back so it does not clash with end-of-the-year graduation ceremonies.

The Board later entered into an agreement amendment with architectural design firm DLR Group for

interim housing construction documents for Beverly High, a \$156,000 project.

"With what we're doing now, plus [Margo's] plan, we would remediate all of the seismic problems in 10 out of the 14 designated buildings," Spitz said. "Of the four that remain to be remediated, three of them have not been designated as severe problems."

The Wallis' new Managing Director Rachel Fine on her long-standing career in the arts

You began your job as the Wallis' new managing director in November. How has it been so far?

Exhilarating. In December, I attended *Guys and Dolls* seven times, as well as several Cabaret offerings. I couldn't get enough.

I'm honored to assume the role as the Wallis' new managing director and thrilled to position this exciting cultural hub and exquisite historic landmark as a vital and robust community resource.

The Board of Directors, staff and community have welcomed me with gusto and embraced the new leadership team warmly, [which includes] Chair David Bohnett and Artistic Director Paul Crewes.

Take us into a typical day.

My typical day begins with a large cup of Peet's coffee and a rapid drive from Pasadena at 6:30 a.m. to avoid traffic.

At eight weeks in, I'm spending much of my time getting acquainted with the Wallis' history and remarkable community – [the Board of Directors], staff, supporters and audience members – and establishing good relationships with those who made the Wallis possible.

At the same time, I am working with the new leadership team on establishing a distinctive vision for the Wallis, as well as a culture of good planning, marketing and fundraising to ensure the Wallis' future success and sustainability.

What the beautiful historic building doesn't necessarily reveal to the public-at-large is that the Wallis is still in its infancy. We're currently in our third season of programming and operations, so there's still a lot of work to be done on laying the foundation and establishing certain systems for the first time. But being a part of a "start-up" operation is



hugely exciting.

Your career in the arts spans 18 years. What is it about the arts that keeps you captivated?

There's nothing more intoxicating, in my humble opinion, than a riveting live performance. I firmly

believe that everyone should have opportunities and access to experience live performance on a regular basis. It's become my personal mission to see the arts better integrated into our communities.

I've spent a lifetime studying music and being a serious pianist. What I know from my own experience, as well as leading the Los Angeles Children's Chorus [from 2007 – 2011], the Los Angeles Chamber Orchestra and the Wallis and recent research, is that meaningful involvement in the arts adds immeasurably to our abilities and capabilities as human beings. Without question, my consistent involvement in music – from the time I was five – has made me a better leader and creative thinker.

Tell us about your family.

I'm married to Christopher Hawthorne, the Architecture Critic for

the *Los Angeles Times*. We just celebrated our 15th anniversary. We have two creative daughters, who love and are heavily involved in the arts at school and outside of school. The arts are central to our daily family life. When we're not working, we're often taking them to music lessons and arts offerings, or off on a pilgrimage to discover the best dumplings or tacos in Los Angeles.

Both girls attended and were thrilled by Debbie Allen's *Salsa Sundays* and *Guys & Dolls*. They will be back for Dan Zanes, one of our favorite musicians, and many other upcoming Wallis performances. They are very keen on being involved in the life of the Wallis.

As managing director, what is your top priority for 2016?

To work in alignment with David Bohnett, Paul Crewes, our board and staff to ensure distinctive and quality arts and community programming at the Wallis; to ensure that our programming and community offerings reflect the richly diverse community of Los Angeles, take full advantage of our local arts environment and are regularly accessible; and to be the pride of our community by positioning the Wallis as a vital and welcoming cultural hub and robust community resource.

The Wallis intends to be a vital force in contributing to Los Angeles as a major global destination for the arts. I'm eager to be a part of its exciting future.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE CITY'S PROCEDURES CONCERNING THE ECONOMIC ANALYSIS OF THE FINAL PROPOSED MEMORANDUM OF UNDERSTANDING

City of Beverly Hills hereby ordains as follows:

Section 1. Section 2-5-505, Economic Analysis, of Article 5, Labor's Negotiations, of Chapter 5, Civil Service Personnel Procedures and Employee Regulations, of Title 2, Administration, Personnel and Procedures, is hereby amended to read as follows:

"2-5-505. Economic Analysis.

Unless reported as provided below, at the conclusion of the negotiation process, the city council shall obtain from a consultant who is not an employee, a fiscal impact analysis of the final proposed memorandum of understanding or amendment to memorandum of understanding analyzing the costs of the final proposal being presented to the city council."

Section 2. Publication. The City Clerk shall certify to the adoption of this Ordinance and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 3. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
