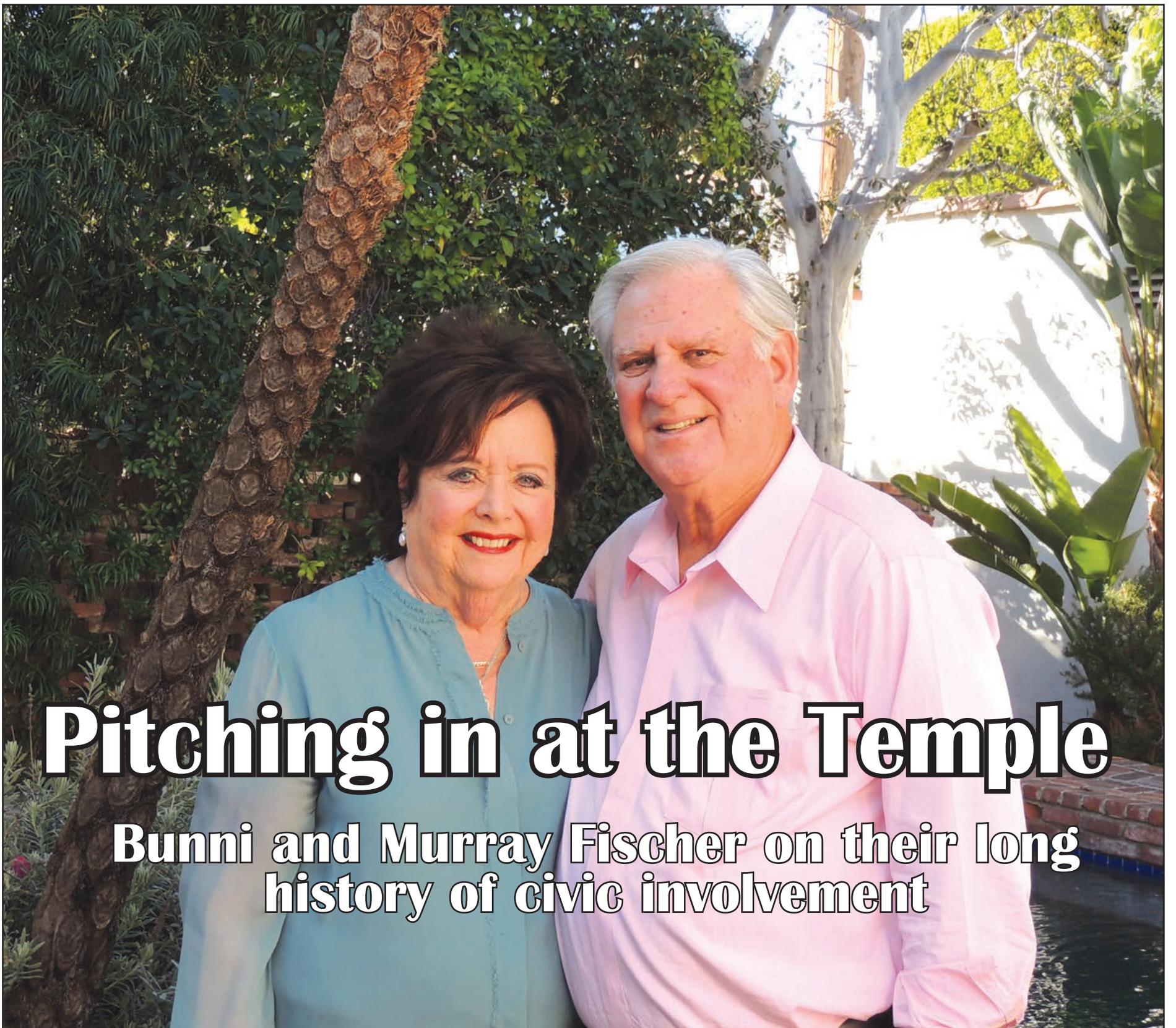

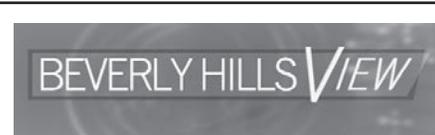

removal left Parcels 12 & 13 on Civic Center Drive stripped of vegetation, upsetting many residents who questioned whether city staff had followed proper protocol.

At a town hall meeting held by the Beverly Hills North Homeowners Association last month, former Mayor Robert K. Tanenbaum suggested the Council fashion an “advisory committee” comprised of residents to further investigate the matter.

And although councilmembers went as far as appointing two residents each to the committee, the Council majority ultimately dismissed the idea, choosing instead to take charge of the investigation themselves.

“To have a newspaper [*Beverly Hills Courier*] who is not a stakeholder in this community, who has a publisher [Marcia Hobbs] who does not live in this community, but who uses a bully pulpit as a bully and spreads the facts is very disturbing to me,” said Dena Schetcher.

The committee would have included Stuart Raffel and Eliot Finkel, appointed

by Mayor Julian Gold; Mark Eggerman and Steve Webb, appointed by Councilmember Willie Brien; Chuck Aronberg and Marty Schwartz, appointed by Vice Mayor John Mirisch; Louis Lipofsky and Tanenbaum, appointed by Councilmember Nancy Krasne; and Thomas White and Lionel Ephrain, appointed by Councilmember Lili Bosse.

"I felt very comfortable with a committee that would have had that advisory role and given input," Mirisch said.

The committee's first organizational meeting was scheduled for Wednesday at 6:30 pm. But Tanenbaum's request that the group have subpoena power seemed to turn people away from the idea.

"This is not about corruption; this is about errors that have occurred. The issues are clear," said Councilmember Nancy Krasne. "What went wrong with the process? It's the process we're talking about—not any one person, not any individuals. There is so much blame to go around, we can all share it. The council can share it."

Bosse pointed out that 17 of the 27 speakers had attended the hearing to defend landowner and developer Lyn Konheim.

"I think the comments that were made about lynching, witch hunts, the H U A C and the inquisition were so over the top and seemed to miss the point — and frankly seemed orchestrated," Mirisch said.

## Board expresses resistance to "school of choice" program

Currently, there are 194 students enrolled in the BHUSD under a system of faculty, staff and city-employee permits.

As a basic-aid district, the BHUSD does not receive state funding based on enrollment numbers, and instead collects a lump sum that is distributed evenly among students.

But under the basic-aid district "school of choice" program, which Board member Noah Margo recently brought to Chief Administrative Officer La Tanya Kirk-Carter's attention, the state would fund the district 70 percent of the amount out-of-district students are qualified to receive at their schools.

"If the Board actually does this, we can call it the 'Margo Plan,'" said Board President Howard Goldstein.

Kirk-Carter said she spoke with four districts that have implemented the pro-

gram.

"Once a child has a school-of-choice permit, it is renewed automatically each year unless the district withdraws from participation in the program," Kirk-Carter said.

The existing 194 "permit" students would automatically be grandfathered into the school-of-choice program.

Implementation of the program could equate to \$1.2 million in extra revenue, Kirk-Carter said, assuming the district grants permits to roughly six other students, bringing the total to 200.

"It would help offset future lost revenue," Margo said.

Though siblings of current permit holders are given priority, a portion of the remaining slots would be filled through a politically unpopular "lottery" process open to out-of-district students.

Board members seemed generally unsure about the initiative.

"My recommendation would be that before any more consideration [is] given to this that we have someone from the California Department of Education come here and explain this to us," Board member Isabel Hacker said.

## Mirisch named Mayor; Krasne, Vice Mayor

Though the mayor and vice mayor are generally elected at the City Council's mid-March meeting, the process was carried out differently this year.

Following a nomination by Councilmember Nancy Krasne, Vice Mayor John Mirisch was elected mayor; Councilmember Willie Brien nominated Krasne for the position of vice mayor.

"Thank you very much," Mirisch said.

Krasne and Mirisch will formally assume the new roles at the installation ceremony on March 16 at 6:00 p.m. at the Academy of Motion Picture Arts and Sciences, Samuel Goldwyn Theater.

## Restrictor water policy receives pushback from Public Works

At their meeting last week, the Public Works Commission expressed resistance to a program that would penalize the city's biggest water guzzlers with limits on the amount of water that flows to their

properties.

"This falls into the category of delving into a very complicated issue with political ramifications that's just been thrust upon us," said Commissioner Jerrold Felsenthal.

Felsenthal wondered whether the city would be exposing itself to liability if a fire broke out on a property that had

restricted water access.

"Believe me, it's a lawsuit," Felsenthal said.

Following direction from the City Council, Planning and Research Analyst Michelle Tse presented commissioners with an overview of the "water restrictor"

The Planning Commission of the City of Beverly Hills, at its regular meeting on Thursday, February 25, 2016, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider:

### AN ORDINANCE OF THE CITY OF BEVERLY HILLS ESTABLISHING TIME LIMITS FOR DISCONTINUED LEGALLY NONCONFORMING USES AND DISCONTINUED CONDITIONALLY PERMITTED USES

Nonconforming uses are uses that were allowed in the City when initially commenced, but, due to subsequent changes in City ordinances, are now prohibited or require some form of discretionary review, such as a conditional use permit. Nonconforming uses vary based upon the zoning district in which the use is established.

Conditionally permitted uses require review and approval by the Planning Commission. The Planning Commission has the authority to add conditions of approval to a conditional use permit in order to ensure that the granting of the permit will not result in impacts that the use might otherwise cause.

Currently, if a nonconforming or conditionally permitted use is discontinued for an extended period of time, the City's zoning regulations allow these uses to be reestablished with no further review as long as no intervening permitted uses have been established at the premises. Under the proposed ordinance, if a conditionally permitted use or nonconforming use is discontinued on a property for more than five years, a property owner would need to obtain discretionary approval to reestablish the use, if the code still allows the use. Residential uses and medical office uses will not be affected by this Ordinance.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance is eligible for a class 5 categorical exemption for minor changes in land use limitations and will not have a significant environmental impact. Accordingly, the Planning Commission will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

policy.

“This would be a final attempt to get the attention of these water customers to conserve,” Tse said.

A restrictor is a device that is clamped onto water meters, dramatically drying up the water flow. The city has never before implemented restrictors.

Under the City of Arcadia’s policy, individuals are penalized if they have received repeated citations for noncompliance.

Commission Chair Sandra Aronberg said there are too many unanswered questions and legal ramifications surrounding the plan.

“We ought to have a way to respond to such problems; I don’t think we need a policy, we just go ahead and do it,” Commissioner Barry Pressman said, citing a recent example involving a property on North Maple Drive.

Rather than develop a policy, the Commission opted for a case-by-case approach driven by individual instances of egregious water use.

### Fine Art Commission welcomes Stephanie Vahn

Stephanie Vahn is the city’s newest commissioner, having been appointed to the Fine Art Commission earlier this week.

An interview panel consisting of City Councilmembers and Fine Art Commissioners reviewed three applications for the position.

“Everyone was qualified and everyone would have been spectacular, but I’m real happy with our choice of Stephanie Vahn—I think she’s terrific,” said Councilmember Nancy Krasne at Tuesday’s study session.

Vahn will fill the vacancy left by Commission Chair Brenda Potter, whose term ends in June.

and we had it knocked down fairly quickly and extinguished in about an hour,” said BHFCD Chief Ralph Mundell.

Superintendent Steve Kessler said there were no injuries or structural damages.

“The situation has been contained and the damage was only to the construction side of the campus,” Kessler said.

No students were on campus due to the federal holiday.

### “Next Beverly” pitches \$55K block party

Mayor Julian Gold’s Committee of Next Generation Leaders—recently rejiggered as the all-ages Next Beverly Committee—has met 11 times since its inception last spring.

At Next Beverly’s bimonthly meetings, the discussion has included plans for a block party event—“in an effort to be inclusive, to educate the community and to highlight the younger generations of residents and business people in Beverly Hills,” reads a report drafted by Marketing and Economic Sustainability Manager Megan Roach.

The “street event” is estimated to cost the city \$55,000. Although the Chamber of Commerce has agreed to funnel \$19,000 into the celebration, the amount was previously set aside for a South Beverly Drive marketing campaign and is still city money.

“I’m having a bit of difficulty with the \$15,000 number,” Councilmember Lili Bosse said of the amount Next Beverly plans to spend on hiring an event coordinator. “I really suggest that you try and bring that number down.”

The Council agreed that expenses should be minimized, and asked the committee to return with an updated budget.

Representing the committee at Tuesday’s City Council study session, Jon Gluck advocated for food trucks at the event and pointed out that the city currently lacks the “optimal and the most attractive for this generation” in terms of its culinary offerings.

The block party is scheduled to take place from 6:00 p.m. to 10:00 p.m. April 9 on the 200 block of South Beverly Drive.

Gold said 54 of the businesses on South Beverly are “in favor” of the event.

### Council OKs fence for Kusama’s tulips

The process behind fencing Yayoi Kusama’s Hymn of Life: Tulips sculpture at Beverly Gardens Park has been a long and intricate one often bemoaned by Fine Art and Recreation & Parks Commissioners.

“For a year we have not had the designer show up one time to have a conversation with anybody,” Fine Art Commission Vice Chair Alan Kaye said last May. “It’s a year later and the Kusama is still imprisoned, and I think we should all be a little embarrassed.”

More than a year into the discussion, the Fine Art Commission accepted a bid from Master Ironworks for a \$40,000 stainless steel fence last December. An additional \$7,500 will be tacked on for footings.

At Tuesday’s study session, Assistant Director of Community Services Nancy Hunt-Coffey updated the City Council on

the project, due to its “sensitive nature.”

Installed in September 2007, Kusama’s trio of polka-dotted, fiberglass tulips began showing signs of wear, such as cracks and scratches, within a few years.

The new enclosure, characterized by curved metal arms and stainless steel cabling, will replace the bright green fence that currently surrounds the sculpture.

### Pilot bike-share test period begins Feb. 22

The city will begin testing a pilot bike-share program the week of Feb. 22. Volunteers are welcome and will be able to ride the bicycles for free and pro-

vide feedback on their experience through April 22.

During the test period, each volunteer may ride the bikes for up to 60 minutes daily. Bike-share docking stations will be located at near the City Hall northeast entrance on N. Crescent Drive at S. Santa Monica Boulevard and adjacent to the Wells Fargo bank located on the southwest corner of North Camden Drive and South Santa Monica Boulevard.

In celebration of Earth Month, the pilot bike-share program is scheduled to roll out in April. At that time, the full system will include 50 smart bikes with onboard technology and 100 bike docking racks in 10 locations throughout the city. Riders will be able to use the ‘Social Bicycles’ smart phone app.

Once the program is launched, the bikes can be returned to a bike-share station for free or at any public bike rack for a small fee.

The Beverly Hills Bike Share program will be compatible with the bike-share system in the City of Santa Monica and future adjacent jurisdictions.

## Dr. Sandra Aronberg Incoming Public Works Commission Chair

**Water is a hot-button topic frequently taken on by the Public Works Commission. What has the discussion been like in recent months?**

The primary focus of late, with the prolonged drought, has been water conservation and achieving the state's goal for Beverly Hills of a 32-percent reduction.

The drought emergency regulations from the state have been extended from February to October 2016, so we're going to remain with the Stage D Water Conservation measure. The Commission is very focused on trying to look at ways that we can reduce our water usage. The Commission has evaluated a number of different ways to either get more water or decrease water. One of the areas that the Commission spent a lot of time on was developing the Water Enterprise Plan, and that's a long-term plan that

should allow the city to be less reliant on Metropolitan Water District (MWD) water. We currently own water rights in the Central Basin, and the plan is to drill some wells in that area. Just

recently, there was a groundbreaking for some shallow water wells just outside of the Public Works building. So there are many different arms to the Water Enterprise Plan, and a big one is water conservation. We're looking at it from a number of different angles.

The Cabrillo Reservoir had been taken out of service because of persistent groundwater seepage into it, but now we're capturing that groundwater and using it for city services rather than having to use purchased water.

**You formerly served on the Health & Safety Commission. How was it different?**

First, it was terrific to be able to serve on the Health & Safety Commission. We actually were the first group of commissioners for Health & Safety, so we were able to develop the groundwork and some of the orientation of that initial commission to get

it going. But they're very different. The Public Works Commission is a very active commission dealing with the current water issues and a number of issues that the Public Works Department is

responsible for. In addition to water, the Public Works Department has a number of different responsibilities.

**In our interview with former Public Works Commission Chair Barry Pressman in issue #673, he said, "Our citizens and business people expect to be able to come to work, turn on the sink, have a little water, be able to flush their toilets and we need to provide that, we can't do that if we start trying to save a percent here and a percent there on rates when our rates are going up." What's your take on the water rate increases?**

The water utility isn't supposed to be a profit center, but it has to break even and it does have to have funds that will allow it to develop in the future. So the Water Enterprise Plan is a long-term plan and in order to be able to pay for that and other capital projects, we do have to be able to at least break even for the water utility and hopefully have enough to develop those projects. We have a decrease in revenue for the city because of the decrease in water purchasing, and

many of the costs remain the same, so the rates have to be increased. I think there's a little confusion because there are several things going on simultaneously: one, is that we have a surcharge if people don't meet a 30-percent reduction, and a number of people came before the City Council to discuss that; the other thing is that there was a ruling called Proposition 218 from San Louis Obispo that ruled that rather than just using conservation to determine the rates, the proposition said that you have to also reflect the cost to provide the services to those various recipients. The city is in the process of updating its tiered water-rate structure, so that's another moving part right now that was discussed at one of the City Council meetings and is now being evaluated again and being worked on. The other is that there is a five-percent increase that I believe is going to start fairly soon.

**What are your thoughts on the Flint water crisis?**

It's terrible that anything like that could be allowed to happen any place, let alone the United States. I've been active with Physicians for Social Responsibility (PSR) for a number of years as one of their environmental ambassadors, so I try to be informed about a lot of the environmental and reproductive health activities that are

going on, but that one is just remarkable in how terrible it is.

**Tell us about your career as a physician.**

I am an OBGYN by my background and I practiced for a number of years in Beverly Hills and then went back to UCLA and got a master's degree in public health and started working in other areas of healthcare. Currently, I teach in the UCLA School of Public Health.

**How did you meet your husband, former Mayor Chuck Aronberg?**

I was considering relocating from Washington D.C. and Georgetown School of Medicine to Southern California and somebody gave me

Chuck's name as a person who was knowledgeable about life and practice in Southern California, so I contacted him. Both of us had very busy schedules and the only time he had available was between meetings and after a study session, so he suggested I come over to City Hall and see

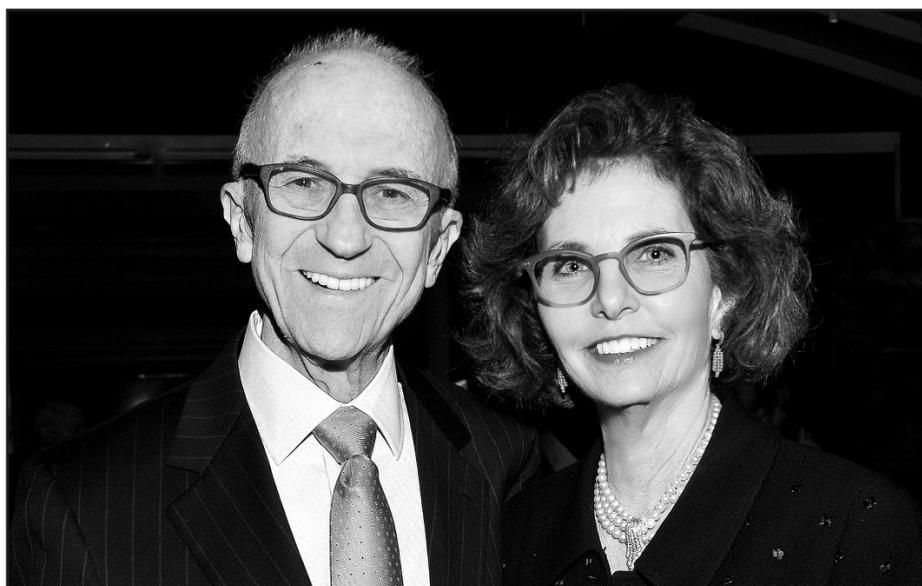
government in action, and we met in City Hall.

**Tell us about your family.**

I have my stepdaughter, Cindy, who has been deputy controller in the State Controller [Betty T. Yee's] office for a number of years. We have two terrific grandchildren, Kate, [who is six years old], and Leo, [who is eight years old], and I'm able to spend a considerable amount of time with them. They live in Santa Monica, unfortunately not Beverly Hills, but it's not far away. I'm originally from South Florida and I went to medical school in Washington D.C. I spent one year at Auburn University in Auburn, Alabama, because I was considering going to veterinary school, and then transferred to the University of Miami and graduated from there with a background in biology and chemistry. I then went on to medical school at Georgetown University in Washington D.C.

**What is your top priority as Chair?**

We're an advisory commission for the city and part of what we have to do is educate the City Council on resident concerns, but also keep track of all the various projects that the Public Works Department is involved with.

## PITCHING IN AT THE TEMPLE

**Bunni and Murray Fischer on their long history of civic involvement**

**You're both being honored with the Humanitarian Award at Temple Emanuel's Purim Ball next month. Tell us about some of your philanthropic work.**

**Murray:** Bunni and I have both been very involved in numerous charity organizations throughout California and the United States. Our involvement in national charities has included the Myasthenia Gravis Foundation—I was the board director and the national president. In addition, we've been involved in ORT America; I've been on both the board and I've been the president of the Los Angeles Chapter. Bunni was president of the Maple Counseling Center Women's Guild in Beverly Hills; she was also very active in the PTAs when our kids were going to school. Bunni has also been active in the Los Angeles County Art Museum Council Board of Directors. She's been a commissioner in the City of Beverly Hills and was a commissioner on the Charitable Solicitations Commission, for which I'm also a current commissioner. I've been president of the Beverly Hills Education Foundation; president of the Maple Counseling Center; president of the Beverly Hills Rotary Club; president of the Beverly Hills Chamber of Commerce; and I've been very active in numerous charities. Currently, I'm on the Board of Trustees for the National Jewish Hospital, which is based in Denver.

**You both grew up and went to Beverly High with a number of people who later became active in the community. What's that been like?**

**Murray:** It's been enjoyable. We still maintain many of our high school friends and we still get together with many of them. In fact, Bunni recently reconnected with one of her high school friends. It's good to know that the people we've made contact with are the same kind of people that care about this community as we do.

**Bunni:** It's been very warm and heartfelt to know that we've known some of these people all our lives and grew up in a community that we've known so well.

**Bunni, when you were 14 you said you wanted your future husband to be like Murray?**

**Bunni:** I told my mother that when I get married, it's going to either be to Murray or to somebody just like him. It took a long

time before that happened—there were many boy-

friends and I ended up with the best.

**Murray:** You know what's really interesting? [On Friday], we were both getting up in the morning and we were watching *Today*, and in honor of Valentine's Day they filmed an event that was going on for couples that have been married for over 50 years. We both thought we're getting close and hopefully, we'll be like that in a couple years.

**How many years have you been married?**

**Murray:** It'll be 48 years in August.

**How has Temple Emanuel affected your family?**

**Murray:** I've been associated with Temple Emanuel since 1957, when I first came out from Columbus, Ohio. I joined the youth group there and found the temple to be amazing. [Bunni and I have been] totally involved in all forms of life-cycle events. I was on the Board of Directors back in the 1980s and Bunni is currently on the board.

**Murray, you currently serve on the Charitable Solicitations Commission; Bunni, you served on the Commission for six years. What drew you both to the**

**Commission?**

**Bunni:** When I went through Team Beverly Hills, we were introduced to all the different commissions and what they represented and did, and I felt that [the Charitable Solicitations Commission] was where I could contribute the most, since I was involved with charity organizations. When I was on the commission, it didn't have much jurisdiction to be able to do a lot of the legal things that we wanted to do, because it was regulated by the state. Since Murray has been on it, the commission has changed quite a bit because they have the ability to do what they need to do.

**Murray:** You asked a very interesting question. First of all, I've been extremely involved in charities. Second of all, I have continually wanted to give back to this community in any way possible. Not only have I served on the Charitable Solicitations Commission, but I've been on many panels over the years and I've been actively involved in different studies that the city has put on. am a real estate attorney and I represent many residents and businesses of the City of Beverly Hills, I was limited in what commission I would be able to serve on because there would be certain conflicts. Because this commission does not necessarily have a potential for conflict, the [City] Council felt that this would be the best place for me to serve with my knowledge. It has been a fruitful experience. The last year, [during which I served as Chair], we've proposed changes to the ordinance to make the reporting process better; we've broadened our scope by being able to look at charities that solicit people even though they have events outside the City of Beverly Hills; and we've put more teeth into the enforcement provisions, so that if people don't comply, we have a much better way of dealing with those entities.

**Murray, as a real estate attorney, is it difficult when your friends on the City Council vote against your clients?**

I really work hard with my clients to vet their matters in the best possible way. I'm the type of attorney that works to find solutions to problems so that it doesn't become difficult to vote against my projects. Have there been people who have voted against my projects? Yes. Do I take it personally? No. Do I strive to find ways to correct it and make it better? Yes.

**You both were honored by ORT America**

**in 2009. Tell us about your involvement with the organization.**

**Murray:** My involvement with the organization began many years ago when a good friend, Stanley Black, asked me to attend a luncheon to start a chapter of men's ORT in Los Angeles. I went to the luncheon and there were about five of us that attended and we all decided to form the Los Angeles Men's ORT Chapter and work for the ORT schools. Over the years, we have been very successful. Stanley and his late wife Joyce were the primary funders of the Los Angeles ORT College on Wilshire Boulevard. But we go beyond just Los Angeles—we provide funds for World ORT as well.

ORT is an organization that takes people of all ages, but primarily people of high school, college and working ages, and makes sure that they have an education in a field that they can better themselves. And the Los Angeles school primarily started as a school when there were many Russian and Iranian immigrants that needed to assimilate and find a way to better educate themselves to improve their families. That's how we started the Los Angeles school. We are worldwide and we have schools all over the world: Mexico, India, Israel and France. Our goal is to make sure that people have proper education and are then employed into society.

**Tell us about your family.**

**Bunni:** We have a daughter, Jill, who is married to Mark; and a son, Allen, who is married to Jillian. Jill has a daughter, Hope, who's going to be 13 and Allen has a son, Brooks, who's nine, and a daughter, Dylan, who's seven. And both our kids live in the Los Angeles area, which is nice. We're an extremely close family; we celebrate holidays together and travel together, and I'm always available for pick up.

**Murray:** We are very fortunate that our children are very successful. Our daughter is a writer and producer of children's programming and she has a new program coming out on PBS this fall called *Splash*. And our son is a manager and represents writers and directors; he represented the director of *Straight Outta Compton*. Both Jill and Allen attended El Rodeo and Beverly High.

**Who will you be thanking in your acceptance speech?**

**Murray:** I'm going to be thanking my wife of 47-plus years for her continuous involvement in the temple and getting me involved in the temple when I was young. I'm going to thank my friends who are there; my clients who have supported me tremendously over the years; I'm going to thank the clergy at Temple Emanuel; and I'm also going to thank our very close and good friend for being the master of ceremonies, Jerry Springer.

**Bunni:** The clergy for being supportive and my parents for giving me a wonderful start in life, and of course Murray. Also, Murray's sister and brother-in-law, who are coming from Columbus, Ohio, and my brother and sister-in-law, who are traveling from Palm Desert. And Jerry Springer, who is doing this out of the goodness of his heart.
