

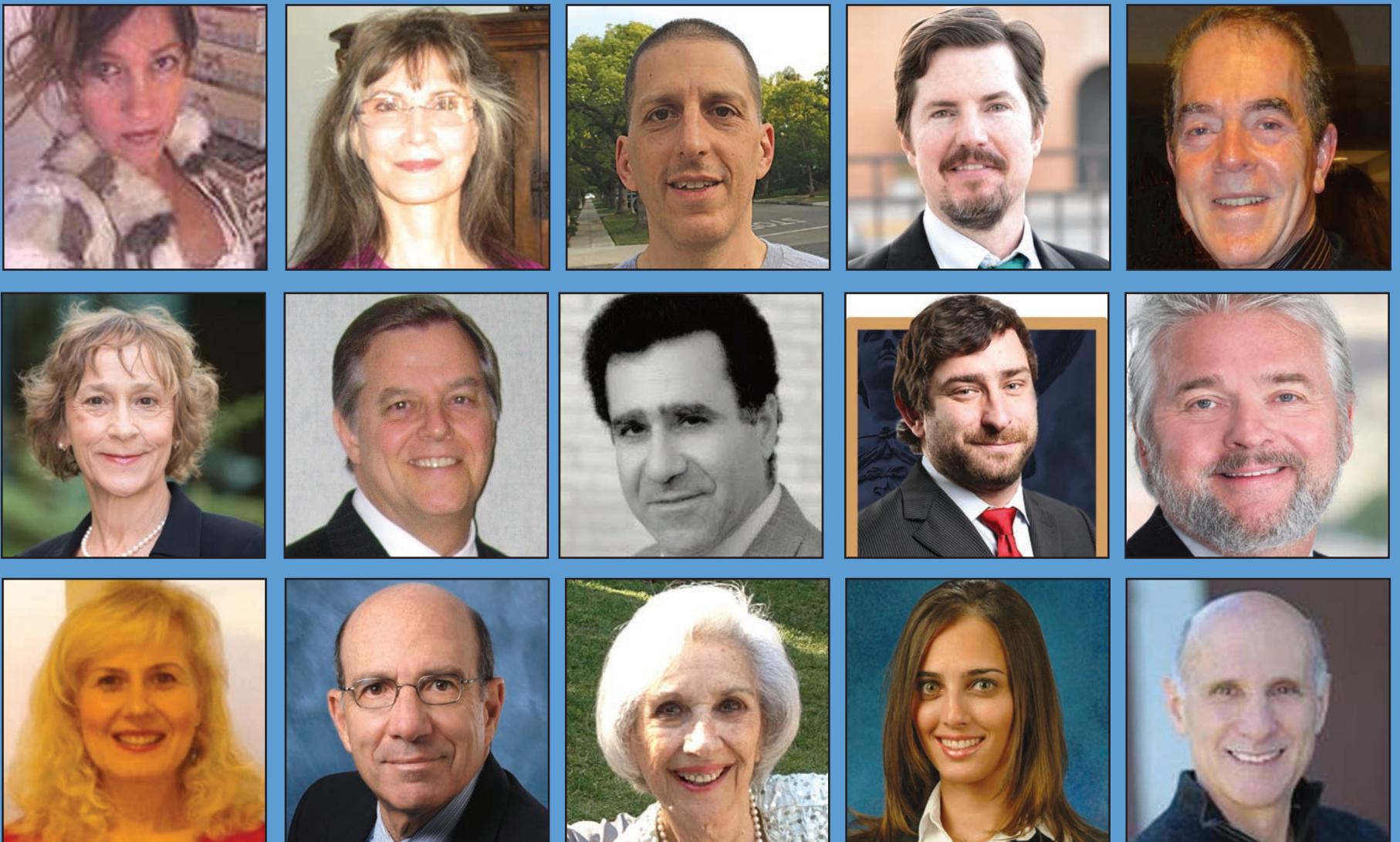

Michelle Halimi Dar named Hawthorne Principal

Beverly High Assistant Principal Michelle Halimi Dar has been named principal of Hawthorne, the BHUSD announced last week.

“I’m really honored to have been selected for the position,” Dar said. “I have heard nothing but wonderful things about the teaching staff and how devoted they are to

the students and their growth, and I’m looking forward to being part of the Hawthorne family again.”

Dar graduated from Hawthorne in 1998 and Beverly High in 2002. She will be the first-ever Hawthorne alum to lead the school as principal. Before becoming an assistant principal at Beverly High, Dar, newly graduated from San Diego State University, began as an English and Service Learning teacher in 2006.

“Mrs. Dar has established a wonderful

reputation in our district as first, an outstanding student, and then, an outstanding teacher, followed by an equally outstanding assistant principal,” said Superintendent Steve Kessler.

Dar’s siblings, Gabe Halimi and Sharon Halimi Eshaghoff, and husband, Amir Dar, are also Hawthorne grads.

“We’re a Viking family,” she said.

The district recently hired Luke Pavone and Philip Wenker as Beverly High assistant principals. Dar’s replacement has not yet been announced.

Kate Mantilini building becomes city’s 30th landmark

A years-long process came to a close May 17 when the City Council unanimously voted to designate the Gibraltar Square/Kate Mantilini building as a local landmark.

“It’s a wonderful property,” said Mayor John Mirisch. “It’s a piece of our history from two eras, [and] the ability to look at that and honor that history gives it not only more character, but value as well.”

The Cultural Heritage Commission first began reviewing the project in June 2014, and in April 2016 recommended the site for landmark designation.

In addition to the building, three interior features, including a painted mural by John Wehrle, were built into the landmark designation.

The Gibraltar Savings and Loan building

was constructed in 1958 and its accompanying seven-story office tower in 1959.

Built in 1968 and designed by architect Maxwell Starkman, the Beverly Hills National Bank building housed the iconic Kate Mantilini restaurant for around 30 years. The establishment's Beverly Hills location closed in 2015.

Though a property can be landmarked without the property owner's consent, such a scenario has not yet occurred.

Beverly Vista soccer fields spike to \$1 million

The addition of two U-10 soccer fields to Beverly Vista's playfield will cost nearly \$1 million, the Board of Education determined last week.

Earlier this year, the Board endorsed a \$969,000 contract with Asphalt, Fabric and Engineering for the project. The bid included an option to add school logos to each field, a \$24,000 addition.

The Board delayed voting on the logos, but pushed forward the item at a special meeting May 20, bringing the final cost to \$993,139.

In addition to BHUSD students, the expanded green space is expected to benefit members of youth organizations like AYSO.

AYSO Regional Commissioner Michael Karon told the *Weekly* earlier this year that school playgrounds play an "important role in our ability to put kids on fields."

The soccer organization has agreed to

fund a significant portion of the \$1-million undertaking, but has not yet finalized the amount.

After the project is complete, soccer fields will take over nearly three quarters of the Beverly Vista playground.

Karon did not return a call to the *Weekly* by press time.

MARY WEISS' LETTER RESIGNING FROM THE CITIZENS' OVERSIGHT COMMITTEE:

I hereby resign from the Citizens' Oversight Committee. While I am very grateful to have worked with many thoughtful and dedicated members, and I am encouraged by the recent addition of new committee members, this is the time for me to step down.

It is not possible to overstate the important function of citizen oversight committees. The California Legislature tasks members to "promptly alert the public of any waste or improper expenditure of school construction bond money." (Ed. Code, § 15264, subd. (c).) Members must also "Ensur[e] that bond revenues are expended only for the purposes

described the California Constitution [Article XIII A, § 1, subd. (b)(3)]." (Ed. Code, § 15278, subd.(b)(1).)

That the COC continues to struggle to obtain documents necessary to perform its duty of ensuring that bond revenues are properly expended is very disheartening. Such documents include the COC's ongoing requests for subway litigation billing records, bond revenue expenditures for the subway challenge(s) and an updated legal opinion concerning the propriety of the use of bond revenues for such legal services. Another question arising from the subway litigation expenditures is the propriety and extent to which former District employee(s) have or are continuing to receive Measure E funded compensation by working as consultants or similar in the subway litigation.

I again make the statement I first made to the public in November 2014; I wish to notify concerned residents that the expenditure of bond funds for items not listed on the original ballot (e.g., "subway litigation") appears to be an improper expenditure of school construction bond revenues.

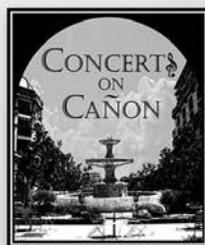

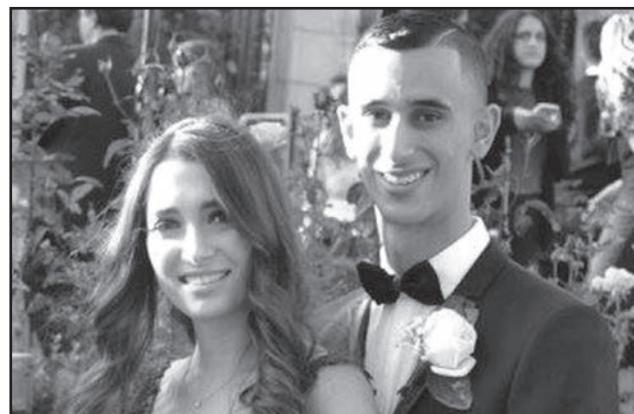

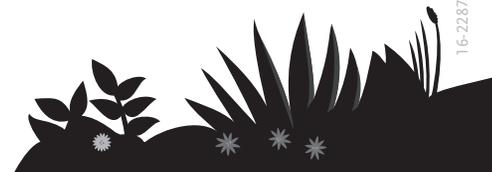
METRO PURPLE LINE EXTENSION IN THE WORKS

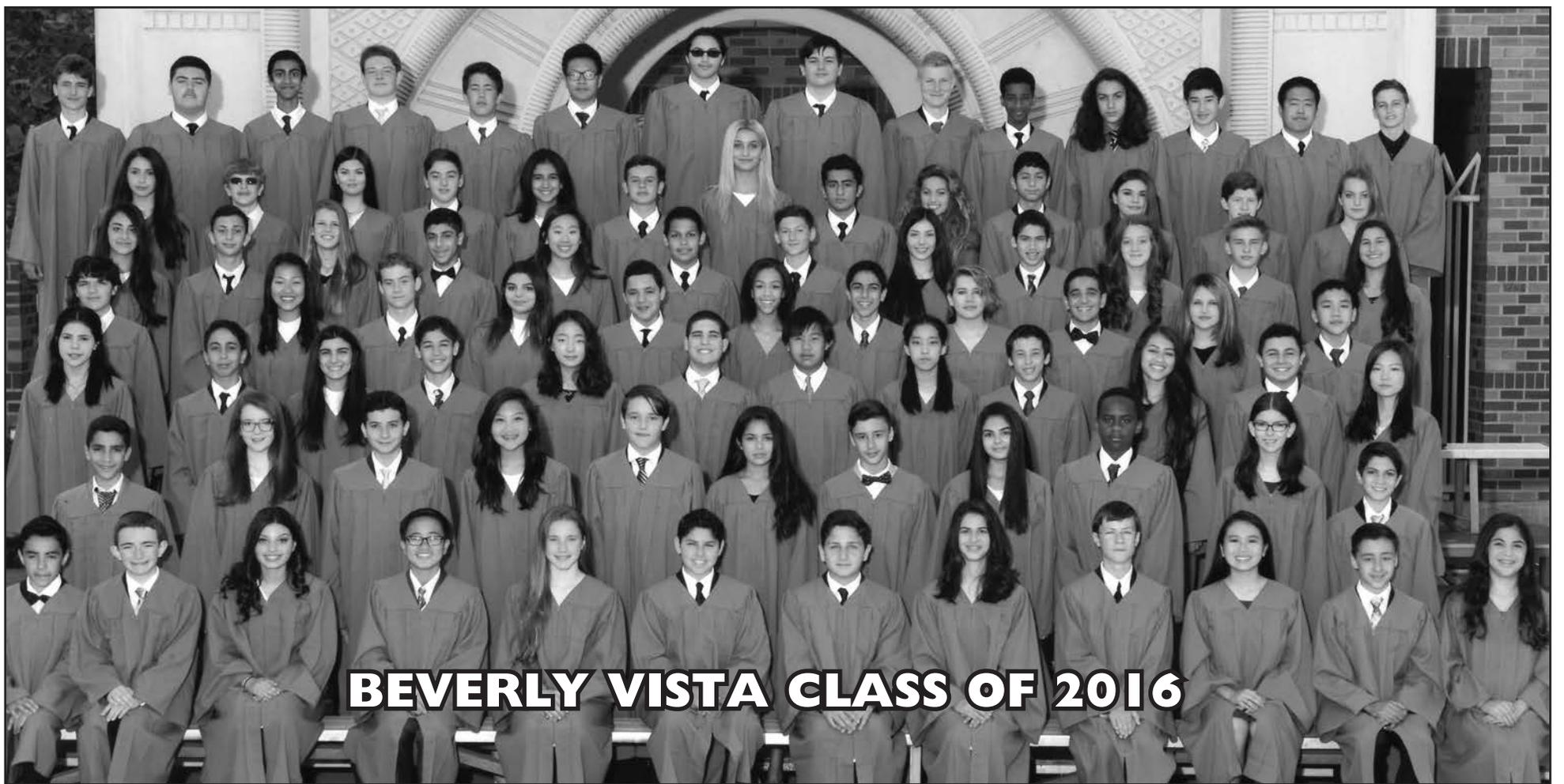

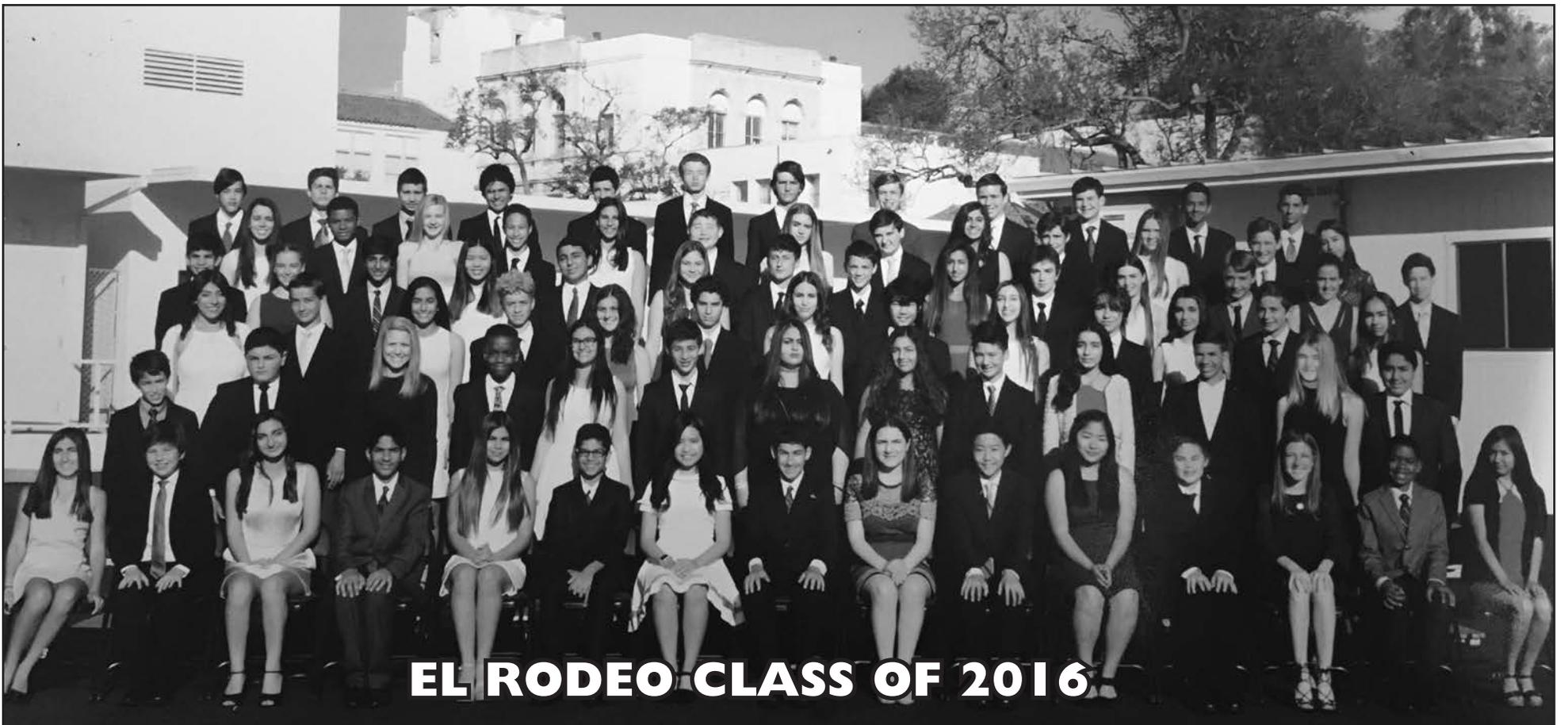

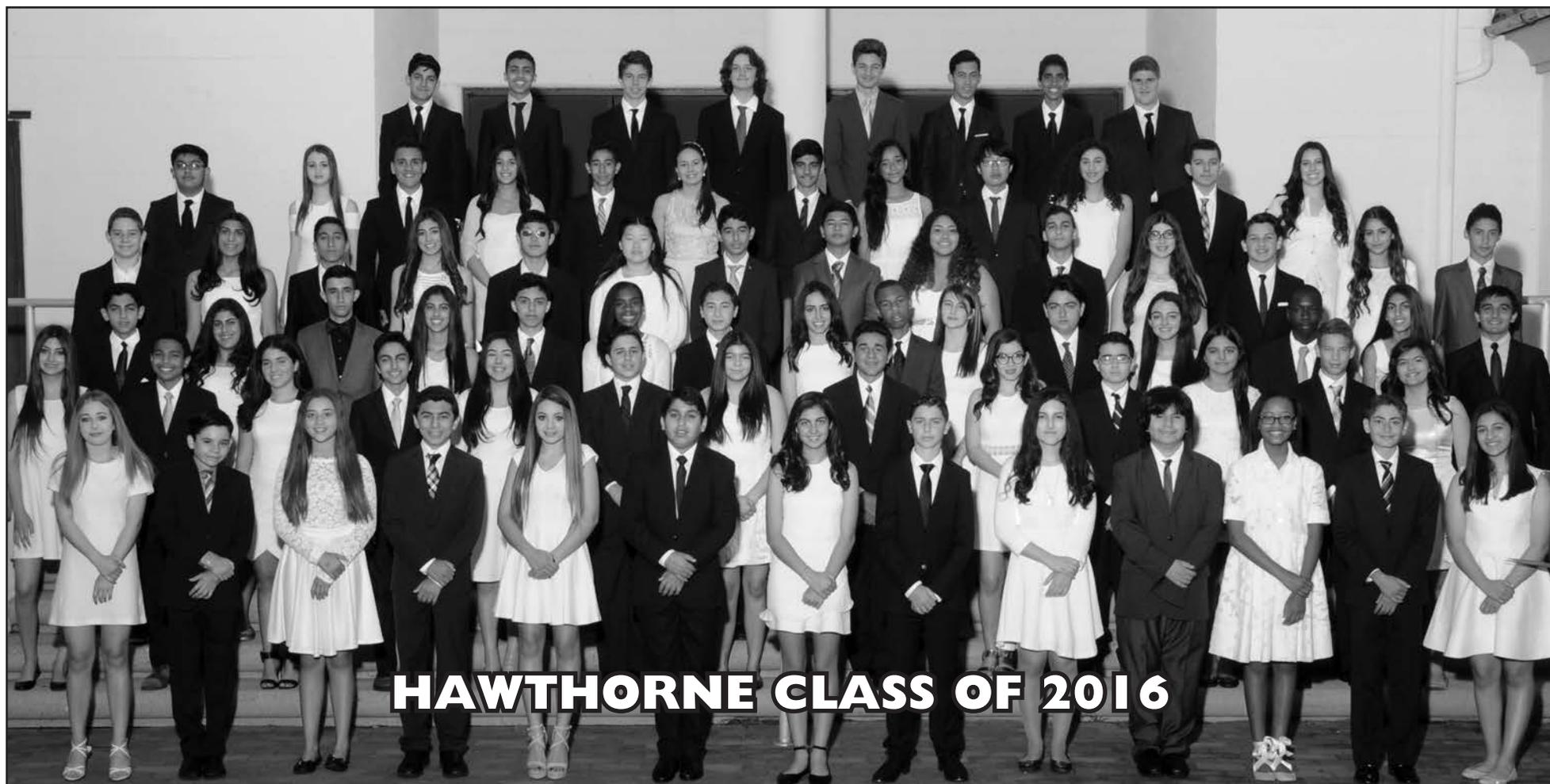

WHO WILL BE THE NEXT COUNCILMEMBER?

24 candidates vie for the vacant seat

At a town hall meeting May 31, the City Council will interview 24 candidates pursuing an appointment to the Council. Fifteen of the applicants spoke to the Weekly about why they are seeking the open seat.



ANN ANOOSHIAN

I seek a position on the Beverly Hills City Council. I have very serious concerns regarding the safety of pedestrians in the city of Beverly Hills.

As well, I have concerns as to the proper posting of speed limit signs (currently none exist); prohibiting loitering for the purpose of panhandling; the design and placement of cross-walks north of Wilshire Blvd; the use of school buses for children of Beverly Hills grammar schools; and I would like to implement methods to reduce the speed of traffic in residential neighborhoods via speed bumps.

I have many other concerns but these are the first to come to mind. Each time I walk with my young daughter, the event is filled with very near misses and is both terrifying and troubling. I have become weary of complaining to myself and now intend to “do something” about it. I love this city and plan to spend many years within it. My former legislative and policy experience on a national level will of course lend itself to qualify me for this position.

I decided to pursue an appointment to the Beverly Hills Council because I would like to help (1) preserve Beverly Hills and protect it from more overdevelopment and traffic; (2) improve resident e-mail notice procedures and utility bill payment website procedures; (3) explore the possibility of underground utility poles; and (4) the possibility of security measures such as gated alleys and added cameras.

A short stint on the Council seems ideal, as well as bypassing an expensive and stressful election.

I did not anticipate so many other worthy candidates, and such a public process. But I am ready for it.

The Council could have appointed a student (much like a Student UC Regent; we have some most capable ones) or a former mayor (there

are still a few not otherwise committed to promote one project or another), but it opted to open the process up to anyone who feels motivated enough.

Twenty-four people have stepped up, and it is an honor to be among them.

The vetting process will be a combination of reality TV and the presidential race. Walls will be erected and they will fall down; Mexico will not be expected to pay for it. At the end, the person chosen will be the one with whom the current four members feel most able to work in concert.

Levity aside, I and the other applicants are taking this process very seriously. We realize 23 of us will return to our daily lives, one will jump into the deep waters for the next nine months.

Norman baseball team loses playoff game in extra innings

Beverly High senior Amanda Block cleared 11 feet, 9 inches to finish in a four-way tie for second in the girls' pole vault in the Southern Section Division 3 track and field finals Saturday at Cerritos College.

The competition opened at 8-9, with the bar being raised at six-inch increments. Block passed on the first three heights, entering the competition at 10-3, which she cleared on her first attempt.

Block also cleared the bar on her first attempt on each of the next three heights – 10-9 and 11-3 and 11-9.

Block, like four of the five remaining vaulters, missed all three attempts at 12-3, three inches higher than her school record.

Clearing 11-9 put Block among the top 12 vaulters in all four Southern Section divisions, qualifying her for the Masters meet, which will be held Friday at Cerritos College, beginning at 3:30 p.m.

Block's final attempt at 12-3, "was the best vault I've ever seen her take," said Norman coach Howard Edelman.

"She just unfortunately brushed the bar on the way down," Edelman said. "She did something (technically) really wonderful during that attempt. If she tries to duplicate that at the Masters meet, we think she has a great shot at

making the state meet."

The top five finishers at the Masters meet, along with any other vaulters clearing 11-7 qualify for the state meet.

Block has announced she will continue to compete at Brown University, which like all Ivy League schools does not offer athletic scholarships.

Edelman credits Block's success to her early training as a gymnast, being coached by her personal coach Anthony Curran, a longtime UCLA coach, and Dwayne Washington at Beverly High, and her work habits.

The Normans took a 3-1 lead in the top of the eighth inning on Sean Kochinski's two-out, two-run double, but the Sea Kings scored twice in their half of the eighth on a lead-off home run and a two-out single and once in the ninth on a two-out single.

The players "did everything I asked of" them in the playoff game, Riesenberg said.

"Every game I asked them to play hard, go for as long as they can, leave it all on the field and have fun and they did all of those things," Riesenberg said.

"It just happened we didn't end up on the winning side."

The Normans had 13 players in uniform to the Sea Kings 34, Riesenberg said.

The team had 13 players for most of the season because "that's all that came out for baseball and that's all that warranted to be on varsity baseball," said Riesenberg, who was in his first season as coach.

Beverly Hills was 11-11 and 5-5 in Ocean League play, tying Santa Monica for third and getting the league's final playoff berth because of its 2-0 record against the Vikings.

Riesenberg said he was "extremely satisfied with our season."

"About halfway through the season I mentioned the playoffs to the kids and they all looked at me like I was speaking a foreign language," Riesenberg said.

The Normans failed to qualify for the playoffs in 2015 when they were coached by Vonzie Paysinger, now the school's softball coach.

"(I) explained to them we could do this," Riesenberg said. "Our kids worked hard and did everything I asked of them. Extremely pleased with how they played this year."

ORDINANCE NO. 16-O-2703

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING ALARM SYSTEMS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The city council hereby amends and restates Sections 4-4-105 ("CALL VERIFICATION RESPONSE FOR SERVICE") of Article 1 ("Alarm Systems And False Alarms") of Chapter 4 ("OTHER REGULATIONS FOR SPECIFIC TYPES OF BUSINESSES AND ACTIVITIES") of Title 4 ("REGULATION OF CERTAIN TYPES OF BUSINESSES AND ACTIVITIES") of the Beverly Hills Municipal Code to read as follows:

4-4-105: REQUEST FOR RESPONSE AT ALARM SITE:

At the time a request for police or fire response to an alarm site is made, the alarm business, central station or other answering service shall provide all information required by the police or fire department dispatcher including, but not limited to, the time, date and location of the alarm; the name, address and telephone number of the alarm subscriber or his or her designee; and the cause of the alarm.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the city Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

ORDINANCE NO. 16-O-2704

AN INTERIM ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE MUNICIPAL CODE REGARDING COUNCIL CALL UP OF DECISIONS OF COMMISSIONS, BOARDS, OR OFFICIALS, AND DECLARING THE URGENCY THEREOF

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. Legislative Findings.

The Beverly Hills Municipal Code provides that if the Council orders a review of a decision of a Commission, Board or official of the City, the effectiveness of such decision is stayed until Council review is final. The City Council of the City of Beverly Hills is concerned that staying the Planning Commission's May 3, 2016 decision relating to the L'Ermitage Hotel, and other similar projects, to allow City Council review will impact the project, in this case by causing the hotel restaurant to be closed down resulting in significant financial impact to the hotel and amenities provided to the community, residents and tourists. Further, conditions of approval imposed to protect the neighborhood from impacts of hotel operations will remain in place and be enforceable by the City during the interim period.

Section 2. Authority.

Pursuant to Government Code Section 65858, the City Council may adopt as an urgency measure, an interim ordinance regarding a contemplated zoning proposal that the City Council is considering, studying or intends to study within a reasonable period of time.

Section 3. Urgency Findings.

The City Council finds and determines that the immediate preservation of the public health, safety, or welfare requires that this Interim Ordinance be enacted as an urgency ordinance pursuant to Government Code Section 65858 and take effect immediately upon adoption. The Planning Commission's decision allows the hotel restaurant to be open to the public, relocates the open air dining area and establishes conditions of approval that relate to the roof-top event space, the hotel restaurant and the open air dining area. These are important issues to be considered by the City Council. However, the Planning Commission approval and conditions protects neighbors in the interim while the hotel operates, inuring benefits to the City and neighborhood. If the Planning Commission's decision to allow the hotel restaurant to be open to the public were stayed, this would have significant impact to the hotel and revenue source for the City, and would also stay the conditions of approval imposed to protect the neighborhood. Enabling the hotel to continue operating pending a final decision by the Council will provide revenue to the City and enhance luxury amenities to tourists and the neighborhood consistent with the City's economic development goals, while protecting the neighborhood through the conditions imposed by the Planning Commission. If this Ordinance does not become effective immediately, but instead becomes effective thirty (30) days after a second reading, there is a real risk that the hotel, a significant revenue source to the City, will suffer financial impact, and residents could suffer other impacts. It is necessary that this Ordinance take effect immediately to prevent such harm pending a final decision by the Council on the matter. Therefore, this Ordinance is necessary for the immediate preservation of the public peace, health, safety or welfare and its urgency is hereby declared.

Section 4. The City Council hereby amends and restates Section 1-4-201 ("RIGHT TO REVIEW") of Article 2 ("Council Ordered Review of Administrative Decisions") of Chapter 4 ("APPEAL AND REVIEW PROCEDURES") of Title 1 ("GENERAL PROVISIONS") of the Beverly Hills Municipal Code to read as follows:

1-4-201: RIGHT TO REVIEW:

The council may order a review of any decision made by any commission, board, or official of the city, except as otherwise provided in this code. Such review may be ordered by motion of the council duly adopted within thirty (30) calendar days after the issuance of the decision. If the council orders a review of a decision, the effectiveness of such decision shall be stayed until council review is final, except for the Planning Commission's May 3, 2016 decision relating to the L'Ermitage Hotel located at 9291 Burton Way, or unless otherwise directed by the Council for any other project.

Section 5. CEQA Findings.

The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption and implementation of this Ordinance may have a significant effect on the environment. This Ordinance does not authorize construction and maintains the status quo as to approved activities with conditions of approval that protect the neighborhood, pending a final decision by the City Council on the matter called for review. This Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Section 6. Severability.

If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 7. This Ordinance, being an Interim Ordinance adopted as an urgency measure for the immediate protection of the public safety, health, and general welfare, containing a declaration of the facts constituting the urgency, and passed by a minimum four-fifths (4/5) vote of the City Council, shall take effect immediately upon its adoption and shall continue in effect for a period of not longer than forty-five (45) days; provided, however, that after notice pursuant to Section 65090 of the California Government Code and public hearing, the City Council may extend the effectiveness of this Interim Ordinance as provided in Government Code Section 65858. If this Interim Ordinance is not extended, then section 1-4-201 shall be reinstated in its previous form.

Section 8. Publication.

The City Clerk shall certify to the adoption of this Ordinance and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

WELL DRILLING CONTRACT

Notice is hereby given that the City of Beverly Hills ("CITY") has determined that all bidders for the construction of the Well Drilling Contract ("Project"), must be pre-qualified prior to submitting a bid on that Project. It is mandatory that all Contractors who intend to submit a bid, fully complete the prequalification questionnaire, provide all materials requested herein, and be approved by the CITY to be on the final qualified Bidders list.

No bid will be accepted from a Contractor that has failed to comply with these requirements. If two or more business entities submit a bid as part of a Joint Venture, or expect to submit a bid as part of a Joint Venture, each entity within the Joint Venture must be separately qualified to bid. The last date to submit a fully completed questionnaire is **2:00 PM Friday, June 24, 2016**. Contractors are encouraged to submit prequalification packages as soon as possible, so that they may be notified of omissions of information to be remedied or of their prequalification status in advance of the prequalification deadline for this Project.

Answers to questions contained in the attached questionnaire are required. The CITY will use these documents as the basis of rating Contractors with respect to whether each Contractor is qualified to bid on the Project, and reserves the right to check other sources available. The CITY's decision will be based on objective evaluation criteria.

The CITY reserves the right to adjust, increase, limit, suspend or rescind the prequalification rating based on subsequently learned information. Contractors whose rating changes sufficiently to disqualify them will be notified, and given an opportunity for a hearing consistent with the hearing procedures described below for appealing a prequalification rating.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the CITY in determining bidder responsibility prior to bid and to aid the CITY in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequalification rating, will preclude the CITY from a post-bid consideration and determination of whether a bidder has the quality, fitness, capacity and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness.

The prequalification packages should be submitted under seal to the **Office of the City Clerk, City of Beverly Hills, 455 North Rexford Drive, Room 290, Beverly Hills, CA 90210**. The following should be clearly marked on the outside of the package **"CONFIDENTIAL PREQUALIFICATION STATEMENT FOR THE WELL DRILLING CONTRACT"**

The prequalification packages submitted by Contractors are not public records and are not open to public inspection. All information provided will be kept confidential to the extent permitted by law.

However, the contents may be disclosed to third parties for purpose of verification, or investigation of substantial allegations, or in an appeal hearing. State law requires that the names of contractors applying for prequalification status shall be public records subject to disclosure, and the first page of the questionnaire will be used for that purpose.

Each questionnaire must be signed under penalty of perjury in the manner designated at the end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the CITY and provide updated accurate information in writing, under penalty of perjury.

The CITY reserves the right to waive minor irregularities and omissions in the information contained in the prequalification application submitted, and to make all final determinations. The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors may submit prequalification packages during regular working hours on any day that the offices of the CITY are open. Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information.

The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Department of Public Works senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.

PROJECT DESCRIPTION

As part of the City's 2015 Water Enterprise Plan, the City of Beverly Hills is planning to develop 1,700 acre-feet per year of new groundwater in the un-adjudicated portion of the Central Basin near Interstate 10, approximately four miles from Beverly Hills. The City plans to develop three (3) new Central Basin wells with approximately 800 gallons per minute capacity each. 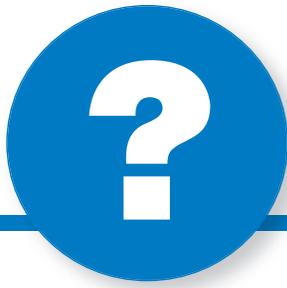
