## Marathon Planning Commission mtg. ends with approval of Hillside Ordinance

A Planning Commission special meeting on the divisive Hillside Development Standards Ordinance lasted nearly four hours June 30 and ended with the Commission unanimously approving the initiative.

“I have sympathy for both sides,” said Commission Chair Alan Robert Block, speaking to an audience that filled the Council Chambers. “I’m concerned for the existing residents who are concerned about having large projects in their area—I would be concerned as well—and I’m concerned about the people that have projects in the pipeline.”

Crafted by Commissioner Craig Corman, whose last meeting was Thursday, the ordinance aims to regulate developments in the hillside area, which have become increasingly larger in scale and size. It reduces the by-right limit of export/import from any single site to 1,500 cubic yards in a five-year period for properties located immediately adjacent to a street that is less than 24 feet wide.

“There’s no scientific amount—it’s half of 3,000—but it was sort of based partly

on the impacts on the narrow streets and partly on the fact that we didn’t want to [capture] too many properties,” Corman said.

Commissioner Lori Greene Gordon said the number was a “good starting point,” but expects the City Council will refine the number.

City staff identified 13 streets that are less than 24 feet wide in some areas: Cabrillo Drive, Calle Vista Drive, El Retiro Way, Garden Way, Glen Way, La Altura Road, Lago Vista Drive, Lago Vista Place, Loma Linda Drive, Monte Cielo Drive, Pickfair Way, Summitridge Place and Tower Road.

The ordinance also limits the maximum cumulative floor area located off the existing level pad to 1,000 square feet. Additional floor area located off the existing level pad in excess of 1,000 square feet would require approval of a Hillside R-1 Permit.

The ordinance will not apply to projects that have received discretionary approvals prior to its passage.

Though the Commission adopted the original “urgency” ordinance June 9, Corman soon after made a motion to reconsider the action.

The draft ordinance will become effective in about two months, according to City Planner and Assistant Director of Community Development/City Planner Ryan Gohlich.

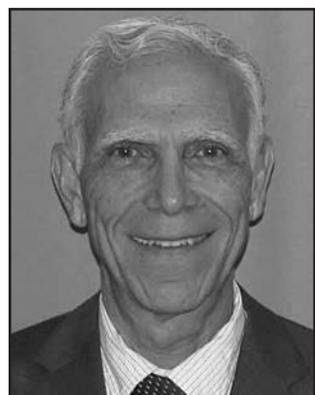


## Council turns down El Rodeo request for 60 Camden spaces

At their study session Tuesday, the City Council turned down a request by the BHUSD to use over 60 city-owned parking spaces.

"I think we all share the concern that we don't want to lose spaces for businesses," said Mayor John Mirisch.

In a May 25th letter to City Manager Mahdi Aluzri, BHUSD Facilities Officer Eitan Aharoni requested the city provide 60 off-street parking spaces, as well as one on-street curbside spot, to accommodate El Rodeo employees while the K-8 campus undergoes construction, which is estimated to last two-and-a-half years.

"Our purpose is to try to alleviate the parking in the neighborhood surrounding El Rodeo," Aharoni said Tuesday.

The city parking facility at 440 North Camden Drive was identified as the most suitable structure, due to its proximity to El Rodeo. For the 183-day period beginning in mid-August and finishing in May, the district offered to pay the city \$25,000.

"The basis for our assessment starts with establishing the daily charge by dividing the \$155 monthly fee by 30 days in a month," Aharoni wrote in the letter to Aluzri. "We then apply the 183 days we need these spaces each year and that we only use them from 7:00 a.m. to 4:00 p.m. or 9 hours per day. Our need is for 60 spaces, which brings our annual fee for

this parking to \$21,300."

But councilmembers outlined several reasons why they do not support the location.

"I'm not so willing to give up the Camden lot, because I've been in it when it's full—you say it isn't, but I've been in there on a Saturday when it's good and full, and I've been in there on a Tuesday when it's full," said Vice Mayor Nancy Krasne.

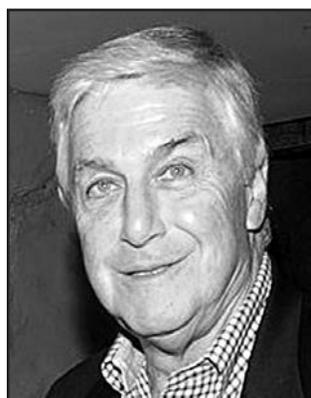
The Council will keep the dialogue with the district open and discuss alternative methods, such as paving over the five-acre lot adjacent to the dog park site.

"It seems that we talk about it a lot, in a lot of different contexts," said Councilmember Julian Gold. "If it were to be that we were going to surface [the lot], we could sell parking to the construction company and make money off this deal."

Councilmember Lili Bosse was absent from the meeting.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, July 14, 2016, will hold a public hearing beginning at 1:30 PM, or as soon thereafter as the matter may be heard to consider the following:

### PROJECT DESCRIPTION

The proposed project involves the construction of a new multi-family residential condominium building containing a total of 31 units on the property located at 332-336 N. Oakhurst Drive. The subject property is partially located in the City of Beverly Hills (westerly portion, including building frontage on N. Oakhurst Drive), with a majority portion located in the City of Los Angeles (easterly portion). The proposed project would have a maximum height of 3 stories and 39' for the portion of the building located in Beverly Hills, and a maximum height of 5 stories and 60' for the portion of the building located in Los Angeles. The portion of the building located in Beverly Hills would contain a total of 7 units, with the remaining 24 units located in Los Angeles. The project would contain a total of 91 subterranean parking spaces, 30 of which would be located in the Beverly Hills portion of the project, with the remaining 61 parking spaces located in Los Angeles. Approval of the project requires approval of a Vesting Tentative Tract Map and a Development Plan Review.

The Planning Commission previously considered this project at its regular meeting held on October 8, 2015. At the conclusion of that meeting, the Planning Commission directed the applicant to redesign the project, and voted to create a Subcommittee consisting of two Planning Commissioners to work with the applicant and members of the public on the design changes. The Subcommittee held one meeting on April 12, 2016 to review a new design. The applicant subsequently requested for the matter to be brought forward to the full Planning Commission for a decision.

### ENVIRONMENTAL REVIEW

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The subject property is partially located in the City of Beverly Hills, with a majority portion located in the City of Los Angeles. As the designated lead agency for this project, the City of Los Angeles prepared an Initial Study to determine the proposed project's potential impact on the environment. After reviewing the Initial Study, the lead agency determined that this project may have a significant effect on the environment, but by implementing certain mitigation measures, the project's potentially significant effects could be reduced to less than significant levels. Accordingly, a Mitigated Negative Declaration (MND) was prepared and adopted by the City of Los Angeles. The City of Beverly Hills, as a responsible agency, will consider the MND prepared and adopted by the City of Los Angeles.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

almost 90 years.”

The stretch of green dates back to 1929. Though once the site of a community clubhouse that boasted famous members like Walt Disney, the Lawn Bowling Green has since been vacated.

“For this body to just dismiss 87 years of activity and maintenance and care and love for the activity that [takes place] on that Bowling Green—I thought it was terribly disrespectful,” Siegman said.

Days before the Commission’s May 24th discussion, the Cultural Heritage Commission voted unanimously to recommend the space for possible landmark designation, following a request by Mayor John Mirisch.

“The issue here is we are taking a piece of grass—that’s what it is, it may have been there for a long time—[but] designating it as a cultural heritage site restricts the use of it—we are very concerned about that,” said Commissioner Howard Rosoff.

Mirisch is one of four Lawn Bowling Green members who are Beverly Hills residents. Siegman is a former resident but Wolfe is not.

### Council gives consensus for revised Revolving Door Ordinance

The City Council supported extending the time limits set forth in the Revolving Door Ordinance at their study session Tuesday. A new ordinance reflecting four different amendments is expected to come before the Council in August for approval.

Vice Mayor Nancy Krasne, who said she is “seeing too many people walk through a revolving door,” had requested the Council amend the current policy.

“I would like the ordinance strengthened and extended and I want it to apply to employees, whether they be Council level or any level,” Krasne said.

Currently, former city employees who were required to file a form 700 cannot represent a person for compensation for the purpose of influencing administration or legislative action for two years after leaving the position.

The restriction also applies to elected officials and Planning commissioners a year after their term of office ended, if it ended prior to April 1, 2009; and elected officials or Planning commissioners 30 months after their term ended, if they were in office after April 1, 2009.

“[City Attorney] Larry [Wiener,] did you tell [former] Mayor [Barry] Brucker that it was OK because his 30 months were up—that he could lobby for [the] Wanda [Group]?” Krasne said.

The Council supported a four-year time frame for all Planning Commissioners and city employees who were required to file a form 700, effective upon reappointment or appointment in January 2017.

“I would be in favor of a four-year period—I do think it should also apply to staff,” said Mayor John Mirisch.

Metro will hold a meeting from 6:00 p.m. to 8:00 p.m. at the Petersen Automotive Museum July 21 to inform residents about the development of the subway station.

Cuneo said the Council is “very concerned” and wants city staff to work with Metro to minimize the impacts of the project.

## DYNAMIC DUO

### Farshid Joe Shooshani on taking the helm of the Planning Commission

**You served on the Public Works Commission from 2007 to 2013. Why did you feel the Planning Commission was the next step?**

To my belief, I had a very successful Public Works [Commission]—we did quite a bit and almost changed the culture of the Commission. It became a very active [Commission], and I'm very happy with the results. When the opportunity came [to serve on the Planning Commission], I went for it, and I'm even happier being on the Planning Commission, because it really has teeth and we can do things [that] benefit the people.

**Compare and contrast Public Works and Planning.**

Public Works is the biggest spender of the city [budget]; most of our budget goes towards roads, water, paving and the infrastructure, and except for water, everything is very technical. The Planning Commission deals more with people and properties and we have much more interaction with the public and property owners. I think the Planning Commission

affects people in small cities even more than the federal government does, because it affects their surroundings, their property values —[for] most of the people I know, their major assets are their homes—so it has a big effect on people.

**In 1980, your family took over Bobco Metals, one of the oldest metal companies in Los Angeles. Tell us about that.**

I came here as a foreign student and because of the [1979 Iranian] revolution,

all my family had to escape and came to this country. We were lucky to find this business, which was already around 30 years old when we bought it. We've been operating it ever since, and it's now 62 years old. We are metal distributors, fabricators and manufacturers, and we cater to [everybody] from contractors to anybody who needs metal for different uses.

**How has your professional background influenced your experience on the Commission?**

In addition to doing the marketing and taking care of the customers at Bobco [Metals], I also have been a builder and have built many projects, including townhouses and apartments, and [I have]

remodeled houses. I also did a project on the Sunset Strip, which is a jumbotron; it is very unique and I've been managing and owning it for the last 20 years. The sign is next to the House of Blues and the Andaz Hotel. The idea came and we did it all from scratch and it's the first successful jumbotron in the city.

**Tell us about your family.**

I've been married to Avid Shooshani for the last 28 years. We have two chil-

dren: our daughter Diba, who graduated from USC and works for a local PR company, and our son Aaron, who will be finishing his last year at Columbia University in New York.

**Many divisive issues have come before the Planning Commission in recent months. Is it difficult to make a firm decision when there are strong arguments for both sides?**

I see it as a privilege to view this as a homeowner and a stakeholder in this city. Everybody on the Commission wants to

do the best for the city, but the question is we have different approaches to it. The beauty of this democratic system is that we sit down and we talk and we reach the best [solution] for the city—sometimes it's my idea and sometimes it's another [commissioner's idea], but the whole aim is to do the best for the city that we love and cherish.

**Can it sometimes get stressful?**

We do it in a very legal and transparent way, and everybody puts their problems on the table. Based on the situation, you use your judgment to come up with a solution. All the solutions are based on how it's going to benefit the city and not harm it. When problems come in, there are many sides to it; they say a coin has two sides, but in many cases the coin is multisided. We have the ideas of the city staff, the commissioners and the homeowners, and we try to study them, learn them and try to find out what's going on and make a decision based on the information we have.

**What are some projects the Commission is working on?**

The [Hillside Development Standards Ordinance] was a very interesting issue. It was time to redo some of the laws and ordinances [relating to] the hillside, which is north of Sunset. Everybody agreed that it should be studied and changed; the question was when to have the cutoff for projects in pipeline. Overall, we wanted a change and we had to regulate the hillside a little bit more because nobody wants to have our hillside degraded and harmed—it's an asset and we have to keep it. In that way, the biggest issue was the timing and the extent that we go with the changes based on the studies that can be done later. At the same time, we had to hear everyone's opinions and value them, because it's important for people to see that we listen

to them. We have to listen to everyone that comes and consider what they say.

The biggest [upcoming project] is the Wanda [Group project, "One Beverly Hills"]. What they're changing is adding some hotel rooms to it, so we have to go over it one by one. The most important part of it is traffic.



**Planning Commissioner Craig Corman ended his seven-year term last week. Any parting words?**

As I told [Craig], he's a commissioner's commissioner—an amazing, talented person, and it's a loss for all of us. I hope he runs for office. I think he's done more than \$1 million worth of free legal work for the city [by] coming up with ordinances. I have learned from him and I'm very sorry his term is up; he truly was an asset to our commission.

**In our interview with Craig Corman in issue #671, he said, "We see a lot of projects that have an impact on**

**the city and I think that we've made an effort to make sure those projects are always beneficial to the city." Do you agree?**

Absolutely, this is our job. And I'll add to it: another one of our duties is to try to keep and enhance our property values. As I said, our properties are probably our biggest assets, and our job is to maintain and enhance it however possible.

**What is your top priority as Chair?**

Our mayor [John Mirisch] is doing automatic cars and I think it's fantastic and the future. I'm hoping to do automatic parking and I think, if implemented, it would really make a difference for our city and eliminate the parking problem for most projects. It can be a big change for us. Our larger homes are doing fabulously, but we have rental units that have not been touched in 40 years and they are getting old and dilapidated and somehow they need to be renewed. I think automatic parking, if done correctly, can revitalize our city.

## DYNAMIC DUO

### Gidas Peteris on steering the Architectural Commission

#### What inspired you to apply for the Architectural Commission?

I sort of grew up in the Beverly Hills community, although I don't live here. My father was an architect and I became an architect as well, and we worked together for a few years and then I started my own firm. He started in Beverly Hills: he worked for an architect in Beverly Hills and then he opened up his own office. I got involved with a number of projects in Beverly Hills and I felt that

Beverly Hills had been very good to me, so I then got involved doing some design work with another gentleman, Jim Ply; we worked on the Beverly Hills 9/11 Memorial Garden together on the corner of [North] Rexford [Drive] and [South Santa Monica Boulevard]. After doing that project, it felt pretty good to give back and I started getting involved with a few other things that were city related. When the opportunity [to serve on the Commission] came up, I felt it would be really nice to give back, so I applied. The rest is history.

#### In 1994, you founded Peteris Architects. Tell us about that.

I graduated from the University of Oregon in 1989 and I worked with my

dad for a couple of years and then I opened my own practice. [My dad] was getting ready to retire, and I thought it would be a good idea that I create my own identity and style and flare [within] the business, so we opened Peteris Architects. We began doing residential and commercial projects, which we continue to this day. We do a lot of high-end residential renovation; we work with larger corporate clients like Verizon, Frontier Communications,

Bank of America and Wells Fargo; and then we take on other types of projects, like commercial tenant improvement and office spaces. I like to have a wide variety of projects, because I enjoy the diversity and the notion that I'm not doing the same thing every single day. I love the creative process [of architecture] and I love working with people, so it's been a really perfect fit for me. I'm the type of person that never watches the clock.

#### Describe your architectural style.

When it comes to residential projects, obviously we try to work and conform to the context that's given to us. In other words, I'm not necessarily the type of person that would give you a modern box in a neighborhood that only has bungalow-style buildings. We tend to

favor modern use of traditional materials, so wood-beam ceilings, granites and marbles, but used in a modern way. We've done a lot of modern, ranch-style houses and a lot of Spanish and Mediterranean-style houses. As far as our commercial aesthetic, I would say it's more of a modern look, whether it's interior-tenant improvements or ground-up construction, we tend to stay a little bit more on the modern side. We like to use some of the more elegant materials and detail them such that they're used in a modern fashion

#### In the Weekly's interview with outgoing Chair Andrea Gardner

Apatow in issue #829, she said, "I think that [good architecture] is just a feeling; it elicits something and it just gives you a sense." How do you define good architecture?

I think good architecture serves a number of purposes. In Beverly Hills, it's a reflection of the image and the character of the city. In general, a good architectural project not only looks good and feels good, but it also functions well, and oftentimes improves the use of the space for the person occupying it. So if you're in a home and it feels right and it works perfectly for you, then that's fantastic; if it's a business and it improves your sales or makes your business model more effective, then that is also a sign of good architecture. For me, it's a blend of the aesthetic and how it functions.

#### How do you select the recipients of the Architectural Design Awards?

For me, personally, I'm looking for a

building that's aesthetically pleasing and functions well with the streetscape—it doesn't have to match exactly, but it has to work well with other architecture around it. I believe that the architecture is a direct reflection of the image and character of Beverly Hills, and so



the type of projects that achieve well in those areas will generally do well in the selection process.

#### Tell us about your family.

My wife, Egle Lesniauskas, is a pediatric dentist and we have been married 21 years. We have no kids and I'm an only child. We've lived in Cheviot Hills for about 17 or 18 years. [Editor's note: the architect is not required to live in the city.] Both my wife and I were born here, but both our parents are Lithuanian in descent. My parents are still both living and they live in San Diego.

#### A year from now, what do you hope

to have accomplished as Chair?

My goal is to continue the process started by some of the chairs that I've had the pleasure of working with. I think we take a lot of pride in working very well together as a commission. I'd like to continue the efficient and fair review process; I think we work with applicants well to expedite approvals. As a commission, we do very well at becoming part of the solution and we avoid just pure criticism: we give a lot of constructive input and maintain an open mind to different ideas and different design processes. Beverly Hills is a very exclusive brand, and its architecture is a real reflection of the image and character of the city, so I think our role as a commission is to maintain that, and that's what I hope to do.
