

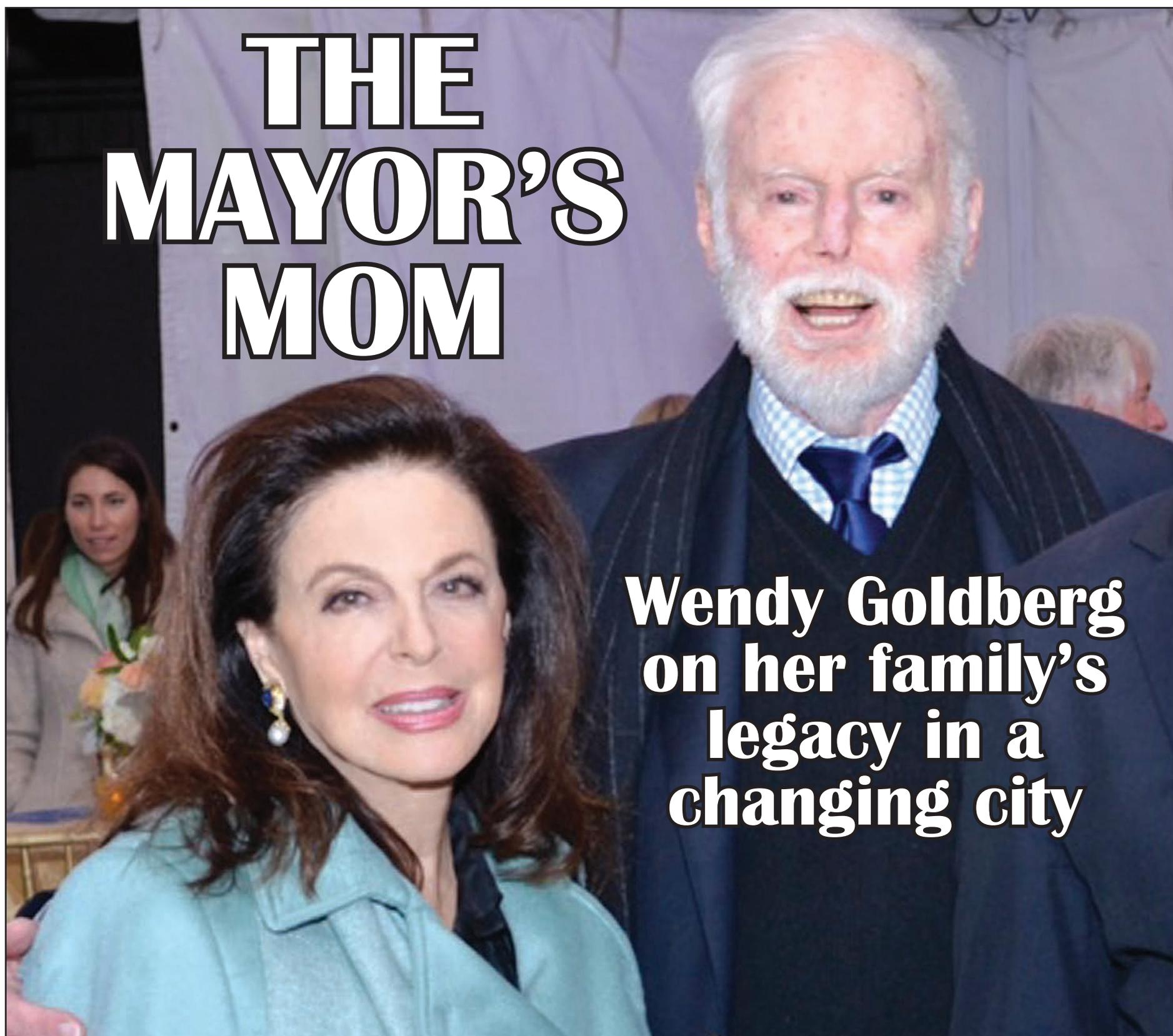

“Ten former School Board Members on why you should vote No on Measure Y” [Issue 889]

Maybe it’s hard to be out of the lime-light. Maybe I’ll feel that way in a few years, but I felt professionally (and somewhat personally) offended by the guest editorial of ten former board members who felt it necessary to “sling” some mud over this bond election. I find it rather curious that several of these Measure Y naysayers forgot the parts they played in the very “wasteful” construction program they began.

They conveniently fail to mention that seven of them were responsible for the thirteen-year construction span at Beverly Vista. That’s right, for thirteen years, students and staff were in portable classrooms. Now, I’m not blaming them for the 1994 Northridge quake or the obvious difficulty in preparing for such a massive undertaking as rebuilding an entire school, but thirteen years could not have been the best use of tax dollars.

To add to that, Beverly Vista’s dark atrium closely resembles a prison yard.

Somebody on that list actually thought that a giant sunken concrete ditch belonged in a school. Of course let’s not forget the incomplete building known as the “Bridge to Nowhere,” the result of running out of money.

And finally, the millions of dollars in latent construction defects that this board is now cleaning up with Measure E funds that could be utilized elsewhere (like technology).

Have any of them even contemplated that the current construction plans are in place to prevent another school closure in the event of a future quake? And finally, it is hypocritical that anyone who was directly responsible for a district being involved in a multi-million dollar judgment should speak about fiscal responsibility, ever.

It was this board who in a time span of four years gave purpose to an undefined \$334 million dollar bond by renovating the Ron Brown auditorium, constructing a new Classroom building, multipurpose room, subterranean parking garage and turf field at Horace Mann. Renovations at Beverly Vista included the entire athletic field, seismic upgrades to the main structural deck, waterproofing, and addressing the latent defects.

Hawthorne Auditorium will see seismic upgrades. In addition, asbestos, lead paint and other environmental toxins are being abated from seven buildings at

El Rodeo and the high school with the budget intact to complete these projects under Measure E. Mismanagement? It must be in the eye of the beholder. So, please vote for Measure Y. The alternative is not something I would want on my conscience.

Howard Goldstein's response to NO on Y is so full of errors and nonsense that correcting it all would require a treatise.

Instead, let's look at the facts as they pertain to Measure Y.

HOW MUCH MORE WILL MEASURE Y COST?

Beverly Hills voters were told that the last school bond, Measure E, would not raise taxes above the then existing \$49.71 per \$100,000 of assessed valuation. That was not true. Look at your current tax bill. Measure E, so far, has more than doubled the school portion of property taxes we pay in Beverly Hills.

Fasten your seatbelts for another major tax hike if Measure Y passes. Measure Y will increase taxes for a home assessed at \$2 million as much as \$1,200. We won't

know the exact amount until the bonds it authorizes are issued.

These are facts, and nothing that has been stated or written refutes them.

WILL NEW BUILDINGS REALLY IMPROVE EDUCATION?

Mr. Goldstein writes, "Research shows that improving a school's physical environment raises student achievement." What research? He doesn't cite any.

The connection between new buildings and better education is a fallacy. It's like saying that fire fighters cause fires because wherever there's fire there are firemen. Expensive new school buildings are found mostly in prosperous, upscale districts. Everyone knows that educational outcomes are better in wealthier districts than in poorer districts.

Better education isn't about classrooms; it's about what happens inside the classrooms.

ARE OUR BUILDINGS REALLY AS UNSAFE AS THE YES-ON-Y FACTION CLAIMS?

Yes on Y is running full-page ads showing pictures of cracks in our school buildings. They say our buildings are old, and imply that old buildings are unsafe. Eight years ago, Beverly Hills voters approved Measure E, which authorized School Boards to issue 334 million dollars for building projects, the maximum allowed by law.

Measure E was a "blank check". It came with no building plan or encumbrances. If 334 million dollars was not enough to fix cracks, then what's another

260 million going to do?

The three sitting school board members behind Measure Y have not prioritized making existing buildings safer. Instead, they want extravagant new buildings and parking garages. Just the three-story underground parking structure planned for the High School alone will cost approximately 36 million dollars and there is no study or data supporting the need for it.

If Yes on Y wants to make the case for replacing perfectly fine classrooms with "21st Century classrooms", they should make that case. But they don't. Instead they resort to scare tactics.

Don't be fooled. Safety is always a concern, but it is not the driving force behind Measure Y.

IS BHUSD REALLY A TOP ACADEMIC DISTRICT?

Should our School Board be devoting its attention to building projects instead of education? Are our academics really, as Howard Goldstein writes, "among the best in California and the nation"?

BHUSD is a district with very few economically disadvantaged students. In fact, according to the latest Smarter Balanced test data, BHUSD is one of only 13 unified school districts in California with less than ten percent economically disadvantaged students.

According to 2016 standardized test data, among those 13 districts, BHUSD is in the bottom 3 in both math and English.

The Planning Commission of the City of Beverly Hills, at its **REGULAR** meeting on Thursday, October 27, 2016, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard, to consider:

A request for a Conditional Use Permit, Development Plan Review, and Extended Hours Permit for the property located at **9400 Olympic Boulevard (Viviane Restaurant at Avalon Hotel)**. The Applicant (the Avalon Hotel) was previously granted a Conditional Use Permit, Development Plan Review, and Extended Hours Permit to allow the following operations at the hotel:

- Operation of a restaurant within the hotel that is open to the public;
- Operation of a hotel dining facility that receives patrons between the hours of 7 A.M. until 11 P.M. daily; and
- Use of patio areas adjacent to the pool for open air dining on private property.

The previously granted entitlements were not renewed in a timely manner and have expired. The Applicant is requesting a new Conditional Use Permit, Development Plan Review, and Extended Hours Permit to allow the same hotel dining operations with open air dining furniture in the same location within the hotel as was previously authorized.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Upon review, the project appears to qualify for exemption from CEQA. Accordingly, the Planning Commission will consider a recommendation to find the project exempt from the environmental review requirements of CEQA as a Class 1 Categorical Exemption (minor alterations to an existing facility) pursuant to Section 15301 of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission. Only five of last year's 396 BHHS graduating seniors matriculated to a top 25 university, based on U.S. News and World Report's rankings. That's a mere 1.3 percent of the graduating class. Another example of our district's mediocre academic standing is our dramatic decline in National Merit Semi-Finalist high school students. One decade ago, we had 24. Current years range from two to six.

Do these facts support the characterization that our district is "among the best in California and the nation"? Should our School Board be concentrating on building projects or on improving education?

IN CONCLUSION

New buildings will raise taxes but they will not improve education.

Measure Y contains no provision for citizen oversight, like Measure E.

Finally, this is the wrong Board to hand another blank check. Remember: two of the five members of this Board voted NO to bringing this hastily thrown together bond measure to the public.

"Hilton expected to spend \$1,000 per vote" [Issue 889]

Those of us who have spent considerable time in Beverly Hills understand that our City Council and Commissions serve to make the City a pleasant and livable environment.

That said; let's talk Measure HH, the Hilton's overpriced and over scaled bid to circumvent the Council, and the Planning Commission. Shouldn't a major building, certainly one which would be the tallest (by a factor of three) conform to the policies and practices that our city's government has implemented? Shouldn't those policies and practices, those which

mitigate safety, environmental and traffic issues, be respected and followed?

Anyone who has built or modified a home or business here has had to play by the rules, set forth by our Council and Commissions. Those policies and practices are not tyrannical or unreasonable, unless of course the builder just has no desire to follow them. Those policies and practices might be inconvenient, costly, or just not what the homeowner or developer wants to do.

So why is it that so many of our former mayors, many of whom once sat on a commission, champion the Hilton effort? Why, indeed. What's in it for them? Why would former mayors demean the planning commission and the City Council thus by joining the party to not only undermine their policies and practices, but elude and evade them altogether? Aren't these former mayors and former council members just saying that the planning commission is irrelevant? That it's meaningless?

I would bet that some of those former mayors and council members actually came up with some of those policies and practices that the Hilton wants to bypass. Why would former mayors embrace such a measure, and risk setting such a dangerous precedent?

The Hilton folks are circumventing the Council and planning commission, and all of their mandates, just because it can, just because it has millions upon millions of dollars to spend on its impressive campaign. Local papers have said that the Hilton enterprise is spending \$1,000 per vote to make sure that you vote for it. \$1,000 per vote? What could possibly be worth \$1000 per vote? Ask the Hilton.

But more important, ask the former mayors and former councilmembers of Beverly Hills who have leaped onto the Hilton's multi-million dollar campaign. Is all of this worth a little garden on the Hilton property?

It's not about the garden: Even if Measure HH loses, we still get the garden called for in the 2008 plan: "4.5 acres of new ground level open space" including "a 1.3... acre public garden."

The 2016 plan identifies "1.7 acres of open space as private garden generally open to the public..." The aggressively advertised "Open Space and Garden Initiative" adds a mere 0.4 acres of garden to the old plan. Why would a developer spend over \$5 million simply to give the City a slightly larger garden than promised in 2008?

It is about the skyscraper: The skyscraper will yield many millions in profit. There would be massive savings from digging for only one building foundation, as well as massive profits from selling more expensive condos on the highest floors. Also, it seems they will gain about 2 more stories of condos - the 2 separate buildings were 101 feet and 218 feet, totaling 319 feet, but the proposed

structure is 345 feet, 26 feet higher than the combined total (and there's another "30 feet in accessory structures above the roof line" - so sometimes it's shown to be 375' in height).

It is about the process: If Measure HH prevails, the developer will be fully released from the process and procedure that every other resident and business in the City must follow. This skyscraper will have no public input, no environmental impact report (EIR), no Planning Commission reviews, no Architectural review, no traffic studies, no shade and shadow studies, no city oversight on uses of the garden as far as noise and music from parties or from the pool which will now be located on Wilshire, across from residences.

But here's the Hilton's biggest win from not following the procedure: by using the initiative process, the developer precludes the City from renegotiating the 2008 development agreement by which the City was to be paid \$10.2 million, based on overall value of the property. Condos above 18 stories vastly increase the value of the property more than it is currently entitled, so the Hilton reaps more millions while the City is robbed of its fair share of development fees.

A statement from Board of Education Vice President Mel Spitz :

Because the "Yes on Y" campaign is stressing urgency of a \$260 million school construction bond measure, many residents have asked me why I voted against placing it on this year's ballot, and why I do not support it.

The need to complete the rebuilding of our schools is unquestioned. However, the prudent way to fund remediation of the remaining seismic deficiencies and replacement of antiquated buildings would be a more carefully crafted bond measure in 2018. Here are the reasons:

First, new construction projects at the high school, El Rodeo, and Hawthorne will be started about the same time whether a bond measure is approved in 2016 or 2018. Construction projects currently in progress at Beverly High and El Rodeo will not be completed until mid-2018. To have multiple projects at those campuses by different contractors simultaneously would be chaotic, if even possible. And, the final construction designs for Hawthorne and Beverly High have yet to be approved by this school board.

Second, since new projects will not start appreciably sooner than if funded by a bond measure in 2018, the "Yes on Y" objectives of avoiding increased construction costs and increased bond interest rates are illusory.

Third, oversight of construction projects currently in progress at Beverly High, El Rodeo, and Horace Mann is in disarray. There are issues that cannot be discussed openly, and taking on

It's definitely about precedent: The floodgates will be opened and developers will vie for the chance to erect their own high rise towers here. The character of our city will be changed for all time. Even though we can't undo existing overdevelopment, we can stand together to take charge of our city's future.

And it's about profit wherever it can be seized: Reduction in graywater usage from the 2008 plan. Recycled water was to be utilized in the operation of all four Hilton buildings (Beverly Hilton, two condominiums, and Waldorf Astoria) for all non-potable uses, such as water cooling and toilet flushing, as well as for the garden. In the 2016 plan, only the garden would utilize the recycled graywater, NOT the remaining three buildings. This was affirmed by the Judge ruling that the ballot language must describe the initiative as "reducing graywater requirements." The Hilton reduction in graywater use is estimated by the BH Public Works Department to waste over 10,000,000 gallons of water a year.

more construction before resolving them should not be an option.

Fourth, our district is faced with unprecedented financial and organizational instabilities. There are critical personnel issues that cannot be discussed openly. However, the precarious financial condition of the District will be disclosed publicly within the next few weeks. Resolving these issues, as well as district-wide academic underperformance, will require focused attention and energy of the school board. Currently that attention and energy is being distracted by the Yes on Y campaign, and the distraction will continue if Measure Y is approved.

Fifth, a professional survey of the community found that approval of a school bond measure by more than 50 percent of the voters is unlikely this year. Several influential community leaders are opposing Measure Y; but indicated they would support a bond measure in 2018 if the District's "house will be in order". Measure Y requires 67 percent voter approval because only 3 out of 5 board members voted for it. A better crafted measure in 2018 will likely be supported by the full school board, requiring just 55 percent voter approval.

Summing up, should this ill-timed Measure Y be defeated, the advantages of scheduling a better crafted measure in 2018 are many: Current construction projects will be completed and out of the way, plans for Hawthorne and Beverly High will be firmed up, critical issues facing the district will be resolved, the voter approval requirement will be 55 percent rather than 67 percent, and community support will be stronger.

Planning Commission approves development plan review for 332-336 N Oakhurst

The Planning Commission conditionally approved the development plan review for 332-336 N Oakhurst Drive with a 2-1 vote, during its meeting on Oct. 13.

Vice Chair Lori Greene Gordon dissented and Commissioners Alan Block and Howard Fisher were absent.

“We have to have discretion,” Greene Gordon said. “[The project] doesn’t fit on this block at this time and I truly feel that if we, as a Commission, say that because it meets code it’s acceptable to us then I think we are not living up to our responsibilities as people who are here to use discretion on behalf of the community, for the betterment of our city.”

The Commissioners approved the construction of a 26-unit condominium partially located in Los Angeles. The portion of the building in Beverly Hills will contain seven units, or fractions thereof, while the remaining 19 residential units will be located in Los Angeles, according to the staff report.

The project previously came before the Commission on Sept. 19. Project attorney Murray Fischer returned to the Commission on Oct. 13 with several revisions to the project, including:

- Reduced the number of residential units from 31 to 26
- Re-designed the project to reduce the number of stories in the Los Angeles portion from five stories, 60 feet tall, to four stories, 52 feet tall
- Introduced rooftop private open spaces consisting of six private roof patios located entirely in the Los Angeles portion of the building
- Reconfigured parking to meet Beverly Hills Municipal Code and no longer include tandem spaces
- Reduced the floor area of the project by 6,979 square feet, compared to the project reviewed by the Commission on Sept. 19

“When you asked us to do something we didn’t come back and say ‘no we don’t want to do that,’” Fischer said. “We’ve met the land use requirements, we’ve met the general plan requirements, we’ve met the City of Beverly Hills requirements and we have lessened, substantially, anything that can be built in the City of L.A.”

Several residents spoke in opposition of the project during public hearing. Chair of the city’s centennial initiative “The Next 100 Years” Woody Clark attended the meeting and told the Weekly he perceives the project as a “[loss] of [the City’s] tradition, culture and heritage.”

“Clearly, the decision was for the builders and their lawyers in Beverly Hills who have money,” Clark said. “The area needs to be designated as a historical district by the City. There is a pattern in Beverly Hills regarding large buildings and we have to put a stop to it. It should not happen as we go into the next

100 years.”

The project demolishes two buildings designed by the first licensed woman architect in Los Angeles Edith Northman. Northman is recognized on the City’s Master Architect list.

“This entire issue needs to be taken before the Cultural Heritage Commission, as well as City Council,” Clark said.

Cultural Heritage Chair Rebecca Pynoos told the Weekly the issue was not brought before her Commission because the City of Los Angeles was deemed responsible for the historic evaluation of the property.

“The City of Los Angeles became the lead agency on this project and made the determination about the historic nature of this property,” Pynoos said. “In my mind, it should have come before our commission because the property straddles both cities. Just because [Northman] is on the Master Architect List doesn’t mean [the property] meets all criteria to be determined historic.”

City Planner Ryan Gohlic previously told the Weekly a 30-day hold is triggered on demolition permits because Northman is recognized on the Master Architect List. During the hold, it is possible the property could be called up for review by the Council or the Cultural Heritage Commission in order to further assess whether the individual properties are eligible for local landmark status.

Totum presents historical preservation plans to Cultural Heritage Commission

The Cultural Heritage Commission received a construction update from Totum, a project management firm hired by the Beverly Hills Unified School District, on the rehabilitation of historic properties located on school campuses, during its meeting on Oct. 5.

Four campuses including, El Rodeo, Beverly High, Horace Mann and Hawthorne, have buildings of historic value which require preservation, according to Totum representative Richard Panos.

“What you see is what you’re going to get,”

Panos said. “There has never been any intent by the school district to make any changes, at all, to any of the historic buildings on those campuses. We have to do something to some of the historic elements because they’re so old. Seismically, they are unsafe and we have to do something.”

Panos noted El Rodeo is the campus with the “biggest challenges.” Totum conducted a “decorative stone assessment” on the façade of the El Rodeo rotunda in order to “replicate it exactly as it is.”

Original record drawings from when the building was first created and 3D-imaging will be used to help recreate a replica of the rotunda.

The restoration of the rotunda is estimated to be about \$8 million, according to Panos.

Following questions from Vice Chair Noah Furie, Panos stated all defining historical characteristics of the El Rodeo buildings will be replaced and duplicated, rather than rehabilitated.

“When you get down to the effort that it would take to do restoration work, when 90 percent of [the features] have to be replaced, economically, it doesn’t make sense,” Panos said.

Panos also discussed the renovation of the Hawthorne auditorium. Currently, there are only plans to restore the auditorium. Funding to remodel the remainder of the school is contingent upon bond money from Measure Y, which will be voted on in November.

The cupola on top of Hawthorne’s tower has been removed, uncovering a 40,000 bee beehive, according to Panos.

“The intent is to replicate [Hawthorne’s tower] in the same fashion as [El Rodeo’s rotunda],” Panos said “but we’re going to remove the bees.”

The old structure will be replaced with lighter weight material. Panos said the restoration of the Hawthorne tower is “far less complicate” than that of the El Rodeo rotunda.

“[The Hawthorne tower] doesn’t have as much applied cut stone to it [compared to] what’s on El Rodeo, so it’s an easier restoration process,” Panos said.

School campuses are not part of the Commission’s jurisdiction.

“We are aware the schools are not under our purview,” said Commissioner Maralee Beck “but we are intensely curious about all these elements.”

Mirisch highlighted the uniqueness of the City and ask the attendees to consider “what [they] can do to be a better first-rate Beverly Hills.”

Among other issues, Mirisch addressed rapid development and congestion within the City. He advocated for “less Big Brother and more local control” when it comes to regulating developers and local land use planning.

“Home is an almost sacred concept,” Mirisch said. “Communities should be able to decide for themselves what kind of development they feel is appropriate for their residents, for their own vision of the future and they should not be forced into models which don’t allow them to fulfill their unique, individual potential.”

He noted densification is not the simple solution to housing problems, as he believes President Barack Obama, Governor Jerry Brown, and Assemblymember Richard Bloom may suggest.

Mirisch suggested a combination of “old and new solutions” such as “a combination of housing subsidies and rent control to ensure a continued diverse mix of residents within the county.”

He was also proud to report the City as a leader in developing public transportation based on emerging autonomous vehicle technology. He believes autonomous vehicles have the “potential to democratize public transportation [and] revolutionize land use planning.”

He concluded his speech by emphasizing the importance of embracing innovative transportation technology so Beverly Hills can maximize its potential as a city.

Vera Markowitz announces candidacy for City Council

Resident Vera Markowitz announced she will be running for City Council in the March 7, 2017 election, in a press release obtained by the Weekly.

“With a myriad of construction projects active currently in our city, I want to make sure that quality of life is not disrupted and that security is maintained throughout this period

of exciting growth,” Markowitz wrote in the release.

Markowitz sees the preservation of Rodeo Drive as the centerpiece of the local tourism industry. She seeks to create a pedestrian promenade along Rodeo Drive that she believes will enhance the beauty of the world-renowned shopping area and improve the quality of the experience for all who frequent the promenade.

Although this is Markowitz’s first time running for office, she has been active in local and statewide politics. She played a role in Governor Jerry Brown’s gubernatorial campaign and served as Campaign Chair for Beverly Hills Mayor MeraLee Goldman. Markowitz. She has also participated in Team Beverly Hills.

Markowitz’s public service extends to the private sector as well. She served as president of the Amy Karen Cancer Fund and is a founding member of the Zimmer Children’s Museum. She is an active member of the Beverly Hills Synagogue and currently serves on the Board of the Sisterhood.

The mother of three and grandmother of six, she and her husband Dr. Harold Markowitz have been married for nearly fifty years.

City Council opposes United Nations’ resolution denying Jewish ties to Temple Mount

City Council agreed to adopt a resolution opposing the United Nations approval of a proposed motion that denies Jewish historical and religious claims to Temple Mount and the Western Wall, during the Oct. 18 study session.

In 2015, Algeria, Egypt, Lebanon, Morocco, Qatar and Sudan submitted a draft resolution to the United Nations Educational, Scientific and Cultural Organization to claim Temple Mount in Israel is sacred only to Muslims, according to the staff report.

UNESCO approved the draft resolution last Thursday. It has been referred to UNESCO’s executive board for formal approval.

Last November, the City and the State of Israel jointly entered into a declaration. The staff report states “the declaration promotes mutual cooperation, understanding and friendships by encouraging ad hoc task forces, trade delegations and professional exchanges.”

Mayor John Mirisch requested the Council support taking a stance against UNESCO’s decision to support the draft resolution.

“I think we have a special relationship

Beverly Hills Post Office moves to new location within same building on Oct. 31

The Beverly Hills Post Office will open in a new location within the same building at 325 N. Maple Drive on Monday, Oct. 31. A new postal unit has been constructed while the existing unit remained in operation during the past year.

The current retail location will operate until 5:00 p.m. on Friday, Oct. 28. This will also be the cutoff time for Post Office Box customers to retrieve their mail until Monday. Post Office Box mail will be moved into the new boxes and Post Office Box numbers/addresses will not change.

The Beverly Hills Post Office will be closed on Saturday, Oct. 29, and Sunday, Oct. 30, for the relocation.

The Post Office will open Monday in the new location with the same operating hours:

Monday through Friday 9:00 a.m. to 5:00 p.m.; Saturday 9:30 a.m. to 1:00 p.m.; and closed on Sunday.

Post Office Box access will also be the same as before: Monday through Friday 6:00 a.m. to 7:00 p.m.; Saturday 6:00 a.m. to 5:00 p.m.; and closed on Sunday.

The relocation shifts the Post Office entrance further west along Third Street and dedicated postal customer parking will still be available on the property.

This relocation is part of a 2012 Postal Service plan to sell the building, which was larger than needed for postal operations. During the sale of the property, the Postal Service negotiated a long-term agreement to lease a portion of the building to continue public retail operations, Post Office Box service and Business Mail Entry service to serve the needs of residents and small businesses in the area.

The Postal Service does not receive tax dollars to fund its operations and facilities.

BHHS football team to play Santa Monica Friday Night

Beverly High will face Santa Monica, the only team it defeated in 2015, Friday night in an Ocean League football game at Santa Monica College. The opening kickoff is set for 7 p.m.

The teams have one common opponent – Hawthorne. The Normans lost to

Hawthorne, 41-0, Oct. 7 at Nickoll Field, while the Vikings lost 40-28, on Friday.

Beverly Hills lost at El Segundo, 69-0, Friday night, its most one-sided loss since a 75-0 loss to Santa Monica on Oct. 18, 2013 and third consecutive game they were shut out.

The Normans (0-7, 0-2 in league play) played without quarterback Thomas Goolsby in their loss to the Cougars. Goolsby was sidelined by a hip injury sustained in practice, coach Steve Geanakos said.

Junior Jeremiah Klapper got the start in place of Goolsby and "showed us some things ... that he hasn't showed us before," Geanakos said.

"Jeremiah ran the ball well, put his shoulder down, got us some first downs," Geanakos said.

Junior Jonathan Tansey, Beverly Hills' starting center, started at quarterback to begin the second half.

Geanakos said dropped two potential candidates to be the third quarterback who wanted to play the position and had "natural ability," but he described as "not sure if they like football" because they missed

practice.

"If you can't come to practice, you're not going to get better," Geanakos said. "You don't come to practice, you're not learning anything, you don't know what to do. The team doesn't have respect for you to do what you ask them to do as a quarterback."

Geanakos said he watched some players, including Tansey, throwing a football. Tansey's qualities that led him to becoming a quarterback include his size – 5 feet, 11 inches and 175 pounds – are appropriate for the position instead of the customary center and his knowledge of what the offensive line does on every play, Geanakos said.

Normans tight end-linebacker Harrison Van Pelt and running back Sebastian Fanucci drew praise for their play against Hawthorne from Geanakos.

THE MAYOR'S MOM

Wendy Goldberg on her family's legacy in a changing city

You grew up in Beverly Hills. You graduated from Horace Mann and Beverly High. How do you answer when people ask how the City has changed?

I remember Beverly Hills as being a more intimate city. The school system was one of the top in the country. We felt privileged to live here.

I miss the intimacy. I still think it's one of the best places to live, but it used to be a little community. There's a lot of overdevelopment and I'm disappointed. I understand we live in a vibrant city and there's a need to keep up with the times, but that's overstated. Why does more traffic and more towering buildings equate to keeping up with the times?

I'm still reeling from the fact that Metro is putting a subway under the high school, when there are so many other stations they could've used.

I'm unhappy with the education system. I have three grown children and five grandchildren. Two of my children live in Beverly Hills [with their kids]. One [grandson] attends my alma mater, Horace Mann, but the other is going to private school.

Giving more money to the schools when they haven't preformed is senseless. Measure Y is like rewarding bad behavior with more money. I'm all for supporting the schools, and I'm very happy with the new board members Isabel Hacker and Mel Spitz.

The school system used to be a jewel. My children flourished here. Now, it's not the same. The children can't continue the tradition of sending their kids to public schools. But, I think Isabel and Mel will have a great impact [on the school board].

You're the Founder President Emeritus of the California Arts Council. Tell us about that.

I was on the California Arts Council about 34 years ago, and I was one of the founders of the California State Summer School for the Arts. [The school] just celebrated its 30th anniversary. It's truly thriving.

Young people from the ages of about 14 to 19 attend for all different kinds of disciplines in the arts including animation, painting, theater and so much more. Fifty percent of the students receive scholarship.

An incredibly diverse group of students come to [the program] for four weeks to live, eat and breathe the arts. It's held at CalArts, the Walt Disney school.

The arts are not as easy [to raise funds for] as diseases, but I call the arts preventative medicine.

Your husband Leonard Goldberg is a prolific television and movie producer who co-created classics such as Charlie's Angels, Family and Hart to Hart. How do you explain his success in the industry?

He's considered one of the gentlemen of our business, but he wasn't a pushover. He could be very tough. He'd always give you a firm answer and he would never dangle you along.

That's what I think our kids have hopefully learned from him over the years. Our motto was "no free rides." [Our children] knew they had to work hard and be fair to everyone.

I'm too impatient, it's my worst quality, but I can say honestly I've never taken advantage of anyone or cheated anyone out of fairness and I think John has learned that [growing up].

[Leonard] co-created the show "Blue Bloods," with Tom Selleck, [about a New York Police Commissioner.]

I love that show because in every episode there is always a scene where [the characters] share a meal together. It reflects our sensibility and the way we live our lives.

I partnered with Bridget Moynahan on a "Blue Bloods" cookbook, which includes both of our family's recipes.

You and Leonard have been acknowledged for your philanthropic work with a multi-million dollar donation to UCLA, which was the largest of its kind. What made you choose this cause?

Leonard and I started a migraine research program at UCLA. No one really had done anything powerful to try to understand and eliminate migraines. It's a very debilitating disease that millions of people suffer from.

It isn't just woman's issue, which is a common misconception, men have migraines too. They [can be] hereditary. Our program at UCLA is led by Dr. Andrew Charles, who is doing incredible research.

Our daughter, Amanda [Goldberg], has suffered from migraines since she was nine. She has found excellent doctors [to help her deal with her migraines], but I saw what she had to go through. You're only as happy as your unhappiest child.

Your son, John Mirisch, is in his second term as Mayor of Beverly Hills. When he first told you he was running for office eight years ago as a relatively unknown candidate, how did you react?

I said, "Oh John..." [I told him] it's going to be a thankless task.

He grew up here and went to school here and he loves our community. He is so entrenched and so caring about the residents and so devoted to doing the right thing for the residents. He takes that responsibility to heart.

There are a lot of great people here, but they seem to be undermined by "the insiders." There's a group of "insiders" who don't have the best interest of our city in mind. I don't think John is perfect, but he is truly concerned about the welfare and wellbeing of the City and the residents.

He saw what was going on eight years ago and decided he wanted to make change. There are a lot of people who appreciate what he's doing.

When you're on the City Council without a majority, you can't get anything done. I think it's very frustrating and difficult when you have to get a consensus.

Which of John's accomplishments on the Council are you most proud of?

I love the Sunshine Task Force. I am a big proponent of accountability and transparency.

I'm all for protecting the residents, because they're not money machines. My code of ethics is fairness for everyone involved. I want it to be a good deal for them and a good deal for me.

John is trying his hardest to make that happen for Beverly Hills, and I don't think that it happens most of the time.

John has recently been attacked by the Courier for some of his political positions.

How do you react to that?

He's not for the Hilton. He thinks 26 stories is too high and he was not happy with the way it was negotiated because he doesn't think it's fair for the residents.

I know he's sat down with [Hilton owner] Beny Alagem and tried to negotiate a fair, equitable solution for both parties, [but] people aren't always willing to compromise.

[Beverly Hills Courier publisher] Marcia [Hobbs] disagrees with John. That's fine. People should agree to disagree.

Marcia's a friend; I've known her for years. I knew her mother and her father and I like Marcia, but there's no need to attack John.

There were disparaging letters, written under phony names, [published in the Courier]. That's playing dirty.

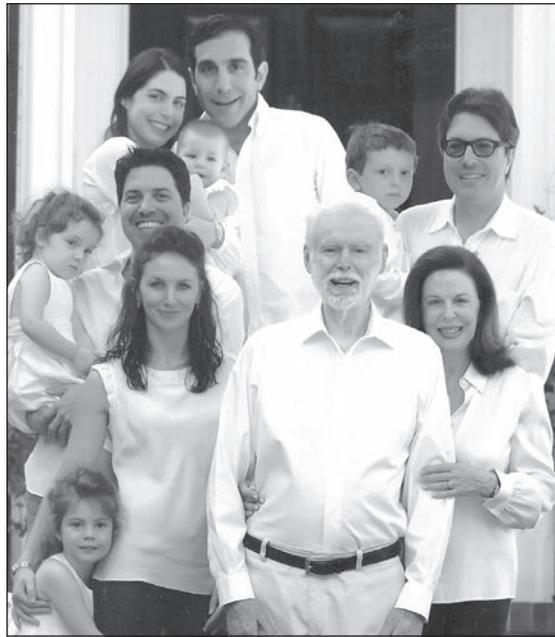
I think it was below the belt the way the Courier went after John. There were a lot of made up stories and they truly said things that were falsehoods.

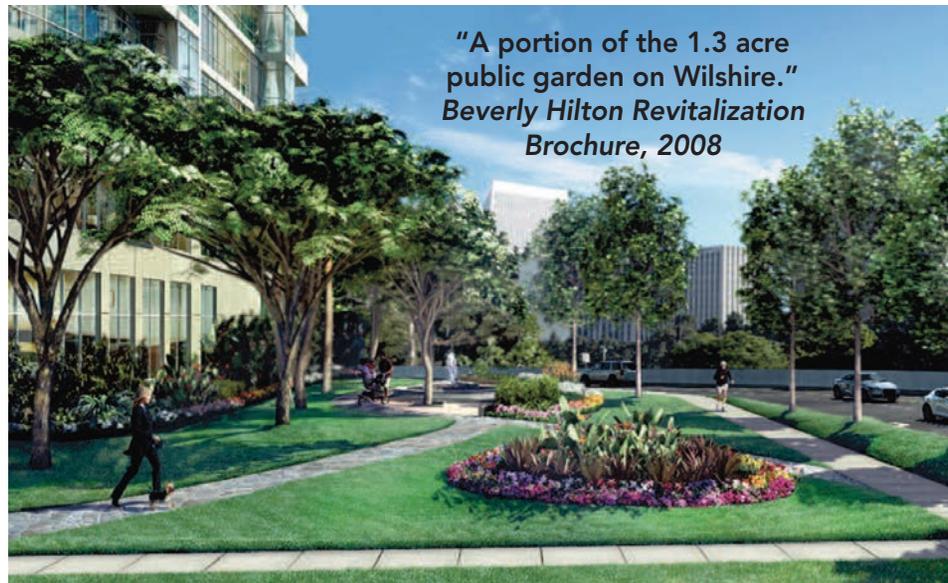
