




I'm voting Yes on Measure Y. Your anti-school paper disgusts me.

The gang who can't fix cracks is coming for your money on Nov. 8. They want another quarter of a billion dollars, on top of the \$334 million dollars we passed eight years ago. That will cost us an estimated \$800 per 2 million dollars of assessed value, on top of the \$2,200 per 2 million of assessed value we're already paying for school construction.

That money can't be used for teacher training or smaller class sizes. It will be used for new buildings and underground parking lots. If Measure Y passes, we'll keep paying these additional taxes for forty years.

Measure Y comes down to this: Do you think the School Board's attention should be focused on new building projects, or on improving education and shoring up the district's precarious financial condition? Even if you favor new building projects, do you want to hand a \$260 million check to three School

Board members who admit they couldn't fix cracks with one third of a billion Measure E dollars?

Board of Education President Howard Goldstein has become the spokesman for the well-funded “Yes” campaign. But Mr. Goldstein is not being straight with the public. In his latest Courier “guest editorial”, he writes, “I stand by my statement that BHUSD is among the best in California and the nation.” How can he say that when BHUSD is third from the bottom in English and math among its peer districts?

Mr. Goldstein wrote: “The 10 former board members focus is strictly on high school achievement as they entirely overlooked our academically acclaimed K-8 sites.” Nice try, but wrong. Our third-from-the-bottom ranking reflects the entire district, K-8s and the high school.

Shouldn't the President of the Board of Education know this basic information? After all, anyone can look it up. The data in the tables accompanying this letter are from the California Department of Education website.

Mr. Goldstein repeats his claim that better buildings produce better educated students. He says this is supported by “research” but he can't cite any specific study. No wonder. Education isn't about expensive classroom walls; it's about what happens inside those walls.

Mr. Goldstein is trying to deceive us. He smears those he disagrees with and makes claims he can't support.

We deserve honest information and our tax

GOLDSTEIN RESPONDS:**

In his editorial, former Board member Herb Young confuses cracks with corrosion. The rusting of reinforcing steel in concrete is a serious structural problem at our schools. When steel corrodes, the resulting rust occupies a greater volume than the steel. This expansion creates stresses in the concrete, which eventually causes cement to crack leading to structural weakening. Rust stains on the surface are an indication that internal corrosion has taken place. By the time corrosion damage is visible, structural integrity is already compromised. The State of California has confirmed that fourteen build-

ings at Hawthorne, El Rodeo, Horace Mann, and Beverly Hills High School are structurally deficient and therefore qualify for State seismic matching funds.

Mr. Young also diminishes the accomplishments of our educators, students, administrators, and the parents who work hard every day to make the BHUSD among the best school districts in California and the nation. State testing placed the BHUSD in the top 1.27% of all school districts in California. The BHUSD ranks 4th out of all Basic Aid school districts in the state.

And yes Mr. Young, modern school facilities do improve student learning. Students who receive instruction in buildings with clean air, good lighting, and quiet learning environments obtain test scores that range from 5 to 17 percent higher than scores for students in substandard buildings. I refer you to the California Department of Education website where you can read for yourself how modern facilities do in fact have a positive outcome on student achievement. <http://www.cde.ca.gov/>

Do you think it would be helpful to Beverly Hills voters to be reminded of the previous bond measure vitals:



NOTICE IS HEREBY GIVEN that the Council of the City of Beverly Hills, at a SPECIAL MEETING to be held on **Monday, November 7, 2016 at 2:30 p.m.**, subject to tentative continuance at the Council's discretion to **Tuesday November 8, 2016 at 1:00 p.m.** and/or **Wednesday, November 9, 2016 at 12:00 p.m.**, or another time as the City Council may determine, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

A request for a Specific Plan Amendment and Development Agreement for the property located at **9900 Wilshire Boulevard** (referred to as the **One Beverly Hills Project**). The 9900 Wilshire Specific Plan was previously approved in 2008 and included 235 residential condominiums and approximately 15,856 square feet of retail and restaurant uses. The proposed project consists of revisions that would allow up to 193 residential condominiums and a luxury hotel with up to 134 rooms and ancillary facilities, ballroom/meeting rooms, and restaurant/bar uses. The proposed project also includes a new motor court access along Santa Monica Boulevard. To allow these changes in use, amendments are required to the 9900 Wilshire Specific Plan. The previously approved project also included adoption of a Development Agreement. Revisions are being proposed to the Development Agreement in conjunction with the proposed project.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City of Beverly Hills has prepared a Final Supplemental Environmental Impact Report (Final SEIR) to analyze potential environmental impacts associated with development of the project. Specifically, the Final SEIR analyzes the following potential environmental effects of the project:

- Greenhouse Gas Emissions
- Land Use Planning
- Transportation/Traffic
- Utilities and Service Systems
- Air Quality
- Noise
- Mandatory Findings of Significance

The City Council will consider the Final SEIR, and may adopt a resolution certifying the Final SEIR, adopting a Mitigation Monitoring and Reporting Program, and adopting a Statement of Overriding Considerations. The City Council will also consider whether to conditionally approve the Specific Plan Amendments and proposed Development Agreement.

At a Special Meeting on October 19, 2016, the Planning Commission of the City of Beverly Hills adopted a resolution recommending that the City Council adopt amendments to the 9900 Wilshire Specific Plan (also known as the One Beverly Hills Project) and associated development agreement between the City and Wanda Beverly Hills Properties, LLC to allow luxury residential condominiums, a luxury boutique hotel, public gardens, and ancillary commercial uses, at 9900 Wilshire Boulevard and made a recommendation to certify the Final SEIR under CEQA.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the Council's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

Tuesday's ballot is unprecedented with the number of initiatives dealing with a variety of subjects, some of which are anything but clear-cut. With the tens of millions of dollars being spent on all the measures, it is sometimes very difficult to know what to believe and how to vote.

In Beverly Hills we have an initiative, Measure HH, the Hilton Condominium Tower Initiative, which has divided the City. The developers who proposed Measure HH are spending millions of dollars, an unheard of amount of money, about \$1,000 per vote, to get your support. Unfortunately, much of the \$5.35 million they have already spent is

on misleading election propaganda.

Elections should be won, not bought.

As the Mayor of Beverly Hills, I urge you to not be fooled by the expensive election propaganda. The Hilton Condominium Tower Initiative is wrong for Beverly Hills for a number of important reasons:

1) Measure HH circumvents the City's development process; it's simply wrong to let developers bypass the environmental, traffic, architectural, and water conservation review process. It is wrong for them not to allow public hearings which every other development project in Beverly Hills needs to go through.

2) A 375-foot skyscraper may be appropriate for Century City or the Wilshire Corridor, but it is wrong for Beverly Hills. This is double the height of the current highest building in Beverly Hills and more than three times higher than the Statue of Liberty. It's just too high for a city with a General Plan that has a 3-story, 45-foot height limit for commercial buildings.

3) The private garden promised by the developer is no more "public" than the hotel's pool is a "public pool." It is private event space which can be closed to the public at the owner's sole discretion. The developer can even choose to allow smoking within the private garden.

4) Circumvention of the City's development process will cost the City tens of millions of dollars. By using the initiative loophole, the developer avoids renegotiating the development agreement with the City; the City would not receive a fair share of the additional value created by the new plan.

5) The project is less-environmentally friendly than what was approved in 2008. In a time when the rest of us are being asked to curtail our water usage, the Hilton is asking to be able to use more water than the 2008 plan.

For all of these reasons and more, please join the Beverly Hills City Council majority and myself in rejecting this cynical, massively funded effort to short-circuit our rules and to put profit over community character.

No developer short-cuts, no subverting our City's process, no 375-foot skyscraper and No on HH, the Hilton Condominium Tower Initiative, is clearly the right choice for Beverly Hills.

Pending City Council approval, the new agreement with Wanda will double the amount of upfront fees by an additional \$30 million dollars; compared to the original agreement approved in 2008.

If the project is approved, the entire development will bring in an estimated \$820 million dollars in total revenue to the City over the next 30 years, which exceeds the previously approved development by \$560 million, according to a press release from the City.

In 2008, the City approved Wanda for the construction of 235 residential condomini-

City announces tentative development agreement with Wanda Group

In a tentative deal announced last Friday, the Wanda Group agreed to increase its fees to the City by more than a half-billion dollars over 30 years to gain approval for the construction of a luxury boutique hotel with 134 rooms.

ums and over 15,000 square feet of commercial space along the north side of Santa Monica Boulevard and Merv Griffin Way.

The amendments approved by a 3-1 vote by the Planning Commission on Oct. 19 reduce the number of condominiums from 235 to 193 to incorporate a hotel.

Throughout the planning process, “One Beverly Hills” has had an ongoing feud with its neighboring development at the Beverly Hilton Hotel.

Contrasted to Wanda, Hilton developer Beny Alagem chose to skip the City’s planning process, for the construction of a new 375 foot residential tower, by going directly to voters with Measure HH, which will appear on Tuesday’s ballot.

An independent report to the Council projects the Hilton’s Waldorf Astoria project would generate 391 million dollars over a 30 year period. The report configured the additional revenue, pending the approval of the new tower, to be approximately 33 million, for a total of 424 million dollars.

“The inability of the City to renegotiate the deal with Hilton means the city will be leaving tens if not hundreds of millions of dollars on the table, as one can see from the magnitude of the ‘One Beverly Hills’ deal,” said Mayor John Mirisch. “Any circumvention of the process means the developer can stiff the City.”

The ad hoc committee comprised of Mirisch and Councilmember Lili Bosse, with assistance from law firm Greenberg, Glusker, negotiated the deal.

Hilton spokesperson Marie Garvey called the City’s announcement “premature.”

“It is completely premature and highly unusual for the City and Wanda to jointly announce and publicize their development agreement,” Garvey said. “This makes it seem to the public that the Wanda project is a done deal before it has even been reviewed or approved by the City Council.”

The terms are still subject to approval by the Council. They will take up the new agreement at their upcoming meetings.

Mirisch, Yaroslavsky face off in radio debate

On Tuesday, Mayor John Mirisch debated former L.A. County Supervisor Zev Yaroslavsky, on KNX 1070 news radio, about Measure M; the half-cent transporta-

tion sales tax proposed by Metro appearing on the Nov. 8 ballot.

Yaroslavsky argued the measure will expand public transit and improve roads. The measure will save people 81 hours a year in traffic, according to Yaroslavsky.

“[This is] an investment in our future, not only our own futures, but those of our kids and our grandkids,” Yaroslavsky said. “It’s time to give motorists an alternative to being stuck in their cars.”

But Mirisch countered that Metro has raised taxes in the past, three times, and ridership has decreased and traffic has not improved.

“Fool me once shame on me, but fool me four times? This clearly is not the solution,” Mirisch said.

He also suggested Metro’s plan is not forward-thinking enough.

“None of this takes into account new, transformative transportation technology, such as autonomous vehicles.”

The Expo Line in Santa Monica has

almost doubled its ridership since opening and is approaching 50,000 riders per day; and the Orange Line in the San Fernando Valley is now over 35,000 riders per day, according to Yaroslavsky.

“People are voting with their feet,” Yaroslavsky said. “This is a system that is going to be expanded to all four corners of L.A. County.”

Mirisch noted the half-cent increase will raise the county’s sales tax to one of the highest in the country.

“This would raise the sales tax in the county to nine and a half percent,” Mirisch said. “That’s among the highest sales tax in the nation. I don’t have a problem spending money on mobility, but this is not the right plan.”

Mirisch is scheduled to appear on the “John and Ken Show” on KFI AM 640, Thursday at 3:00 p.m.


11,211 vote by mail ballots were issued, total as of that date.

fiscal integrity, transparency, and financial stability," Fisher wrote in a statement. "I will continue in that tradition of excellence in the

office that oversees the City's budget and finance."

Fisher is a Beverly High 1969 graduate. He previously served on the Public Works Commission, and is the president of the Beverly Hills Bar Association.

City defers maintenance on La Cienega Park Community Center

The maintenance work on the La Cienega Park Community Center has been postponed, according to a staff report written for the City Council study session on Oct. 18.

As part of the Council's priority setting exercise for 2016 through 2017, it was determined a master plan needed to be developed for the La Cienega Park and Tennis Center site. The staff report stated the plan "requires exploration and coordination of a regional water retention system, parking needs and a plan for the community center."

It will be a few years before the planning process is complete, and interim deferred maintenance measures need to be taken to keep the current La Cienega Community Center functional, according to the report.

The La Cienega Community Center was built in 1981. The report attributed water intrusion from the skylight, which runs along the main corridor of the facility, to interior damage of the building.

Earlier in this year, the skylight was sealed and water tested, but testing demonstrated the roof also needs to be repaired and sealed.

Additionally, the drywall in the building entry needs to be replaced due to the presence of nontoxic mold, which has resulted from the water intrusion, and the roof on the facility needs to be replaced.

Lastly, only 2 of the 9 heat pumps/type A-C units are functional. The staff report noted the community center houses a City run licensed preschool and many programs for seniors, and city staff has received complaints about it becoming uncomfortably warm in the summer heat and difficult to heat in the winter.

The cost to replace the roof, drywall, air conditioning, and to perform the required fire alarm upgrades is estimated to be about \$350,000 to \$375,000, according to the staff report.

Staff is collecting the bids for this deferred maintenance work. A date has not been set for Council approval.

Health & Safety Commission finds challenges with regulating smoking in multi-unit housing

The Health and Safety Commission continued to draft a policy regulating smoking in multi-unit housing, during its meeting on Oct. 24.

The City Council decided to pursue this type of policy at a study session on Aug. 16 and tasked the Commission with the project. On Sept. 26 the Commission was presented with initial information on the framework for the policy.

The City's Municipal Code currently allows landlords to regulate smoking within their buildings, including electronic cigarettes. The new city policy will expand upon state legislation by regulating smoking within multi-unit housing, instead of

leaving it as a choice for the landlords, according to the staff report.

Although the policy is still in its early planning phase, Commissioner Myra Lurie expressed concerns regarding its enforcement. She indicated that she anticipates several issues with the policy's overall practice.

"I still feel ill-equipped to understand the actual enforcement," Lurie said. "How do you prove any of this? How do you possibly prove if someone is smoking? How do people catch this violation, let alone enforce it. I see how complicated and cumbersome the enforcement process could be. There could be enormous exploitation of our resources in terms of code enforcement."

Senior Management Analyst Kevin Kearney gave an informational presentation at the meeting where he outlined similar ordinances passed by several other cities, including Santa Monica, Burbank, Pasadena and Glendale.

Currently, 69 of the 482 incorporated cities throughout Southern California regulate smoking inside multi-family housing, according to Kearney.

"I will say it is very difficult to catch these violations," said Code Enforcement Manager Nestor Otazu. "We do have to observe them first-hand, so in many cases when we receive complaints by the time we get out there; they're long gone."

According to a 2010 report from the Los Angeles County Department of Public Health, approximately eight percent of the City's adult population smokes, which is six percent lower than the Los Angeles County average rate.

A smoke-free multi-unit housing policy in the City could impact up to 63 percent of

Community outreach meetings are scheduled for Nov. 28 and Dec. 13 in the City Hall Municipal Gallery. Free two hour parking is available across the street.

Council provides prospective on North Santa Monica Boulevard Reconstruction project

The City Council provided input and direction on the North Santa Monica Boulevard Reconstruction project, during its meeting on Oct. 18.

City staff requested the Council give feedback on construction sequencing, project scheduling, South Santa Monica Boulevard parking strategies, and neighborhood traffic mitigation "toolbox".

"It's not easy, but when it's done [it will] bring Santa Monica [Boulevard] back up to Beverly Hills standards," said Mayor John Mirisch.

During project design the Ad-Hoc Committee, comprised of Mirisch and Councilmember Julian Gold, evaluated options for lane closure alternatives throughout construction.

The Ad-Hoc Committee recommended "[keeping] four lanes open during construction to the extent possible, but [allowing] a reduction in the number of lanes to two or three lanes to expedite completion of the project as soon as practical," according to the staff report.

With that direction and Council in agreement, the project team developed a phasing plan that divides the construction of the roadway into west and east segments of

similar size.

The estimated duration of construction is approximately 18 months, according to the staff report. Work is expected to begin early in January 2017.

Recreation & Parks Commission seeks more community input on Coldwater Canyon Park

The Recreation and Parks Commission extended the public outreach process, regarding plans to replace the playground equipment at Coldwater Canyon Park, to its meeting on Oct. 25.

To encourage further public input, a total of 425 postcards were mailed to all residences within 2,000 feet of the Park and three banners were placed on site, according to Recreation Services Manager Teri Angel.

One resident, former PTA president Franny Rennie, attended the meeting to speak during public comment. Rennie also spoke at the previous regular meeting on Sept. 27.

Angel received an additional phone call and email from two more residents providing feedback.

"You have to give the residents an opportunity to voice their opinion," said Chair Francis Bilak. "Then, if they choose not to, that's okay. But you have to provide the opportunity. Nothing good gets done unless you have the people voice their opinions. I would love if Council will turn around and allow us to do more extended work, because people were talking about shade structures and benches there's a lot more that can be done at Coldwater We have to continue to engage our community on issues that arise because if we don't than we can't asses their needs."

At the Sept. 27 meeting, the Commission

began the public outreach process. City staff also provided results of a playground survey and March Studios representative Summer Vaughn presented information on the current playground, the surrounding area and improvements for consideration.

The Commissioners agreed city staff should move forward with the planning process.

BHHS football team shut out by Santa Monica

Team to conclude season Friday

Injuries and illness limited Beverly Hills to 23 players in uniform for its 67-0 loss to Lawndale in an Ocean League football game Friday night at Nickoll Field.

The lack of players did not hurt the Normans, coach Steve Geanakos said.

"I think we had more focused players because they knew there wasn't any room for error," Geanakos said after his team suffered its fifth consecutive shutout and sixth of the season.

"The game before (a 43-0 loss to Santa Monica) we had to call a couple time outs because (there) weren't enough players on the field. It wasn't a problem (against Lawndale).

"It probably teaches us something. Maybe with 35 to 40 players ... they just need to pay more attention to what's going on. Sometimes they get

off the field and don't focus on the next phase."

When asked who played well for his team, Geanakos first answered senior defensive lineman Mert Cantasdemir, who is playing football for the first time.

Geanakos then went on to praise junior quarterback Jeremiah Klapper, senior running back-linebacker Alex Dennis, junior running back-defensive back Sebastian Fanucci, senior tight end Patrick Levy and junior defensive lineman Greg Carter.

The loss assured Beverly Hills (0-9, 0-4 in league play) of its fourth consecutive season with one victory or less.

What's Next?

The Normans are set to conclude their season Friday night by playing host

to Culver City (6-3, 3-1) in an Ocean League game beginning at 7 p.m. at Nickoll Field.

The Centaurs use a short-pass oriented spread offense with "skinny, fast kids" that "poses big issues to us because the strength of our defense is more to the interior and the line," Geanakos said.

"Now we have to spread out with them," Geanakos said. "Our speed won't be up to theirs, so we'll have to scheme some things and hope for the best."

Geanakos said his goals for his team are to score touchdowns on offense and defense, get six first downs, have more takeaways than giveaways and no unsportsmanlike conduct personal fouls.

Geanakos said he expects to have about 30 players in uniform.

Junior Thomas Goolsby, who began the season as the Normans starting quarterback, but has missed the past four games because of a hip injury, participated in practice this week without contact, but was listed as questionable for Friday's game. Geanakos said.

Culver City was ranked second in the Southern Section Division 11 poll released Monday.

The Normans are winless in their last 13 games with the Centaurs, a streak that includes two ties. Culver City was

a 41-6 winner last year, scoring the final 34 points in a 15-minute, 34-second span over three quarters.

What's Next?

The Normans are scheduled to conclude their season today by playing Culver City in an Ocean League game beginning at 3 p.m. at the Culver City Municipal Plunge.

City Council on Nov. 1.

L.A. Councilmember David Ryu announced in a statement that the project was reduced by nearly a quarter, capping the height at 178 feet.

Additionally, the density will be reduced, community benefits will be provided to the adjacent neighborhoods, parking and pedestrian access will be increased, traffic improvements will be implemented, and additional workforce housing units will be provided with increased affordability

overall.

“Compromise is never easy, but it’s a core virtue of our city and democracy,” Ryu wrote in a statement. “When I was sworn in last year, I promised to listen and advocate on behalf of every neighborhood in Council District 4. I want my constituents to

know the following: I hear you. And while this compromise isn’t perfect, 8150 Sunset Blvd. is a much better project today.”


