Board of Education elects new president and vice president at organizational meeting

The installation of the 2016-2017 Board of Education officers took place on Tuesday, Dec. 6 at Beverly High.

Vice president Mel Spitz was unanimously voted president. He was sworn in by Superintendent Steve Kessler.

Board member Lisa Korbatov was unanimously named vice president. She was sworn in by Board member Noah Margo. In his speech, Spitz repeated the pledge

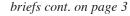
he made one year when campaigning for election to the Board. He pledged to provide leadership to resolve financial and organizational problems, promote transparency and restore confidence within the community. He also promised to deliver results.

'Within the coming weeks we will demonstrate to staff and the community beyond the shadow of a doubt that we must stop deficit spending without delay or the District will become insolvent," Spitz said. "Accordingly, we will reduce expenditures significantly in the upcoming school year. We have no alternative. In making decisions we will select the options that are the least impactful on the educational program. Our deliberations will be in open session,

> and we will encourage staff and parents to attend and provide input."

> At the installation meeting, the Board also adopted the re-stated Mission and Vision Statement. Spitz encouraged residents to go online and familiarize themselves with the statement

"Our re-stated mission is clear and concise. It is to enable each student to achieve academic excellence and meet the goals



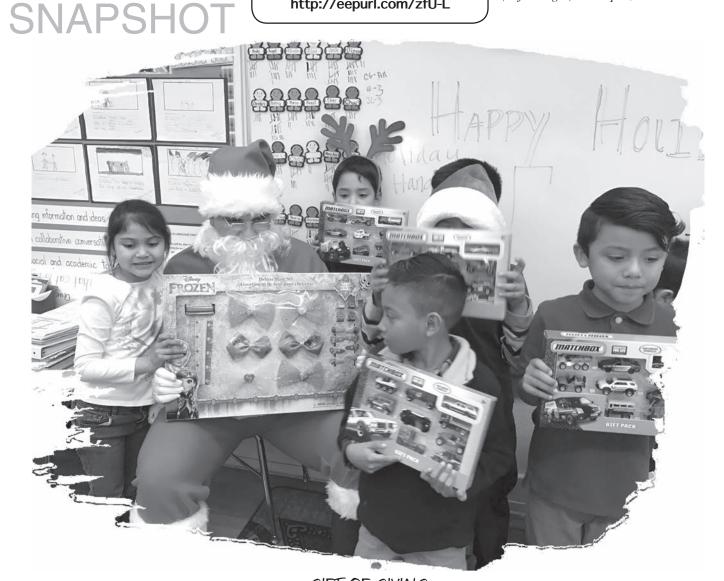

Mayor John Mirisch pulls nomination papers for City Council reelection

Mayor John Mirisch pulled nomination papers on Friday, Dec. 2 with the City Clerk's office for reelection to City Council during the March 7, 2017 race.

As of Monday, Dec. 5, incumbent Vice Mayor Nancy Krasne, City Treasurer Eliot Finkel, Metropolitan Water District Board member Robert Wunderlich, Traffic and Parking Commissioner Lester Friedman and resident Vera Markowitz have all filed nomination papers for the City Council election.

Planning Commissioner Howard Fisher is the only candidate for City Treasurer as of press time.

Candidates preparing to run for Council have until Dec. 9 to pull their papers and return their completed forms and signatures, presuming incumbents Mirisch and Councilmember Kathy Reims submit reelection papers. Reims pledged not to run for Council in March. The deadline will extend to Dec. 14 if she does not pull papers.

Board of Education V i c e President L i s a Korbatov announced

his donation at the Board Installation on Tuesday.

Occhipinti taught history for 35 years at the high school. He retired in 1985.

Toward the end of his career, his curriculum focused on teaching Modern Civilization. His course also hosted the infamous "Culture Vulture."

Mayor John Mirisch had Occhipinti for 10th grade European History and remembers him as one of his favorite teachers.

"Culture Vulture' became legendary at [the high school]," Mirisch said. "It was [an activity] that reminded us history is about much more than just dates and names. I'm blown away by the donation. I think it shows, not only did he make an impression

on his students, but there was a mutual affection. It is one of the qualities that makes our city and our [schools] so special."

City in search of Community Services Assistant Director

The Community Services Assistant Director position is currently vacant. The first round of interviews took place last week, according to Community Services Director Nancy Hunt-Coffey.

The Assistant Director is responsible for planning and managing services provided in the department's four main areas: the Beverly Hills Public Library, Recreation and Parks, Human Services and Administrative Support.

In addition, the Assistant Director will also support the work of the department's Recreation and Parks, Fine Arts and Human Relations Commissions.

The annual salary range for the position is \$148,968 to \$201,552, according to the City's brochure detailing the job description.

In an email to *the Weekly*, Hunt-Coffey also indicted second round interviews are expected to take place during the first part of December.

"I'd love to bring someone onboard in January [2017]," Hunt-Coffey wrote.

City officials continue to tackle challenges of going smoke free in Beverly Hills

The Health and Safety Commission engaged in a more detailed dialogue regarding the legalities behind enforcing a policy regulating smoking for multi unit housing, during the Nov. 28 meeting.

On Oct. 24, the Commission was presented with initial information on the framework for this type of policy. Some of the commissioners expressed concerns regarding the feasibility of its enforcement.

Senior Management Analyst Kevin Kearney returned to the Commission with a report explaining code enforcement may model its regulation after the "Barking Dog Enforcement Program."

"I think this a good framework to gain a better understanding of what code enforcement [might] do once a policy like this goes through," Kearney said.

The "Barking Dog Enforcement" model requires a series of complaints to the City, followed by warnings to the offender, before Code Enforcement officers conduct site inspections and issue citations, according to Kearney's presentation.

Code Enforcement Manager Nestor Otazu explained the citations issued are administrative and have a much lower level "preponderance of evidence than in the criminal remedy."

"It isn't very difficult to hear dogs bark," Otazu said. "Our observations are directly linked to someone's voluntary consent to allow us in. It does become difficult to enforce that way."

Commissioner Myra Lurie anticipates

problems with the policy's overall practice. When researching other municipalities with smoking regulations for multi unit housing, she was unable to find effective examples of enforcement.

"I don't see anywhere there has been any kind of effective enforcement that has [actually] resulted in any kind of citation or a court order," Lurie said. "Perhaps after you go through these multiple steps of complaints, and talking to [the offender] it all works out at some stage, [but] my point is I can't see any evidence that there's been any situations where it's gone to the last step in meaningful numbers considering how much has to go into enacting [this program]."

The financial impacts are currently unknown, as the costs are dependent on the nature of the final policy design, according to the staff report. Enforcement costs will generally be associated with additional staff salaries/ wages by code enforcement and/ or the police, if required by the final policy outcome.

The report also noted depending on quantity of complaints, Code Enforcement may need to hire an additional secretary or a dedicated code enforcement officer.

Directly following the Commission meeting, the community was invited to an outreach session where several members of the public spoke in favor and against regulating smoking for multi unit housing.

Executive Director of Smoke
Free Air for Everyone Esther
Schiller explained to the Commission "there is no constitutional right to smoke."

"The problem for landlords and condominium boards is there is a liability issue if someone gets sick," Schiller said. "The laws that have been passed so far do require landlords to produce a no smoking lease, but not necessarily to enforce the law. It's very helpful if the City will."

City Council has encouraged greater smoking regulations throughout the City. Kearney attended the Council meeting on Tuesday to give a short presentation about the current regulations and an update on the Health and Safety Commission's progress.

The City regulates smoking in accordance to state law. The City has also adopted additional regulations to define where smoking is permitted. The City currently regulates smoking within five feet of open air dining except while actively passing through. Smoking is also regulated in city parks and public and private plazas.

Ron Demeter asked the Council to consider matching the stricter regulations enforced in surrounding cities.

"Right now we have five feet of protection," Demeter said. "From an enforce-

ment standpoint this is something [self enforced]. Nobody calls the police when you see somebody smoking. If you see a no smoking sign you're probably not going to smoke. Our signs currently say five feet. Five feet doesn't provide much protection."

The next public outreach meeting regarding smoking regulations for multi unit housing is scheduled for Dec. 19 in the Council Chambers at City Hall.

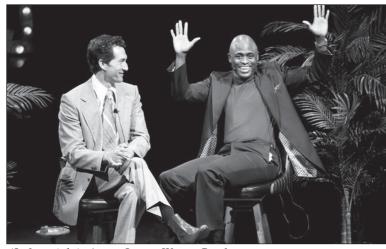

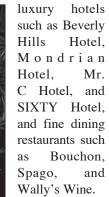

You started as a playground aide at Beverly Vista. Tell us about that.

I was working for the L.A. Unified [School District] services in 1978. The voters had just passed Proposition 13, which basically cut off a lot of the funding that went to the public school systems. The kids on my playground needed equipment, [but] we didn't have

any budget once Proposition passed.

I had to go out and use my own money to purchase equipment [programs during] the summer of '78. I had already been working with kids in the recreation environment for a couple of years prior to coming to Beverly Hills.

I officially started in November of 1978 working at Beverly Vista School. It was a whole different world for me, because now I was given a catalogue and was told to order what I needed for the playground.

Here I was com-

ing from a culture where I had to go spend my own money in order to purchase equipment. Coming to Beverly Hills, I was told to order [anything] I needed to make my programs successful. That was my introduction to Beverly Hills.

It was fantastic. It was a great introduction into the City, working with the youth. I was working with kids, Kindergarten through high school. I worked on Saturdays and a lot of the high school kids would come over and we'd have some great basketball games.

I was able to meet a lot of residents of the City. It was a blast, truly a great time.

I worked for some fantastic teachers in the school district. Russ Hillman was a longtime P.E. teacher at Beverly Vista. I worked closely with him for my first year and a half. He was a great mentor. He had such longevity here with the school district, so I could immediately

> tell what an incredible school system we had.

Who hired you in the department?

Lynn Cohen was the senior recreation supervisor, and she gave me my first job with the City in 1978. I started full time with the City in May of 1980. Two recreation supervisor openings happened and I was fortunate enough to be hired for one of the positions.

Brynan, Cindy who is one of my coworkers, hired at the same time to fill the other position. We were both working for the City prior to getting these full time jobs, but we still had to

compete against other applicants for these full time positions.

What has changed about city government since you first started?

The biggest thing [is] technology. When I started, we had no computers; we had rotary phones. The only time you saw cell phone was on the "Jetsons." There was more of a personable environment because you had to pick up the phone; you had to talk to people face-to-face. You couldn't do it through a machine.

The technological changes have really made the biggest impact. Our outreach is far greater now. We [previously] relied on fliers and newspapers to get the word out. There was no social media.

Who were some of the most influential residents throughout your career?

When established our Recreation and Parks Commission, around 1989 or 1990, I started working closely with residents who were very involved with the community and were volunteering their time as commissioners.

One of our original Recreation and Parks Commissioners John Melnick was the head of senior little league for many

years and a little league coach for over 30 years. I talked to him [the other day] and we still keep in touch.

There's been many Councilmembers over the years, from Linda Briskman to Tom Levyn, that were always involved. Linda and Tom had a major impact on bringing the Farmer's Market to Beverly Hills.

I knew [BHUSD Board member] Noah Margo and [his twin brother] Josh Margo when they were little kids. Their mother, Abbie, worked for us. I've known her for probably 30 of my 38 years [with the City]. They're a very close knit family I still keep in close contact with.

What is your favorite project you have worked on with the Community Services Department?

There have been a lot of great activities and programs we put on [throughout the years]. It's not just been me; it's been my team and my coworkers. We put on great events that we're very fortunate to get the funding for. The community also embraces all the work that we do.

The concert series I helped start at Beverly Canon gardens about seven

> years ago has been the most satisfying for me because of the demographics of the patrons that come. It's multi generational. We have families with two and three year olds that come to every concert. We've got all the seniors who are in the senior housing or live over on Crescent [Drive].

I love doing the concerts every Thursday night during the summer because I see people walking away with smiles on their faces. That's really why I got into this field to begin with. Mel Spitz is sworn in as new Board of Education President Tuesday

You were sworn in on Tuesday. What has changed about the Board since you last served in the 1970s?

There were challenges then. There are challenges now. They're different, but they're equally severe.

For example, while I was on the Board in the 1970's we had three tremendous challenges. The first one was a Serrano-Priest decision of the Supreme Court and that demanded there be equal education for all students everywhere, regardless of where they lived.

That gave us the threat of district busing. The kids that lived in Beverly Hills might be bused for hours to [alternate school districts]. We resolved it by modifying our student population with out of district permits, and we got our student population to the point where we weren't going to be bused.

When I got on the Board in 1971 our district established its own revenue base [from] property taxes. When I was on the Board, there was a new law passed and we couldn't do that. We had to accept whatever the state handed out to the school districts. That meant we were going to have a tremendous reduction in revenue. How we resolved that was we quickly built up a very substantial reserve. Our reserve was 50 percent of our annual budget. That lasted a long time, in terms of keeping the academic

programs f r o m b e i n g cut.

The third one was [when] teachers' unions were initiated. There were no teachers' unions [at that time].

We were able to handle that really through integrity and trust. We established what I would say was a win/ win relationship. Those were three tremendous issues.

Today our issues are just as severe,

but they're different. Right now we have financial instability. We've got organizational instability. We've got academic under performance, in terms of being compared with peer districts. We're still battling with the Metropolitan Transit Authority on tunneling under the high school, which is a big issue. We know that we still have to complete the rebuilding and modernization of all of our schools. Those are our great challenges.

There was a tremendous similarity and that was this: the roles and the responsibilities of the Board of Education and the Superintendent are unchanged.

Some other differences [include] the cost of running a campaign for election to the Beverly Hills Board of Education; then it was about \$4,000. Now, with rare exception, it has to be between \$35,000 and \$40,000, just the cost of campaigning.

Our budget today is about \$66 million annually; then it was under \$25 million. In the '70s, [the] Beverly Hills Unified School District was considered a "lighthouse" school district. It was one of the three premiere districts in the country, in terms of academic performance. Now, if you compare us with peer districts, we are under performing academically. The student enrollment then was about 6,000; today it's about 4,000.

[Community support] is unchanged;

we have a supportive community. However, some of the interestdifferences are in those days the League Women voters was a force within the City. I would say if wanted to get elected

to the Board of Education, you had pass muster with the League of Women Voters. That's an interesting difference.

The Municipal League was more influential then because there were no other neighborhood homeowner groups.

It was a citywide force.

In the '70s there was an unwritten rule, Board of Education members did not endorse city councilmen and vice versa. City councilmen did not endorse board members. That rule is gone now. The endorsements flow.

Tell us about your priorities this term

These are my expectations for this coming year, and they're not in any particular order of importance. I expect that we will achieve financial stability. We will strengthen the districts academic programs, and actually we're really getting started on that in math. We're just taking the initial steps now; that's why I expect there to be some achievement in the coming year.

We've set a course whereby our present K-5 math curriculum is going to be replaced by a more rigorous curriculum. We've set a protocol on how the new curriculum is going to be selected.

We will implement a program to provide technology equally throughout the district. I expect that we will settle the [Metro] tunneling issue. I expect

that we will schedule completion of the modernization of our schools in a time frame similar to what would've been possible with Measure Y funding. I expect that we will improve communication and liaison with the [Citizens Oversight Committee].

During the 2016 election, you were unwavering in your stance against the three Board members in favor

of Measure Y. The community rejected measure Y and an op-ed from 10 former Board members expressed skepticism in the district's construction plans. How do you think the district should proceed?

A big majority of the community voted for it, but you also have to know that there was a very aggressive and expensive campaign in favor of it. I don't know if a dollar was spent in opposition. I had made a statement as to why I couldn't support it. Then there was one statement made by 10 former board members, but that was it.

Measure Y was intended to fund construction at three schools: Beverly High, El Rodeo, and Hawthorne. There's currently major construction going on at Beverly High. That construction is not scheduled to be complete until mid 2020. The construction at El Rodeo is going to be completed in mid 2018. The idea [behind] Measure Y was [to] pass it

so we can get going right away with the rest of the construction because [costs] are going to go up.

But the point is this: you couldn't start anymore construction at Beverly High until the current construction is completed. [It is] the same at El Rodeo. The thought of having two separate construction projects at one school site, simultaneously, with different contractors where each one would need its own staging areas and its own ingress and egress, its own blocking of the existing facilities, would've been impossible.

With Hawthorne, we haven't even started architectural and detailed drawings. So it's going to be sometime before anything could be started there regardless. The point is the timing was all wrong. In addition to that, I can't go into any details because it's a closed session issue, but we need to improve the management of construction. We're in the process of working that out. My position is we should have a bond issue in 2018. The timing will be right and we can move forward and there won't be any delay in getting the work done.

Do you have any concerns about serving as Board President with a new Superintendent?

None at all. From my experience I know this, the Superintendent is the CEO. [A Superintendent] is the manager [and] runs the operation. The Board's role is to set policy and to evaluate the Superintendent's performance.

What you need

from the Superintendent is leadership. As a result, there should be stability. The Board president has no more power than any other board member. But, the Board president works with the Superintendent in setting the meeting agendas and has a responsibility of communicating on behalf of the Board. [I have] to show a certain amount of leadership in this role. I'm looking forward to it.

The Board is often criticized for spending millions on legal fees on unsuccessful lawsuits. What's your plan for curbing these expenditures?

First of all, the major lawsuit that we have which is outstanding is the Christiansen lawsuit. There is a judgment against the district which now, with interest and penalties, is in excess of [about] \$22 million.

The district is appealing [it]. We don't

know what the outcome will be. Our attorney has told us he expects it to be overturned. On the other hand, it's quite possible that a portion of it might still be upheld by the appeals court. That is a potential problem for us.

We should be looking at our reserves, maintaining our reserves and even increasing them so we can be prepared for any event on that issue. However, school boards have a right to setup a 10 year payout so [we should be able to handle it], unless the whole thing is upheld.

As far as other legal expenses, some of them are unavoidable. The district probably faces at least one lawsuit a week from parents of children who are in our special education department. It's almost a regular practice. The law is if a student requires services that [the district] is unable to fulfill, then the district has the responsibility of providing those services through some external staffing. Sometimes the parents will initiate a lawsuit just to see that it's carried through. Those lawsuits are normally worked out and the total cost to the district might be as little as \$5,000 or it may be as much as \$30,000. Those are kind of run of the

Other lawsuits that the district has had in the past, we should be able to cut back on and reduce just through better management and stability. Some of those lawsuits have been by former employees, and we shouldn't have that. If we operate correctly we shouldn't have lawsuits by former employees.

Another major area of legal fees is fighting [Metro] on the tunneling. Those expenses have not come out of our General Fund, they've come out of the Measure E money that we have because it actually has to do with how we're going to be able to rebuild the school. I am very hopeful that we'll be able to resolve that issue this coming year. Looking ahead, I know that all the board members want to get a handle on this cut down on the legal fees.

How do you respond to people who have expressed concerns over the Board's use of its authority?

There is a perception in the community that the Board is micromanaging or has micromanaged. That has been a problem in the past. I can tell you that since I got on the Board, it's been one year; the Board has not been micromanaging. There's a perception of it. I think that it will become clear that we're on a good track. I feel from the very beginning of the next calendar year it will be pretty evident that we are on the right track.

pursuant to Public Contract Code section 20111.6, it shall be mandatory that all General Contractors, Mechanical, Plumbing, and Electrical Subcontractors seeking to participate in the bidding on the District's Beverly Hills High School Modernization of Buildings B1 and B2 ("Project") be prequalified. General Contractors are required to have a CA License "B" (General Contractor) and mechanical, electrical, and plumbing subcontractors shall have CA Licenses "C-4, C-7, C-10, C-16, C-20, C-34, C36, C-38, C-42, C-43, and C-46" to participate in the bidding on the Project.

Subcontractors must be also be prequalified and can submit prequalification packages at this time or with the bid documents.

Project Description

The project is a modernization and seismic upgrade of a 1928 masonry building that was upgraded in 1936 by a gunite seismic upgrade. This project changes the use of the B1 & B2 Buildings to new and upgraded classrooms, dance studio, media center, café, library, administration and support function staff spaces. It consists of approximately 50,000 square feet in one story, two story and three story portions of the building. The majority of the demolition and all of the known abatement has been done in a previous or current phase of the work. A contractor may appeal the District's decision with respect to its request for prequalification, by giving notice to the District no later than five (5) business days after receipt of notice of its qualification status. Notice shall be sent to the address listed above, requesting a hearing and setting forth in general terms the basis of the appeal.

The District's Superintendent or his/her designee will convene an appeals panel for the hearing as necessary, and will conduct a hearing on the appeal no later than 5 business days following the Contractor's delivery of the written notice of appeal. The hearing conducted by the District will be informal and is not an evidentiary hearing. At the hearing, the Contractor will be given the opportunity to present information and reasons in opposition to the District's determination. The appeals panel will consider all evidence, information and arguments submitted by the Contractor relevant to the District's determination, the District's response to such evidence, information and arguments, and any other information the Director deems relevant.

Within five (5) business days following the hearing, the District Superintendent or their designee, will provide a written decision whether the Contractor is qualified or not qualified. The written decision is the final determination of the issue, and the Contractor shall have no further administrative appeals.

The procedure and time limits set forth above are mandatory and the Contractor's sole and exclusive remedy in the event of protest. Failure to comply with these procedures shall constitute a waiver of any right to further pursue the protest, including filing a Government Code claim or legal proceedings. Unless a contractor files a timely appeal, the contractor waives any and all rights to challenge the qualification decision of the District, whether by administrative process, judicial process or any other legal process or proceeding. The District reserves the right to resolve appeals before or after bid opening or award of any contract. Bidding

Bids will not be accepted from any contractor that did not submit in a timely manner, a completed prequalification questionnaire and supporting documents, including financial statements, to the District.
