




"Legal fees exceed \$1.1 million in second half of 2016" [Issue #898]

Notwithstanding the promises during the campaign to stop the litigation against Metro and the fact that 70 percent of the voters supported Measure M to fund Metro's expansion to Beverly Hills and beyond, I was shocked to learn that the School District recently filed yet another lawsuit against Metro seeking a preliminary injunction to hold up the entire Metro construction process. The court has once again (at least in its tentative ruling) rightfully denied this request. Now the Board is planning to spend more money appealing this decision. At the same time, the School Board is looking for ways to make up its anticipated \$5 million dollar deficit and is even considering closing Hawthorne School.

It should be readily apparent to everyone that the Board should stop throwing away hundreds of thousands of dollars in legal fees and focus its efforts where they should be, on your children's education.

The article in [last week's] issue of Beverly Hills Weekly regarding the future of Hawthorne School concludes with the statement that "The Board has gone into deficit spending for a number of reasons." One of the reasons included is "high teacher salaries." On behalf of the Beverly Hills Education Association, I strongly disagree with this assessment. Evidence from the California State Department of Education support our position.

If you take a look at the Form J90 released by the State Department of Education, you will see that within Los Angeles County, we are nowhere near the top in terms of highest teacher salary or average teacher salary. We are 28th out of 74 school districts in terms of highest paid salary. We are 72nd out of 74 in terms of average teacher salary. If we had the 28th highest test scores in the county, would you write that we were among the best schools in terms of test scores? Of course not. Keep in mind that providing this information to the state by districts is voluntary so our actual ranking might be even lower.

This also does not take into account our employees' health and welfare benefits. We receive \$8500 a year after fighting hard to gain a \$1500 increase in the last few years. Despite this gain, someone with a family of four such as myself still has to pay over \$1000 a month out of pocket to provide



insurance for myself, my wife, and my two daughters. Neighboring districts such as Hawthorne pay less than \$50 a month out of pocket no matter how big their family is. LAUSD and Culver City educators receive over \$10000 a year in health and welfare benefits. In Los Angeles County, we rank near the bottom in this area. How is it possible that Beverly Hills Unified can claim to have trouble paying its educators but nearby districts have not? In short, our educators do not have the impact on our district's budget as some would have you believe.

For these reasons and more, we strongly disagree that there is a financial problem in the district and more importantly, we believe that reducing staff salaries and laying off educators is not the remedy to any financial situation the district might be in. Certainly, educator salaries are not the cause of any problem the district may have. BHEA has always been willing to work with the district to develop long-term well-thought-out plans that minimize the impact felt by our schools, our staff, and our students. We remain so now.

#### "Adult soccer players struggle to find field space in the City" [Issue #902]

To follow up on our presentation to the City Council at the Dec. 20 meeting, our adult men's soccer team still does not have a local playing venue. Our issue is unresolved. If you recall, my husband, Pinhas Rahav, plays on a soccer team in Beverly Hills with 23 other 40 to 60 year old men. They meet every Sunday almost without fail usually at Hawthorne Elementary here in Beverly Hills. Over the years, they have played at El Rodeo and Beverly High as well. The team began as fathers and sons playing together on the weekends and developed into a more formal team. Sons still join the team when they are back from college. Most of the kids had played on the Beverly Hills AYSO team.

For more than 10 years the team has played together and is diligently organized with veekly Evites to verify what team members will attend the Sunday games. The men have uniforms and all of their own equipment. Team leader Hertsel Botteh manages the information sharing and organization tasks. I have always been impressed by the level of commitment from the team. All of the team members are residents of Beverly Hills and most own property in Beverly Hills, including myself. They are professionals and hard working taxpayers-successful doctors, lawyers, real estate investors, etc. They are also inclusive. The team has members from all backgrounds and nationalities and are wonderful example of the diversity of our City.

They have always been respectful the locations where they play. The team always plays from 7am until 9am and they are very careful to respect other events at the site. They clean up and leave promptly when they finish.

About a month ago, the team was told by police that they would be unable to use the school as a venue due to policy changes from the City. Further, Beverly Hills parks-as you know- have militant rules regarding park usage. So, they are unable to use the Beverly Hills public parks for their games. I went to the Recreation and Parks office and I have spoken with Teri Angel, Recreation Service Manager. I found out that the schools will no longer allow adult teams to play on their campuses. The City said that they were organizing an adult soccer team and that would be the only option for adults wanting to play soccer in Beverly Hills. All of the parks are very protective of their turf and they never allow groups to play on it for fear that it will be damaged. I am frustrated that the City has put such restrictions around how the parks are used.

Basketball and tennis courts are available for use at Beverly Hills parks but no public soccer fields. WHY??

This team wants to continue to play. They love it. I love that it is a positive outlet for all

#### Board of Education expected to vote Tuesday on extending their terms

The Board of Education is expected to vote on a resolution drafted in response to a new state law which could have significant influence over future city elections, during its next meeting on Jan. 24.

Senate Bill 415, signed by Governor Jerry Brown during the fall of 2015, applies to cities, counties and school districts that have a regular election date that is different from the statewide primary or general election.

The Planning Commission of the City of Beverly Hills, at its regular meeting on Thursday, January 26, 2017, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

#### AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING TEMPORARY BUSINESS SIGNAGE DURING SUBWAY CONSTRUCTION

The proposed Ordinance would add § 10-4-615 to the Beverly Hills Municipal Code in order to allow certain businesses along Wilshire Boulevard to request additional temporary signage during the construction of the Westside Purple Line Extension project. A business that is entitled to business identification signage under the existing code may request additional signage if the construction obstructs the visibility of a substantial portion of the property or building entrance where the business is located. The Ordinance references design guidelines for signage approved pursuant to the new code section. These design guidelines will also be considered by the Planning Commission at this hearing. The guidelines will establish the size and location of signs allowed pursuant to the new zoning code. Both the Ordinance and design guidelines will require City Council approval at a future date.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance is eligible for a class 5 categorical exemption for minor changes in land use limitations and will not have a significant environmental impact. This Ordinance is exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

Public agencies with "off schedule" regular elections must change their date to either the statewide primary or general election date in June and November of even-numbered years, if the agency's voter turnout for its current election date is at least 25 percent lower than its average turnout for the last four statewide general elections.

The law "[aims] to increase voter participation across California" and will take effect on Jan. 1, 2018. SB 415 also requires city municipalities to adopt a plan prior to Jan. 1, 2018, and implement the plan prior to Nov. 8, 2022.

In order to comply with the new senate bill, the Board will be required to consolidate their elections to coincide with statewide election. By doing so, the Board members' terms could be potentially extended or shortened.

Last October, the San Marino Board of Education approved a resolution that changed the election cycle for board members from odd years to even years. As a result, the board added one year to each of their terms.

The Las Virgenes Unified School District also adopted a resolution to comply with SB 415 and board members' terms will extend by one year, meaning board members with terms expiring in 2017 will expire in 2018 and those with terms expiring in 2019 will expire in 2020.

Not all jurisdictions have extended their terms.

The West Hollywood City Council voted last August to move its municipal election date to coincide with state and national elections. The candidates elected to the West Hollywood City Council on March 7, 2017 will have their terms reduced by four months.

If the Board votes to extend their terms, Vice President Lisa Korbatov is expected to be the next Board president in 2018. Normally, Korbatov's term would have been up in November.

This item was scheduled to appear on the Jan. 10 BHUSD agenda, amidst a contentious number of speakers regarding the future of Hawthorne School, and was tabled for the Jan. 24 meeting.

Commissioner Rich Waldow was required to recuse himself from the vote because he owns real property within 500 feet of the building.

The Mills Act is a state law that enables local governments to enter into contracts with owners of qualified historic properties to provide property tax abatement in exchange for the continued preservation, restoration, maintenance or rehabilitation of an identified historic property.

In exchange for annual property tax reduction, the owner agrees to fully restore, protect, and maintain the historic property. Specifically, the applicant has agreed to use Mills Act contract savings on an annual basis to complete numerous restoration projects valued in excess of \$609,000, according to the staff report.

A Mills Act contract carries a 10-year term initially, with automatic yearly extensions, and runs with the title of the property when transferred.

The staff report also noted that execution of this Mills Act contract would result

in reduced property tax revenue to the City of approximately \$3,000 per year and to the BHUSD of approximately \$2,800 annually.

The City's pilot Mills Act program caps the total property tax losses

to the City at a maximum of \$100,000 per year.

The current annual property taxes for this property are approximately \$36,000 which would be reduced under the Mills Act Program to approximately \$18,329.

Under a Mills Act contract, the estimated annual property taxes would be reduced over the period of the contract. The actual yearly revenue loss is subject to annual review and determined by the County Tax Assessor once the contract has been executed and recorded with the County.

"This applicant has worked with staff for almost a year now," said the City's Urban Designer Mark Odell. "We are so proud of the work they've done so far. Originally, they planned to change the building into a more contemporary interpretation of a midcentury building."

Constructed in 1956, the two-story structure was architect Jules G. Salkin's second apartment endeavor. The building was nominated for landmark designation by the Commission in July 2016.

During the nomination hearing, the Commissioners briefly touched upon Salkin's checkered past. In 1968, he was indicted for defrauding the U.S. Small Business Administration of \$445,000, and later for tax evasion.

To date, the City has entered into a total of three other Mills Act contracts with the property owners of the historic properties, including Fox Wilshire-Saban Theater at 8440 Wilshire Blvd., Wallis Annenberg Center for the Performing Arts at 9390 North Santa Monica Blvd., and Joe E. Brown Residence at 707 Walden Dr.

On Dec. 20, the City Council approved a three year extension on the pilot Mills Act program. City staff is expected to bring the Commission's recommendation before Council for approval.

#### Municipal League and Southwest HOA to host candidate forums in City Council Chamber

The City Council approved a request from the Municipal League of Beverly Hills and the Southwest Beverly Hills Homeowners Association to use the Council Chamber to host City Council candidate forums.

The Municipal League will host its forum on Wednesday, Feb. 8 from 7:00 p.m. to 9:00 p.m. The Southwest Beverly Hills HOA's forum will take place on Wednesday, Feb. 15 from 7:00 p.m. to 10:00 p.m.

Both candidate forums will be livestreamed and rebroadcasted on local Beverly Hills Television, BHTV 10.

Sample ballots are expected to be sent out during the last week of January and the vote by mail ballots are expected to be mailed out on Feb. 6, according to City Clerk Byron Pope.

#### Planning Commission requests changes before approval of 472 South Spalding permit

The Planning Commission denied a permit request at 472 South Spalding Dr. for additions to an existing accessory structure and the conversion of the second story of an accessory structure into an accessory dwelling unit, during its meeting on Jan. 12.

The Commissioners requested the applicants make changes to the project proposal and return at the first meeting of February.

The proposal included a 60 square foot addition to the first story of the accessory structure, a 151 square foot addition to the second story of the accessory structure and a request

meeting on Dec. 8, the Commission adopted an ordinance modifying the City's regulations regarding accessory dwelling units.

California enacted Assembly Bill 2299 and Senate Bill 1069, which limit the ability of cities to regulate accessory dwelling units, according to the Dec. 8 staff report.

The law changes the terminology from "second units" to "accessory dwelling units,"

which are defined as units containing independent living facilities on a property such as a kitchen, bathroom, living room, and usually a bedroom.

The ordinance approved by the Commission changes the Municipal Code to bring city regulations into compliance with the new state legislation.

The proposed project has been reviewed for compliance with these modified regulations, according to the Jan. 12 staff report.

Attorney Mitchell Dawson, representing



property owner Israel Lasry, quoted SB 1069 "Allowing accessory dwelling units in single family or multi-family residential zones provides addi-

housing stock and these units are an essential component of housing supply in California."

Conditions of approval set by the Commissioners included additional landscaping, increased setback of the deck from the neighbor's property line, and time limit set should the property owner decide to rent out the accessory dwelling unit.

"The previous ordinance, also under state law, required allowance for rental of second units, so that continues on," said Assistant City Attorney David Snow. "There is a new limitation that's allowed, under state law, for limiting the time of those so that they don't turn into the short term 'Airbnb.' We have also, in the new ordinance, continued the existing regulations that the City had adopted to limit those. Those protections are in place with respect to the rent stabilization."

The project applicants are expected to return before the Commission on Feb. 9.

#### **City Council will consider** using General Fund monies toward water fund

Chief Financial Officer Don Rhoads attended the Public Works Commission meeting on Jan. 12 to discuss the possibility of using

money from the General Fund toward water rates. About a year

in January 2016, city staff recommended that the Council water

ago modify *Don Rhoads* 

rates in order to cover costs resulting from increased water conservation and the Water Enterprise Plan.

The Council directed staff to conduct a prior study of the water fund operations and finances to find any cost savings or efficiencies before rates were considered.

Matrix, a consulting firm, was hired to study the water fund and made many recommendations but found that, overall, financial savings would still be relatively small.

At a liaison meeting on Jan. 3, between the Commission and the City Council, it was asked if it would be possible to consider General Fund contributions during the next conversation about water rate scenarios.

The liaison committee agreed to consider funding from the General Fund with two conditions, including it must be a one-time only suggestion and it will only be used for capital expenditures.

Rhoads also noted that contributions from

#### BHUSD legal fees exceed \$400,000 before the close of 2016\*

Beverly Hills Weekly assembled legal fees from the Jan. 10 Board of Education warrant report and found that the Board of Education has spent over \$400,000 since the fees were last reported on Dec. 15, 2016.

Attorney Fred Fenster from Greenberg Glusker represents the district in the litigation involving former BHUSD Facilities Director Karen Christiansen. The total judgment against the district exceeds \$20 million.

As of October 2014, Horvitz & Levy represented the district in the CEQA appeal involving Metro's proposed Purple Line extension project, which the district lost. Kasowitz, Benson, Torres is also retained for the district's suit against Metro.

the General Fund could be made in many forms. One possibility is that it could come as a gift from the La Cienega property.

The City is in escrow for a property on La Cienega Boulevard at Chariton Street in Los Angeles, intended to be used for at least one of the three wells proposed in the WEP, according to the staff report. Water quality testing is underway to ensure that the property will be viable for groundwater development.

Large General Fund subsidies may be viewed negatively by bond investors and rating agencies, according to Rhoads' presentation. Rhoads explained that this is a caveat that should be noted whenever there is talk of using General Fund money for enterprise operations.

"It could have an effect on our bond rating," Rhoads said. "It could drop us from our 'AAA' rating. The water fund is a utility that has a high rating because of its [strong reserves] and history of setting rates where they need to be to pay for the fund. [I would] work very hard to make sure that it didn't drop, even if there were general fund contributions, I would not roll over on that fight."

Rhoads suggested this is alternate option the Council could consider.

"This is unique," Rhoads said. "It's a [new] plan to increase our water sustainability, our ability to produce and treat our own water so that's why there's a major infusion of cash from the General Fund right now."



#### City Council may need to issue permits before construction of Purple Line Extension

As Metro prepares to begin the construction of Section two of the Westside Purple Line Extension project, the City Council will be required to decide how it will go about approving the impending work.

According to the Jan. 10 staff report, the City has currently not entered into negotiations with Metro on a Memorandum of Agreement for Section two, so there is not means to approve the upcoming work unless it is granted through the City's permitting process.

Metro has submitted to the City design documents and Work Traffic Control Plans for the relocation of third party utilities, including Southern California Edison, Southern California Gas and AT&T, on and adjacent to Wilshire Boulevard between Beverly and Crescent Drives.

The relocation of third party utilities is the first phase of work to occur in the sequence of work. The third party utility relocation work is anticipated to start in early 2017 and is estimated to take approximately 18 months to complete.

Although the item was not discussed at the Jan. 10 study session, a two-step approach was recommended in the staff report, which included issuing individual work permits for each third party utility relocation and then commencing negotiations of a MOA for Section two to govern all work performed by Metro.

Section two of the Westside Purple Line Extension project extends west of the La Cienega Station a little more than two and a half miles and it includes the stations at Wilshire/Rodeo and Century City/ Constellation.

The Council would issue individual permits to Metro for each third party utility owner through the City's permitting process. The scope of work would include the use of the public right-of-way for temporary traffic controls; trenching/excavation; installation of conduit and vaults for electrical and telecommunication; installation of gas pipes and appurtenances; backfill and pavement restoration.

The Wilshire/Rodeo station is located underneath Wilshire Boulevard starting at Beverly Drive and extends approximately 1,000 feet to just east of South Canon Drive. Metro has purchased the Ace Gallery site at 9430 Wilshire Blvd., southwest corner of Wilshire Boulevard and Reeves Drive, as the future Wilshire/Rodeo Station entrance.

#### **Beverly Hills applies to be** test site for autonomous vehicles

Beverly Hills has applied to the U.S. Department of Transportation to become a test site for autono-

mous vehicles. In its application, the City laid out a case based on readiness, support from the City Council, the City's unique and varied driving environment and commitment to safety.

"Beverly Hills should be a policy leader in this emerging technology," said Mayor John Mirisch. "As an employment center and tourist destination, Beverly Hills has more than its share of regional traffic; and many traffic, safety and parking problems can be solved with AVs, especially when used as a form of public transportation. Perhaps most importantly, autonomous vehicles have the potential to democratize public transportation by creating an efficient. first-choice system of mobility that Southern Californians use because they want

to, not because they have to."

If selected, the City would need to get a permit from the California Department of Motor Vehicles, which has not yet approved the use of AV's on public streets. Then Beverly Hills would need to set up a testing area and work with companies developing AV technology to bring in the "smartest" and safest vehicles.

The City is proposing a Municipal Autonomous Shuttle System (MASS), to address "first and last mile" challenges and encourage the use of regional public transportation, as well as to provide on-demand, point-to-point mobility citywide. The City is also installing fiber optic cable, which will greatly enable AV communications as well as bring high-speed access to every business and resident in the City.



### **Sue Himmelrich** Newly elected Executive Board member of AD 50

Santa Monica City Councilmember Sue Himmelrich was elected to the Executive Board of the 50th Assembly District, which represents Beverly Hills, during the Assembly District Election Meeting on Jan. 8. Eight of the 14 winning candidates came from the Grassroots slate and the remaining six were from the rival *Progressive slate, splitting the delegate* seats almost in half.

#### Why did you decide to run for delegate of the 50th Assembly District on the **Progressive slate?**

My first political campaign was in 1970 for a democrat in Maryland, who had been a friend of Bobby Kennedy, and ran on a gun control platform after the Ambassador Hotel shooting [in 1968]. I was 17 years old.

It was a very hard fought campaign, but we lost. Since then, I've been sort of a worker bee in Democratic politics. The first time I ever ran for office, of any kind, was in 2014 when I ran for Santa Monica City Council. When I say I never ran for

office, I mean I didn't even run for class secretary in high school. I literally didn't run for office.

I was an appointed delegate of [State Senator] Ben Allen for the last two years in the state party. The woman who had been the head of the Progressive slate, who also worked on my campaign for city council, had been the E-board representative and is now a representative to the [Democratic National Committee]. Those are two positions you don't hold at the same time, so there was an opening.

There were other people who I would have preferred to do it, but they didn't want to so that left me. I did agree to do

either, but I think no one expected the kind of fervor around this [Assembly District Election Meeting] as happened after November 8.

I ran because I believe the Democratic Party needs a different kind of direction then the one it had during the last election.

#### You were also elected the Executive Board member by five votes. Tell us about your role in this position.

[The Executive Board makes the final decision on almost everything, as I understand the bylaws.]

I hope to be collaborative and to not simply make up my mind about what I think is right, but actually do it from the bottom up. I was a Bernie Sanders supporter. I believe in his message of no more top down politics. I think there

are too many Super Delegates.

I hope to not just represent my own views [and not only] the views of the 13 other members who were elected, but also the people in the district. I do that as a city councilmember, I talk to everybody, and I plan to continue to do it.

#### Do you see any major differences between the opposing slates?

In other districts there was also a Nurses' slate that did very well other places, and they were present at our election but they didn't have enough members to get traction

I [do] think that there were two slates. There was some distinction that a lot of people [thought] our slate had been Bernie people, but there were also Bernie people on their slate, so I don't think that was the only distinction. I think that there were people who felt the Progressive slate was too old or too entrenched. Although most

a few people who had been elected before, Democratic politics. but not very many.

Marcy Winograd, also an elected delegate from your Progressive slate, is an opponent of Israel according to the Atlantic and several other publications. She has gone on record saying she "[does] not want [her] name or country associated with occupation or extermination." Do you agree with, or renounce, this position?

I think that that's a fairly un-nuanced view of what she believes. My understanding is that Marcy was opposed to the [Anti Boycott, Divestment and Sanctions] bill that was put forward in the state legislature and ultimately passed in a very watered down form. I'm a Jew. I've been on several missions to Israel, I support the Federation and I believe that Israel has the right to exist. I don't believe in a one state solution. I believe in a two state

Why has Santa **Monica historically** played such a large

solution.

role in the Democratic Party?

We, right now, have a state senator and an assembly person who live in Santa Monica. Ben Allen is the 26th Senate District representative and Richard Bloom is the 50th Assembly District representative.

Beverly Hills had a higher percentage of Trump voters than Santa Monica. About 70 percent of the registered voters in Santa Monica are registered Democrats. I think that Santa Monica, traditionally, has been a more Democratic leaning city maybe than Beverly Hills. That [is] pure speculation on my part because I don't know what the number of Democrats in Beverly Hills is

Santa Monica is the center of the district, but then I look at our Congressperson Ted Lieu, and he's from Torrance. I

#### What do you hope to accomplish as an incoming delegate of AD 50?

I would like to see [the ADEM election] become an easier process. There is no reason people should have to stand in line for two hours. Whether it is electronic elections where people can vote from their computers or their phones, [or some other form], I think it should be easier to vote.



AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO PROHIBIT SMOKING IN BEVERLY CANON GARDENS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The city council hereby re-numbers Section 5-4-16 (PENALTIES AND ENFORCEMENT) to be Section 5-4-17 (PENALTIES AND ENFORCEMENT) and adds a new Section 5-4-16 (PROHIBITION OF SMOKING IN CITY PARKS AND BEVERLY CANON GARDENS) to the Beverly Hills Municipal Code to read as follows:

5-4-16: PROHIBITION OF SMOKING IN CITY PARKS AND BEVERLY CANON GARDENS:

Smoking is prohibited in all City parks as designated in Section 8-1-101 of this code and in the Beverly Canon Gardens located at 241 N. Canon Drive in the City of Beverly Hills.

ORDINANCE NO. 17-O-2722

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE COMMERCIAL REGARDING OR PROFESSIONAL INSTRUCTION IN **CITY PARKS** 

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby adds Article 1 ("General Parks and Recreational Facilities Provisions") to Chapter 1 ("PARKS AND RECREATIONAL FACILITIES") of Title 8 ("PARKS, STREETS, AND OTHER PUBLIC PROPERTY") of the Beverly Hills Municipal Code, and renumbers Sections 8-1-1 through 8-1-7 to be Sections 8-1-101 through 8-1-107 of Article 1. All references in the Beverly Hills Municipal Code to such old section numbers (such as in Section 5-6-1501 and in Title 8, Chapter 1) shall be changed to the new section numbers.

Section 2. The City Council hereby adds Article 2 ("USE OF PUBLIC RECREATIONAL PROPERTY FOR PROFESSIONAL INSTRUCTION") to Chapter 1 ("PARKS AND RECREATIONAL FACILITIES") of Title 8 ("PARKS, STREETS, AND OTHER PUBLIC PROPERTY") of the Beverly Hills Municipal Code to read as follows:

Article 2. USE OF PUBLIC RECREATIONAL PROPERTY FOR PROFESSIONAL INSTRUCTION

8-1-201: DEFINITIONS.

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

"Commercial or Professional Instruction" shall mean instruction performed in whole or in part for salability or profit or for any form of consideration, such as time or money.

"Director" shall mean the Director of Community Services or his or her designee.

"Public Recreational Property" shall mean all City parks as designated in Section 8-1-101 of this code, and City-owned or Parking Authority-owned facilities.

#### 8-1-202: PERMIT REQUIRED.

No person shall conduct any Commercial or Professional Instruction such as boot camps, fitness instruction, day camps, yoga classes, youth sports camps, dog training or similar activities on Public Recreational Property without first obtaining a permit pursuant to the provisions of this article. No person shall bring onto any Public Recreational Property any equipment to be used for Commercial or Professional Instruction except as authorized by a permit issued pursuant to this Article.

8-1-203: CONTENTS OF THE APPLICATION.

(a) An application for a permit shall be on forms as prescribed by the Director. The application shall include:

- (1) The name and address of the applicant, and if the applicant is a corporation, the names of its principal officers, or if the applicant is a partnership, association, limited liability company, organization or fictitious company, the names of the partners or persons comprising the association, organization or company with the address and telephone number of each;
- (2) The proposed dates, hours, and location where the Commercial or Professional Instruction is to be held;
- (3) The number of participants anticipated to
- participate in the Commercial or Professional Instruction; and
- (4) A list of the number and type of equip ment and the weight of the equipment to be used by the applicant.

(b) The application shall be signed by the applicant under penalty of perjury and shall contain an agreement whereby the applicant agrees to defend, indemnify and hold harmless the City and its employees from and against any claims arising from the actions or omissions of the applicant or the applicant's client(s). The agreement shall also require the applicant to fully compensate the City for any damage to public property, as well as to clean and otherwise restore any Public Recreational Property to the condition in which it was found prior to the conduct of the Commercial or Professional Instruction.

#### 8-1-204: INSURANCE REQUIRED.

The permittee shall be responsible to carry. maintain, and keep in full force and effect, a policy or policies of comprehensive general and/or professional liability insurance with minimum limits of one million dollars (\$1,000,000.00) per occurrence, combined single limit coverage and two million dollars (\$2,000,000.00) in the aggregate against any injury, death, loss or damage as a result of wrongful or negligent acts or omissions by the permittee, with an endorsement naming the city as an additional insured. In addition, permittee is required to carry workers' compensation and automobile coverage sufficient to meet requirements of the State of California. The insurance shall comply with the provisions of title 3, chapter 4 of this code.

8-1-205: PERMIT ISSUANCE OR DENIAL.

An application for a permit may be denied by the Director for any of the following grounds: (1) The applicant fails to include all of the information required by section 8-1-203.

(2) The Director determines that the instructional activity or equipment proposed by the applicant will unreasonably interfere with the public's use and enjoyment of the Public Recreational Property.

(3) The instruction proposed in the application is prohibited by other provisions of this Code.

(4) The proposed instruction or equipment will unreasonably interfere with the activities authorized by another permit.

(5) The proposed equipment is greater than 25 pounds.

(6) The proposed instruction equipment will interfere with normal operation of the Public Recreational Property.

(7) The proposed instruction equipment will damage Public Recreational Property.

(8) The applicant has not provided evidence of an insurance policy that complies with subsection 8-1-204 of this article.

The Director may impose reasonable terms and conditions concerning the Commercial or Professional Instruction or the equipment authorized by the permit, including the time and location of the activity, the maximum number of participants, the type and number of equipment, the duration of the activity.

8-1-206: REVOCATION OR SUSPENSION OF PERMIT:

A permit issued under this article may be revoked or suspended for any of the following reasons:

A. Permittee or permitee's client damages public property;

B. A material false statement contained in the application;

C. Failure to comply with federal, state or local laws and regulations;

D. Loss of insurance;

E. Failure to comply with any conditions imposed by the City on the issuance of the permit;

F. Conduct of the business or activity in a manner which endangers the public health, welfare or safety.

#### 8-1-207: PROCEDURE FOR SUSPENSION OR REVOCATION:

A. Except as provided in Section 8-1-208, no permit shall be suspended or revoked prior to providing a ten (10) calendar day written notice to the holder of the permit and an opportunity to be heard before the officer considering revocation or suspension of the permit. On determining that grounds for permit suspension or revocation exist, the Director shall furnish written notice of the proposed suspension or revocation to the permittee. Such notice shall set forth the time and place of a hearing, and the grounds upon which the proposed suspension or revocation is based. The notice shall be mailed, postage prepaid, addressed to the last known address of the permittee, or shall be personally delivered to the permittee, at least ten (10) days prior to the hearing date.

B. Hearings shall be conducted in accordance with procedures established by the Director. All parties involved shall have a right to: 1) offer testimonial, documentary and tangible evidence bearing on the issues; and 2) be represented by counsel.

C. The decision of the hearing officer des-

ignated by the City to hear the matter shall be rendered within five (5) days of the close of the hearing. The decision shall be in writing, and shall set forth the findings and reasons for the decision, and the permitee shall be notified in writing in accordance with title 1, chapter 5, article 1 of this code. If the hearing officer determines that there are sufficient grounds for disciplinary action, the hearing officer shall impose one of the following penalties:

1. A warning;

2. Suspension of the permit for a specified period not to exceed six (6) months; or

3. Revocation of the permit.

The hearing officer shall, in conjunction with the issuance of a warning or the suspension of a permit, order the permittee to take appropriate corrective action.

8-1-208: EMERGENCY TEMPORARY SUSPENSION OF PERMIT:

Certain types of Commercial or Professional Instruction may create an imminent peril to public health or safety. Where the conduct or activity of the permitee creates an imminent peril to the public health or safety, the permit may be summarily suspended upon notice to the permittee, provided further, that the permitee shall be entitled to a hearing within two (2) weeks thereafter and a decision within two (2) days after the hearing.

8-1-209: VIOLATIONS; ENFORCEMENT:

A violation of any provision of this article is punishable as provided for in title 1, chapter 3 of this code.

<u>Section 3.</u> <u>Severability.</u> If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

#### ORDINANCE NO. 17-O-2723

ORDINANCE OF THE AN CITY BEVERLY HILLS BEVERLY HILLS AMENDING OF THE MUNICIPAL CODE TO CLARIFY LANGUAGE ON EXISTING REGULATIONS RELATED TO PORTE COCHERES SOUTH SANTA MONICA BOULEVARD. OF PUBLIC NOTICING REQUIREMENTS, PAVING IN FRONT YARDS, TIME RIGHTS EXTENSION OF FOR CONDITIONAL USE PERMITS, AND MINOR ACCOMMODATIONS IN THE CENTRAL AREA OF THE CITY.

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. On July 28, 2016, the Planning Commission held a duly noticed public hearing after which it adopted Resolution No. 1782, recommending that the City Council amend portions of Title 10 (Planning and Zoning) of the Beverly Hills Municipal Code to correct the public noticing requirements table; clarify language on existing regulations related to porte cocheres south of Santa Monica Boulevard; clarify front setback paving requirements in the Central Area of the City; correct a typographical error in regulations regarding time extension of rights for conditional use permits; and remove a no longer applicable provision from the list of allowable minor accommodations (collectively, the "Amendments"). On December 20, 2016, the City Council held a duly noticed public hearing, received public testimony, and thereafter introduced this Ordinance.

Section 2. This Ordinance and the Amendments were assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA). the State CEQA Guidelines, and the environmental regulations of the City. The adoption and implementation of the Ordinance represents minor semantic changes to the existing code and does not represent substantive changes in meaning or interpretation of the code. It can therefore be seen with certainty that there is no possibility that the proposed amendments may have a significant effect on the environment. Therefore the City Council finds that the Amendments are exempt from CEQA pursuant to Section 15061(b)3 of Title 14 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment.

Section 3. The Amendments are consistent with the objectives, principles, and standards of the General Plan. General Plan Goal "LU 3 – Managed Change" calls for orderly and well-planned change to the community that provides for the needs of existing and future residents and business, effective and equitable provision of public services, and makes efficient use of land and infrastructure. Amending the zoning code to clarify language and correct errors will contribute to creating orderly change to the community by providing clear rules to regulate land use. Additionally, periodic modifications to the code will contribute to the provision of effective public services in that accurate and understandable land use rules will be available for the use in the community. General Plan Policy "LU 16.11 Community Engagement" encourages engaging all segments of the community in planning decisions. It calls for the maintenance and enhancement of the public involvement process to assure transparency and enable the public to be well informed. Amending the code periodically to address inconsistencies ensures that the code is legible and accurate, which enhances the ability of the public to understand regulations that govern development projects.

<u>Section 4.</u> The City Council hereby amends Section 10-3-253 A of Article 2.5 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows with all other provisions in Section 10-3-253 remaining in effect without amendment:

"A. Standard Requirements:

not be permitted in this nine foot (9') setback area except for: 1) roof eaves pursuant to subsection 10-3-2409B of this chapter, and 2) encroachments along the side property line for side

<u>Section 5.</u> The City Council hereby amends Section 10-3-2406 (B) of Article 24 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows with all other provisions in Section 10-3-2406 remaining in effect without amendment:

"B. South Of Santa Monica Boulevard: Except as otherwise provided in this section, the minimum side setback for buildings located south of Santa Monica Boulevard shall be five feet (5') on one side. On the other side, the minimum side setback shall be nine feet (9'). Encroachments in side setbacks otherwise permitted pursuant to section 10-3-2409 of this chapter may yard fences, walls, or hedges, provided that a flat area with a minimum width of nine feet (9') is maintained between the side property line wall, fence or hedge, and any structure or building. Parking, including a porte cochere covering said parking may be provided in this nine foot (9') setback area pursuant to section 10-3-2419 of this chapter.

1. Exception: The setback requirements set forth in this subsection B shall not be applicable to: a) any corner lot, b) those site areas located south of Olympic Boulevard and west of Roxbury Drive, nor c) those site areas located south of Olympic Boulevard and east of Doheny Drive. a. Corner Lots And All Lots South Of Olympic Boulevard And West Of Roxbury Drive: The side setbacks for all corner lots located southerly of Santa Monica Boulevard and those site areas located southerly of Olympic Boulevard and westerly of Roxbury Drive shall be at least five feet (5'). In addition, the sum of the side setbacks adjacent to the two (2) longest side lot lines shall be at least twenty percent (20%) of the lot width.

b. South Of Olympic Boulevard And East Of Doheny Drive: The side setbacks for site areas southerly of Olympic Boulevard and easterly of Doheny Drive shall be five feet (5').

2. Exception; Two Or More Lots: For those buildings located on site areas that consist of two (2) or more lots as subdivided on July 3, 1984, the side setback shall be ten feet (10') plus ten percent (10%) of the width of the lot in excess of one hundred feet (100')."

Section 6. The City Council hereby adds Subsection O to Section 10-3-2409 of Article 24 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code with all other provisions in Section 10-3-2409 remaining in effect without amendment:

"O. For single-family properties south of Santa Monica Boulevard Section 10-3-2406(B) shall control allowable encroachments in the nine foot setback."

<u>Section 7.</u> The City Council hereby amends Section 10-3-2423 of Article 24 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-3-2423: LANDSCAPING AND LANDSCAPING PLANS:

This section is intended to require design and implementation of a landscaping plan prior to occupancy of a new development in order to ensure that landscaping is not ignored in the design and construction process. However, this section is not intended to require a specific type or standard of landscaping.

For the purposes of this section, "landscaping" shall mean the development of the open space on a property with plantings, such as trees, bushes, shrubs, hedges, lawns, other live ground cover, or greenery. Landscaping may include nonliving decorative treatment, such as walls, fences, curbs, groupings of rock, or similar accent material, interspersed with plantings, but shall not include paving.

- A. All unpaved portions of a front yard shall be improved and maintained with landscaping.
- B. Each proposal for the construction of a single-family residence shall be accompanied by a landscaping plan that is designed with the goal of maintaining the garden quality of the city of Beverly Hills. Prior to final inspection of a new residence, the property owner shall attest, on a form provided by the city, that the subject site area has been planted in accordance with the landscaping plan.

The landscaping plan shall include a minimum two foot (2') wide landscaped area the length of each required side yard, except in portions of the side yard occupied by approved accessory structures, approved elevators or elevator enclosures, a permitted swimming pool, or a driveway, including a driveway covered by a porte cochere, in accordance with sections 10-3-2419 and 10-3-2422 of this chapter."

<u>Section 8.</u> The City Council hereby amends Subsection 10-3-2422 E of Article 24 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows with all other provisions in Section 10-3-2422 remaining in effect without amendment:

\*E. Setbacks For Paving: No portion of a front yard within three feet (3') of any property line shall be paved, except for a driveway not exceeding the width of its curb cut and a walkway pursuant to 10-3-2422. In addition, no portion of a front yard within five feet (5') of a building shall be paved except for a driveway and a walkway of no more than ten feet (10') in width."

Section 9. The City Council hereby amends Section 10-3-3805 of Article 38 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-3-3805: TIME FOR EXERCISE OF RIGHTS:

Unless otherwise provided in the resolution granting a conditional use permit, the exercise of rights granted in such approval shall be commenced in accordance with the time limits imposed by section 10-3-207 of this chapter."

Section 10. The City Council hereby amends Section 10-3-3600 of Article 36 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to repeal subsection H, which concerns the height of buildings north of Santa Monica Boulevard, without renumbering, to read as follows, with all other provisions of Section 10-3-3600 remaining in effect without amendment:

"H. Repealed."

Section 11. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 12. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 13. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
