Accusations from Beverly Hills Courier

Yellow journalism is alive and well in Beverly Hills.

In their past Friday's edition, the *Beverly Hills Courier*, without any evidence, accused me of writing a letter under the name of an elderly woman regarding [Vice Mayor] Nancy Krasne. The letter was published in *the Weekly's* [Issue #908].

Prior to publishing their false and disparaging story about me, *the Courier* failed to contact me for a statement. Instead, *the Courier* chose to rely only on rumors from unnamed sources. Journalists have an ethical and professional responsibility to verify rumors before publishing them. *The Courier* clearly failed in this regard.

I categorically and emphatically deny writing any portion of the Hermine Beck letter, or seeing the letter prior to reading it in print, or providing any of the facts in the letter. Many of Nancy Krasne's supporters, including Robert K. Tanenbaum, claim that the statements in the Beck letter are false. Yet, rather than attempting to

disprove any of the statements in the letter, Krasne's supporters instead attack the 95-year old writer, claiming she is incapable of writing such a letter. I suggest that these people not bully the elderly citizen, but instead focus on Ms. Beck's message.

To make matters worse, Nancy Krasne herself first falsely accused candidate and current Mayor John Mirisch as the writer of the Beck letter. She falsely claimed that she saw Mirisch write the letter during a City Council meeting. However, after Mirisch produced his handwritten notes about only City issues (which were written on a City notebook maintained by the City staff), Krasne was compelled to apologize to Mirisch.

Krasne then changed her story with another lie. She next accused candidate Frances Bilak of writing the letter. Apparently, that lie didn't work well either, so now *the Courier*, whose publisher is good friends with Krasne, has falsely accused me as the writer. While I am not a candidate for City Council, this false accusation by *the Courier* is another smear against the Mirisch campaign, which I chair. It is true that I believe that Nancy Krasne does not have the required temperament or leadership qualities to continue being a council member, let alone the next mayor. But I will let Ms. Beck's letter [stand] on its own.

I am sending a letter to *the Courier* demanding a retraction and apology.

Mirisch re-elected; other seats too close to call

Incumbent John Mirisch was re-elected Tuesday to the Beverly Hills City Council. The remaining two seats are too close to call with incumbent Nancy Krasne and challengers Robert Wunderlich and Les Friedman in a virtual three-way tie.

molded to try to support a position rather than evidence stemming from an actual problem. The district may indeed be suffering from issues related to its finances and spending but the teachers' salary formula is not the cause.

One of the concerns mentioned is the possibility that decreases in property tax revenues will leave the district on the hook for high teacher salaries. In the last 33 years, property tax revenues in LA County have decreased 4 separate years for a cumulative and un compounded 5%. In contrast, property tax revenues in the county have increased in 29 separate years for a cumulative and un compounded 202%.

Furthermore, the district's Chief Administrative Officer has stated that property tax revenues are projected to increase in the next four years. The salary formula is not the cause of fiscal problems in the district. Rather, it is an indicator of financial health and in this regard, the district is very healthy. Remember, the salary formula was created to allow employees' salaries to keep up with increases in the cost of living.

Currently, according to the Form J90 released by the State Department of Education, we are ranked 72 out of 74 in terms of average teacher salary. To argue that there should be no salary formula is to argue that employees' salaries should remain stagnant for years at a time. Given that our health and welfare benefits package is also below average among districts in our surrounding area, keeping our salaries low and stagnant would not only be

wrong but the time spent having to bargain salary and benefits every single year as was done in the past would take away time from refining other aspects of our collective bargaining agreement - something that would be a benefit to both the district and BHEA.

Blaming the salary formula masks the true problems afflicting the district. These problems include the lack of financial transparency, the inability or unwillingness to adhere to a long term plan, and a decision-making process that favors short-term quick fixes that lead to long-term damage. BHEA continues to wait for information from the district that will allow us to offer solutions to minimize cuts to programs and staffing.

We encourage the Board of Education to accept Superintendent Michael Bregy's recommendation to have more time to review our financial situation before making drastic decisions. Finally, we urge the district to focus on long-term strategic planning. For instance, one of the proposed cuts is an intervention program that was brought back less than a year ago!

Instead of placing blame on the educators and proposing cuts only to the classroom, we ask that the district work with us to find solutions that address our financial issues in a way that doesn't hurt our programs and students. The solutions are there - the district just needs to be willing to invest the time to work with us to find them.

that could potentially change the order of second, third and fourth place, it's still a nail-biting time," Wunderlich told *the Weekly*. "I feel good about the process. I felt I ran a good campaign [and] really everyone ran a positive campaign, much to the credit of the City."

Wunderlich also indicated he is undecided about a recount.

"I haven't made a determination about a recount one way or the other. I'm just waiting to see what happens with the remaining votes to be counted."

Krasne and Friedman could not be reached in time for comment.

According to the county registrar, the unofficial preliminary number of vote-by-mail ballots remaining is 426. The unofficial preliminary number of provisional ballots is 311. Additional ballots could arrive in Thursday and Friday's mail.

Ballots received by Friday that were post-marked by Election Day will be counted. Another update is expected Friday. In the event of a tie, candidates will flip a coin.

In the event the election is not certified until March 31, the mayoral installation will be moved from March 28 to April 4.

Faculty rallies to save Jen Tedford

Several members of the BHUSD staff attended the Board of Education meeting on Tuesday morning to speak on behalf of Chief Academic Officer Jennifer Tedford, who received a reassignment notice earlier in the week.

Tedford was given direction from the Board and Superintendent Michael Bregy to either resign or be reassigned to an English position.

An online petition, created by Beverly Vista teacher Victoria Hanlon on Sunday, was circulated to parents, students and faculty via Facebook. The petition had over 500 signatures, as of press time.

"Dr. Tedford has no intention of leaving BHUSD and wants to continue her work here and grow professionally," the online petition states. "Further, Dr. Bregy told her that the [Board of Education] has decided to take immediate action on this issue. They have scheduled a meeting at the district office for this Tuesday, March 7 at [9:00 a.m.] Note, this is a time when most teachers cannot attend and when many involved and concerned parents will be helping with [the Every 15 Minutes] program. The timing was deliberate so that teachers would not be able to attend and let their voices be

heard in opposition to his decision."

Parents and faculty left "reasons for signing" in the comments section of the petition.

"To let Dr. Tedford go would be a huge mistake," Shannon Hunt wrote, "and grossly explains the unhealthy situation of our Board of Education members, clearly some of which need replacing! I have three children in BHUSD, and this whole situation is very disappointing and distracts from the real issues we should be focusing on to better our children's education."

March 15 is the deadline to notice faculty and staff of any personnel changes, which includes reassignments.

The Board will not comment on personnel issue.

Former Congressman Anthony Beilenson passes at 84

Former Congressman Anthony Beilenson passed away on Sunday, March 5. He was 84 years old.

Over his 20 years in Congress, Beilenson championed affordable healthcare, environmental safeguards like the Clean Air Act and abortion rights.

He represented Beverly Hills for most of his career.

Beilenson was first elected to the state Assembly in 1962, representing a Democratic district that included Beverly Hills and West L.A. Four years later, he was elected to the state Senate. In 1976, he went to Congress when Tom Rees retired.

As a state senator, he wrote what became one of the most liberal abortion laws in the nation. The Therapeutic Abortion Act legalized the procedure in cases where a woman's mental or physical health was at risk or if pregnancy resulted from rape or incest. In 1967, then just six months in office, Gov. Ronald Reagan signed the bill into law, although Reagan later expressed regret over the decision.

In addition, he singlehandedly blocked plans for a Beverly Hills freeway, which would have run under Santa Monica Boulevard.

Among some of his other achievements was sponsoring the 1978 legislation that created the Santa Monica Mountains National

Recreation Area that protected a wilderness that extends from the Hollywood Hills to Point Mugu. He later helped secure federal funding that created Lake Balboa Park, which now bears his name, and the Sepulveda Basin Wildlife Refuge.

Toward the end of his career, Beilenson was redistricted out to the San Fernando Valley after the 1991 census. After a closer than expected election in 1994, he chose to retire in 1996. Brad Sherman now represents his district.

"I was honored to have his support, friendship, and advice," Sherman wrote in a statement about Beilenson's passing. "He had an incredibly dedicated staff that helped thousands of his constituents over the years, and I was very lucky to inherit some of those people when I first came to Congress."

Former State Senator Alan Sieroty could not be reached for comment.

No resolution for El Rodeo parking problem

The Traffic and Parking Commission denied a temporary parking permit program for El Rodeo School staff that would have allowed faculty and administration to park on adjacent residential streets during the school's ongoing construction at its meeting on Thursday, March 2.

At the Jan. 24 City Council meeting, Principal Kevin Allen spoke during public comment to ask for of alternative employee parking options during the school's two-year construction project, which is expected to last through Fall 2019.

Approximately 60 vehicles have been displaced as a result of onsite construction staging. As a result of continued resident complaints, the four-hour parking signs on the west side of Whittier Drive between Elevado and Lomitas Avenues were enforced and 10 school employees received parking citations, according to the staff report.

Currently, school employees park on Lomitas Avenue and street blocks that do not have parking restrictions and take a shuttle to and from the school at designated times throughout the day.

Some of Allen's concerns include staff members walk long distances to their cars, sometimes carrying instruction materials, when shuttles are not available and school employees not being able to get to their cars immediately in case of an emergency.

The Commission reviewed a proposal modeled after the Beverly Vista school teacher preferential parking permit program. Council adopted a resolution allowing issuance of temporary permits during Beverly Vista School's seismic retrofit program.

However after a two hour discussion and complaints from several residents, the Commissioners rejected the proposed parking permit program.

"This is probably the most unfortunate

[dereliction] of planning, duty and responsibility of a school board [that] I have seen in the last 20 years," Commissioner Jake Manaster said during the meeting. "[The] only reason we are looking at this is because the school board was incredibly short sighted in the timing and method, [and/ or] did not make for other mitigation measures that would've allow you [Principal Allen] to maintain your parking. [The] area should have been staged in such a way where people could park onsite without any problems."

Manaster is a former president of the BHUSD Board of Education. Chair David Seidel is a former astronomy teacher at Beverly High.

No Board of Education members spoke at the meeting.

Minimal solutions were offered by the Commissioners at the conclusion of the meeting. Seidel directed city staff to return to the Commission with more information on potentially extending the four-hour parking restrictions currently in place on Whittier Drive

"If the residents were okay with it, [I would've] been perfectly fine to move forward," Seidel said. "But that's not the case. It's an impacted neighborhood on a [daily] basis. I think there needs to be an effort to look at alternatives."

He also advocated against the Commission voting on a motion rejecting the proposed permit parking program.

"I'd like to avoid a motion. [I] don't think it serves any purpose at this point. Our advice to the staff [is] that we don't like the idea [because] we feel that there is additional investigation that still could be done. I don't think a motion is actually helpful here."

City expected to renew tree services contract with West Coast Arborists

Urban Forest Manager Ken Pfalzgraf attended the Recreation and Parks Commission meeting on Feb. 13 to discuss the renewal of the contract services related to the care of the City's 25,000 street and park trees.

For more than two decades, the trimming, removal, planting and watering of trees in the City has been outsourced, with the vast majority of the work being provided by tree services contractor West Coast Arborists. The current contract with WCA

was set to expire on Dec. 31, 2016. The contract also allowed for three additional

one-year extensions, pursuant to the same terms and conditions.

City staff decided to issue a request for proposal last November to 25 tree service companies, in addition to posting it on the City website. Three bids were submitted and evaluated by Public Works Department administrative staff. A panel consisting of Chair Howard Rosoff and Public Works Commissioner Sandra Aronberg rated presentations by each of the bidders as well.

All three proposals, including WCA, represented a substantial cost increase to the City, ranging from approximately 23 percent to 61 percent.

Currently, \$1,330,176 is budgeted annually for contracted tree services in the City of Beverly Hills, according to the staff report. The report also noted Street Tree Master Plan capital improvement projects could increase the annual tree budget to nearly \$2,000,000 in future years.

Pfalzgraf explained that the City will likely continue its contract with WCA.

“West Coast has decided to come back to us and honor the terms of the current agreement, so the pricing structure will remain the same,” Pfalzgraf said. “We will look to go out three years from Dec. 31, 2016 to do this process again.”

Later on in the meeting, Pfalzgraf also talked about the prioritization and scheduling of the Street Tree Master Plan projects.

Among the list is the replacement of the Indian Laurel Fig trees currently planted along Park Way. Commonly known as the Rusty Leaf Fig, the tree produces pod-like fruit which residents have experienced issues with. Beverly Hills resident Abraham Assil told the Commission in 2015 he has fallen twice from slipping on the berries, which coat the sidewalks for several weeks a year during the annual berry drop period [Issue 810].

Assemblymember Richard Bloom honors activist Ivy Bottini as “Woman of the Year”

Assemblymember Richard Bloom (D-Santa Monica) selected activist and artist Ivy Bottini as the 50th Assembly

Bottini had a decades-long career as an illustrator and graphic designer before going on to

become a trailblazing activist best known for her feminist and LGBT work. Over the course of her career as an activist, Bottini organized marches, founded several nonprofits and led campaigns against statewide initiatives that targeted and sought to mar-

ginalize the LGBT community.

“Ivy Bottini has left a lasting impact on the lives of countless people,” said Bloom in a statement. “She fights, unrelentingly, to bring justice and equality for marginalized people and communities, and has championed women’s rights and LGBT rights even when it came at personal cost. I am proud to celebrate her accomplishments as an artist, a mother, and an activist.”

Bottini was a founder of the first New York chapter of the National Organization for Women (NOW) where she fulfilled the roles of both activist and artist, designing the organization’s national logo.

She helped found a number of nonprofit organizations including the Los Angeles Lesbian/Gay Police Board, AIDS Network LA, and AIDS Project Los Angeles.

Bottini was recognized at a ceremony in Sacramento on Monday, March 6.

Planning Commission approves permit for accessory dwelling unit at 472 S Spalding Dr.

The Planning Commission unanimously approved a permit request at 472 South Spalding Dr. for additions to an existing accessory structure and the conversion of the second story of the accessory structure into an accessory dwelling unit, at its meeting on Thursday, Feb. 23.

The project includes a 60 square foot addition to the first story of the accessory structure along with a 151 square foot addition to the second story, according to the Feb. 23 staff report.

At a previous meeting on Jan. 12 the Commissioners denied the permit request for this location and asked the applicant to make changes to project proposal.

“I struggle to find, historically, any other project that has not been in such compliance as this is,” said attorney Mitchell Dawson,

who represents the project applicant. “[I’m] not quite sure what else an applicant could do, in any set of circumstance, [to] comply with the requests of the governing body that made those requests.”

At the end of 2016, the Commission adopted an ordinance modifying the City’s regulations regarding second units, often referred to as “granny units.”

California enacted Assembly Bill 2299 and Senate Bill 1069, which limit the ability of cities to regulate second units, according to the Dec. 8 staff report.

The law changes the terminology from “second units” to “accessory dwelling units,” which are defined as units containing independent living facilities on a property such as a kitchen, bathroom, living room, and usually a bedroom.

SB 1069 states “allowing accessory dwelling units in single-family or multi-family residential zones provides additional rental housing stock, and these units are an essential component of housing supply in California.”

Proponents of the bill say it will help ease California’s housing crisis by making it easier and less expensive to build rental units throughout the state.

The ordinance approved by the Commission changes the Municipal Code to bring city regulations into compliance with the new state legislation.

The project at 472 South Spalding Dr. has been reviewed for compliance with these modified regulations, according to the Jan. 12 staff report.

Attorney Murray Fischer, representing adjacent neighbors of the project such as Larry Goodman, asked that the Commissioners consider the inclusion of a time limit on the scope of work for the project.

Renovation rights granted by the permit are required to be completed within one year, with the opportunity for a single three-month extension deemed necessary by the director with good cause.

Other conditions for approval also includ-

ed additional landscaping, increased setback of the deck from the neighbor’s property line and a time limit set should the property owner decide to rent out the accessory dwelling unit.

BHHS girls' basketball team wins Southern Section championship Second-half comeback gives team title

Beverly High won its first Southern Section girls' basketball championship Saturday, rallying from an 11-point third quarter deficit to defeat Knight, 43-36, in the Division 4A final at Azusa Pacific University.

The Normans took the lead for good on Dominique Petrie's basket with one minute, 19 seconds to play, part of an 11-0 run Petrie began with 3:15 remaining by making two free throws.

Megan Saghian gave Beverly Hills a 39-34 lead with 35 seconds left with a 3-point basket. Her two free throws with 19.3 seconds to play increased the Normans lead to 41-34. Arbri Gillis' two free throws with 9.9 seconds remaining concluded the run.

From when the Normans trailed 26-15 midway through the third quarter, they outscored the Knights 28-10, including a 21-6 advantage over the final 11:05.

"The whole playoffs it's been amazing," Beverly Hills coach John Braddell said.

"The fourth quarter comes and they rise up. I can't explain it and I don't want to explain it. I just want to enjoy it.

"I give all of them the credit. They listened. They do exactly what they're supposed to do and they play extremely hard."

Knight made 10 of 30 shots in the first half, 33.3 percent, en route to a 24-15 half-time lead. It made five of 31 in the second half, 16.1 percent.

Braddell cited a switch from a zone defense to a man-to-man in shutting down the Hawks in the second half along with "getting out" on Hawks guard Ryan Stuart-Flores and not letting guard Sasha Duckett "beat us."

Duckett missed 12 of her 13 shots, only making a third-quarter 3-point basket.

"She's excellent going to her left so we took that away," Braddell said.

Stuart-Flores was scoreless in the second half, missing all nine of her shots, after leading all scorers in the first half with 13 points.

Beverly Hills made five of 30 shots in the first half, 16.7 percent.

"The gym has a little bit to do with it," Braddell said. "It's a struggle when you're looking into a wide open space. Some of the misses we had we're pretty bad."

The Normans made eight of 31 shots in the second half, 25.8 percent.

Gillis, a freshman point guard, began Beverly Hills comeback, scoring seven consecutive points, including one of her four 3-point baskets, cutting the deficit to 26-22 with 3:47 left in the third quarter.

Knight (19-11) responded with Duckett's 3-point basket – what would be its last basket for nearly seven minutes – and a free throw by Keyna Hadley to lead 30-22 with 3:06 left in the quarter.

The Normans (22-9) closed the quarter a layup by freshman forward Chantal Moawad and Gillis' 3-point basket to trail 30-27 entering the fourth quarter.

Beverly Hills took its first lead, 32-30, with 5:24 to play on Saghian's 3-point basket.

The Hawks tied the score 47 seconds later on Bailey Cassell's layup and regained the lead on Cierra Steemer's basket with 3:55 remaining, they final points until Hadley's layup with 1.1 seconds to play.

Gillis led all scorers with 20 points, 18 over the first three quarters. Saghian added eight, all in the final 5:24, Petrie six, Moawad five and Isabel Rund four.

Stuart-Flores led Knight with 13.

Petrie had a game-high 16 rebounds and Moawad 13. Saghian led the Normans with five assists.

Gillis moved with her family to Beverly Hills after she completed sixth grade in the Sacramento area when her mother Artha Gillis became a postdoctoral fellow in the Department of Psychiatry and Biobehavioral Sciences at the UCLA Semel Institute for Neuroscience and Human Behavior.

The younger Gillis said her mother chose Beverly Hills as the place to live because after researching the Santa Monica and Culver City school systems concluded "Beverly Hills had the best education system."

Gillis, who graduated from Hawthorne School in May, said she attended one Norman game last season and noticed the team "couldn't really bring the ball up past half court" during a season it was 5-22.

Gillis said her mother asked her if she thought she could lead the team as a freshman and responded "Yeah, I do."

Gillis, who called basketball a "huge" part of her life, was asked if she considered she would be better off going to a high school with a better girls' program after seeing the team play.

"Part of me was thinking like that ... but I thought just do it," Gillis said.

To Braddell, one reason for the improvement from last season was the leadership from the team's captains, Rund and Saghian, which he called huge.

"With any team, you have ups and downs, you win, you lose, personalities come together," Braddell said.

"We have 15 girls on this team, all kinds of different personalities, but the captains and the team really came together. It was impressive the leadership we've had this year."

Saghian credited the improvement to a combination of the additions of Gillis and Moawad, and the team's closeness.

"It's more like a family than just players on a court," said Saghian, a junior guard who also played on last season's team. "Last year I feel like everyone was playing for themselves. We didn't know how to do anything together.

"But this year, I feel like the heart was there. We all wanted it a lot more. We grew and it showed on the court 100 percent."

What's Next?

The eighth-seeded Normans were scheduled to play host to ninth-seeded Viewpoint in a Division IV CIF State Championships Round I game at the Swim-Gym that began after Beverly Hills Weekly's deadline.

If Beverly Hills won, it would play Saturday at 6 p.m. against the winner of the game between top-seeded Los Osos and 16th-seeded Lincoln. The game will

be played on the home court of the higher-seeded team.

TAKING THE HELM

Newly appointed Superintendent Michael Bregy on the challenges of taking over the BHUSD

What made you want to accept the BHUSD Superintendent position given the BHUSD's challenges?

I had been looking for quite some time to move to California. But I was already a Superintendent, so I wasn't looking for that promotion. I was in a good place at a high performing school district, so I was able to wait for the right [position]. That's not usually how it works when people are looking for a job.

I was very intentional about waiting. There were only two school districts I had been interested in for the last couple of years. I knew there was going to be an opening [at BHUSD] two years ago, but I didn't realize [former Superintendent] Steve [Kessler] was going to be [promoted from] within, which was great, but at the time I thought I had missed my opportunity.

There have been hundreds of openings for Superintendents in California, but I never applied because I wanted to wait for the best.

There are challenges in every school district. I did my homework and spent years researching [BHUSD]. I was very attracted to the size of the district [and] the high student achievement, but I also knew there was room for improvement.

I thought it would be a good fit [because of some of my strengths]. Knowing that it was a good fit for me [was] only half of it.

Usually in an interview, you're trying to think of what [the interviewer] wants to hear. I didn't do that in this particular setting because I knew that if I wasn't myself I wasn't going to be successful in the position.

It was a very long interview and I was very honest about what I expect of the school board and what they can expect of me as [the] instructional leader for the school district.

What are some of the similarities between the BHUSD and North Shore School District 112 in Highland Park, Illinois?

One of the similarities is student achievement. [They are both] high performing school districts with very rigorous and robust curriculum offerings. Also the size of the districts [are] the same, both at just over 4,000 students.

[BHUSD] is a very generational school district where grandparents, parents and kids have all come back to go to school. That was the same in Highland Park. It's unique and

it says a lot about the school district. What I liked about my former district was people were proud of the district and wanted to have their kids [come] back. That doesn't happen very many places. That was a similarity that I really connected to.

Like Beverly Hills, the buildings were old. It's great that there's modernization happening. It's beautiful. I'm excited about it. I think it's the right thing to do for the community. I'm excited I get to watch that happen and develop. That's another similarity.

North Shore has had declining enrollment issues and your district proposed a controversial plan to close schools. What did you learn from that?

Twenty-five years ago there were three school districts [that] merged into one. That was a really divisive period. People did not want to give up local control of their school boards. The plan was to consolidate the school districts into one and then close buildings because there were so many.

But it was so divisive 25 years ago; it was like civil war in the community. [After they merged the districts], they decided to close the buildings later. Boy, do I wish they would've ripped that band-aid off. For 25 years, after the community has healed, they've been trying to come up with plans to close the buildings and be more efficient.

They've been able to, much like Beverly Hills, [carry on] but spend a lot of money. There are 12 schools [in the North Shore district]. Twelve schools for 4,100 kids. You have 12 principals. You have 12 assistant principals, [etc.] That is an expensive model.

When I came on to North Shore, I knew [something had to change.]. If we don't reconfigure, we'd have to go for a parcel tax. I never [pushed] closing buildings, but in that district the decision was to close buildings.

If the community values 12 buildings, then let's find a way to pay for them.

The situations are not the same, but they are very similar. It is absolutely critical to understand what the community values. In my North Shore school district, there were all kinds of plans to come up with reconfiguration options but the difference is those were closing buildings. We're not doing that here. We are not closing school buildings.

We did extensive public engagement and the lesson that I learned was before decisions are made truly understand what the community values. That's not an easy thing to do. When you have 85 or 90 percent of the people in your community without kids in your system, getting to them is really critical because it's their school too. That's the most important lesson I've probably learned in my entire life.

You have to go out and educate people as to why this is needed. There is a sense

of urgency with our finances that needs to get out to every single person that lives in Beverly Hills. Getting input after [the community is] educated and finding out what they value before [is extremely important] otherwise it will not work. I've lived through that in my other school district.

How will the BHUSD address its own issues pertaining to lower enrollment?

With the lower enrollment, we have made some recommendations for reductions. What's difficult about any projections, whether they're financial projections or student projections, is knowing when [they'll] begin to change.

While we should be looking five to 10 years out, we also have to be careful. Our schools are being modernized and they're [going to] reopened with these amazing facilities.

I know for a fact we're going to start getting more students. We need to be careful and not overestimate or over plan with some of the declining enrollment.

We have to prepare for that too.

What advice did you get from former Superintendent Steve Kessler?

We met for [over] four hours my very first day. I drove three days, practically nonstop

from Chicago. I had about three hours sleep and met with Steve. We talked for four hours and it felt like five minutes.

At the very end he shook my hand, hugged me and said, "You're going to be great, just don't forget who you are as a leader. Stand proud of the decisions that you make." I'll never forget that.

It's hard to leave knowing that somebody else is going to come into your position and have different ideas and a different style. But [Steve] did something that a great coach would do, and that is he really set me up with all the information. He took time to plan and prepared me to take over.

March 15 is the deadline for pink slips. Do you anticipate significant layoffs in the BHUSD?

Not significant, it [could] have been. The Board charge was \$5 million and not only would that have impacted a higher number of pink slips and reductions in staff, it would have also targeted some of the programs.

Something that people need to realize is there's always attrition through people that are retiring or people [that] transfer. It is a low enough number where somebody that is pink slipped has a very high probability of being asked right back into their job.

What do you hope to have accomplished one year from today?

The most important issue is to get a handle on our finances and to truly educate everyone in our community that there is a sense of urgency in our schools. Certainly from our financial standpoint, it's the education piece.

It's also about engaging the community because it's one thing to be aware of the problem, but we don't want to admire the problem. It's engaging people to be part of the process. To be successful we need people to really understand that whatever we do in the future is going to create opportunities to serve our kids in a better way.

In a year, I would love to see a focus on student growth. Right now, there is a heavy concentration on standardized test scores and using that as the predominant measure on whether or not our kids our learning. That becomes your profile. People look at that one number.

Instead, we have such capabilities now to drill down into that data per student. I'd like to see a focus and a concentration on the individual students and their growth. Making sure each child is appropriately challenged and if they've met targets for growth. If we lose sight of that than we're stuck on one number and one statistic. It starts within and it's the magic in the classroom. It's the work of the teacher and the student. Knowing where the student is at and where you want the student to go.
