



### Updated election results: it's Mirisch, Friedman and Wunderlich

The county registrar's office updated the Beverly Hills City Council election results on Tuesday, March 14 at around 3:00 p.m. Incumbent Nancy Krasne has fallen behind challenger Robert Wunderlich by 45 votes. Les Friedman has moved up to second place.

As of press time, vote totals were:

John Mirisch, 2,053; Les Friedman, 1,871; Robert Wunderlich, 1,862; Nancy Krasne, 1,817; Eliot Finkel, 1,570; Vera Markowitz, 1,080; Frances Bilak, 1,006; Jim Wayne, 219.

Although an undermined amount of ballots remain to be counted, the results are not expected to change. There is another update scheduled for Friday, March 17. See attached vote graph.

### Many complaints, few solutions in BHUSD's financial dilemma

A raucous Board of Education meeting on Tuesday night featured a number of confrontational parents and teachers offering many complaints and few solutions.

A large group descended on the meeting to air grievances related to the reported

On Monday, March 13 the Beverly Hills Education Association issued the following statement on its public Facebook page:

"BHUSD is moving forward with the layoff of 23 of our teachers. We believe there is a better way, a more collaborative way, to address any financial issues the district may have that will minimize the impact to our classrooms and our students. Join our educators at [the Board] meeting on Tuesday, March 14 [at 5:00 p.m.] Your voice can and will make a difference."

As the speakers advocated for the protection of several educators, they also criticized the Board and administration for a suggestion to create a new administrative position within the district.

Superintendent Michael Bregy has proposed the acquisition of a communications director to help convey the critical circumstances of the district's financial status to the community.

The BHUSD continues deficit spending by over \$4 million annually.

On Tuesday Chief Administrative Officer La Tanya Kirk-Carter also gave the Second Interim Financial report. In her presentation, she noted that this type of deficit spending is "concerning."

"We have a lot of money, but we spend it," said Kirk-Carter. "I tell everybody [at the State], 'We spend it like drunken sailors in port.""

Her report went on to outline some of the main reasons why the district currently suffers from deficit spending, including high salaries and low class sizes.

According to the 2015-2016 class size penalties report of attendance, the countywide average enrollment for grades first through third is 23.45 and for grades fourth through eighth it is 27.65. The BHUSD currently averages at 18.6 and 14.5 respectively.

In addition, the county's average per average daily attendance is \$12,551.02. The BHUSD currently spends \$15,571.86 per ADA making it the highest total expenses per ADA of the 48 districts ranked by the report.

At the conclusion of Kirk Carter's report, the Board voted unanimously to approve the second interim budget.

The deadline for layoff notices was March 15, but can be rescinded later.

Permit request for 1146 Tower Road exposes concerns regarding Hillside development



1146 Tower Road

The Planning Commission was expected to review a permit application for the addition of approximately 2,461 square feet to 1146 Tower Road during its meeting on Thursday, March 9.

However, the applicant asked that the project be continued to a later date. The home, reportedly owned by the Sultan of Brunei, will be returning before the Commission for the second time to make modifications to its previously approved Hillside R-1 permit.

In the proposed revision to the approved project, the guest room wing addition on the north side of the structure will be foregone, and instead, the additional floor area would be distributed throughout the residence in the form of other additions

The project is also expected to return with a 120 square foot pool house

on the eastern side of the property, adjacent to the main residence. A proposed pool house addition was withdrawn from the original request and not approved as part of the Planning Commission's decision.

The development underscores a larger debate taking place on Tower Road.

Tower Road is about 22 feet in width. It is a single lane residential street that continues past the City's northern boundary into Los Angeles. The road is also accessible from Benedict Canyon Drive, which is a busy travel corridor with high traffic volumes. At any given point, there are a number of remodels and redesigns taking place on the high-profile street. Neighbors living on Tower Road have expressed concerns regarding safety impacts as traffic increases due to congestion from the additional construction trucks on the winding, narrow canyon.

Last August, City Council approved the Hillside Ordinance in an attempt to help alleviate some of these concerns.

Drafted by Craig Corman, who will return to the Commission after Howard Fisher is sworn in as City Treasurer, the ordinance aims to regulate developments in the hillside area, which have become increasingly larger in scale and size.

It reduces the by-right limit of export/ import from any single site to 1,500 cubic yards in a five-year period for proper-

> ties located immediately adjacent to a street that is less than 24 feet wide. The ordinance also limits the maximum cumulative floor area located off the existing level pad to 1,000 square feet. Additional floor area located off the existing level pad in excess of 1,000 square feet would require approval of a Hillside R-1 Permit.

The project at 1146 Tower Road is expected to be continued at the Commission's meeting on March 23.

### Public Works Commission looks for landscape solutions to restore two City medians

The Public Works Commission attempted to find ways to enhance the current state of the Burton Way and Sunset Boulevard medians, at its meeting on Thursday, March 9.

The recent drought of 2014 through 2016 and the watering restrictions caused the ornamental turf lawns on the Burton Way and Sunset Boulevard medians to deteriorate, according to the staff report. The medians are brown and dead during the warmer months. As of now, weeds populate the medians due to recent storms.

At last Thursday's meeting, city staff presented two different options to the Commission regarding potential ways to handle the situation.

Fist, staff suggested the City maintain the current conditions of Burton Way and Sunset Boulevard medians. Irrigation of ornamental turf would remain prohibited and the height of the weeds would be retained.

The present cost of annual maintenance is \$34,343.23, according to the staff report. The cost includes turf grass aerating, maintenance and fertilization. This option does not accrue any additional costs for the City.

For the second option, staff considered the possibility of using non-potable groundwater from the Cabrillo Reservoir to irrigate the medians and restore the ornamental turf.

The chart included in the staff report estimated the total cost of option two would be \$391,672 for two-years of maintenance on both medians. The table indicates that watering is the most the most expensive task. In addition, the water source is contingent upon the reliability of ground water at the Cabrillo Reservoir.

Staff assessed other alternatives, such as using existing potable water to irrigate the medians; however, the staff report noted it is in violation of the current Emergency Conservation Regulation.

Staff recommended to the Commission that the City maintain the current conditions of the two medians.

Commissioner Barry Pressman expressed dissatisfaction with the suggestion to leave to medians in their current conditions, which could be considered an eyesore.

"This is Beverly Hills," Pressman said. "This isn't Los Angeles. This isn't some crummy town in the middle of nowhere, and we look like it. Make it work. In my opinion, all the negatives you listed are all surmountable. We're talking about, over two years, a \$320,000 delta. You guys spend that on consultants in an hour. Figure out one less consultant, we'll have the money. This is Beverly Hills."

There are long term landscape solutions for the restoration of the medians. For

example, the Burton Way Green Streets project will incorporate water efficient landscape in the final design, which is expected to be completed by 2018 and construction is expected to start in 2019 after the conclusion of the Santa Monica Boulevard reconstruction project.

"I had a meeting [about the] Burton Way project about a year ago," Pressman said. "It's gone nowhere in that time. For it to get done in two years is a pipe dream."

Staff is still considering different landscape design options compatible with existing utilities underneath the Sunset Boulevard median.

Staff will bring the Commission's comments and suggestions to the City Council at the upcoming liaison meeting.

### Shana Epstein named new director of Public Works

Shana Epstein will be the next director of Public Works last Friday. Epstein has served as the City of Ventura's Water General Manager since May 2011. She is also a former Beverly Hills utilities manager.

"I am honored to return to Beverly Hills and have this opportunity to address innovative challenges with familiar and new colleagues," Epstein wrote in a statement.

Epstein is expected to assume her new role on April 24. She replaces Public Works Director and Assistant City Manager George Chavez, who has been filling both positions for more than a year.

The Beverly Hills Public Works Director oversees more than 200 employees who develop, construct, inspect, improve and maintain the City's infrastructure, including traffic lights, sidewalks, street lights, roadways, urban forest and City parks. In addition, the department operates the water, solid waste, wastewater, storm water and parking enterprise operations.

"We are very fortunate to welcome Shana back to Beverly Hills," said City Manager Mahdi Aluzri. "Both in Beverly Hills and in Ventura she has proven herself to be an outstanding manager whose knowledge of public works operations and best practices will help guide our Public Works Department into the future."

While working in Ventura, Epstein and her staff built a potable reuse demonstra-

uses, wrote a Water Shortage Contingency Plan and oversaw the creation of a Water Commission.



### The Weekly's exclusive interview with BHPOA **President Christopher Coulter**

### Who does the Beverly Hills Police Officers Association represent?

Right now we have close to 130 [sworn] officers. We represent the rank of sergeant and police officer. There is a separate association called the Police Management Association but they are also members of the [BHPOA] along with the Chief of Police. They all pay dues to the [BHPOA] and we represent them.

We're the funding source for our medical trust, which provides medical benefits to our members when they retire. We also represent their interests when it comes to negotiations with the City. We work with the Chief and the administration to deal with policy and procedure. We give our input so the officers feel they have the benefit of [participating] in everything we do around the police department.

In California, the officers have the right to not be members of the association but all of our officers here [in Beverly Hills] are paying dues and are in good standing with the [BHPOA]. That includes the Chief of Police.

### What is your role as the head of the union?

I oversee the day to day business of the association, along with my fulltime job as a detective. I work the residential burglary detail. I try and wear two hats.

[As president of the association], I set the agenda for our meetings that we have bimonthly. We talk about [things like] requests for donations. For instance, we have requests for donations to the "Every 15 Minutes" program or other programs throughout the City we're involved in.

We had a Valentine's Day event at the Beverly Hills senior center where a bunch of officers went down there and spent some time hanging out with the seniors, even sharing some dances with them. We're involved in the Beverly Hills artSHOW every year. We're always at the Father's Day car show and, of course, we have our pancake breakfast in August. This year it's Aug. 27.

We like to involve the community as much as we can in the day to day business of the police department.

### Why has it been difficult to recruit officers to BHPD?

Actually, it is a nationwide problem. It's not just Beverly Hills. Obviously, Beverly Hills has its unique issues. Anyone who lives in this community knows it's really hard to get here. We have one officer in our entire

membership that actually lives in the City. Getting to Beverly Hills is always a challenge.

Finishing our most recent contract negotiations, we are much more competitive. For a little while, we were below the curve and we were not the highest paid officers in Los Angeles County.

I believe we were number three or number four in total compensation.

When someone is looking to become a police officer, they're obviously going to look at pay and the benefits. My assumption is that most men and women graduating from college are looking at all these officers go out there every different agencies and they're going to look at the ones with the best pay and benefits.

Cities like Santa Monica and Newport earn every penny we get." Beach were offering better pay and benefit packages than

Beverly Hills was. That probably led to us having problems finding qualified candidates. One of the other challenges that we have

is with the most recent [statewide] legislation In the middle of 2013 the Pension Reform

Act took over, so now anyone who gets hired is hired into a different retirement system. [They have] a much older retirement age. Qualified lateral applicants from other agencies won't get the same benefits as they're getting at their current agency if they come to Beverly Hills. Beverly Hills always had a good reputation of getting highly qualified lateral applicants from other agencies, but because of those pension reform issues we haven't been as successful in getting high quality lateral applicants.

[I] would say 90 percent of the people we've hired in the last two or three years have been entry level, so these are officers that [have to] go to the Police Academy and then go out to the streets. They don't have any prior experience, so we're working to make sure these brand new officers. [making up] a majority of our patrol, are able to provide the level of service Beverly Hills expects.

We're going to have a very young police force. One of the things Chief and the Police Officers Association really prides themselves on is teaching these new officers the importance of having a good relationship with the community. Unlike a lot of communities in L.A., in California or even nationwide, we enjoy a really supportive relationship with our community.

With every new officer we hire, we let them know how important it is to get involved with the City. That's one of the things we do as the Police Officers Association. We push really hard to try and get officers to be involved in the events around the City [and] to get to know the people who live in our community.

### How did you come to the BHPD?

I have kind of known my whole life I wanted to be a police officer. I remember when I was nine years old sitting on the couch watching that T.V. show "Cops" on the weekends. I knew I wanted a job where it was different every day, so that's why I was attracted to law enforcement.

I went to the Ventura County Criminal Justice Training Center, so it was the Ventura County Academy.

While I was going to college, I was a cadet with the Ventura County Sheriff's Department. Then I applied to become a deputy sheriff, so I was a deputy sheriff in Ventura County for almost 10 years.

I realized the cost of health insurance was going through the roof. I was paying thousands of dollars out of pocket per year, so I started looking into moving

to another agency. Beverly Hills was advertising heavily in a lot of the police related magazines at the time. I came here in 2006. I've been here ever since.

I worked patrol and then came into the detective bureau. I've now been a detective going on seven years. I've worked our crimes against persons detail; I've worked burglaries on different levels such as auto, commercial and residential. I'm currently assigned to investigating residential burglaries.

### What has changed for the union since Sandra Spagnoli was appointed Beverly **Hills Police Chief last March?**

The best thing that she has done is open up a line of dialogue. As soon as she started here, she met with the Board of the Association. She said she wanted to schedule meetings once a month with the entire Board and to put that on her calendar for the next year. She's held true to that

Every policy and procedure that the administration is either thinking about changing or updating or adding, we're always involved in that process. Our input is just as important as the captains' or lieutenants' that work for her. The Association has a seat at the table.

She also involved the Association in the ongoing process of selecting an Assistant Chief. There were representatives from the Association sitting in on most formal interviews with the potential candidates for Assistant Chief

Even though I'm a detective and the highest ranking person we have on the association's board is a sergeant, our voice with the Chief is the same as any person that's ranked. She takes our opinions to heart and uses that when making policy decisions.

Obviously we're not always going to agree with the police chief. There's always going to be times where the rank in file does not agree with the management, but so far we've seen Chief Spagnoli involve us throughout the process of decision making and ensure that the police officer's opinions are respected.

### The City Council recently approved salary increase for all members of the BHPOA. How do you respond to people who believe police officers are overpaid?

Last week, a police officer in Whittier was responding to a traffic accident and he was shot and killed. He'll never go home to his family again. Anyone who thinks being a police officer is overpaid needs to look at the current attitudes toward police in general.

[You] may think this is a relatively safe community, and you're absolutely right. I think the police department and the fire department do a great job of keeping this community safe. What a lot of people that live in this community don't understand is that those same things can happen here.

We had an officer a few months ago who go into a fight with a suspect and the suspect was literally choking the officer to the point where the officer was about to lose consciousness.

We've seen a definite spike in violence against police officers, even in our community.

We have several officers right now who are out injured. We had an officer who got spit at right in his face. I think almost any officer working in the United States right now is earning every dollar keeping their communities safe and putting their lives on the line doing what needs to be done.

I can say specifically for Beverly Hills, our officers go out there every day and every night and deal with some things no one would ever want to deal with. We really earn every penny we get.

### What advice do you give to new officers?

I was a field training officer before, so I've had the chance to be in a police car with a brand new officer. I always tell them just use common sense. If something is telling you things aren't right than they probably aren't.

You need to trust that little voice in your head telling you that something isn't right. Act accordingly.

Do what needs to be done, but also take into consideration that the state of California gives us the right to take away someone's constitutional freedoms. We need to hold that in the highest regard and take our job very seriously.


