Council and Board Extend JPA Two Months

After a lengthy negotiation process about the future of the Joint Powers Agreement (JPA), the City Council and Board of Education have finally settled on extending the current contract for two more months.

The current JPA, extended through August 31, allows the school and city to access school site recreation amenities like sports fields, gyms and multipurpose rooms while the Council and Board work to decide on a long-term agreement.

The Board has presented a proposal of \$13.5 million from the city — 20 percent rise in the base contribution from the City.

Council liaison to BHUSD and Vice Mayor Julian Gold initially recommended with Councilmember Mirisch that the JPA be extended through December 31, to which BHUSD was not receptive.

“From my perspective, this was not a good process,” said Gold. “It was a disingenuous process.”

At their June 29 formal meeting, the Council discussed the new consideration, contending that they need time to dissect what is being proposed in order to reach a practical decision. Councilmember Robert Wunderlich emphasized that the JPA cannot serve solely as a vehicle to fix the district’s

budget deficit.

At public comment, several speakers spoke in support and in opposition of the proposal. But others just wanted to know what the final outcome would be, asserting that it’s been deferred long enough. “If the city’s going to make a decision, make a real decision—not just six month and two month extensions,” said resident Amir Duranni.

Mayor Lili Bosse said that the end goal is the same: to foster a healthy joint venture in determining the best way to support the kids. “We all want a strong school system and a good city-school partnership,” said Bosse, “[but] I think it’s fair to take the time and sit and understand the numbers. So what I’m proposing is that we do just that.”

With Mirisch out of the country, the Council voted 4-0 in favor of the extension.

Edison Underground Utilities to Relocate

At their June 29 formal meeting, the City Council approved 4-0 a Memorandum of Agreement (MOA) and permit request from Metro for use of the public right-of-way to relocate Southern California Edison (SCE) facilities to make way for the Wilshire/Rodeo Subway Station.

The decision follows a previous Council meeting on April 20, where staff presented Metro’s original request to relocate SCE facilities. The proposed scope of work included excavation and trenching in order to install conduits near the future station on Reeves Drive, Wilshire Boulevard, and

the alley between Canon Drive and Beverly Drive. But after many local business representatives expressed concern about the proposed left-turn restrictions from eastbound Wilshire Boulevard to North Canon Drive, Council directed staff to work with Metro and adjacent businesses to devise a solution to the potential traffic impacts.

After considerable review in revisiting the work and traffic control plans, staff, Metro and SCE representatives concluded that the left-turn restrictions are “required to safely perform the proposed utility relocation work,” according to the staff report.

The proposed work at the June 29 meeting was similar to before, with the added change of limiting the permitted workdays when left-turn movements are restricted to Sunday from 10:00 a.m. to 6:00 p.m. and Monday through Wednesday from 9:00 a.m. to 4:00 p.m., instead of Monday through Friday from 9:00 a.m. through 4:00 p.m.

On behalf of nearby restaurant Spago, attorney Murray Fischer spoke in support of the proposed MOA, but not without raising the question of whether the start of the project will be delayed as Santa Monica Boulevard is currently down to two lanes—a condition where the MOA states no construction work would occur.

“Our goal is to make this happen sooner [rather] than later, with the least amount of impact to our clients, and that message was loud and clear at the last meeting,” said Fischer. “We believe that it’s all been

incorporated in there as long as we have the protections that we need.”

Project Manager Robert Welch responded by saying that Metro has been working closely with staff to keep track of their schedule. “[In] the last conversations I’ve had with staff, we were thinking that the delay may happen at the back end of our work and not the front end,” said Welch.

As it stands, the approved SCE work will begin in late July and take approximately 44 days of construction.

“We have come full circle from day one in terms of working with the restaurants, the hotels, the residents, working on the impacts, working on the timing, working on the schedule, working on the business mitigation, having it be a joint partnership with the City, the clear timeline that is in place now, the fact that there has been clearly a lot of open dialogue—I think tonight, for this one issue, is a success story,” said Mayor Lili Bosse.

Bosse Brings “BH Healthy City” to Annual Conference of Mayors

Last week, the 85th United States Conference of Mayors’ Annual Meeting adopted a resolution recognizing Mayor Lili Bosse’s Healthy City initiative.

The resolution passed unanimously, encouraging cities nationwide to “advance community health and wellness.” It aims to put the focus on creating healthy people,

healthy government, and a healthy community in U.S. cities.

"This conference was especially inspiring," Bosse told the *Weekly*, "because I was honored to be a featured speaker."



The conference—which took place in Miami Beach this year—is a non-partisan organization that brings together may-

ors of cities with populations of over 30,000 to develop policies and strategies.

Every member in attendance is given the opportunity to discuss and then vote on each policy resolution. Each mayor represents his or her city by casting one vote. The decisions made at the annual meetings are ultimately passed on to the elected officials in Washington.

The resolution regarding Bosse's initiative focused aspects like her Walk with the Mayor, S.O.U.L. (Seeking Original Unique Learning) and B.O.L.D (Businesses Open Later Days) programs. It passed unanimously.

Council Approves Funding for Chamber, RDC

Following recommendations from both

the CVB/Marketing Liaison Committee and the Chamber of Commerce Liaison Committee, the City Council approved the 2017-2018 Scope of Work and Funding Request from the Chamber of Commerce and the Rodeo Drive Committee (RDC).

On May 30, the Liaison Committee, consisting of Mayor Lili Bosse and Councilmember Lester Friedman, met with Chamber representatives to review their work plan for business retention and attraction services. It includes the development of new initiatives like a nightlife study to support the B.O.L.D initiative (Businesses Open Later Days), additional support for the Economic Sustainability Strategic Plan update effort, and refinement of the City's support for the Beverly Hills Tomorrow program, according to the staff report.

Additionally, the work plan includes a restoration of the New York Business Mission from a 3-day trip last year to a 4-day trip, and keeping the My Beverly Hills program as a year-round event.

"In order to be able to schedule the meetings and really allow variable time so people can meet, the extra day is suggested because there's a travel day there and a travel day back and you really don't have enough time" said Friedman.

The Chamber funding request was approved at \$252,660—a 14 percent increase to the Chamber's funding agreement from the prior fiscal year.

Then, on June 19, the CVB/Marketing Liaison Committee, consisting of Mayor Lili Bosse and Councilmember Robert Wunderlich, met with RDC representatives

to discuss these programs and the work plan in general.

Subsequently, they recommended Council approve the \$1,500,000 RDC request—a total that will come out of a Tourism and Marketing budget of \$6,421,326.

At the study session, Vice Mayor Julian Gold did note that an education about the relative value of "hits" the RDC events garner. "It would be helpful at some point to understand if there is a translation in terms of dollars and how it compare[s] to what we've traditionally looked at as markers of success," said Gold, who eventually proceeded to express his support of the proposal.

"This is money well spent to ensure the vitality of our city," said Wunderlich of the unanimous approval.

LA County Continues to Develop Community Choice Aggregation

At their June 29 study session, the City Council chose to not yet enter Beverly Hills into the Los Angeles Community Choice Energy (LACCE).

Los Angeles County is currently working to develop a joint powers agreement to implement a Community Choice Aggregation (CCA), a program where local jurisdictions come together to purchase electricity on behalf of the residents, businesses and municipal agencies. The goal is to form a non-profit electric utility that allows residents to buy cheaper, greener electric power if they so choose.

In early 2017, LA County and interested

cities like Rolling Hills and Calabasas developed joint-powers agreement, the LACCE, which would govern the county-wide JPA. The formal creation of the JPA will begin as a six-month window where cities can opt in as "initial participants" in LACCE.

At last week's meeting, though, Councilmember Lester Friedman noted that Council is still in the dark as to what the financial risks would look like if Beverly Hills joined the LACCE now instead of several months from now when they have had time to think it over more thoroughly.

"There's a lot of financial and economic analysis that I would like to look at first," said Friedman.

Public Works Commission Chair Jeff Wolfe said that joining in the first six-month period would mean the City is guaranteed no cost to join, and given the opportunity to play a role in the early decision-making as a part of the joint powers authority board.

"We could lose that opportunity [after the six months]," said Wolfe. "It's just that the terms could change."

But as the financial risk is still uncertain, the City decided to exercise due-diligence by further reviewing the proposal and bringing it back to Council before the six months is up.

Wallis to Premiere "Primo Passo"

Next Beverly Hills to Present "Next Night"

The City Council unanimously supported the Next Beverly Hills' proposal for city sponsorship of its "Next Night" event.

Since its inception in May 2015, the Next

Beverly Hills Committee has dedicated its mission to engaging the City's age 25-45 demographic through platforms that address the economic and civic needs of the next generation.

The very first Next Night, held on August 27, 2016, was a local outdoor block-party festival that brought together residents and over 54 Beverly Hills businesses. The event included a live band, DJ, and food trucks to supplement existing restaurants. It attracted over 2,000 attendees and generated over \$5,000 in beverage sales at the beer garden.

The City spent a total of \$33,959.80 on last year's event. It also received funding from the Chamber of Commerce and Gibson Guitars. The overall cost was \$52,944.80.

This year, with the Council's approval at their June 29 study session, the next event



will include more kid friendly activities, more tables and seating, a larger beer and wine garden, and more "ambiance."

The proposed new budget is \$59,629, which includes last year's budget and key earnings.

"I see this event growing," said Councilmember Lester Friedman. "I think

Planned Development Permit. The applicant proposes to modify the project by reducing the commercial space to 5,696 square feet, increasing the multi-family residential component to 90 units, shifting the areas of building modulation, and changing project access and circulation (Modified Project). Thus, an amended Planned Development Permit is required for the Modified Project. The Modified Project does not include any changes to the maximum height or floor area ratio that were previously approved.

Vesting Tentative Tract Map. The Approved Project included a Vesting Tentative Tract Map to subdivide the subject property and associated airspace to allow for up to 54 condominium units. The Modified Project includes up to 90 condominium units. Thus, an amended Vesting Tentative Tract Map is required for the Modified Project.


The subject project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City has prepared an Addendum to an Environmental Impact Report (EIR) for changes to the previously Approved Project, for which the City certified a Final EIR in 2007. This Addendum serves as the CEQA documentation for the proposed Modified Project. According to Section 15164 of the State CEQA Guidelines, an addendum to a previously certified EIR or Negative Declaration is the appropriate environmental document in instances when “only minor technical changes or additions are necessary” and when the changes or additions do not involve significant effects not discussed in the previous EIR or significant effects that are substantially more severe than those previously examined in the previous EIR. The Addendum prepared for the Modified Project contains an environmental impact analysis that compares the impacts of the Modified Project to those of the Approved Project as identified in the 2007 FEIR. This analysis indicates that the Modified Project would not result in any new significant environmental impacts or any substantial increase in the severity of previously identified significant environmental impacts as compared to the Approved Project. Consequently, the Planning Commission will consider the prepared Addendum as the appropriate environmental document for the Modified Project under CEQA.

Artal Named BHUSD Student Board Member

Incoming Beverly High senior Jonathan Artal has been named the newly-elected student Board of Education member for the 2017-2018 school year.

Motivated by the many challenges currently facing the district—from next year’s budget to the current Metro situation—Artal says he hopes to bring a “student perspective” to the table.

“Very few districts offer a student board member position,” said Artal, “[so] I felt that it would be a great opportunity to not only see what goes on at the administrative level, but also to see how decisions are made and how I can have an impact on the decisions that will shape my educational future.”

Although he was initially a bit intimidated by the undertaking, Artal says he was pleasantly surprised by how much of a voice he’s been given by Superintendent Bregy and the board members.

In fact, at the June 27 board meeting, Artal voted against approving the 2017-2018 budget due to the lack of consensus between the Board and the City regarding the JPA. Although his opposition didn’t count as an official vote, Artal says he was still thankful he got to make his position known.

“The biggest surprise [is] the role that I’m able to play [in more than] just observing, but also contributing my thoughts,” he said.

Artal, who is no stranger to using his voice to stand up for matters important to him, also started a school club called “By Your Side” that aims to help students with special needs. The group meets once a week during lunchtime and pairs up its members with kids who have disabilities. They talk, eat lunch, and work to provide a comfortable environment that allows the kids develop and enhance their social skills.

The idea of “By Your Side” was inspired by Artal’s younger brother, a current student at Horace Mann who has special needs.

“Seeing many of the challenges he’s had to face, both socially and academically, I was inspired to create a club that helps individuals in his position—students who maybe [don’t] have a friend to sit with at lunch or someone they could open up to,” said Artal. “The goal of the club is ultimately

“Beverly Hills: 100 Years, 100 Stories” to Screen at Academy Theater

At their June 29 study session, the City Council unanimously supported a request by director Phil Savenick to screen his film, “Beverly Hills: 100 Years, 100 Stories” at the Academy of Motion Picture Arts and Sciences Samuel Goldwyn Theater for the second time.

The first screening of the film took place in January 2015 at the Wallis Annenberg Center, filling up over 500 seats with several hundred placed on a waiting list.

“The premier was a glorious event for our hometown, because hundreds of our residents are the stars of our story,” said Savenick, who is also a Beverly Hills Historical Society Member. “I would just love to do it again.”

The documentary revolves around the way Beverly Hills has progressed over the past 100 years, honoring the city’s founders, pioneers, and visionaries. It poses no significant fiscal impact.

As part of its agreement with the Academy,

the City is able to use the theater for three events per year between the months of March and December. With reservations for the mayoral installation and ceremony and an annual fundraiser for the Maple Counseling Center, the City has one remaining event use, which will now be “Beverly Hills; 100 Years, 100 Stories.”

“The heart and soul of the community is exactly what this movie is showing,” said Mayor Lili Bosse.

The screening is tentatively set to take place on September 14 and will be free to the public.

Health and Safety Commission Honors Haytayan and Lehrer

On June 26, the Health and Safety Commission presented their monthly Recognition Award to Leon Haytayan and Valerie Lehrer for their contribution to enhancing the health and safety of the Beverly Hills community.

Kathy Davoudi-Gohari Rodeo Drive Committee President

You're currently the General Manager at Valentino. What's it like working for a luxury brand?

It's been an amazing experience, and it becomes a bit of a lifestyle. I spend my entire career, pretty much, on Rodeo Drive. I started working on the street when I was in my late teens. I'm a fashion design major—I went to design school and I thought I wanted to be a designer. While I was in design school I started working on Rodeo Drive, and very quickly I found out that it will take a lot for me to be able to be around this type of quality and this kind of quality. So I decided not to be a designer and to go into selling this stuff and managing stores. It's not just a job; it's actually my passion.

Tell me about why you decided to get involved with the Rodeo Drive Committee.

I'm kind of a vocal personality to begin with, and I'm very passionate about everything. And I have a lot of friends on the street; we are a very tightly-knit group of people. And when you spend as many hours in a day as we all do in our jobs, we feel that we have a role and actually a social responsibility in many ways and we want to help

make it better. Who better than the actual merchants on the street who have a pulse of the latest happenings to be able to influence, change and share what's needed for the street to stay relevant?

What is the mission of the Committee?

There are many different missions. It is a merchant support committee, basically. We have almost around 80 members at this point, and our goal is to hear their needs and concerns, and address them and share them so that we can partner up with different areas of the community. We work with the Chamber, we work with the CVB very closely to be able to combine our resources and to be able to maximize our outcome and our efforts. We are not just looking at Rodeo Drive today; we are thinking of Rodeo Drive ten years, twenty years from now.

In what ways does the Rodeo Drive Committee combine resources with the Chamber of Commerce and CVB in order to maximize outreach?

We have many meetings mutually and

together. They actually attend our monthly meetings also. Right now, my biggest passion of upcoming activities is the B.O.L.D initiative. Basically, us staying open late and being able to create a continued ambiance for the street up until the time the stores are [closed] to create energy, to create a vibe, and to be like where many other luxury stores around the world are, with these extended hours in the summer and



also the holidays. We're planning on doing the same thing for the holidays. So this is a major partnership with the CVB and the Chamber and the City, of course. We're putting all of our resources together, all of our experiences, all of our information, it really helps make things so much easier.

In issue #770 of the Weekly, outgoing Rodeo Drive Committee President Mark Tronstein said "There are other destinations for other people to shop in the city [and] we're cognizant of that. All of that feeds into, 'How do we keep Rodeo Drive relevant? How do we keep it in the forefront?'" What do you think is the best way to do that?

I think it's a combination of things. In the past weeks, I've been asked "What do you think the danger of online shopping is?" And obviously there are times where I buy things online. But I have categories of what I can actually buy online effectively and what I trust to buy online. I think what sets us apart is [that] we are a group of professionals with some of the most amazing brands that are world renowned. The experience you get on this street is not something you can ever get from a computer. In the luxury business, you might be able to find a shoe or a bag online that you feel comfortable with because you're comfortable with your size, but would you feel comfortable buying an expensive gown online, without trying it on? How much better would

your experience be if you had a store and you had an associate that would honestly tell you if the gown was not so pretty on you or was able to find you something season after season? So the reality is that we have a very, very close-knit community that supports our businesses. They shop local, they support us, and it's a relationship.

What have you learned from Mark?

Mark is an amazing individual. We have a lot of things in common and a lot of things that are very different. I've learned from him to listen more and to really concentrate and look into the future. I have been his Vice President of Special Events

during his term as president and we've been working closely together for a few years now. Really, again, [he's taught me about] looking not just into what we need now, but what the needs are for the future: social media, experiences, how to use influencers, how to use social media in a proper way that actually builds credibility for the brand and the street, and is able to show the world what we're really about. If you look on our website, we did an experiential "Flowerbox". It was basically really pretty spring flowers—you would go stand inside this box and there was a hashtag [that] said something like #OnlyOnRodeo. My twelve-year-old asked me, because she had seen it on her friend's Instagram account, to go and take a picture in the Flowerbox. We want to make sure people understand how accessible and welcoming we are, and how we are one big happy family.

Tell us about your family.

I'm married. I have two daughters—a twelve-year-old [Celine] and a fourteen-year-old [Chloe]. I call them "retail daughters" [because] for their entire life I've been working on Rodeo Drive. Actually, for their entire life I've been working for Valentino! So they're probably [some] of the very few children who don't complain that their mom goes to work every day.

What are your main goals for the future of the Rodeo Drive Committee?

Our immediate goal is this B.O.L.D program. [The whole committee] really would like to see Rodeo Drive evolve into a livelier evening environment. And I'm not talking about midnight hours, but at least slightly later hours to be able to cater to our afternoon and evening shoppers. We by no means think that we're ever going to be a mall. We're not a mall; we're not a shopping center. We are absolutely an experience; however we'd like to also offer the convenience for our out-of-town visitors, or people who work and want to go shopping in the evening, or people who are having an early dinner and are strolling down the street. I want

to be able to do this myself if I'm ever in the neighborhood in the evening hours, so the B.O.L.D program is pretty important. Also, many merchants here have truly put [in] many years. I've been on the committee for around two decades now. But I'm not alone; there are many, many people who have been involved in so many different aspects. They've brought relationships and experiences and ideas into this committee. We are fortunate enough to have this kind of association where we are able to impact our street. So, the future is getting my twelve and fourteen-year-olds to feel comfortable with shopping on Rodeo Drive.

CHECKING IN WITH THE CHAMBER

Incoming President Jennifer Kullmann on what's ahead for Beverly Hills business

Your background is in entertainment management. Tell me about that.

Yes. I am Chief Operating Officer and Chief Financial Officer for a talent agency called the Gersh Agency. The agency was founded more than 70 years ago by Phil Gersh. His two sons now run the agency. We represent actors, writers, directors, comics, theater—those are probably the biggest areas.

Talent agencies rarely have officers in the Chamber, so what made you want to get involved?

A friend of mine was involved with the Chamber. She started bringing me to a few events, and I really enjoyed it. She told me that the entertainment industry didn't really have any presence at the Board level, so she took me in to meet the then-head-of-the-Chamber and a couple of the Board members on the Executive Committee and they decided that I would be a good complement to their existing Board. I pretty much immediately started getting involved and chairing

the Beverly Hills Tomorrow event, which obviously made sense—to have someone from entertainment chair an event that's about entertainment. So I've done that for three years, and I also took on the Treasurer role when Mark Wolfe became Chairman of the Board.

Do you have a strategy for attracting new businesses and retaining existing businesses in Beverly Hills?

Yes, we have quite a lot. One of the

most important things is that we feel like we throw amazing events and amazing programs. Some of them are standing room only, but others have empty seats. So what we really want to do is make sure that our events are attractive to all the members, so that they can come and enjoy them and be a part of them. Two, in this next year we've got quite a bit of competition cropping up around us with Westfield, Century City, and the new Beverly Center. The mayor has been talking about her B.O.L.D initiative, and we as the chamber are wholeheartedly supporting her in that and feel that is a really, really important initiative for us in the next fiscal year. It stands for "Businesses Open Later Days" and the concept is to have all of the retailers and the restaurants stay open later, until 8:00 or 9:00 p.m., during the month of August during Thursdays, Fridays and Saturdays

to help keep people in Beverly Hills shopping in Beverly Hills. There's a component of it, I believe, that is also around the holidays. What we as a Chamber really need to do is obviously embrace this

program but then also keep it alive and keep it going beyond August and beyond the holidays.

You were sworn in last Wednesday. What issues are currently facing the Chamber that you're working to address?

It's really getting to know our members even better and trying to figure out why they first got involved with the Chamber, what their expectations were early on, and how

the Chamber has fulfilled them or hasn't fulfilled them. It's trying to really understand what's important to our members and make sure that we can deliver that, because we have had drops. I mean, there's a natural amount of drops when businesses unfortunately close or move out of town—they're economically driven. But then there are the others which are ones where people just didn't want to pay their dues again, so that's a real focus for us. And to try to create some mentoring programs between existing members and new members, so that we get more information and we figure out how we can ideally have zero attrition, or at least zero voluntary attrition.

In our interview with outgoing Board

Chair David Haimovitz in issue #873, he said "We're looking at using social media and marketing to help the communication here in the city, [because] social media is one of the ways we can reach a more diverse business community." Is this something you want to continue to utilize?

Absolutely. 100 percent. Our internal marketing people, under the guidance of Charles Black, have developed an outstanding measurement recording so that literally every month at the Board meeting we look at all of the main social media platforms; we look at all of the metrics around all of them. We're putting a lot of effort towards really trying to extend our reach in social media. At the Beverly Hills Tomorrow event, a couple of young social media influencers were there as panelists: Jacob Jonas and Amanda Cerny. That was very well-received by our audience. We also want to use our existing network to market to expand our reach at our events to the next generation.

What are some things you've learned from David?

I think he's been an amazing leader, he's been very thoughtful, very committed, very organized, and the things he set out to accomplish, he accomplished. He was really dedicated, always positive and I feel like he put some structure in place that I think will make my transition a lot easier. He's also made himself 100 percent available to me to try to show me the ropes before I actually have to take the ropes for myself. So he's been absolutely terrific and always available whenever

I have questions. And I think he's really committed to staying committed and continuing to be very involved and very much a leader within the organization and the city.



Tell us about your family.

I'm married. My husband is Jason Weinstein. We live on the Westside in Venice. We don't have any

kids. I'm from Atlanta—my parents and sister live there. I have 13 nieces and nephews, most of them are on my husband's side. And my nephew is actually coming out to California to go to college.

What are your goals for this upcoming year?

My goal is for the Chamber to embrace change. There's a lot of change coming. We've already talked about the competition, the B.O.L.D initiative, but we've got a subway coming through, we've got construction happening that's hampering peoples' ability to get in and out of the city, so I just want us as a Chamber and as a community to really embrace this change and turn it into something as positive as
