## “Rent Stabilization Ordinance”

AN OPEN LETTER TO THE CITY COUNCIL:

I have written two prior letters voicing

my opposition to the City’s rent stabilization ordinance. My wife and I are the owners of a 4-unit apartment building in Beverly Hills, which is our residence. As outlined in my previous letters, as a rental housing provider in our City, I am completely against the rent stabilization ordinance. Not only is rent control bad for me personally, but the City’s ordinance will have long and lasting negative consequences in our City.

Unfortunately, none of the members of our City Council, nor any of the City’s staff that has helped to craft the rent stabilization ordinance actually own rental housing, and are clearly not qualified to craft a rent stabilization ordinance. In a purely political move, our City Council has turned an emergency ordinance into a permanent ordinance. As a small, one location rental housing provider, I am being overwhelmed with regulation, forms, and my income, property value and ability to maintain my property will all suffer.

Our City Council instituted the rent control ordinance in such a hurry, no one ever stopped to ask some basic questions:

- Who’s really going to benefit from the City’s rent control ordinance?
- What’s the cost of implementing and maintaining the rent control ordinance?
- How will success be measured so that the effect of the City’s rent control ordinance can be measured over time?

Unless there is a means to actually assess the financial needs of the City’s renters,

the law of unintended consequences will result. Young, healthy, successful professionals will benefit by receiving cheap rent, and rental housing providers will see less income and have difficulty maintaining their properties. Rent control should assist the fixed income seniors or others in financial need within our City that can demonstrate a proven need. Rent control should not serve to benefit the young, healthy professionals in our City such as rent control advocate, Mark Elliot, who probably just wants a break on rent so he can afford to buy a new, high end bicycle and more expensive biking vacations. As Margaret Thatcher, former Prime Minister of the United Kingdom once said: “The trouble with Socialism is that eventually you run out of other people’s money.”

The costs of the rent stabilization ordinance are slowly becoming clear. Within a recent City Council agenda package, the City’s consultant, Management Partners, reported the preliminary estimate of the rent stabilization program costs for the next two years. The start-up and one year costs are expected to be \$1,492,200 of which \$250,000 has already been appropriated. The fiscal year 2018-19 costs are expected to be \$1,649,200. However, what is not included in these estimates are the cost impacts within other City departments and the resulting allocation of these costs. In actuality, the true cost of the rent control ordinance will be north of \$2.0 mil-

lion per year!

Other than the success of rolling back rent increases and making themselves feel good with my money, our City Council has not even contemplated how to measure its success. But, unfortunately, what we will see is guaranteed failure. Over time, there will be less turnover of apartments, therefore less opportunity for young families to move into our City. Less families moving into our City will negatively impact our schools. Rent control lowers property values, which will result in lower property taxes. Less families, and less basic aid providing property taxes will ultimately negatively impact our schools, which will ultimately have an adverse impact on all property values of and property tax revenue from both rental housing and single family residences.

Yet, my opinion expressed here is only the opinion of a small, one location, rental housing provider. But, there are numerous, sophisticated economic studies supporting my anti-rent control argument.

In its 2003 study, “Rent Control and Housing Investment: Evidence from Deregulation in Cambridge, Massachusetts” sponsored by the Manhattan Institute, M.I.T. economist Henry O. Pollakowski concluded that “...when price controls (rent regulation) are imposed on housing stock, housing quality declines over time because landlords are unable to recoup their investment and routine maintenance

## Rent Stabilization Expected to Cost \$1.4 Million—Year 1

Although they made no formal decisions because Councilmember John Mirisch was out of the country, the City Council discussed on July 18 the Rent Stabilization 2017-2018 Budget, whose start-up and one year costs are projected at \$1,492,200.

The agenda item—which has already been appropriated \$250,000—outlines a proposal that includes a staffing plan, program costs, and action plan for the program.

The discussion comes after an approval of an “urgency ordinance” earlier this year that requires a registry of all multi-family rental units in the City and outlines provisions for protection of tenants including a three percent cap on annual rent increases and relocation fees for no cause evictions. The program was implemented to adminis-

sions for protection of tenants including a three percent cap on annual rent increases and relocation fees for no cause evictions. The program was implemented to adminis-

ter these provisions.

The City then entered into an agreement with Management Partners to assist with enhancing the ordinance. They iden-

tified four major program support categories: program management, communication, legal and administrative hearing services, and enforcement. This includes the need for eight full-time equivalent positions for the program.

Although Council did not take formal action, they did open up public comment, where several people expressed their concerns with the ordinance.

Landlord Gary Wiest argued that the three percent

increase cap is illogical and with upcoming repairs to the almost 60-year-old apartment building, “will likely sink us.”

“A ten percent maximum allowable rental

costs.” Once deregulated, the study concluded that Cambridge, Massachusetts experienced a tremendous boom in housing investment, which led to “major gains” in housing quality, which would not have otherwise occurred. The study further noted that these investments, or “investment boom” occurred across both affluent and modest income neighborhoods.

In a 2015 Manhattan Institute commentary paper, “New York City Would

Be Better Off Without Rent Control,” author and economist, Howard Husock, noted that New York City, which has had rent controls for 7 decades, experiences the lowest housing turnover of America’s 10 largest cities. Mr. Husock refers to New York City as the “frozen-city” noting “regardless of their capacity to pay a higher rent, households protect their good, rent-regulated deals even if they no longer need the space.” Mr. Husock further notes:

“...more turnover would open NYC’s housing market to newcomers, blunting the

notion that the only way to accommodate a growing population is to build more subsidized housing that few tenants ever leave. Further, as more housing came on the market, upward pressure on market-rent costs would be reduced, as supply better adjusted to demand. In short, deregulating NYC’s housing market, notwithstanding potential disruption to some rent-regulated Manhattan tenants, would immeasurably improve it.”

Somehow, New York City always suffers from a severe housing emergency. To this, Mr. Husock asks the question: “Could it be that current law is to blame?”

In the Journal of the American Institute for Economic Research’s study, “Rent Control: Do Economists Agree?,” 76.3% of economists surveyed “generally agreed” that “a ceiling on rents reduces the quantity and quality of housing available.” Another 16.6% of economists surveyed “agreed with provisions” to this statement. Overall, more than 90% of economists surveyed agreed that rent control is detrimental to both housing quality and quantity of available housing. The Journal of the American Institute for Economic Research’s study also notes that rent control “...creates an incentive to stay in the same apartment, which leads people to remain in the same apartment even if their tastes and conditions change.” As a result, rent control causes housing shortages in addition to other adverse consequences such as “discrimination, quality deterioration, substitution of tenant for landlord maintenance...finder’s fees, side payments and bribes...” In comparing the cities of Chicago and New York, the study further notes:

“It is hard for the casual observer not to notice the difference in the supply of new construction for rental purposes in Chicago (which is very much a non-rent controlled city) and New York City (which has among the most Byzantine and volatile rent control rules). Chicago’s lakefront is dotted with apartment buildings built after World War II for rental purposes. New York’s Upper East Side is filled with one-

time rental buildings that were gradually turned into cooperatives and lacks new rental buildings despite the fact that technically these buildings would be free from rent control.”

Rent controls are just another form of price controls. Unfortunately, our City Council is under a misguided opinion that these price controls will somehow protect tenants from extortion and exploitation without hurting landlords or housing supplies. Yet, the negative effects of the rent control ordinance will become far worse the longer it remains in place. Incentives to build new housing will or the ability to maintain the City’s 70-80 year old rental properties will become non-existent. As the costs of operating rental housing increase, the level of rents will result in shrinking returns for rental housing providers, which will then have trouble remodeling and/or maintaining their properties. As a result, property conditions and values will decline, property tax revenue will decline, and revenues of both our City and schools will decline.

The City rent control ordinance is a blatant injustice that is being imposed on our City’s rental housing providers like me. Our City Council, none of which has actually taken the risk and invested in multi-family rental housing, has literally thrust their hands into my pockets to subsidize tenants, many of which are not in need of financial assistance and many of which are far wealthier than my wife and me. If our City Council’s heart bleeds for the City’s tenants, I urge our City Councilmembers to contribute their own money to rent subsidies in order to assist those who they perceive are the “true” needy within the City of Beverly Hills. After all, as the author Terry Goodkind once said in his book the “Pillars of Creation,” “Charity, if you have the means, is a personal choice, but charity which is expected or compelled is simply a polite word for slavery.”

rate increase is reasonable and has worked for many years in Beverly Hills,” said Wiest. “Please don’t change it now.”

Most people agreed, though, that mediator Professor Sukhsimranjit Singh’s facilitated dialogue sessions have been helpful in pushing landlords and tenants to reach a compromise. The last session was held on July 25 at Roxbury Park from 7:00 p.m. to 10:00 p.m.

A vote on the item will take place on August 8, when Mirisch returns to the U.S.

### Architectural Commission Discusses 100 North Crescent Project

At their meeting on July 19, the Architectural Commission heard a presentation regarding the remodel of Beverly Hills Media Center on 100 North Crescent Drive, also known as the “Real D” building.

Located on the northeast corner of Wilshire Boulevard and North Crescent Drive, the building will receive the addition of two new floors and new landscaping. The existing building was designed by

Master Architect Gin Dan Wong.

In the presentation, Gensler CEO Andy Cohen outlined the project aspirations. Among the proposed modifications to the Media Center are a new glass wall system, a cappuccino bar, and public space for art shows on the ground floor.

“The idea is to get ten-

ants to experience the ground floor,” said Cohen.

More specifically, the project will include metal and wood louver panels, a glazed curtainwall system, poured-in-place concrete accents, rooftop terrace with landscape features, laminated glass balcony enclosures, and building identification signage.

However some residents are opposed, arguing that the proposed project design includes elevations that will offer no privacy to the entire east side.

“We have people looking into our backyards, we have people looking into our living rooms, we have people looking into our bedrooms,” said North Rexford resident Dora Arash. “They have completely left that off and I think that’s very important.”

Ari Bussel, a resident who previously called attention to a defective notice regarding the project, has also expressed his opposition to the project in general.

“The process is absurd, as it misleads us and creates a wrong impression that it is permissible to build higher and more densely and to ignore the General Plan,” said Bussel. “It is also very costly, for limited City resources are focused on something that should not even happen, resources that are better spent elsewhere.”

Because the Architectural Commission doesn’t have purview over the specifics of the project, they offered a preliminary review solely of the outside facade, providing the applicant with design feedback as the project moves into its next stages. Though expressing her love for the “fluidity” of the proposed rotunda, Commissioner Sheri Hirschfeld also commented that the

grid on the ceiling is too defined and doesn’t “speak to the circular nature.”

“A linear pattern, to me, stops the eye from that more organic shape,” said Hirshfeld.

Following these recommendations, next month the project will move to the Planning Commission for consideration.

### Sexual Battery Suspect Arrested

On July 21 at approximately 8:30 p.m., the Beverly Hills Police Department arrested suspect Joshua Daniel Stevens, 26, of Culver City for an alleged series of assaults he committed the night before.

Between 6:00 p.m. and 10:00 p.m. on the 200 block of North Rodeo Drive, 400 block of North Canon Drive, and the 9600 block of South Santa Monica Boulevard, Stevens allegedly approached several female victims and made physical contact by grabbing them.

They each were able to retreat from the suspect and sustained minimal or no physical injuries. According to a press release from the BHPD, “the preliminary investigation indicates the suspect’s motive may have been sexual in nature.”

A citizen promptly called police after observing a person matching the suspect’s description walk-



ing in the area: a white male of 20-30 years, 6’0” with a thin build, and last seen wearing a white long-sleeved shirt with black lettering, dark gym shorts, red tennis shoes and a dark baseball hat. Stevens was ultimately arrested based on his strong resemblance to the surveillance video captured at the time of the crimes.

Stevens is currently being held without bail and scheduled to be arraigned on July 25 at the Airport Courthouse.

### Temple Emanuel Hires New Rabbi to Run Day School

Temple Emanuel has announced Rabbi Educator Adam Lutz to spearhead the Religious School and Lifelong Learning program.

Having received a Bachelor of Science in Aerospace Engineering from the University of California, San Diego, and a Master of Science in Engineering from the University of California, Los Angeles, Lutz worked for three years as an aerospace engineer focused on Navy planes on Coronado Island.

Rabbi Lutz’s expertise and progressive approach to problem-solving and technology, meet the needs of the 21st Century, offering human-centered and holistic methods as meaningful alternatives to classroom learning.

“As a rabbi I believe it is my obligation to lead with the heart, to reach out with compassion and empathy, and to help others do the same,” Lutz.

### AKA to Install Building Identification Sign

At their meeting on July 19, the Architectural Commission conditionally approved a request for AKA to install a building identification sign on the back of its building.

The request originally asked for a 94.1 square foot sign on the western elevation of the building along parapet of the building and would have been highly visible from Wilshire Boulevard.

The Commissioners, however, felt the proposed size was too large and that shrink-

ing it a bit would make it more “tasteful.”

“I would scale it down a bit,” said Commissioner Sheri Hirschfield. “I understand what you’re trying to accomplish; it just feels a little bit aggressive.”

But Commissioner Andrea Apatow wasn’t receptive to the entire idea at all, stating that it seemed as though AKA simply wanted to increase their advertising because they were the “bigger guy.”

“It just doesn’t feel authentic to borrow the air space of other [stories],” said Apatow. “It’s not on their street. It seems like someone had a clever idea of getting more exposure. I just don’t think that it’s appropriate.”

Eventually, the commission and applicant settled on a resolution to reduce the signage by 30 percent and shift it closer to the south by the balcony area.

### Public Works Launches “Your Dollar\$ At Work” Campaign

The Public Works Commission discussed an update of the new outreach campaign, “Your Dollar\$ At Work” at their meeting on July 24.

The campaign was created in order to regularly provide the community with information on where and how its tax dollars and utility rates and charges are being used as part of the Public Works Department’s ongoing efforts to enhance the City’s infrastructure.

It will be used to provide information about various aspects of the Department’s operations and capital investment projects with the intention of creating brand awareness around investments the City is continually making within the community.

Although icons have been chosen for the seven largest functions for Public Works,

Commissioner Joshua Greer said perhaps a different logo should be chosen for parking.

“[It] looked like electric vehicle. I didn’t quite understand that meant parking,” said Greer. He also noted that the one for waste water looked like it was missing a roll of toilet paper.

The five other most identifiable areas include water, stormwater, solid waste, streets and street lighting, which the commission fully supported.

Staff will now present this new program to the City’s branding committee during its next meeting, likely in August.

### Beverly High Students Participate in Cedars-Sinai Research Week

Nineteen Southern California high school students participated in Cedars-Sinai’s sixth annual Research Week, two of which are Beverly High seniors.

## ART TALK

### The Weekly's exclusive interview with Fine Art Commission Chair Michael Smooke

#### What inspired you to apply for the Fine Art Commission?

I've always been interested in art. When I was in college, I was an economics major, and then I went to law school. I realized, not too long after graduation, that I remembered virtually nothing about my economics [classes], and I remembered virtually everything about my art history [classes]. The writing was on the wall, so to speak. When I returned to Los Angeles after law school, my wife Terri and I would go on the Monday night gallery walks on La Cienega Boulevard, which at that time were quite influential in the art scene. We also used to spend a lot of time at the

Los Angeles County Museum of Art (LACMA) looking at their collection, so we were well on our way. While I was at LACMA we found out about a group called the Modern and Contemporary Art Council, which acquired art from young artists—the requirement was without gallery representation—and donated those works to the museum. At that time the museum had seven councils, each supporting a different segment in the museum. There was an Ancient Art Council; there was one council that was a service council that provided opportunities for people to work at the museum in service positions like helping at the check-in stands and so forth. Each one of these councils provided ways for people to be involved but those were venues to purchase work for the department that that particular council was supporting.

We spent a lot of time at LACMA and I became the Chair of the Modern and Contemporary Art Council, and some time after that I was asked to become a member of the Board of Trustees of LACMA. So it's been an enjoyable path and our lives have been rather focused around art.

#### You've been on the LACMA Board for over 20 years. Tell us about that.

I think I'm the longest-sitting Board member at the museum at this point. My father was very involved in the arts and he was on the Board of Trustees before me. There's been a Smooke at the museum for quite some time. That experience is very apropos for the Fine Art Commission in the sense that we're dealing with the public and for the public, and dealing with art and dealing with the installers and all the people it takes to run an art institution.

#### How did those experiences prepare you for your role on the Fine Art Commission?

A lot of my prior participation is very similar to what we do on the Fine Arts Commission. We have a staff, which is phenomenal, we have an administration, we acquire art for the institution, and I knew nothing about this until my wife became a Fine Art Commissioner and I was able to see what she was doing. I said to myself, "Boy, that's really interesting. I would like to do that too." So after her term was up I waited a term or

too [and then] applied. I was fortunate enough to be selected to be on the Fine Art Commission, and virtually all of the involvement that I've had up until this point fits very well with duties of an art commissioner for the City.

#### In our interview with former Fine Art Commission Chair

Sandy Pressman in issue #752, she said, "Art is a conversation. It really is an emotion. It doesn't matter if it's settling or unsettling, positive or negative; it's always a thoughtful conversation." What goes into the decision-making process of what pieces you bring to the City?

For me, what it involves is, "Do I feel like I am responding to the piece, the piece is responding to me?" Perhaps the best that I can give you is that I had purchased a work of art one time and a curator said to me, "When you walk by that work of art in the morning after you get up, do you still look at it?" And I thought that was a very powerful statement. What's really important is your reaction and interaction with the work. Is there communication that will last? And certainly in the case of public art for the City, it's going to be there forever so a great deal of care must go into selecting work that's going to be there forever.

#### What public art piece are you most proud of having obtained for the City?

That's kind of like asking me which one of my children I like the best. I would say right now it would be the Kentridge, and if you had asked me a couple months ago I would have said the Bove. So it seems like [my favorite] is always the most recent].

#### What's the latest status of Yayoi Kusama's "Hymn of Life," which the commission has spent quite a bit of time on?

Right now the Fine Art Commission staff is in talks with the Kusama representatives with regard to what kind of restoration needs to be done to bring

the piece up to the standards of strength that it should be. There seems to be a lot of conversations about what is the best way to do that. The Kusama is one of the highlights of the collection and the commission is going to take every step possible to ensure the piece will be there for the long haul.

#### What is the Fine Art Commission currently working on?

Yeah. I'm not sure I want to mention anything in particular in case it goes a different way but we've got all the top experts anyone could possibly have working on it. Kusama always has a

group of people standing around it. It's very popular. We want to make sure we keep the piece and keep it in proper condition.

#### Tell us about your family.

[My wife] Terri was a Fine Art Commissioner, and had she not been a Fine Art Commissioner, I may never have heard about the position. So she's probably directly responsible there. We have two daughters [Stephanie and Ellen], both of which were art history majors

in college. Now one's a doctor and one's a lawyer, which is kind of unusual for art history majors. Each of our daughters is married and they each have two kids, so I have four grandchildren. That makes me a happy guy.

#### What are some of your top priorities as Chair?

Top priorities at this point are the preservation, protection and conservation of the works that we have. [I want to] make sure everything is properly maintained and protected, and to find and acquire world-class art for the city. Beverly Hills is a world-class city; it deserves to have world-class art. It should have world-class art. And it should be known for having world-class art.
