# Council Approves Rental Registry

The City Council unanimously approved the details of the rental registry program at their meeting Tuesday night, but not without landlord resistance.

The decision follows the Council's direction to staff on September 5 regarding the registration process, thus setting forth the rent certification process. The regulations set forth the deadlines by when registration and re-registration are required.

More specifically, the Council confirmed that landlords should provide the rent that is being charged for each of their rental units as part of the registration process. They also determined that the number of bedrooms and bathrooms is more important to the City than the square footage of the units.

The regulations are separated into two chapters. The first specifies the information that landlords are required to provide as part of the registration process. If they feel inclined, landlords may provide approximate square footage of each rental unity.

Landlords are also not obligated to gather information about the tenants of the units, which is relevant to the amount of any required relocation fee.

The second chapter establishes the new rent certification process, including an appeal process by which a tenant may object to the rental amount initially provided by the landlord.

It also establishes the process that the City must adhere to when certifying rents after the initial certification process has been completed. This includes appeals from certified rent levels and deadlines for the City and parties.

At public comment, several people spoke in opposition of the agenda item. Landlord Harvey Miller expressed frustration regarding the reduction from 7 percent to 3 percent. "7 percent is a fair and reasonable number, and a good compromise," he said.

Miller argued against the validity of the alleged emergency basis on which the Rent Stabilization Ordinance was enacted, requesting that the Council delay making a decision on the registry until public documents he requested have been returned.

Additionally, Miller requested that the Council seek expert advice on rent control. At deliberation, Mayor Lili Bosse stated that the Council would indeed make the topic of hiring real estate experts an agenda item at a future meeting.

While Miller said the landlord group is "pleased" with the Council's decision, he also stated that he wishes it would have been done prior to the enactment of the ordinance. "They would have been given the guidance and information that they now obviously need."

According to the staff report, there are no significant fiscal impacts arising from the adoption of the regulations and are "within the budget that the City Council approved."

The approved budget, which is over \$750,000, currently allows for six tem-

porary positions—three to perform analytical work, two to address customer service needs, and one to provide clerical support.

# Council Passes Smoke-Free Multi-Unit Housing Ordinance

At their meeting on September 19, the City Council approved an ordinance that will ban smoking in multi-unit houses.

The decision follows Council's initial request in August 2016 to pursue a policy that would expand smoking regulations in multi-unit housing.

According to a 2010 report from the Los Angeles County Department of Public Health, approximately 8 percent of the Beverly Hills adult population smokes. A smoke-free multi-unit housing policy in the City could impact up to 63 percent of the housing stock.

The Council asked the Health and Safety Commission to review the issue and report back with findings and recommendations.

Then, on June 26, the Health and Safety Commission voted 3-1, with Commissioner Myra Demeter dissenting, to recommend an ordinance that would regulate smoking in multi-unit residencies. The City Council Health and Safety Commission Liaisons discussed the ordinance and regulations on July 27, where Mayor Lili Bosse concurred with the recommendations.

The ordinance will prohibit smoking at apartments and condominiums in all indoor and outdoor common areas as well as private enclosed spaces and private outdoor spaces.

There will be a one-year phase-in period for units with existing leases and a two-year phase-in period for condominium units.

"I think we did a marvelous job and I'm very proud of it," said Health and Safety Commissioner Myra Demeter at the meeting.

At deliberation, the councilmembers discussed whether or not to shorten the phase-in period for condominium units to one-year before expressing support for the proposal.

"I want to thank our commission. Twelve meetings on this item is huge. Very few issues in our City require that," said Mayor Lili Bosse. "But what it also shows is how much time [we] put into it. This was not done in haste—clearly."

# Council Opts to Retain Bove Sculpture Amidst Controversy

After a lengthy discussion on Tuesday night about whether to return Carol Bove's IO sculpture to the Zwirner Gallery the City bought it from, the Council decided to retain the sculpture.

Not even a month after its installation in September 2015, the sculpture began to see significant scuff and scratch marks. In October, the fabricator provided two cleanings, and the City found that any future cleanings would amount to approximately \$1,000 monthly.

After the City's art conservator proposed to restore the piece for \$24,000, staff recommended to Council that the best option would be to return IO to the gallery and obtain nearly a full refund (minus the \$20,000 design fee).

But at the meeting, Commissioner Alan Kaye noted that the piece, originally purchased at \$200,000 has absolutely appreciated in value—perhaps from 10 to 30 percent. He stated that the Fine Art Commission—who was in full attendance—is "100 percent" behind retaining the piece as Bove is "an artist of incredible importance."

"All outdoor sculptures require maintenance, frankly," said Kaye. "The Bove piece will require more maintenance than initially anticipated, but not so much that it should be discarded."

He also noted that with artist and deinstallation fees, the City would lose approximately \$60,000.

During the question period,

Councilmember Robert Wunderlich asked if there was any way to ascertain that the scratches were indeed from humans rather than atmospheric degradation, to which Fine Art Commission Chair Michael Smooke said that the sculpture showed clear black streaks that could only be created by wheels.

Smooke added that many of the commissioners have seen skate-

boarders playing on and jumping off of the piece.

Councilmember John Mirisch expressed frustration that the gallery had not been more cooperative in resolving maintenance issues, going as far as to say that the City should never work with them again.

"I don't understand why the gallery isn't more receptive to finding a more permanent solution," said Mirisch. "It really bothers me I have to say."

Ultimately, the Council approved 4-1 with Mirisch dissenting—Mayor Lili Bosse's suggestion to lift the piece up from the ground and add signage around it that would prohibiting visitors from touching it.

# Planning Commission to Hear 9200 Wilshire Blvd Project Modification

During a special meeting early next month, the Planning Commission will hear a new iteration of a previously

approved Planned Development Permit on 9200 Wilshire Boulevard.

The hearing will follow the commission's denial of an application to modify the building at their July 13 meeting.

The original permit allowed the development of a six-story mixed-use building that consists of ground floor retail uses and 54 residential units above. The modified project would have added an additional 36 residential units.

It also would have reduced the amount of ground floor retail space, shifted the building modulation, changed the site circulation, and removed one level of subterranean parking while increasing the total number of parking spaces on site.

Several neighbors—citing a potential increase in traffic and crowding as perhaps the biggest concerns—spoke against the project, including Julia Joseph, Anne Markowitz, and Board of Education member Noah Margo on behalf of himself and his wife Laura Hornwood Margo.

"Adding density to our community is wrong. Bigger is not always better," said Margo at the last meeting. "When are we going to admit that we don't need bigger homes, that gluttony should not be celebrated?"

At an Ad-Hoc Committee meeting on July 27, the applicant proposed a modified design that would have reduced the number of residential units from 90 to 84. After further consideration, the applicant reduced that number even further to a once-again 54 residential unit project with further commercial space.

The evening meeting will take place on October 3 at 7:00 p.m.

# **Board Reviews 2016-2017** School Year Performance

At their meeting on September 12, the Board of Education discussed and reviewed the 2016-2017 school year. Following the release of California

Assessment of Student Performance

and Progress (CAASPP), Assistant Superintendent of Educational Services Dustin Seemann presented a PowerPoint that highlighted the data.

The presentation showed data from math scores to English/ Language Arts scores, to Advanced Placement

(AP) scores, to SAT/ACT scores. It also offered a list of goals for the 2017-2018 school year.

CAASPP data showed that the percentage of third grade students who met or exceeded the English/Language Arts portion was 73 percent at Beverly Vista (an increase from 63 percent in 2015-2016), 78 percent at El Rodeo (an increase from 73 percent in 2015-2016), 75 percent at Hawthorne (an increase from 73 percent in 2015-2016), and 55 percent at Horace Mann (a decreases from 75 percent in 2015-2016).

Additionally, the percentage of third grade students who met or exceeded the math portion was 77 percent for Beverly Vista (an increase from 74 percent in 2015-2016), 91 percent for El Rodeo (an increase from 83 percent in 2015-2016), 81 percent for Hawthorne (an increase from 76 percent in 2015-2016), and 71 percent at Horace Mann (a decrease from 74 percent in 2015-2016).

At Beverly High, CAASPP data showed that 86 percent of 11th graders met or exceeded the English/Language Arts portion (the same percentage as in 2015-2016) and 62 percent of 11th graders met or exceeded the math portion (a decrease from 65 percent in 2015-2106).

For the SAT, Beverly High students averaged a reading score of 569, a math score of 587, and a writing score of 590. They also averaged a composite ACT score of 26.1, compared to the California average of 22.6.

"That's why we're getting students into such competitive institutions," Seemann said of this number.

Finally, he presented several goals including increasing CAASPP scores of students meeting/exceeding standards by a minimum of 5 percent annually with the overall goal of reaching/maintaining 80

# Saban Theatre to **Amend Memorandum** of Agreement During Construction

With the City Council's September 19 approval, the Saban Theatre will now amend its Memorandum of Agreement (MOA) between the City and Metro for the construction of the La Cienega Subway Station.

The Saban Theatre has requested eliminating a requirement to install a temporary twenty-foot tall sound barrier adjacent to the Theatre during certain street decking operations nearby; and suspending construction work the weekend of November 11 for a special filming event, which Metro has expressed agreement with as long as Council offers an alternative weekend.

The sound barrier requirement was negotiated specifically for the Saban Theatre in order to prevent decking-related noise from affecting performances. The theater has expressed concern that the wall will create an aesthetic and operational hindrance during performances.

But the Saban Theatre said in a letter that the construction during a concert "will likely not exceed heritage rock shows in the theater." It also stated that the additional space required to erect the sound wall will "even further reduce the already diminished area for ingress and egress for patrons and will cause a negative guest experience."

"While we appreciate the City's good intentions putting the sound wall into the MOA as an intended extra precaution to protect the Saban Theatre, it isn't effective or helpful and it actually hurts us," said Saban Theatre representative Lance Sterling.

The weekend work suspension and allowing Metro to skip the weekend of November 11 may extend the work by at least one week. Staff recommended that the Council allow Metro to close Wilshire Boulevard on the weekend on January 15, 2018 (Martin Kuther King, Jr. Day weekend) instead of working on November 11.

According to the staff report, "this

would keep the project on schedule in order to minimize impact on the community.

The Saban Theater isn't the only place that has been affected by Metro construction. In April, Hot 8 Yoga owner Vincent Nicoletta applied for additional signage for his business, arguing that the Purple Line construction has impeded people's view of his business and certain entrances.

At Tuesday's public comment, several residents expressed frustration regarding noise and parking problems near the theatre, stating that it's not a Metro issue but a theater issue. Resident (and landlord) John Luca presented a slideshow with pictures and videos highlighting the problem, and asked the Council to assuage resident frustrations by implementing a noise curfew or tightening parking enforcement.

"This is not the Staples Center; it's a community theater but is being run [as though] it's the Staples Center," said Luca.

Although the commission ultimately approved the agenda item, they also directed staff to maintain contact with the residents so as to alleviate the problem as much as possible.

"Everybody is on the same page in terms of a goal, so we need to achieve that goal," said Mayor Lili Bosse. "I would like to get solutions on the table and a report to the Council very quickly."

# **Citizens' Oversight Committee Discusses Campus Reconfiguration, Criticizes Pace**

On September 14, the Citizens' Oversight Committee (COC) held their second to last meeting of the year. Among the many topics discussed were the Building B construction at Horace Mann and the new BHUSD reconfiguration.

Assistant Superintendant of Facilities Dave Jackson said that the building is slated to be completed by December 14, to which several COC expressed frustration at the length and increasing expenses of the project.

Originally, the project was to cost nearly \$62 million. Then, that number was increased to \$76 million. As of now, Jackson said Horace Mann will cost \$80 million to complete the project. Members said that the district has nearly "killed" their credibility in the past by delivering numbers that "have no connection to reality.'

"This is our fourth iteration of 'don't worry, it's different now," said member Lee Egerman. "The lesson should have been learned after the first iteration, not the fourth."

Superintendent Michael Bregy called these questions "fair" and said staff will reach out for specific answers.

The cost estimate to the City for the



event is estimated at \$20,057-including permit fees, equipment, personnel costs, and other associated costs, etc). Additionally, the City will have a Certificates of Insurance for \$2 million in General Liability.

"This is something that will benefit the participants and reflect well on the City, so I'm in support," said Councilmember Robert Wunderlich, before the rest of the Council expressed unanimous support.

# **Former Board of Education Member Marty Prince Passes**

Born in the Bronx, raised in Albuquerque, NM and settling down in Beverly Hills and Westwood, Marty was a father of five and grandfather of nine.

Prince was an optometrist to thousands of patients over the years. He was a philanthropic soul with years of work at the Venice Family Clinic where he was honored with the Morton K. Rubenstein Humanitarian Award as the most dedi-

cated and compassionate volunteer physician among 500 volunteers, and a community activist in his Lions Club and Westside Chamber of Commerce, who honored him with the Rancho Park Man of the Year award.

Marty served on local, state and national optometric boards including the Board of Education from 1967-1971. There, his legacy included

# Next Beverly Hills Co-Chair Wil Master on this weekend's big event on South Beverly Drive

What is your professional background? I typically consult to different businesses, mostly producers and help them put together packages and financing for movies and TV shows as well as some digital assets.

# Next Night is an event put on by Next Beverly Hills. How did you get involved with that organization?

I got involved with Next Beverly Hills when I met then-Mayor [Julian] Gold at his installation in 2015. I talked to him a little bit about my involvement with CERT [Community Emergency Response Team]. I've been a red cross shelter volunteer shelter manager for close to 15 years and just told him a little bit about my involvement in helping others and he invited me to come to see Next Beverly Hills Committee and through that we

It's gonna be like you're walking through an outdoor art exhibit that's interactive and playful, and some of them will also be a screen of videogames. It's going to be a very interesting, very millennial, very next generation, entre into the event. And I believe we're going to feature an electric car. That's gonna be different. And we also have a little surprise that's gonna be at the [other side] of the event. We're calling it an "instagrammable" experience. It'll be kind of like the box they had on Rodeo Drive.

The original purpose of Next Night was to get young people involved. When the City Council removed the age limit, what became the purpose of the event?

It's certainly to engage millennials, to engage the 25-25 year-

olds in the City. That hasn't changed. I think what the Council wanted to [was that] they just wanted it to be an open group so that people who are outside of those age groups can still be involved and still offer Next Gen ideas. Just because someone is older than 45 doesn't mean they don't understand and relate [to] what the millennials are doing. So it's still to engage the next generation. That mission has not changed. We just, with the Council together, didn't want to limit to a specific age group [but] it really caters to that age group.

# The theme this year has to do with technology and innovation. Tell us about that.

Last year was a little more artsy and craftsy, and this year we were looking at

more technology and innovation through the micro amusement park and games. That's all Next Gen technology. There's the electric car. We're trying to connect not just with the technology; we're trying to connect it with the initiatives that are going to happen in the City. Especially with the subway coming through-Metro actually has their own booth at the event which will be able to address any questions people have regarding the Purple Line that's coming through. The Fire Department has a booth with the Police Department and they are doing a big push for their CERT program.

# What else do you think Beverly Hills can do to make its image more youthful?

I think groups like the Next Beverly Hills Committee is really the perfect group to find ways to make the City more youthful, more Next Gen. For the past three months our focus has shifted to the Next Night

A touchdown with less than two minutes to play Friday night kept Beverly High from its first varsity football victory since Oct. 30, 2015.

The 20-16 loss to Cerritos in a nonleague game at Gahr High was "kind of heart-wrenching for all of us, especially all the kids," Norman coach Steve Geanakos said.

"At this point, there's no moral victories any more," said Geanakos, whose team lost to 19-14 Malibu Sept. 8 in what had been the smallest margin of defeat since he became coach in 2016.

"They're definitely playing more cohesively. There are so many seniors who have struggled through all this time. They know how to play. They're just undersized and don't have the speed that the other teams have."

The Dons had "four guys on the team faster than anybody on our team," Geanakos said.

The players have been heartbroken by the consecutive narrow losses "because they can feel and sense they're close," Geanakos said.

"Sometimes it's maybe one or two small things during

Quarterback Jeremiah Klapper ran for one touchdown for Beverly Hills (0-4) and threw a pass to Thomas Goolsby for the other.

Colby Nielsen threw for 401 yards and two touchdowns and Tye Anderson also ran for a score for Cerritos (1-3), which had been outscored 120-11 in its first three games.

Both teams had safeties, with Normans intentionally conceding a safety in the fourth quarter to give them better field position for a kick, Geanakos said.

The Beverly Hills defense played well until the Dons winning touchdown drive, Geanakos said, specifically the defensive line of Greg Carter, Paul Chun Jr. and Alex Movaghar, whose play Geanakos called exceptional.

"They were able to dominate their five (offensive linemen)," Geanakos said.

Geanakos also praised the play of Klapper and running back Nick Sullivan.

The Normans are set to conclude nonleague play Saturday at Peninsula High. The opening kickoff is set for 2 p.m.

The Normans are 0-10-1 against Peninsula, formed in 1991 by the merger of Miraleste, Palos Verdes and Rolling Hills high schools. (Palos Verdes High School reopened in 2002.)

The Panthers defeated the Normans, 45-0, last season. Peninsula is 2-2 this season, including a 21-20 loss to Torrance Friday.
