

WHAT IS BEING PROPOSED: The Department of Toxic Substances Control (DTSC) has prepared a Statement of Basis to support a determination of "Corrective Action Complete with Controls" for HRL Laboratories, LLC (HRL, Site, Facility), Public Comment HRL, formerly known as Hughes Research Laboratories, is located at 3011 Malibu Canyon Road, Malibu, California 90265. It is a Research and Development (R&D) facility jointly owned by The Boeing Company and General Motors.

The Facility currently performs scientific research mainly owned by the becking ownpairy and ovned and models. The Facility currently performs sciences, and information sciences. DTSC and HRL signed a Corrective Action Consent Agreement (Consent Agreement) on February 3, 2004. The Consent Agreement addressed concerns about potential releases of contaminants into the environment at the HRL Facility: (i) petroleum hydrocarbons (disel); (ii) mercury; (iii) reactive phosphorus compounds; (iv) metals; (v) polycyclic aromatic hydrocarbons; and (vi) halogenated solvents. The following solid waste management units (SWMUs)/areas of concern (AOCs) were addressed: Acid Waste Neutralization Tank (SWMU1), Hazardous Waste Storage Area (SWMU2), the drain area from SWMU2 and the ravine area into which the drain discharged (AOC1), and the area surrounding the SWMU1 (AOC2).

The 30-day Public Comment Period is open from October 2, 2017 through November 1, 2017. 

Commission Weighs Non-Resident Use of Dog Park

Following its first year of operation, the Recreation and Parks Commission reviewed the progress of the Community Dog Park.

On September 18, Chair Howard Rosoff and Vice Chair Simone Friedman met with City Council Liaisons Mayor Lili Bosse and Councilmember John Mirisch to discuss progress and recommendations.

Regarding the hours of operation, the liaison recommendation is to keep the park open from 8:00 a.m. to 8:00 p.m. seven days a week.

Currently, the park is open to Beverly Hills residents, individuals who work in the City of Beverly Hills, Beverly Hills hotel guests, and City residents' guests. The recommendation is to have a 6 month trial period that would allow approximately 200 non-residents access to the park. While the trial period would be at no-cost, charges may apply once it ends.

Regarding the permit process, the recommendation is to keep the current online

registration process in place in order to insure dog park users' dogs have current vaccinations, and to monitor/control access to the off leash area, according to the staff report. Staff is working to develop the process for the registration of non-residents on a first come first serve basis for the trial period.

A ranger is currently present during all operating hours, but the recommendation is to only have a ranger present during peak hours, High Holy Days and weekends. Peak hours are considered 8:00 a.m. to 10:00 a.m. and 4:00 p.m. to 8:00 p.m.

They will also patrol the dog park throughout non-peak hours to monitor peak usage and address any issues. Staff has recommended that the rangers patrol Beverly Canon Gardens, Beverly Gardens Park and La Cienega Park.

At the meeting, Commissioner Frances Bilak said that staff should specify which High Holy days the rangers should be present for. She also noted that in both surveys sent out to the public, many stakeholders expressed that they don't want to open the dog park to non residents.

"I'm a little concerned about opening it up to non-residents when residents don't want to open it up to non-residents," said Bilak.

Rosoff responded to her by pointing out that the park is rarely, if ever, used to capacity. He said that at the liaison meeting, the thought was that because there isn't full implementation, they could open the park to non-residents on a limited basis and see how it works.

"If we're not fully utilizing it, we should be fair to the people who live adjacent to the City and want to make use of it," said Rosoff.

Commissioner Julian Javor said that another potential option would be to open the park to non residents during non peak hours. He added that five digit codes could be given to non-residents instead of the four digit code that residents receive.

Although there was no formal vote, the



commission showed support for the project. Their comments and recommendations will be forwarded to the City Council, who will discuss the item at a later date.

BHUSD Faculty and Staff to Receive Salary Increase

At their meeting on September 26, the Board of Education approved a salary increase for

several district employee unions. They include the Beverly Hills Education Association (BHEA) California Teachers' Union, the BHEF Instructional Assistants Unit, the BHEA Office Technical Business Unit, and the California School Employees Association (CSEA).

Effective on July 1, the increase will start at 2.174 percent for the first year, upping to 3.003 percent for 2018-2019 and back down to 2.805 percent for 2019-2020.

The salary formula was initially approved by the Board in July 2014 to provide salary enhancements for these specific employee groups. It's based on a percentage applied to secured property tax revenue growth. For 2017-2018 that applied percentage is 55, thus resulting in the 2.174 percent increase.

With the cost of the agreements, the district projects reserves of 16.7 percent for 2017-2018, 19.48 percent for 2018-2019, and 21.83 percent for 2019-2020 in the General Fund and Fund 17.

BHUSD to Spend Over \$3,000 on Temple Emanuel Rental

As the KL Peters Auditorium continues to be closed, the BHUSD will rent Temple Emanuel's Corwin Family Sanctuary for the Beverly High choir's Winter Concert.

The concert is scheduled for December 13 with a dress rehearsal on December 6. The cost of these two evenings is \$3,321.50, not including a cleaning/damage deposit of \$500.00.

According to the staff report, the rental will be paid for through Measure E funds "because the [KL Peters Auditorium] is unavailable as a consequence of the construction of the Beverly Hills High School Modernization Project."

The KL Peters Auditorium will be unavailable for at least the 2017-2018 school year, and possibly longer.

City Launches BOLD Holidays

In order to celebrate the upcoming holiday season, Beverly Hills has announced its launch of BOLD Holidays—an extensive public lighting display.

Beginning in November, the display will stay lit through the first week of January. According to a press release, the "stunning geometric and iridescent light installations" will be placed along North and South Beverly Drive, Canon Drive, and Rodeo Drive.

Metro to Hold Community Meeting

Metro will hold a pre-construction community meeting about the Purple Line Extension from 6:00 p.m. to 7:30 p.m. on September 28 at Century Plaza Towers.

The Purple Line project is a rail project that will provide an alternative for commuters to travel between downtown Los Angeles and the Westside. Section 2 will add new stations in Beverly Hills and Century City.

"Metro wants your input on construction activities," said the mailer that was sent out to residents.

The section 2 meeting will discuss the project overview and schedule, provide an update on advance utility relocation, and allow attendees to meet team members and ask questions.

The mailer also indicated that work is anticipated to take 3-5 days at each location, lane reductions will be required, and that all work will receive necessary permits and approvals from the City.

Additionally, access to driveways, residencies, businesses, pedestrians, and the Fire Department will all be maintained.

Century Plaza Towers is located at 2029 Century Park East, and the event will take place in Conference Room A on Concourse level D. For more information, visit www. metro.net/purple.

Alive & Running 5K Run/Walk Raises \$375,000

On September 24, over 2,000 participants showed up for the 19th annual Alive & Running Walk/Run for Suicide Prevention. The event raised about \$375,000 for Didi Hirsch Mental Health Services' Suicide Prevention Center.

Wrapping up Suicide Awareness and Prevention Month, the event included special performances by the Baker Brothers Jazz Combo and Chikara Daiko, a Taiko drum group. The Reverend Shawn Amos, a blues artist who lost his mother to suicide, also spoke about the healing power of sharing stories o n social media.

Didi Hirsch Board member and event co-chair Pamela Kluft, who lost her sister, Beth, to suicide, presented Didi Hirsch Board member Sara Rutenberg and her brother, Andrew Berman, with the Hope Award. Rutenberg and Berman created Team L'Chaim in memory of their sister, Julie, who died by suicide 41 years ago and shared their loss for the first time on the Alive & Running website.

"By speaking honestly and openly about their sister's suicide, they have given other survivors hope that healing is always possible—even after decades of silence," Kluft said.

On October 10, the Beverly Hills Police will hold their annual Black and White Gala at the Beverly Hilton.

On September 14, the owner of 410 Chris Place withdrew a previously submitted request for a View Restoration Permit



430 Dabney Lane (Foliage owner)

to remove eight trees from a neighbor's property located at 430 Dabney Lane.

Represented by former Mayor Linda Briskman, property owners Michael and Ronnie Kassan, originally submitted the project request in 2015.

The request was previously scheduled for a Planning Commission hearing in August 2016, but the View Owner notified staff that he and the Foliage Owner were working towards reaching a private agreement outside of the City's View Restoration process. However, they did not reach that agree-

Surrounding neighbors show little interest in park construction

On September 26, the Recreation and Parks Commission meeting featured a presentation on the proposed conceptual design for the Coldwater Canyon Park renovation.

The presentation comes after the selection of architectural firm March Studtios and playground equipment vendor Landscape Structures, which Recreation Services Manager Teri Angel previously said will bring a different, unique aspect the area hasn't seen before. She called their playground schematic design "whimsical" and "woodsy."

The objective of the playground is to "provide a friendly, cohesive and enriching experience for the preschool as well as park visitors and a well-functioning facility for staff," but since the current equipment is approximately 15 years old and has faced maintenance and safety concerns, staff felt it was time for an upgrade.

"The current playground has just reached the end of its lifespan," Angel previously told the Weekly.

On September 18, staff and Recreation and Parks liaisons appraised City Council liaisons of the process and renovation concepts at a meeting.




