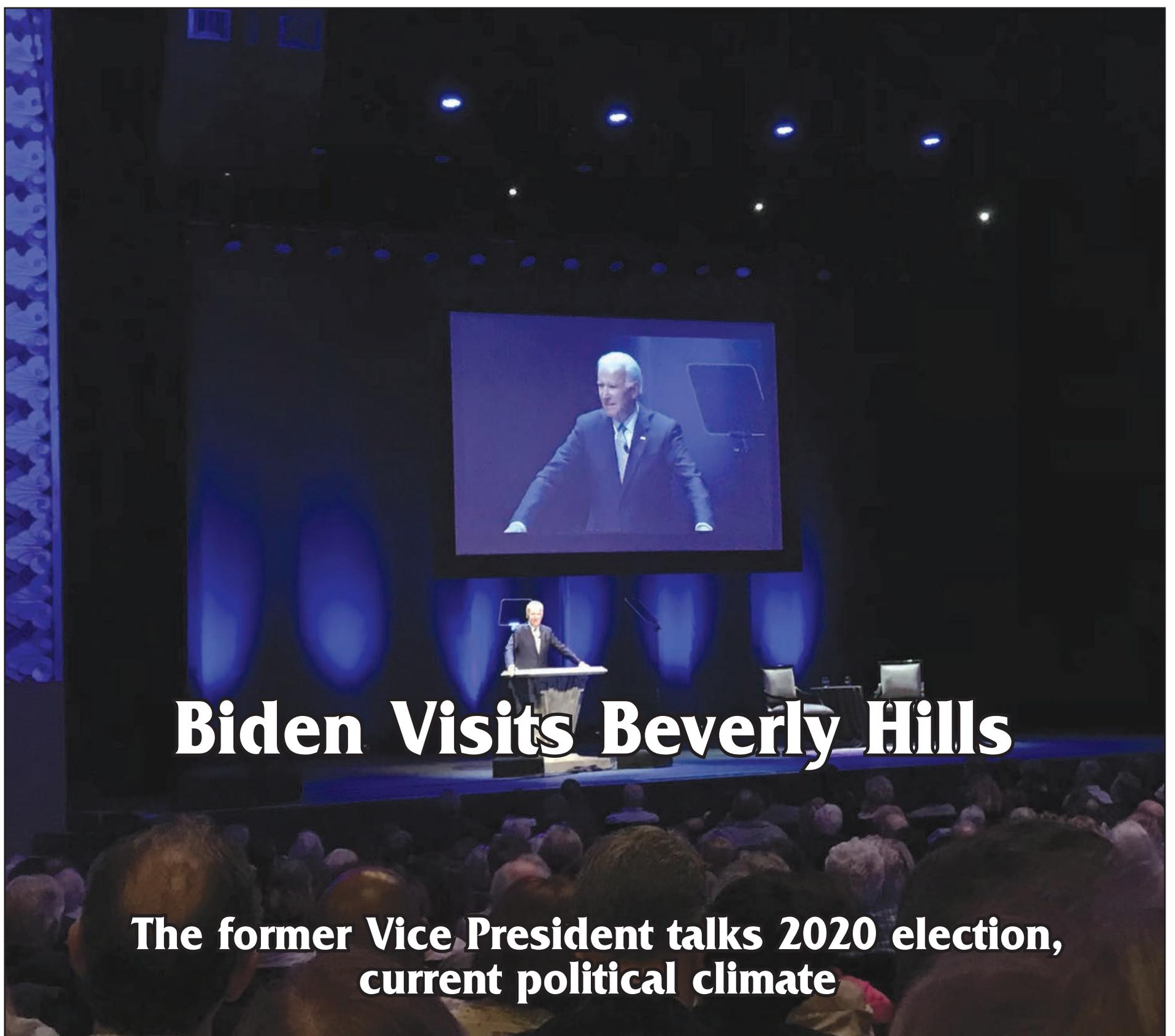

### Bouchon to Close Amidst Dispute with City

The nine-year-old Bouchon restaurant will close its doors come the end of the year, according to Chef and Proprietor Thomas Keller.

In a statement released last week, Keller said that the current “adverse conditions” with the landlord, the City Beverly Hills, made it impossible to operate a profitable restaurant.

Keller wrote that the restaurant could



not find common ground with the City, alluding to monetary disagreements but also thanking the loyal customer base.

“We will conclude our operations at the end of the year, but remain committed to providing our guests and neighbors with the cuisine, the service and the excellence they have come to expect from us until the very last minute of our last day,” wrote Keller.

The City responded to Keller last Thursday by releasing its own statement—attributed to Timothy Hou, Assistant to the City Manager:

“We are sorry to hear about the upcoming closing of the Bouchon restaurant, café and bar. As property owners, the City has done everything it could to help these businesses become profitable, including a significant capital investment in the building, a tenant improvement allowance as well as granting rent reductions of more than 50% from the original lease. As a local government and as stew-

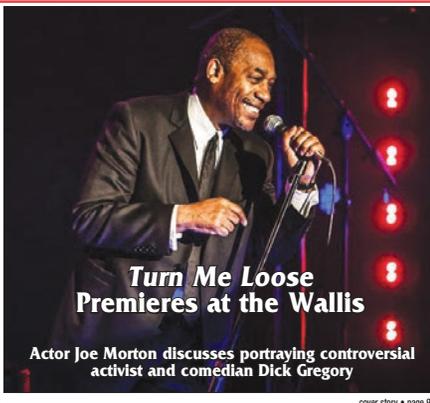

### Irene Stern, Longtime Beverly Vista Principal, Passes

Longtime Beverly Vista principal Irene Stern died October 24 at her home in Westlake Village.

A fixture at the K-8 school for many years, Stern was first hired full-time by then-principal Walt Puffer in the early 1980's as a 6th, and later 8th grade, Social Studies teacher. In 1993 she became Assistant Principal alongside Nadine Breuer. Stern served as the Beverly Vista Principal from 1999-2006, and again from 2010-2012.

After pressure from then-superintendent Jeff Hubbard, Stern resigned in 2006, but a new Board of Education rehired her in 2010, where she served as principal again until 2012.

Former Beverly High Principal Dan Stepenosky remembered Stern as “a joy and an honor” to work alongside.

“I distinctly remember sitting on her interview panel for the principal position at BV,” said Stepenosky. “I was so inspired by her, [former BHUSD administrators] Tanis Haris, Rick Munitz, and Ben Bushman that I knew I wanted to be an educational leader with their passion and dedication. She was focused on her students and their wellbeing at every turn.”

Survivors include her husband of 58 years Mark, son Mitch, a 1982 Beverly High graduate, daughter-in-law Sandi,

and grandson Colin.

Stern's memorial service will be held on October 29 at Mount Sinai Simi Valley at 12:30 p.m., located at 6150 Mount Sinai Drive.

### Could There Be a New Cultural and Art Commission?

At their meeting on October 17, the City Council discussed the possibility of expanding or creating a new commission to handle cultural and art activities.

Earlier this year, on June 20, Councilmember John Mirisch requested that the Council discuss the initial proposal. The item was subsequently refer the item to the Council Liaisons for discussion with representatives of the Fine Art Commission, whose charge the liaisons discussed expanding.

On August 28 the liaison committee met to go over information about what other cities do to address cultural and art activities. In Culver City, for instance, staff found that there is a Cultural Affairs Commission made up of five members who are advisory to the City Council on matters pertaining to enrichment of the community through visual arts, performing arts, etc.

Additionally, they found that the City of Fremont has a Cultural Arts Council with an 11-member Board of Directors that helps to share information, create a community events calendar, and assist with event promotion.

The Council discussed three potential options for expanding culture and arts in the City, including increasing community cultural events and activities, creating a new Beverly Hills culture and arts collaborative or culture and arts alliance, or expanding the scope of an existing commissions' responsibilities—either Fine Art or Recreation and Parks into Cultural Affairs or Cultural and Arts Oversight.

Councilmember Lester Friedman expressed interest in expanding the Fine Art Commission, to which Mirisch agreed and suggested eliminating the word “Fine” so the commission would

## NOTICE OF PUBLIC HEARING

The Council of the City of Beverly Hills, at its regular meeting to be held on **Tuesday, November 7, 2017 at 7:00 p.m., or as soon thereafter as the matter may be heard**, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

### AN ORDINANCE OF THE CITY OF BEVERLY HILLS REGARDING THE VALIDITY AND EXPIRATION OF CERTAIN BUILDING PERMIT APPLICATIONS

The proposed uncodified Ordinance would clarify the validity of Certain Pending Building Permit Applications. Notwithstanding any other ordinance, any application for a building permit that was: (1) submitted to the City before January 1, 2017 and (2) that was submitted to plan check, originally or the response to comments, after January 1, 2016, shall be and remain a valid building permit application through the close of City offices on March 7, 2018. This shall include building permit applications that may be considered expired under Beverly Hills Municipal Code Section 9-1-107.L.3, or that may expire under that section prior to March 7, 2018. All such applications would be deemed expired upon the close of City offices on March 7, 2018 if the applicant has not received a valid building permit from the City before that time.

The proposed Ordinance addresses the validity of building permit applications; it is administrative in nature and will not result in a physical change to the environment. The City Council will consider finding the proposed Ordinance exempt from environmental review because it is not a “project” pursuant to Public Resources Code Section 21065 and furthermore, would qualify as exempt under California Environmental Quality Act (CEQA) Guidelines Section 15061(b)(3) because the project merely clarifies existing administrative regulations regarding building permit applications and will have no significant effect on the environment.

All interested persons are invited to attend and speak on this matter. Written comments also may be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. Written comments should be received prior to the public hearing.

Please note that if you challenge the City’s action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

## Don Blake BHUSD Construction Capital Improvement Bond Manager

### How did you first get into school construction?

I was retired in the late 1990's. I was still kind of young; I had kids in school. I was a real estate developer—commercial and residential in Washington, California and Oregon. I felt it was a good time for me; I sold all my properties. I was lucky and successful, so I stopped. At that time, I had some friends who were involved in school construction, who asked me if I would be willing to talk to a couple of superintendents and having a conversation about public works schools and my thoughts. It was kind of an open discussion and the discussion went to, "Well, Don if you were king, what would you do?" And I said, "Well, I'm an owner." And what that means is I'm written into the script and make decisions to change the outcome. For public works, you as the owner are not written into the script; you're reported to by an architect or by the architect. That's just how the communication process works. To me, I didn't think it was all that spectacularly new and exciting; it was just answering the question. Because you're not written into the script, only the



owner for a lot of school districts. So we get together and say, "Let's write a contract." We invented a contract that said I'll represent the Board and I'll take the bond monies from the acquisition entitlements, design process, construction process, all the way to occupancy. Since then, a number of school districts we've managed bonds over the years. I haven't written a change order in all those years. We've been able to deliver a certain deliverable. It's a business model is the point. It's not magic.

**Tell us about the two performing arts centers you built in the Las Virgenes school district.**

During the design process, we were managing it with

John Fischer Zunich, probably the father of theater design worldwide. The mission was [for] these buildings to compete with professional spaces. Two, can we have all the parts and pieces in the building that would create an education department that would feed kids into UCLA or USC or the larger universities. The stage, the articulating orchestra pit, the back of

the house scene shops were all designed with those two things in mind. And additionally, they added a black box theater component which has become a very popular not just performance space but teaching space as well. As in all cases, I used the Lease-leaseback methodology. In it is a guaranteed maximum price component. So I built a non-adversarial relationship with the builder and we built it together. On those two projects, we delivered them with no change orders and no lawsuits. We opened on the same day we promised to open when we signed the contract.

### How'd you get involved with Beverly Hills?

I was retired again. I had finished up the last grouping of bonds over in Las Virgenes. We had finished and made a decision that this was fun but it was time. And there wasn't a bunch of working coming online for much of the school districts in the state. So I had gotten all my employees positions at other firms and we just felt like this was a good time. I went to Colorado with my wife and grandsons and then Terry called me and said, "A school district here has had a long history of some difficulties and the Board is really serious about learning from that experience and making decisions to find a way to get on track to be successful again. Would you come and look and help them and advise them?" So I came out in July and looked at the financial history, all that, and mostly just talked to them.

### Many residents have little confidence in the BHUSD's construction plans. What do you plan to do differently this time?

What's important to me to make things work is having a working relationship with the Board. It's not just reporting to the Board. So I asked for a facilities sub-committee where two Board members would attend and we'd talk about what we're doing. So it's not just reporting to them after something has been processed. We've been doing that since July. As time went along they began

to see that there's the possibility of a relationship first, and then a model. So, we built a relationship before we signed the contract. The idea is that this can be fixed and put back on track and begin to move towards completing the balance of the bond monies. The building process—we have a program that's proven and tested—can deliver effectively the purpose of the bond. The purpose of the bond is to produce buildings in the end. So, the Board and I agreed that we'd like that business model. It came organically through the process. [Superintendent] Dr. Bregy and I developed a relationship and I understood what he was trying to accomplish. We spent a lot of time building those bridges so we understand where [the] other is coming from and what the goals are. Most of it was what the Board learned through this experience up until now that they don't want to repeat.

### What are your goals for the BHUSD construction?

The goal is to deliver to the school district their real estate capital investment, and that we deliver it on the day that we've planned for and with costs that we've planned for. That's the goal. That's the deliverable. The experience is incorporating a good relationship with the COC and a good relationship with the staff. We manage the architects and the contractors and by doing that we're deeply involved in each of the sites we're working so we become involved with the parents, the teachers and the culture. That's the fun part.

### What projects are you working on?

B1 and B2 at the high school. They've already decided what they want in phase 1, but strategically with the funds you have left in an environment where it's pretty well known that escalation through this next year is going to run not five percent but 20 percent, so being careful to manage the wallet and match that with the scope is what I'm doing first. Out of that exercise came B1 and B2 and El Rodeo buildings A, B, C, and D.

## Police Department Could Receive Facilities Upgrade

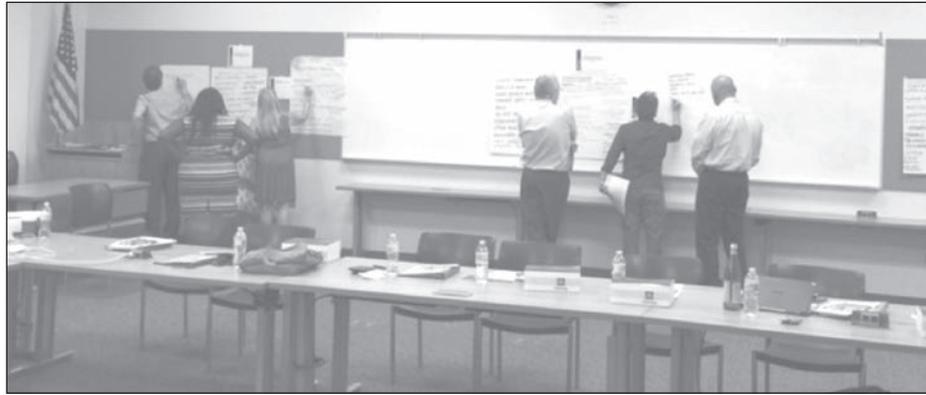
The City Council discussed last Tuesday a proposal by the Beverly Hills Police Department to upgrade the BHPD facilities. Earlier this year the police

### “Future Focused Schools” Talks Global Society

On Tuesday the Future Focused Schools team held their second meeting, which was framed around the question, “What opportunities should a TK-12 BHUSD student experience to competitively thrive in a global society?”

Team members formed into smaller groups to answer sub-questions such as the positives and negatives of the reconfiguration and the district's current structure.

They also discussed the types of experiences students should be having in elementary school, middle school, and high school.

At the October 23 Board meeting, Superintendent Michael Bregy said that while many of the members sat on opposite ends of the spectrum in terms of reconfiguration goals, the meeting was beneficial in creating readiness and building relationships amongst the team in order to move to the development stage.

The 21-member Future Focused Schools committee will work in the coming months to develop reconfiguration options for the five Beverly Hills school campuses.

Superintendent Michael Bregy originally brought this idea to the Board last month in a presentation that discussed the BHUSD's currently unsustainable financial path.

He said that because the district is currently at a financial “tipping point,” the Future Focused Schools program would aim to “improve educational opportunities for students while ensuring long-term financial sustainability.”

The next Future Focused Schools meeting takes place on November 7.

of the Police Department 20 years into the future.

The study found that a major reconstruction of the existing building is estimated to be approximately \$71 million. This includes the building construction (\$41 million), soft costs like architectural engineering consultants, fees, furniture and fixtures (\$14 million), and contingency and escalation costs (\$16 million).

But at the meeting, the councilmembers agreed that \$71 million was simply too much for a project that would still have deficiencies, with Councilmember John Mirisch calling the amount “absurd.”

“I’m having trouble putting \$71 million into a project and maybe getting 20 to 25 years out of it,” said Councilmember Lester Friedman.

Mayor Lili Bosse asked BHPD Chief Sandra Spagnoli why the immense changes presented in the proposal are necessary given the departments current “amazing response time and high performance,” to which Spagnoli responded by saying that there is always room for improvement.

Spagnoli also noted that other cities, such as Santa Monica have much more “functional” facilities than the BHPD—which, according to the staff report,

has been aging and proven to be inefficient in useable floor area due to its geometry and placement of building core.

“Improving the internal efficiency will also impact services to the community,” said Spagnoli.

There was consensus among the Council to delve into a deeper analysis and possibly consider a new site before making any commitments.

### Recreation and Parks Commission Tours Greystone Demonstration Garden

On Tuesday the Recreation and Parks Commission toured the Greystone Demonstration Garden.

The tour follows a September 26 presentation by Beverly Hills resident and

## BIDEN VISITS BEVERLY HILLS

The former Vice President talks 2020 election, current political climate

Gun control, violence against women, and the 2020 election were just some of the many topics former Vice President Joe Biden tackled when he addressed the Saban Theatre on Sunday evening.

Just prior to 7:00 p.m., hundreds of people filed into the dimly lit theater as a guitarist set the scene until blue faded to black and a speaker introduced the former Vice President.

Biden commanded the room from the moment he began talking about the Charlottesville protest, and maintained it all the way through his unwavering but lengthy

thoughts about sexual assault during the question and answer period.

Spanning about an hour, Biden's speech centered on the current political climate and his experience in office.

He referenced a piece in the Atlantic he wrote about the Charlottesville incidents, emphasizing the importance of speaking out when leaders draw a moral equivalency between Neo-nazis and people marching to protest the actions of white supremacists.

"Our children are listening. It matters what our leaders say. It matters whether we stand up and condemn actions that

are [against] everything we stand for as a nation," said Biden. "Silence is complicit."

But Biden also emphasized the importance of maintaining hope under such circumstances, and encouraged different political parties to engage with one another in order to make progress.

"To blame whatever troubles we think we have on the outside or the other—we have to reject this dangerous theory [that] groups the [narrative] into us and them rather than rebuilding from a shared narrative of freedom and democracy that inspires nations to unite," said Biden.

But perhaps one of the most burning

topics Biden addressed was whether not he would run for president in the 2020 election. The question, asked during the question and answer period, elicited a loud applause from the crowd when didn't outright reject the option.

Biden stated that although he had considered running for president in 2016, personal issues prevented him from being able to wholly commit to a campaign. He also said however that if 2020 creeps up and he hasn't seen anyone viable stepping up, he wouldn't rule out the possibility.

"I just don't know," said Biden. "We'll see."

### BHUSD Students Raise Over \$3,000 for Hurricane Relief

BHUSD students raised more than

\$3,000 this month in support of people affected by this summer's hurricanes.

The first round of the district's #BH1 For the Gulf fundraising efforts will go directly to the Alief Independent School District in southwest Houston, where an estimated 200 staff members lost their homes and vehicles in the destruction from Hurricane Harvey in August.

Students, with the assistance of teachers and parent volunteers, collected donations at the district's school sites over a two-week period this month. The total amount of money raised came to \$3,180.

"It's important - because when something happens, not everyone is willing to help others," said Hawthorne 5th grader Daniela Rabbanian, "We did a pretty good job because lots of kids worked to ask for donations - and we got lots of people to give donations."

"We wanted to reach out directly to another school community, knowing that recovering and rebuilding from a disaster like this is going to take some time," said Beverly Vista Principal Christian Fuhrer, who has

been coordinating the #BH1 for the Gulf effort, "The goal is to teach our kids that even in the most difficult situations, we can all make a difference."

The BHUSD plans to hold additional fundraising activities throughout the school year, to assist fellow school communities impacted by natural disaster.

### Santa Monica Blvd. Construction Moves to Final Segment

Construction on N. Santa Monica Boulevard is moving eastward to the

final segment of the project. Workers began dismantling the south part of the roadway between Alpine and Doheny drives last week.

Construction on the final segment will be completed in phases, similar to the approach used during the two previous segments. Until the end of December, four lanes of traffic will be open, two in each direction. During this time curbs and gutters will be replaced and bioswales and raised crosswalks will be built. Starting at the end of December and after the holiday season has ended, the road will be demolished and rebuilt, requiring lane closures and detours. A detour plan similar to the two-lane phase of Segments 1 and 2 will be implemented at that time.

The work and road closures have been scheduled in order to shorten the overall duration of construction, which is now scheduled to be finished in the spring of 2018. The previous schedule was for a completion date in July 2018.

Buses will continue to travel westbound on N. Santa Monica Blvd with stops at Cañon and Camden Drives and Wilshire Boulevard. Buses travelling eastbound will be diverted onto S. Santa Monica Boulevard in Century City.

Buses will stop just west of Charleville Blvd and continue on S. Santa Monica Boulevard with stops west of Camden Drive and west

of Crescent Drive. The eastbound buses will return to N. Santa Monica Boulevard by way of Doheny Drive.

Left turns are restricted during the construction of this segment. In order to limit

vehicles diverting into residential neighborhoods, traffic will be monitored and right turns restrictions could be implemented if necessary.

Reconstruction of the intersections and construction of raised crosswalks. While this work is underway, intersections will be closed intermittently to both north and south traffic. Notice will be provided ahead of time.

Raised crosswalks will be built at unlighted intersections on the north side of N. Santa Monica Boulevard (Linden, Alpine, Foothill, Elm, Maple, Hillcrest, Arden, Alto and Sierra drives). These striped, high-visi-

bility crosswalks will connect the Beverly Gardens Park jogging/walking path where it pauses at the intersections. The crosswalks will be constructed at the same level as the curbs, allowing for a safe transition for pedestrians.

An extensive outreach program is underway to inform the community of the N. Santa Monica Boulevard Reconstruction progress and how to navigate streets during construction. Watch for mailers, social media messages, newspapers ads and signage.

### Recreation and Parks Commission Discusses Robertson Tree Removals

At their meeting on October 24, the Recreation and Parks Commission discussed the removal and replacement of several Ficus trees lining Robertson Boulevard.

The discussion follows an increasing incidence of Ficus tree related infrastructure damage and associated liabilities. The City Council previously approved the replacement of Ficus trees on several streets since adopting Phase II of the Street Tree Master Plan in 1999.

To date, City Ficus trees have been removed and replaced on Durant, Lasky, Chevy Chase, and Angelo Drive. They have also been replaced on a portion of South Santa Monica and Olympic Boulevard.

Currently there are about 100 Ficus trees on Robertson. The Southeast Task Force initiative to remove and replace the Ficus trees as a part of the beautification effort stalled due to lack of public participation in the outreach process.

Only one member attended a scheduled public meeting, but the Recreation and Parks Commission requires more than 50 percent public participation to recommend consideration by the City Council.

The City Attorney's office has advised that removing Ficus trees and using a test model planting at Horace Mann, accord-

ing to Community Services Director Nancy Hunt-Coffey as replacements on Robertson Boulevard is a solution to trees that could be destabilized in the process of repairing a root damaged sidewalk.

Earlier this month, the City's Urban Forest Manager Ken Pfalzgraf wrote a letter that was sent to affected Robertson addresses notifying them of the Recreation and Parks meeting on October 24 and encouraging community input.

Ultimately, at Tuesday's meeting the Council opted to recommend filling the current holes in the line of trees with the same trees that are in front of Horace Mann. These species include Mexican Fan Palms and Crepe Myrtle Trees.

Winless Beverly High will play at undefeated Lawndale Friday in an Ocean League football game set to begin at 7 p.m.

The Normans lost to Santa Monica, 35-7, Friday at Nickoll Field, with Ilai Dardashti running for their touchdown in the fourth quarter. The loss was the 19th in a row over three seasons for Beverly Hills (0-8, 0-3 in league play).

The Cardinals (8-0, 3-0) were ranked third in the Southern Section Division 5 poll released Monday. They have held five opponents to seven points or less, including three shutouts.

The teams have two common opponents. Lawndale defeated El Segundo, 49-14,

Friday. El Segundo defeated the Normans, 56-7, Oct. 13. The Cardinals defeated Santa Monica, 60-0, Oct. 6.

#### ORDINANCE NO. 17-O-2740

#### AN ORDINANCE OF THE CITY OF BEVERLY HILLS MOVING THE DATE OF THE CITY'S GENERAL MUNICIPAL ELECTION FROM THE FIRST TUESDAY AFTER THE FIRST MONDAY IN MARCH OF ODD-NUMBERED YEARS TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN MARCH OF EVEN-NUMBERED YEARS

#### THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Change of Election Date. The date of the General Municipal Election in the City of Beverly Hills is hereby moved from the first Tuesday after the First Monday in March of each odd-numbered year to the first Tuesday after the first Monday in March of each even-numbered year beginning in March of 2019.

Section 2. Increase in Terms of Office. Due to the change of election date, the terms of office of those members of the City Council presently serving and the term of the City Treasurer shall be increased by 12 months as follows:

A. Those members of the City Council whose

terms of office would have, prior to the adoption of this Ordinance, expired following the City's March 2019 General Municipal Election shall instead conclude their terms of office following certification of the results and administration of the oath of office after the March 2020 General Municipal Election.

B. Those members of the City Council and the City Treasurer whose terms of office would have, prior to the adoption of this Ordinance, expired following the City's March 2021 General Municipal Election shall instead conclude their terms of office following certification of the results and administration of the oath of office after the March 2022 General Municipal Election.

Section 3. Ordinance No. 94-O-2218 is hereby repealed.

Section 4. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 5. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 6. Effective Date. Pursuant to Government Code section 36937, this Ordinance shall become effective immediately.

Notice is hereby given that the City of Beverly Hills ("CITY") has determined that all bidders for the upgrade of civic center Honeywell control system ("Projects") must be pre-qualified prior to submitting a bid on that Project. *This prequalification is valid for a year.* It is mandatory that all Contractors who intend to submit a bid, fully complete the prequalification questionnaire posted on the City's website, provide all materials requested herein, and be approved by the CITY to be on the final qualified Bidders list.

No bid will be accepted from a Contractor that has failed to comply with these requirements. If two or more business entities submit a bid as part of a Joint Venture, or expect to submit a bid as part of a Joint Venture, each entity within the Joint Venture must be separately qualified to bid. Contractors are encouraged to submit prequalification packages as soon as possible, so that they may be notified of omissions of information to be remedied or of their prequalification status in advance of the prequalification deadline for this Project.

Answers to questions contained in the questionnaire (posted on the City's Website [Beverlyhills.org -> Business -> Bid Listings -> Prequalification Package for Civic Center HVAC Control Upgrade]) are required.

The CITY will use these documents as the basis of rating Contractors with respect to whether each Contractor is qualified to bid on the Project, and reserves the right to check other sources available. The CITY's decision will be based on objective evaluation criteria.

The CITY reserves the right to adjust, increase, limit, suspend or rescind the prequalification rating based on subsequently learned information. Contractors whose rating changes sufficiently to disqualify them will be notified, and given an opportunity for a hearing consistent with the hearing procedures described below for appealing a prequalification rating.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the CITY in determining bidder responsibility prior to bid and to aid the CITY in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequalification rating, will preclude the CITY from a post-bid consideration and determination of whether a bidder has the quality, fitness, capacity and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness.

The prequalification packages submitted by Contractors are not public records and are not open to public inspection. All information provided will be kept confidential to the extent permitted by law. However, the contents may be disclosed to third parties for purpose of verification, or investigation of substantial allegations, or in an appeal hearing. State law requires that the names of contractors applying for prequalification status shall be public records subject to disclosure, and the first page of the questionnaire will be used for that purpose.

Each questionnaire must be signed under penalty of perjury in the manner designated at the end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the CITY and provide updated accurate information in writing, under penalty of perjury.

The CITY reserves the right to waive minor ir-

regularities and omissions in the information contained in the prequalification application submitted, and to make all final determinations. The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors may submit prequalification packages during regular working hours on any day that the offices of the CITY are open. Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information.

The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested

by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier

than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Department of Public Works senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.

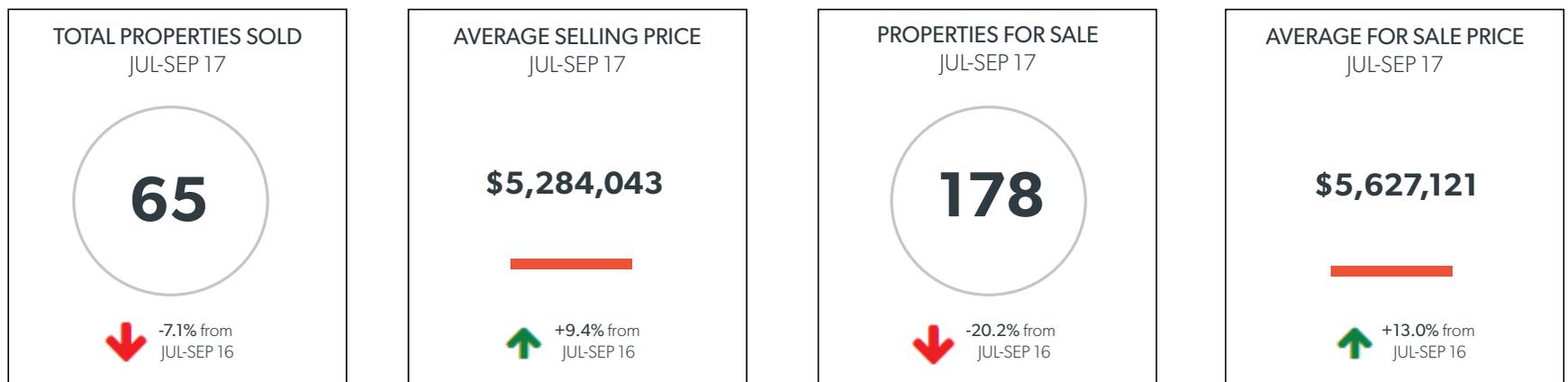

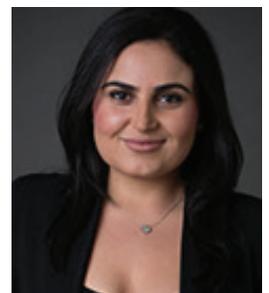
