

## Planning Commission Denies Covenant Amendment at 9150 Wilshire

The Planning Commission denied last Thursday a request by Dr. Armand Newman of New Lion Enterprises for an amendment to an existing covenant to allow an increase in medical floor area in the existing building located at 9150 Wilshire Boulevard.

Nearly 20 years ago, the Environmental Review Board approved development of the building when it adopted a Mitigated Negative Declaration. The decision was appealed the City Council, which upheld the decision and imposed additional conditions for approval.

Currently, the covenant limits the

building to a maximum of 5,000 square feet of medical floor area and requires the building to maintain parking spaces in excess of parking requirements for the uses on-site.

The request would have increased the maximum amount of medical use floor area to 11,000 square feet and to modify the number of excess parking spaces required from 86 spaces to 65.

But the commissioners expressed reservations with turning combining a medical building with general office space, which was the proposal's intention.

"I don't think the two uses fit well together," said Commissioner Lori Greene Gordon.

Commissioner Andy Licht commented that he doesn't see any point in changing the original decision made many years ago, calling the proposal "a tough one."

"It's always [about] the greater good and what's best for the city," said Licht. "I'm not sure what the city is gaining from this."

But Commissioner Joe Shooshani said that as long as the project proposal is amended to add more public parking, he would be in favor.

A 4-1 vote—with Shooshani dissenting—directed staff to prepare a resolution denying the project.

## "Do Not Increase the JPA" [Issue #935]

THE EMBARRASSMENT CONTINUES.

On Friday October 20, there was a Board of Education (Board)/City Council liaison meeting, which I attended along with about 20 other attendees, to discuss the Joint Powers Agreement (JPA).

The meeting began with an impassioned plea from Rick Wolfen, Assistant Regional Commissioner of the American Youth Soccer Organization (AYSO) Region 76. Without an agreement on the JPA, the AYSO might not be able to find sufficient venues for the upcoming season. It is hard not to sympathize with Rick who is volunteering his time for the youth of our community.

Next, Vice Mayor Dr. Julian Gold read an October 12 letter from Board President Mel Spitz withdrawing the Moss Adams report, prepared in support of the Board's request for a \$3.5 million increase in the JPA. Mr. Spitz's letter went on to withdraw the request of a \$3.5 million increase in the JPA, newly appoint Isabel Hacker and Mel Spitz as JPA liaisons and request a 60-day

extension to accommodate renewed negotiations. Dr. Gold said he was sure the city would accept the terms of the Spitz letter. Board liaisons Howard Goldstein and Lisa Korbatov then informed those present that President Spitz had rescinded the October 12 letter on October 16 and restated Mr. Goldstein and Mrs. Korbatov as Board liaisons. No one in the city received a copy of the October 16 letter prior to the October 20 meeting. HOW EMBARRASSING!

The meeting continued with City Manager Mahdi Aluzri stating that the "cost model" referred to on page 5 of the Moss Adams report had not been provided to the city in support of the results. The BHUSD claimed the cost model did not exist and/or may have been lost. MORE EMBARRASSMENT!

The remainder of the meeting dealt with the Board's claims that damage done by people using the JPA had not been reimbursed. The city replied that they had not received the claims being discussed but would certainly reimburse the BHUSD for any damage to District property associated with the JPA. WILL THE EMBARRASSMENT NEVER END?

After an hour and a half I walked away ashamed for our community and especially our children that we are so poorly represented by our Board of Education. I look forward to next year's election and the opportunity to help make some much needed improvements to the Board.

## Recreation and Parks Hears Ambassador Report

The Recreation and Parks Commission received an Ambassador Report at their meeting last Tuesday.

The Ambassador Program was created in 2015 to curb the panhandling that has plagued the City in recent years. According to Human Services Administrator James Latta, many people come to Beverly Hills because they find it “safe” and are aware of its great reputation. They will panhandle during the day and live in the City parks or parking garages at night.

The program, which is a hybrid of hospitality, safety, and social services, works to address this issue. During the business hours the team focuses on hospitality and safety services in collaboration with the City’s homeless outreach team.

At night, the team patrols over 1.85 million square feet of the City’s parking structures.

“Before, the person would just have to move to a different stairwell,” said Latta. “Now, with the Ambassadors Program, we have better coverage.”

Last Tuesday’s meeting discussed the 2016 Ambassador statistics. The presentation included numbers for the categories of Hospitality, Outreach, Night, Panhandling, and Hotline Calls.

In May, there were 224 unauthorized

field permits, and one in September. “Clearly the Ambassadors have been very effective with this and I thank you for doing that,” said Commissioner Frances Bilak.

## South Wilaman to Receive Preferential Parking Permit

The City Council approved a request to implement a preferential parking permit (PPP) zone “UU” on the 200 block of South Willaman Drive between Charleville Boulevard and Gregory Way.

It will include a permit parking regulation of “1 Hour Parking, 8 a.m. to 6 p.m., Monday through Friday, Permit ‘UU’ Exempt.”

The decision follows a Traffic and Parking meeting on August 3 where the commission reviewed a resident-initiated petition to establish a PPP zone

on South Willaman Drive. The request for a daytime regulation was signed by 75 percent (21 of 28) of the households on the 200 block of South Willaman and submitted in June.

The initial request was for a PPP of “No Parking, 8 a.m. to 6 p.m., Monday through Friday, Except by Permit” to address commuter parking impacts from businesses on Wilshire Boulevard, but the commission instead recommended a one hour parking allowance except for a ‘UU’ permit.

They voted unanimously to support the request with additions, with Chair David Seidel recusing himself from the discussion due to the proximity of his home to the block.

At deliberation, Councilmember Lester Friedman said that he was in support of the Traffic and Parking Commission’s recommendation, saying that the parked cars could actually be conducive to Willaman, which is a through street.

“Having parked cars on a street like Willaman acts as a traffic calming measure in and of itself,” said Friedman. “When there are parked cars, then people tend to go a bit slower.”

Ultimately, the Council voted a unanimous 5-0 to support the Traffic and Parking Commission’s recommendation.

## BHHS football team to face top-ranked Culver City in Season Finale

The Beverly High football team will end its season Friday night by playing at Culver City. The opening kickoff is set for 7 p.m.

The Centaurs (8-1, 3-1 in league play) were ranked first in the Southern Section Division 11 poll released Monday.

The Normans (0-9, 0-4) and Culver City have four common opponents – El Segundo, Hawthorne, Lawndale and Santa Monica. Beverly Hills is 0-4 against those teams, and were outscored by them 196-32, including 55-0 by Lawndale Friday night at Lawndale.

The Centaurs were 3-1 against those teams, outscoring them 149-60, including a 47-0 victory over Hawthorne and 42-0 victory over Santa Monica in their last two games.

The lone loss came Oct. 13 to undefeated Lawndale, 33-14. The Cardinals are ranked third in Division 5.

The Normans are winless in their last 14 games with Culver City, a streak that includes two ties. Beverly Hills lost the Centaurs, 63-8, last season.

## Todd Johnson

### Chamber of Commerce CEO

#### On last week's New York City trade mission

Tell us about last week's trade mission trip to New York.

The City and the Chamber have had these attractions/retention meetings with New York City for [a long time] because obviously there are a great deal of businesses that either come from Europe and go to New York or actually start in New York and work their way out this way or whatnot. This trip was extremely successful in the sense that Blair [Schlecter] reaches out and either finds businesses or we are contacted by businesses that want to come to Beverly Hills that we think would be a good fit. We certainly look for unique, different luxury items, restaurants, and not just main frame companies. We had 24 meetings, [and] the people that were there were the mayor, the vice mayor, the city manager, the assistant to the city manager, and then Blair and myself. We broke up into two teams of three and paired people up with their expertise. My background is in hospitality and restaurants so I certainly went to most of the restaurant meetings. [Mayor] Lili [Bosse] certainly has her luxury taste and became friends with the Gucci president. The trip predominately was attraction, but we did have a hand-

ful of retention meetings — with Barneys, Saks Fifth Avenue, Gucci, some of these main frame businesses that are here, we meet with their high-ups just to check in and see how things are, if there's something that we can do to help. We touched on the BOLD [initiative] to see how people felt about that. I've gone to four or five of these and this is probably the best one we've done.

#### How did you determine which businesses would be a good fit?

That's part of Blair's and my job is to research. We look up who's the hot topic, who's the hot restaurant, who's the hot business. We actually went and saw a virtual reality that's very new but probably going to be pretty big. These guys have been in business for about six months and seem to be killing it, so that's an example. So, we do our research, we look up ratings and Yelp.



#### Who were some of the retailers and restaurants you connected with while in New York?

We met with Chanel [and] Gucci. We met with Paul Stuart. We met with a very famous restaurant, Balthazar, and we have a meeting with them next week. They're coming out here and we have two or three other companies that are probably going to come first quarter next year— January, February, or March. Barney's, Saks of course, we met with a market called Canal Street, we met with a hot concept called Nur, which is an Israeli chef owner combination that's killing it back there. It's between a bakery and a restaurant. We met with a pretty interesting gym called Tone House. The industry seems to think it's one of the hardest workouts in New York City. And then, as I mentioned, VR World, which is the virtual reality.

#### The group met with supermodel Christie Brinkley. Tell us about that.

She was there for the CVB event. She has a line of Prosecco, three different healthier alternatives. One is sugar-free.

#### How are we sure that the annual trade mission actually leads to new business in Beverly Hills?

Blair. He did some real good research ahead of time and communication with these businesses, so when we came into town and met with them, we knew that we were meeting with the right people and not just a store general manager. If we go meet a Gucci store general manager, they don't have any influence over Beverly Hills. The

president of Gucci does. The head of Saks has a pretty big pull. It was successful because we/Blair did some serious homework and knew exactly who was coming and what, and there was a good line of communication ahead of time. So when we walked in there they were excited to meet us.

#### You're going straight to the source, essentially.

Exactly. It's a better, quote unquote bang for your buck, because you want to meet with the people who are decision makers and not someone who's regional. We did outreach to the RDC, the CVB, and just talked to some of our members—what do you think? Who do you think? Instead of just kind of guessing on our own, we really asked people because they know businesses.



## PLANNING COMMISSION APPROVES HILLSIDE ORDINANCE

So why are some residents and developers concerned?

The Planning Commission held a special meeting on the evening of October 26 to discuss an ordinance to amend development standards generally pertaining to basements and to grading and retaining walls in the City's Hillside area.

The proposed ordinance includes measures to an amendment of the definition of "floor area" that would define a basement as an area that is located directly below the portion of a story above which has a finished floor level that is a maximum of three feet above finished grade at any cross-section cut through the building with certain exceptions for driveways, light courts, pools and water features, and stairs and access ways that might otherwise cause a basement to be exposed by more than three feet above grade.

It also includes the addition of a definition of "light court," "finished grade" and "natural grade," and an amendment

of the language governing the maximum height of walls, fences and hedges within the Hillside area of the City.

A number of residents spoke at public comment about their approval of the ordinance, calling them "thoughtful and impactful."

"[The provisions] will serve to protect us from development that is out of scale and out of character with our neighborhoods, and shield us from severe traffic dangers," said resident Larry Murphy.

He also recommended that the provisions be "strengthened" by requiring R-1 applicants to submit projections of the total overall and weekly number of construction related trips by vehicle type.

But others expressed frustrations with the ordinance, both in person and in written correspondence. One particular letter from attorney Murray Fischer stated his objections and that he did "not generally support the items" of the ordi-

nance, according to Chair Lori Greene Gordon. Although Fischer requested it be read aloud, Gordon said she wouldn't for the sake of expediency.

Resident and developer Bob Etebar denounced the increasing restrictions on buildings, asserting that the only people in support of the proposal are the people who aren't building and "not interested in making their properties better, nicer, [and] more valuable."

A developer himself, Etebar said that the proposal's restrictions are "far more stringent" than other cities he has built in. He predicted that developers would be less likely to build in the future and that the city would go "stale."

"The facts are that there are properties that are smaller and properties that are larger. We can't paint everything with the same brush," said Etebar. "There needs to be proportional adjustments made."

Etebar encouraged the commission to conduct further research on the item before approving it.

"To say you want to place a limit on the number of trips—are we going to limit the number of furniture moves into the properties now? Are we going to limit food deliveries [and] parties?"

asked Etebar. "Where does it stop?"

At deliberation, the commissioners discussed the necessity of clarifying the basement definition as proposed.

"It's not to penalize people, it's not to pull the rug out from under people who were thinking about developing their homes, it's really trying to bring it back to what we all understood basements to be before the value of square footage has become so high that it now makes sense to start building these third floors," said

Commissioner Craig Corman.

The proposal also requested simplifying the landform alteration formula and further limiting the total amount of landform alteration allowed on a site. Commissioner Andy Licht said that although he doesn't know what the correct lower numbers would be, the proposed regulations "don't pass the smell test."

The commission said that they would like to hire an engineer to continue to look into the formula for further development.

Ultimately, they unanimously voted to recommend that the City Council adopt the ordinance as amended.


